

Attempts being made to 'finish off' Lingayat leadership: Community seer

(IANS) : Lingayat seer Dingaleshwara Swamiji of Balehosur has said that attempts are being made to eliminate second-rung leaders and major religious pontiffs of the community in the state. The statement was made in the presence of

Hubballi (Karnataka), Dec 20 former chief minister Jagadish Shettar during a programme organised to celebrate Swamiji's 68th birthday. Addressing the gathering, the seer stated, "There is a systematic conspiracy to destroy the mutts and second-rung leadership in state politics. I don't know if I should be talking about this on this occasion of birthday, but we must not tolerate one's destruction." "Religious seers and political leadership are strong pillars for society. We should ensure that the pillar of Lingayat leadership is stronger, and the time has come to be awakened in this regard," the seer said. Referring Hindu

to purans, Dingaleshwara Swamiji said: "Leaders of the community and religious pontiffs must be given weapons to ensure their protection." He said, "The goddess did not have a weapon. After receiving weapons from others, she destroyed evil forces. I am referring to this because our leaders need to be given weapons. There is a conspiracy in Karnataka to weaken strong leaders, and religious seers are no exception. Even religious seers are targeted and defamed."

FIR against six men for demanding Rs 20 lakh extortion in Bihar

Patna, Dec 20 (IANS) : Police have registered an FIR against six persons for demanding Rs 20 lakh extortion from a doctor in Bihar's Rohtas district. The FIR was registered on a written complaint by Manoj Kumar Pandit, a homeopathic doctor, who has a clinic in Masidiha village under Aayar Kotha police station in the district. As per the FIR, Pandit claimed that six persons in an SUV came to his clinic on Wednesday, entered into the staff room and demanded extortion of Rs 20 lakh. "The accused barged into the staff room and demanded extortion. Soon all staff members assembled in the room after which the miscreants fled the spot," Pandit said. "We have received a complaint and registered an FIR in this matter. We are also scanning the CCTV footage obtained from the clinic and trying to identify the accused. They will be put behind the bars soon," Prachi Kumari, SHO of Aayar Kotha police station, said.



Atiq's aide Nafees Biryani dies of heart attack

Prayagraj (UP), Dec 20 Khuldabad home in Prayagraj (IANS) : Nafees Biryani, wanted in the Umesh Pal murder case and a close associate of slain gangster Atiq Ahmad, died in a Prayagraj hospital on Wednesday.

Nafees, 40, had suffered a massive heart attack in Naini jail on Sunday night and was taken to hospital. He died hours later.

Nafees, wanted in the Umesh Pal murder case, was arrested on November 23 after gunfire with Uttar Pradesh Police near Prayagraj.

When the police started checking near the border Pratapgarh-Prayagraj, Nafees and his associate opened fire. In the retaliatory firing, Nafees was shot in the leg and got injured. Cops arrested Nafees but another accused escaped in the bushes. Nafees was carrying bounty of

Rs 50,000 on his head.

3 killed, 3 hurt as drunk driver crashes into 6 vehicles in Thane

Thane, Dec 20 (IANS) : At least three persons were killed and three more injured when an inebriated driver rammed his speeding car into four other cars and two autorickshaws, here shortly before dawn on Wednesday, police said. The pile-up of the seven vehicles occurred on the Badlapur-Kalyan Road around 5.30 am near the Shantinagar locality. Won't allow PM Modi to form govt again in 2024: Lalu Prasad

Patna, Dec 20 (IANS) : RJD chief Lalu Prasad on Wednesday said that he will not allow Prime Minister Narendra Modi to form a government at the Centre again in 2024. After SC directive for Mathura, green activists in Agra demand action to control Juli Flora's spread

Emboldened by the Supreme Court directive for Krishna Janmabhoomi (Braj Bhoomi) to control the spread of Juli Flora, a foreign invasive species, green activists in the Taj Trapezium Zone have demanded firm action to promote native vegetation after clearing uncontrolled growth of Vilayati Babool that was disturbing the eco-balance.

Alarmed over the uncontrolled spread of Juli Flora at the cost of native varieties of plants and trees, groups of green activists have urged the Uttar Pradesh Forest department and the horticulture department to draw up a strategy to arrest the further growth of Juli Flora all over the state. A concerted campaign has been launched by Taj City's environmentalists against (vilayati babool) Prosopis Juliflora, a foreign specie, and highly invasive with pan India

Agra, Dec 20 (IANS) : spread. Senior Supreme Court advocate K C Jain, the campaign crusader, said: "This foreign species had become aggressively invasive and was a menace to local species of flora. It spread rapidly overtaking native vegetation thus threatening biodiversity."

This thorny shrub disturbed the ecological balance and was causing esthetic pollution in the city of the iconic Taj Mahal, Jain told the activists at Paliwal Park on Sunday.

Activists said the spread of the Juli Flora in the eco-sensitive Taj Trapezium Zone was a matter of concern and the UP Forest Department should immediately draw up a battle plan to mitigate its spread at the cost of other local varieties of trees that could sustain the exploding simian population, the butterflies and the migratory birds in the Soor Sarovar sanctuary area. Tree lover Ankush Dave said the first step was to contain the spread of this "evil tree" by removing the



existing plants with the roots. "This of course would be a huge challenge due to its rapid growth and resilience, but further expansion had to be prevented at any cost," Dave added.

The UP Forest Department has to start a monitoring and surveillance programme to control and manage the spread of this tree. Along with physical removal, herbicides could be used in the initial stages. Care should be taken not to harm the native vegetation or disturb the surrounding ecosystem.

Dr. Mukul Pandya, passionate horticulturist of Agra, said: "We need to start a public awareness and

education programme to garner support from all stakeholders. The UP Forest Department, the Archaeological Survey of India, the UP Tourism Department, and other agencies should get involved and mount a concerted attack on this vile species of flora which had hit the wide biodiversity of the Braj Mandal."

After clearing the areas steps should be taken to restore the native vegetation in specified areas. Replanting native species and promoting their growth could help balance the ecosystem and biodiversity in the Agra region, Pandya added. The Juli Flora spe-

cies had spread its tentacles wide from the Chambal River in the southwest of Agra to the Yamuna river banks up north.

"Earlier, hundreds of varieties of local trees were grown, hundreds of species of birds and butterflies were seen, but now all you see is the ubiquitous thorny Juli Flora," said Eco Club president Pradip Kumar. Lok Swar President Rajiv Gupta said: "Juli Flora was essentially a foreign species popularised in India by some British officials who brought it from South America. Some kings of Rajasthan took a fancy to this species because it is suited for semi-arid and arid areas, requiring little or no care. Brackish water and high salinity soil are also no deterrent for this species which propagates on its own. It has a pan India spread from Tamil Nadu to Kutch in Gujarat. We need to get agriculture scientists involved in research on this species."

NIA searches 19 locations in terror module network

New Delhi, Dec 20 (IANS) : The National Investigation Agency (NIA) on Wednesday carried out searches at over 19 locations in the country in connection with a radicalised jihadi terror group. Agency sources said that the searches are underway at over 19 locations since early morning. The sources said that the searches are in connection with the busting of a major IS jihadi terror group.

Last week, the NIA carried out searches at over 44 locations and arrested 15 people in connection with the IS Module case.

During the searches, the anti-terror probe agency seized large quantities of unaccounted cash, weaponry, sharp implements, sensitive documents, and various digital devices.

The Dubai COP 28 summit started a fortnight ago with little promise of any major break through on climate rules. However, the governments and delegates this time proved their critics wrong and the final agreement announced that for the first time the world has agreed to move away from the coal, oil and natural gas that are the principal causes of global warming. Though right from the start or even before it started, the vibes from the Dubai Summit were not positive. However, as the jamboree ended, 198 countries announced that they are committed to phase out fossil fuels as they pose the main climate change accelerators. The countries agreed to contribute to a transition "away from fossil fuels in energy systems in a just, orderly and equitable manner, accelerating action in this critical decade, so as to achieve net zero by 2050 in keeping with the science."

This could be counted as some progress as just a few years ago it was inconceivable that fossil fuels, which in fact still fulfil almost every country's energy needs to a large extent will be shamed and might be banned. However, the announcement doesn't mean anything, as there is no mandate behind it, but it could help build momentum for more action from governments. The Paris climate agreement's commitment that countries would pursue efforts to limit global heating to 1.50 degree C, above pre-industrial levels staged a version of this in 2015. In fact, the agreement doesn't underline the urgency required to avoid worsening climate destruction, and it includes language, which may fuel further delay or non-action. While oil and gas companies have not yet committed to producing less fossil fuel, their pledge to cut emissions from their own operations is noteworthy. In the agreement, instead of highlighted the harmful effects of Carbon Dioxide - CO2, the delegates were somehow influenced to focus more on Methane-CH4. Methane, an odourless gas, is produced by virtually every oil and gas project worldwide. When it is not cost-effective to capture it, companies often release methane into the atmosphere via venting or burn it through flaring, which ironically converts it into Carbon Dioxide. The gas also leaks into the atmosphere from facilities via innumerable small, undetected or unreported leaks in pipelines or other equipment, or through large-scale releases called "superemitter" events. Scientists say methane has been responsible for up to 30 per cent of global warming since the industrial era began, so the Dubai agreement offers a win for the climate, even if the 50 signatories account for less than a third of the industry's total operational emissions. Oil companies may choose to shut some production because that is the most cost effective answer to the target of zero flaring of methane. Some of the biggest oil companies have already promised zero routine flaring and near-zero methane, and a number have shown that big progress can be made on the latter. A second COP28 commitment could affect demand for fossil fuels by tripling the world's renewable energy generation capacity to at least 11,000 Gigawatts -GW by 2030. More than 120 countries signed up to this pledge, which will require a big leap in effort from what has been done before. It took 12 years from 2010 to 2022 to achieve the last tripling of renewable capacity. This one has to be done in the space of eight years. This means that meeting the goal will be difficult, but achievable. This is also supported by the fact that solar and wind are now the cheapest sources of new energy generation in most countries, but the growth of renewables is being held back by a range of bureaucratic and regulations bottlenecks that many authorities are struggling to unblock. The third COP28 commitment with implications for hydrocarbons is aimed at boosting energy efficiency. More efficient and smart use of energy is widely referred to as the "first fuel" in clean energy transitions because it offers some of the quickest and most cost-effective options for cutting emissions, lowering energy bills and bolstering energy security. The countries that signed up to the 2030 renewables pledge agreed to collectively double the global average annual rate of energy efficiency improvements from around 2 per cent to more than 4 per cent every year until 2030.

Has Dawood Ibrahim been poisoned in Pakistan? Why the speculated rumours do not fit?

mors about a suspected poisoning of underworld don and absconder terrorist Dawood Ibrahim Kaskar have taken the social media platforms by storm, making headlines on almost every mainstream media. While the news is still unconfirmed, there were many loopholes in the rumoured development that do not fit right.

This week started with the major news development, referring to a rumour that the underworld Dawood, allegedly residing in Karachi, has been poisoned by an "unknown man" and was shifted to a hospital in critical condition. The news, banked on a rumour and unknown source, further claims that the 67-year-old has been living in Karachi with his second wife along with his three daughters and a son under tight security and away from the public glare. It also claimed that the hospital where Dawood has been taken is also put under tight se-



peculated reports and ru curity. While all the rumoured claims are yet to be confirmed by a reliable source in Pakistan, the news itself does not seem to have been thoughtfully drafted.

Firstly, Pakistan has officially denies Indian claims that Dawood resides in Karachi or any other part of the country and therefore, would not confirm the rumour if it may be considered to be true.

And even if the rumour is to be seen on its face value, the claim that Dawood has been poisoned by an unknown man seems to be far from the actual position on ground, especially in reference to the fact that he is an underworld don and India's most wanted man. Reliable sources have said that it is almost impossible for any unknown person to have an access to Dawood as he is surrounded by his most trusted people, family members, close aids and security, who ensure that he is kept safe.


"It is almost impossible for any person to have such kind of an access to Dawood Ibrahim. As I un-



derstand, he would be surrounded by his trusted security and aids. And even if he may be in Karachi or anywhere else, keeping him safe would remain as the top most priority of his people. So reports about him being poisoned by an unknown man do not fit at all," said one of the sources.

Dawood Ibrahim is an elderly man now. At the age of 67, it has been reported that he has medical issues and maintains his health through various medications. It is highly likely that he may have gotten sick due to the some medial issues, if only any part of the rumor is to be believed to be true.

The claim about presence of Dawood in Karachi is what India claims, referring to confirmations by his family members and their statements to the National Investigation Agency (NIA). In January 2023, it was reported that Dawood's nephew confirmed to NIA that he had remarried in Pakistan and was living with his family in Karachi. "Dawood Ibrahim has a second wife. Her name is Maizabin. He has three daughters Marukh, Mehrin and Mariya, and one son Mohin Nawaz, "Alishah Parkar, son of Dawood's sister Haseena Parkar, had said in a statement given to NIA during November last year.

US Defense Secretary Lloyd Austin to arrive in Israel today

Tel Aviv, Dec 20 (IANS) : Following the recent high-profile visits by US Secretary of State Antony Blinken and National Security Adviser Jake Sullivan to Israel, US Secretary of Defense Lloyd Austin will arrive here on Wednesday.

The visit assumes significance as the raging war between Israel and Hamas has entered the 73rd day, with International pressure mounting on the Jewish nation to stop the hostilities in Gaza following several civilian casualties.

Sources in Israeli Defence Ministry told IANS that Austin will announce a new Marine Protection Force in the Red Sea as the Iran-backed Houthi militia in Yemen have attacking and even hijacking ships passing through the crucial region.

The Defense Secretary will also visit Qatar as part of a larger framework for mediatory talks between Israel and Hamas. He is also slated to make a stop in Bahrain.





US to suspend rail operations on southern border due to migrant surge

: The US Customs and Border Protection (CBP) announced that it will temporarily suspend operations at the international railway crossing bridges in Eagle Pass and El Paso, Texas, from Wednesday due to the continued surge in migrant crossings. In a statement on Sunday, the CBP said the suspension, which will come into force at 8 a.m. (local time) on Monday morning, is "in order to redirect personnel to assist the US Border Patrol with taking migrants into custody". The agency further said that it is "continuing to surge all

Washington, Dec 20 (IANS) available resources to safely process migrants in response to increased levels of migrant encounters at the southwest border, fueled by smugglers peddling disinformation to prey on vulnerable individuals". "After observing a recent resurgence of smuggling organisations moving migrants through Mexico via freight trains, CBP is taking additional actions to surge personnel and address this concerning development, including in partnership with Mexican authorities." it added.

> The CBP went on to say that in the past few weeks, it has made a "number of operational adjustments in order to maximse our

ability to respond, process, and enforce consequences". "In Eagle Pass, vehicular processing remains suspended at Eagle Pass International Bridge 1. In San Diego, California, San Ysidro's Pedestrian West operations remain suspended. In Lukeville, Arizona, the Lukeville Port of Entry remains closed.

""We continue to adjust our operational plans to maximise enforcement efforts against those noncitizens who do not use lawful pathways or processes... and those without a legal basis to remain in the US," it added. Earlier Wednesday, border authorities apprehended nearly 3,000 migrants in Del Rio, Texas, and around 1,300 migrants in El Paso, straining federal resources, CNN quoted a Homeland Security official as saying.

Eagle Pass is in the Del Rio Border Patrol Sector.

In the first 14 days of December, more than 37,000 migrants were apprehended in the Tucson Border Patrol Sector alone -- which includes Lukeville. Last month, border authorities apprehended about 192,000 migrants between ports of entry in November, a 2 per cent increase compared with the 188,000 migrant apprehensions in October.



4 more Israeli soldiers killed in Gaza, overall toll reaches 126

Gaza, Dec 20 (IANS) : Qatar derstandings for a humanitarhas presented new proposals to resume the hostage deal between Israel and the Hamas to facilitate a ceasefire in the Gaza Strip amid the raging war, a Palestinian source said.

12 shot dead in Mexico Christmas party

Mexico City, Dec 20 (IANS) : At least 12 people were shot dead during a Christmas party in the municipality of Salvatierra of Guanajuato state, Mexico, authorities have said. The bloodshed occurred on Wednesday during a Christmas posada, a traditional Mexican celebration, in the community of San Jose del Carmen, the Guanajuato Attorney General's Office said, adding that an investigation is under way. A group of armed attackers arrived unexpectedly and opened fire at posada participants, the majority of them young people, leaving 12 dead and 10 injured, Xinhua news agency reported, citing initial reports from the municipal government. The wounded were taken to hospitals in the municipality, authorities said, without providing details about their conditions.

HK media mogul Jimmy Lai's trial begins

Hong Kong, Dec 20 (IANS) : The trial of Hong Kong media mogul Jimmy Lai, who has been in prison since 2020 over charges of colluding with "foreign forces", began on Wednesday and if found guilty, the 76-year-old could face life imprisonment.

Lai, a UK citizen, was arrested under the National Security Law (NSL), introduced by China in 2020 in response to massive pro-democracy pro-

tests in Hong Kong, insisting that the law was necessary to quell unrest. China considers Lai a traitor who sought to undermine its national security, the BBC reported. According to the media mogul's legal team, he has been denied his choice of legal representation, after Beijing barred him from appointing a UK lawyer. He is being tried by three judges handpicked by Hong Kong Chief Executive John Lee, the team

added. Lai, an outspoken critic of

the Chinese Communist Party, is one of the most high-profile people to be arrested under the NSL. Before he was detained, he was often at the frontline of pro-democracy protests, such as the 2014 Umbrella Movement and the 2019 demonstrations against an extradition bill. He founded and ran some of Hong Kong's best-known media outlets, including the now-defunct newspaper Apple Daily.



the scheme, Rs 1,943.34 crore was taken as premium from the farmers, while the state's share was Rs 2,575.10 crore and the Centre's Rs 2,295.42 crore. A total of Rs 6,813.87 crore has been given to insurance companies, while a total compensation of Rs 7,967.40 crore to farmers. Replying to another question, Dalal said the government is making all-out efforts to ensure that the Yamuna river area in Karnal district is not af-

fected due to floods. At a meeting of the Flood and Drought Relief Control Board, projects worth Rs 33.77 crore have been approved and their work will be completed soon.

Apple Watch ban may cost firm \$300 to \$400 mn in sales: Report

San Francisco, Dec 20 (IANS) : Apple's decision to stop selling two of the latest models of Apple Watches -- Series 9 and Ultra 2 -- in the US this week could cost the company hundreds of millions of dollars, media reports said. As estimated by Wedbush Securities analyst Dan Ives, if Apple moves ahead with its plan to stop selling the two smartwatches, the decision will likely cost Apple about \$300-400 million in holiday-season sales, reports Insider. That's a relative drop as analysts are expecting Apple to generate close to \$120 billion in sales during the October-December period, including the holiday shopping season.

The sales suspension on the two Apple Watch models "doesn't move the needle much for the company, but still, it couldn't have come at a worse possible time," Ives was quoted as saying.

So far, Apple's stock hasn't been significantly affected by the sales suspension on the two watch models, remaining near its record high, the report noted.

"Apple strongly disagrees with the order and is pursuing a range of legal and technical options to ensure that Apple Watch is available to customers," a representative for Apple was quoted as saying.

New Delhi, Dec 20 (IANS) : In a strategic move to bolster SpiceJet's financial position and spur growth, Mumbaibased businessman Harihara Mahapatra and his wife Preeti have announced a substantial investment of Rs 1,100 crore in the airline. The acquisition secures the couple a 19 per cent stake in SpiceJet, as revealed in a stock exchange filing by the airline. The investment plan includes participation from Aries Opportunities Fund, holding three per cent, and Elara Capital, securing an eight per cent stake through the conversion of warrants.

Earlier, the Board of Directors of SpiceJet unanimously approved the infusion of fresh capital exceeding Rs 2,250 crore.

This move involves issuing equity shares to financial institutions, foreign institutional investors (FII's), high net worth individuals (HNI's), and private investors.

An official from SpiceJet said, "The Board's unanimous decision reflects our commitment to strengthening the airline's financial foundation and propelling its growth trajectory. The issuance of equity shares and warrants under private placement is subject to necessary approvals from shareholders and regulatory bodies."

The proposed preferential issues encompass a diverse group of investors, including Elara India Opportunities Fund, Aries Opportunities Fund, Mahapatra Universal Limited, Nexus Global Fund, Prabhudas Lilladher, Resonance Opportunities Fund, among others, aiming to raise funds aggregating over Rs 2,250 Crore.

The Board of Directors, in a meeting held on December 12 gave the green light for issuing up to 31,83,00,000 equity shares of face value Rs10 each ('Tranche I Issue') and up to 13,00,00,000 warrants, convertible to equity shares ('Tranche II Issue'), on a preferential basis.

Sugar output rises in UP but falls in Maharashtra, Karnataka

New Delhi, Dec 20 (IANS) : Sugar production in the country declined by 10.7 per cent to 7.4 million metric tonnes during the current season so far (till Dec 15) as several mills in Maharashtra and Karnataka started operations a fortnight after the scheduled date of the start of the crushing season from Oct1, according Indian Sugar Mills Association (ISMA).

The sugar output in Maharashtra's dropped to 2.44 million tons from 3.3 million tons compared to the same period last year, while Karnataka's production fell 11.7 per cent to 1.7 million tons. However, sugar production in Uttar Pradesh increased by 9 per cent to 2.2 million tons during the current season as mills started their operations early. The government has eased the ban on diverting sugarcane juice for the production of ethyl alcohol to allow mills to divert up to 1.7 million tons of sugar for the purpose so that their profitability is not hit and sugarcane farmers are paid in time.



Delhi HC refuses to entertain PIL for urgent implementation of Women's Reservation Bill

The Delhi High Court on Wednesday refused to entertain a Public Interest Litigation (PIL) urging to urgently implement the Women's Reservation Bill, 2023, ensuring 33 per cent reservation for women in the 2024 Lok Sabha polls.

The Union Government, represented by Additional Solicitor General (ASG) Chetan Sharma, informed the court that the Bill has become an Act. "It is an exercise after the census. It has been engrafted under the Act. It has been debated in the parliament...This is a publicity litigation," the ASG said. The petitioner, while not challenging the Act or Bill's

New Delhi, Dec 20 (IANS) : validity, sought time-bound implementation of women's reservation. "I am not challenging the Act or the Bill...In the history of India, for the first time the parliament has unanimously passed the Bill. Since 75 years, there has been no representation. Let them come and say we can do it in a time bound manner. I am not challenging anything. I am only trying so that it can be done in a time bound manner. Otherwise it is not going to happen," petitioner's counsel said. The court noted the parliamentary stipulation for delimitation before women's reservation and suggested challenging the provision's validity. It stressed on the ongoing matter in the Supreme Court and the need for the petitioner to

either seek quashing or present compelling grounds.

With the PIL withdrawn, Acting Chief Justice Manmohan and Justice Mini Pushkarna granted the petitioner, lawyer Yogamaya MG, the liberty to approach the Supreme Court, where a similar petition is already pending. Last week, Justice Subramonium Prasad had refused to entertain the same matter and had observed that the prayers resembled a PIL and suggested the petitioner to withdraw the plea and file a fresh PIL. The court had granted the petitioner the liberty to file a new PIL properly framed according to the Delhi High Court rules.



Increased benefit for lapsing customers to affect returns for persistent life insurance policyholders

New Delhi, Dec 20 (IANS) : The ticket policies with increased proposed modification in the surrender value (or charges) of nonlinked life insurance policies in the recently released the 'Exposure Draft Product Regulations 2023' by Insurance Regulator IRDAI has stirred up a hornet's nest, Emkay Global Financial Services said in a report.

The idea behind this move seems to be bringing in additional control on expenses.

The proposed changes in the surrender charges are looking to eliminate any surrender penalty above the "threshold premium", which means a material and increasing change in the surrender value for higher-

premium, the report said. The proposal is still in the draft stage, to be applied prospectively, and there is no clarity on the "threshold premium", making it extremely difficult to gauge the extent of impact on individual life insurers.

The accidental outcome of this proposal by the Regulator, to improve policyholders' friendly aspect, is an indirect nudge or encouragement towards surrenders—and this goes against its philosophy of positioning life insurance as the long-term savings and protection product, the report said.

Congress slams Vijayan as Kerala turns India's 'Covid capital'

The reason behind the outage is yet not clear as the Pakistan Telecommunication Authority (PTA) has not issued any statement on the matter, the media outlet reported.



Serbia holds extraordinary parliamentary election

Belgrade, Dec 20 (IANS) : Polling stations are open as Serbia conducted extraordinary elections on Wednesday, with citizens voting at parliamentary and local levels to decide state leadership for the next four years. Polling stations, numbering 8,273 both within Serbia and abroad, opened early Wednesday morning. A total of 18 political parties or coalitions are vying for 250 seats in the national parliament, Xinhua news agency reported. The political parties or coalitions securing the highest votes can engage in negotiations to shape the upcoming government.

Serbian President Vucic claims absolute majority at snap polls

Serbian President Alexander Vucic announced that the coalition around the ruling Serbian Progressive Party (SNS) won over 127 out of 250 seats at the snap parliamentary elections.

"This is an absolute victory that makes me very happy," Vucic said on Wednesday night, noting that the coalition around SNS also won the elections in Serbia's northern

Belgrade, Dec 20 (IANS) : province of Vojvodina. Vucic said that Serbia will stay on the path to European Union (EU) accession while defending its territorial integrity in its southern province of Kosovo and Metohija, reports Xinhua news agency.

> According to unofficial results of the independent election monitoring organisation CESID, based on 80.2 per cent of their sample, the coalition around SNS "Serbia Must Not Stop" won 46.4 per cent of votes.



The second-ranked is the pro-European opposition coalition "Serbia Against Violence" which won 23.3 per cent.

The SNS has been in power since 2012 but there have been three


elections in the past three years. As well as voting for parliament, Serbians were deciding on Sunday who would control 65 local authorities.

Turnout nationally was estimated

at 59.1 per cent. Serbia is a candidate to become a member of the EU, and President Vucic is under pressure from both the bloc and the US to normalise relations with Kosovo.

Kosovo declared unilateral independence from Serbia in 2008, and while it is recognised by more than 100 UN members, Serbia has refused to do so - backed by allies like Russia, China and five EU members.

Some 95,000 ethnic Serbs live in Kosovo and those who wanted to vote had to cross into Serbia to cast their ballot.



Vivek Ramaswamy participates in over 40 campaign stops in a week

Washington, Dec 20 (IANS) : Indian-American presidential hopeful Vivek Ramaswamy participated in 42 campaign stops last week, more than any other 2024 candidate.

According to the USA Today newspaper, the 38-year-old biotech entrepreneur hopes to keep up his rigorous timetable, hitting 38 events this week. At a campaign stop in Iowa on Wednesday, Vivek acknowledged that there is a "logistically grueling element" to his schedule, but the energy of the crowds in the state is keeping him motivated. The Yale Law School graduate with a net worth of about \$630 million said the formula that works for him is "W-O-R-K", and it all stems from a lesson learned from his parents. "Here's how you spell luck: W-O-R-K," Ramaswamy said.

"It's always been a formula that has worked for me in my life and be it in my academic background, be it as a student, be it in my career, as a businessman and now on this journey," he told USA Today. Anson Frericks, who co-founded the company Strive Asset Management with Ramaswamy early last year, told USA TODAY there's no time for rest in the latter's schedule. "There's no one that I've ever met that gets up in the morning, works out while he's taking phone calls," said Frericks, who's known Ramaswamy since high school. Ramaswamy worked 16 hours per day at Strive, Frericks said, and that work ethic culture "permeated" throughout the organisation. He is running fourth nationally in the aggregation of polls by RealClear Politics, which shows him with five per cent support in Republican primaries.

In the New Hampshire state primary, RealClear Politics places him fifth with seven per cent. On January 23, that state will be the second to hold intraparty elections for the Republican Party nomination, which can enable it -- and Iowa, which will be the first on January 15 -- to influence the primaries that follow in determining who stays on in the race where former President Donald Trump holds an overwhelming lead. N.Korea fires 'unspecified ballistic missile' toward East Sea for 2nd day Seoul, Dec 20 (IANS) :

North Korea fired an unspecified ballistic missile toward the East Sea on Wednesday, the South Korean military said, just hours after it launched a short-range missile, amid speculation the latest one could be an intercontinental ballistic missile.

The Joint Chiefs of Staff (JCS) said it detected the launch but did not give further details, Yonhap news agency reported.

North Korea fired a shortrange missile from in or around Pyongyang at 10:38 p.m. Sunday, and it flew about 570 km before splashing into the East Sea, according to the JCS.

The back-to-back missile launches came after South Korea's First Deputy National Security Adviser Kim Taehyo said a few days earlier

that the North could fire an ICBM within this month. The firings also came days after Seoul and Washington held the second session of the Nuclear Consultative Group (NCG) and agreed to complete the establishment of guidelines on the planning and operation of a shared nuclear strategy by the middle of next year.

Just after Wednesday's launch, the North's defence ministry lambasted the NCG meeting as "an open declaration on nuclear confrontation" and criticized the U.S.' deployment of major military assets to the Korean Peninsula this year. The North's latest sabre-rattling also came amid heightened tensions after Pyongyang scrapped a 2018 inter-Korean military agreement designed to reduce tensions and prevent accidental clashes along the border last month.

Assam Police arrest 4 persons involved in **Jorhat blast**

Guwahati, Dec 20 (IANS) : Assam Police have arrested at least four persons for their involvement in the minor blast which happened recently in Jorhat town near an Army camp, officials said on Wednesday.

The arrested individuals have been identified as Rahul Mohan, Dibyajyoti Chetia, Mintu Chetia, and Rintu Nath. Police said that all of them were working closely with the United Liberation Front of Asom -- independent (ULFA-I) cadres.

On December 13, a mild blast occurred near an Army camp in Assam's Jorhat town's Lichubari area.

Lt. Col. Mahendra Rawat, the Army PRO at Guwahati told IANS: "The miscreants threw a handmade bomb in a dustbin near the gate of the army camp in Jorhat. However, there were no casualties."

The banned militant group ULFA-I had taken responsibility for three small explosions that happened in the districts of Tinsukia, Sivasagar, and Jorhat in Assam between November 22 and December 13.





WBSSC faces Calcutta HC's ire over unsatisfactory report in school job scam

Kolkata, Dec 20 (IANS) : The West Bengal School Service Commission (WBSSC) authorities, on Wednesday, faced the ire of a Division Bench of the Calcutta High Court for an unsatisfactory and incomplete report on the school job recruitment irregularities case that had been submitted to the court. The Division Bench of Justice Debangsu Basak and Justice Shabbar Rashidi even observed that in the last report filed in court, the third such report filed by the commission, the WBSSC seemed to have made an attempt to hide a lot of things.

Justice Basak and Justice Rashidi also directed the commission to file its fourth report within the next 48 hours as the matter will come up for hearing again on December 20. The Division Bench of Justice Basak and Justice Rashidi is a Special Bench constituted by the Calcutta High Court's TS Sivagnanam to hear the cases relating to the multi-crore cash-for-school job case in West Bengal. The Special Bench was constituted following a direction from the Supreme Court in the matter. Earlier, several secondary teachers in different state-run schools in West Bengal lost their jobs following an order of the Calcutta High Court. The job-losers subsequently approached the Supreme Court of India challenging that order.

ASI submits survey report on Gyanvapi mosque, court reserves verdict

Varanasi, Dec 20 (IANS) : The Anjuman Intezamia Masajid Archaeological Survey of India (ASI) on Wednesday submitted a 1,500-page survey report on the Gyanvapi mosque at a Varanasi court in a sealed cover.

ASI submitted the report before

the Varanasi district Judge A.K.

Vishvesha.

Committee (which manages the mosque) seeking information about the survey report. After the submission of the report, the Hindu worshippers prayed before the court to make the report public and sought directions for the supplying of copies of the report to all parties. The ASI conducted a scientific survey of the Gyanvapi complex in Varanasi as per the July 21 order of the Varanasi District Judge to determine if the mosque was constructed over a pre-existing structure of a Hindu temple. On August 4, the Supreme Court refused to stop the ASI from surveying the mosque, except the 'wuzukhana' area where a 'Shivling' was claimed to have been found last year. Taking on record an undertaking made on

behalf of the ASI that no excavation would be done at the site and no damage will be caused to the structure, the court had allowed the survey to take place.

The court had ordered thus while disposing of a petition filed by Anjuman Intezamia Masjid Committee (which manages the Gyanvapi Mosque at Varanasi) challenging the Allahabad High Court order (of August 3) which permitted the ASI survey. On July 21, Varanasi District Judge directed the ASI Director to conduct a "scientific survey" of the Gyanvapi mosque premises except for the area that was sealed earlier (wuzukhana) to find out if the same has been built over a pre-existing structure of a Hindu temple. This order was upheld by the Allahabad High Court on August 3.

Fine villagers who stood mute spectators during victim's nude parade : K'taka HC to Govt

Bengaluru, Dec 20 (IANS) : Chief Justice PB Varale and Jus-The Karnataka High Court on Wednesday expressed the opinion that the villagers who stood mute spectators as a Dalit woman was stripped and paraded naked, should be fined by the Government, and the amount must be given to the victim.

A Division Bench, headed by

tice Krishna S Dixit, while looking into the PIL filed regarding the case, further stated that the Karnataka Government should make a provision for punishment or imposition of fines on the people of Vantamuri Village in Belagavi district where the incident took place. The Bench mentioned that William Bentinck, a Governor General of British-occupied India, imposed additional duties on villages where people indulged in thefts. Likewise, if additional duties are levied in the present circumstances, the people will show more responsibility in future.

"If people turn mute spectators when such incidents occur, what message goes out to society? The villagers who displayed cowardice for selfish goals should understand their responsibility towards the community. Such acts cannot be tolerated. The Government has to impose additional duties and collect fines from every resident of the village," the Bench stated. "The behaviour of the villagers at a time when a woman is stripped and assaulted, being mute spectators, is condemnable. If incidents like this are to stop in the future, a message has to be delivered to civil society. In this backdrop, we are ordering the collection of fines," the Bench explained. Advocate General Shashi Kiran Shetty, representing the Government, submitted that a person named Jahangir helped the woman. "When the incident took place, there were 60 to 70 people, and no one, including gram panchayat members, dared to help the victim," said Advocate General Shetty.

"The victim has undergone counseling, and better treatment is being administered. Her health is improving daily. "The Government has taken the case seriously and handed it over to the CID for an effective probe and 11 people were arrested.

The Government has also given two acres of land and Rs 5 lakh as compensation to the woman," he explained.

The police officers and others who showed negligence are suspended. This incident would not have taken place if the members of the gram panchayat had intervened, he added

"A man entered the office of a kindergarten director who is Jewish, brandished a large knife, and said, 'You're a Jew. You're a Zionist. Five of us are going to rape you & amp; cut you up like they did in Gaza'," the group said in a post on X. There has been a marked increase in both anti-Semitism and Islamophobia since October 7. ADL has said it recorded

2,031 anti-Semitic incidents between October 7 and December 7, which is 337 per cent more than the 465 incidents recorded over the same period in 2022. The Council on American-Islamic Relations, an advocacy group for Muslim Americans, has said it has received 2,171 complaints of anti-Muslim and anti-Palestinian bias. The rift has been playing out in U.S. colleges where anti-Semitism reached an alarming level that ended in the resignation of the president of one of the top universities following a congressional hearing.

Moscow, Dec 20 (IANS) : The Russian air defence downed 33 Ukrainian drones over several Russian regions, the Russian Defence Ministry said on Sunday.



S.Korea to coordinate bilateral, trilateral measures with US, Japan against N.Korea's provocations: Official

Korea will work toward coordinating bilateral and trilateral measures involving the US and Japan if North Korea continues to engage in provocations, a senior Seoul security official said on Wednesday. Principal Deputy National Security Adviser Kim Tae-hyo made the remarks at Incheon International Airport, west of Seoul, after returning home following his attendance at the second meeting of the South Korea-US Nuclear Consultative Group (NCG) in Washington.

Last week, Kim raised the pos-



"If such provocations from North Korea continue, we will work toward coordinating necessary measures between South Korea and the US, actions the two countries can take individually and joint actions that South Korea, the US and Japan can collectively implement," Kim told reporters after arriving at the airport. Kim added that Washington also "recognises the possibility of North Korea

He noted that the North Korea's potential capability to equip missiles with nuclear warheads was a crucial concern that the NCG needs to be attentive of. Amid renewed North Korean ICBM launch concerns, the USS Missouri (SSN-780), a Virginia-class nuclear-powered US

attack submarine, entered a key naval base in Busan, 320 km southeast of Seoul, earlier on Sunday, according to the South Korean Navy. The deployment of the submarine comes just three weeks after the USS Santa Fe (SSN-763), a Los Angeles-class submarine, entered the Jeju Naval Base on the southern resort island.

Floods displace over 6,500 people in Malaysia

Kuala Lumpur, Dec 20 (IANS) : Floods displaced more than 6,500 people in four states in Malaysia following heavy rains on Wednesday. The east coast states of Kelantan and Terengganu are the worst hit, with more than 6,370 people being held in 39 flood relief centres, according to the Social Welfare Department. Meanwhile, the west

coast states of Perak and Selangor recorded 85 and 50 flood victims, respectively, Xinhua news agency reported. The Meteorological Department has issued warnings of heavy rains due to the northeast monsoon, which typically lasts from October to March, with strong winds and rough seas expected in northern states and the country's east coast.



Emergency flood alerts issued for parts of Australia's Queensland

Sydney, Dec 20 (IANS) : Emergency flood alerts were issued for parts of Australia's northeastern state of Queensland on Wednesday as a result of torrential rainfall in the wake of Tropical Cyclone Jasper. Major flood warnings were issued for the Barron river, the Daintree river, the Herbert river. the Johnstone river catchment, the Mulgrave river, and the Tully and Murray rivers, according to the Bureau of Meteorology. The Barron river at Lake Placid was currently sitting at 13.34 metre, which was 1.34 metre above the major flood height, the local Courier Mail newspaper reported. More water was pouring down towards the coast from the Atherton Tablelands, and the river was expected to rise further, the report said. Queensland Fire and Emergency Services urged residents to move to higher ground if it was safe to do so, or to the upper floors of their buildings, Xinhua news agency reported.





Trump tells rally immigrants are 'poisoning the blood of our country': Report

Washington, Dec 20 (IANS) : Former US President Donald Trump, just weeks after using the fascist terminology "vermin" to describe sections of American society he dislikes, again declared at a New Hampshire rally that immigrants are "poisoning the blood of our country," the media reported. Condemned for his previous remarks at the last rally he held in New Hampshire -- where he threatened to "root out the communists, Marxists, fascists and the radical left thugs that live like vermin within the confines of our country that lie and steal and cheat on elections" -- Trump appeared to double down in Durham, The Guardian re- in Nazi Germany.

ported. "They're poisoning the blood of our country. That's what they've done," Trump told the crowd. "They poison mental institutions and prisons all over the world, not just in South America ... but all over the world." "They're coming into our country, from Africa, from Asia, all over the world," The Guardian reported.

It is the second time Trump has used the "poisoned blood" phrase, which has been widely condemned for echoing white supremacist rhetoric.

The first time he did so, in October, US President Joe Biden said the former President, who faces 91 criminal charges, was starting to use language heard



Bangladesh to deploy army ahead of general elections

Dhaka, Dec 20 (IANS) : Amid continued tensions, army personnel will be deployed across Bangladesh to assist the civil administration in ensuring security ahead of the country's general elections slated for January 7, 2024, according to a poll body official. Bangladeshi Election Commission Secretary Md Jahangir Alam told journalists that President Mohammed Shahabuddin on Wednesday approved in principle the deployment of the army during the upcoming general elections, reports Xinhua news agency.

Army personnel would be deployed as a striking force, Jahangir Alam said, adding that the decision came from a meeting between the president and the chief election commissioner Kazi Habibul Awal on Wednesday.

Migration threatens to 'overwhelm' Europe nations: Rishi Sunak

Prime Minister Rishi Sunak has said "enemies" want to use migration as a "weapon" to deliberately drive people to their shores to 'destabilise the society'. In one of his strongest attacks on illegal immigration, Sunak warned that the growing number of migrants could "overwhelm" European countries if swift action is not taken to address the issue, The Evening Standard reported.
