



Suvendu Adhikari claims irregularities in voters' list preparation, complains to ECI

Kolkata, Feb 5 (IANS): The leader of opposition in West Bengal Assembly, Suvendu Adhikari, on Monday complained to the Election Commission of India (ECI) claiming massive irregularities in the preparation of voters' list in the state, especially in the Diamond Harbour Lok Sabha Sabha constituency in South 24 Parganas district represented by Trinamool Congress' national General Secretary Abhishek Banerjee. On Monday, Adhikari reached the office of the Chief Electoral Officer (CEO), West Bengal, along with 25 voters from the Diamond Harbour constituency whose names have been deleted from the new voters' list despite they being voters there for many years.



Goa Speaker exposes own party minister, Oppn seeks resignation of Gaude

Panaji, Feb 5 (IANS): The opposition parties in Goa have sought the resignation of Art and Culture Minister Govind Gaude after Goa Legislative Assembly Speaker Ramesh Tawadkar levelled allegations against him over alleged misappropriation of 'special grants'

Tawadkar, a senior BJP leader from the ST community, said that he would not

tolerate the indiscipline of the minister "who was behaving without any protocol". "I am witnessing such an incident for the first time that a Minister from my government is behaving in an irresponsible manner... is being indisciplined and the one who is not following protocol. I feel sad

about this. It should not happen. I will not tolerate it," Tawadkar said, According to him, the Art and Culture Department has released funds to families who have formed multiple organisations, and have failed to organise programmes for which the grants were released.

Reacting to the allegations by Tawadkar against his own party minister, opposition has demanded resignation from Gaude and face inquiry.

"Speaker Ramesh Tawadkar's accusation is severe, action is inevitable. His allegation of a scam in the Art and Culture Ministry, and his accusation of misappropriation of funds by the minister has to be viewed with the utmost seriousness and attention it deserves," Goa Forward MLA Vijai Sardesai said. WORKFORCE, WOMEN, AND YOUTH MET A RAW DEAL IN THE INTERIM UNION BUDGET

ur Prime Minister firmly believes, we need to focus on four major castes, said Union Finance Minister Nirmala Sitharaman in her Interim Union Budget 2024-25 speech – Garib (poor), Mahilayen (women), Yuva (youth), and Annadata (Farmer). Their needs, their aspirations, and their welfare are our highest priority, she claimed. However, in reality, as the budget papers reveal, it was an utter lie, advocacy of the just opposite of what the government did, a mere reverse psychology. The reality is, they suffered the worst in the last 10 years of Modi rule, but on the eve of Lok Sabha General Election 2024, Government just needed to pacify them for their votes.

What does it mean by the 'highest priority'? For unsuspecting electorate, it would mean the welfare of poor, women, youth, and farmer was accorded the most important priority by the Modi government. If it would have been true, how come it did not figure in the "Core of the Core Schemes"? If we go by the budget, not the hypocritical speeches of political leaders of the ruling establishment, the "highest priority" core of the core central sector schemes are: 1. Mahatma Gandhi National Rural Employment Guarantee Programme, 2. National Social Assistance Programme, 3. Umbrella Programme for Development of Minorities, 4. Umbrella Programme for Development of Other Vulnerable Groups, 5. Umbrella Programme for Development of Scheduled Tribes, and 6. Umbrella Scheme for Development of Schedule Castes. There are 31 Core Schemes and 133 Major Central Sector Schemes. Nirmala Sitharaman, as being the Finance Minister of the Country, is supposed to know the fact of the "highest priority" and whoever tells otherwise than one knows is a lie.

Modi government can say only for the sake of logic that the "Core of the Core Schemes" also intended to help the poor, women, youth and farmer, but they would have to accept that there are other welfare programmes that specifically target these four groups, irrespective of their caste, creed, or religion, which are certainly accorded the "highest priority".

The top Core of the Core Schemes of India is the MGNREGA scheme, but it should be noted that it was not brought by the Modi government. Rather the Modi government is obliged to implement it under the Mahatma Gandhi National Rural Employment Guarantee Act, 2005. It gave legal guarantee of a hundred days of wage employment in a year to adult members of a rural household on demand. How the Modi government tried to sabotage the scheme is now well known, which included non-payment for months which the Supreme Court of India said amounted to slavery, since there were no jobs in the market and rural people had no option but to accept the injustice and work. Non-payment on one or the other pretext, such as implementing online attendance when connectivity itself was unreliable, not providing work if not registered online, low payment, sometimes even below the minimum wages, or at the minimum wage that breeds "working poverty" were intended to suppress the demand for work, which helped the government to reduce allocation for MGNREGA scheme. Another strategy of the Union Government was not to disburse money due to states for wages of MGNREGA workers, who had to go without wages for months. It is worth recalling that NREGA Sangharsh Morcha had demanded a budget allocation of Rs2.72 lack crore to enable all card holders willing to work to get employment of 100 days, for the current year 2023-24.

And with general elections round the corner, time is a problem for INDI-Alliance leaders in ED's crosshairs.

Also, with INDI-Alliance running short of leaders, one after another, the burden of carrying the hopes and aspirations of the Opposition is falling on the much-tested shoulders of Congress leader Rahul Gandhi. RJD leaders Lalu Prasad Yadav and Tejashvi Yadav also have the ED after them. The INDI-Alliance is facing a leadership crunch and by the time elections are overhead, only Rahul Gandhi and Mallikarjun Kharge might be there to represent the "28-party" INDIA Block.

So, he planned to use a nuclear device to irradiate it to make the gold useless, which would make his own gold more valuable.

Today, if someone wanted to attack places as important as Fort Knox, they would look at the giant data centers of big companies, such as Amazon, Google, Meta and Microsoft. Taking down these centers would require a very extreme plan, similar to what Goldfinger had thought of. "She was still in shock, learning to live with a disability in the context where rehabilitation services were not available." Due to a lack of food, water and shelter, extended families are unable to take care of extra children, he said. The mental health of Palestinian children is severely impacted, he said. "UNICEF now estimates that almost all children of Gaza, more than one million, need mental health and psychosocial support," the UN official noted. "The only way to have this mental health and psychosocial support delivered at scale is with a ceasefire."



Destroyed Hamas' rocket-making unit in Gaza: IDF

Tel Aviv, Feb 5 (IANS): The Israel Defense Forces (IDF) has said that its troops have destroyed a rocket-making unit of Hamas in central Gaza.

The IDF in a statement on Monday night said that its 646th Brigade destroyed a complex used by Hamas to produce rockets in Nuseirat in central Gaza.

The IDF said that the complex contained civilian and dual-use machines which were converted by Hamas for the production of

weapons. The Israeli military said that the 99th division of the IDF eliminated several terror infrastructures in central Gaza and many terror operatives were also neutralised. Soldiers from the Yiftah Brigade raided safes belonging to Hamas and seized several documents showing how Hamas was transferring funds.

The IDF statement also said that soldiers from the 179th Brigade discovered a significant tunnel route and destroyed it.

Houthis say they strike Israel with ballistic missiles

Sanaa, Feb 5 (IANS): Yemen's armed Houthi group has said that they have struck the Israeli city of Eilat with several ballistic missiles.

EU countries unanimously endorse 'landmark' AI legislation

Brussels, Feb 5 (IANS): The 27 member states of the European Union (EU) have unanimously endorsed the bloc's "landmark legislation" governing the utilization of artificial intelligence (AI), also known as the EU AI Act, according to European Commissioner for the Internal Market Thierry Breton.

Breton described the move as "historic, world first, pioneering" on the social media platform X, emphasizing that negotiators have found the "perfect balance between innovation and safety."

In December, EU lawmakers and

member states reached a political agreement on the key provisions of the AI Act, hailed by the European Commission as the "first-ever comprehensive legal framework on AI worldwide". However, the complexity of the legislation prompted monthslong technical refinement, during which countries like France and Germany expressed concerns particularly regarding the stringent regulatory rules for powerful AI models, prompting a new round of discussions on its contents, Xinhua news agency reported.



Govt rakes in Rs 600 crore as penalties from taxpayers' delay in PAN-Aadhar link

New Delhi, Feb 5 (IANS): The government has collected over Rs 600 crore as penalties from persons who failed to meet the deadline for linking their PAN with their Aadhaar card, the Parliament was told on Monday. Minister of State for Finance Pankaj Chaudhary told the Lok Sabha, in a written reply, that the number of PANs not linked with Aadhaar, excluding exempted categories, is 11.48 crore as of January 29, 2024. The deadline for linking PAN and Aadhaar was June 30, 2023.

The Income Tax Department had stated in its order that PAN cards will become inoperative if taxpayers fail to link their documents with Aadhaar within the deadline. Moreover, no refunds would be made against such PANs. Failure to link PAN with the biometric document would also attract a higher TDS and TCS.

India well positioned to use AI to make software development more productive: Google



"We completely abide by the direction of the regulator, and the team's effort is to ensure a smooth customer experience with the products offered by the Paytm Payments Bank Ltd (PPBL)," the spokesperson added.

Earlier, Paytm Founder and CEO Vijay Shekhar Sharma assured the staff that there would be no layoffs and the company has been in talks with the RBI, besides, weighing partnership options with other banks. "We will figure out everything soon. We will reach out to the RBI to see what can be done," Sharma said while addressing employees during a virtual town hall. On Monday, Paytm shares were locked in lower circuit of 10 per cent on the BSE, trading at Rs 438.35.

After the RBI's directive to Paytm's associate bank, there has been an impression that the company and its associates are one. However, giving clarity on the same, Madhur Deora, President and Group CFO at Paytm, has said that both by design and structure, the fintech company and its associate is not and cannot be one. "There may be this impression that Paytm and Paytm Payment Bank is one, but by design and by structure, it is not and it cannot be.

Govt moving to one regulator system for food safety certification

Justice Vaidyanathan was appointed as a judge of the Madras High Court in October 2013. He is the senior most puisne Judge in his parent high court. Before his elevation as a judge, he got enrolled at the bar in 1986 and practised at the Madras High Court and various Tribunals. His area of practice was labour, service, criminal and company matters. In a statement released on the website of the apex court, the SC Collegium had noted that during his tenure of 10 years as a judge of the high court, he authored 1,219 reported judgments, of which 692 were delivered during the last 5 years. "He has acquired considerable experience in dispensing justice in one of the largest high courts in the country...He is a competent judge with humility, judicial temperament and unimpeachable integrity," it had said.

Govt makes stock disclosure mandatory for rice traders, millers

New Delhi, Feb 5 (IANS): The Government of India has made declaration of stock position of rice/paddy mandatory for traders/wholesalers, retailers, big chain retailers and processors/ millers. The initiative has been taken to manage the overall food inflation and to prevent unscrupulous speculation. The Ministry of Consumer Affairs, Food & Distribution said that this order will be implemented in all the states and Union Territories until further orders. The respective legal entities -- traders, wholesalers, retailers, big chain retailers, processors and millers -- have to declare stock position of paddy and rice in categories such as (i) Broken Rice, (ii) Non-Basmati White Rice (iii) Parboiled Rice (iv) Basmati Rice (v) Paddy.

The entities are expected to update it every Friday on the portal (https://evegoils.nic.in/rice/ login.html) of the Department of Food and Public Distribution. The stock position of rice shall be declared by these entities within seven days of issuance of the order, an official said.



Further, to check inflationary trends in food economy, it has been decided to start retail sale of 'Bharat Rice' to general consumers.

In the first phase, 5 LMT of rice has been allocated for retail sale under 'Bharat Rice' brand through three agencies -- NAFED, NCCF and Kendriya Bhandar. Retail price for the sale of Bharat Rice to general consumers will be Rs 29/kg. Rice will be sold in 5 kg and 10 kg bags. Bharat Rice will be available for purchase from mobile vans and physical outlets of the three central co-operative agencies to begin with, and it will also be available through other retail chains including e-commerce platforms very soon, the ministry added.




Four of family badly burnt in attack in Bihar's Bhagalpur

Monkey fever spreads in K'taka, 21 cases reported

They said that among the 21 persons affected with monkey fever, eight have been admitted to the hospitals while 13 are being treated at home. They said that the authorities are carrying out awareness among people about the precautions to prevent the disease from spreading.

Kyasanur Forest Disease (KFD) is commonly known as monkey fever. It is a seasonal tick- Dr. Niraj, the District Health borne viral haemorrhagic fever endemic to Southern India and may prove to be fatal to

People living in and around the forests are at high risk of catching the viral infection as the virus is mostly found in forest areas. Monkey fever is caused by a virus belonging to the family Flaviviridae, the same family of viruses that

causes yellow fever and dengue, which is transmitted by monkeys.

Humans contract the disease either by coming in contact with the infected animal. Since infected individuals are dead-end hosts, they do not play any role in the further transmission of Kyasanur Forest Disease.

Officer (DHO) said that the people are warned not to venture into the forest area.

"Those who will have to go into the forests are provided with repellent oil to be applied to exposed areas of the body like legs and hands.

"Their signatures are taken for 30 working days, but are paid only for 26 days. Where does the payment of rest four days goes and in whose pockets? This amount comes to around Rs 1.22 crore annually. We want to know in whose pockets this loot goes," he said. Bhike alleged that even their uniform allowance is not spared, and Home Guards are yet to receive this amount.

"This amount is around Rs 4.80 crore. We want to know in whose pockets this money goes."

"The insensitive BJP government


has failed to release arrears of Home Guards since 2017, which comes to around Rs 8.64 crore," he said. He said that Home Guards are suffering due to not getting salaries on time.

"They are from poor families and

Assam: Youth killed while trying to chase away herd of elephants

Pavitra Phukan tried to drive the elephants away after they created "chaos" in a Digboi neighbour hood, causing panic among the people. The people later contacted the police and forest officials. When Phukan was taken to a government hospital by forest officials, the medical staff pronounced him dead. According to forest officials, elephants frequently come out from the forest in search of food as the location is close to the Dehing Patkai Wildlife Sanctuary.



Water tanker meant for Manipur police hijacked in Moreh

Imphal, Feb 5 (IANS): Suspected armed attackers hijacked a private tanker meant for supplying potable water to the state police commandos deployed in conflict-torn Moreh, sending a threat to the presence of the force at the border town along Myanmar, the police said on Monday. The development came a day after radical village volunteers in Tengnoupal district asked the traders not to sell essential items, even water, to state police commandos, who mostly belong to the Meitei community. A police officer in Imphal said that the armed attackers hijacked the water tanker on Thursday and freed the driver in the night, while the ill-fated vehicle remained traceless till late on Monday night.

On the other hand, the government has made all arrangements to airlift essential commodities for the police commandos in the wake of the Kuki volunteers' threat, the police said.

The Centre on Monday issued a notification appointing Justice Chakradhari Sharan Singh as the Chief Justice of the Orissa High Court.

"In exercise of the power conferred by clause (1) of Article

New Delhi, Feb 5 (IANS): 217 of the Constitution of India, the President is pleased to appoint Shri Justice Chakradhari Sharan Singh, Judge of the Patna High Court, to be Chief Justice of the Orissa High Court, with effect from the date he assumes charge of his office," said the notification issued by the Union Ministry of Law and Justice.

The Chief Justice of India (CJI) D.Y. Chandrachud-led Supreme Court Collegium in November 2023 forwarded its recommendation to the Centre to fill in the vacancy in the office of the Chief Justice of the Orissa High Court which had arisen consequent upon the retirement of Justice Subhasis Talapatra.

Justice Singh was appointed as a judge of the Patna High Court in April 2012 and has been functioning there as the senior most puisne judge. Before his elevation as the judge, he was enrolled at the Bar in 1990 and practised at the Patna High Court. His area of practice was constitutional, service, criminal and arbitration matters.

During his practice of 22 years, he had also served as Additional Advocate General for Bihar since December 2010 till his elevation as a judge of the high

In a statement released on the website of the apex court, the SC Collegium had noted that "during his tenure of more than 11 years as a judge of high court, he authored 1,246 reported judgments, of which 562 were delivered during the last five years".

"He has maintained a high standard of professional ethics at the Bar and Bench and enjoys good reputation for conduct and integrity," it had

It added that the SC Collegium has also taken into consideration the fact that at present the Patna High Court has no representation among the Chief Justices of High Courts.

"I won't be ready for the Olympics, but I'll improve," Austin was quoted by the US News and World report as saying. Austin's reassurances come as developments this week hinted that a US response to the drone attack in Jordan is imminent.

CBS News reported on Thursday that US officials have approved plans "for a series of strikes over a number of days against targets including Iranian personnel and facilities - inside Iraq and Syria." Weather will be a big factor in determining when the strikes will take place, CBS News reported.



Iraq, Saudi Arabia discuss repercussions of drone attack on US base in Jordan

Foreign Minister Fuad Hussein held a phone talk with his Saudi counterpart Faisal bin Farhan Al Saud to follow up on regional repercussions of a deadly drone attack on a US military base in Jordan. The two Ministers discussed possible post-attack scenarios regarding the regional security situation, according to a statement issued by the Iraqi Foreign Ministry on Monday. Hussein stressed the need to "continue communication and coordination between Baghdad and Riyadh to remove the threat of an all-out war in the region

Baghdad, Feb 5 (IANS): Iraqi and protect the security of the two countries". The White House said on Wednesday that an umbrella group known as the "Islamic Resistance in Iraq" was responsible for the recent drone attack that killed three US soldiers in Jordan, Xinhua news agency reported. US President Joe Biden said on Monday that he had already made a decision on how to respond to the attack that caused the first US fatalities since the Israeli-Hamas conflict broke out on October 7, 2023. He didn't elaborate, but reiterated that his administration is not looking for a "wider war in the Middle East".

Trump's federal trial on election interference postponed from March 4

Washington, Feb 5 (IANS) : Former US President Donald Trump's federal trial set for March 4 on charges of election interference has been postponed -- confirmed after it was dropped from the Washinton DC District Court's calendar -- as an appeals court has to dispose of his claim of immunity from the charges. Trump's March 4 trial date on federal charges that he conspired to overturn the 2020 election has disappeared from the district court's calendar, confirming that his fight over whether he is immune to the charges will delay the case, media reports said. The delay could have a domino effect on other cases pending against the former President.

Trump, as it stands today, will first face criminal trial in New York, where he is charged with falsifying business records on a scheme to pay hush money to an adult film star and a former Playboy model. That trial's tentatively set for March 25. Manhattan District Attorney Alvin Bragg has said that the judge was waiting to see what was happening in other jurisdictions. He said he would have a better idea of the schedule after the next hearing in the case on February 15. In the federal case

in Washington, US District Judge Tanya Chutkan set the tentative trial date in August, weeks after the former President was indicted on three conspiracy charges and one obstruction charge. But the case has dropped off the court's calendar and hasn't been rescheduled before the November election. Chutkan hasn't explained the change in the court docket, USA TODAY reported. The trial dropping off the schedule appears to result from the legal wrangle over whether Trump is immune to charges as he has invoked executive privilege not to testify in a court on grounds of having been the President of the US.





Four Indian students dead in US: Angry netizens call for travel advisory

New Delhi, Feb 5 (IANS): Four Indian students have died in quick succession in the US, sparking fears regarding the safety and security of those studying abroad, and angry netizens calling for a travel advisory.

The most recent reported case was of Shreyas Reddy Benigeri, a student of Lindner School of Business in Cincinnati, on Monday after the deaths of Purdue University's Neel Acharya, MBA student Vivek Saini in Georgia, and University of Illinois' Akul B Dhawan. Announcing Benigeri's death, the Indian Consulate in New York said that a police investigation is underway even as calls for an advisory for Indian students grew louder among netizens.

"Deeply saddened by the unfortunate demise of Shreyas Reddy Benigeri, a student of Indian origin in Ohio. Police investigation is underway. At this stage, foul play is not suspected," the Consulate said in a post on X.

The Consulate further said it is in touch with the Benigeri family and is extending all possible assistance to them. "MEA (Ministry of External Affairs) needs to issue an advisory for Indian students on keeping them safe in the US. Just shipping their remains to India is not their sole job," Debashish Sarkar, a user on X, wrote in response to the Consulate's post. Calling the US an "increasingly becoming an unsafe place for Indians", X user Sonam Mahajan wrote: "It's high time India issued a travel advisory against the US for Indians looking to move to the country for both higher education and work opportuni-

"India should perhaps issue travel advisory for Indian students wanting to study in US," another user Rakesh Bakshi wrote, while many others urged External Affairs Minister S Jaishankar to take swift action. India last issued a travel advisory for its students and nationals in Canada in September 2023, given growing anti-India activities and politically condoned hate crimes and criminal violence in the country.

Israel's army to reach Rafah to dismantle Hamas brigades: **Defence Minister Yoav Gallant**

Tel Aviv, Feb 5 (IANS): Israel Defense Minister Yoav Gallant has said that the Israel forces would soon reach Rafah border and eliminate Hamas units in the border areas. In a statement late Monday night, Gallant said that the ongoing operations have severely weakened the terror group's ability to wage war. He said that the fire power and force displayed by the Israel army so far during the war has put huge pressure on Hamas, forcing it to agree to release hostages it held during October 7 attack. The Israel Defense Minister, considered a hawk in Israel cabinet, said that Hamas' Khan Younis Brigade had boasted that it would stand against the IDF, but it is falling apart.

After completing the mission in Khan Younis, the IDF would reach Rafah and eliminate everyone there who is a terrorist and attacking Israel.

Gallant had visited the IDF's 98th division command in Khan Younis on Monday and had addressed troops.

We wish him well in his future endeavors and look forward to welcoming his replacement."
