

Telangana Assembly session to begin today, likely to witness stormy scenes

Hyderabad, Feb 7 (IANS): The Telangana Assembly session will begin on Thursday with Governor Tamilisai Soundararajan addressing both the Houses on the first day. This is the second consecutive session of the Assembly after the Congress government took over the reins of power in the Telangana State. The session is anticipated to resonate with vigorous exchanges between legislators of the ruling Congress and the opposition BRS over the issue of Krishna river waters, particularly related to handing over the outlets of Srisailam and Nagarjuna Sagar projects.

To this extent, the State Cabinet has already approved the Governor's speech. After the Governor's speech, Finance Minister Bhatti Vikramarka will introduce the budget in the House.

The State government is also planning to release a white paper related to the irrigation department in the Assembly and to expose the failure of the previous BRS government which has allegedly handed over the management of irrigation projects to the Centre. Meanwhile, Irrigation Minister Uttam Kumar Reddy has announced that the State government will introduce a vigilance inquiry report on the Kaleswaram project, which is said to be the brainchild of former chief minister K Chandrashekar Rao.

He revealed that he wants to contest for Lok Sabha from Warangal constituency but did not disclose which party he would be joining.




Andhra Pradesh presents Rs 2.86 lakh crore Interim Budget

Amaravati, Feb 7 (IANS): Andhra Pradesh Finance Buggana Rajendranath on Wednesday

presented an interim Budget of Rs 2,86,389.27 crore. The outlay is about 2.5 per cent higher than the previous year. The budget size for

2023-24 was Rs 2,79,279 crore. The revenue expenditure is estimated at Rs 2,30,110.41 crore, and capital expenditure Rs 30,530 crore. The estimated revenue deficit is around Rs 24,758.18 crore and the fiscal deficit is estimated at around Rs 55,817 crore. Presenting the last Budget of the YSRCP government before the election, Rajendranath said the fiscal deficit will be around 3.51 per cent of the GSDP, whereas the revenue deficit will be around 1.56 per cent of the GSDP. In his Budget speech in the Assembly, he said the revenue deficit was Rs 44,487.49 crore and fiscal deficit Rs 52,508.34 crore during FY 2022-23.

Check Malnutrition with Siri Nutrition Program

At the launch of the Siri Nutrition Pilot Project: **State Women and Child Welfare Department** Secretary Vakati Karuna

Rajannasirisilla, Feb 7 (TIM Bureau): Mrs. Vakati Karuna, Secretary of the State Women and Child Welfare Department, said that the experimental Siri nutrition program in the district is very helpful to overcome malnutrition. Secretary of Women and Child Welfare Department Mrs. Vakati Karuna along with Collector Anurag Jayanthi launched the Siri Nutrition Pilot Project program

aimed at distribution of sprouted seeds and multi millet laddu. On this occasion she said that although Telangana ranks first in the country in the field of health, women and children are suffering from malnutrition. It is said that 40 percent of women in the state are suffering from anemia. 30 percent of children are underweight and height for their age. It is said that women think more about their family members than about themselves and their health. Through multi millet laddus to pregnant women, infants and children under six years of age once a week, the negative factor of malnutrition can be changed into a positive one and diseases caused by malnutrition can be kept away from them. He said that through this program the importance of millets will increase in the awareness of the people. District Praja Parishad Chairperson Nyalakonda Aruna Raghava Reddy said that if the unborn children are to be healthy, pregnant women must go to the Angadi Anganwadi centers near them and take the balanced food offered there. Not as expected. He said that although the government is providing nutrition, there are still women suffering from anemia problems and children suffering from stunted growth in the district. To overcome this, a program called Siriposhan is being conducted by 41,000 people in 587 Anganwadi centers in the district in the month of February." Copper brownies will be given to pregnant women, infants and children under six years of age once a week. With everyone's participation, this program will be successful and the district will be made a malnutrition-free district.

Delhi govt announces free bus travel for transgender community

New Delhi, Feb 7 (IANS): The Chief Minister also ex-Delhi government on Wednesday announced free bus travel for the transgender community in the national capital.

Chief Minister Arvind Kejriwal said that a proposal will soon be passed in the Cabinet to implement the new scheme.

Just as women can travel free in buses in the national capital, the transgender community will also be granted free tickets from now onwards.

The Delhi government had announced free bus travel for women in October 2019, and since then, approximately 147 crore free tickets have been issued to women, Kejriwal said.

He hoped that this decision by the government will greatly benefit the transgender community.

Transgender individuals will receive the benefit of free bus service based on government certificate.

Currently, certificates for transgender individuals are issued by the district magistrate's office in all districts.





Manipur education officials tender apology over CBSE affiliation row

Three senior officers from Manipur Education Department, who were suspended on January 12, have reportedly furnished written apologies for "irregularity in issuing noobjection certificates (NOCs)" to schools in Churachandpur Kangpokpi districts seeking CBSE affiliation, officials said on Wednesday.

An Education Department official said that the officers cited "pressure" from elected representatives, civil society organisations and student bodies as the reason behind

Imphal, Feb 7 (IANS): their unilateral actions without permission of the state government. Sources said four MLAs from Churachandpur and two from Kangpokpi districts told these officers - two zonal education officers and a deputy inspector of schools, to issue the NOCs. These MLAs are part of the 10 Kuki-Zo legislators demanding for a separate administration (equivalent to separate state) for the tribals since Manipur faced ethnic riots on May 3 last year. The Central Board of Secondary

Education (CBSE) canceled the affiliation of 25 schools in these districts on December 20 last year as the state government had not

provided the necessary NOCs. The CBSE mandates that state board schools obtain NOCs from the state government before applying for central board affiliation.

The change in the education

board from state to central in the two districts was perceived as an attempt to formalise a new arrangement amid ethnic strife. The apology letters reveal that the officers were aware of the procedural violations but "felt compelled to succumb to external pressures due to the ongoing ethnic conflict", disrupting government services and communication protocols, the sources added. In one letter, Churachandpur ZEO Jangkhohao Haokip explained his predicament, stating that he initially resisted but eventually yielded under duress from various stakeholders. Water quality monitoring

overnment of India, in partnership with States, is implementing Jal Jeevan Mission (JJM) since August, 2019 to provide potable tap water supply in adequate quantity, of prescribed quality and on regular & long-term basis to every rural household in the country. Drinking Water being a state subject, the responsibility of planning, approval, implementation, operation, and maintenance of drinking water supply schemes, including those under the Jal Jeevan Mission, lies with State/UT Governments. The Government of India supports the States including Assam by providing technical and financial assistance. As per operational guidelines for the implementation of the Jal Jeevan Mission up to 2% of the allocation to States/ UTs under JJM can be utilized for carrying out water quality monitoring and surveillance activities. The water quality monitoring and surveillance is done through testing of water samples in Labs as well as testing through field testing Kits (FTKs) by community.

As reported by States/UTs, so far 2,118 drinking water quality testing laboratories (including 83 laboratories in Assam) at different levels viz. State, regional, district, sub-division and/or block level, have been set up in the country. To encourage water quality testing to ensure potable drinking water supply, these laboratories have also opened for general public for testing of their water samples at a nominal rate.

In order to empower the communities to monitor the water quality, States/ UTs have also been advised to identify and train 5 persons, preferably women, in every village to conduct water quality testing using Field Testing Kits (FTKs)/ bacteriological vials at village level and report the same on the WQMIS portal. So far, as reported by States/UTs, more than 22.98 lakh women (including 1.08 lakh in Assam) have been trained for testing water using FTKs.

To enable States/ UTs to test water samples for water quality, and for sample collection, reporting, monitoring and surveillance of drinking water sources, an online JJM - Water Quality Management Information System (WQMIS) portal has been developed. As reported by States/UTs on WQMIS portal, as on 30/ 01/2024, more than 60.93 lakh water samples have been tested in the water testing laboratories and more than 99.99 lakh water samples using Field Testing Kits, during 2023-24. As reported by Assam, as on 30/01/2024, more than 2.23 lakhs water samples have been tested in water testing laboratories and more than 10.04 lakh water samples using Field Testing Kits, during 2023-24.

Under the Jal Jeevan Mission, priority is accorded to make provision of tap water supply in drought-prone & desert areas, water quality-affected habitations, villages in Aspirational & JE–AES affected districts, Saansad Adarsh Gram Yojana (SAGY) and SC/ST majority villages. Under JJM, 0.5% of annual allocation is earmarked to States having Japanese Encephalitis-Acute Encephalitis Syndrome affected districts. Due to priority given to JE-AES affected districts (61), the tap water supply to households has increased from 8.01 lakh (2.71%) HHs in August 2019 to 216.04 lakh (72.99%) as on 30.01.2024.

Washington, Feb 7 (IANS): US President Joe Biden's team fears that the results of a classified documents investigation could lead to embarrassing information, and possibly photos, that could hurt his re-election campaign, media reports said. Biden's aides believe that though special counsel Robert Hur's investigation won't lead to any criminal charges, as per Axios, unflattering details and photos could still lead to political fallout.

Former President Donald Trump is facing felony charges related to his handling of classified documents that he took to his Florida home on the last day of his office in the White House. Soon after Trump's Mar-a-Lago

August 2022, Biden weighed in by asking aloud how "anyone could be that irresponsible".

But Biden soon found himself at the receiving end of the Department of Justice (DOJ)'s case on the classified documents scandal, when documents from his eightyear term as Vice President were found in his Wilmington home and at the Penn Biden Center think tank in Washington.

Biden's campaign fears Trump could use the report and any accompanying photos to create equivalency with his charges, Axios reported.

British universities to review international student admissions

London, Feb 7 (IANS): The international student admission process in the UK is set to be reviewed after accusations of universities lowering entry standards for foreign applicants who pay far higher tuition fees.

Universities UK, which represents 140 universities, announced a series of measures to review international foundation programmes and the use of recruitment agents employed to attract foreign students, The Guardian reported. In addition to taking a review, the universities will also up-

date their admissions code of practice "to clearly state its applicability to international students". The move comes after Higher Education Minister, Robert Halfon said in the House of Commons that he was "very disturbed" by a Sunday Times report that "clearly showed bad practice in the use of agents and that's not acceptable".

"While I am a strong supporter of international students, I want a level playing field for all domestic students as well," Halfon said while taking up questions from the MPs last week.

After Halfon's remarks, Vice

Chancellors said they would work with the government to review the use of agents and make changes to "improve resilience and identify bad practice". According to the Times report, the University of York has told staff to be "more flexible" in admitting international students with lower-than-expected grades. The Times investigation also recorded agents acting for universities such as Durham and Exeter claiming that international students with poor grades could easily gain entry via international foundation courses.

Singapore Parliament waiting for outcome of Indian-origin minister's court case

Singapore, Feb 7 (IANS): Before deciding upon a Committee of Inquiry (COI) in Indian-origin minister S. Iswaran's case, the Singapore Parliament will wait for the court case against him to conclude, Leader of the House Indranee Rajah said on Wednesday. Iswaran stepped down as Transport Minister last month after facing 27 charges of offences in a corruption probe, which saw him getting arrested in July 2023 and later released on bail.

Responding to an MP's question in the parliament, Rajah said: "The purpose of a COI is to investigate something with a view of finding out how it happened," The Straits Times reported.

"In this case, the CPIB (Corrupt Practices Investigation Bureau)

has investigated the matter. Based on the investigations, the Attorney General's Chambers took the view that there is a basis for criminal charges to be brought against

"Determination of criminal offences is a matter for the court, which is currently dealing with the case. We should wait for the court proceedings to conclude before deciding if anything else needs to be done," Rajah said.

She added that everyone who is alleged to have committed wrongdoing, including MPs, should be given due process.

Arriving at the State Courts on January 18, Iswaran pleaded not guilty to 27 charges -- two counts of corruption, 24 counts of obtaining items from someone he had



business dealings with as a public servant, and one of obstructing the course of justice.

According to court documents, most of the offences Iswaran faces involve billionaire hotelier Ong Beng Seng, who brought Formula One to Singapore in 2008. The chargesheet states that Iswaran

received "valuable things" worth more than S\$384,000 (US\$285,000) from Ong between 2015 and 2022.

These ranged from tickets to shows, private plane rides, hotel stays, football matches, and various editions of the Singapore F1 Grand Prix.

New Zealand ministers to visit Pacific island countries

Wellington, Feb 7 (IANS): New Zealand Foreign Minister Winston Peters, and Health Minister and Minister for Pacific Peoples Shane Reti will visit Tonga, Cook Islands and Samoa this week to reaffirm connections with the region. "New Zealand enjoys strong and long-standing relationships with our Pacific partners -- especially in Polynesia, where we have close political, economic, and people-topeople ties," Foreign Minister Peters said on Wednesday as quoted by Xinhua news agency report. New Zealand



has deep and longstanding cultural links with the Cook Islands, Samoa and Tonga, Reti said, adding that he will discuss the shared issues the communities face in New Zealand and the Pacific, particularly in health.

'10 yrs in jail, Rs 10cr fine for unfair means in exam': Assam govt introduces Bill

Guwahati, Feb 7 (IANS): government the authority to pros-The Assam government introduced a Bill in the state assembly on Wednesday to penalise anyone found to have used unfair methods in recruitment examinations with a maximum sentence of 10 years in prison and a maximum fine of Rs 10 crore.

Chief Minister Himanta Biswa Sarma introduced the Assam Public Examination (Measures for Prevention of Unfair Means in Recruitment) Bill, 2024, stating that any government servant enforcing the provisions in "good faith" will receive complete immunity under the proposed law.

In the Bill's Memorandum, Sarma stated that it gives the ecute anyone, including test takers, who engages in any endeavour to leak, create, sell, publish, or solve exam questions in order to help a candidate or administer exams at undesignated locations. According to the Bill, such an individual would face a minimum five-year prison sentence, which could be extended to ten years, as well as a minimum fine of Rs 10 lakh, and a maximum fine of Rs 10 crore.

Furthermore, the introduced legislation stated that an examinee who merely engages in unfair means faces a maximum sentence of three years in prison, a fine of at least Rs 1 lakh, and a further nine months in jail should they fail to make payment.

The Bill also gives the govern-



ment the authority to prevent any examinee who has been found guilty under the terms of this law from appearing in any public examination for two years.

The Bill said "the court shall make an order of recovery of any wrongful gains made by such person, by way of attachment and sale any of the assets/property movable or immovable, or both, of such person".

According to the Bill, such an individual would face a minimum five-year prison sentence, which could be extended to ten years, as well as a minimum fine of Rs 10 lakh, and a maximum fine of Rs 10 crore.





India's smartwatch shipments grow 50% in 2023, Fire-Boltt leads: Report

India's smartwatch shipments have witnessed 50 per cent (year-on-year) growth in 2023, with Fire-Boltt leading the market, a new report said on

New Delhi, Feb 7 (IANS): Wednesday. According to Counterpoint Research, this growth was fueled by the rising penetration of smartwatches, proliferation of low-cost devices to target firsttime users, and enhanced efforts by Indian brands through extensive marketing and distribution, promotions and local manufacturing. "The market saw over 125 active smartwatch brands in 2023 even as it started moving towards consolidation. The combined share of the top five brands reached the highest ever at 81 per cent," said Research Analyst Harshit Rastogi.

Fire-Boltt led the market with a 30 per cent share. According to the report, the brand maintained its focus on offering a wide SKU portfolio and a strong offline presence. Noise (along with sub-brand Alt) secured the second spot with a 26 per cent market share, while boAt (with sub-brands TAGG and Defy) maintained its third spot with a 17 per cent share and 40 per cent (year-on-year) growth. Samsung declined by 3 per cent (year-on-year) last year but regis-

tered 17 per cent (year-on-year)

growth in the fourth quarter (Q4) of 2023, whereas Apple's shipments declined by 57 per cent (year-on-year) in 2023 owing to longer replacement cycles and higher ASP coupled with iPhoneonly compatibility, the report

While the market continues to register high growth rates, the analysts said they are seeing some stabilization, signaling wider adoption. "The quarterly growth rates have come down from triple to double digits. We expect the market to grow 23 per cent (year-onyear) in 2024. DBS slashes CEO's bonus by 30% after disruptions to its digital services

Singapore, Feb 7 (IANS): Singapore's biggest bank DBS has slashed its CEO's bonus by 30 per cent after disruptions to its digital services, despite it posting a record profit, a media report said. The company said the cut to CEO Piyush Gupta's variable pay amounts to \$\\$4.14 million (\$3.1 million), and that his full salary for 2023 will be disclosed in March, BBC reported. In 2022, Gupta was paid S\$15.4 million.

After several glitches last year, the country's central bank banned DBS from buying new businesses or making non-essential IT changes for six months, BBC reported. The outages saw digital payment services and cash machines go offline across the city-state. At the time, DBS apologised and announced plans to improve the resiliency of its systems. In its latest statement, the bank said that other members of its management team will have their variable pay cut by 21 per cent, while more junior employees will get a one-off bonus to help them with higher living costs. DBS' variable pay is made of both

a cash bonus and deferred shares.

It comes on top of base pay and is usually based on an employee's performance. The cuts to the pay of senior DBS executives come despite the bank posting annual record earnings, with its 2023 net profit rising by 26 per cent to S\$10.3 billion, BBC reported.

Like many other banks around the world, DBS has benefited from higher interest rates as central banks have kept the cost of borrowing up as they try to curb rising prices.



Amazon slashes hundreds of jobs in Pharmacy, One Medical units

Amazon has eliminated hundreds of jobs from its healthcare units, including Amazon Pharmacy and One Medical, as part of a broader cost-cutting campaign.

The company confirmed the development to CNBC.

"As we continue to make it easier for people to get and stay healthy, we have identified areas where we can reposition resources so we can invest in invention and experiences that have a direct impact on our customers and members of all ages," Neil Lindsay, who leads

"Unfortunately, these changes will result in the elimination of a few hundred roles across One Medical and Amazon Pharmacy," he added. In the memo, the company also mentioned that it will support those employees who are affected by the latest job cuts with financial support, benefit continuation, and career assistance to aid in their transition, as well as the opportunity to apply for new roles in the organisation.

Last month, Amazon announced

nearly 5 per cent of its workforce at its Buy with Prime unit. In the same month, Amazon-owned audiobook podcast division Audible announced it was laying-off 5 per cent of its staff, which is more than 100 employees, as part of overall job cuts at the e-commerce giant.



iPhone users targeted by govt hackers with o-days vulnerabilities: Google

New Delhi, Feb 7 (IANS): Google has said that government hackers last year used three undiscovered flaws in Apple's iPhone operating system to target users with spyware created by a European startup. Google's Threat Analysis Group (TAG), which investigates nation-backed hacking, published a report on Tuesday analysing several government campaigns using hacking tools developed by several spyware and exploit sellers, including a Spain-based startup called Variston. Google reported that in a particular campaign, hackers working for the government exploited three iPhone vulnerabilities known as "zero-days," which were not previously known to Apple.



Condemning the decision, SAD leader Daljit Singh Cheema said the new policy was against the ad hoc arrangement agreed to by the UT administration at the time of division of the state into Punjab and Haryana.

He said it was then agreed that staff for the UT would be taken from Punjab and Haryana on 60:40 ratio respectively.

Asserting that the deputation of Punjab and Haryana government employees could not be equated with other such deputations in the country, Cheema said, "In the case of Punjab and Haryana employees, they are posted as a right by the two governments."

He said the employees so posted did not draw any deputation allowance like other deputations. "It is clear that the new policy is aimed at discouraging the posting of employees from Punjab and Haryana in the UT. With such uncertain conditions they would not like to shift to Chandigarh permanently."

Cheema said the UT administration should keep in mind that the entity was a temporary arrangement pending transfer to Punjab.

"In such a case the UT administration does not have any right to frame such policies," he said.



US Senate approves \$118 billion package for southern borders control; dead on arrival, says House Speaker

The US Senate on Wednesday approved a \$118 billion funding package which includes a bipartisan deal to redress the migrant crisis at the southern border and fresh aid for Ukraine, Israel, and other US allies. But its fate is uncertain in the House of Representatives as Speaker Mike Johnson, Republican from Louisiana, said the Bill was "dead on arrival."

Democrats have embarked on a challenging path forward in the upper Congressional chamber where they hold the majority at 51 to 49, where the Republican leadership quickly panned it. But in the House of Representatives Republicans hold the majority and it will take a tough call on like-minded liberals and conservatives to come together to approve the package.

Washington, Feb 7 (IANS): Reports about the bipartisan majority of Senators want to get agreement were in the offing as President Biden's aid package for Israel and Ukraine was stuck with Republicans wanting to take the latter out and there was no hope in the lower chamber of the House of Representatives.

10 cops killed in terror attack on Pak police station ahead of polls

Islamabad, Feb 7 (IANS): At least 10 police officials were martyred and six critically injured in yet another targetted terror attacks on a police station in Dera Ismail Khan during the early hours of Wednesday. The attack signifies the tense, sensitive and critical situation in the Khyber Pakhtunkhwa (KP) province with increased terror attacks, only four days before the polling day on February 8.

According to the police, terrorists entered the Chodhwan police station at around 3 a.m. on

Monday morning, sniping out the guards standing around it. "They hurled grenades as well as

shot at police officers they encountered. Four of the martyred belong to the Elite Force," said a police official.

"After entering the building, the terrorists used hand grenades which caused more casualties to the police," said Malik Anees ul Hassan, Deputy Superintendent of Police (DSP) of Draban. Police sources also revealed that the attack was carried out by at least 30 terrorists, who attacked from at least three different directions.

Maldives to attract 2 mn tourists in 2024

Male, Feb 7 (IANS): Maldivian President Mohamed Muizzu on Wednesday forecasted that the country can attract two million tourist arrivals this year, for the first time in the history of the Maldives since the inception of its tourism industry, according to local media. Muizzu made the statement while delivering his first presidential address at the opening sitting of the last session of the ongoing 19th Parliament on Wednesday morning.

The President said the expansion of Velana International Airport (VIA) would increase tourist arrivals by 10.3 per cent on average in the medium term, Xinhua news agency reported.



Indian-American admits to passport and citizenship fraud in US

New York, Feb 7 (IANS): An Indian-American man in Florida has pleaded guilty to procuring citizenship unlawfully, misusing evidence of naturalisation, and making false statements in a passport application. Jaiprakash Gulvady, 51, faces a maximum penalty of 10 years in federal prison, a release by the US Attorney's Office, Middle District of Florida, announced last week. According to court records, Gulvady, an Indian national, came to the US in 2001 on a temporary business visa. In August 2008, less than two weeks after divorcing his wife, a US citizen whom he had married the year before, Gulvady married another US citizen.

Snowfall in eastern Canada causes state of emergency

Ottawa, Feb 7 (IANS): A historic multi-day snowstorm in eastern Canada has caused a local state of emergency, leaving many schools, universities and government offices closed. Cape Breton Regional Municipality of Nova Scotia has declared a local state of emergency with some places in the region receiving up to 80 centimetres of snow, Xinhua news agency reported, citing local media. "Residents are directed to shelter in place and advised to clear snow from their home's entryways, walkways and driveway to facilitate home access," a news release from the municipality read. "Residents should also remove snow from ventilation points at your home." "Do not travel. Roadways are being cleared for emergency response and travel of essential workers. The process is slow and ploughs require several passes to deal with the significant accumulation," the news release said.





Blinken meets Saudi Crown Prince in Riyadh

Riyadh, Feb 7 (IANS): Saudi Arabian Crown Prince Mohammed bin Salman Al Saud and visiting US Secretary of State Antony Blinken met in the Saudi capital of Riyadh on Wednesday.

The two sides reviewed regional developments and bilateral relations on Wednesday, Xinhua news agency reported, citing the Saudi Press Agency. Saudi Arabia is the first stop of Blinken's fifth tour in the region since the onset of the Israel-Hamas conflict on October 7, 2023, which has led to escalating tensions across the region.

Israel resumes attacks in northern Gaza

Jerusalem, Feb 7 (IANS): Israel has resumed battles in the northern Gaza Strip amid growing international calls for a ceasefire.

In its latest operational update on Wednesday, the Israel Defense Forces (IDF) reported that its troops have returned to areas where they previously operated.

Over the past few weeks, attacks in the north of the strip have decreased following Israel's assertion of gaining control over the area, fostering hopes that displaced civilians could return to their homes -- a prospect the Israeli army has indicated that it will not permit at this stage, Xinhua news agency reported.

"The forces operating under the division are preventing Hamas from rebuilding its capabilities," Itzik Cohen, the commander of IDF's 162nd Division, said in the update, stressing the forces were "intensifying operations against and pressure on Hamas remaining in the



Centre failed to double farmers' income, says Harsimrat Kaur in LS

Former union minister and Bathinda MP Harsimrat Kaur Badal on Wednesday said the Central government has failed to double farmers' income, increase employment and control inflation. Speaking after the President's Address in the Lok Sabha, Badal said: "Even though the President had stressed that improving the lot of farmers, poor and youth was the focus of the Union government, the same has not been supported with data." Asserting that the data was to the contrary, the Bathinda MP said even though the Union government had promised to double farmers' income by 2022, this promise remained elusive.

"As per the data of the National Statistical Office (NSO), the

New Delhi, Feb 7 (IANS): average income of agriculture same was not done," the households increased from Rs 8,000 per month in 2015 to only Rs 10,000 per month in 2019."

The Shiromani Akali Dal leader said in stark contrast the NSO data revealed that the average debt of farmers had increased by 58 per cent in the same period.

"As many as 10,880 farmers also committed suicide in 2021 as per the Centre for Science and Environment," she added.

Stating that farmers were most indebted in Punjab with small farmers in the state incurring a debt of Rs 3 lakh per farmer, she said the issues of farmers were also not being addressed.

"Despite a clear cut undertaking by the Central government that a sub-committee would be formed to make minimum support price (MSP) a legal right of farmers, the former Union Minister said. She said even as there was an 80 per cent increase in agriculture inputs, the increase in the MSP was increased by 30 per cent only. She said how there was a 26 per cent decrease in the Kisan Samman Nidhi beneficiaries in Punjab which was contributing the most to the national food kitty.

She said similarly even though crop insurance companies had earned Rs 57,000 crore, farmers in Punjab did not get any compensation for successive crop losses even though its Chief Minister Bhagwant Mann had promised to release com-



pensation for crop losses even before the conduct of the 'girdawari'. Talking about the menace of drugs in the country, Badal said the situation was precarious in Punjab with drones from Pakistan flying in drugs into the state.

"A demographic disaster is taking place but the Central government is yet to come out with a concrete policy to stop the influx of drugs into Punjab from across the border," she added.

Since the Israel-Hamas conflict broke out on October 7, 2023, the Houthis have carried out more than 40 missile attacks against commercial vessels and US naval ships in the Red Sea and the Gulf of Aden.

The Houthis said they aimed to press Israel to end the offensive and siege of Gaza.

Commitment to our citizens more than anything else: Israel Def Min to US envoy

Tel Aviv, Feb 7 (IANS): Israel Defence Minister Yoav Gallant has said that the commitment to the citizens of the country is more important for the government than anything else.

He conveyed this to Amos Hochstein, the vising special envoy of US President Joe Bien, in Tel Aviv on Wednesday, said the minister's office.

It may be noted that Hochstein played a major role in brokering arrangements between Israel and Lebanon, such as the late 2022 agreement delineating the

maritime border between the two countries. In November 2023 also, Hochstein landed in Israel in an attempt to curb the re-emerging violence between Hezbollah and Israel.

The Defence Minister's office said in a statement that Gallant emphasised on the need to solve the crisis in North of Israel with the Hezbollah.

Gallant told Hochstein that his country was ready to resolve the crisis (in the North) through diplomatic means, but were prepared for any other option.

Rachin Ravindra refuses to share POTM award with Kane Williamson, says: 'He's got 31 Test hundreds for my one'


