Hyderabad, Feb 8 (IANS): Chief Minister A Revanth Reddy has made serious remarks against former chief minister K Chandrashekar and termed him as an expired medicine. In an informal chat with media persons in the Assembly

Modi govt's White Paper exposes UPA's 'corruption'

New Delhi, Feb 8 (IANS): The Modi government's 'White Paper on Indian Economy', which was tabled by Finance Minister Nirmala Sitharaman in the Lok Sabha on Thursday, has "exposed" the "fiscal mismanagement" of the United Progressive Alliance (UPA) government, which was in power for 10 years from 2004 to 2014.

It also said that the UPA era was marred by "massive corruption". In the paper, the government criticised the UPA regime for the massive inflation between 2009 and 2014, saying that the government missed the golden opportunity offered by the years of high growth and investment. The government's White Paper also blamed the UPA for the banking crisis during its rule, calling it an infamous legacy of the UPA. The White Paper further said that the UPA government turned a healthy economy stagnant. The UPA undermined macroeconomic foundation and abandoned reforms in 2004, it said. In the overview part of the White Paper document, it said, "In 2014, when we formed the government, the economy was in a fragile state; public finances were in bad shape; there was economic mismanagement and financial indiscipline, and there was widespread corruption. It was a crisis situation." Market borrowings were used unproductively during the UPA regime, said the

The paper further said that "the responsibility to mend the economy step by step and to put the governance sys-



tems in order was enormous". "Our government refrained from bringing out a white paper on the poor state of affairs then. That would have given a negative narrative and shaken the confidence of all, including the investors. The need of the hour was to give hope to the people, to attract investments, both domestic and global, and to build support for the muchneeded reforms," said the White Paper. The government believed in 'nation first' and not in scoring political points, it added. "Now that we have stabilised the economy and set it on a recovery and growth path, it is necessary to place in the public domain the seemingly insurmountable challenges – left behind as a legacy by the UPA government," said the White Paper.

Luthra added that the Union Government was issued a notice in May last year and a copy of the petition was served to the office of the Attorney General of India as well.

The mob was instigated by Anand Mohan Singh.

100 FIRs registered against 15 landowners in Gurugram for illegally developing colonies

Gurugram, Feb 8 (IANS): In a major action against illegal colony developers, the Department of Town and Country Planning (DTCP) Gurugram has registered 100 FIRs against 15 people. As per the complaint filed by the department, these colonies were being developed on nearly 110 acres, including six illegal colonies in Farrukhnagar, three in Pataudi, two in Sohna, and one each in Bhondsi, Sidhrawali, Bilaspur and Bohdakalan in Pataudi.

The complaint mentions that these colonies were carved out on agricultural land which falls under Sector-7A of the Haryana

Development and Regulation of Urban Area Act without prior permission of the department.

"We had issued show-cause notices on these landowners and did not get satisfactory answers. We issued orders that they remove the illegal structures themselves but they failed to do so, forcing us to carry out demolition drives. These landowners were trying to rebuild these demolished structures and thus we had to take action," Manish Yadav, DTCP (enforcement) said.

He said that since the last six months, the department carried out more than 70 demolition drives and around 100 illegal colo-

nies spread over 500 acres have been razed.

"The DTCP Department has given clear instructions to the Tehsildar concerned that registries should not be done in these colonies, if this is done then action will be taken against the Tehsildar concerned," he said.

He said that we have also asked the people not to invest in these illegal colonies.

"These illegal colonies come under section 7A of the Haryana Development and Regulation of Urban Areas Act. It is mandatory to take NOC from the Town and Country Planning Department before any activity," he said.

BJP begins shortlisting candidates for RS polls

Lucknow, Feb 8 (IANS): The BJP is all set to shortlist candidates for the upcoming biennial elections, due on February 27, keeping in mind the caste factors relevant in the Lok Sabha elections and also the organisational importance of candidates.

The names will be shortlisted soon and then sent to the party's central leadership for final approval.

In Uttar Pradesh, 10 Rajya Sabha seats are falling vacant in April and elections for these are being held this month.

Of the ten seats, the BJP holds nine and its retiring members include Anil Jain, Anil Agarwal, Ashok Bajpai, Kanta Kardam, Sakaldeep Rajbhar, GVL Narsimha Rao, Vijay Pal Singh Tomar, Sudhanshu Trivedi and Harnath Singh Yadav. Sources said that the BJP was likely to field some fresh faces for the Upper House this time and also accommodate some veterans.

Jaya Bachchan is the sole Samajwadi Party MP who will retire from the Upper House of Parliament.

Given its strength in the Assembly, the BJP-led NDA is expected to win seven seats and the SP-RLD combine could win three seats.

The BJP will be backed by its three allies, the Apna Dal-S, Nishad Party and SBSP.

The BJP will also receive the support of Raja Bhaiya led Jansatta Dal (Loktantrik) which has been leaning in favour of the ruling party.

The SP-RLD combine will face the test of solidarity from the Congress which has two MLAs in Uttar Pradesh. These three parties are also the key constituents of the Opposition bloc INDIA.

This way, the strength of the NDA in the Rajya Sabha from Uttar Pradesh is expected to go down from 25 to 23 seats, while the strength of the Opposition bloc



will go up from three to five. At present, Uttar Pradesh has 31 MPs in the Rajya Sabha — 25 from the NDA, three from the SP, one each from BSP (Ramji Gautam) and RLD (Jayant Chaudhary), and one Independent Kapil Sibal.

Both, BJP and SP, will try to make deft electoral moves while nominating candidates.

Sources said there is a possibility of the BJP accommodating its allies in the Rajya Sabha to cement support from their voter base for the Lok Sabha elections. While the RLD and Congress will go with SP in these polls, the BSP's stand will be made clear by Mayawati after all candidates are announced.



BJP's Eshwarappa predicts end of Cong rule in K'taka post Lok Sabha polls

Shivamogga, (Karnataka) Feb 8 (IANS): Former Deputy Chief Minister and senior BJP leader, KS Eshwarappa stated on Thursday that after the Lok Sabha elections, there won't be a Congress Government in Karnataka.

Addressing the media in Shivamogga, Eshwarappa claimed, "The drama company led by CM Siddaramaiah is reaching New Delhi. Are you taking soldiers to wage a war? This is a desperate attempt to save the MLAs by taking them on a picnic."

How big-ticket offenders are able to relocate, escape long arm of the law

Tt has been several years since high-profile eco nomic offenders such as Vijay Mallya and Nirav ■ Modi made headlines by fleeing the country, leaving a trail of unpaid debts amounting to thousands of crores from Indian banks. Their departure thrust the nation into a web of financial challenges and raised poignant questions about the effectiveness of legal processes and probe agencies tracking their movement. It also triggered a broader conversation about accountability and the resilience of the financial system.

Sources say that a joint team of the Enforcement Directorate (ED), Central Bureau of Investigation (CBI), and National Investigation Agency (NIA), is actively working to identify properties belonging to such financial fugitives in the UK and other countries. The goal is to seize the 'proceeds of crime' acquired by these financial fraudsters.

A joint team is also working on the extradition of arms dealer Sanjay Bhandari, who fled the country in 2016 amidst investigations into multiple defence deals. Bhandari, allegedly linked to Robert Vadra, husband of Congress General Secretary Priyanka Gandhi Vadra, is said to have acquired properties in London and Dubai, and transferred them to shell companies associated with Vadra's alleged aide.

Bhandari, Nirav Modi, and Mallya, all three declared fugitive economic offenders (FEOs) are expected to be extradited to India, but they still have pending appeals against their deportation.

The government has already attached their assets in India, with some properties sold to recover funds for outstanding bank dues. Under the Mutual Legal Assistance Treaty (MLAT), India and the UK are obligated to share information on criminal investigations related to economic offenders. "A three-agency team is set to hold bilateral discussions in London to facilitate the exchange of information, emphasising the importance of international cooperation," the sources say. While the Union Home Ministry typically handles MLAT, the Ministry of External Affairs (MEA) has taken charge due to diplomatic engagements requiring all requests to be routed through the MEA.

Meanwhile, in a recent setback for Vijay Mallya, who fled from the country on March 2, 2016, the UK High Court ruled in favour of his extradition to India, dismissing his appeal. However, Mallya's legal team has obtained permission to appeal to the UK Supreme Court, further extending the extradition process.

In March last year, the CBI submitted an additional chargesheet in a bank fraud case related to Mallya in a Mumbai court.

The chargesheet stated that while Kingfisher Airlines faced a severe cash crunch in 2008, and lenders were still attempting to recover loans defaulted in 2015-16, Mallya acquired a property valued at Rs 80 crore in the UK and another worth Rs 250 crore in France. The CBI had said that evidence obtained from the UK, through a Letter Rogatory, indicated significant diversions to Mallya's motor-racing team, Force India Formula-1 Team Ltd (F1F1), from Kingfisher's account with HSBC Bank, London.

Information provided during the opening of Swiss bank accounts linked to Mallya in 2014-15 stated that he was neither a politician nor a member of any political party. The chargesheet also revealed that Mallya was slated to receive \$75 million (\$40 million upfront and the remainder in the form of \$7 million annually from 2017 to 2021) from Diageo PLC in exchange for stepping down from the position of Chairman of United Spirits Limited (USL) and refraining from competing with Diageo PLC in Asian liquor markets. The amount constituted an asset that Mallya was obligated not to alienate, as per the terms of the personal guarantee agreement dated December 21, 2010, executed by him in favour of the lenders, including IDBI Bank, for the loans obtained by Kingfisher. For Nirav Modi and Mehul Choksi, accused in the Punjab National Bank (PNB) scam, their legal battles have also taken an international turn.

Soren's arrest revives memories of father's role in cash-for-votes, coal scams

Hemant Soren's arrest by the Enforcement Directorate (ED) on money laundering charges has revived the memories of his father Shibu Soren whose name emerged in the 1993 cash-for-votes scandal and later in a coal scam case.

Four Jharkhand Mukti Morcha (JMM) MPs, including party supremo Shibu Soren, were accused of taking bribes to save the Narasimha Rao government in 1993. It was alleged that Shibu Soren and three of his party's MPs - Shailendra Mahato, Simon Marandi and Suraj Mandal received kickbacks to ensure the survival of the then Rao-led Congress government

ormer Jharkhand CM On July 28, 1993, BJP brought a no-confidence motion against Narasimha Rao and it was almost certain that the Congress government at the Centre would fall, but when voting took place in the Parliament, JMM MPs voted in Rao's favour saving the Congress government.

However, the Supreme Court bench acquitted them, ruling that they had immunity for any acts committed inside the Parliament under Article 105(2) of the Constitution. In 2000, the court convicted only Rao and Buta Singh, but in 2002 they were also acquit-



Kazakh president appoints Olzhas Bektenov as new PM


Astana, Feb 8 (IANS): Kazakh President Kassym-Jomart Tokayev appointed a new Prime Minister to the Republic of Kazakhstan, according to a presidential decree signed on Thursday. Kazakhstan's ruling Amanat Party proposed the candidacy of Olzhas Bektenov, who previously served as the head of the presidential administration. Xinhua news agency reported. Tokayev discussed Bektenov's candidacy with leaders of party factions during a plenary session of the Mazhilis, or lower house of Kazakhstan's parliament. Tokayev later appointed Bektenov as the country's new Prime Minister. Kazakhstan's government resigned on Thursday.

Lebanon: Army does not have capacity to deploy on Israel border in potential Hezbollah deal

Lebanon's interim Foreign Minister Abdullah Bou Habib told the media on Thursday that the Lebanese army does not have the capacity to deploy on the border with Israel, the media reported. Bou Habib cites "a shortage of equipment" as reason for his opposition to the idea, which is reportedly part of the diplomatic solution the US is pushing to keep the fighting between Israel and Hezbollah from expanding

Beirut, Feb 8 (IANS): into a full-blown war, The Times of Israel reported.

The plan, according to Hebrewmedia reports, would see Hezbollah withdraw 8-10 km from the border, and would have UN and Lebanese forces move into the area in greater numbers. IMF tepid to Pak interim govt proposals

Islamabad, Feb 8 (IANS): The International Monetary Fund (IMF) has not immediately endorsed Pakistan interim government's proposals to reduce industrial electricity prices, settle over one-fifth of the circular debt and make the Rs 268 billion debt of the Pakistan International Airline (PIA) part of the public debt, media reported.

The IMF also asked as to why the interim government is showing haste when the Election Commission of Pakistan (ECP) has already barred it from taking any decisive action on the privatisation of PIA, according to government sources, Express Tribune reported.

The global lender sought more details about the economic and legal viability of the three major proposals. The IMF held two back-to-back virtual meetings but their outcomes were below the expectations of the Pakistani authorities.

The next round of discussions on these proposals would take place after the Pakistani authorities provide additional information and the global lender reviews it internally.

The IMF neither rejected nor accepted the three proposals. It emerged from these two meetings that the IMF would give more serious thoughts to them once an elected government takes charge, Express Tribune reported.

The caretaker government is keen on getting the three proposals implemented before leaving the office.

Heavy downpour, floods batter California

The heavy downpour, flooding and power outages caused by the tail end of a powerful atmospheric river storm has disrupted life for hundreds of thousands of Southern California homes and businesses. The atmospheric disturbances deluged the state on Thursday with more heavy rain, mudslides, flooding and several feet of snow in the moun-

tains, media reports said. The city of Hollywood, Los Angeles, bore the brunt of the storm's fury on Monday where some 1.4 million people live

Washington, Feb 8 (IANS): and were faced with a flash flood warning -- including Hollywood's famous Beverly Hills, where filmstars reside. A local state of emergency was issued for the city of Los Angeles by Mayor Karen Bass on Thursday afternoon.

> Across Southern California, heavy winds that battered the region on Sunday were diminishing on Monday, but the National Weather Service warned that an unstable weather pattern could generate waterspouts or small tornadoes.

"Flash floods is a much greater threat than any weak tornado that the storm may spawn," the weather service said, and dangerous flooding was likely across much of the region from the atmospheric river -- the likeness of a river in the sky that is responsible for extreme rain and snow in the West, USA TODAY reported on Thursday.

Some additional rainfall totals of 5-8 inches were forecast in some areas, which would bring 48-hour totals as high as 14 inches for some locations, the weather service said.

A state of emergency was declared in eight Southern California counties by the California Governor Gavin Newsom.

"Life-threatening conditions may

evolve extremely fast in some communities," AccuWeather Se-Meteorologist Alex Sosnowski warned.

A debris flow caused significant damage to about five homes in Beverly Hills on Thursday, the Los Angeles Fire Department (LAFD) said. Although no one was trapped, about 10 people have been displaced, the LAFD added. The LAFD reported that 1,000 firefighters were responding to 49 mudslides and debris flows, 130 reports of flooding, half a dozen structure fires and other rescues of motorists stranded in vehicles. Los Angeles recorded more than



four inches of rain on Thursday, breaking the record for the day by more than an inch. It was the most rain in one day in more than 20 years, and surpassed the average for the month of February.


Officials have attributed three deaths to the storm. In Yuba City, 40 miles north of Sacramento, a man was killed when a redwood tree toppled on him in high winds, police said.

Indian-origin man charged with stealing donations from temples in Canada

Toronto, Feb 8 (IANS): A 41year-old Indo-Canadian man has been charged with breaking into temples and stealing cash from donation boxes. The accused has been identified as Jagdish Pandher from Brampton city.

According to police, multiple break-and-enter incidents were reported in Peel Region comprising Brampton, Mississauga and Caledon between March and August 2023. Surveillance footage from three places of worship showed the suspect breaking into temples and stealing cash from donation boxes. Pandher was also caught on surveillance cameras breaking into other commercial locations and stealing money. Following a lengthy and coordinated investigation by police agencies across the Greater Toronto Area, Pandher of Brampton has been identified as the suspect. Pandher, who is already in custody for similar offences, has been charged with five more counts of breaking in temples and businesses and stealing money.





Man accused of stabbing Indian to death appears in NZ court

Wellington, Feb 8 (IANS): A 33-year-old technician charged with stabbing a 28year-old Indian to death appeared before a New Zealand court and has been remanded in custody without a plea.

Appearing before Justice of the Peace, Helen Meiklejohn, at Dunedin District Court on Thursday, the man, who was arrested on the same day, was granted interim name suppression. He was ordered to appear at the High Court on February 27 in connection with the murder of Gurjit Singh, the New Zealand Herald newspaper reported. Police said they were called to a Dunedin address on January 29 after Gurjit's body was found outside his home covered in blood and glass. Hailing from Pamal village in

Ludhiana, newly-married

Gurjit was working as a tech-

nician with the telecom com-

pany Chorus and was waiting for his wife to join him at the Hillary Street house that he had been renting. Detective Senior Sergeant Kallum Croudis confirmed pathological findings indicate Gurjit died as a result of multiple stab wounds inflicted by a sharp instrument, the Herald reported. Croudis confirmed a homicide investigation was continuing into his

In a statement released on Monday, the New Zealand Police said that a team of 25 Dunedin-based investigators and Christchurch-based ESR scientists were tasked with investigating his death.

In addition, they are assessing CCTV footage provided by the public and interviewing Gurjit's family, friends and colleagues to try to establish his movements before his death.



S.Korea's NSA meets Russian Deputy FM during Seoul visit: Sources

Seoul, Feb 8 (IANS): South Korea's National Security Adviser Chang Ho-jin met with Russia Deputy Foreign Minister Andrey Rudenko when he visited Seoul last week, sources said on Thursday, amid heightened tensions between Seoul and Moscow over North Korea. The meeting took place on Saturday, the sources said, as tensions have flared anew since Russian Foreign Ministry spokesperson Maria Zakharova denounced South Korea President Yoon Suk Yeol's remarks on North Korea as "blatantly biased" on Thursday, Yonhap news agency reported.

In response, Seoul's Foreign Ministry called in Russian Ambassador Georgy Zinoviev and lodged a protest.

SAD opposes stamp duty on property transfer in Punjab

Chandigarh, Feb 8 (IANS): Shiromani Akali Dal (SAD) on Thursday condemned the Aam Aadmi Party (AAP) government in Punjab for increasing stamp duty on loans sanctioned by banks as well as imposing a two per cent stamp duty on property transfer through power of attorney.

Trump up against a 'make-or-break' week of legal cases

Washington, Feb 8 (IANS) lated to election interference and : Former US President Donald Trump is up against a "make or break" this week as he faces several cases down the road starting with the New York Attorney General's tax fraud case where a judicial opinion could send him spinning into a great financial ruin and other issues that could spiral out of control and undermine his defence against election subversion charges. Trump is staring down a \$370 million penalty in a tax fraud settlement that could plunge him into financial ruin with his business licences in New York being cancelled and a judicial opinion that could undermine his defence

against criminal charges re-

a Supreme Court case that could keep him off the ballot come November.

There's a great chance that all three cases could run parallel causing a major headache for Trump and much tension as the legal dramas gain momentum this week within days of each other keeping him off the campaign trail, media reports said.

New York's Judge Arthur Engoron, presiding over Trump's civil fraud trial, allowed a selfimposed January 31 deadline to slip, though a ruling is expected imminently that would finalize damages incurred when Trump reportedly committed fraud by inflating his net worth to obtain favourable treatment from banks and insurers. He's alleged to have

secured loans violating legal norms based on inflated valuations from Deutsche Bank (from \$3.5 billion to \$6.5 billion).

As the New York judgement is projected to go into early to mid-February, according to a court spokesman, Judge Engoron has pushed his ruling timing closer to the date the High Court considers Trump's ballot status.

Of pivotal importance to Engoron's ruling is a federal appeals court could expedite its judgement on a Trump plea that he enjoyed executive immunity as President and so would not be obliged to testify. Any decision on presidential immunity could either upend the former president's several criminal cases or undercut his principal defence in them, media reports said.



The reasons for Judge Engoron's delayed decision are not clearly unknown, though he had given a summary judgment penalising Trump with fines and ordering the cancellation of his business licences but kept them in abeyance waiting for the appeals court to decide pleas of presidential immunity. In any case, the stakes are very high for both the prosecutor New York AG Letitia James and

her predecessor Cyrun Vance and Trump's legal team. New York AG Letitia James is seeking a staggering \$370 million penalty

from Trump. The ruling will also determine whether Trump is barred from participating in New York's real estate industry or running any company in the state – a potentially blistering decision that could effectively eviscerate the business empire he built over decades, which ultimately propelled the real estate mogul to the world's most powerful political position, a USA TODAY commentator observed.

The long-running civil fraud case has been a source of intense frustration for the likely Republican presidential nominee, who is certain to appeal Engoron's decision in the Supreme Court. As he did with the Colorado's SC's decision that kept him off the ballot in the state invoking the 14th amendment on insurrection charges with his inciting attacks by supporters on Capitol Hills on January 06, 2021. Notably, the pending judgment comes in the wake of a jury ordering Trump to pay \$83.3 million in damages for defaming writer E. Jean Carroll.

Those coming to Iran via the land route through Turkey, Afghanistan, Pakistan or any neighbouring nation would not be allowed to enter without a prior visa.

Bengal govt utilised FC funds for paying power bills : Suvendu Adhikari to FM

Kolkata, Feb 8 (IANS): The leader of opposition in West Bengal Assembly, Suvendu Adhikari, wrote to Finance Minister Nirmala Sitharaman on Thursday alleging that the state government has utilised funds allotted under the 15th Finance Commission (FC) for paying electricity bills.

"I had a meeting with the Union Finance Minister on Monday during which I informed her about such irregularities. She asked me to submit the complaint in writing. Today, I sent the details to the Finance Minister through email," Adhikari said.

According to him, the total value of the electricity bills paid by the state government from the allotted funds under the 16th Finance Commission amounts to Rs 330.35 crore. "This is yet another major irregularity, considering that the funds allotted under the Finance Commission are supposed to be spent for development projects like rural road construction and development of sewerage systems, among others.





Siddaramaiah silent over farmer suicides in K'taka: BJP

Bengaluru, Feb 8 (IANS): Karnataka unit BJP General Secretary P. Rajeev on Thursday said that the Chief Minister has remained silent on the farmer deaths in the state.

"More than 850 farmers have committed suicide in the state and the Chief Minister has remained silent over these deaths. Minister Shivanand Patil has in an uncivilized manner said that farmers are ending their lives to get compensation for their families," Rajeev said during a protest at the Freedom Park in Bengaluru.

The protesting BJP workers had also brought cows to the protesting site against the alleged failure of the government to release the subsidy of Rs 715 crore on milk from July 2023 to Jan 2024.

"Did you stop the milk subsidy so that farmers commit suicide?" Rajeev asked.

He said that the Chief Minister travels in a chartered plane with Minister Zameer Ahmad Khan to New Delhi but does not have the humanity to release the subsidy on milk for farmers.

Bangladesh Assistant High Commissioner Mohammad said that one of the 12 Bangladeshi nationals is a minor girl, who was brought by their relatives to Tripura to perform domestic tortured by her relatives in Tripura before she escaped from her employers' home and went to the police seeking help. The girl was in a government home before Tuesday's repatriation," he told the media after the repatriation of the 12 Bangladeshis through the Agartala-Akhaura check-post.

He said the 11 adult persons entered Tripura illegally in search of jobs. After completing the legal and diplomatic formalities, they were handed over to the Bangladeshi officials and family members on Thursday.

Arif Indian and Bangladeshi officials, including Border Security Force (BSF) and Border Guards Bangladesh (BGB) officials, were present at the Agartala-Akhaura check-post during the



repatriation process. Many Bangladeshi nationals, including women, children and mentally challenged individuals, are often apprehended by the BSF and other security forces after lies after completion of medithey inadvertently cross the international border. After medical treatment, they are handed over to their families in their country.

In the past two to three years, around 20 Bangladeshi citizens,

including women, who had accidentally crossed the international border into India in a mentally sick condition, were handed over their famical treatment and a lengthy legal and diplomatic process. Tripura, which is surrounded by Bangladesh on almost all four sides, shares an 856 km international border with the neighbouring country.

Amid objection from NE states, Centre to fence entire 1,643 km stretch of India-Myanmar border

New Delhi/Aizawl, Feb 8 (IANS): Amid objection from different northeastern states, including Mizoram and Nagaland, and many other organisations, the Centre on Thursday reiterated that the Indian government is committed to fence the entire 1,643 km-long India-Myanmar border.

Commenting on the development, Union Home Minister Amit Shah said on Tuesday, "It has been decided to construct a fence along the entire 1,643 km

India-Myanmar border. To facilitate better surveillance, a patrol track along the border will also be paved." Shah also said the Narendra Modi government is committed to building impenetrable borders. "Out of the total border length, a 10 km stretch in Moreh, Manipur, has already been fenced. Also, two pilot projects of fencing through a Hybrid Surveillance System (HSS) are under execution. "They will fence a stretch of 1 km each in Arunachal Pradesh and Manipur. Additionally, fence

works covering approx 20 km in Manipur have also been approved, the work for which will start soon," Shah said. After the Mizoram government, the National Socialist Council of Nagalim-Isak-Muivah (NSCN-IM) has also opposed the Centre's move to fence the India-Mayanmar border and scrap the Free Movement Regime (FMR) between the two countries.

The FMR allowed citizens residing close to both sides of the border to move 16 km into each other's territory without passport or visa.

"The person seen in the video firing the weapon was identified as one Satpal (50), the father of the groom," said the officer. "A case under Sections 25(9) Arms Act and 336 of the IPC has been registered against him. The accused has a valid pistol licence," the officer added.

Justice Subramonium Prasad's direction came in accordance with a ruling by the Supreme Court last year.

The judge stressed the importance of the State's proactive measures to disburse the remaining compensation to all eligible individuals, rather than requiring them to individually petition the court.

Justice Prasad stressed the principle that once a court declares a law in favour of an individual, the State is expected to extend the same benefit to all similarly situated persons.

"It is well settled that when a person approaches a court and gets a declaration of law in his State shall extend the same benefit to all the similarly situated persons without forcing those persons to approach the court of law," the court said.

The court was hearing a plea filed by various widows seeking the Delhi Government's obligation to fulfill the Supreme Court's ruling by paying them Rs. 20 lakh each.


The Supreme Court had mandated an increase in compensation for sewer deaths to Rs. 30 lakh and for permanent disability arising from sewer operations to Rs. 20 lakh, with no less than Rs. 10 lakh for other forms of disablement.

Indian-American presidential candidate Haley seeks Secret Service protection: Report

: Indian-American Republican Presidential candidate Nikki Haley, the lone challenger left against former US President Donald Trump, has formally requested Secret Service protection citing "multiple issues," the BBC reported. The former South Carolina Governor and United Nations ambassador discussed the request for protection in an interview with The Wall Street Journal on Thursday.

"We've had multiple issues. It's not going to stop me from doing what I need to do," she said after a campaign event in Aiken, South Carolina.

"When you do something like this, you get threats. It's just the reality. That's not going to deter me. Does it mean we have to put a few more bod-

Washington, Feb 8 (IANS) ies around this? Yes, that's fine," she told the paper.

> Haley, who has been urged by the former President Trump and his backers to exit the race and unify the party against Democrat Joe Biden, currently uses personal security while campaigning.

In addition, protesters have shown up at her campaign events to slam her support for Israel and Ukraine. "At the end of the day, we're going to go out there and touch every hand, we're going to answer every question, we're going to make sure that we are there and doing everything that we need to," she said. The White House hopeful has been a target of "swatting" attempts with the recent one on New Year's Day when a hoax call was made to law enforcement agencies, saying Haley's daughter had been shot and was lying in a pool of blood.

Days before, her Kiawah Island



home was also swatted when a man called the police and claimed to have shot a woman.

While Haley was not at home, her parents were there along with a

Calling it an "awful situation," she had said: "It put the law enforcement officers in danger, it put my family in danger... That's what happens when you run for president."

Secret Service protection is granted to "major" candidates under federal law, usually when they look certain to become their party's nominee, the BBC said. A call on providing Haley with Secret Service support would be taken by the US Secretary of Homeland Security, who would first confer with a Joint Congressional Committee.

As former President, Trump who enjoys a large doubledigit lead over Haley, gets Secret Service protection for life. Despite lagging behind her former boss in the two primaries held so far, Haley raised a massive \$16.5 million in January alone.



More N.Koreans negative about leader Kim Jong-un, hereditary power succession: Report

Seoul, Feb 8 (IANS) : A growing number of North Koreans have negatively assessed Kim Jong-un as a political leader and harboured doubts about whether the Kim family's hereditary power succession is legitimate, a report showed on Thursday.

Seoul's Unification Ministry released the 280-page report on North Korea's economic and social situation for the first time on Thursday. The report is based on in-depth interviews with 6,351 North Korean defectors conducted between 2013 and 2022, Yonhap news agency reported.

It showed 43.8 per cent of the North Korea's defectors said they thought Kim Jong-un taking power was inappropriate when they lived in North Korea. For those who fled North Korea between 2016 and 2020, some 56.3 per cent gave a negative assessment of Kim as a leader.

"Negative public sentiments toward the 'Paektu bloodline'-based leadership system have been increasing and this perception appears to be gaining traction since Kim Jong-un assumed power (in late 2011)," the report showed.

North Korean propaganda has idolised the ruling family as the "Paektu bloodline," claiming that Kim's late father, former leader

Kim Jong-il, was born on Mount Paektu, the highest peak on the Korean Peninsula, despite the fact that he was born in the far eastern Russian city of Khabarovsk. Nearly 55 per cent of the North Korea's defectors who fled the North Korea between 2016 and 2020 said they had a negative opinion of the Kim family's power succession. Some 42.6 per cent held such a view among those who escaped the country between 2011 and 2015. Kim Jong-un has brought his teen daughter, Ju-ae, to public events since late 2022 in an apparent bid to demonstrate his commitment to the third hereditary power succession. The National Intelligence Service, Seoul's spy agency, said it sees Ju-ae as the "most likely suc-

Amid a sluggish economy, more North Koreans have been doing various activities in the "private" economy, including selling goods at markets, cultivating unauthorised lands, smuggling and engaging in housing construction projects.

Markets are playing a critical role in the livelihoods of North Koreans, as the food rationing system has collapsed. Around 91 per cent of the North Korea's defectors said life was not sustainable without markets, and for those who fled the North Korea after 2012, some 68.1 per cent of their income came from "non-official income sources.

"The influence of markets has been expanding to healthcare, education, transportation and information infrastructure from the necessities of life, such as food, clothing and shelter, as well as energy, water and sewage," it said.

North Korea has been suffering from a chronic food shortage amid prolonged UN sanctions on Pyongyang's nuclear and missile programmes. The North Korean economy probably contracted 0.2 per cent on-year in 2022, marking the third straight year of falls, according to data from the Bank of Korea.

Fresh US-British airstrikes hit Yemen

Sanaa, Feb 8 (IANS): The US-British coalition launched three airstrikes on Yemen's northern province of Saada before dawn on Thursday, media reported. The strikes targetted sites in the eastern part of the province's capital city, which bears the same name, the Houthi-run al-Masirah TV said without elaborating. The fresh airstrikes occurred following a reported missile attack towards the Red Sea, Xinhua news agency reported. The US Central Command confirmed that the US military struck two Houthi explosive uncrewed surface vehicles in Yemen. The command said in a statement that the strikes were launched at nearly 3:30 p.m. Sanaa time, and the targets were deemed "an imminent threat to US Navy ships and merchant vessels in the region". The airstrikes are part of an ongoing military response by Washington and London since January 12, targetting Houthi-controlled areas of Sanaa and other northern provinces.



Democratic forces gaining ground against junta, says Myanmar envoy at UN

United Nations, Feb 8 (IANS): we wish to live in a free, peaceful, The democratic forces are gaining ground and the military junta is "losing", Myanmar's Permanent Representative Kyaw Moe Tun, who represents the democraticallyelected government overthrown in a coup three years ago, has said while appealing for effective UN Security Council action against the dictatorship. "We the people of Myanmar are unified in opposition to the military dictatorship. And if

inclusive, just and democratic society," he told reporters on Monday before a closed Council meeting on the situation in that nation. "Democratic forces are gaining ground and the military junta is losing every day," he said.

"But we need help from the international community, coordinated concrete actions, both from the Security Council and individual member states."



GEF Council allocates \$916 million for biodiversity, pollution control

The Global Environment Facility (GEF)'s 186 member governments have allocated \$916 million for international action on biodiversity, climate change, nature renewal, and pollution control, and advanced five Integrated Programs designed to tackle complex challenges in their entirety.

The GEF Council, in a meeting in Washington on Thursday, approved funding for 45 projects and programs, including four blended finance initiatives involving the private sector.

The support will directly help more than 12 million people,

including indigenous peoples and local communities. The work program -- the sec-

New Delhi, Feb 8 (IANS): ond-largest in the GEF's history -- includes \$530 million for Integrated Programs for the ocean, food systems, transportation infrastructure, wildlife conservation, and critical forest biomes that have been designed to break down silos and advance holistic action across sectors and borders.

"To achieve impact that lasts, we need to work in an integrated and inclusive way," said Carlos Manuel Rodríguez, GEF CEO and Chairperson. "The GEF is moving quickly and efficiently to target donor contributions to urgent needs. We also recognize that financing alone cannot reverse environmental degradation for the long term. This work program therefore stands out not only for its size but also for its focus on a whole-of-society approach to phasing out harmful practices."



The GEF Trust Fund work program is set to mobilize \$7.5 billion in co-financing, including from bilateral governments and multilateral development banks. It spans 77 countries, including 22 Least Developed Countries and 14 Small Island Developing States, with the largest regional shares of the funding package going to Africa and Asia.

The total GEF Family of Funds financing package is expected to exceed \$1 billion this week when the Council considers another \$203 million from the Least Developed Countries Fund (LDCF) and Special Climate Change Fund (SCCF). The new Global Biodiversity Framework Fund Council will also meet for the first time this week.
