Telangana Governor, CM worship tribal deities at Medaram

Hyderabad, Feb 23 (IANS) : Telangana Governor Tamilisai Soundararajan and Chief Minister A. Revanth Reddy on Friday offered prayers to tribal deities Samakka and Saralamma at Medaram in Mulugu district.

The two leaders reached Medaram by separate helicop-

ters and paid their obeisance to the deities as part of the ongoing Sammakka Saralamma Jatara, considered as Asia's largest tribal fair.Chief Minister Revanth Reddy told mediapersons that he prayed for the prosperity of Telangana and its people.

He was accompanied by state ministers Seethakka, Sridhar Babu,

Ponguleti Srinivasa Reddy and several other Congress leaders. Revanth Reddy said he always draws inspiration from the story of Samakka and Saralamma to fight against exploitation and injustice, adding that the Congress with the support of the people fought with the same spirit to end the 10-year 'misrule' of BRS. The Chief Minister also said that a people's government has been formed in the state with the blessings of the tribal goddesses.

The state government released Rs 110 crore for the biennial Jatara to provide all facilities for the devotees, the CHief Minister said, even as he criticised the Centre for sanctioning only Rs 3 crore for the event.

Revanth Reddy also said that he shares a special relationship with Mulugu district and minister Seethakka, whom he considers his sister, adding that he starts all his important programmes from this place. Recalling how he had launched the 'Haath Se Haath Jodo Yatra' from Medaram, the Chief Minister promised to provide necessary funds for the allround development of the place. For Tamilisai Soundararajan, this was her third visit to the Medaram Jatara as the Governor. She offered traditional sarees as tokens of respect.







BRS MLA Lasya Nanditha dies in car accident

Hyderabad, Feb 23 (IANS) Bharat Rashtra Samithi (BRS) MLA G. Lasya Nanditha died in a road accident near Hyderabad early Friday morning. She was 33.

The accident occurred when the car she was travelling in hit a road divider on the Outer Ring Road (ORR) near Patancheru. The MLA's driver was injured in the crash. describing him as a villain who tried to stop the poor from getting house sites. Addressing a public meeting at Ongole, the Chief Minister alleged Chandrababu Naidu and his supporters filed 1191legal cases in courts to stop the distribution of house site pattas and construction of houses for the poor. He said that Naidu, who had humiliated SCs, BCs and other weaker sections of society with disparaging remarks during his tenure as Chief Minister, approached courts to create hurdles. While construction of 8.90 lakh houses has been completed for the poor, 22 lakh more houses are under construction, he said, adding government has faced hurdles in the construction of houses for the poor in the CRDA (Capital Region Development Author-

ity) region as Chandrababu and his men approached courts citing demographic imbalance.

He observed that it is very unfortunate that Naidu is still continuing in politics after cheating all sections of people by defaulting on his loan waiver promise to farmers and self-help groups and throwing his 2014 election manifesto into the dustbin after coming to power. Naidu, who didn't give a single cent of land to the poor during TDP rule, created legal hurdles as he didn't want the poor to gain social and economic empowerment, Jagan Mohan Reddy said.

Judicial probe to begin soon in Kaleshwaram lift irrigation project: Revanth Reddy

Hyderabad, Feb 23 (IANS) : Telangana Chief Minister A. Revanth Reddy on Friday said the state government will soon appoint a retired judge of the High Court or Supreme Court to conduct a probe into alleged irregularities in the construction of Kaleshwaram lift irrigation project by the previous BRS government.

He said the leaders of Bharat Rashtra Samithi (BRS) will have to face the probe by a retired judge. He was talking to mediapersons in Medaram in Mulugu district after paying obeisance to tribal deities during ongoing Medaram jatara.

Revanth Reddy said it was only after the Congress government decided to order a judicial probe into Medigadda barrage (a part of Kaleshwaram project), the BJP started demanding an inquiry by the Central Bureau of Investigation (CBI). He asked what the BJP was doing for 10 years. "The CBI, ED and the



I-T are all in the hands of BJP but they did not file a single case against KCR or his family," he said while recalling that the BJP ignored the representations the opposition parties made for a probe into allegations of corruption. He also claimed that that and BJP have reached an understanding for the forthcoming Lok Sabha elections in Telangana. He said as per the understanding between the two parties, BJP will contest 10 seats while BRS will contest the remaining 7 seats.

Hyderabad, Feb.23 (NSS): Advisor to the Government of Telangana Mohammed Ali Shabbir on Friday directed the contractors not to reduce the size of Secretariat mosques further and ensure their protection by proper barricading. Shabbir Ali, along with Minorities Welfare Department Secretary Syed Omer Jaleel and other senior officials, offered Friday prayers at the Secretariat mosque. He inspected the temporary sheds (pandal) erected in the open area adjacent to the mosque. He said these sheds would be kept till the end of the coming holy month of Ramzan, and they would be re-erected for all Friday prayers. He said that the engineers and contractors have been asked not to carry out any construction activity further and to keep the open area for the use of mosques.

He pointed out that the previous BRS regime had reduced the size of Masjid Hashmi by more than half, now measuring 18 x 18 feet. Similarly, the size of Masjid-e-Moatamadi has been reduced to 48 x 48 feet from its original dimensions of 100 x 60 feet, drastically impacting its capacity from 500 to a mere 180-200 worshippers. Therefore, temporary sheds have been erected in the open area of the mosque to accommodate more worshippers during Ramzan and on all Fridays. He also inspected other facilities like the Wuzu Khana, toilets, parking and other arrangements. The advisor informed that Taraveeh prayers would be offered in the Secretariat mosques during the month of

RSS-BJP clan had also tried to project PM Narendra Modi as embodiment of Ram during the Ram Temple inauguration event in Ayodhya on January 22, 2024. The clan's deception and falsehood seemed having no limit.

The performance narrative under the last ten years rule of PM Narendra Modi is also not less deceptive and false. PM Modi himself has said that the world is in praise of his government's wonderful performance and looking forward to India. He said that India was ranked 5th biggest economy of the world, and the country would become 3rd biggest in his third term, and a developed country in Amrit Kaal by 2047. This ranking forms the core of the performance narrative under Modi rule. It would be of great help to know how actually world ranks India under PM Modi? Deceptive fastest growing country tag with the 5th biggest economy, conceals many facts including the one that World Bank describes India as lower middle income country. Due to low earning, working poverty is very high. World Bank says over 97 crore people can't afford even healthy food, while 80 crore people are dependent for foodgrain on PM Garib Kalyan Ann Yojna. Despite PM Modi's claim of pulling 25 crore people out of poverty, the number of poor remained the same since introduction of Food Security Act in 2013. India houses largest number of poor in the world. This is how India is ranked by the world. Deception in the performance narrative is obvious, since the World Bank had said in 2022 that India needs about one decade to become even an upper middle income country. It makes the narrative of Modi's "Vikasit Bharat" (Developed India) guarantee farfetched, especially in the backdrop of rising inequality within the country under his rule, though wealth creation is also a fact, but for handful of entities, such as 20 companies bagging 60 per cent of wealth generated and 70 per cent of earning of the entire country. When even PM Modi is talking about India's ranking in growth and economy, it will not make any harm to anyone to know key rankings of our country on various areas of interest, and it would not be an anti-national activity as the government has been alleging certain individual Indian political leaders of maligning Modi rule abroad. India has been one of the least happy nations in the world, even lesshappier than Nepal, China, Bangladesh, and Sri Lanka. The World Happiness Report by UN-SDSN ranked India 136 out of 146 nations it studied in 2022. One of the chief reasons was failure of governance and performance of the government. In Human Development Index (HDI), the UNDP ranked India 132 out of 191 countries in 2021-22. In inequality-adjusted HDI, the UNDP put India at108thin 2022 report out of 156 nations. Undersea cables play a crucial role as essential infrastructure for digital connectivity, consisting of around 500 fibre-optic cables that span the ocean's floor globally. British firms, including British Telecom, are part of consortia owning cables in the Red Sea, with British Telecom holding an interest in the significant AAE-1 cable that stretches from Europe, through Africa, to Asia. The AAE-1 (Asia-Africa-Europe-1) cable is a 25,000 km submarine communications cable system from South East Asia to Europe across Egypt, connecting countries in Asia, the Middle East, Africa, and Europe. This cable system is designed to provide telecommunications services like internet access, data transfer, and other forms of digital communication, enhancing connectivity be-

Israeli army re-enters Nasser Hospital in Khan Younis after short withdrawal

Gaza, Feb 23 (IANS) : The Is- He urged the World Health Orraeli army sent four armoured personnel carriers into Nasser Hospital shortly after it withdrew troops from the facility, the Gazabased Palestinian health ministry has said in a statement. Palestinian security sources told Xinhua news agency on Friday that the Israeli army forces have converted the complex into a military barracks through days of siege and attacks. An earlier report by Israel's Channel 13 news claimed that the Israel Defense Forces (IDF) had ended their operation at the hospital.

Ashraf al-Qedra, the spokesman for the health ministry, told the news agency that the hospital housed more than 120 wounded people and patients, as well as medical teams.

He noted that during the siege, the hospital, which is the second-largest hospital in the Gaza Strip, was "without electricity, water, food, oxygen, and proper medical care for critical cases."

Two days ago, Israeli public radio reported that the army forces fighting in the Nasser Hospital area needed a few more days to complete their control over the site. It added that the hospital had become a refuge for a large number of Hamas fighters who fled from the northern Gaza Strip, noting that dozens of them were killed, while around two hundred surrendered to the Israeli army, many of whom were disguised in medical personnel uniforms. In addition, it mentioned that large quantities of weapons, ammunition, and drugs were found at the site, which were transferred to the Israeli detainees. However, the forces did not obtain any information that would contribute to the release of the abducted persons.

PTI offered 'lucrative position' for making rigging allegations, claims ex-Rawalpindi Commissioner

Islamabad, Feb 23 (IANS) out of "guilty conscience" for : Withdrawing all his allegations related to rigging in the February 8 general elections Pakistan, former in Rawalpindi Commissioner Liaquat Ali Chattha said he was "extremely ashamed, embarrassed", and claimed that he made the move in coordination with a Pakistan Tehreek-e-Insaf (PTI) leader, a media report said.

"I take full responsibility for my actions and surrender myself before the authorities for any kind of legal action," Chattha said in a statement to the Election Commission of Pakistan (ECP), Geo News reported. In a dramatic development last Saturday, Chattha had tendered his resignation, which he said was



abetting large-scale electoral rigging in the garrison city, further raising the political mercury in the country. The Commissioner, in the

rare press conference, had taken responsibility for the "rigging" that he claimed took place in Rawalpindi Division. "We converted the losers into winners with 50,000 votes margin," he had stated. In response to his allegations, the PTI, Jamaat-e-Islami (JI), and other political parties -- most of whom had already rejected the election results -- demanded an investigation into the matter. In the same presser, Chattha had also accused Chief Justice of Pakistan Qazi Faez Isa of facilitating the rigging.



Israel to send delegation for Gaza truce talks in Paris

Jerusalem, Feb 23 (IANS) : Israel's war cabinet decided on Friday night to send a delegation for Gaza ceasefire talks in Paris on Friday, as international negotiators renew efforts to secure a deal between Israel and Hamas. A government official confirmed to Xinhua news agency that the head of the Mossad intelligence agency, David Barnea, will lead the Israeli delegation. The talks will be attended by Qatari Prime Minister Sheikh Mohammed bin Abdulrahman bin Jassim Al Thani and Director of US Central Intelligence Agency William Burns. The White House's Middle East coordinator, Brett McGurk, was in Israel on Thursday for talks with senior officials to negotiate the release of hostages held in Gaza and to secure

a pause in the fighting. McGurk's visit comes amid heightened efforts to broker a ceasefire agreement, as Israel's declared intention to launch an incursion into the densely populated city of Rafah raised global concern and more than four months of heavy Israeli bombardments in the Gaza Strip had killed 29,410 Palestinians and wounded 69,465 others as of Friday. After meeting McGurk, Israeli Defense Minister Yoav Gallant said that the Israel Defense Forces (IDF) is "preparing the continuation of intense ground operations". Gallant's office said in a statement that their meeting focused on efforts to free the remaining 134 hostages still held in Gaza, at least 30 of whom are believed to be dead.

72 killed in Lassa fever outbreak in Nigeria

72 fatal cases of Lassa fever have been reported in Nigeria, Africa's most populous country, since the beginning of this year, public health authorities said on Friday. The 72 deaths were among a total of 411 cases confirmed so far from the outbreak of the viral hemorrhagic fever recorded across 21 states since January, Xinhua news agency reported, citing the latest report of the Nigeria Center for Disease Control and Prevention (NCDC). Sixty-five per cent of the total confirmed cases were reported from the three states of Ondo, Edo, and Bauchi, while 35 per cent were reported from 18 other states, the NCDC said. A total of 2,122 cases have been

recorded so far this year, marking

Abuja, Feb 23 (IANS) : At least a significant decrease from 8,280 suspected cases recorded in the same period in 2023, said the national disease control agency. Two health workers have been so far affected by the Lassa fever outbreak in the country, with the predominant age group of victims being 21 years and 30 years of age, the NCDC said in its report.

Lassa fever is a disease spread to humans through food or household items contaminated with rodent urine or feces. It is reportedly transmitted when saliva, urine, and excreta of rats come into contact with humans. In 2023, at least 219 deaths were recorded from 1,227 confirmed cases of Lassa fever, according to the NCDC.



Palestinian death toll rises to 29,410

Gaza, Feb 23 (IANS) : The Palestinian death toll from the ongoing Israeli attacks on Gaza has risen to 29,410, with 69,465 others wounded since the Israel-Hamas war broke out, authorities said on Friday. As per Palestinian Health Ministry, the Israeli army killed 97 Palestinians and wounded 132 others during the past 24 hours, noting that some victims remain under the rubble amid heavy bombardment and a lack of civil defense and ambulance crews, Xinhua news agency reported. At least 20 Palestinians, including children, were killed when an aircraft bombed a number of homes in the Al-Sabra and Al-Zaytoun neighborhoods in Gaza City. The sources told Xinhua that artillery shells were fired towards residential homes in the Al-Rimal neighborhood, west of Gaza, resulting in casualties among the residents. Warplanes also launched three raids on the border area in the city of Rafah, south of the Gaza Strip, targeting homes without causing casualties.

Strong earnings report from **Nvidia bolsters optimism on Wall Street**

New York, Feb 23 (IANS) : companies on Wall Street, led US stocks soared higher on Friday after a strong earnings report from tech giant Nvidia bolstered investor optimism on Wall Street, a media report said.

The blue-chip Dow Jones Industrial Average was up 278 points, or 0.7 per cent. The S&P 500 gained 1.6 per cen%, while the tech-heavy Nasdaq Composite was 2.4 per cent higher, CNN reported.

The S& P 500 hit a record high during morning trading on the pop in big tech and the Nasdaq is tracking towards a new all-time high as well, the report said.

Nvidia, one of the largest



gains after reporting extraordinary earnings growth, fuelled by the artificial intelligence boom.

Profits of the chipmaker grew to nearly \$12.3 billion in the three months ended January 28 -- up from \$1.4 billion in the year-ago quarter, a gain of 769 per cent year-over-year and even stronger growth than Wall Street analysts had expected. That result helped bring the company's full-year profits up more than 580 per cent from the year earlier, CNN reported. Nvidia CEO Jensen Huang said in a statement on Friday evening that generative AI has now "hit the tipping point"

Manipur HC cancels order for examining inclusion of Meitei community in Scheduled Tribes list

Imphal, Feb 23 (IANS) : The Manipur High Court has modified its March 2023 order in part, whereby a contentious direction was issued to the state government for considering the inclusion of Meiteis in the Scheduled Tribes (ST) list, observing that a paragraph of that order was in conflict with the Supreme Court's constitution bench observation, court sources said on Friday.

The single judge bench of Justice Golmei Gaiphulshillu was hearing a review petition filed against para 17 (iii) of the decision dated March 27, 2023 rendered by the then acting Chief Justice M.V. Muralidharan in a petition by a Meitei organisation.

"....the direction given at Para No. 17 (iii) needs to be deleted and is ordered accordingly for munity claiming over 200 lives deletion of the Para No. 17 (iii) of the judgment and order dated 27.03.2023 passed in W.P.(C) No. 229 of 2023," the order of Wednesday said.

The contentious paragraph no 17 (iii) of last year's High Court verdict instructed the state to expedite consideration of Meitei community inclusion in the ST list. Then acting Chief Justice M.V. Muralidharan, who was subsequently transferred to the Calcutta High Court, in his March 27, 2023 order directed the state government to send a recommendation to the Union Tribal Affairs Ministry to consider the ST status for the Meitei community.

The directive is believed to be a catalyst for ethnic conflict between the non-tribal Meitei community and tribal Kuki-Zo comand injuring 1,500 and displacing over 70,000 people of both communities.

Erstwhile princely state Manipur merged with the Indian Union in 1949.

Justice Gaiphulshillu's order said: "The Meetei (Meitei) of Manipur has lost the identity of the tribe while merging with the Union of India on September 21, 1949 and earlier Manipur was a simple classless tribal society. However, at the time of merging, 29 communities of Manipur have been included in the Scheduled Tribe list of Indian Union and thereafter, as per the order of May 26, 2003 of the Gauhati High Court's Imphal bench, Chongthu, Khoibu, and Mate have been included in the list of Scheduled Tribes. Accordingly, now there are 34 num-



bers of tribal communities of Manipur included in the list of Scheduled Tribes of the Indian Constitution, but the Meetei (Meitei) tribe was left out."

After the outbreak of ethnic violence on May 3 last year (post the March 27 High Court order), several petitions, including challenges to the high court directive, were filed to the Supreme Court. The ethnic violence broke out in the northeastern state after March 27 High Court order as a 'Tribal

Solidarity March' was organised in the hill districts to protest against the Meitei community's demand for ST status. Meiteis account for about 53 per cent of Manipur's estimated population of about 36.49 lakh and live mostly in the six Imphal Valley districts, while tribals, which include Naga, and Kuki-Zo, constitute 40 per cent and reside mainly in the 10 hill districts.

Apple's India revenue up 42% to \$8.7 bn in 2023: Morgan Stanley

New Delhi, Feb 23 (IANS) Apple's revenue in India rose nearly 42 per cent (on-year) last year to \$8.7 billion, foreign brokerage Morgan Stanley said in a report on Friday.

According to the report, iPhone shipments grew about 39 per cent to 9.2 million units last year. "In CY23, India represented 4 per cent of iPhones shipments and revenue, up from 3 per cent in CY22 and 1 per cent 5 years ago," said analysts in the report. "If India continues to grow at the same trajectory while China iPhone shipments stay flat,

India would be a bigger iPhone market than China by 2027," it added.

TechCrunch was first to report on Apple India's 2023 revenue. Apple registered strong doubledigit growth in the December quarter in India, reaching another quarter revenue record in the country, company's CEO Tim Cook said earlier this month.

Responding to an analyst's questions, Cook said that the India market "hit a quarter revenue record". India's smartphone shipments remained flat in 2023 at 152 million units, but Apple reached the 10million-unit mark in shipments and captured the top position in revenue in a calendar year for the first time. In a bid to further boost mobile manufacturing in the country, the government in January slashed import duty on parts used for manufacturing of mobile phones to 10 per cent from 15 per cent. The move will help companies like Apple to manufacture more of its high-end premium smartphones in the country.



Goldman Sachs downgrades key banking stocks, says goldilocks period over

Delhi HC stays single judge bench's order for return of seized property if money-laundering probe goes beyond 365 days

New Delhi, Feb 23 (IANS) : The Delhi High Court on Friday stayed a single judge bench's order that mandated the return of seized property to its original owner if the Enforcement Directorate's investigation under the Prevention of Money-Laundering Act extends beyond 365 days without leading to any related offence proceedings.

A division bench of Acting Chief Justice Manmohan and Justice Manmeet Pritam Singh Arora, stayed Justice Navin Chawla's January 31 ruling in favour of Mahender Kumar Khandelwal, the Interim Resolution Professional (IRP) for Bhushan Power and Steel Ltd (BPSL).

Justice Chawla had pointed out that continuing to hold Khandelwal's property without initiating court proceedings or filing a complaint against him amounted to a confiscatory act devoid of legal authority, thus infringing upon Article 300A of the Constitution. "The continuation of such seizure beyond 365 days, in absence of the pendency of any proceedings relating to any offence under this Act before a court or under the corresponding law of any other country before the competent court of criminal jurisdiction outside India, shall be confiscatory in nature, without authority of law and, therefore, violative of Article 300A of the Constitution of India," the order read.

Therefore, the judge had said, "the natural consequence of the investigation for a period beyond three hundred and sixty five days not resulting in any proceedings relating to any offence under the Act, in terms of Section 8(3) of the Act, is that such seizure lapses and the property so seized must be returned to the person from whom it was so seized".

Kerala hospital performs rare surgical procedure on critically-ill youth

"If not well contained in time, it can go beyond regional disputes," Dhankhar said while addressing the Indian Maritime Seminar (MILAN 2024) organised by the Indian Navy here on Thursday.

Dhankhar highlighted that the challenge to rule-based order is at its peak at the moment, and described its resolution as unavoidable necessity.

"In recent years, we have seen formidable security challenges in the maritime domain and these have acquired a

Drugs valued at Rs 35 crore seized in Mizoram; 3 held

Aizawl, Feb 23 (IANS) : The Assam Rifles in co-ordination with the Mizoram Police, recovered 11.39 kg methamphetamine tablets and 218 gm heroin valued at around Rs 35.19 crore and arrested three drug peddlers including two women in Mizoram's Champhai district in this connection, an official said on Friday. Acting on a tip-off, a joint team of Assam Rifles and Mizoram Police conducted a raid at Dungtlang village on Wednesday night and seized methamphetamine tablets and heroin, an Assam Rifles official said

A 25-year-old man hailing from Assam's Silchar town and two women from Zotlang in Champhai district have been arrested for possessing drugs, smuggled from neighbouring Myanmar. The drugs and the apprehended persons have been handed over to Champhai police station for further legal proceedings. "Ongoing smuggling of contraband items is a major cause of concern for the state of Mizoram and India," the Assam Rifles said in a statement.

An official said the highly addictive methamphetamine tablets, also locally called Yaba tablet or party tablet, smuggled in from Myanmar have been one of the most trafficked drugs in recent years. These tablets have a huge demand in northeastern states, and other parts of India and neighbouring Bangladesh.



Imran wants IMF aid to Pakistan stalled over 'rigged' elections

Rawalpindi, Feb 23 (IANS) : Pakistan Tehreek-e-Insaf (PTI) founder Imran Khan will write to the International Monetary Fund (IMF), demanding to stop its support for Pakistan due to the "rigged elections", party leader Ali Zafar said on Friday, media reports said. "Imran Khan will issue a letter to the IMF today. The charter of IMF, EU, and other organisations stipulates that they can function or provide loan to a country only if there's good governance," Zafar told journalists after meeting Khan at Rawalpindi's Adiala Jail, Geo News reported

Zafar claimed that the "most important section" of their

charter is that a country should be democratic.

"If there's no democracy, neither can these institutions function in such countries, nor should they," he said, Geo News reported.

"The basic pillar of democracy is free and fair elections. However, the entire world saw how the nation's mandate was stolen. Let's leave pre-poll rigging aside, in post-poll rigging, victory was snatched from PTI's winning candidates," Zafar said.

This isn't the first time that the opposition PTI will try to affect the IMF deal, as in 2022, its ex-leader Shaukat Tarin had told PTI's then Finance Mministers of Khyber Pakhtunkhwa and Punjab that they should "tell the IMF that the commitment made to them cannot be fulfilled" and to cite the recent devastation caused by floods in the country as the reason behind it.

Pakistan secured a short-term \$3 billion programme from the IMF last year, which helped the country avert a sovereign debt default. It will run out next month and securing a new and much bigger one is widely seen as the priority for the new administration.



China one of the costliest places in the world to raise a child

Hong Kong, Feb 23 (IANS) : China is one of the most expensive places in the world to raise a child in relative terms, a new report said, with the disproportionate impact on women driving the country's precipitously low fertility rate as it grapples with a demographic crisis. The study by the China-based YuWa Population Research Institute found that the average nationwide cost of raising a child from birth to age 17 was about \$74,800 - rising to more than \$94,500 to support a child through a bachelor's degree, CNN reported. The cost of raising a child to age 18 in China is 6.3 times higher than the country's GDP per capita, the report said – a ratio second only to South Korea, which has the world's lowest fertility rate, and where the cost of child-rearing is 7.79 times the GDP per capita, CNN reported.



Two arrested for breaking into Secret Service vehicle of Biden's granddaughter

Washington, Feb 23 (IANS) : Two teenagers have been arrested in connection with the break-in of a secret service vehicle assigned to US President Joe Biden's granddaughter Naomi Biden. The break in had occurred outside Naomi Biden's house in Georgetown area in Washington DC last year, BBC reported. The incident occurred on November 12 and Naomi Biden's secret service agent had fired at the thieves. As per the court records, the accused was identified as Robert Kemp and an unnamed juvenille.





Japan: Train services suspended between Tokyo, Yokohama due to concrete on tracks

Tokyo, Feb 23 (IANS) : Train services on Japan's JR Yokosuka line between Tokyo and Yokohama stations were suspended on Friday due to concrete on tracks in a tunnel.

Multiple pieces of concrete have fallen onto the tracks in the tunnel between Tokyo and Shinagawa stations, leading to suspension of train operations since morning, said East Japan Railway Company, or JR East, Xinhua news agency reported. The closed section was extended from Tokyo to Yokohama stations due to restoration work.

JR East's Narita Express trains, which connect Narita Airport in Chiba Prefecture and the greater Tokyo area, have consequently been suspended from the first departure on all routes, but are expected to resume in the afternoon.

Russia-US relations won't improve for decades : Dmitry Medvedev

Moscow, Feb 23 (IANS) : Russian Security Council Deputy Chairman Dmitry Medvedev Friday said that Russia-US ties will not improve in the coming years and even decades. In an interview to the local media, Dmitry Medvedev said that his current position allows him to speak more categorically and openly than during other periods, Xinhua news agency reported.

Both countries will not be able to develop normal ties in the upcoming years after what has happened, no matter who is in power in Washington, Dmitry Medvedev said. He reiterated that Moscow had never refused to negotiate with Kiev as it is Ukraine that forbids talks, but attempts made by Western countries to steer Ukraine in this direction have remained unsuccessful. Russia's preconditions for such negotiations would be "the recognition of the results of the special military operation," he said, adding that Ukraine is trying to delay the negotiation process fearing immediate defeat.



US asks Pakistan to respect freedom of expression, end social media curbs

Washington, Feb 23 (IANS) : The US has asked Pakistan to respect freedom of expression and restore access to X and so-

cial media platforms. On disruptions on social media in Pakistan, US state department spokesperson Matthew Miller, in a media briefing, said: "So we are concerned by any report of restrictions on the exercise of the freedom of expression and association in Pakistan, including the partial or complete government-imposed internet shutdowns, which includes, of course, on social media platforms. "We continue to call on Pakistan to respect freedom of expression and restore access to any social media that has been restricted, including Twitter, I think now known as X," the spokesperson added. On irregularities in election process in Pakistan, Matthew Miller said the US wants full investigation into the matter. Mobile internet was suspended on February 8, the polling day after which the country's caretaker government had said that the step was taken as a security measure.



2 killed, 3 missing as cargo ship rams bridge in China

Beijing, Feb 23 (IANS) : Two people were killed and three others went missing after a cargo ship rammed into bridge, leading to collapse of a portion of the structure on Friday morning in Guangzhou in China's Guangdong Province. The incident occurred around 5.30 a.m. when a container ship hit the pier of the Lixinsha Bridge, plunging five vehicles, Xinhua news

agency reported. According to preliminary investigation, of the five vehicles, two plunged into the river and the others fell onto the vessel. A crew member was slightly injured in the accident. Rescue efforts are underway and the cause of the accident is being investigated.

15 killed as mine collapses in Venezuela

Caracas, Feb 23 (IANS) : Fifteen people were killed and 11 others injured after a mine collapsed in La Paragua in Venezuela's Bolivar state. Venezuelan President Nicolas Maduro said search and rescue teams are on the spot to find trapped miners, Xinhua news agency reported.

Nicolas Maduro said: "We immediately dispatched all the civil the rescue phase."

Hasani, who arrived here for the 9th Raisina Dialogue on Wednesday, said that Albania will soon open an embassy in New Delhi.





US makes first lunar landing in over 50 years

Los Angeles, Feb 23 (IANS) : US company Intuitive Machines' first lunar lander has touched down on the moon, marking the first American spacecraft to land on the lunar surface in more than 50 years. The uncrewed lander, named Odysseus, landed at the lunar South Pole on Friday at 6:23 p.m. Eastern Time, according to NASA. Odysseus carries NASA science and other commercial payloads to the moon. The spacecraft was launched on a SpaceX Falcon 9 rocket on Friday last week from NASA's Kennedy Space Center in Florida. The mission, codenamed IM-1, marks Intuitive Machines' first robotic flight to the moon's surface, Xinhua news agency reported.

The scientific objectives of the mission include studies of plumesurface interactions, radio astronomy, and space weather interactions with the lunar surface. It will also demonstrate precision landing technologies and communication and navigation node capabilities, according to NASA. NASA is working with several US companies to deliver science and technology to the lunar surface through the Commercial Lunar Payload Services initiative.

Jay Shah hails Ashwin on becoming first Indian to take 100 Test wickets vs England




Ashwin achieved the feat on day 1 of the fourth Test against England after dismissing Jonny Bairstow lbw in the 22nd over.

CAS dismisses Russia's appeal against suspension by International Olympic Committee

New Delhi, Feb 23 (IANS) : The Court of Arbitration for Sport (CAS) on Friday dismissed the appeal filed by the Russian Olympic Committee against the decision by the International Olympic Committee (IOC) to suspend its membership.

The IOC suspended the Russian Olympic Committee in October last year for breaching the Olympic Charter. The suspension means ROC is no longer entitled to operate as a National Olympic Committee, as defined in the Olympic Charter, and cannot receive any funding from the

Olympic Movement. "The CAS Panel in charge of this matter dismissed the appeal and confirmed the Challenged Decision, finding that the IOC EB did not breach the principles of legality, equality, predictability or proportionality," the CAS statement read.

"The CAS Panel's decision is final and binding except for the parties' right to file an appeal to the Swiss Federal Tribunal within 30 days on limited grounds," it added. The ROC called the suspension "another counterproductive decision with obvious political motivations".
