

TN CPI-M to contest from Madurai, Dindigul LS seats

Chennai, Mar 13 (IANS): In a surprise move Tamil Nadu CPI-M has agreed to contest the upcoming Lok Sabha elections from Madurai and Dindigul instead of its traditional seat in Coimbatore. The INDIA bloc had allocated two seats to CPI-M in Tamil Nadu. The party was keen to contest from Coimbatore and Madurai which is currently represented by its leaders P.R. Natarajan and Su Venkatesan respectively. Makkal Needhi Maiam (MNM) President and Tamil superstar Kamal Haasan also wanted to contest from Coimbatore Lok Sabha seat as part of the INDIA bloc. However, the move was opposed by CPI-M which demanded the Coimbatore seat.

On Wednesday, CPI-M State Secretary K. Balakrishnan signed the alliance deal with DMK President and Tamil Nadu Chief Minister M.K. Stalin.

Opinion of all state BJP leaders taken for K'taka LS candidates: LoP Ashoka

: The BJP Leader of Opposition in the Karnataka Assembly, R. Ashoka, on Wednesday said that the party's high command has taken the opinion of all the state leaders on finalising the candidates for the upcoming Lok Sabha elections.

The final discussion will be held on Wednesday on all the 28 Lok Sabha seats of the state. "I do not know if the announcement of tickets will be at once or in a phased manner. A few of the MPs have announced their retirement, naturally alternative candidates will be selected," he said. "The leaders have discussed the Mysuru-Kodagu seat of MP Pratap Simha and Kawar MP Ananthkumar Hegde. I can't reveal the details of the discussion. There is no need for the sitting MPs to get concerned. Anything can happen till the last minute," Ashoka stated.

When asked about Mysuru former royal scion Yaduveer Wodeyar being considered instead of MP Pratap Simha for

Meanwhile, Pratap Simha's supporters have started a campaign against former CM Yediyurappa and his son B.Y. Vijayendra alleging that they were attempting to finish off Simha. Former minister K.S. Eshwarappa is seeking a ticket for his son for the Haveri Lok Sabha seat. Former minister B.C. Patil has openly stated that the ticket should be given to him otherwise he will take a call. Meanwhile, party sources said that the BJP has decided to give the Mandya LS seat to the JD (S). Sitting Independent MP Sumalatha Ambareesh had already started a campaign expressing confidence that she would get the BJP ticket for the constituency.

Congress MLA Pradeep Eshwar meanwhile stated on Wednesday that former BJP minister K. Sudhakar is indulging in a double game. He is trying to get the ticket for Chikkaballapur seat from the BJP. In case he does not get it, he is trying to contest from Bengaluru North as the Congress candidate. "I know Sudhakar is touching the feet of leaders for this. I advise him to stay put in one party and not indulge in such double games," he added

No EWS quota for 69k assistant teachers: Allahabad HC

Prayagraj (UP), Mar 13 (IANS) : Allahabad High Court has refused to extend the benefit of reservation under the Economically Weaker Section (EWS) category for the recruitment of 69,000 Assistant Teachers held in 2020, as the recruitment process was initiated before the enactment of the Uttar Pradesh Public Services (Reservation for EWS) Act, 2020. The state enacted the Uttar Pradesh Public Services (Reservation for EWS) Act, 2020 (UP Act No. 10 of 2020), published in the gazette on August 31, 2020 for implementation of the reservation for economically weaker sections of the society.

Section 13 of the Act provides that the EWS Act shall not be applicable to selection processes that have been initiated before the commencement of the Act.

All such processes initiated before the commencement of the Act shall be dealt with in accordance with the laws in force before the commencement of the Act. Dismissing a bunch of writ petitions filed by Shivam Pandey and several others, Justice Saurabh Shyam Shamshery observed: "Selection process of appointment of 69,000 posts of Assistant Teachers was commenced from May 16, 2020 i.e. after 103rd Constitutional Amendment but before the enactment of EWS Act i.e. on August 31, 2020.

"Therefore, as per the savings clause (Section 13), provisions of this Act would not be applicable and it would be governed by provisions of law and government order as they stood before the commencement of this Act."



'Big win for human rights': Hindus in Canada, US, UK laud CAA implementation

Calling the government's decision to offer Indian citizenship to persecuted minorities a "big win for human rights", Hindu organisations across the US, the UK, and Canada on Wednesday hailed the announcement of the implementation of the Citizenship Amendment Act (CAA).

"The government's decision to offer Indian citizenship to persecuted minorities from Pakistan, Bangladesh, and Afghanistan is a commendable move... India, as a signatory to the Universal Declaration of Human Rights and various other international conventions, has an obligation to provide asylum to persecuted individuals regardless of their religion," the Hindu Forum Canada said in a statement. The group hoped that "Pakistan and Bangladesh will consider implementing a similar Citizenship Amendment Act to foster brotherhood among Indian nationals". US-based advocacy group, Coalition of Hindus of North America (CoHNA), called the move "a big win for Human Rights for the persecuted religious minorities of Pakistan, Bangladesh and Afghanistan.

SBI PLEA FOR EXTENSION OF DEADLINE ON ELECTORAL BOND DETAILS IS UNSUSTAINABLE

The Supreme Court of India had struck down the electoral bonds scheme as unconstitutional and manifestly arbitrary. That the Modi government would find this verdict unpalatable is not surprising, given the fact that the electoral bonds scheme was devised by it to legitimise political corruption. The government has moved through the State Bank of India (SBI) to undermine the implementation of the judgment. The Supreme Court had directed that all the details of electoral bonds purchased since April 2019 must be made public, including the date of purchase, the name of the buyer and the denomination of the bond. For this, the State Bank of India, which was the sole agency for the transaction of electoral bonds, was asked to submit all the relevant details of the bonds to the Election Commission of India by March 6 and thereupon the Election Commission was to make public all the details by March 13. The SBI has approached the Supreme Court on March 4 asking for more time to submit the details of electoral bond transactions. It has asked for an extension of the time till June 30. This would mean that instead of 21 days given to the SBI by the Supreme Court, the bank now wants another 116 more days to complete the work. In effect, the public will be informed about the details of the electoral bonds only after the Lok Sabha elections are over and a new government is

The request of the SBI has been met with widespread criticism and ridicule. All banking operations of the SBI are digitalised. According to a RTI reply given by the SBI, Rs 60,43,005 was spent on IT system's development for the floating of electoral bonds out of a total cost of Rs 1,50,15,338. If over Rs 60 lakh was spent for developing an IT system for the electoral bonds scheme, how is it that the SBI now claims that certain records of the electoral bonds have been kept manually and in sealed covers at the Mumbai headquarters of the SBI?

When a bond is purchased at a designated branch of the SBI by any person or entity, that would be recorded digitally. When the bearer bond is deposited at any of the other designated SBI branches, for that too there would be a digital record. As early as in 2019, Nitin Sethi writing in the HuffPost India had shown how a bond issued by the SBI carries a secret alphanumeric code, which can be used to keep track of who bought a bond and to which party it has been donated to. Even if some of the records have been kept manually, there is no reason whatsoever to believe that accounting for 22,217 electoral bonds cannot be done in a space of 21 days. All that the SBI needed to do was to put additional personnel for the job. It is, therefore, crystal clear that the SBI has come out with a lame excuse and spurious reasons which amount to insulting the intelligence of the Supreme Court. The ulterior intent is also evident from the fact that the SBI filed its petition in the court just a day before March 6, so that missing the deadline becomes a fait accompli. The Modi government and the ruling BJP have every reason to try and scuttle the publication of the details of the electoral bonds so far issued and redeemed. As the court itself pointed out, the scheme was so devised as to facilitate a quid pro quo. Once the break-up of Rs 6,565 crore worth of bonds received by the BJP is known, then it can be correlated to which company or individual capitalist had donated the bond and what policy or favour was given as a quid pro quo.

There is another angle which will be exposed by the publishing of the details of the electoral bonds received by the BJP. A study conducted recently by the Newslaundry and The News Minute of corporate donations received by the BJP (not through electoral bonds) shows that there are at least 30 companies, which donated a total of nearly Rs 335 crore to the BJP in the five previous financial years, had faced action by central agencies during the same period.

BOLIVIA'S RULING LEFTWING MOVEMENT VERTICALLY SPLIT BEFORE PREZ ELECTIONS IN 2025

olivia which elected the Left wing President Luis Arce in 2020 giving a big boost to the Left and progressive forces in Latin America, is facing a split in its political leadership with the present president fighting the former president and Arce's mentor Evo Morales. Since the Movement Toward Socialism (MAS) returned to power under Luis Arce in 2020, ex-president Evo Morales has been honing his support base with the hope of returning as president. But in December last year, Bolivia's Plurinational Constitutional Court ruled that presidents can only hold power for a maximum of two terms and

that indefinite reelection "is not a human right." The ruling dealt a catastrophic blow to the presidential ambitions of the thrice-elected Morales.

Morales has since accused Arce, his former economy minister and close ally, of orchestrating an attempt to outlaw him from holding office, declaring on X, formerly Twitter, that a "judicial coup" is underway.

To force elections for a new judiciary, which should have been held in December in accordance with the plurinational constitution, in late January Morales mobilized his base in the coca-growing heartland of Cochabamba to form roadblocks, along the roads con-

necting Cochabamba with the business hub of Santa Cruz. The blockades, combining demands for judicial elections with other local grievances, have caused food and fuel shortages and have been suppressed by security forces. Huáscar Salazar, an economist and a member of the Centro de Estudios Populares in Bolivia says there is little hope of conciliation between the two camps. "What we are experiencing at this moment is that arm-twist, in which Evo and Arce dispute the acronym of the Movement Toward Socialism and, especially, the candidacy for the presidency of that party for 2025."

BJP-BJD ALLIANCE IN ODISHA CAN SHIELD BJP FROM POSSIBLE LOSS IN LOK SABHA POLLS

Odisha is in advanced state. "There were discussions on the alliance among other issues," said BJP MP Jual Oram, adding "the party's central leadership will make the final call." Obviously, there is greater possibility of pre-poll alliance between the two parties, and if it becomes a reality, BJP may hope for shielding its possible loss from Odisha in the Lok Sabha election 2024, especially those seats which it had won by a very thin margin in 2019. BJP wants to "prioritise the greater interests of the people of Odisha" as BJD's Vice President Debi Prasad Mishra told reporters. For Congress, it is indeed a bad news, though it has only one Lok Sabha seat and 9 Vidhan Sabha seats at stake. In National Politics, BJD has always sided with the BJP even without alliance, but BJP's deft move for pre-poll alliance with BJD, would rule out any

Talks for BJP-BJD alliance in Odisha is in advanced state. INDIA Bloc o any collaboration in future.

In the last 15 years, Odisha politics has undergone a significant change, especially after 2009 when BJP-BJD alliance broke after 11 years of partnership. During this period, the BJP has emerged as chief opposition in the state, while BJD led by Navin Patnaik remained the most popular political leader. Congress has been relegated to the third position, which is evident from the results of the Lok Sabha and Vidhan Sabha elections simultaneously held in 2019.

The state sends 21 Lok Sabha members. BJD had won 12 seats, while BJP had won 8, and only 1 seat went to Congress. Barring only two seats—Koraput and Nabarangpur — Congress was not in one-on-one contest. Congress lost Nabarangpur seat to BJD by a margin of 41,634 votes, while it won Koraput defeating BJD by a



very thin margin of 3,613. In as many as 19 seats BJP and BJD were in contests. The result shows that even after a pro-BJP Hindutva wave after Pulwama attack, BJP could win only 8 seats, out of which it won 6 seats with a very thin margin – Sambalpur by a margin of 9,162 votes; Mayurbhanj by a margin of 25,256 votes; Balasore by a margin of 12,956 votes; Bolangir by a margin of 19,516 votes; Kalahandi by a margin of 26,814 votes; and Bhubaneswar by a margin of

23,839 votes. This time, when there is no wave in favour of BJP, the party is running a risk of losing these to BJD. This is the real cause behind BJP's move to realign with BJD. When PM Narendra Modi and the BJP are seeking for their third term, they can't afford to lose any of the Lok Sabah seats it had won in 2019. BJP not only trying to secure and or retain all the 8 Lok Sabhas seats it has at present, but also trying to increase its national tally.



Rome, Mar 13 (IANS): Three multilateral food and aid agencies, together with Italy, have unveiled a "Food for Gaza" initiative aimed at coordinating international humanitarian efforts. The initiative is made to increase food and health aid in Gaza in the short term, and then to focus -- in the long term -- on the human and social reconstruction of Gaza, according to Antonio Tajani, Italy's Deputy Prime Minister and Minister of Foreign Affairs, on Wednesday. Qu Dongyu, Director-General of the United Nations Food and Agriculture Organisation; Cindy McCain, executive director of the World Food Program; and Deputy Secretary General of the International Federation of Red Cross and Red Crescent Societies Xavier Castellanos were present at the event held at the headquarters of the Italian Ministry of Foreign Affairs, Xinhua news agency reported.

"This is a program whose objective is to coordinate the activities of these important institutions," Tajani said. "Together we want to focus on

projects and the creation of a humanitarian aid corridor." Tajani added the corridor will start from the Mediterranean island nation of Cyprus, noting that current efforts to bring aid to the citizens of Gaza via airlifts are "proving to be inadequate".



South Korea providing consular assistance to its national arrested in Russia

Seoul, Mar 13 (IANS): South Korean foreign ministry on Wednesday said it has been providing consular assistance to its national arrested in Russia reportedly on

espionage charges. Russia's TASS news agency reported Monday that South Korean citizen Baek Wonsoon has been held in the Lefortovo detention facility in Moscow since late February. and a court extended his detention until June 15, citing a law enforcement official, Yonhap news agency reported. Baek was arrested by Russian law enforcement earlier this year in the Russian Far East city of Vladivostok and transferred to Moscow for further investigation, according to the news report. TASS cited a law enforcement source as saying that Baek was handing over classified information to foreign intelligence agencies. South Korea's foreign ministry confirmed the arrest.

"Upon learning of the arrest, the local diplomatic mission has been providing necessary consular assistance," the ministry said. It declined to give further details, citing an ongoing investigation.

It marks the first time a South Korean has been arrested in Russia on spying charges.

Baek, a missionary with a South Korean humanitarian foundation, was working in Vladivostok at the time of the arrest, mostly engaged in helping North Korean defectors flee and providing them with other assistance, people with knowledge of the matter told Yonhap. The Russian authorities had arrested Baek's wife as well but later released her. She is currently in South Korea.

Five killed after school bus collides with semi-truck in US

Washington, Mar 13 (IANS): Five people, including three children, were killed after a school bus collided with a semi-truck on a highway in Rushville, about 91 km northwest of the US Illinois state capital, Springfield.

Addressing a press briefing, Illinois State Police said the crash happened on Wednesday around 11:30 a.m. (1730 GMT) when the school bus heading east on US Route 24 crossed the center line into the westbound lanes for an "unknown reason" and collided with the semitruck carrying sand, Xinhua news agency reported. Both vehicles erupted into flames after the collision. All four people aboard the school bus, including the driver and three children -- one five years old and two three years old -- as well as the driver of the semitruck were pronounced dead at the scene.

Following the incident, the school district canceled school on Tuesday and Wednesday.





US sanctions against country caused \$700 bn GDP loss: Venezuelan VP

Caracas, Mar 13 (IANS): Venezuelan Vice President Delcy Rodriguez has said the US sanctions against the country have caused losses of nearly \$700 billion in GDP. At an international seminar in the Bolivian city of Santa Cruz de la Sierra on Wednesday, the Vice President said Venezuela's oil industry sustained losses of almost 232 billion dollars due to the sanctions, which have in addition frozen more than 22 billion dollars Venezuelan assets in international banks, Xinhua news agency reported. The US, she said, has failed to comply with the lifting of sanctions as established in the Barbados Agreement reached between the government and Venezuelan opposition parties in October 2023. The agreement brought a relief, known as General License 44, from the US on Venezuelan President Nicolas Maduro's government in October 2023, but the Joe Biden administration reimposed sanctions on Venezuela in January, saying the move was in response to Maduro's decision to ban a leading opposition candidate from running for president. In view of US unilateral policies, Latin America "essentially" needs a new financial architecture, Rodriguez said. "If we want to think about a new financial architecture, we must carry out trade in our own currencies," said the Venezuelan vice president.

Yemen's Houthis launch new attack on Red Sea cargo vessel

Sanaa, Mar 13 (IANS): Yemen's Houthi reported. Also on Wednesday, movement has launched a missile strike in the Red Sea against a vessel identified as the US ship Pinocchio, said the group's military spokesman, Yahya Sarea, on Wednesday.

The statement, disseminated via the Houthi-run al-Masirah TV, claimed the strike was precise.

Sarea also said that the Houthis plan to intensify their attacks during Ramzan in solidarity with Palestinians in Gaza, Xinhua news agency reported.

The UK Maritime Trade Operations announced an incident concerning the Liberian-flagged container vessel Pinocchio, which took place 71 nautical miles southwest of Hodeidah, a port under Houthi control, on Monday.

Meanwhile, AIUDF chief Badruddin Ajmal has fielded a strong candidate in Nagaon, fuelling the chances of a potential vote division between the opposition parties. Congress has also dropped sitting Barpeta MP Abdul Khaleque and fielded Deep Bayan instead. It has also pitted former Assam minister and MLA Rockybul Hussin in Dhubri against Badruddin Ajmal.

Meanwhile, two seats - Dibrugarh and Lakhimpur - were left by Congress for its allies. Lurinjyoti Gogoi, a former General Secretary of the All Assam Students' Union (AASU) may fight from Dibrugarh on behalf of the INDIA bloc while it is not clear who will contest from Lakhimpur. The BJP has earlier announced that Union Minister Sarbananda Sonowal will fight polls from the Dibrugarh seat and he had already started campaigning.

If Lurijyoti Gogoi fights against Sonowal, it may become an interesting contest.

This is Assam's first election since the Election Commission conducted a delimitation process only



for the state last year, which the opposition parties fiercely criticised, claiming it was done to benefit the ruling BJP.

Capex has emerged as a key growth driver in India: Morgan Stanley

New Delhi, Mar 13 (IANS): A F2008, which was close to the decade after steadily decline in investment to GDP, capex has emerged as a key growth driver in India, global brokerage, Morgan Stanley said.

"We think the capex cycle has more room to run, therefore the current expansion closely resembles that of 2003-07," it added.

The most important feature of this expansion is that investment ratios are picking up after an 11-year decline, Morgan Stanley said.

"We see a long runway ahead for the current expansion cycle and remain constructive," it said.

The defining characteristic of the current expansion is the rise in the investment to GDP ratio. Similarly, in the 2003-07 cycle investment to GDP rose from 27 per cent in F2003 (fiscal year ending March 2003) to 39 per cent in

peak. Investment to GDP then hovered around those levels until it peaked in F2011. 2011 to 2021 then registered a decade of decline - but the ratio has now inflected again to 34 per cent of GDP and we expect it to rise further to 36 per cent of GDP in F2027E, Morgan Stanley said. In 2003-07, the capex boom led to acceleration in productivity, job creation and income growth. As more labour was absorbed into employment by the strengthening economy, savings to GDP also rose from 28 per cent in F2003 to 39 per cent in F2008. Against this backdrop, we saw strong growth outcomes yet very few concerns on the macro stability front. During 2003-07, GDP growth averaged 8.6 per cent and headline CPI inflation averaged 4.8 per cent.



Odisha govt hikes remuneration, allowances of Panchayati Raj representatives

Bhubaneswar, Mar 13 has enhanced the remunera-(IANS): Odisha Chief Minister Naveen Patnaik on Wednesday increased the remuneration and allowances paid to the representatives in the three-tier Panchayati Raj system in the state. For Zilla Parishads in the state, the monthly remuneration of presidents has been enhanced to Rs 30,000 from the existing Rs 9,380. Vice presidents, who are currently getting Rs 7,040, will now get Rs 20,000 per month. Members will get Rs 10,000 in place of Rs 3,530. The Daily Allowances (DA) and Sitting Fee (SF) charges of the representatives have also been doubled to Rs 600 per month from the existing Rs 300, the Chief Minister's office said in a statement. For Panchayat Samitis, the state government

The representatives will get financial assistance of Rs 2 lakhs in case of permanent disability (irrecoverable loss of eyes, hands and feet) and Rs 1 lakh in case of partial physical disability (irrecoverable loss of one eye, one hand or one leg) due to any accident while in office.

New Delhi, Mar 13 (IANS): Ministry spokesperson, Randhir Jaiswal, said in a statement released on Wednesday. Asserting that objecting to such visits or India's developmental projects does not stand to reason, Jaiswal said: "It will not change the reality that the State of Arunachal Pradesh was, is, and will always be an integral and inalienable part of India". The Spokesperson further added that the Chinese side has been made aware of "this consistent position on several occasions".

Infighting in TMC in Bengal's Murshidabad dist over Yusufs Pathan's nomination

Kolkata, Mar 13 (IANS): Infighting in Trinamool Congress, especially in Murshidabad district of West Bengal, has started brewing over party's decision to nominate former Indian cricketer Yusuf Pathan as its candidate from Baharampur Lok Sabha constituency.

Trinamool Congress MLA from Bharatpur assembly constituency in Murshidabad district, Humayun Kabir, has become most vocal on the issue. According to him, the party leadership has announced Pathan's name without any prior discussion with the district leadership of Trinamool Congress. "At least, the district leadership could have been intimated in advance about the party's decision to field Pathan from Baharampur. I am not accepting it. Let the election dates be announced and you will see

my next course of action. I will ensure voting against him," Kabir said. However, he ruled out the possibility of joining any rival political party. "If necessary, I will float my own political outfit," said Kabir. This is not the first time that Kabir raised his voice against party leadership on such issues

In September last year, Kabir accused the party leadership of indulging in ensuring tickets to candidates paying money in the panchayat polls in the state. Since the candidate list was announced on Wednesday afternoon, rumblings of discontent had started brewing in Trinamool Congress over the choice of candidates. On Monday, party state general secretary and actress-turned-politician Sayantika Banerjee tendered her resignation from the party post.

Delhi HC grants parole for convict to arrange fine payment, re-establish social ties New Delhi, Mar 13 (IANS)

: The Delhi High Court has allowed a man, Harish Yadav, convicted under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, three weeks of parole. The order by Justice Anoop Kumar Mendiratta allowed Yadav to gather funds to pay a fine associated with his sentence and to reconnect with his family.

Despite nearly completing his 10-year sentence, Yadav faced an additional six months of imprisonment for not paying the required fine. His parole request had been previously rejected due to the generic nature of his appeal under Rule 1211 of the Delhi Prison Rules, 2018, which did not state exceptional circumstances for relief.

However, Justice Mendiratta recognised sufficient reasons for granting parole, especially considering Yadav's near completion of his sentence, satisfactory jail conduct, and non-misuse of emergency parole in 2021.

The court mandated a personal bond of Rs 25,000 for Yadav's release.





MVA wrangles over 10 seats, claims Prakash Ambedkar; hints at going solo

Mumbai, Mar 13 (IANS): Signalling that all is not well in the opposition Maha Vikas Aghadi (MVA), Vanchit Bahujan Aghadi (VBA) President Prakash Ambedkar claimed that the alliance members are still engaged in a tug-of-war over at least 10 of the 48 Lok Sabha seats in Maharashtra, here on Wednesday

Rubbishing the statements by MVA constituent Shiv Sena (UBT) MP Sanjay Raut's that the seat-sharing has almost been finalised amicably, Ambedkar accused him of 'misleading' the media.

"They have yet to reach an understanding on around 10 seats. Sanjay Raut is giving out wrong information on this issue. Everybody is concerned about the delay... The squabble is between the Congress and SS-UBT," Ambedkar contended.

Taking umbrage, Raut shot back

asking Ambedkar to prove what he was 'lying' about, adding that the MVA is in touch directly with Ambedkar on the issue.

The SS-UBT is reportedly firm on contesting 18 seats, while the Congress is eyeing 20 seats, barely leaving room for manoeuvre for the other allies including the Nationalist Congress Party (SP) or VBA.

Ambedkar also expressed doubts over the national opposition I.N.D.I.A. bloc's ability to keep regional parties together and referred to All India Trinamool Congress President and West Bengal Chief Minister Mamata Banerjee unilaterally putting up candidates in all 42 LS seats there.

Ambedkar -- whose VBA has allied with the SS-UBT -- again dropped hints at going solo in case the MVA fails to reach an acceptable seat-sharing agreement with all the allies on priority.

Interestingly, the VBA chief's

statements came just hours before Congress MP Rahul Gandhi's Bharat Jodo Nyay Yatra enters Maharashtra at Nandurbar this afternoon on its final lap which will end at Chaityabhoomi in Mumbai, followed by an I.N.D.I.A. bloc mega-rally on March 17.

Ambedkar added that on March 10, he wrote to Congress President Mallikarjun Kharge highlighting his conversation with AICC General Secretary Ramesh Chennithala. Since there was no progress in the seat-sharing discussions in the MVA, Ambedkar said he spoke with Chennithala on March 9 extensively.

"Chennithala shared his concern about Shiv Sena (UBT) being adamant on at least 18 seats. I proposed that VBA and Congress should sit together and have a discussion on all those seats which Congress has in mind and demanded in the MVA.



Dalit youth in K'taka hacks girl's father to death for causing their separation

Bagalkot, (Karnataka) Mar 13 (IANS): A shocking incident of a young man hacking his girlfriend's father to death with a machete for causing their separation was reported from Bhagavathi Village in Bagalkot District of Karnataka on Wednesday. A Dalit youth, Praveen Kamble was in a relationship with the daughter of 52-year-old Sanganagouda Patil, who belonged to an upper caste. However, Sanganagouda Patil was not in favour of the alliance and had warned Praveen Kamble to stay away from his daughter.

Web portal for citizenship seekers launched, 'CAA-2019' mobile App to come soon

New Delhi, Mar 13 (IANS): The Ministry of Home Affairs (MHA) on Wednesday launched a web portal for facilitating the registration of people, seeking citizenship under the Citizenship Amendment Act (CAA), 2019. The MHA informed on X, that a mobile app called CAA-2019 will also be launched soon to expedite the applications by non-Muslim migrants seeking Indian citizenship.

The web portal and mobile app for seeking citizenship under CAA will not only simplify the procedure but also enable non-Muslim migrants to apply for the same, via their mobile phones.

The migrants, who escaped Pakistan, Bangladesh and Afghanistan to India be-



fore 2015, can apply under the scheme. They will have to first register themselves on the web portal and mobile App and create individual logins, before filling applications for the same.

Notably, the Centre on Monday no-

tified the rules for CAA implementation and also released the application formats which could be filled by migrants for getting Indian citizenship.

The law granting citizenship to refugees pertaining to six religions other than Muslims was cleared by Parliament in 2019.

Translator's post could not be filled in LS due to dearth of qualified talent: Goa CM

Panaji, Mar 13 (IANS): Goa Chief Minister Pramod Sawant on Wednesday said that there is a dearth of translators in the coastal state and hence the government could not fill the post of 'translator' in Lok Sabha despite it being a highly paid job.

"Many learn Konkani (the official language) and yes one should learn it. But we don't have a single translator who can translate from English, Hindi to Konkani or vice versa. We want translators who can do this job," Sawant said was speaking after inau-

gurating a girls' hostel of a government college in Sanquelim, North Goa.

"I have a question when students pursue BA, MA and PhD in Konkani language, why don't we find translators? We wanted a translator in Lok Sabha, but we could not get a single person for that job. I feel sad over the issue," Sawant said. Sawant said that students while pursuing education in such streams should acquire a caliber of translation.

"We should not pursue education only for the sake of degrees, but it should be brought into practical use. Degrees will not resolve such



problems," he said.

He said that teachers should take the initiative to help their students build their careers. "If this thing happens then there will be no unemployment. Everyone can get employment," he said.

He said that students should take advantage of the 'Dual degree or certificate course' introduced by the government, wherein one can study any course while pursuing traditional education. "Traditional education like BA, B.Com B.Sc... we should not be limited only to that, but along with that we should pursue career-oriented education," Sawant said

Investigation underway in farmers violence in Haveri: K'taka Home Minister

Bengaluru, Mar 13 (IANS): Karnataka Home Minister G. Parameshwara on Wednesday said that an investigation is underway to find out who triggered the violence in Haveri after prices of the famous Byadgi chilli crop came crashing down at the Byadgi APMC market.

He said that the farmers from Andhra Pradesh also come to Byadgi market. "Six to seven vehicles have been torched by the farmers. We do not know why the prices crashed suddenly. The Chief Minister Sidddaramaiah has asked for an investigation into the sudden crash of prices," he stated.





Nine killed, two injured as building collapses in Pakistan

Islamabad, Mar 13 (IANS): At least nine people were killed and two others injured on Wednesday when a three-storey building collapsed in Pakistan's Multan city. The incident took place around 3.30 a.m. at Multan's Mohalla Jawadian after which teams were sent to the spot, Rescue 1122's District Emergency Officer Kaleem Ullah was quoted as saying by Geo News.

Confirming the death toll, the official said that out of the 11 trapped under the debris, nine lost their lives.

The two injured were rushed to Nishtar hospital and their condition is stated to be critical. The deceased included seven members of a family.

Congress worker killed, hanged from a tree in K'taka



Gadag (Karnataka), Mar 13 (IANS): An incident of a Congress worker being killed and hanged from a tree by some miscreants came to light on Wednesday near Dambala village in Mundaragi taluk of Gadag district in Karnataka. The deceased was identified as Sharanappa Sandigoudra, a local Congress leader from Doni village.

More Australians in favour of becoming independent middle power than US ally

Canberra, Mar 13 (IANS) : More Australians believe the nation should aim to become an independent middle power than primarily an ally of the US, a poll has found. Published by the online Australian edition of British newspaper 'The Guardian' on Wednesday, the poll found that 38 per cent of Austra-

lians said the country's role in global affairs should be as an independent middle power, Xinhua news agency reported. Twentyfive per cent said the nation should do its best not to engage in world affairs and 17 per cent were unsure. The poll found that 63 per cent of Australians described themselves as concerned about Israel's military action in Gaza.

Thirty-seven per cent of Australians said Israel should withdraw permanently from military action in Gaza, twice as many than 18 per cent who supported it continuing. Two thirds of participants in the poll said they believed the world is either very or somewhat divided and 10 per cent described it as united. Sixty-eight per cent agreed that global instability



makes trade more expensive and 57 per cent said it would undermine efforts to solve problems including climate change.

UN chief calls for action as women's rights face backsliding, violence

United Nations, Mar 13 (IANS): UN Secretary-General Antonio Guterres has stressed the critical urgency of protecting women's rights, now endangered by regressing achievements, escalating violence, and a widening digital gender divide.

Addressing the opening of the Commission on the Status of Women (CSW), the pivotal forum dedicated to promoting and safeguarding the rights of women and girls worldwide, the UN chief on Wednesday stressed the disproportionate impact of wars on women. "In conflict zones around the globe, women and girls are suffering most from wars waged by men," he said, urging immediate ceasefires and humanitarian aid, Xinhua news agency reported. He highlighted the dire circumstances in Gaza, where reportedly more than two-thirds of casualties and injuries during Israel's military actions involve women and girls, and pointed out alarming reports of sexual violence against Palestinian house raids, and checkpoints in the Occupied Palestinian Territories. Guterres also voiced concern over the situation faced by women in other countries, including Afghanistan and Sudan.

The Secretary-General stressed that despite evidence that women's participation makes peacebuilding much more effective, the number of women in decision-making roles is falling.

"The facts are clear: Women lead to peace," he said, calling for more funding and new policies to boost women's participation and investment in women peacebuilders.

The UN Chief also emphasised a growing digital gender divide, noting the dominance of men in digital technologies, particularly in artificial intelligence.

He cautioned that algorithms controlled by men might embed disparities across multiple life facets, observing that the design of systems by male leaders and technologists frequently neglects women's needs, bodies, and essential rights. "It's time for governments, civil society and the Silicon Valleys of the world to join a massive effort to bridge the digital gender divide and ensure



roles in digital technology at all levels," he urged. Guterres also drew attention to the pressing need for women to hold leadership roles, particularly in financial institutions. He highlighted the stark gender disparity in finance, with more than eight of ten Finance Ministers and more than nine out of ten central bank governors being men. The top UN official emphasised that dismantling structural barriers is crucial for achieving gender parity in leadership roles. "Overwhelmingly male-dominated financial institutions need to dismantle the structural barriers that are blocking women from leadership roles," he said. Drawing parallels with the UN's successful achievement of full gender parity among senior management and leaders worldwide, he urged governments, women during detentions, women have decision-making banks and businesses to replicate opment Goals (SDGs).

In concluding his speech, the Secretary-General called on the global community to rally together for gender equality, highlighting the role of the CSW as a driving force for transformative change. He advocated for joint actions to eradicate poverty in all its forms. PMLA case: ED raids 27 premises linked to Lalu's aide Amit Katyal in Delhi-NCR

New Delhi, Mar 13 (IANS): The Enforcement Directorate (ED) on Wednesday conducted raids at several locations in Delhi-NCR on Wednesday as part of an investigation into money laundering case involving a real estate and alcohol conglomerate associated with Amit Katyal. Katyal, who is purportedly a close associate of RJD leader Lalu Prasad's family and named in the land-for-job scam case along with some companies, was arrested by the central agency last year.

"The raids targeted a total of 27 premises belonging to Haryanabased Krishna Buildtech Pvt Ltd in Delhi, Gurugram, and Sonipat, under the provisions of the Prevention of Money Laundering Act (PMLA)," said the sources. In another case, Katyal has been accused by the agencies of acquiring several lands from aspirants on behalf of the Rashtriya Janata Dal (RJD) Chief and former Railways Minister Lalu Prasad Yadav.



IUML moves SC seeking stay on Citizenship Amendment Rules

New Delhi, Mar 13 (IANS): case, CAA is held to be un-Indian Union Muslim League (IUML) has moved an application before the Supreme Court seeking a stay on the implementation of the rules notified by the Union Home Ministry under the Citizenship Amendment Act (CAA). In its application, IUML said that the Citizenship Amendment Rules, 2024 are manifestly arbitrary and create an unfair advantage in favour of a class of persons on the ground solely of their religious identity, which is impermissible under Articles 14 and 15 of the Constitution.

It added that around 250 petitions challenging the provisions of the CAA are pending before the apex court and in

constitutional, an "anomalous situation" would arise when people who would have got citizenship under the impugned Act and Rules would have to be stripped of their citizenship.

"Therefore, it is in the best interest of every person to defer the implementation of CAA and impugned rules till this Hon'ble Court finally decides the matter...The Petitioner had pressed for a stay of the implementation of the provisions of the impugned act. However, the Union of India had told this Hon'ble Court that the rules have not been framed and therefore the implementation will not take place.





Women make a foray in Lucknow's liquor business

Lucknow, Mar 13 (IANS): In a surprise development, as many as 370 out of 1,046 liquor shops in Lucknow have been allotted to women entrepreneurs in the new fiscal year.

From April 1, the women shop owners will take over the reins of more than onethird of the business which has been predominantly dominated by men in the past. Officials said that overall participation of women has increased by 7 per cent compared to the previous year in Lucknow and more shops have been taken over by women this time.

Though no special incentives or relaxations are offered to the women, the upwards trend shows that women are no more hesitant to participate in the alcohol trade.

South Korean minister concerned over SNU medical professors' resignation decision



Seoul, Mar 13 (IANS): South Korean Health Minister Cho Kyoo-hong on Wednesday expressed deep concerns over a decision by medical professors to resign unless there is a breakthrough in a prolonged walkout by trainee doctors, saying that such a collective action would pose a threat to the safety of patients.

On Wednesday, medical school professors at Seoul National University (SNU) resolved to submit resignations en masse next week if the government fails to present "a reasonable breakthrough" in the prolonged walkout, Yonhap news agency reported.

"The decision threatens the lives and health of patients, which is a source of grave concern. Another mass resignation will put the lives of the patients at risk and will not be able to win the public's understanding," Cho Kyoo-hong said during a meeting of the Central Disaster and Safety Countermeasures Headquarters.

More than 90 per cent of the country's 13,000 trainee doctors walked off the job in the form of mass resignations more than three weeks ago to protest the government's decision to increase enrollment at medical schools by 2,000 spots starting next year to

address a shortage of doctors.

The current quota is 3,058. "The resignation decision threatens the lives and health of patients, which is a source of grave concern. Another mass resignation will put the lives of the patients at risk and will not be able to win the public's understanding," Cho Kyoo-hong said.

Medical school professors have warned of action if the government fails to come forward for dialogue without conditions.

"We will hold the government responsible if the ongoing situation will cause damage to trainee doctors and medical school students," an association of medical school professors said in a statement.

"Voluntary resignation by professors will grow further, which will lead to the collapse of the country's health care system and medical education."

Medical professors of the Catholic University of Korea also threatened to further suspend surgeries and cut back on treatments for both inpatients and outpatients.

Ashwin reclaims pole position in ICC Test bowling rankings

: Veteran India off-spinner Ravichandran Ashwin is back at the top position in the ICC Men's Test Bowling Rankings after finishing with a ninewicket match haul in his 100th Test match, which happened in Dharamsala.

Ashwin returned hauls of 4-51 and 5-77 against England as India won by an innings and 64 runs in the fifth and final Test to complete a 4-1 series win, which also puts them in the top position of the ongoing ICC World Test Championship table.
