
officials should perform their election duties honestly and impartially in the upcoming Parliament elections.

The announcement, made via a social media post by the former president of the Gujarat Congress, is a strategic choice to focus on his responsibilities as the AICC in-charge for Jammu & Damp; Kashmir and spearhead the party's campaign efforts in Gujarat. Solanki, 70, has contributed to the party during his tenure as Gujarat Congress president. How-

Gandhinagar, Mar 14 ever, following successive defeats in the 2014 and 2019 Lok Sabha elections, Solanki has chosen to step aside. He affirms his dedication to the party by stating, "I will accept and obey whatever decision is made by the Central leadership." Jagdish Thakor, another seasoned Gujarat Congress figure, echoed this sentiment of withdrawal from electoral contention.

> Through a video post, Thakor articulated his decision to forgo participation in the Lok Sabha election, attributing his decision to a blend of personal reflections and health concerns, alongside a commitment to Rahul Gandhi's vision for invigorating the party with new faces.

> Thakor's decision is grounded in his extensive political journey with the Congress. He has served as a two-time MLAgress, Gujarat Pradesh Congress Committee, among other roles.



Court in UP's Hapur sentences ten to life terms in mob lynching case

Hapur (UP), Mar 14 (IANS) A court in UP's Hapur district on Thursday convicted all ten persons accused in the 2018 mob lynching case and sentenced them to life imprisonment. The court of Additional District Judge Shweta Dixit, after hearing both parties, convicted 10 people of killing 45-year-old Qasim and assaulting Samaideen, 62, on a false rumour of cow slaughter. Government counsel Vijay Chauhan said that the court has also imposed a fine of Rs 58,000 each on the accused -- Rakesh, Hari Om, Yudhishthir, Rinku, Karanpal, Manish, Lalit, Sonu, Kaptan, and Mange Ram of Bajhaida village.

SCBA President urges President Murmu to seek presidential reference of SC judgement in Electoral Bonds case

New Delhi, Mar 14 (IANS) : Senior advocate and Supreme Court Bar Association (SCBA) President Adish C. Aggarwala on Thursday urged President Droupadi Murmu to seek a presidential reference of the Constitution Bench judgement in the Electoral Bonds case. In his letter written on the letterhead of the All India Bar Association, Aggarwala said that revealing the names of corporates would render them vulnerable to victimis ation by those parties which had received less contribution from them and would have a chilling effect on corporate donations and participation in the democratic process. "Besides drying up further donations, such an act



(of disclosing names of corporates and their quantum of contributions to various parties) would discourage and dissuade foreign corporate entities from setting shops in India or participating in the democratic process but contributing to winning horses," he said in the letter to President Murmu.



Arrah district court issues summon to Udhayanidhi Stalin

Patna, Mar 14 (IANS): The district court of Arrah has issued a summon to Udhayanidhi Stalin in connection with his comparison of Sanatan Dharma with dengue, malaria and corona. A hearing in this regard was held in the court of chief judicial magistrate Manoranjan Kumar Jha. The court considered that the statement of Stalin has hurt the sentiment of a section of people who believe in Sanatan Dharma.

J&K cop suspended after murder of Jammu gangster

Jammu, Mar 14 (IANS): A J&K Police Sub-Inspector was suspended on Thursday after a gangster was killed by another gang in neighbouring Punjab, officials said. 'Historysheeter' and gangster Rajesh Dogra, originally from Reasi district and presently living in Jammu, was murdered in broad daylight in the Mohali area of Punjab on March 4. SSP Jammu, Vinod Kumar has placed Sub-Inspector, Mushtaq Ahmad, posted at Sarwalpolice post, under suspension for alleged negligence for his inability to keep a watch on the gangster.

Coast Guard seizes Pak boat with Rs 480 crore drugs off Gujarat coast; six held

New Delhi, Mar 14 (IANS) : In an overnight joint operation on the intervening night, the Indian Coast Guard (ICG) apprehended a Pakistani boat off the coast of Porbandar, Gujarat, with six crew members and narcotics valued at around Rs 480 crore on board.

The boat was apprehended about 350 km from Porbandar in the Arabian Sea in a sea-air coordinated operation involving ICG ships and Dornier Aircraft. The operation exhibited well-coordinated efforts between the ICG, NCB, and ATS Gujarat. The ICG said that on specific intelligence inputs from the security agencies, the ICG strategically positioned its ships in the Arabian Sea on Thursday.

BJP-TDP-JSP ALLIANCE TO MAKE ANDHRA PRADESH POLLS COMPETITIVE

haratiya Janata Party (BJP) and the Telugu Desam Party (TDP) have agreed in principle for an alliance on the eve of Lok Sabha and Vidhan Sabha election 2024 in Andhra Pradesh. Both the BJP and the TDP are in urgent need to ally to protect their political interests at the national and state level respectively, and hence there is every possibility of their proposed alliance becoming a reality.

BJP hopes to win two seats by this arrangement in the forthcoming Lok Sabha election from the state, in addition to its expectation that TDP may prove to be an asset for achieving the NDA's target to 400+, in addition to finding an opening in the state election again. For TDP, it's a question of re-establishing its political clout in the state again and overcome the political dominance of YSR Congress Party (YSRCP) led by YS Jagan Mohan Reddy. Even though, one cannot say with certainty which party could gain how much since considerable size of BJP rank and file consider Chandrababu Naidu as a "traitor" for BJP, and very large number of TDP leaders and workers believe that BJP ultimately ditched them by not conceding their demand of giving special status to Andhra Pradesh leading their loss of power in

Actor-turned-politician Pawan Kalyan is playing a key role between the two, since his political outfit Jana Sena Party (JSP) is already an ally of BJP in NDA and an ally of TDP in Andhra Pradesh. In 2014 elections, BJP-TDP-JSP alliance won 103 Vidhan Sabha seats out of 175 in the state, after carving out Telangana from Andhra Pradesh as separate state. This bifurcation had also reduced the Parliamentary seats of Andhra Pradesh from 42 to 25, while 17 seats went with Telangana. Chief Minister Chandrababu Naidu demanded special status for Andhra Pradesh which Modi government refused to grant, which led to split in NDA, and TDP parted ways from BJP in 2018. The political development thereafter has compelled TDP to seek re-alliance after six years. However, electoral outcome will depend much on how they go ahead and finalise seat sharing among themselves, both for Lok Sabha and Vidhan Sabha elections 2024.

YSRCP emerged as dominant force in both the Lok Sabha and Vidhan Sabha elections held in 2019. In Lok Sabha election YSRCP was able to win 22 seats out of 25. The ruling TDP in the State could win only 3 seats. YSRCP had gained 14 Lok Sabha seats compared to 2014, while TDP lost 12. In terms of vote share, YSRCP bagged 49.15 per cent of votes with a 20.25 per cent of swing in its favour. TDP suffered 11.49 per cent of swing against it, and could achieve a vote share of 39.59 per cent. JSP's vote share was 7 per cent, while BJP could reach a vote share to only 0.96 per cent, after a swing of 7.54 per cent against it. BJP lost its 2 seats in 2019 that it had won in 2014 Lok Sabha election.

The result of the Lok Sabha election was a clear indication that both the BJP and TDP suffered great loss in terms of seats and vote share when the contested the election separately. Therefore, alliance between the two was imperative. The additional personal reason for Chandrababu Naidu is his recent arrest in corruption case, which he alleges was nothing but personal vendetta of the CM YS Jagan Mohan Reddy. TDP leader is therefore very keen to comeback to power again. JSP leader Pawan Kalyan also knows that his party has little support base, and he can't hope for gain without an alliance.

It should be noted that BJP and YSRCP have also been in very friendly terms, and almost on all occasions, YSRCP supported Modi government. However, PM Modi needs to increase the number of seats of NDA, and such outside support naturally gets priority. As per the internal assessment of BJP, the party has no hope of gaining any Lok Sabha seat from the state by fighting solo, but if they contest in alliance with TDP, it could regain its two seats that it won in 2014. The reason for BJP's hope is the growing antiincumbency in the state against ruling YSRCP.

TDP also hopes to considerably regain its lost ground – fist on account of growing anti-incumbency against YSRCP regime, and secondly on account of alliance with the BJP and JSP.

COMMOTION AND CONFUSION AS 2024 GENERAL **ELECTIONS NEARS**

The Rajya Sabha elections have stirred a po litical commotion, not only because of crossvoting, as has often taken place in the past, but also because the BJP is out to get every seat it can and the defeat of the official Congress candidate in Himachal Pradesh and a Samajwadi Party (SP) nominee in Uttar Pradesh are being viewed as attempts to demoralize a downhearted Opposition on the eve of Lok Sabha polls. The defeat of Abhishek Manu Singhvi, the Congress candidate for the only seat in Himachal Pradesh that was up for grabs, took many by surprise for it wasn't expected to become a close contest. The Congress was far ahead of the BJP with 43 MLAs on its side and only 25 legislators of the opposition party arrayed against Singhvi. In the lead-up to the election, Singhvi had openly hinted at the possibility of the BJP weaning away Congress MLAs.

Then, why and how did the Congress fail to manage the situation staring it in the face? Was it only a factional war in the party? The party is, after all, in power in the state with all the advantages that power brings with it. In contrast, Karnataka Chief Minister Siddaramaiah and Deputy Chief Minister D K Shivkumar, who were also in power, managed things in the Southern state and ensured all three Congress nominees were elected to the Upper House despite attempts by the BJP and its ally Janata Dal (Secular) to queer the pitch.

When it seemed that the Congress might be on the verge of losing the government in Shimla -Singhvi's defeat raised questions about its majority in the assembly – the party's leadership swung into action and pulled the government back from the brink, at least for the moment.



BJP OPENS UP TO ITS ESTRANGED ALLIES TO SCORE HIGH IN LOK SABHA POLLS

Tust 13 months back, precisely on Febru ary 10, 2023, Narendra Modi had made an audacious boast on the floor of Rajya Sabha "ek akela sab par bhari" (he alone was overpowering for all). He had even said "one person is proving too much for so many". He is so confident of his abilities, dexterity and political power that he was heard offering "Modi's guarantee" to the common people. During his ten-year rule he virtually turned his allies irrelevant and pushed them out of the political ring. Unfortunately one feels really pity to watch the same person, the iron man of Indian politics, begging to his former allies to come back, join the rank, for fighting the challenge of the INDIA bloc. Modi abhors the idea of listening to advice and suggestions from any other person. He is the wisest person.

It is an open secret that after winning the 2014

general election he had pushed away leaders like Chandrababu Naidu of Telugu Desam and Sukhbir Singh Badal of Akali Dal, once both were the strongest allies of BJP. He even ignored Navin Patnaik of BJD of Odisha. Modi behaved in a very ruthless manner with them. Modi sent an intelligible message that he did not care for such allies and he was capable of single-handedly winning elections, whether in the states or at the Centre.

Though the Akalis had severed ties with the BJP over the three controversial and now-revoked farm laws, the fact is Badals were feeling let down.



PRESIDENT BIDEN OPTS FOR **ECONOMIC POPULISM AT** HOME, IMPERIALISM ABROAD

resident Joe Biden's last State of the Union address before the 2024 elections laid out an agenda of sharp contrasts, with economic populism dominating domestic policy and Cold War confrontation and militarism defining his international strategy.

At home, Biden pledged to

impose higher taxes on billionaires and price-gouging corporations, make prescriptions cheaper for Americans on Medicare, and defend democracy and abortion rights from Trump and the GOP. Derailing this otherwise liberalprogressive program, however, was an approach to immigration that outflanks Republicans on the right, a foreign policy of Cold War confrontation with China and Russia, and a promise of further support for Israel's war against Palestinians.

Public anger over the latter issue disrupted Biden's speech before it even began: A large sit-in protest by ceasefire demonstrators blocked Pennsylvania Avenue, forcing Biden's motorcade to drive an alternate route from the White House to the Capitol.

Once he was able to make it to the House chambers, though, Biden launched into a speech that was d'état attempt at the U.S. Capicombative with Republicans at times, short on progressive substance at others, but crafted from beginning to end with the intention of ending speculation about his age and mental sharpness.

Biden continually invited comparisons between himself and Donald Trump, whom he referred to as "my predecessor" and described as a threat to democracy both in the United States and other countries.

He slammed Trump as a threat to the rights and freedoms Americans now take for granted. Analysts called the speech Biden's formal re-election campaign kickoff. Throughout, on their side of the House chamber, glum-looking Republicans sat on their hands, often looking down.

Biden's criticism of misogynist, 91-count-indicted, and twice-impeached Trump focused on the Republican's instigation and encouragement of Jan. 6, 2021, invasion, insurrection, and attempted coup

"It is we who face an unprecedented moment in the history of the union," Biden declared at the outset. "And, yes, my purpose tonight is to both wake up this Congress and alert the American people that this is no ordinary moment either." He sought to warn the country about Trump's increasingly belligerent and erratic statements. Atop them: Trump's promise to be a dictator "on day one" if he takes office again next Jan. 20.

IN MEXICO, LEFTWING MORENA LOOKS POISED TO WIN THE PRESIDENCY AGAIN

left-wing Morena party marked the beginning of the country's official presidential campaign season with a kickoff event in Mexico City's central square, or Zócalo. Before a maximum-capacity crowd and following an introduction by the party's mayoral candidate for the city, Clara Brugada, presidential standardbearer Claudia Sheinbaum laid out a hundred-point plan for building the "second floor of the transformation.".MexicoI going for te Presidential elections on June 2 this year.

While many of the proposals dealt with consolidating projects already underway or under consideration — including a package of constitutional reforms sent to the Congress of the

On Friday, March 1, Mexico's Union by President Andrés Manuel López Obrador (AMLO) in February — Sheinbaum offered glimpses into how this second floor would look different from the first. It includes a greater emphasis on women's issues, building on programs instituted during her term as mayor of Mexico City; the most eye-catching proposal was one to reduce the age at which women could qualify for the universal adult pension, with a partial payment kicking in at the age of sixty. Sheinbaum's platform also entails

greater attention to education, culture, sports, and the arts, including health and social security benefits for artists typically left out of those systems. It offers an increased focus on preventative and mental health, including a national

mental health program that encompasses victims of violence. It promises to tackle Mexico's chronic water problems, including reforms to the North American Free Trade Agreement (NAFTA)-era National Water Law that turned hydric resources over to wealthy licensees and corporations (Sheinbaum has said that water will be a defining issue of her administration). And building on Sheinbaum's strengths as a climate engineer, it promises to drive the energy transition — not along the lines of the greenwashing model promoted by energy multinationals but within a framework of strengthened public control over the sector, which has been one of the most significant battles of AMLO's term.

MAJOR LEGAL-POLITICAL **VICTORY FOR CASH-STRAPPED KERALA**

ash-strapped Kerala scored a significant 'legal-political victory when the Supreme Court directed the Union Government to allow the State additional market borrowing to the tune of Rs 13,608 crore. The apex court's ruling has come as a big relief for Kerala, which has been struggling to meet its financial commitments, including payment of salaries and pensions. To the acute embarrassment of the Union Government, the SC also came down heavily on the Centre's insistence that Kerala withdraw the case before the Centre released the funds.



1 dead, 22 injured in China eatery explosion

Beijing, Mar 14 (IANS): One person was killed and 22 others were injured following an eatery explosion in China's Hebei Province on Thursday, local authorities said. The blast occurred at 7:54 a.m. at a fried chicken shop in Yanjiao township in the city of Sanhe, according to the city's emergency management bureau.

It is suspected to have been caused by a gas leak, the bureau said, Xinhua news agency reported.

Rescue workers have rushed to the site immediately. More details are awaited.

Putin critic Navalny's ally Leonid Volkov attacked in Lithuania

Warsaw, Mar 14 (IANS): Leonid Volkov, a long-time ally of the late Russian Opposition leader Alexei Navalny, has been attacked outside his home in Lithuania, the media reported. Volkov was assaulted with a hammer and tear gas while in his car in Vilnius on Thursday night, Navalny spokesperson Kira Yarmysh said as quoted by BBC report. The alleged assailant is unknown, as is their motive. The Lithuanian Police have been informed of the incident and are investigating, according to the Reuters news agency.

Another member of the Navalny team, Ivan Zhdanov, posted pictures on social media of Volkov with a bloodied lower left leg and what looked like bruising to his temple.



Hamas delegation to visit Cairo this week for truce talks, temporary ceasefire likely

Bringing an end to the deadlock in ceasefire talks, a delegation of senior Hamas leaders led by its political bureau head, Ismail Haniyeh is set to visit Cairo this week for mediatory talks.

Sources in the Israel Defence Ministry told IANS that the talks would be held at the mediation of the special envoy of US President Joe Biden, Brett McGurk, who will visit Cairo this week.

According to the sources, Hamas leasership has agreed to release, women, elderly and wounded Israeli hostages in its custody in exchange for

Tel Aviv, Mar 14 (IANS): the Palestinian prisoners kept in Israeli jails. Qatar's Prime Minister Sheikh Mohammed Bin Al-Thani and Egyptian Intelligence Head Major General Abbas Kamel will also be part of the mediatory talks in Cairo.

However, the Israel Defense Ministry source did not give the exact date of the truce talks but instead revealed that the talks will take place this week itself.

US President Joe Biden had announced earlier that ceasefire would commence before the holy Ramadan month. While Ramadan month has begun, there was no progress in ceasefire talks and the sudden breakthrough has given hopes for an imminent ceasefire.



In the ongoing war between Israel and Hamas that began on October 7, 2023, more than 31,000 Palestinians, including a large number of women and children have lost their lives.

Around 241 Israeli soldiers were killed in addition to the 1,200 people killed in southern Israel on October 7 last year when Hamas militants swarmed into Kibbutz Beeri, Kfar Aza and Reim festival areas of southern Israel.

Since the start of the war, there was a one-week ceasefire from November 24 to December 1, which saw the release of 105 Israeli hostages in exchange of 324 Palestinian prisoners kept in Israeli prisons.



Japan's Space One rocket explodes after lift-off

Tokyo, Mar 14 (IANS): The inaugural rocket launch of Japanese company Space One failed on Thursday as the Kairos rocket exploded seconds after lifting off, marking the first attempt from the country's private sector to put a satellite into orbit.

Shortly after 11:00 a.m. local time (0200 GMT) at the launch site in Wakayama Prefecture, western Japan, smoke and fire were seen following the take-off of the 18-meter, four-stage solid-fuel rocket, multiple local media live streams showed, Xinhua news agency reported.



Imran barred from holding meetings inside Adiala Jail for two weeks

Rawalpindi, Mar (IANS): Pakistan Tehreeke-Insaf (PTI) founder Imran Khan has been barred from holding meetings inside the Adiala Jail in Rawalpindi for two weeks, as per a media report. According to a notification issued by Pakistan Punjab's Home Department, all kinds of visits, meetings, and interviews have been restricted in Adiala Jail due to security alerts, Geo News reported.

The notification instructed the authorities to install barbed wires outside the jail premises. A fresh security audit of the officials of the special branch of the police, Intelligence Bureau, and the jail staff be done within a single day, it added.

14 Expressing severe concerns over the abrupt ban on Khan's meetings in the prison, PTI Chairman Gohar Ali Khan feared that the former Prime Minister's life is in danger, The News reported. Addressing a press conference outside the jail, Gohar claimed that they were barred from meeting the incarcerated PTI founder. He said that the authorities did not inform anybody about the two-week ban on Khan's meetings.

The authorities gave "terrorism" as a reason for the move, he added. Gohar also demanded an immediate meeting with the incarcerated PTI founder, as he sought details about Khan's health, The News reported.





Biden clinches Democratic nomination, Trump likely to win GOP nod

Washington, Mar 14 in the general election in 2020. (IANS): US President Joe Biden clinched the number of delegates needed to win the Democratic Party's nomination in primaries held on Thursday. His predecessor Donald Trump will have won the Republican nomination by the end of the day.

The Biden-Trump rematch has, thus, cleared its final qualifying threshold.

Biden crossed the Democratic Party threshold of 1,968 delegates with a win in the primaries in Georgia, which was critical to his win

Trump won the Republican Party primaries in Georgia as well but will have to wait for results from the three other states that held their primaries on Thursday -- Hawaii, Mississippi and Washington -- to clinch the nomination.

Neither of them faced a real challenge for their respective party nominations although the Republican primaries had remained open till March 5 when Nikki Haley, the former Ambassador to the UN, suspended her campaign leaving Trump the only one in the field. In an election system typical to the US, aspirants to the White House need to win enough delegates -- every state primary or caucus grants them a certain number of delegates -- who will officially anoint their nominees at their party conventions later in the year. But the Biden versus Trump presidential election gets technically underway on Thursday night.

Biden cleared the 1,968 delegates on Thursday and Trump will have his 1,215 by the end of the day. "Just a few minutes ago, this team helped me clinch the Democratic Party's nomination for President of the US," Biden said in a statement.

Ukraine-based Russian armed groups claim raids into Russia

Three Ukraine-based Russian paramilitary groups said that they have crossed into Russia and are now fighting government troops there, media reported. The Freedom of Russia Legion (FRL) and Siberian Battalion (SB) posted videos purportedly showing their fighters in Russia's Belgorod and Kursk regions, BBC reported. The FRL and an exiled Russian politician claimed two villages were now in control of "liberation forces".

Russia's Defence Ministry said the breakthrough attempts were thwarted. It claimed more than 234 Ukrainian troops had been killed and several tanks had been destroyed.

According to Belgorod's regional governor, Vyacheslav Gladkov, one member of Russia's territorial defence

Moscow, Mar 14 (IANS): forces was killed and 10 civilians were injured, BBC reported. These numbers have not yet been verified by the BBC.

Undriy Yusov, a spokesman for the country's military intelligence, said the paramilitary groups were "independent organisations" of Russian nationals, and therefore operating "at home". In a separate development, Russia said Ukraine had launched 25 drones on targets across Russia, but the attack was thwarted. However, videos have emerged which appear to show several Russian oil facilities on fire, BBC reported. In the Ivanovo region, just east of Moscow, an Il-76 military transport plane with eight crew and seven passengers crashed shortly after take-off, Russia's Defence Ministry was quoted as saying by Russian state-run news



agencies. The Ministry said an engine fire caused the crash. It gave no details of survivors.

Videos have emerged purportedly showing the plane on fire circling in the sky, and later plumes of black smoke from the crash site. Elsewhere, at least three people were killed and 38 injured on Tuesday night when a Russian missile struck two apartment buildings in the central Ukrainian city of Kryvyi Rih, according to the Ukrainian Minister of Internal Affairs, Ihor Klymenko.

Klymenko said children were

among the victims and that the number of deaths may go up as the search and rescue operation is continuing, BBC reported. Ukrainian President Volodymyr Zelensky said the country would "inflict losses on the Russian state in re-

sponse -- quite rightly". A full-scale invasion of Ukraine launched by Russian President Vladimir Putin is now in its third year, with no signs that the biggest war in Europe since World War Two could end soon.

Increasing medical school admissions based on scientific grounds: South Korean PM

Seoul, Mar 14 (IANS): South Korean Prime Minister Han Duck-soo on Thursday said the government's decision to increase the medical school enrollment quota by 2,000 to address the shortage of doctors was based on scientific analysis.

Over 90 per cent of the country's 13,000 junior doctors have been on mass resignations for nearly a month, protesting against the government's decision, leading to the cancellation of crucial surgeries and crippling the medical system, Yonhap news agency reported.

"It is regrettable that the medical community is now claiming a lack of scientific analysis and consultation," Han Duck-soo said during a meeting with relevant officials at the government complex in Sejong.

Han Duck-soo referred to a study projecting a shortage of around 10,000 doctors by 2035 and noted that universities have requested the government to increase the medical school quota. "We have decided to increase enrollment by 2,000 starting from 2025, taking into account the time required for medical training," Han Duck-soo said.

The prolonged walkout by medical interns and residents, who play crucial roles in assisting with surgeries and emergency services at the five hospitals, has escalated. Medical school professors at Seoul National University.

As per the Ministry of New and Renewable Energy, India has the fourth highest wind installed capacity in the world. The National Institute of Wind Energy has estimated India's gross wind power potential at 695.5 at 120 metres and 1163.9 GW at 150 metres above ground

As part of the investment plan, the Chinese e-commerce giant plans to spend \$200 million this year to build the logistics center, according to a business strategy document of Alibaba, obtained by Yonhap News Agency.

Alibaba also plans to spend

midsized South Korean firms sell their products overseas, the document showed. AliExpress, an ecommerce platform of Alibaba, has been under scrutiny in South Korea over growing consumer complaints.

Alibaba said it will invest some 100 billion won to help bolster consumer protection in South Korea. Earlier this month, South Korea's antitrust regulator launched an on-site inspection into AliExpress on suspicion of the e-commerce platform's violation of consumer protection duties. The inspection was part of the regulator's investigation into whether the company has fulfilled due responsibilities to protect consumers in accordance with the country's e-commerce law and relevant regulations. The move came as the number of complaints filed against AliExpress and submitted to the Consumers Union of Korea rose sharply to 465 cases last year from the previous year's 93.



India second-largest region for VC investments in Asia-Pacific: Report

New Delhi, March 14 (IANS): India retained its position as the second-largest destination for venture capital and growth funding within the Asia-Pacific region last year, a report showed on Thursday.



Of those, 169,932 Hyundai Motor and Kia units were found to have software errors in the integrated charging control unit. Models affected are Hyundai's Ioniq 5, Ioniq 6, Genesis GV60, GV70 and GV80 EVs, totaling 113,916 units, and 56,016 units of Kia's EV6, reports Yonhap news agency.

Slain poetess's sister alleges firing outside her house by ex-UP Minister

Lakhimpur Kheri (Uttar Pradesh), Mar 14 (IANS): Nidhi Shukla, the sister of poet Madhumita Shukla, who was found shot dead at her Lucknow residence on May 9, 2003, has accused former Uttar Pradesh Minister Amar Mani Tripathi of trying to kill her.

The allegation came after unidentified men allegedly fired shots outside her house. She has demanded police protection.

In a written complaint with police, Madhumita's sister Nidhi Shukla alleged the firing incident took place outside her house in Lakhimpur Kheri in the early hours of Thursday. Both Amar Mani Tripathi, who was a Minister in the Mayawati-led Bahujan Samaj Party government in the state at that time, and his wife Madhumani Tripathi were, in 2011 sentenced to life term in Gorakhpur district jail for their involvement in Madhumita Shukla's murder.

In August 2023, the state government granted the couple premature release, prompting Nidhi to move the Supreme Court, which upheld the relief.



Delhi HC seeks standard operating procedure for timely release of prisoners on bail

New Delhi, Mar 14 (IANS): The Delhi High Court on Thursday directed authorities in the national capital to develop a standard operating procedure (SOP) to ensure the release of jail inmates granted bail within 48 hours. In February, the court initiated a suo motu petition to address the concerns surrounding delays in the acceptance of bail bonds by Jail Superintendents, thereby hindering the timely release of accused or convicts.

On Thursday, a bench of Acting Chief Justice Manmohan and Justice Amit Mahajan, stressed the need for expeditious release, particularly in cases involving emergencies like attending funerals, or marriages.

It asked the Delhi government counsel to draft an SOP and submit a fresh affidavit within 10 days.

As counsel said potential delays in inmate release are due to police verification of surety details, citing an existing police circular with set timeframes for verification, the court, noting the challenges faced by indigent inmates, stressed the importance of promptly releasing individuals granted bail, especially those represented by legal aid lawyers who may struggle to follow up effectively.

The court stressed the urgency of the matter, suggesting a compressed timeframe of 5-6 hours for special emergen-

cies like funerals. Recognising the overcrowded conditions in jails, the court proposed leveraging technology to streamline processes and expedite releases.

Furthermore, the court urged the Delhi government lawyer to consult with Jail Superintendents and the Director General of Prisons to identify necessary steps and resources for addressing delays in inmate release.

Justice Mahajan had, last month, raised the issue noticing the procedural delays that often negate the immediate benefits intended by bail orders. The court frequently directs that bail bonds be furnished directly to Jail Superintendents to expedite the release process, bypassing additional steps that could delay an accused or convict's release.

CAA can't be implemented in tribal autonomous council areas in NE: Experts

Even as several organisations in the northeastern region, including the All Assam Students Union (AASU) and the North East Students Organisation, are agitating against the notification of the Citizenship (Amendment Act) (CAA), legal and constitutional experts are of the view that the Act will not be enforced in the areas of tribal autonomous district councils created under the 6th Schedule, and the areas where the Inner Line Permit (ILP) is in place. Quoting the provisions of the new Act, legal expert Apurba Kumar Dey

Agartala, Mar 14 (IANS): said the CAA will not be promulgated in the 10 tribal autonomous district councils (ADCs) of Assam, Mizoram, Meghalaya, and Tripura.

"Besides the ADCs, several states in the northeast have special protections under Article 371 of the Constitution," Dey told IANS.

There are three tribal autonomous district councils each in Assam, Meghalaya, and Mizoram, while Tripura has one such tribal autonomous body. All the 10 autonomous bodies were constituted under the 6th Schedule of the Constitution.

These 10 tribal ADCs facili-



tate the socio-economic development of the tribals, who constitute 28 per cent of the northeastern region's total population of around 45.58 million.

The ILP, under the Bengal Eastern Frontier Regulation, 1873, has been in force in Arunachal Pradesh, Nagaland, Mizoram.

The case was registered at Colvale police station in North Goa. The accused is identified as Nagarmal Verma, 35, a resident of Lobowada, Thivim and a native of Rajasthan.

Colvale police said that the parents of the 18-year-old girl lodged a complaint that Verma, who is their neighbour, recorded a video on his mobile phone while she was taking a bath.



Fake cancer medicine manufacturing unit busted in Delhi, 7 arrested

New Delhi, Mar 14 (IANS): Tushar Chauhan. Special Com-With the arrest of seven persons, including two employees of a reputed hospital, the Delhi Police on Thursday busted an illegal unit indulging in manufacturing fake life-saving cancer chemotherapy medicines. A senior police official said they have also recovered spurious cancer medicines of seven international brands and two Indian brands worth Rs 4 crore from the illegal unit in the Moti Nagar area and other three locations, which were raided by the police.

The accused were identified as Viphil Jain, Suraj Shat, Neeraj Chauhan, Parvez, Komal Tiwari, Abhinay Kohli, and

missioner of Police, Crime Branch, Shalini Singh said that simultaneous raids were conducted at four different locations in Delhi and Gurugram based on the information. "The prime location for manufacturing spurious cancer medicines was DLF Capital Greens, Moti Nagar, where Jain, the mastermind of this operation, had taken two EWS flats to produce these medicines. Suraj Shat, another accused, managed the refilling and packaging of the vials," she said. During the raid, 140 filled vials of spurious cancer injections from brands like Opdyta, Keytruda, Dextrose, and Fluconazole were seized. Additionally, cash amounting to Rs

50,000 and 1,000 US dollars, three cap sealing machines, a heat gun machine, and 197 empty vials along with other essential packaging materials were recovered.

"At South City, Gurugram, Haryana, Neeraj Chauhan hoarded a large cache of spurious cancer injections/vials," the Special CP said.

During the raid, 137 vials of spurious cancer injections from brands like Keytruda, Infinzi, Tecentriq, Perjeta, Opdyta, Darzalex, and Erbitux, and 519 empty vials of similar brands along with cash totalling Rs 89 lakh and 18,000 US dollars were recovered.

"Neeraj's cousin Tushar Chauhan, who was involved in the supply

chain, was also apprehended," she said. "At Yamuna Vihar, the raid was aimed at nabbing Parvez, who arranged empty vials for Viphil Jain and was involved in supplying the refilled vials. Twenty empty vials were recovered from his possession," she added.

"In another raid at a reputed cancer hospital in Delhi, two individuals, Komal Tiwari and Abhinay Kohli, working in the Cytotoxic Admixture Unit, were apprehended. They were supplying empty vials for Rs 5,000 each," she said.

Jain, originally from Delhi, started his career as a medical store employee in Seelampur and gradually ventured into supplying medicines from wholesale markets to local stores. "About three years ago, he conceived the idea of refilling spurious cancer injections, targeting expensive brands. He collaborated with Parvez for empty vials and Neeraj Chauhan for further supply. Shat assisted Jain in refilling vials at his rented flats in Moti Nagar," said the Special CP.

Neeraj Chauhan, who previously worked as a manager in the Oncology Department of reputed hospitals, joined forces with Jain in 2022, leveraging his experience to provide fake chemotherapy injections at affordable



"Parvez, an ex-pharmacist of a reputed cancer hospital, ran a pharmacy shop and supplied empty and filled vials to Jain. Tiwari and Kohli, employed at a reputed cancer hospital since 2013, facilitated the supply of empty and filled vials to Parvez," said the Special CP. "Tushar Chauhan, a laboratory technician, collaborated with Neeraj Chauhan to distribute fake medicines," she added.

Govt bans JKNF for 5 years under UAPA

Srinagar, Mar 14 (IANS): The Centre has banned the Jammu Kashmir National Front (JKNF) led by Nayeem Ahmad Khan under the Unlawful Activities Prevention Act (UAPA) for a duration of five years.

The Ministry of Home Affairs (MHA) in a notification issued on Thursday said that the organisation was engaging in activities detrimental to the integrity, sovereignty, and security of the nation.

"The leaders and members of JKNF have been involved in mobilizing violent protestors in various parts of Kashmir for perpetrating unlawful activities, including supporting terrorist activities, sustained stone pelting on security forces in Jammu and Kashmir," the notification stated.



Defence Minister approves proposal for NCC expansion with additional three lakh cadet vacancies

New Delhi, Mar 14 (IANS): Defence Minister Rajnath Singh has approved a proposal for expansion of the National Cadet Corps (NCC) with the addition of three lakh cadet vacancies to cater to its increasing demand from educational institutions throughout the country.

From just 20,000 cadets in 1948, the NCC will now have a sanctioned strength of 20 lakh cadets on its roles making it the largest uniformed youth organisation of the world, Ministry of Defence said in a statement on Thursday. With NCC being offered as an elective subject as per the National Education Policy 2020, the expansion will be a step towards

meeting the aspirations of the youth towards playing a pivotal role as future leaders of the nation. The far reaching impact of this expansion will lead to proportionate distribution of vacancies across all States and Union Territories and would reduce the waiting list of institutions aspiring for the NCC.

The expansion plan encompasses the establishment of four new Group Headquarters and the addition of two new NCC units. An important facet of the expansion plan involves the proposal for employment of ex-servicemen as NCC instructors thus leveraging their skills and vast experience.

'Zero food children' report a malicious attempt to sensationalise fake news: Govt

New Delhi, Mar 14 (IANS) : The Union Women and Child Development Ministry on Thursday rebutted a recently published article on the "zero food children" in India and termed it a deliberate and malicious attempt by interested lobbies to sensationalize fake news. The article, published on February 12 on the JAMA Network, claimed that the prevalence of mal-

nourished children in India who haven't eaten anything in 24 hours (also known as 'zero-food' children) is comparable to the prevalence rates in West African nations like Guinea, Benin, Liberia and Mali. The ministry in a statement said that it is surprising that no primary research has been conducted by S.V. Subramanian and co-authors in the study to arrive at such broad and incorrect generalizations on the nutritional status of



children in India. "The authors themselves have admitted to deep misgivings on the data and have

referred to at least 9 limitations which make their study absolutely unreliable.

CM Mamata snaps ties as brother turns rebel after being denied Trinamool ticket from Howrah

Kolkata, Mar 14 (IANS): Now, Swapan Banerjee a.k.a. Babun, the younger brother of West Bengal Chief Minister, Mamata Banerjee, has turned rebel after being denied nomination in the Lok Sabha polls from Howrah, the constituency of his choice.

The Chief Minister also announced snapping of all ties with Swapan Banerjee soon after the news reached her.

From the Howrah constituency, the Trinamool Congress has renominated former Indian football player Prasun Banerjee, which has irked Swapan Banerjee.

Claiming that Prasun Banerjee was not fit for re-nomination, the Chief Minister's brother said he was even considering contesting as an independent candidate from

Howrah. However, he ruled out the possibility of joining the BJP. "Joining the BJP is out of question. If I contest I will be contesting as an independent candidate. I am a voter from that constituency also. It is not just me, there are several other leaders from the district who are better candidates than Prasun Banerjee," he said.



Devotee footfall at Ram Mandir in Ayodhya remains high

Shri Ram Janmabhoomi Teerth Kshetra Trust (SRJTKT) on Thursday said that since the opening of Ram Mandi, the pilgrim footfall has not come down.

"The temple is witnessing an average of 1 to 1.5 lakh pilgrims daily," the Trust in a social media post said.

It said that the devotees are allowed for darshan form 6.30.a.m to 9.30.p.m.

"Devotees can enter the Shri Ram Janmabhoomi Mandir for Darshan from 6:30 AM to 9:30 PM," the Trust said.

The trust said that the entire process from entry to exit after darshan at the temple is extremely simple and conve-

"Typically, devotees can have a darshan of Lord Ram Lalla within 60 to 75 minutes," it said.

The Trust said that the devotees are expected to leave their mobile phones, footwear, purses, etc., outside the temple premises for their convenience and to save time. "Devotees should not bring flowers, garlands, prasad, etc to the Shri Ram Janmabhoomi temple," it said. The Trust said that to attend the Mangala Aarti at 4 a.m, Shringar Aarti at 6:15 a.m, and Shayan Aarti at 10 p.m, devotees require an entry pass.

It said that no entry passes are required for other aartis.

"Information such as the devotee's name, age, Aadhar card, mobile number, and city is required for the entry pass. This entry pass can also be obtained from the website



of the Shri Ram Janmabhoomi Teerth Kshetra Trust. The entry pass is free of charge," the Trust said in the social media post.

The Trust has clarified that there is no arrangement for special darshan by paying fees or through any special pass at the Shri Ram Janmabhoomi Mandir.

The Trust has also warned devotees not to fall for such claims which could be fraud because the temple management has no connection to this. "Wheelchairs are now available in the temple for the elderly and differentlyabled," the Trust said.

It said that these wheelchairs are intended solely for use within the Shri Ram Janmabhoomi Mandir premises and not for Ayodhya City or any other temple.

"There is no rental fee for the wheelchair, but a nominal fee is to be given to the young volunteer assisting with the wheelchair," the Trust said.



Bengal Guv urges Mamata Banerjee to first study the details before commenting on CAA

Kolkata, Mar 14 (IANS): West Bengal Governor C.V. Ananda Bose on Thursday advised Chief Minister Mamata Banerjee to first study and understand the details of the Citizenship (Amendment) Act (CAA) before passing any comment on it.

The Governor's remarks came a day after the Union Home Ministry decided to implement the CAA, paving the way for granting citizenship to non-Muslim migrants from Pakistan, Bangladesh, and Afghanistan. Soon after the ministry's announcement, CM Banerjee had termed the Centre's move as a 'political gimmick' ahead of the Lok Sabha elections. Reacting to the Chief Minister questioning the legal sanctity of the CAA, the Governor said the Act has an important legal aspect, which is meant to "unite India" rather than to "divide the country".


VHP to help refugees in getting Indian citizenship after CAA

Lucknow, Mar 14 (IANS): Vishwa Hindu Parishad (VHP) will get in touch with refugees living in hundreds of various camps in the border states, to facilitate them in getting Indian citizenship. The decision comes two days after the Centre notified the rules for the Citizenship Amendment Act (CAA). VHP President Alok Kumar said that the workers have been asked to allay the fear of refugees, get them registered for citizenship and help them gain access to all the facilities which every Indian is entitled to. "Many of the refugees, essentially persecuted minorities of Pakistan, Afghanistan and Bangladesh are living in subhuman conditions. They need to be reached out immediately," he told reporters. "This is in accord with the Indian tradition of giving refuge, respect and dignity to all those who suffer indignities outside and seek shelter in India," he said. The CAA was passed in December 2019 and subsequently got the President's assent. However, it was notified on Thursday.

Protests had initially erupted in several parts of the country against it in December 2019, stalling the process. Many opposition parties including the Congress and Samajwadi Party spoke out against the law, calling it "discriminatory".

The VHP President said that a host of refugees have managed to get ration and Aadhaar but not citizenship and voting rights.

"All these problems need to be sorted out by coor-



dinating with the authorities," he said, maintaining that the applicants need to be mollified so that they come into the mainstream of development. Sources said that the cadres within the VHP have been advised to fan out across the country as early as possible and help the refugees complete the requisite formalities.

A senior VHP functionary said that the workers have already been working in a host of camps for the past many years. These camps have come up in the past 30 to 40 years in bordering states like Punjab, Rajasthan, West Bengal and North-East states. Communities which would be covered under CAA include Hindus, Sikhs, Parsis, Christians and Buddhists.

Excise policy case: Delhi court extends Manish Sisodia's judicial custody

New Delhi, Mar 14 (IANS) : A Delhi court on Thursday extended, till March 22, the judicial custody of former Delhi Deputy Chief Minister Manish Sisodia, arrested in an excise policy case being probed by the Central Bureau of Investigation (CBI).

Sisodia was produced before Special Judge M.K. Nagpal of the Rouse Avenue Court on the expiry of his previously extended judicial custody of 19 days.

On Tuesday, the CBI counsel told the court that the investigation was at a critical stage and releasing Sisodia on bail might impede the ongoing probe or lead to his evasion of justice.

The judge also reserved for March 22 his order on Sisodia's application raising an objection to the commencement of arguments regarding the framing of charges. The judge had earlier also directed the CBI to submit a detailed status report on the case expressing concerns over incomplete disclosure about the probe's status.

The central agency had also filed a report stating that the investigation is ongoing and at a crucial stage, with completion regarding the 16 charge-sheeted accused persons. However, the defence counsel had objected, citing incomplete status reports and the need for time to scrutinise translated documents received recently. The court, recognising the complexity of the case, had directed the CBI to install necessary software in the laptops of defence counsel for efficient access to the voluminous case files.

Counsel for various accused individuals in the case expressed concerns regarding the accessibility of certain documents provided to them by the CBI. Complaining



that these documents were not opening on their computers, the counsels sought recourse from the court to address the issue.

Responding to the concerns raised, the court granted them one week to visit the CBI office directly and view these documents. The CBI had submitted the status report to the court, presenting an update on the progress of the investigation. Notably, the report was presented in a sealed cover. The alleged excise policy scam is being probed by both the enforcement agencies - the Enforcement Directorate and CBI.

Food prices in New Zealand see smallest annual increase in almost 3 years

New Zealand's food prices increased 2.1 per cent in the 12 months to February 2024, the smallest increase since May 2021, according to the statistics department Stats NZ on Thursday. Lower fruit and vegetable prices are welcome news for New Zealanders who have been doing it tough at the supermarket, said Finance Minister Nicola Willis, Xinhua news agency reported.

The 2.1 per cent increase is noticeably lower when compared with the 12 per cent increase in the 12 months to Feb-

Wellington, Mar 14 (IANS): ruary 2023, Stats NZ said, adding the lower annual increase was due to cheaper fruit and vegetable prices, down 9.3 per cent in the 12 months to February 2024.

> Cheaper prices for fresh produce such as tomatoes, broccoli, and lettuce drove the decrease in fruit and vegetable prices, said Stats NZ consumer prices manager Will

"Lower fruit and vegetable prices are a step in the right direction for Kiwi families who have been pulling in their belts to cope with rising prices and rising pressures across the board," Willis said, adding inflation continues to be tracking down in the right direction and people can start feeling more in control of their own finances.

All other broad food groups increased in the 12 months, with restaurant meals and ready-to-eat food prices up 6.7 per cent, grocery food prices up 3.9 per cent, nonalcoholic beverage prices up 4.3 per cent, and meat, poultry, and fish prices up 0.2 per cent, statistics show.

"Going out for a meal or grabbing takeaways was more expensive in February 2024," Bell said.





White House to send new \$300 mn weapons package to Ukraine

The US will send \$300 million (£234 million) in military weapons to Ukraine, including ammunition, rockets and anti-aircraft missiles, the White House has said as quoted by media reports. The surprise announcement on Thursday comes as a bill in Congress to send further aid to Ukraine stalls amid partisan debate, BBC reported.

The US shipment, the first in nearly three months, is intended to prevent Ukraine from losing ground to Russia.

National Security Adviser Jake Sullivan said this aid "is nowhere near enough to meet

Washington, Mar 14 (IANS): Ukraine's battlefield needs". "This ammunition will keep Ukraine's guns firing for a period, but only a short period," Sullivan told reporters on Thursday, adding that "it will not prevent Ukraine from running out of ammunition".

> The White House has been appealing to Congress for months to pass a budget that sends aid to Ukraine, as well as Israel and Taiwan, BBC reported.

> A \$60 billion aid bill has already passed the Senate, but has yet to face a vote in the House of Representatives.

> Speaker of the House, Mike Johnson, has so far refused to

consider the Senate bill. Johnson, an ally of Donald Trump, has said the House will vote on its own aid bill, but only after Congress passes a budget that overhauls the US immigration system. On Thursday, a group of bipartisan lawmakers in the House launched a longshot petition -- an attempt to force the House to vote on the Senate bill -- using a rare procedural tactic that hasn't been successfully employed since 2015, BBC reported. Thursday's emergency package of weapons and equipment comes from cost savings made in earlier Ukraine weapon contracts.

Varun Dahiya, Assistant Commissioner of Police (Crime) identified the accused as Sunil Kumar and Amit Kumar Jangid. "The culprits used to steal the vehicles and take them to Rajasthan and further sold the car to their other companions for Rs 1 lakh.

Congress played vengeful politics over 2G, 3G scams: Goa CM

ernment... you need to compare ten years of the Congress regime and ten years of the PM Modi government till 2024. You need to know how reforms have taken place now. We need to know about changes taking place in infrastructure and human resources. Only then we will come to know the difference," Sawant said. He said that under the leadership of PM Modi, India is witnessing a transformation in every sector with an increased number of AIIMS, IITs, IIMs, and Institutes of National Importance like All India Institute of Ayurveda, National Forensic Science University in Goa among others.



> The accused-appellants contended that the FIR primarily involves a civil dispute and the entire criminal proceedings initiated against them were nothing but an abuse of the process.

> In its verdict, the apex court said that the dispute as to how many bicycles the complainant had assembled and the amount liable to be paid is a "civil dispute".

> The complainant has not been able to establish that the appellants' intention to cheat him was there



Criminal Procedure Code for

quashing the FIR. Refusing to accept the contention that the dispute between the parties in any case was civil in nature, the High Court had held that prima facie a case of cheating was made out against the appellants.

In its 2015 ruling in Vesa Holdings (P) Ltd. vs State of Kerala case, the apex court had held that every breach of contract would not give rise to the offence of cheating.
