

#### Excise policy case: Delhi court denies bail to K. Kavitha noting 'gravity & seriousness of offence'

The court noted that the investigation is in a very crucial stage on certain key aspects, including the involvement of public servants and private persons and to ascertain the flow of ill-gotten money (proceeds of crime).

The judge noted that prima facie, Kavitha appears to be the key conspirator of the criminal conspiracy hatched for the purpose of collection and payment of upfront money to the Aam Aadmi Party through the co-accused for get-

ting favourable provisions in the now-scrapped Delhi Excise Policy 2021-22.

"Her role in demanding upfront money and the alleged payment thereof for favourable provisions in the excise policy has also been highlighted in the course of the arguments," the court noted.

The CBI submitted that though Kavitha is not named in the FIR, her role in the case emerged during the investigation, from the statements of witnesses and approvers, WhatsApp chats, and from the documents recovered during the probe pertaining to the transaction of money in the guise of a land deal. "The said documents/materials are stated to reveal the role of the accused/applicant as one of the key conspirators in the case," the CBI

argued while opposing the bail plea. Kavitha had cited hypertension as a reason for bail, stressing the need for medical care after her arrest by the ED. On this, the judge noted that the documents relied upon were found to be old medical records, i.e., from the year 2013 onwards, and her complaints have apparently been addressed.

Mentioning that he is coming from Odisha, PM Modi exuded confidence that NDA will form governments in all states where Assembly elections are being held. Asserting that when Chandrababu Naidu's government was in power Andhra Pradesh was on top on development, he alleged that the YSR Congress derailed the train development. "Instead of working in the interest of people, it drowned Andhra Pradesh into huge debts," he said, adding that NDA is the only guarantee of development.

The Prime Minister said that in the name of development,

the performance of YR Congress government was zero while corruption was 100 per cent.

"The projects of the Central government were delayed and people's interests derailed. Therefore when in the state and at the Centre there is a double engine government of NDA, all stalled works will be completed," he said. PM Modi said when the entire world is positive about India, the people of Andhra Pradesh should stay away from the negativity of Congress and YRS Congress and connect with BJP and NDA.

Stating that the YSR Congress came to power with the promise of prohibition, he alleged that the government itself is dealing in liquor and resorting to corruption.

"A big liquor syndicate is operating here. It is said that the Andhra government is running sand and liquor mafia," PM Modi said.

The Prime Minister said that the YSR Congress talked about developing three state capitals but all these years could not develop even one. "In the name of three capitals

they were planning a big loot but before that they emptied the treasury. They can only do corruption management. They can't do financial management." PM Modi alleged that the YSR Congress put brakes on the lifeline of Andhra Pradesh by stalling works on the Polavaram project.



#### Delhi Police, NSG security conducting mock drills across city



#### MODI-SHAH WANT TO GET BACK LOST SUPPORT BASE VIA COMMUNAL RHETORIC

ith voters remaining lukewarm to Narendra Modi's "Abki Par 400 Paar" campaign slogan, the prime minister's chief lieutenant, Union home minister Amit Shah has started reaching out to the smaller parties, apart from the official NDA allies, to help Modi form the government for a third consecutive time. Shah has conveyed it to his state leaders and chief ministers of the BJP ruled states to ensure that the voters come out in large numbers to prop up the voting percentage of the ruling party at the centre. The decline of the polling percentage during the two earlier phases, especially in the second phase which witnessed a staggering 8 per cent decline in votes polled in comparison to 2019 across the country, has unnerved Modi and Shah. With around 1 crore voters, out of total 16 crores, staying away from voting, the BJP leadership is haunted by the fear that the third phase of polling would be a virtual repetition of the earlier two phases. The third phase of the elections will be held on May 7 in 94 Lok Sabha constituencies in 12 states. In this phase, states which are crucial for BJP are Bihar (5 seats), Chhattisgarh (7 seats), Gujarat (26 seats), Karnataka (14 seats), Madhya Pradesh (8 seats), Maharashtra (11 seats), Uttar Pradesh (10 seats) and West Bengal (4 seats). SC, ST and OBC voters are dominant in these constituencies.

Incidentally, all the seats in Bihar and Uttar Pradesh going to polls in the third phase have high density of backward and EB castes. The caste structure could be understood from the popular saying: "Rome Pope ka, Madhepura Gope ka [What Rome is for Pope, Madhepura is for Yadavs]". Besides Madhepura, the other four poll-bracing constituencies are Jhanjharpur, Supaul, Araria, and Khagaria. These areas have been traditionally anti-BJP. In the ten constituencies in Uttar Pradesh that go to poll in the third phase, OBCs, including Yadavs, Lodhs, and Kachhi/ Shakya/Murao communities, are the dominant castes and exert high level of influence as decisive polling factors. Besides, the Muslims are the most potent force demographically. The 10 Lok Sabha constituencies scheduled for polls in this phase include Sambhal, Hathras, Agra, Fatehpur Sikri, Firozabad, Mainpuri, Etah, Budaun, Aonla, and Bareilly. Notably, the first two phases comprised eight seats each. The third phase marks a significant shift from the Jat belt observed in the initial two phases. In these areas, the Yadav-Muslim equation is quite strong. Incidentally, the Dalits and EBCs have suffered extreme form of upper caste repression. In earlier elections, the BJP managed to win quite convincingly. But the scenario has changed this time. BJP had won seven out of the 10 seats in 2014 and eight in 2019. Jharkhand constituencies will have election in the fourth phase. The third phase will witness a paradigm shift in the allegiance of the voters. The farmers, Jats and Rajputs are already up in arms against the BJP, especially against Modi. The farmers have been quite angry with him for the ill-treatment and deceit meted out to them by Modi during their movement. They haven't forgotten the images of elderly farmers being assaulted and even tortured by the police. Earlier, over 700 farmers had died in the yearlong agitation. Still, Modi did not guarantee them "legal MSP". Their demands are yet to be met.

It is the bitter realisation that BJP, especially Modi, is not the first choice of Dalits, poor, OBCs and EBCs, that mass made Modi turn desperate to rope in this big chunk of voters at any cost. The Dalits and EBCs, who were once considered to be the strong support groups of BJP, have shifted their allegiance to IN-DIA bloc. RSS, over the years and through its various dalit organisations, has been striving hard to bring them into the Hindu fold. But as the general secretary of the CPI(ML) Dipankar Bhattacharya, [who is in Jharkhand, where the party has fielded its candidate from Koderma] said, the Dalits, tribals and EBCs have realised the futility of associating with the RSS and BJP and they are now fully on the side of the INDIA bloc. Realising the shift in his Dalit, EBC and tribal base, Modi has now come out with a new slogan: "SC-ST aur OBC ki Sarkar". Modi, who had started his electioneering with a thrust on communal polarisation and insinuation against Muslims, has now changed the gear midway.

#### ELON MUSK'S SUDDEN VISIT TO CHINA CANCELLING MEETING WITH INDIAN PM HAS STRATEGIC SIGNIFICANCE

Tesla Inc. CEO Elon Musk made an unexpected trip to China on Sunday. Landing in Beijing, Musk met Premier Li Qiang shortly after arrival. This meeting came just a week after Musk postponed a highly anticipated trip to India due to urgent Tesla matters, sparking speculation on Tesla's shifting priorities in its international engagements.

During this meeting, reported by China Central Television (CCTV), the Premier welcomed foreign enterprises and acknowledged Tesla as a key player in successful trade relations between China and the US. CCTV also reported that Musk had expressed Tesla's interest in deepening ties with China, reinforcing this sentiment at a separate meeting with Ren Hongbin of the China Council for the Promotion of International Trade. This visit comes at a critical time for Tesla, which has been implementing significant cost-cutting measures, including reducing its global staff by over 10%, in response to declining electric ve-

hicle (EV) sales. Musk's engagements in China, particularly his discussions on Tesla's Full Self-Driving (FSD) software and the potential international use of data collected in China, underscore the strategic importance of the Chinese market, where Tesla aims to bolster its technological and competitive standing. China's strong backing for EVs and its vast market size make it a key area of focus for Tesla. The Chinese government has fostered a supportive environment for EV producers with various incentives, establishing China as a crucial market in the midst of intense competition. Local brands, such as Xpeng Inc., are enhancing their own autonomous driving solutions, known as Advanced Driver-Assistance Systems (ADAS), which are increasingly prevalent in China's EV sector. Here, Tesla is facing declining market share as companies, including Xpeng, Xiaomi Corp. and Huawei Technologies Co., emphasise advanced technology to attract buyers. Additionally, widespread price reductions by

The South China Morning Post refers to industry insiders and analysts citing the ongoing elections in India as the main reason why Musk has rescheduled his visit, as Delhi is preoccupied with campaigning and is not capable of announcing any new economic policies.

outh Africa celebrated its 30th anniversary of the end of the racist apartheid regime in the country last week end amidst intensive campaign that is going on among the electorate for the general elections to be held on May 29 this year. The African National Congress (ANC) which is ruling the country since the fall of the racist regime on April 27, 1994 is not feeling comfortable for the first time in the last three decades.

South African President Cyril Ramaphosa led the ANC government and the people in the celebrations when he said' South Africa changed forever on April 27, thirty years ago and it signalled a new chapter in the history.

The combination of yadav-muslim is also deciding factor in these constituencies. The constituencies going to polls in third phase are Sambhal, Hathras, Agra, Fatehpur Sikri, Firozabad, Mainpuri, Etah, Badaun, Bareilly and Aonla. It would be worth mentioning here that BJP clinched victory in seven out 10 Lok Sabha seats of this phase in 2014 and expanded to eight in 2019 polls.. It may be noted that Samajwadi Party had won in Sambhal and Mainpuri in 2019 and had also won Mainpuri, Badaun and Firozabad in 2014.

Mainpuri Lok Sabha seat is witnessing an interest-

#### **JUDGES, POLITICS AND PUBLIC TRUST IN INDIAN JUDICIAL SYSTEM**

the country has been facing its biggest credibility crisis over the past ten years. Several instances that cannot be overlooked have battered public trust in the nation's judicial system. The judicial system of politics, thereby blatantly renouncing his allegiance to the Constitution. A former judge of the Supreme Court joins the Upper House of the Parliament after giving judgments widely regarded as favourable to the ruling party at the Union level.

High court judges decline to release opposition party politicians on bail even though the matter is prima facie politically motivated. Many judges of high courts and the Supreme Court brazenly encourage the culture of 'sealed envelopes' in the trial proceedings, side-lining the principles of free and fair trial. Judges deliver decisions that suit the ruling party and



after retirement join government offices, i.e., as Lokpal, governors and chairpersons of Central bodies. The above-stated incidents of judicial impropriety have not only affected the integrity of the judiciary but have also put at risk the trust people repose in the judiciary as the custodian of the Constitution. Unfortunately, these inci-

dents raise questions about judicial impartiality and create suspicions about the existence of a quid pro quo system. The political class is found offering high-paying post-retirement offices and other lucrative positions to judges, indicating a low level of ethical standards and integrity.

#### South Korea, US could explore possible 3-way energy cooperation with Japan

Seoul, May 6 (IANS): South Korea and the US could explore expanding bilateral energy cooperation dialogue to a trilateral format involving Japan in the future, given the importance Washington puts on its two Asian allies, a US official said on Monday.

Geoffrey Pyatt, US assistant secretary of state for the Bureau of Energy Resources, made the remarks in response to a reporter's question on the prospects of expanding the talks to include other likeminded countries, such as Japan, Australia and New Zealand, Yonhap news agency reported.

"I think there is a possibility for us to do more, in the North Asia context, leveraging what the United States has strongly supported in terms of the deeper cooperation between Japan, Korea and the United

States," Pyatt said during an online discussed efforts to secure critical press briefing. While agreeing that the energy area certainly offers opportunities for the three countries or more, Pyatt struck a cautious note in that developing such possibilities would need "more work." "There are certainly some areas where I could imagine the US-Japan-Korea relationship meeting that test, but that's going to require more work by all of us, and we're not quite there yet," he said. "The relationships are different," Pyatt said. "I think we've got more work to do if we want to develop those opportunities for multilateral cooperation."

"But this is very much something that's on the agenda as we look to the future," Pyatt said.

In the latest Energy Security Dialogue between Washington and Seoul earlier this week, Pyatt said he and his South Korean counterpart, Kim Hee-sang, deputy foreign minister for economic affairs,

energy supply chains, such as solar energy, away from Chinese dependence on sourcing.

The discussions also included talks on ways to work together to accelerate the clean energy transition in Southeast Asia and across the Indo-Pacific, Pyatt added.

On South Korea's energy dependence on Russia, such as coal imports, Pyatt noted that reducing the

portion of fossil fuels is more of a broader goal to achieve the green energy transition than a matter concerning the ties with Russia. "Korea has already gone to zero on certain key fossil energy imports from Russia, its imports of Russian liquefied natural gas down by about half, compared to before the full-scale invasion began," he said.





#### Over 50 die of heatstroke in Myanmar in April

Yangon, May 6 (IANS): In the scorching month of April, over 50 fatalities were recorded due to heatstroke in Mandalay, central Myanmar, an official from the Mani Sala Rescue Organization told Xinhua on Monday. Among the victims, about 30 had pre-existing chronic diseases, with the majority falling within the age range of 50 to 90, he said. The incidence of heatstroke spiked dramatically amid the heatwave in April this year in Myanmar. In March, the

number of hospitalised heat-related cases was only eight, but surged to over 50 by April, he added. On April 28, Mandalay experienced the hottest April day in 77 years, with the temperature reaching 44.8 degrees Celsius, according to the country's Department of Meteorology and Hydrology. In the Southeast Asian country, April and May are typically the hottest months as the temperature spikes before the start of the monsoon season.



#### Over 400 hospitalised in Vietnam due to suspected food poisoning

Hanoi, May 6 (IANS): As many toms of suspected food poisonas 487 people were admitted to hospital in Vietnam's southern province of Dong Nai over the past few days after having eaten the bread sold by a local eatery, Vietnam News Agency reported on Monday. Among the cases, 19 have recovered and returned home. Two cases remain in critical condition while others are recovering with less severe symp-

It is rare for a ranking North Korean official to visit Iran. The last such visit took place in 2019 when Pak Chol-min.


#### Russia responsible for cyber attack on governing party: Germany

"Russian state hackers attacked Germany in cyberspace," Baerbock said in Adelaide

According to the SPD, this was made possible by a security vulnerability in software which was not known at the time of the attack. "It cannot be ruled

out that data was leaked from individual email inboxes," a SPD spokesperson said.

According to Baerbock, the German government's investigation into the matter, led by the Foreign Office, has now been concluded. "We can now clearly attribute this attack from last year to the APT28 group, which is controlled by the Russian secret service GRU," said Baerbock.





#### HM Amit Shah dares Uddhav Thackeray to declare if he agrees with Congress manifesto

Ratnagiri (Maharashtra), May 6 (IANS): Union Home Minister Amit Shah on Monday dared Shiv Sena-UBT chief Uddhav Thackeray to publicly admit that the construction of Ram temple in Ayodhya was a good thing.

Narayan Rane, Eknath Shinde, Raj Thackeray are taking forward Balasaheb Thackeray's legacy," he said, accusing Uddhav Thackeray of abandoning Bal Thackeray's legacy.

Calling the INDIA bloc an "Aurangzeb fan club", Home Minister Shah asked the crowd to decide whether to go with "this fan club" or stay with Prime Minister Narendra Modi.

"One vote for Narayan Rane will make Modi the Prime Minister for the third time and enrich the country. Congress Prime Minister Manmohan Singh stepped down leaving the country's economy at number 11. Beechwal in Bikaner and Umren in Alwar. An e-auction was also held on October 3, 2023. However, the matter got stuck after the government in the state changed. After the BJP came to power in Rajasthan, the Central government linked the ERCP with the River Link Project and announced to provide 90 per cent of the funds required for the project. An MoU has also been signed between the Union Jal

Shakti Ministry and the state government.

Meanwhile, Rajasthan BJP Spokesperson Laxmikant Bhardwaj welcomed Chief Minister Sharma's move to cancel land auctions and termed it a "historic decision".

#### Financial regulator finds 'illegal' stock short selling at 5 more global banks

Seoul, May 6 (IANS): South Korea's financial regulator said on Monday that it has found suspected cases of naked stock short selling at five more global investment banks (IBs), bringing the total to nine out of the 14 largest global IBs in the country.

The additional cases come after the Financial Supervisory Service (FSS) reported in January that it has detected suspected illegal stock short-selling activities at two global IBs, reports Yonhap news agency. The FSS has been conducting an inspection on all 14 global IBs here since it exposed two IBs suspected of placing naked stock short-selling orders worth 55.6 billion won (\$40.3 million) in 2021-2022.

The financial regulator, together with the Financial Services Commission, had since imposed a temporary ban on stock short selling, currently set to expire at the end of next month.

### HCLTech partners AWS to accelerate GenAI adoption

China's current equity market capitalisation is double that of India, at a time when it's GDP is 5 times that of Indian GDP.


Between 2004 and 2021, China's economy outgrew India's GDP at a ferocious pace but has lost some relative momentum since. Over the past 3 years, the Indian have outperformed China, the report said.

At this juncture, India's frontline stock index, the Nifty 50 Index trades at 23x trailing earnings, while the Shanghai Composite trades at 11x trailing earnings. Emerging markets vary widely in

quality, with India considered high-quality and traditionally expensive, while China and South Korea are perceived as lower quality and cheaper.

India's appeal stems from favourable demographics, economic reforms, and supply chain realignment. Despite its high price-to-book ratio (over 4x, akin to the US), its return on equity matches that of the US, justifying a premium valuation. If India were to cheapen significantly, it could economy and equity markets offer an excellent entry point for long-term investors, the report said. Similarly, the US market features quality companies with elevated valuations, contrasting with Japan's historically opposite traits. The global market is currently experiencing a phase of remarkable optimism, buoyed by ro-

bust corporate performance and substantial earnings growth. Notably, amidst this landscape, Brazil has emerged as a standout case. It not only exhibits significant earnings growth but this growth is accompanied by an equally impressive valuation trend, the report said. India stands out for its impressive earnings growth, albeit accompanied by premium valuations. "Consequently, Indian equities no longer represent a bargain opportunity. Indian equities lack a margin of safety," it added.

#### Sensex gains 300 points but broader markets weak

Mumbai, May 6 (IANS): BSE Sensex gained 300 points on Monday although the market breadth is extremely negative.

Sensex was trading at 74,183 points, up by 305 points. As many as 62 per cent of the stocks, 2388 stocks are declining while 31 per cent are gaining.

PSU shares tanked on Monday, with the sectoral index down 2.5 per cent. PFC was down 8.6 per cent, REC was down 6.2 per cent, MRPL was down 5.8 per cent, Canara Bank was down 4.7 per cent, BHEL was down 4.7 per cent, and PNB was down 4.2 per cent.

Among the Sensex stocks, Kotak Mahindra Bank was up 5.1 per cent, and TCS was up 2.1 per cent. Among the losers, Titan was down 6.2 per cent, SBI was down 3 per cent, and NTPC was down 2 per cent.

V K Vijayakumar, Chief Investment Strategist, Geojit Financial Services, said the cut of 172 points on the Nifty last Friday is rumoured to be triggered by fears of changes in the longterm capital gains tax in the Budget after elections. "The Finance Minister quickly clarified that these are speculative. This clarification and positive global cues are likely to support



the market in the near term," he said. He added that the US jobs data for April has come lower than expected indicating a weakening labour market and a slowing economy. US unemployment has risen to 3.9 per cent in April. So the possibility of a rate cut by the Fed has again brightened. The decline in the dollar index to 105.8 and the cut in the 10-year US bond yield to 4.49 per cent augur well for the market.

"Positive comment by Warren Buffett that India is an untapped market with great potential is hugely important. FIIs can take a cue from that rather than reacting every time to changes in US bond yields.

Kotak Mahindra Bank is likely to respond positively to its impressive Q4 results. The Q4 auto results coming this week will be keenly watched by the markets and positive market responses are likely," he said.

## Heroin, foreign cigarettes, explosives seized in Mizoram

Aizawl, May 6 (IANS): The In another raid, the security per-Assam Rifles and the Mizoram Police, in three separate joint operations, have seized heroin, foreign cigarettes, and a consignment of explosives, officials said on Monday.

Assam Rifles officials said that acting on a tip-off, the para-military troopers and police conducted a joint operation at Falkland, near Aizawl, arrested two drug peddlers, and recovered 598 grams heroin, valued at Rs 4.18 crore from them, on Monday night.

sonnel apprehended one person and recovered 22,000 packets of foreign cigarettes valued at Rs 16 lakh from Lungpuk in Siaha district on Monday evening.

In the third operation, the Assam Rifles and the police seized 1,622 gelatin sticks (approx 200 kg) and 200 detonators, along with one vehicle, at Silaimul, near Aizawl and apprehended one person on Monday. Mizoram Police, in collaboration with the members of the Young Mizo Association

(YMA), also seized eight fully loaded trucks of dried areca nuts smuggled from Myanmar at Seling in Saitual district, a police official said adding that ten people have been arrested in connection with the seizure. Official sources said that the Assam Rifles, which guards the 510 km India-Myanmar border in Mizoram, have stepped up their efforts against illegal drug trafficking and smuggling of various contraband substances from across the border.

#### SC asks Parliament to consider amending Bharatiya Nyaya Sanhita's provisions on matrimonial cruelty

On Monday, Delhi's Patiala House Court took cognisance of Delhi Police's first charge sheet filed against the news portal's founder-editor Prabir Purkayastha, Chakravarty, and others. The matter will come up for arguments on charges on

May 31. On Monday, Justice Swarana Kanta Sharma of the Delhi High Court reserved the order following submissions from Chakravarty's counsel, who argued that he has been named as a prosecution witness after becoming an approver, and that the charge sheet has already been filed in this case. Chakravarty's lawyer cited Section 482 of the Code of Criminal Procedure (CrPC), which grants the high court discretionary power to grant bail. BJP nominee Tandon's father, Balramji Dass Tandon, was a founding member of the Jan Sangh in 1951. He was also the Deputy CM of Punjab from 1969-70, and served as an MLA for six terms. He was the President of Punjab BJP from 1995 to 1997.

Earlier, the Bombay High Court in September 2022 had refused to interfere with the judgment of Greater Mumbai's Special Court rejecting the bail application filed by Babu.

A Bench of Justices Nitin Jamdar and NR Borkar of the Bombay High Court had said, "We find that there are reasonable grounds for believing that the accusations of the NIA against the Appellant having conspired, attempted, advocated and abetted the commission of a terrorist act/s and the act/s of preparatory to the commission of a terrorist act, are prima facie true."

The case pertains to organisation of the Elgar Parishad at Pune, Maharashtra on December 12, 2017 which promoted enmity between various caste groups and led



to violence resulting in loss of life and property and state-wide agitation in Maharashtra.

In its investigation, the NIA revealed that Prof Babu was allegedly in contact with Paikhomba Meitei, Secretary Information and Publicity, Military Affairs, Kangleipak Communist Party (MC), an organisation banned under the Unlawful Activities (Prevention) Act and was propagating Maoist activities and Maoist ideology and was a co-conspirator with other accused.



#### **Gujarat Congress slams** BJP for 'unethical practices' amid election season

#### US spacetech startup establishes Bluetooth connection

#### with a satellite for 1st time

New Delhi, May 6 (IANS): In a first, US-based spacetech startup Hubble Network has established a Bluetooth connection directly with a satellite 600 kilometres away — a development which can help connect millions of devices anywhere.

The Seattle-based startup is backed by a \$20 million funding round from Transpose Platform and Y Combinator. On March 4, 2024, from the grounds of Vandenberg Space Force Base in the US, Hubble Network successfully launched its first two satellites. "These aren't just any satellites; they've successfully reached their orbits and managed to receive signals from a simple 3.5mm Bluetooth chip over an astonishing distance of 600 kms."

#### Denmark raises limit for abortions to 18 weeks

Copenhagen, May 6 (News Pulse): The Danish government announced on Monday that women in the Scandinavian country will, in the future, have the right to choose abortion up to the end of the 18th week of pregnancy.

Until now, the limit for abortions in Denmark has been 12 weeks. Danish Minister for the Interior and Health Sophie Lohde said in a statement: "There is no medical evidence for the current limit, and there is also nothing to suggest that there will be significantly more or later abortions if we raise the limit." The amendment to the law is due to take effect in mid-2025. Additionally, it grants 15 to 17-yearolds the autonomy to have an abortion without parental consent or approval by a specialist commission.




