Prime Minister Narendra Modi on Wednesday slammed the Congress party and its senior leader Sam Pitroda over the latter's alleged racist remarks, warning that he would not tolerate "such insult on the basis of skin colour" and that any such further comments could harm the unity of the nation. Addressing an election rally here,

Tough battle for Pawan Kalyan in Pithapuram

Amaravati, May 8 (IANS) : In search of his maiden electoral victory, Jana Sena Party leader and actor Pawan Kalyan faces a tough fight against seasoned politician Vanga Geetha of the ruling YSR Congress Party (YSRCP) in Pithapuram Assembly constituency in Andhra Pradesh. The constituency in Kakinada district is expected to see a fierce battle for supremacy as YSRCP is going all out to stop Pawan Kalyan from entering the Assembly. The actor-politician, whose party has an electoral alliance with the Telugu Desam Party (TDP) and the Bharatiya Janata Party (BJP), is confident of finally making it to the Assembly. The YSRCP has fielded Vanga Geetha, the sitting MP from the Kakinada Lok Sabha constituency.

Pithapuram is one of the Assembly segments under the Kakinada constituency. Power star, as Pawan Kalyan is popularly known, has been campaigning in Pithapuram for more than oneand-a-half months, conducting road shows. His nephew and actor Varun Tej also joined the highoctane campaign late last month by holding a road show. In an apparent move to counter his political rivals, who brand him an outsider for the constituency, Pawan

Kalyan has bought a home in the town and announced that he would actually reside in the town to be close to the people and work for their development. The Jana Sena leader has also promised to promote temple tourism in the constituency at a cost of Rs 300 crore with the development of the ancient Kukkuteswara temple as 'Mini Kashi' along with the Puruhutika temple.

25 BRS MLAs will join Congress on June 5, says Telangana minister

Hyderabad, May 8 (IANS) : Telangana minister Komatireddy Venkat Reddy on Wednesday claimed that 25 MLAs of the Bharat Rashtra Samithi (BRS) will join the ruling Congress on June 5. The Congress leader predicted that the BRS would get not more than two Lok Sabha seats from the state in the elections and the party would get emptied as 25 MLAs will switch loyalties to Congress soon after declaration of results of Lok Sabha polls. The BRS, which lost power to Congress in Assembly elections held in November 2023, has already lost three MLAs to the ruling party.

CPM urges govt to help rain-hit farmers

Hyderabad, May 8 (NSS) : CPM secretary Tammineni State Veerabhadram today urged the State government to help those who have suffered losses due to the recent unseasonal rains. In a statement, he said on May 7, seven people were killed due to hailstorms across the State and added that several houses were damaged due to the breakdown of electricity poles and trees. He also said the grains got wet in the markets and the bags were washed away.



Nirmal, May 8 (NSS): If the BJP is voted to power in the Lok Sabha elections, the people will lose their rights and democracy will be in jeopardy, said Deputy Chief Minister Bhatti Vikramarka.

Speaking to the media here on Wednesday, the Deputy Chief Minister said the election battle was being held between Prime Minister Narendra Modi's dictatorship and the protection of the Constitution.

He further said that now it is clear why the Congress party had opposed Droupadi Murmu's candidature as the President of India. "Now I have understood that on the basis of the skin colour, they believed that Droupadi Murmu is also African and since her skin colour is black, she should be de-

feated," he said.

He asked if the talent of a person be decided on the basis of the colour of the skin.

"I am very angry today. When I am abused, I don't get angry. But, today the prince's philosopher has thrown such a big insult that I am filled with anger."

INDIA'S ADIVASI COMMUNITIES ARE FACING BRUTAL REPRESSION FROM MODI GOVT

In the mineral-rich heartland of India's Bastar region in the state of Chhattisgarh, a severe on slaught against indigenous communities, known as Adivasis, is currently unfolding. The Indian government officially recognizes the major Adivasi community in the region, the Madia, as a "particularly vulnerable tribal group." Despite this recognition, the ongoing state-led aggression against them poses a grave threat to their existence, putting thousands of lives at stake.

At the heart of this unfolding tragedy lies the Indian government's steadfast commitment, echoed by the declarations of Home Minister Amit Shah, to eradicate Maoist revolutionaries by the end of 2024. In their pursuit of a "Maoist-free India," state forces have intensified their operations in 2024. Over the past four months, they have killed eightytwo Adivasis and Maoists. On April 16 alone, security forces killed twenty-nine Adivasis and Maoists, fifteen of whom were women.

To carry out this bloodshed, the Indian state has deployed not only thousands of local police operatives but also more than ten thousand troops from border security and paramilitary forces as well as special counterinsurgent units. They have established hundreds of military camps across Adivasi terrain to terrorize and eliminate them.

Military and police camps have been strategically established at intervals of three to five kilometres to saturate Bastar. In Chhattisgarh, there are nearly three hundred such camps, with Bastar alone hosting about a hundred. Each camp accommodates between five hundred and two thousand personnel, armed with heavy weaponry, and supported by drones of various sizes. Additionally, every camp is equipped with two mine-proof vehicles, all-terrain vehicles, and war tanks. Furthermore, the state is resorting to the use of drones to drop bombs in Adivasi areas. This aggression illustrates how the Indian state is endangering its indigenous people. The question remains: Why? For over five decades, the Maoists, also known as Naxalites, have been waging a relentless struggle against the state, advocating for socioeconomic justice and people's rights over water, forest, land, and self-respect. However, the Indian government views this revolutionary movement as a major "internal security threat" and labels it a "menace" to the nation. In response, it has embarked on a mission to "sanitize" regions under Maoist influence. In the context of Bastar, renowned writer Arundhati Roy has offered valuable insights into the complex dynamics of the conflict by looking at it in terms of three main factors: mineral resources, the Adivasi communities, and the Maoists. At the core of this issue lies the abundant reserves of minerals. The state of Chhattisgarh accounts for a large proportion of India's mineral reserves, including 38 percent of its tin ore, 20 percent of its bauxite, 18 percent of its iron ore, 17 percent of its coal, and 4 percent of its diamonds. Mineral extraction in the state contributes almost 13 percent of India's total mineral production value. The Bastar region alone possesses several minerals that are essential for various industries, including coal, iron ore, bauxite, dolomite, limestone, diamonds, and manganese. It also contains rare-metal and rare-earth (RMRE) pegmatites such as niobium, cerium, yttrium, lithium, and tantalum. The estimated value of these mineral resources is staggering. The Indian state's strategy revolves around privatizing existing public sector mining operations and providing licenses for new mines to corporations. This initiative aims to create designated zones for the extraction of minerals. To achieve this objective, the state has undertaken three major steps. Firstly, it has created a conducive policy environment for privatizing mining operations, paving the way for increased corporate involvement in the sector.

NARENDRA MODI GOVT WORKED ONLY FOR CRONY CAPITALISTS OF INDIA

arendra Modi during his campaign for the Prime Ministership in 2013 and early months of 2014 focused mainly on corruption of the UPA-2 government in the last two years of its tenure and promised to the Indian voters a corruption-free government in 2014 Lok Sabha polls. The Congress stuck by the developments related to 2-G telecom spectrum scam suffered the defeat leading to the taking over of the Prime Minister's position by the fighter against corruption Narendra Modi. Ten years after, as the country is going through the polling phases for constituting the 18th Lok Sabha, Prime Minister Narendra Modi has been focusing on the same corruption issue against the Congress taking advantage of the raids by the central agencies on the opposition leaders and close associates mainly belonging to the Congress party. Many of the opposition leaders are not clean in their business dealings, but this is more true for the BJP leaders and supporters who have been kept out of the purview of the central agencies like the CBI, ED and the income Tax department. Prime Minister's one sided attack on the opposition on the issue of corruption hides the reality that the BJP led government has continued the corrupt



practices at the level of the centre as also the states ruled by the party and the common people have day to day experience about the presence of corrupt practices. The recent pre-Lok Sabha election survey done by the Centre for the Study of Developing Societies and Lokniti found that 55 per cent of respondents said that corruption had increased in the last five years. A look at the history of the functioning of the government of India since independence in 1947 shows that the corruption was present all through, only the method changed with the ruling elite taking more interest in collecting kickbacks from big contracts. In fact, Rajiv Gandhi after his take over as the elected prime minister in 1984-85 mentioned corruption as one of the areas he proposed to do away with, but unfortunately, he got implicated in the so called Bofors controversy which became a major issue in 1989 Lok Sabha elections.

Tel Aviv, May 8 (IANS) : The Hamas health department said that 16 people were killed in an Israeli air attack on Wednesday. Death toll from Brazil floods rises to 75



Over 1,000 documents wrongly issued from govt portal in S. Korea

Seoul, May 8 (IANS) : In a cyber incident, more than 1,000 civil documents were wrongly issued from the government's online civil service portal called 'Government 24', leading to the leak of personal information, the interior ministry said on Wednesday.

Kinshasa, May 8 (IANS) : The death toll into the bombings at three sites for internally displaced persons (IDPs) in the eastern Democratic Republic of the Congo (DRC) has mounted to 12, the United Nations said.

The attack on the three IDP sites, located in the Lac Vert, Lushagala, and Mugunga neighbourhoods of Goma, the capital of the eastern province of North Kivu, also damaged shelters and other humanitarian structures the UN said in a statement late Tuesday, Xinhua news agency reported.

South Korea to take part in US-led cyber exercise amid rising security threats from North Korea

Seoul, May 8 (IANS) : South Korea's Cyber Operations Command will participate in a US-led multinational cyber exercise this week to boost its capabilities to counter malicious cyber activities, Seoul's defence ministry said on Wednesday, amid growing security threats from North Korea.

According to the defence ministry, nine personnel from South Korea's military will join the Cyber Flag exercise to be held from Sunday through Saturday (local time) in the US state of Virginia. Cannot accept Hamas' demand to withdraw from Gaza, asserts Netanyahu

Tel Aviv, May 8 (IANS) : Amid ongoing talks for a 'pause' and mounting demands for the release of hostages, Israel's Prime Minister Benjamin Netanyahu on Wednesday asserted that his country will not accept Hamas's demands to end the Gaza war, reports said.

"We are not ready to accept a situation in which the Hamas battalions come out of their bunkers, take control of Gaza again, rebuild their military infrastructure, and return to threatening the citizens of Israel in the surrounding communities, in the cities of the south, in all parts of the country," he said, the BBC reported. "Israel will not agree to Hamas' demands," he reiterated.





Defence chiefs of US, Australia, Japan decry N. Korea-Russia military cooperation

Washington, May 8 (IANS) : The defence chiefs of the US, Australia, and Japan denounced growing military cooperation between North Korea and Russia, including their weapons transactions, during their trilateral talks in Hawaii this week.

US Secretary of Defence Lloyd Austin and his Australian and Japanese counterparts, Richard Marles and Minoru Kihara, held the meeting on Wednesday to discuss a range of regional and global issues, including North Korea, Russia's war in Ukraine, the South China Sea and the Taiwan Strait, Yonhap news agency reported.

"The ministers strongly condemn the increasing military cooperation between North Korea and Russia, including North Korea's export and Russia's procurement of North Korean ballistic missiles in violation of UNSC resolutions, as well as Russia's use of these missiles against Ukraine," the statement read. Austin, Marles and Kihara also expressed concerns over Pyongyang's unceasing weapon developments.

Hamas team to consult with

leadership on Gaza deal after Cairo talks

Cairo/Tel Aviv, May 8 (IANS/DPA) : Another round of indirect negotiations on the Gaza war came to an end on Wednesday in the Egyptian capital Cairo, with representatives from Hamas set to head to Qatar next for consultation with their leadership, according to the group. The Hamas delegation had delivered a response to the mediators' proposals and discussed them with the representatives of Egypt and Qatar, the organization wrote on its Telegram channel. The delegation planned to leave Cairo on Sunday evening and consult with the organization's leaders in Qatar, it said.

The latest round of negotiations to find a solution to the months-long conflict in Gaza had begun on Saturday. Israel had not sent a delegation as the government wanted to wait and see whether Hamas would accept the latest proposal from the mediators, which also includes the US. This envisages a multi-stage agreement between Israel and Hamas, which should



lead to the release of the remaining Israeli hostages held in Gaza, the release of Palestinian prisoners from Israeli prisons and an end to the war in Gaza. Negotiations for a solution to the conflict have stalled for months, following a brief ceasefire in November, with Israel and Hamas trading blame for the lack of progress.

The Gaza war was triggered by the unprecedented massacre of more than 1,200 people killed by militants from Hamas and other groups in Israel on October 7. They also abducted some 250 people to Gaza.

Israel responded with massive airstrikes and a ground offensive. As of Friday, the Hamas-controlled Health Ministry said the death toll in Gaza from Israeli attacks stood at more than 34,600. In its statement on Sunday, Hamas emphasized that it was conducting the negotiations "in a positive spirit and responsibly." However, a breakthrough did not appear to be on the horizon.

The Palestinian group is insisting on an agreement in which Israel commits from the outset to ending the war and completely withdrawing its troops from the Gaza Strip. However, Israel denies such a commitment and wants to reserve the right to take further military action.



High possibility of 8 pc GDP growth for India in 2023-24: CEA Nageswaran

New Delhi, May 8 (IANS) : There is a high possibility of India's economic growth touching 8 per cent in 2023-24, government's Chief Economic Adviser (CEA) V Anantha Nageswaran said on Wednesday.

Speaking at an event here, the CEA said that he expected a 7 per cent GDP growth rate for 2024-25 and it was important to maintain it. He also said that inflation was expected to remain under control and the country was in a position to pursue a stable "non-inflationary" growth path. "We don't see, at the moment, scope for nasty upside surprises on inflation. There can always be scenarios

in geopolitics that can cause inflation to be more than we expect, but at this point the baseline scenario is that inflation gradually converges to the mid-point of the target range," Nageswaran said. He was referring to the 4 per cent mid-point target range set by the Monetary Policy Committee before the central bank starts to reduce key interest rates to spur growth. The inflation rate came down



to a five-month low of 4.85 per cent in March. However, the RBI is still focused on controlling inflation before it goes in for a cut in interest rates. India's GDP growth for 2024-25 is projected at 7 per cent while the forecast for

inflation for the year has been retained at 4.5 per cent, RBI Governor Shaktikanta Das said recently. The RBI Governor said, "Headline inflation has eased to 5.1 per cent during both January and February.

SC cancels bail of UP Police SHO accused of raping minor inside police station

New Delhi, May 8 (IANS) : The Supreme Court has cancelled the bail of a Station House Officer (SHO) accused of raping a 13-year-old girl inside a police station in Uttar Pradesh's Lalitpur district. The minor girl was lured to neighbouring Madhya Pradesh by four boys of her village, where she was gang-raped and then left back to her village. When the survivor went to the Pali police station to lodge a complaint against the boys, she was detained and raped by SHO Tilakdhari Saroj.

A bench, headed by Justice A.S. Bopanna, said that the apex court had occasion to consider the issue of granting bail to a police official in a situation where he is alleged to have abused his office in the case of State of Jharkhand vs Sandeep Kumar and held against any lenience being shown, by treating such an accused policeman on par with a common man accused of such an offence.

"Notably, that (Sandeep Kumar judgment) was not even a case involving a heinous offence. In the present case, the situation is far worse as respondent No 1, being the Station House Officer of the Police Station, where the minor victim girl was brought for securing her justice, is alleged to have resorted to committing



the same heinous crime of raping her," said the bench, also comprising Justice Sanjay Kumar. In March last year, the Allahabad High Court had granted conditional bail to the accused police official saying that the prosecution's allegations do not inspire confidence. A bench of Justice Siddharth had observed that the electronic data and call details showed that the victim was not in the police station on the alleged date of the incident.

Allowing the appeal filed by the victim's mother, the apex court said that it did not find any reasons worth the name justifying the grant of bail to the accused police official at this stage and ordered him to surrender forthwith.

"The appeal is accordingly allowed.... (Accused SHO) shall surrender forthwith, failing which the state shall take necessary steps to apprehend him and send him to judicial custody," it ordered.

Police constable arrested in Tamil Nadu for sexually assaulting daughter

Chennai, May 8 (IANS) : A police constable with the Tamil Nadu Armed Reserve Force has been arrested for sexually assaulting his 14year-old daughter, an official said on Wednesday. The alleged incident happened in Cuddalore district of the state. The 14-year-old girl in her complaint lodged with the Cuddalore Superintendent of Police said that her father had been sexually assaulting her for the last one year. Cuddalore Superintendent of Police, R. Rajaraman then ordered the Cuddalore All Women Police Station Inspector Rathika to investigate the case.

BJP releases manifesto for Odisha Assembly polls

Bhubaneswar, May 8 (IANS) : The Bharatiya Janata Party (BJP) on Wednesday released its manifesto during a programme here ahead of the Odisha Assembly polls.

Releasing the manifesto, BJP national president JP Nadda said: "We will move from commitment to perfection and fulfill all our commitments. This is not a document only. It is our implementation programme for the next five years."

JP Nadda said wherever the BJP government comes to power, manifesto subcommittees are constituted, and its implementation is monitored every month so that the promises made in the manifesto can be completed in five years. He said the BJP is not fighting elections in Odisha to be in opposition but to form a government in the state. The party in its manifesto has promised that it will make a top-performing economy and create 3.5 lakh jobs by 2029. The BJP promises to fill 1.5 lakh vacant government posts while 65,000 posts will be completed within two years. Aiming to woo the women voters, the party has made the commitment to provide a cash voucher of Rs 50,000 to each woman resident of the state under the 'Subhadra Jojana'.

The beneficiaries can encash the voucher over a two-year period.



The BJP has further promised to create 25 Lakhpati Didis in Odisha by 2027 through industrial clusters for every 500 SHGs.

Samrudh Krushak Niti will be started in Odisha under which the rate of paddy procurement would be Rs 3,100 per quintal and the payment will be transferred to farmers within 48 hours through DBT. The party also promised to end the practice of 'katni-chhatni' by procuring the paddy through electronic weighing machines in all mandis.

The BJP also promised to return the money looted through Chit fund scams within 18 months of coming to power in the state. The party aims to install 36,000 beds in the CHCs & amp; PHCs at grass root level under 'Mission Swasthya Odisha'.

The Community Health Centers will be modernised by 2027 with ICUs, dialysis units and operation

theatres and upgrade 100 CHCs into Sub-Divisional Hospitals. The party promised to establish a nursing college, a medical college, and a super-speciality hospital in every district.

Tribal students will be provided with Rs 5,000 annually as Madho Singh Haath-Kharcha to reduce dropout rates. All elderly persons, divyangs, widows, and destitutes in the state will get Rs 3,000 per month under the 'Mukhyamantri Sahayata Jojana'. Those elderly above 80 years of age and divyang with 80 per cent disability will get a pension of Rs 3,500 under the scheme. Odia Samudaya Bhawan will be established in every Metro city across the country if the BJP government comes to power in Odisha. Fishermen in the state will be provided with Rs 10,000 annually as lean period allowance.

Three textile parks will be established in western Odisha that would generate 51,000 job opportunities in the state. The BJP also mentioned that IT parks in Bhubaneswar, Rourkela, Berhampur and Balasore will be established if it comes to power. Two youths drown in Kerala's Kollam

Thiruvananthapuram, May 8 (IANS) : In a tragic incident, two youths drowned to death in the Kallada river in Kerala's Kollam district on Wednesday, police said. The deceased were identified as Nithin, 21, of Kulanada and Sujin, 20, of Manchaloor. The incident occurred at the Manakkatu Kadavu near Manchaloor Matam in Pathanapuram of Kollam. Pathanapuram police told IANS that it was Sujin who began drowning while swimming, and Nithin tried to save him but also fell prey to the strong undercurrents in the Kallada river. Manchaloor Matom resident Mathew told IANS that the Kallada was dangerous as there were several pits in the riverbed and those not familiar with the river's course had chances of getting drowned.





Rains, with hailstorm and strong

winds, wreak havoc in parts of Manipur

Imphal, May 8 (IANS) : After a heat wave for over three weeks, heavy rains, accompanied by gusty winds and hail, lashed several parts of Manipur on Wednesday, damaging a large number of houses and other buildings, vehicles and leaving trees and power poles uprooted, officials said.

Officials said that a large number of houses were damaged in different parts of the state with the heavy hailstones leaving holes in tin roofs while the strong winds blew away hutments in different districts, leaving many people homeless.

The hailstorm was so powerful that parts of the valley areas of Imphal East and Imphal West Districts were blanketed with 4-5 inches of ice, resembling a landscape covered in thick snow. Vehicles parked in the open either developed cracks or were badly damaged.

A huge number of trees and electric poles were also uprooted in many areas by the winds.

Traffic in various places, including Imphal, was also disrupted due to the hailstorms and debris, caused by the rains and gusty winds.

Officials said that the damages to houses and properties are being assessed.

The Meteorological Department issued an orange alert and predicted heavy to very heavy rains in several northeastern states, including Manipur, till Tuesday. Chief Minister N. Biren Singh said that the state government would provide compensation for the damages to houses and other properties as well as crops.

Pak forms new cyber crime agency that experts reckon will also target Imran Khan supporters

Pakistan government's decision to form a national agency called the National Cyber Crime Investigation Agency (NCCIA) has raised concerns in the country with several experts citing that the move would not only gravely affect citizens' right to privacy but is also aimed at targeting the massive social media presence of jailed ex-PM Imran Khan's Pakistan Tehreek-e-Insaf (PTI) party.

The Establishment Division of the Pakistan government announced the formation of NCCIA with the prime focus on countering propaganda and rumours on social media and safeguarding the digital rights of people.

Islamabad, May 8 (IANS) : "There must be an end to harassment, including online," said Federal Minister for Information and Broadcast Attaullah Tarar on Wednesday. He added that there was an "immediate and dire need" of an authority like NCCIA to address the issue of online harassment and also to protect the digital rights of consumers.

However, security experts do not agree with the government and have expressed serious concerns over the negative effects on the citizen's right to privacy.

"It raises concerns that go beyond the duplication of efforts and resources, the move may also gravely affect citizen's right to privacy which seems to have been overlooked in the rush to bolster cyber defences," said Khawaja Khalid Farooq, former Inspector

General of Police and ex-head of National Counter-Terrorism Authority. Another view states that the military establishment wants to have a strong strategy and authority in place to tackle the anti-establishment campaigns run by PTI through its large presence on social media. "PTI is the only political party in Pakistan with a very strong social media presence. Its campaigns and social media teams have the strongest influence on the masses through social media engagements," says senior political analyst Javed Siddique. "The anti-military sentiments have prevailed and broadly expressed on social media platforms by PTI and Imran Khan's supporters. NCCIA may be designated and directed to work with prime focus on tackling the dissemination of PTI-led anti-establishment campaigns on social media under the legal cover of the controversial PECA act," he adds. It is pertinent to note that formation of NCCIA would render the already-existing Cyber Crime wing of the Federal Investigation Agency (FIA) as defunct.

Indian Americans caution US university on demand to display 'flag of Kashmir'

Washington, May 8 (IANS) : Indian Americans are calling upon a US university not to implement a portion of one of the demands it conceded to protesting students to display on campus the flags of "occupied people", which listed Kashmiris along with Palestinians and the Kurds.

"This is a dangerous territory for Rutgers to get involved (sic)," Thomas Abraham, chairman of the Global Organization of People of Indian Origin (GOPIO), wrote in a letter to Jonathan Holloway President, Rutgers University-New Brunswick in New Jersey state. "By even considering this demand, you are questioning the integrity of India. Kashmir is very much part of India. There is no separate flag for Kashmir.

Kashmir residents are not displaced people. In fact, the displaced people are the Hindu minorities who had to leave Kashmir because of violence against them.

If Rutgers displays such a flag of Kashmir, that will be the beginning of more sit-ins by students who are opposed to such flags," Abraham wrote. The university has not implemented this demand.





Amid Cairo peace talks, Israel steps up efforts to hit Hamas leader Yahya Sinwar

Tel Aviv, May 8 (IANS) : Amid the ongoing peace talks in Cairo to reach a ceasefire agreement between Israel and Hamas, the former has stepped up its efforts to assassinate Hamas military commander Yahya Sinwar, widely believed to be the man behind the October 7 massacre. Sources in Israel's defence ministry told IANS that a high-level meeting called by Defence Minister Yoav Gallant discussed Sinwar and whether to catch him dead or alive. According to the information available, the Defence Minister, considered a hawk, has told the top Army and intelligence officers that killing Sinwar has to be a top priority. Sinwar and Mohammed Deif are reportedly hiding in the Rafah region of Gaza surrounded by Israeli hostages.

India holds talks for closer ties on critical minerals, shrimp farming with Australia

New Delhi, May 8 (IANS) : tralia Economic Co-operation and India has discussed the issues of pharmaceutical pricing control in generic drugs and the need for closer cooperation in critical minerals with Australia, the Union Commerce Ministry said on Wednesday.

The need for closer collaboration for establishing diseasetree zones for shrimps and prawns in India also came up for discussion at the first Joint Committee Meeting (JCM) in Canberra under the India-AusTrade Agreement (Ind-Aus ECTA), the ministry said.

Besides, the JCM meeting also addressed certain critical services issues, including the consideration of India's request for facilitation of cross-border e-payments and mutual recognition of qualifications in professions like nursing and dentistry. India and Australia are looking at joint investments to build new supply chains underpinned by critical minerals processed in Australia that will help

India's plans to lower emissions from its electricity network and become a global manufacturing hub, for electric vehicles and smartphones. Critical minerals are a key raw material in these hi-tech products. Currently, China has a near-monopoly on critical minerals. India and Australia are both keen to set up a strong alternative supply chain to break China's dominance of the market.

CMFRI holds awareness campaign on climate change for fishing communities

Kochi, May 8 (IANS) : In response to the impact of climate change on fishing communities, the ICAR-Central Marine Fisheries Research Institute (CMFRI) launched an initiative to create awareness among the fisher folk in Kerala's Ernakulam district. As part of the awareness campaign under the National Innovation in Climate Resilient Agriculture (NICRA) project, scientists of the institute explained the science behind climate change, its effects on fishery and the adaptation strategies to reduce its impacts on the livelihood of the fisher community of two major fishing villages in the district. According to scientists, increasing sea surface temperature results in the migration of many economically harvestable fish stocks to relatively cooler waters.

Sadiq Khan re-elected as London Mayor despite criticism over rising crime rate

London, May 8 (IANS) : Incumbent Sadiq Khan of the Labour Party was re-elected as the Mayor of London for a record third time on Wednesday, defeating Conservative Party candidate Susan Hall by over a million votes.

Voting was held on May 2 across the 14 London Assembly constituencies, and the results were declared at the City Hall

London's mayoral election generated quite a bit of interest considering that Khan has been accused of going soft on crime - from thefts, shoplifting, and robberies to attacks involving knives - and also widening the Ultra Low Emission Zone (ULEZ) which imposes a daily charge of 12.50 pound on non-compliant polluting vehicles operating in a selected territory of the capital city. Hall, who promised to "get a grip" on crime in London, accused Khan of closing 36 police stations and failing to hire more than 1,000 police officers. She also repeatedly listed stats showing how the crime rate has surged since Khan took over as the London Mayor in 2016.





South Korean govt appears to shelve punitive measures against mass walkout by doctors

South Korean government appears to have shelved a plan to take punitive measures against a prolonged walkout by trainee doctors and have pulled back slightly from its plan to increase medical school admission quotas amid a standoff with major doctors' associations, according to officials on Wednesday. Seoul, May 8 (IANS) : The tions remained adamant over the issue and renewed their call for the government to revisit the medical reform from scratch, despite some signs of an internal split, reports Yonhap News Agency.

> During a media briefing last week, Second Vice Health Minister Park Min-soo said the government has decided to grant local universities autonomy in deciding their medical school quota by a range of 50 to 100

per cent for the 2025 academic year in a bid to break the monthslong deadlock, the officials said.

Additionally, the government has delayed the suspension of licenses for doctors who have been inactive for months under its "flexible disposition" policy since late March. No executive order has been issued for medical school professors who have resigned alongside their students.

Houston, May 8 (IANS) : fall is expected late (Tuesday) into Wednesday," the National Weather Service posted on social media, Xinhua news agency reported. More than 21 inches (53 centimetres) of rain fell

in the past five days near Splendora, about 30 miles (50 km) northeast of Houston, said the service.

Lina Hidalgo, judge of Harris County, said at a news conference on Saturday that nearly 180 people and 122 pets had been rescued from murky water across multiple areas in the county.

Annual anti-Semitism report finds worst outbreak since World War II

Tel Aviv, May 8 (IANS/DPA) : In the seven months following Hamas' shocking attack on Israel, the world has seen the worst outbreak of anti-Semitism since World War II, an annual report released on Wednesday said.

If this trend continues, Jews in many countries will no longer be able to live their identity in safety and freedom, according to the report by the Center for the Study of Contemporary European Jewry at Tel Aviv University and the Anti-Defamation League (ADL) in the US. Last year, for example, there was an average of around three bomb threats per day against syna-

gogues and Jewish institutions in the US. "The year is not 1938, not even 1933," said Professor Uriva Shavit.

"Yet if current trends continue, the curtain will descend on the ability to lead Jewish lives in the West-to wear a Star of David, attend synagogues and community centres, send kids to Jewish schools, frequent a Jewish club on campus, or speak Hebrew."

Anti-Semitism had been steadily increasing in the months and years leading up to the massacres by Hamas and other Palestinian extremist groups, the report notes, but "October 7 helped



spread a fire that was already out of control."

In the US, for example, where some 6 million Jews live, a total of around 3,500 anti-Semitic incidents were counted between January and September 2023, but almost 4,000 in the last three months of the year.

The picture is similar in other countries, such as Germany, where 1.365 anti-Semitic incidents were tallied from January to September last year and 2,249 from October to December.

Other countries with large Jewish minorities - including France, Britain, Australia, Italy, Brazil and Mexico - also saw increases. The report entitled "Concern for the Future of Jewish Life in the West" warns against explaining the trend as a reaction to the humanitarian catastrophe in the Gaza Strip.

That is because some of the most vile anti-Jewish statements in connection with the conflict were made in the first days after October 7, it said. The authors wrote that anti-Semitism rears its head on both the extreme right and extreme left - and spreads to the centre of society, often via social media.



South Korea: 40 flights cancelled on Jeju Island due to bad weather

Jeju, South Korea, May 8 (IANS) : At least 40 flights have been cancelled on the southern resort island of Jeju due to adverse weather conditions, officials said on Wednesday. According to officials from Jeju International Airport, 20 arrivals and 20 departures had been cancelled as of noon, Yonhap news agency reported. Strong wind warnings have been issued for the island, with an advisory for wind shear also in effect at the airport. The Korea Meteorological Administration (KMA) asked air passengers to check their flight schedules in advance as the bad weather is expected to affect Jeju Island until Wednesday morning. Meanwhile, rain was falling across much of the country as of 2 p.m., with gusty wind, thunder and lightning in some places, according to the weather agency. In the mountainous areas of Jeju Island and some regions of South Jeolla Province, heavy rain warnings were issued, while heavy rain advisories were posted for other regions of South Jeolla and the Gyeongsang provinces. Due to the rain, most outdoor festive events for Children's Day were cancelled, with five professional baseball games postponed. The KMA said an accumulated 30 to 80 millimetres of rain is forecast to fall in most of the country, including regions of Seoul, Incheon and Gyeonggi Province, until Tuesday, with 50 to 150 mm on Jeju Island.

Australia police shot dead teenager who stabbed man

Sydney, May 8 (IANS) : Western Australian (WA) Police Force announced on Wednesday that a 16-year-old boy who stabbed another man with a kitchen knife in Perth was shot dead by police. WA Police Commissioner Col Blanch said at a press conference that police received a call at about 10.10 p.m. local time from a male that indicated he was going to commit acts of violence. But he didn't provide his name or a location, Xinhua news agency reported.

Some minutes later, police received another call from a person stating that a male with a knife was running around a car park. Police immediately responded to that call, and three officers attended that location. When they exited their vehicle, the officers were confronted

by a male alone, with a large kitchen knife on Saturday night. Blanch said that the officers challenged the male to put down the knife, but he did not comply and rushed one of the officers. Two officers deployed their tasers but both of them didn't have the full desired effect. The male continued to advance on the third officer with a firearm, who fired a single shot and fatally wounded the male. The deceased male was a 16-yearold Caucasian man. He was taken to hospital and declared deceased at approximately 11.00 p.m., the police commissioner added.



"There was a report and we didn't know that until after the shooting, that a male had been stabbed in the back in the car park where police did respond," Blanch said. "That male is currently in hospital with a stab wound to the back.

He's in a serious but stable condition." State media Australian Broadcasting Corporation quoted WA Premier Roger Cook as saying that there were indications that the boy had been radicalised online.

Chinese embassy in Canada refutes foreign interference accusations

Ottawa, May 8 (IANS) : The Chinese embassy in Canada expressed "strong dissatisfaction and firm opposition" to the "baseless accusation of China's interference in Canada's internal affairs," according to its spokesperson. The initial report released by Canada's Foreign Interference Commission on Wednesday launched a scathing attack on countries including China, Russia and India, accusing them of interfering in Canada's 2019 and 2021 general elections.



The Third Eye: A new Cold War with a difference

New Delhi, May 8 (IANS): The Middle East is in a situation of flux because of the recent exchange of drone and missile attacks between Iran and Israel, an important visit to Pakistan made by the Iranian President following these events, and the fallout of Israel-Hamas conflict that produced pro-Palestinian demonstrations in the US and elsewhere in the Muslim world.

This is opening up the question as to what impact are the religious divides in the region making on the ideologically delineated Cold War that was already on the horizon involving the US-led West on one hand and the China-Russia axis, on the other.

The old political rivalry between the two strong players in the region, Israel and Iran, took a violent turn when Israel -- opposed to the rule of Bashar Al Assad, the Alawite President of Syria -- made a missile attack on Damascus on April 1 in which Iran's diplomatic mission was hit and seven officers of the Islamic Revolutionary Guards Corp were killed.

Iran retaliated on April 13 by firing missiles at Israel that were mostly shot down by the Iron Dome Defence system of the latter and a few days later on April 18 Israel responded by making a drone attack on Isfahan that reportedly did not cause any significant casualties.

There was an element of restraint on both sides which stemmed from a combination of factors

-- Iran weighing in the US support for Israel and Israel sensing the limitations on American backing put by the international criticism of the loss of civilian lives in Gaza at the hands of Israeli Defence Forces.

White House was contemplating measures to balance its support to Israel with an effort to counter any Islamophobic trends that the Israel-Hamas conflict could produce following the October 7 'terror' attack of Hamas on Israel. The US is also at the same time, having to deal with pro-Palestinian demonstrations held in the country, particularly on the university campuses there.

Iran and Pakistan, the two neighbouring Islamic countries -though inherently prone to the repercussions of the historical Shia-Sunni divide, have maintained a cautious line of peaceful relationship that could even overcome the incidents of exchange of missile attacks between them in January this year.

The Sunni Islamic radical outfit Jaish Al Adl based in Baluchistan intruded into the adjoining Sistan area of Iran whereupon Iran fired missiles on the outfit's base in Baluchistan -- inviting in return, a retaliatory military strike from Pakistan that seemed somewhat symbolic.

Hamas conflict, Iran was getting politically drawn to the China-Russia combine -- it had already extended military help to Russia by way of supply of drones to the latter during the Ukraine-Russia 'war'. Pakistan on its part, has historically been opposed to the creation of a Zionist state and maintains no diplomatic relations with Israel even today. Pakistan has a strong strategic alliance with China but has managed to be on the right side of the US after playing the role of a mediator in the talks between the Taliban and the US at Doha that resulted in the withdrawal of American troops from Afghanistan and the reinstallation of the Taliban Emirate at Kabul in 2021. Pakistan is also a key member of the Organisation of Islamic Conference (OIC) and has been extremely close to Saudi Arabia, the Chairman of this block of 57 Islamic countries.

French President Macron criticises blockades at university Gaza protests

Paris, May 8 (IANS/DPA) : French President Emmanuel Macron has criticised blockades at pro-Palestinian demonstrations at French universities, saying that the tactics went beyond legitimate means of debate and protest. Macron said he understands that the events in the Gaza Strip, in particular, are upsetting people, "but preventing a debate has never helped resolve the conflict," according to an interview published on Wednesday in the newspapers La Provence and La Tribune Dimanche.

"It is perfectly legitimate and even reasonable and reassuring that our youth can say that international events affect them and discuss them. But using violence and blockades to force an institution to adopt this or that policy, to prevent other students from entering a lecture hall on the pretext that they are Jewish - that is not the Republic," Macron said. He said such behaviour does not reflect mutual respect, pluralism and a condemnation of racism and anti-Semitism.
