



PM Modi, concluding the two-day debate on the 75th anniversary of Constitution adoption in Lok Sabha, ripped into the previous Congress regimes for its

has substantially increased the charges for diet and cosmetics in one decisive move.

"Diet charges have been raised by 40 percent and cosmetic charges by 200 percent, taking into account the rising prices and challenges faced by students. This marks the first time in the nation's history that such a significant increase in charges has occurred, specifically in Telangana State," Revanth Reddy revealed.

He further stated that the State government is endeavouring to upgrade the skills of the students and make them partners in the reconstruction of Telangana State. Stating that the unemployment problem is increasing due to lack of skills, the Chief Minister said the State government has upgraded 75 ITIs as Advanced Technology Centers in collaboration with Tata Company and it is providing skill development training to the unemployed through Young India Skills University.

The Young India Skills University is a role model for the country, he

Stating that the State government is setting up Young India Integrated Residential Schools in every Assembly constituency to compete with the corporate institutions, the Chief Minister said the government has taken the responsibility of providing quality education along with basic facilities. "Welfare and development are like two eyes for me. Spending on the education is not an expenditure

and instead an investment for their future. I have already instructed the officials and elected representatives to visit residential schools two to three days a week. I will too visit residential schools during my every official tour in the State," Revanth Reddy revealed. The Chief Minister urged the teachers to encourage students to excel in other talents as the government is ready to provide facilities for required training.

Cautioning that the stringent action will be initiated against those who failed to perform their duties, the Chief Minister has directed the officials to set up Mess Management committees with the students and to empower the students to monitor food they consume everyday.

M. Lokanathan, a farmer in Gudalur, told IANS, "A herd of more than ten elephants is camping in the forest area, which is barely 2 km from our homes. We urge the forest department to act immediately to drive away these elephants." According to Gudalur range forest officials, Suresh opened his door after hearing noises, only to find the wild tusker outside. He and his wife fled through the back door, but the elephant demolished their house and belongings. The previous night, a herd of wild elephants emerged from the forest and destroyed houses in the Allurvayal area of Gudalur district. Villagers have demanded that the forest department implement preventive measures such as digging trenches and erecting solar fences to prevent wild elephant camping in Thailathoppu, just 2 km from the forest area.

Denkanikottai locality of Krishnagiri district have also urged the forest department to drive elephants back into the forest. Tamil Nadu has recorded 256 deaths due to wild elephant attacks in the past five years. Many people have been injured

or incapacitated due to random attacks, particularly in areas adjacent to forests. The Environment Ministry has issued guidelines to states and Union Territories to manage human-wildlife conflicts, including damage to crops. These guidelines advocate for cultivating crops that are unpalatable to wild animals in forest fringe areas. Migratory birds create riot of colour as they keep tryst with Kashmir wetlands

The evening cackle in the sky as a large flock of migratory birds start descending on the water surface announces the fact that these avian visitors are keeping their annual tryst with Kashmir Valley. The kaleidoscopic view on the water surface inside the Hokersar bird reserve on the outskirts of Srinagar city proves beyond doubt that nature is the greatest painter of them all.

Teals, Mallards, Coots, Wigeons, shovelers, Brahminy ducks, Pochards,

Srinagar, Dec 14 (IANS): Pintails, Tufted ducks, Shelducks and the Greylag geese are the major species of migratory birds that come to the Valley from Russian Siberia, China, Japan, Eastern Europe and the Philippines.

These visitors come to spend the winter months in the rather sanguine environs of the Kashmir winter to ward off the extreme cold of their summer homes.

Regional wildlife warden, Tawheed Ahmad Deva told IANS that although the migratory bird arrivals are still not very large because of the long dry spell, as the winter season brings rain and

snow in the common days, the bird arrivals will improve in the next 10 to 20 days. "Say for example, if we expected 100 bird species till now, we have around 60 of them in our wetlands at the moment. This is definitely going to improve as rain and snow occurs in the days ahead", the wildlife warden said. Last year, official data said the Valley hosted 8 to 12 lakh migratory birds while in 2021-2022, the number was 11 to 12 lakh. In addition to the migratory birds that make Kashmir's wetlands their winter home, certain species of migratory birds called 'birds of

passage' spend some time in early winter and late spring in the Valley before moving to and out of the Indian plains.

These are the Sandhill cranes and Cormorants that spend just a few weeks in the Valley while on their way to and back from the Indian

plains. The first to arrive are the Coots and the Teals while the Greylag geese come towards the first week of December.

The famous migratory bird reserves of Kashmir are Hokersar, Chatlam.

INDIA-BANGLADESH RELATIONS ARE **GETTING MORE AND MORE COMPLICATED** ON THE MINORITIES ISSUE

indu-Muslim is a post-2014 phenomenon. Now, there is the allegation that India is look ing at Bangladesh through a "Hindu lens", instead of looking at Bangladesh through a "Muslim lens." The critic forgets that Bangladesh is looking at India through a "Muslim lens" and that there is an undeclared war between India and Bangladesh. Also, Pakistan is taking advantage even as the minority Hindus in Bangladesh are being subjected to untold miseries. Rape. Murder. Abduction. Religious Persecution. And imprisonment. Bangladeshis in control of Bangladesh are looking at Bangladesh's Hindu minority through a "Muslim lens." Mohammad Yunus, the puppet who is a puppeteer, controls the strings of miseries heaped on the Hindu minority of Bangladesh, who have nowhere to run to, boxed in as they are, in ghettos, where protection is scant and distrust roams unbound. But ignoring the plight, the question is asked, "Should all this be the reason for India to look askance at Bangladesh? Why is India looking down on our neighbouring country, which isn't any different from how we look at our neighbour to the west? The argument is to give Bangladesh the benefit of doubt, hold back criticism and give Bangladesh the chance to arrive at a correct Hindu: Muslim population balance, i.e., whittle Hindu population to a number that Bangladesh's Muslims will accept as the right ratio. Above all, India is not the United States. India has never ever engaged in regime change except in 1971, when India was the driving force behind the creation of Bangladesh. India fought a war for the liberation of the Bengalis, Muslim, Hindu and Christian, from the persecution of Pakistani Muslims. Everyone celebrated except Pakistan and the United States, which had ordered its Seventh Fleet into the Bay of Bengal, but had to leave without a torpedo fired. Since then, there has been a secular government in Bangladesh, unlike in Pakistan, which is an Islamic Republic.

The objection now is, how dare India's looking at Bangladesh through a "Hindu lens"? The Yunus regime, which strictly speaking isn't a recognized government of Bangladesh but an arrangement between Yunus and the "American deep state", has relaxed visa rules for Pakistanis and there are Indians of a certain bent who are looking at Bangladesh through Pakistani lens. These elements are adamant that India is behaving with Bangladesh exactly like it behaved with Pakistan. India plays cricket with Pakistan but only in neutral countries. Otherwise, India doesn't want anything to do with Pakistan, which for lack of bonhomie, regularly breaches the LoC and engages in trans-border terrorism.

The ties between India and Pakistan are nothing to talk about; yet, the current set of people in control of Bangladesh think it's the best model for the Bangladesh of today. Will Bangladesh be satisfied with "no trade, air, bus, or rail links" with India? Bangladesh's "Hindu Policy" isn't helping Bangladesh, which will be the bigger loser if Bangladesh continues with its "Muslims first" policy against India. It is not on "Hindu India" but on "Muslim Bangladesh" to walk both countries back from the brink. There will always be critics, those who have their own idea of what constitutes "communal harmony", and who wouldn't mind if India's rightwing leadership gets the short end of the stick. The Indian Opposition has its own reasons for giving Mohammad Yunus a long rope. Having said that, what is the NDA government of Prime Minister Narendra Modi doing to protect and liberate Bangladeshi Hindus from the clutches of narrow Islamic fundamentalism? There are no answers forthcoming, the Modi regime is far from the madding crowd, leaving the feeling that Modi has cut himself out by telling the world, "this is not an era for wars." For, the world knows, the only way to get Bangladesh to stop the "Hindu Genocide" in that country is to go to war with it.

The mills of Bombay (now Mumbai) were serious cash – generators. Obviously many independent trade unions, not affiliated to any left party, have came up. They functioned more on the regional affinity line.





The French voted against all this in the summer. The parallels in Britain are striking. Britain's first-past-the-post election did not deliver a hung parliament, but a proportional system would have done.

The "centre" was rejected, with Labour and the Conserva-



tives receiving their lowest combined vote share in a century. Labour were less popular at the last election than at any stage of Jeremy Corbyn's leadership, but they have still managed to become more unpopular since. One poll this week put them in third place, behind both the Tories and Reform UK. Reform is surging. The far-right threat so ob-

vious in France applies in Britain too. As Trademark Belfast's Stiofan Nuaillain told the TUC's anti-racism conference on Wednesday, we have four years to beat the far right. O Nuallain pointed out that the key to far-right success has been presenting itself as the alternative to the status quo.



US: 1.1 million oven gloves recalled after consumers report 92 minor burns

New York, Dec 14 (IANS): US video and e-commerce retailer QVC is recalling about 1.1 million of its "Temp-tations Oven Gloves" because they fail to provide sufficient heat protection, according to a notice published by the US Consumer Product Safety Commission. QVC has received 162 reports of insufficient heat protection, including 92 minor burns, reports Xinhua news agency. Consumers in possession of the now-recalled gloves are urged to stop using them immediately and contact QVC for a refund. More information can be found on the recall's online registration page. According to the recall notice, the oven gloves were sold online at qvc.com as well as through QVC's televised and digital shopping platforms from August 2018 to August 2024 for between 4 dollars and 13 dollars a pair.

12 killed, dozens injured in attacks on Ukrainian cities

Kyiv, Dec 14 (IANS): At least 12 people were killed and 39 others injured in Russian attacks on Ukraine, authorities reported. Ten people lost their lives, and 20 others were injured when guided aerial bombs struck the southern city of Zaporizhzhia, igniting a fire at a car service station, said the State Service for Emergencies on Saturday. The blaze, which spread to an area of 250 square metres and damaged six vehicles, was extinguished, Xinhua news agency reported. In central Ukraine's city of Kryvyi Rih, a ballistic missile hit a civilian administrative building, killing two people and injuring 19 others, said Oleksandr Vilkul, head of the city's defense council. Vilkul said the attack also damaged six apartment buildings, five private houses, and several vehicles.

Lebanese army deploys along border as Syrian conflict escalates

Beirut, Dec 14 (IANS): The Lebanese army has reinforced its deployment along the Lebanese-Syrian border in the Bekaa region amid escalating conflicts in Syria, according to security sources. The move comes as Lebanon fears that the intensifving clashes between the Syrian government and rebel groups could increase the likelihood of extremist groups reaching the Lebanese border, Xinhua news agency reported. Anonymous Lebanese security sources told Xinhua that the army had heightened its readiness and strengthened its presence along the 375-km border separating Lebanon and Syria. They added that units from the Airborne Regiment had been deployed to the eastern mountain range near the Syrian border, along with



land border guards assigned to monitor mountain paths and illegal crossings linking the two countries. Lebanon remains concerned about a repeat of the events of 2014, when armed groups from ISIS and Jabhat al-Nusra stormed the border town of Arsal, killing soldiers and civilians before occupying areas along the Lebanese-Syrian border for years. Meanwhile, the General Directorate of Public Security issued a statement on Friday announcing the closure of several land border crossings.



National Assembly in S.Korea to vote on Yoon's impeachment motion amid president's public apology

Seoul, Dec 14 (IANS): The National Assembly is set to vote on Saturday on an impeachment motion against South Korean President Yoon Suk Yeol over his short-lived attempt to impose martial law earlier this week, which left South Korea in political turmoil. The plenary session for the motion will be held at 5 p.m., yet it remains unclear whether the motion submitted by opposition lawmakers will get the two-thirds majority required to pass, Yonhap news agency reported. Earlier in the day, Yoon delivered a nationally televised apology for the public anxiety caused by his botched attempt on Tuesday night, while pledging not to make such an attempt again.

Cabinet green lights Rs 6,230 crore Rithala-Kundli corridor of Delhi Metro

New Delhi, Dec 14 (IANS): The Union Cabinet, chaired by Prime Minister Narendra Modi, on Saturday approved the Rithala-Narela-Nathupur (Kundli) corridor of Delhi Metro's Phase-IV project with Rs 6,230 crore outlay. The 26.463 km-long corridor will further enhance connectivity between the national capital and neighbouring Haryana. The corridor is scheduled to be completed in 4 years from the date of its sanction, said the Cabinet.

The completion cost is to be implemented by Delhi Metro Rail Corporation Limited (DMRC) under the existing 50:50 Special Purpose Vehicle (SPV) of the central government and the Government of National Capital Territory of Delhi (GNCTD) in four years. According to a Cabinet note, this Metro line will be an extension of the presently operational Shaheed Sthal (New Bus Adda)-Rithala (Red Line) corridor and will boost connectivity in the north-western parts of the national capital in areas such as Narela, Bawana, parts of Rohini etc.

The entire stretch will comprise 21 stations. All the stations of this corridor will be elevated. This corridor will be Delhi Metro's fourth extension into Haryana. Presently, the Delhi Metro operates up to Gurugram, Ballabhgarh and Bahadurgarh in Haryana.





J&K Police, BSF carry out joint patrolling along IB in Samba

Jammu, Dec 14 (IANS): J&K Police personnel and Border Security Force (BSF) troopers carried out joint patrolling along the international border (IB) in Samba district on Saturday, officials said. Centre committed to buy farmers' produce at MSP of 50 pc above cost: Shivraj Chouhan

New Delhi, Dec 14 (IANS): Union Minister for Agriculture & Farmers' Welfare Shivraj Singh Chouhan on Saturday said that the Centre will not only fix the Minimum Support Price (MSP) for crops at more than 50 per cent of the production cost but also procure the produce from farmers. Speaking in the Rajya Sabha, he said that the Congress had previously denied farmers the Minimum Support Price (MSP) for their crops.

"In contrast, the Central Government, led by Prime Minister Narendra Modi, has consistently increased the MSP over the last decade," the minister said.

He highlighted that in 2015, the ministry was renamed as the Ministry of Agriculture and Farmers' Welfare, marking a significant shift towards prioritising farmers' welfare, which was previously lacking.

He said that when the Congress was in power, they said that they cannot accept the recommendations of the MS Swaminathan Com-



mission. In 2019, Prime Minister Narendra Modi's government decided that MSP rates would be fixed by adding 50 per cent profit on the cost.

"When the Congress government was in power, they never gave more than 50 per cent profit to the farmers on cost, but we are committed to buying the crops of the farmers by giving at least more than 50 per cent profit," he said. "There has been an unprecedented increase in the budget allocation for agriculture. Till 2013-14, it was only Rs 21,900 crore, which has now been increased to Rs 1.23 lakh crore," he pointed out.

"We have six priorities for farmers' welfare -- we will increase production, reduce the cost of production, give fair price for the production if there is any loss in the crop, we will compensate for it through Pradhan Mantri Fasal Bima Yojana, we will diversify agriculture and by taking them towards natural farming.

INDIA bloc in Manipur urges PM Modi to visit state to resolve ethnic crisis

New Delhi/Imphal, Dec 14 (IANS): The 10-party INDIA bloc in Manipur on Saturday urged Prime Minister Narendra Modi to visit Manipur, at the earliest convenience or hold talks with political parties from the state in New Delhi. The bloc, led by the Congress, submitted a letter to the Prime Minister's Office (PMO), requesting him to visit Manipur to resolve the 19-month-long ethnic conflict. Manipur state Congress President Keisham Meghachandra Singh, while talking to the media in Delhi, said that the leaders of the INDIA bloc sought permission to hold a sit-in demonstration in Jantar Mantar but the authorities declined permission. "It is very unfortunate that we can't practise our right to protest unprecedented turmoil... Our movement will not stop. We will continue to protest in different forms," said Singh, who was part of the delegation of leaders of the bloc's parties. He said that due to the 19-monthlong ethnic violence over one lakh people were displaced from their homes and villages while a few hundred people were killed and hundreds of others injured.

The violence also destroyed huge



amounts of property of the people of different communities, the Congress leader said, adding that the continued violence has also further escalated the turmoil with unprecedented pain, trauma, fear and complete helplessness among the people of Manipur.

SC issues notice on PIL raising concerns on removal of ICC members in private sector

The Supreme Court on Saturday agreed to examine a public interest litigation (PIL) seeking the introduction of safeguards for the members of the Internal Complaints Committee (ICC), constituted under the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013, in the private sector.

A bench of Justices Surva Kant and Ujja Bhuyan issued notice and sought responses from the Union Ministries of Women And Child Development and Corporate Affairs, and the Nation Commission For Women in the matter.

As per the computerised case status, the matter is tentatively listed for hearing on January 24, 2025.

The plea, filed through advocate Munawwar Naseem, said that though Internal Complaints Committees are bestowed with the power of

New Delhi, Dec 14 (IANS): a civil court but ICC members, akin to judges, have not been provided with any safeguards, which will enable them to act without fear and favour.

"An anomalous situation has arisen where ICC members have been conferred quasi-judicial powers without the requisite independence and safeguards. Samsung to launch 'extended reality' headset next year

Seoul, Dec 14 (IANS): South Korean tech giant Samsung Electronics said on Saturday it will launch an "extended reality" (XR) headset jointly developed with Alphabet's Google and Qualcomm in global markets next year.

The extended reality headset is part of wearable devices to be powered by the new version of Google's Android software -- called Android XR -- developed in tandem with Samsung.

"The XR headset product will arrive in global markets sometime next year. No further details are available about the product for now," a company spokesperson said over the phone, reports Yonhap news agency. Extended Reality is a blanket term that refers to a range of virtual-, augmented- and mixed-reality technologies.

The new headset, code-named Project Moohan, taken from the Korean word for "infinity," will have Google's Gemini chatbot built into its core, allowing users to control their apps with conversational commands and physical gestures.

The Samsung headset is equipped with Qualcomm's XR2 Gen 2 chip for mixed-reality devices.

Commercial-level air taxis arriving soon in South Korea

Seoul, Dec 14 (IANS): The transport ministry said on Saturday it will conduct a flight demonstration of a commercial-level air taxi model this week, as part of a government project to introduce the urban air mobility (UAM) industry in the country. The ministry will demonstrate the operation of the S-4 model built by U.S. electric aircraft manufacturer Joby Aviation Inc. at the Korea Aerospace Research Institute's aviation center in Goheung.



Zomato gets GST tax demand notice of Rs 803 crore

Mumbai, Dec 14 (IANS): Food delivery and quick commerce services provider Zomato has received a tax demand notice of Rs 803 crore from the Goods and Services Tax (GST) department.

In a stock exchange filing, the company said this notice has been given by the Joint Commissioner of CGST and Central Excise in Thane. This tax notice includes GST demand and interest and penalty.

"This tax demand notice is for not paying GST on delivery charges. The total amount of Rs 803 crore includes GST demand of Rs 401.7 crore and interest/penalty of the

same amount," according to the exchange filling.

The company further said, "We believe that we have a strong case on merits, supported by the opinion of our external legal and tax advisors. The company will file an appeal against the order before the appropriate authority."

Earlier, in January and June this year, Zomato received Rs 4.2 crore and Rs 9.45 crore GST demand notices, respectively.

Zomato in 2023 received a GST



demand notice of Rs 400 crore on delivery charges. Delivery charges are levied by Zomato, Swiggy and other food and quick commerce companies on their services.

"These companies claim that gig

workers work as delivery partners. They are paid on an order basis. This delivery charge collected from the users is given directly to the gig worker," according to reports.



India's industrial growth to accelerate, inflation to ease in 2nd half of 2024-25: Report

New Delhi, Dec 14 (IANS) : India's industrial activity is expected to accelerate in the second half of the current financial year on the back of recovering consumption demand and higher export growth while inflation is likely to ease, according to a CRISIL report released on Saturday. "So far, high food inflation, elevated interest rates and slowing credit growth have impacted consumption recovery. However, with food inflation showing signs of easing, the space for discretionary consumption is expected to increase," the report states. Moreover, the rural economy will likely improve following healthy agricultural production this year, it adds.

Passenger vehicles clock highest ever November sales in India

New Delhi, Dec 14 (IANS): Passenger vehicles in India saw their highest-ever November sales at 3.48 lakh units, with a growth of 4.1 per cent as compared to the same month last year, according to figures released by the Society of Indian Automobile Manufacturers (SIAM) on Saturday. Though the Diwali festival did not fall in the month of November, the two-wheeler segment posted sales of 16.05 lakh units, crossing the 16 lakh units mark for the first time in a non-Diwali November, the figures showed. The total production of automobiles during the month including of passenger vehicles, three wheelers, two wheelers, and quadricycle in November 2024 was 24,07,351 units. "The demand momentum which was seen in October during the festive period has continued in November for the industry as a whole," said Rajesh Menon, Director General, SIAM.

Data released by the auto manufacturers earlier this month showed there was an uptick in the sale of cars and SUVs in the domestic market during Nov with market leader Maruti Suzuki India Ltd, Tata Motors and Toyota Kirloskar recording an increase in dispatches to dealers during the month. Maruti Suzuki's total domestic passenger vehicle sales went up to 141,312 units during November this year from 134, 158 units in the



same month last year. The main growth was recorded in the SUV segment where sales of its popular models such Brezza, Grand Vitara and Jimmy surged to 59,003 units during the month from 49,016 units in Nov 2023. Toyota Kirloskar Motor (TKM) registered a monthly sales volume of 25,586 units in November 2024, representing a 44 percent increase over the 17,818 units sold in the same month last year. In addition, the company exported 1140 units. "Our diverse portfolio, spanning from hatchbacks to SUVs, continues to offer tailored mobility solutions that resonate with varying lifestyles," TKM Vice President, Sales-Service-Used Car Business Sabari Manohar said in a statement. The year 2024 has exceeded the company's expectations, he said. Tata Motors recorded a 2 per cent year-on-year increase in passenger vehicle sales during November this year at 47,117 units.

India's GDP growth to hold steady in FY25, likely to clock 6.7 pc in FY26 Mumbai, Dec 14 (IANS):

India's economic growth will continue to hold steady in FY25 despite global uncertainties, with a projected GDP at 6.7 per cent in FY26, a report showed on Saturday. CareEdge Ratings said that it expects Indian government to continue on the path of fiscal consolidation and projects India's GDP growth to remain healthy at 6.5 per cent in FY25 and 6.7 per cent in FY26.

"We expect to see improvement in private investment in 2025, supported by anticipated monetary policy easing," said Sachin Gupta, Chief Rating Officer and ED, CareEdge Ratings.

The report said that CPI inflation is expected to moderate in the coming quarters. It expects food inflation to moderate, driven by a strong kharif harvest and favourable conditions for rabi sowing.

The CPI inflation, excluding vegetable inflation, has been below 4 per cent in the last few months. The average CPI inflation is projected at 4.8 per cent in FY25 and 4.5 per cent in FY26. Core inflation is expected to remain benign, averaging 3.5 per cent in FY25 and 4.3 per cent in FY26.

The Lashkare-Taiba terror group had carried out the 2008 Mumbai attacks, one of the deadliest terror attacks in the country. The matter was immediately escalated to the Mumbai Police, who conducted a search. However, nothing suspicious was found. 193 cases pending before **Constitutional Benches of SC**

These 193 cases are in addition to the others pending before Division Benches, Chamber-Judge and Registrar Court, estimated to be over 80,000. Minister of State (Independent Charge), for Law and Justice Arjun Ram Meghwal, in a written reply in Lok Sabha, said the disposal of cases is within the exclusive domain of the judiciary. However, as per information provided by the Supreme Court, numerous IT initia-

tives to streamline the day-to-day operations have been carried out by the top court to handle the increasing pendency of cases. Responding to a question by Kuldeep Indora of the Congress on reasons behind the accumulation of these cases, MoS Meghwal said, "There is no single conspicuous reason for pendency of cases. It is a multi-faceted situation. The increase in the population of the country, ease of access, and awareness amongst the public have contributed to the filing of fresh cases that are continuously increasing year after year. The pandemic, which set in around 2020, has also contributed significantly in increasing the



pendency in the last four years." Highlighting the Centre's efforts to augment judicial infrastructure, the MoS said, "As on date, Rs 11571.57 crore have been released since the inception of the Centrally Sponsored Scheme (CSS) for Development of Infrastructure Facilities for the Judiciary in 1993-94." "The number of court halls has increased from 15,818 as on June 30, 2014 to 23,590 as on October 31, 2024, and the number of residential units has increased from 10,211 as on June 30, 2014 to 21,076 as on October 31, 2024, under this scheme," MoS Meghwal said. Clashes reported in Syria's Dara amid murky situation in Homs

Damascus, Dec 14 (IANS): Heavy clashes broke out Saturday in parts of Syria's southern Daraa province as local factions seized multiple government-held positions. Meanwhile, in central Homs province, the Syrian army asserted that its defenses remain solid despite opposition claims of troop withdrawals.

Pro-government Sham FM radio said clashes erupted in eastern rural Daraa and near the Nassib border crossing with Jordan, though the militants had not entered the compound

The Syrian Observatory for Human Rights, a Britain-based war monitor, reported that factions in western Daraa took over several government sites in the city of Nawa, including the local security branches. At least one civilian was killed, and government soldiers stationed in the targeted buildings were reportedly captured. In response, government forces shelled residential areas from their nearby positions, triggering panic among civilians, according to the Observatory, Xinhua news agency reported. WHO joins investigation in Congo undiagnosed disease

Kinshasa, Dec 14 (IANS): The World Health Organisation (WHO) is deploying experts to support health authorities in the Democratic Republic of the Congo (DRC) with investigations to determine the cause of a yet undiagnosed disease that has been reported in Panzi, a locality in Kwango Province in the southwest of the country.

The WHO experts are joining the Congo response team and are on their way to Panzi, the WHO regional office for Africa confirmed in a statement on Saturday, Xinhua news agency reported. An initial local WHO team has been supporting the health authorities in Kwango since the end of November to reinforce disease surveillance and identify cases.

"Our priority is to provide effective support to the affected families and communities. All efforts are underway to identify the cause of the illness, understand its modes of transmission, and ensure appropriate response as swiftly as possible," said WHO Regional Director for Af-



rica Matshidiso Moeti. According to the Congo public health ministry, 394 cases and 30 deaths have been reported so far in the Panzi health zone. Symptoms of the illness include headache, cough, fever, breathing difficulties, and anaemia. A respiratory pathogen such as influenza or Covid is being investigated as a possible cause, as well as malaria, measles, and others. Until laboratory test results are received, the cause remains unclear, said the WHO.

Panzi is a rural community located more than 700 km from the capital of Kinshasa. Access by road is difficult, and the communication network is limited.



Russia sees rise in new year holiday hotel cost

Moscow, Dec 14 (IANS): The average hotel cost in Russia for this year's New Year holidays increased by 19 per cent from the same period last year, the latest data from analytics firms showed. The mean cost of short-term rental apartments for the holidays in the 16 largest cities in Russia also rose by 16 per cent year on year to about 8,000 rubles (around 81 US dollars) per day, according to CIAN. Analytics, Xinhua news agency reported. The price rise is most noticeable in Moscow, where an apartment for a weekend costs 25.7 per cent more than during the

previous holiday season, the data showed. Analysts attributed the price increase to growing demand and limited hotel supply during the New Year holidays. TravelLine, an online hotel reservation provider, showed that the volume of hotel bookings in popular destinations during the New Year holidays increased by 6.9 to 25.2 per cent year on year. Thirty-three million tourist trips are expected across Russia in the winter season, up by 13.8 per cent year on year, Russian Minister of Economic Development Maxim Reshetnikov has



Singapore's charity launches fundraiser for migrant workers with critical illnesses Singapore, Dec 14 (IANS): A

Singaporean charity has unveiled a new initiative to support migrant workers facing critical illnesses, aiming to raise 410,500 Singapore dollars (about \$307,875) to assist 20 workers over the next two years. According to the fund's founders at a press briefing on Saturday, the CritiCare Fund for Migrant Workers seeks to bridge the financial gaps for workers whose insurance payouts fall short of covering treatment costs, Xinhua news agency reported. Donations will be managed by Ray of Hope, a registered charity overseen by Singapore's Ministry of Social and Family Development. Disbursement decisions will be made by a community-led council that includes doctors, civil society folks, employers, migrant workers and others. The council has estimated that each case will require approximately 20,000 Singapore dollars, setting aside an additional 10,500 Singapore dollars for administrative expenses. The team will also collect data on the incidence of critical illnesses among migrant workers.

The SAA pilots started the strike Saturday following a breakdown in salary negotiations with the company. This resulted in the cancellation of nearly half the carrier's flights on that day, Xinhua news agency reported. The SAA said the strike was suspended Saturday morning after the pilots reached an agreement with the South African Airways Pi-

lots Association (SAAPA). The airline said they offered an additional one per cent salary increase, resulting in a total salary increase of 9.47 per cent for the pilots. "As part of the agreement that broke the deadlock in wage negotiations, engagements on a continuous enterprise improvement program will continue over the next eight weeks. We are committed to implementing work-life concessions that should enhance the productivity of our worldacclaimed pilots."



Italy vows to continue supporting Lebanon's army

The decision comes amid several members of this iconic institute of the country holding a sit-in-protest against the show-cause notice

Kolkata, **Dec 14 (IANS)**: as well as the decision to replace three departmental heads within the institute in the last two days. IITTA insiders claimed that the sitin protest might also be followed by a hunger strike by some of the protesting faculty members of IIT-Kharagpur.

The protesting faculty members have already sought the intervention of the Chairman of the Board of Governors in the matter.

Subsidiary of US consulting co. pays \$122 mn to resolve S. Africa bribery case involving Indian ex-executive

New York, Dec 14 (IANS): A subsidiary of global consulting company McKinsey has reached a \$122.85 million settlement with US prosecutors in a South African bribery case involving a former Indian executive, according to officials. "McKinsey Africa has agreed to pay a criminal penalty of more than \$122 million" to resolve the case of bribery of "South African officials in order to obtain lucrative consulting business that generated tens of millions of dollars in profits," Principal Deputy Assistant Attorney General Nicole M. Argentieri said on Saturday.

The Department of Justice (DOJ) said that between 2012 and 2016 the subsidiary of the global consultancy company McKinsey through its senior partner Vikas Sagar agreed to pay bribes to former officials of state-owned South African companies to get confidential information that netted the company \$85 mil-



lion in profits. It said that Sagar, 56, had separately pleaded guilty "to participating in a conspiracy to violate the Foreign Corrupt Practices Act" in a case before the federal court of the Southern District of New York in Manhattan. In court documents, federal prosecutor Damian Williams said Sagar would forfeit -- meaning the government will seize -- all his property traceable to the bribery scheme. Court papers identified Sagar as an Indian citizen with a green card who was living in South Africa.




Death toll from monkeypox in Africa rises to 1200 as cases exceed 62,000 : Africa CDC

Addis Ababa, Dec 14 (IANS): The death toll from the ongoing monkeypox outbreak in Africa has reached 1,200, with the number of cases reported so far this year surpassing 62,000, according to the Africa Centers for Disease Control and Prevention (Africa CDC).

During an online media briefing

Data from the African Union's specialized healthcare agency show that during last week alone, the African continent reported 2,708 new cases, including 565 confirmed cases and 36 deaths, Xinhua news agency reported. "If we compare from the first week of January to the final week of November 2024, we have an increase of more than 716 percent (compared to the entire 2023). If we continue with this trend, for sure, by the end of December, we will have more than 800 percent increase of cases compared to 2023," Kaseya said. "This is evidence that after the COVID-19 pandemic, monkeypox is the largest outbreak that Africa is facing." The Africa CDC chief added that the African continent is presently facing different monkeypox outbreaks, with the combination of four strains of the virus. "In some places, we have a combination of different clades, and this is what makes monkeypox more complicated in terms of appropriate response.'



Erdogan hopes Syrian opposition to march 'without accidents'

Turkish President Recep Tayyip Erdogan expressed hope on Saturday that Syrian opposition forces' march will "continue without accidents," the TRT World reported. "Idlib, Hama, Homs, and the target, of course, is Damascus. The opposition's march continues. Our wish is that this march in Syria continues without accidents or disasters," Erdogan told reporters in Istanbul after Friday prayers.

The Turkish leader also voiced frustration with Syrian President Bashar al-Assad, whom he accused of rejecting dialogue. "We reached out to Assad, saying, 'Come, let's shape Syria's future together.' Unfortunately, we did not receive a positive response," Erdogan said.

Istanbul, Dec 14 (IANS): Assad has previously indicated openness to dialogue with Ankara but insisted on respect for Syria's sovereignty and prioritizing counter-terrorism efforts as prerequisites for improved relations, Xinhua news agency reported.

> Ankara has long supported Syrian opposition forces seeking to oust the Iran and Russia-backed Assad government. However, Türkiye also views some regional actors as terrorists, including Hayat Tahrir al-Sham (HTS), a former Al-Qaeda affiliate that is now leading the ongoing rebel offensive in Syria.

> "The ongoing troubled advances in the region are not unfolding as desired, and Türkiye does not wish for such developments," Erdogan said, without explaining further.

UNICEF seeks \$278 million to support South Sudanese children in 2025

Juba, Dec 14 (IANS): The United Nations Children's Fund (UNICEF) on Saturday issued an urgent appeal for \$278.2 million to support children in South Sudan in 2025 amid an escalating humanitarian crisis.

UNICEF highlighted the worsening situation in South Sudan, where funding gaps have severely hampered the humanitarian response. "Approximately 9 million people, including 4.9 million children, 2.2 million women, and 1.4 million people with disabilities, will need humanitarian assistance," the UN agency said.

South Sudan is bracing for a challenging 2025, with deepening vulnerabilities, rising humanitarian needs, and significant reductions in aid budgets. The political landscape remains fragile following a two-year postponement of general elections initially scheduled for December, Xinhua news agency reported.

UNICEF noted that a convergence of crises, including extensive flooding linked to climate change, conflicts, disease outbreaks, economic deterioration, and an influx of refugees and returnees fleeing war in Sudan, has exacerbated the country's challenges.
