# 'One Nation, One Election' Bill

### tabled in Lok Sabha, Opposition protests

New Delhi, Dec 17 (IANS): Union Law Minister Arjun Ram Meghwal introduced the Constitution Amendment Bill for 'One Nation, One Election' (ONOE Bill) in the Lok Sabha on Tuesday. The tabling of the ONOE Bill set the stage for yet another showdown in Parliament as Opposition parties stood in protest, demanding its withdrawal over its 'anti-constitutional and anti-democratic' nature. Congress leaders, in a scathing critique of the government, demanded that the Bill be withdrawn immediately. Home Minister Amit Shah rebutted the charge and said that it has become a habit of the Congress party to oppose progressive legislations. The TDP, a key BJP



ally expressed unwavering support to the ONOE Bill and said that this will not only ease India's fiscal burden but will also cut down the electoral expenses by more than 40 per cent. Among the parties who vociferously opposed the ONOE Bill were the Trinamool

Congress, Samajwadi Party, the Shiv Sena (UBT), AIMIM and more. All of them called the Bill an assault on the Constitution and a brazen attempt to 'kill democracy and bring authoritarianism and dictatorship.' Continued on pg 02

Komatireddy also revealed that initiatives are underway to provide high-quality free education and healthcare in Telangana, similar to the services available internationally. Furthermore, he mentioned that a nodal officer will be assigned to oversee the collaboration between the Roads and Buildings and Medical departments for the construction of the TIMS Hospital in Erragadda, Sanath Nagar.

The Minister explained that a coordination meeting will be held with the officials of the two departments in the next two to three days and a route map will be prepared for the activities to be undertaken in the future.

The officials have also been to construct the electricity system, oxygen piping system, and water and drainage systems without any defects.

The Minister also advised officials to make the emergency pickup and drop points, which are crucial for saving the lives of patients in the hospital, more spacious.

Apart from this, the Minister said that if there are problems of space to Alwal TIMS, the NOC will be given. He explained that the construction of LB Nagar TMS will be speeded up. Similarly, in the next two or three months, the construction of new Osmania hospital will be done at the Goshamahal Stadium.

#### Calcutta HC extends stay on demolition of hotels at Mandarmani

Kolkata, Dec 17 (IANS): The Calcutta High Court on Tuesday extended the stay, till January 24, on a notification by the District Magistrate of West Bengal's East Midnapore district for the demolition of 140 hotels, resorts, and lodges at the seaside of the popular coastal tourist hub of Mandarmani. Extending the stay on the demolition notice, the single-judge bench of Justice Jay Sengupta fixed January 17 as the next day of hearing in the matter. In 2022, the National Green Tribunal directed the demolition of these 140 hotels, resorts, and lodges on the grounds that they were constructed violating the provisions of the Coastal Regulated Zone Management Authority and accordingly, November 20, 2024, was the deadline for the demolition.

Accordingly, the East Midnapore District Magistrate also issued a notification for the demolition. However, on November 19, that is a day before the demolition deadline.

# MAKING JUDICIARY ABOVE SUSPICION IS THE NEW TASK FOR **CHIEF JUSTICE OF INDIA**

The current week is crucial for the Chief Jus tice of India Justice Sanjiv Khanna. He has a new task in hand -making judiciary above suspicion. The task has come on his way through two sets of petitions – the first was relating to the Places of Worship Act, and the second is relating to a sitting judge of Allahabad High Court making Hindutva speeches. Earlier, several judges came under suspicion for aligning with Hindutva forces, during their tenure as judge after retiring or resigning, though by and large, judiciary as a whole still enjoys the credibility of being neutral. A three-judge special bench headed by CJI Sanjiv Khanna will begin hearing on a batch of petitions challenging the constitutional validity of the Places of Worship (Special Provisions) Act 1991, which Ayodhya Verdict of 2019 by a fivejudge bench of the Supreme Court of India had already upheld that bars altering status of any place of worship and maintain the status quo as on August 15, 1947, when India became independent. Though the Places of Worship Act bars entertaining of any case aiming at changing the nature of the places of worship, dozens of cases have been filed in various courts in the country against Mosques and Dargahs (Muslim places of worship), because of a judge on the Ayodhya bench Dr DY Chandrachud had observed in 2022 that the Places of Worship Act does not bar ascertaining of the nature of the place of worship. Since the CJI who led the Ayodhya bench joined the Hindutva political party BJP after a few months following his retirement and was nominated by the party as Member of Parliament in Rajya Sabha, it gave rise to the suspicion, in the backdrop that the bench directed construction of Ram Temple at the place where Babri Mosque was demolished. The suspicion became

Since the Places of Worship Act 1991 held abiding by secularism, a basic feature of the Constitution of India, and the outcome in the case would impact the present and future of the country, the case poses a great challenge before the three-judge special bench. Survival of secularism is at stake which is constitutionally guaranteed. Communal tensions need to be defused at any cost that has propped up on account of cases being filed against Mosques and Dargahs by Hindutva forces claiming historical injustice to Hindus, while the Places of Worship Act prohibits entertaining new cases. Oversight of the fundamental purpose of the Places of Worship Act committed by a judge paving the way for the flood of cases against Mosques and Dargahs, will have to be dealt carefully by the three-judge bench now.

There is another petition before the CJI Justice Khanna made by the Campaign for Judicial Accountability and Reforms (CJAR) on December 10, 2024 against a sitting judge of Allahabad High Court over his recent Hindutva speech at a Vishwa Hindu Parishad event. CJAR has urged for an 'in-house enquiry' for initiating appropriate action against Justice Shekhar Kumar Yadav whose controversial speech has "raised doubts in the minds of average citizens about the independence and neutrality of the judiciary, given the wide coverage it has received, a strong institutional response is needed." Yet it is today in the doldrums, after years mired in an identity crisis. It scored under 3 percent in this year's European Union (EU) elections, dropped out of one eastern state parliament, and now risks losing its cohort in the federal Bundestag. So what went wrong?

For many both in and outside Die Linke, it all boils down to one name: Sahra Wagenknecht. Doubtless, Die Linke's decline has been evident since Wagenknecht, in the 2010s its most prominent representative, began publicly flouting the party line. This began with dubious antiimmigration talking points around 2018 and her abortive attempt to launch a "Gilets Jaunes"style movement under her (not Die Linke's) auspices in 2019.

# **ROMANIA'S ANNULLED ELECTION SETS A DANGEROUS** PRECEDENT FOR EUROPE

The annulment of the first round of Romania's election marks a new phase in European authoritarianism.

Given the growing alienation of populations across the West from "mainstream" politics — Britain is no exception to this — the precedent Romania sets is dangerous. This is the first case in which social media influence has been officially used to annul an election. Rejecting the results of elections which Western governments don't like is common enough: this happened before 2019's military coup in Bolivia, follows every election in Venezuela, and has been applied within Europe too, to Belarus. Recently, the defeat of the pro-EU opposition in Georgia has been contested by the country's president, with the resulting standoff ongoing. But the claims have always been that the election itself was interfered with: that fake votes were included, or real votes excluded, or the process disrupted by intimidation or foul play. eremy Seabrook, who dedicated his life to writings which speak for the underprivileged and oppressed people everywhere, is no more. He breathed his last in a care home in London on November 30.. He was 86. His absence will be deeply felt by friends, admirers and countless readers in many parts of the world.

Although his initial writings were based more on reporting from the UK, he subsequently travelled to many countries of the global south to write about important issues and struggles there.

These were initially published in leading newspapers and journals, but subsequently more in the alternative media, following a pattern which writings of many authors known for their commitment to the underprivileged sections have experienced. There have been very few writers



who have displayed such consistency and continuity in their writings on justice as Jeremy Seabrook. His writings on justice and other issues of high social relevance are marked by deep sympathy for those who deserve and need this the most. Readers often tend to read some of his pages again and again due to the sheer brilliance of his deep insights.



# Iran not to 'pay ransom' to West over nuclear program says first Vice President Reza Aref

Tehran, Dec 17 (IANS): Iran's First Vice President Mohammad Reza Aref affirmed the country's commitment to negotiations over its nuclear program but firmly rejected any form of "paying a ransom," according to Iran's official news agency IRNA.

During a visit to the Atomic Energy Organization of Iran, Aref criticised Western threats to activate the snapback mechanism, which would reinstate international sanctions against Tehran. He emphasised Iran's focus on "constructive interaction" to lift "cruel sanctions" while continuing "peaceful nuclear activities." Aref reaffirmed Iran's readiness to rejoin the 2015 Joint Comprehensive Plan of Action (JCPOA) if other parties also return to compliance. He highlighted Iran's transparency in its nuclear activities and adherence to the safeguards agreement, which ensures the peaceful use of nuclear materials and technology, Xinhua news agency reported. Rejecting recent Western statements on the snapback mechanism, Aref warned that such actions would effectively end the JCPOA, adding, "Our strategy is action for action."

#### Greece: Roman-era statue unearthed in Athens

Athens, Dec 17 (IANS): Greek archaeologists have unearthed a Roman-era statue in Athens, the country's culture ministry

The headless statue, made of white marble, depicts a nude male figure resembling a god in Greek mythology. The statue, which is in good condition, was found a few hundred meters from the ancient Odeon of Herodes Atticus, at the foot of the Acropolis hill, reports Xinhua news agency.





# Arab states reaffirm commitment to women's empowerment at Muscat meeting

Beirut, Dec 17 (IANS): Oman tries' commitment to advancing lenges, including the impact of hosted a high-level regional meeting on Tuesday to review progress in implementing the Beijing Declaration and Platform for Action, nearly 30 years after its adoption, the Lebanonbased UN Economic and Social Commission for Western Asia (ESCWA) announced.

The meeting, attended by ministers, officials, civil society representatives, and UN agencies, concluded with the Muscat Declaration, reaffirming Arab counwomen's rights under the Beijing framework, Xinhua news agency reported. Omani Minister of Social Development Laila Al Najjar emphasised the progress witnessed in Oman in terms of laws and regulations that guarantee the protection of women's rights.

ESCWA Executive Secretary Rola Dashti highlighted over 100 legislative amendments issued across Arab states in the past two years to improve women's rights but acknowledged ongoing chalarmed conflicts on 15 million women in the region.

Discussions focused on combating violence against women, boosting women's economic participation, advancing their decision-making roles, and protecting women in conflicts. UN Women Executive Director Sima Bahous stressed that sustainable development and peace require women's full empowerment and called for transforming commitments into impactful actions.



# Nigerian govt commits over 450 mln USD to natural gas initiative

Abuja, Dec 17 (IANS): The Nigerian government has committed more than \$450 million to the country's compressed natural gas (CNG) value chain since the launch of an ambitious initiative partly to address rising petrol or gasoline costs and promote cleaner energy.

This whopping sum of money was invested into creating CNG mother stations, daughter stations, refueling stations, and conversion centers that are springing up across the most populous African country, Tosin Coker, head of commercial for the Presidential CNG Initiative, Xinhua news agency reported quoting the reporters at the 2024 Nigeria Energy Forum in the southwestern state of Lagos.

Coker said the initiative has successfully converted more than 10,000 vehicles from petrol to CNG. It aims to push the conversion rate to "more than 1 million vehicles using petrol to CNG" by 2027. In May 2023, Nigerian President Bola Tinubu halted the decades-long subsidy on gasoline.

Washington, Dec 17 (IANS): A US federal indictment has charged two former senior Syrian intelligence officials from the regime of former President Bashar al-Assad with "war crimes against Americans and other civilians," the Department of Justice announced.

The indictment accuses Jamil Hassan, 72, and Abdul Salam Mahmoud, 65, of conspiring to commit war crimes by subjecting detainees, including US citizens, to cruel and inhuman treatment at detention facilities such as the Mezzeh Military Airport prison near Damascus, according to the justice department.

Warrants for their arrest have been issued, though both remain at large, the statement read on Tuesday. "The perpetrators of the Assad regime's atrocities against American citizens and other civilians during the Syrian civil war must answer for their heinous crimes."

### **African Union official** calls for collective efforts to curb hate speech

Kigali, Dec 17 (IANS): African Union Special Envoy on the Prevention of Genocide and Other Mass Atrocities Adama Dieng called for urgent actions to combat racism, negative ethnicity, xenophobia, and all forms of intolerance in the region.

Speaking at the International Conference on Genocide Prevention in Kigali, the Rwandan capital, Dieng said on Tuesday that the Rwandan genocide against Tutsi in 1994, in which about a million people were killed, did not start with machetes but dehumanisation of the Tutsi ethnic group.

South Sudan started as a political crisis, where hate speech across ethnic lines was encouraged and instigated, Xinhua news agency reported.

The situation is very fluid, with reports of more people returning in the last couple of days. Transportation routes were disrupted, limiting the movement of people, goods and humanitarian aid, reports Xinhua news agency.

Some looting of civilian properties and factories, as well as warehouses holding humanitarian supplies, has been reported, according to OCHA. "Despite the challenges and the volatile situation, we and our partners continue to provide emergency aid," the office said.

The office said that in northwest Syria, all humania r i a n organisations in Idlib and northern Aleppo resumed regular operations and the three border crossings from Turkey used to deliver aid into Syria remained open.

# Seelampur MLA Rehman quits AAP, accuses Kejriwal of ignoring minority rights & public concerns

New Delhi, Dec 17 (IANS) : In a major setback for the Aam Aadmi Party (AAP) ahead of the upcoming Delhi elections, Assembly Seelampur MLA Abdul Rehman resigned from the party on Tuesday.

In his resignation letter, Rehman accused AAP national convenor Arvind Kejriwal of prioritising political gains over public issues, stating: "The party has become ensnared in power politics and has ignored the rights of Muslims and other

deprived sections of the society. Arvind Kejriwal has continuously avoided addressing public issues for his own political benefit. I will continue to fight for justice and rights."

Rehman's resignation follows his denial of a ticket for the upcoming elections, with AAP replacing him with Zubair Ahmed as the Seelampur candidate in the party's second list.

Rehman sent his resignation just 24 hours after the announcement, accusing the party of neglecting the rights of minorities. In the letter addressed to the national

convenor of the AAP, Rehman stated that the party keeps mum whenever it comes to defending the rights of any community.

He further stated: "Your government's approach during the Delhi riots was disappointing as you did not do anything to ensure that the riots affected people get justice. Nor did you express any sympathy for them."

He added that it has been observed that the AAP has been involved in vote bank politics only. Reports indicate that Rehman's dissatisfaction with AAP had been building for over a month, particularly



after the induction of Zubair Ahmed into the party.

There was already speculation that the AAP MLA would make this move, saying goodbye to the party. He is expected to defect to Congress in days to come.

#### Delhi HC temporarily suspends sentence of expelled BJP MLA Kuldeep Sengar

New Delhi, Dec 17 (IANS): The Delhi High Court on Tuesday ordered a temporary suspension of the sentence of expelled BJP MLA Kuldeep Singh Sengar in connection with the death case of the Unnao rape victim's father.

A bench of Justice Manoj Kumar Ohri took note of the submission that Sengar is suffering from severe lower back aches with Radiculopathy, lower gastrointestinal tract infection, Periodontitis, anxiety and sleeping disorders.

Sengar's application said that he would suffer irreparable loss and injury in case his sentence is not suspended temporarily and he is not released.

Earlier on December 5, a bench of Justices Prathiba M Singh and Amit Sharma granted interim bail for two weeks to Sengar, who is sentenced to life imprisonment for raping a minor girl in Unnao in 2017, in view of his precarious health condition.

It had ordered AIIMS Delhi to undertake Sengar's initial assessment to determine if his ailments could be treated in the national Capital or would require any referral beyond Delhi.

#### Bangladesh's forex reserves dip to \$18.61 bn

Dhaka, Dec 17 (IANS):

Bangladesh's foreign exchange reserves fell by 1.23 billion U.S. dollars to 18.61 billion dollars by the end of November 2024, the latest central bank data showed. The Bangladesh Bank data showed the country's foreign exchange reserves stood at 18,611.40 million dollars on Nov. 28, the last working day of the month, according to the International Monetary Fund (IMF) calculation method, Xinhua news agency reported. The central bank, however, said gross reserves were 24.35 billion dollars by the end of November. The reserves calculated under the IMF's balance of payments and investment position manual method were immediately usable, while gross reserves were also usable subject to the realization of investment.



#### India's trend GDP growth to move closer to 6.5-7 pc in FY25: Crisil

New Delhi, Dec 17 (IANS): The main macro drivers remain healthy and India's GDP growth is likely to move closer to the trend growth of 6.5-7 per cent this fiscal, a Crisil Insight report said on Tuesday. Trend GDP growth is the average sustainable rate of economic growth over time. Private consumption growth in the country has fared better than last year in the first half of the current fiscal (FY25). "While investment growth has moderated relative to last year, its share of GDP remains higher than the pre-pandemic decade,"

Technical factors contributed to an above-trend GDP growth last year. They are expected to have a moderating effect on GDP growth this current fiscal as they

the report mentioned.

"GDP growth had averaged 6.6 per cent in the pre-pandemic decade. This fiscal is likely to see GDP growth move closer to trend growth of 6.5-7 per cent," according to the report.

It is worth noting that the main macro drivers of growth remain healthy. Private consumption grew 6.7 per cent on average in the first half of this fiscal, compared with 4.1 per cent in the corresponding period last year.

## India's banking sector poised for continued resilience: S&P Global

New Delhi, Dec 17 (IANS): India's financial sector is poised for continued resilience, bolstered by structural improvements and robust economic growth prospects, according to the S&P Global Ratings 2025 banking outlook. "We anticipate asset quality will stabilize, with weak loans in the banking sector projected to decline to approximately 3.0 per cent of gross loans by March 31, 2025. This positive trend is supported by healthy corporate balance sheets and enhanced risk management practices," said Deepali Seth-Chhabria, Analyst, S&P Global Ratings.

While underwriting standards for retail loans remain strong and delinquencies manageable, the rapid growth of unsecured personal loans could introduce some risks. S&P Global foresees loan growth slightly outpacing nominal GDP, particularly in the retail segment. However, deposit growth may lag, potentially impacting credit-to-deposit ratios. According to the rating agency, credit costs are expected to normalize from a decade-low of 0.8 per cent in fiscal 2024 to a range of 0.8 per cent - 0.9 per cent. Despite this, profitability should remain strong, with returns on average assets projected around 1.2 per cent in fiscal 2025, she further pointed out.





# 2025 to see new growth opportunities in tier 2, 3 cities for Indian real estate sector

New Delhi, Dec 17 (IANS): After witnessing a bumper growth in 2024 across residential, office and industrial domains, 2025 is likely to be a year of consolidation and continued innovation for the Indian real estate sector, a report showed on Tuesday. While residential and office markets can potentially stabilise after consecutive peaks, industrial and warehousing demand can witness heightened traction, fuelled by rising manufacturing output and a thriving logistics industry, according to a Colliers India report.

In 2025, rapid urbanisation, key infrastructure project completion and industrial corridor development will create new growth opportunities, particularly in tier 2 and 3 cities. In 2024, annual gross leasing across the top six cities reached 47 million square feet by the third quarter of the ongoing year, reflecting a 23 per cent year-on-year

On the residential front, supported by stable interest rates, launches and sales across major cities of the country are likely to end on a strong note this year. Average housing prices across the top eight cities have already surged 11 per cent annually in 2024. The first nine months of 2024 saw a 17 per cent annual growth in industrial and warehousing demand, registering 20.2 million square feet of leasing across the top five cities. Almost half of the leasing activity is expected to come from Delhi-NCR and Chennai.

Institutional inflows in Indian real estate continue to remain healthy in 2024, indicating sustained investor confidence. Of the \$4.7 billion real estate investments during the first nine months of 2024, office and industrial and warehousing segment together accounted for over 70 per cent share.

Buoyed by domestic growth prospects and long-term returns, institutional investments are likely to be around \$5-6 billion by the end of 2024.



#### Chinese automaker Chery launches new model in Israel

Jerusalem, Dec 17 (IANS) : Chinese carmaker Chery began selling a new model in Israel on Tuesday, as announced by its official Israeli dealership, Freesbe. The new model, Arrizo 8, is

a plug-in hybrid mid-size sedan equipped with a 1.5liter turbine engine. It can accelerate from 0 to 100 km/ h in 7.8 seconds and reach a top speed of 185 km/h, with a pure electric range exceeding 100 km, Xinhua news agency reported. Chery entered the Israeli market in November 2022 and has since offered the gasolinepowered crossover models Tiggo 7 Pro, Tiggo 8 Pro, and FX, also known as the Omada 5. In January this year, the company launched its first full-electric model in

# **India glucose monitoring market** to grow at 2pc CAGR by 2033: Report

New Delhi, Dec 17 (IANS): Amid the growing prevalence of diabetes in India, the glucose monitoring market in the country is forecast to grow at a 2 per cent compound annual growth rate (CAGR) during 2024-33, according to a report on Tuesday.

The report by GlobalData, a data and analytics company, said that the growing prevalence of diabetes in India, combined with limited access to reliable monitoring tools, presents a significant public health challenge.

Effective glucose monitoring is crucial for disease management, yet affordability and accuracy remain key barriers. In 2024, India's glucose moni-



toring market accounted for about 10 per cent of the Asia-Pacific (APAC) market. The report said this reflects the growing focus on affordable and innovative solutions tailored to local needs. "Despite the growing availability of glucose monitoring solutions in India, there remain significant gaps in affordability, user education, and accessibility, particularly in rural areas. Locally manufactured devices can help bridge these gaps, but broader efforts in education and support systems are vital for effective diabetes management," said Kanchan Chauhan, Medical Devices Analyst at GlobalData.

# India sees over 90 pc rise in smartphone exports in Nov, Apple leads

New Delhi, Dec 17 (IANS): India has seen a record smartphone exports in November this year, surpassing the Rs 20,000 crore mark for the first time in a month, which was led by Apple. According to industry data, smartphone exports crossed Rs 20,300 crore, a more than 90 per cent rise from the same period last year. Apple led the exports last month, followed by Samsung. In November last year, the smartphone exports from the country was over Rs 10,600 crore, as per the industry data. The smartphone market in the country is expected to exit 2024 with a singledigit annual growth. Meanwhile, riding on the government's production-linked incentive (PLI) scheme, Apple's iPhone production in the country reached \$10 billion in the seven months of this fiscal (FY25), with \$7 billion in exports alone which is a record.

The tech giant manufactured/assembled \$14 billion of iPhones in India last fiscal (FY24), with exporting more than \$10 billion worth of iPhones. According to Union Electronics and



IT Minister Ashwini Vaishnaw, this is yet another milestone for the smartphone PLI scheme in 7 months. "\$10 billion iPhone production by Apple with \$7 billion exports. Total smartphone exports from Bharat crossed \$10.6 billion in 7 months," the minister had posted on X last month. India's smartphone market is estimated to

grow 7-8 per cent this year, driven by strong demand for premium, 5G and AI smartphones. The mobile handset market in India is expected to maintain steady growth. According to industry experts, to achieve the goal of \$500 billion local electronics manufacturing by FY30.

# 123 regular Ayush, 221 e-Ayush visas issued to foreigners in one year: Centre

About 123 regular Ayush visas and 221 e-Ayush visas have been issued to foreigners seeking treatment in India, between July 2023 and December 2024, said the Union government on Tuesday.

During the same period, 17 e-Ayush attendant visas have also been issued, said Union Minister of State (Independent Charge) for Ayush Prataprao Jadhav in a written reply in Rajya Sabha.

On July 27, 2023, the Government introduced a separate category of Ayush Visa for foreigners visiting India for availing treatment under the Ayush system of medicine.

New Delhi, Dec 17 (IANS): Ayush Visa is available under four sub-categories namely: Ayush visa; Ayush attendant visa; e-Ayush visa and e-Ayush attendant visa. An Ayush Visa is granted to a foreigner whose sole purpose is to seek treatment through Ayush systems. "A total of 123 regular Ayush Visa, 221 e-Ayush Visa and 17 e-Ayush Attendant Visa have been issued till December 4," MoS Jadhav said.

The Ministry of Health and Family Welfare also has launched an official portal for Medical Value Travel (MVT), which is the Advantage Healthcare India portal. The "one-stop" portal aims to facilitate information for those who want to avail medical treatment in India from abroad. The Govern-



ment aimed to sensitise the stakeholders like Ayush facility providers and others involved in MVT.

# NIA arrests absconder in Laos human trafficking, cyber slavery case

New Delhi, Dec 17 (IANS): A man who arranged flight tickets and documents for victims in Laos human trafficking and cyber slavery case was arrested by the National Investigation Agency (NIA) in coordination with the Delhi Police's Special Cell, an official said on Tuesday. Kamran Haider's arrest on Monday marked a significant step by the agency towards dismantling the international human trafficking syndicate, said the official. Along with co-accused, Kamran Haider was directly involved in arranging flight tickets and documents for the victims, and in facilitating their illegal border crossings, with the help of contacts in the Golden Triangle Region, he said.

NIA had charge-sheeted Kamran and four others in October 2024 in relation with a network of traffickers and touts involved in various illegal activities. The four co-accused were identified as Manjoor Alam alias Guddu, Sahil, Ashish alias Akhil and Pawan Yadav alias Afzal alias @ Afroz.

All the accused were involved in sending vulnerable Indian youths to the Golden Triangle Region in Lao PDR, where they were forced to commit cyber scams targeting European and American citizens.

### Digital arrest: 1700 Skype IDs; 59000 WhatsApp accounts blocked

New Delhi, Dec 17 (IANS): The Indian Cyber Crime Coordination Centre (I4C) identified and blocked more than 1,700 Skype IDs and 59,000 WhatsApp accounts used for Digital Arrest, the Parliament was informed on Tuesday. Minister of State for Home Affairs Nityanand Rai told Lok Sabha that till November 15, more than 6.69 lakh SIM cards and 1,32,000 IMEIs as reported by police authorities have also been blocked by the Central government.

Replying to a question on cyber frauds and crimes from K. Eswarasamy of DMK, MoS Rai said, "The Ministry has set up the I4C as an attached office to deal with all types of cyber crimes in the country, in a coordinated and comprehensive manner." The Indian Computer Emergency Response Team (CERT-In) is also operating an automated cyber threat exchange platform for collecting, analysing.

Lamola noted the pivotal role of Sherpas in translating G20 leaders' commitments into actionable cooperation.

# Tunisia busts drug trafficking network near capital

**Tunis, Dec 17 (IANS):** Tunisian security units have dismantled a drug trafficking network active in the Grand Tunis area, the largest metropolitan area in Tunisia, seizing 3 kg of cocaine, the National Guard said Tuesday on its Facebook page.

In two separate operations, the security units arrested five individuals and seized the cocaine, varying quantities of narcotic pills, money, jewelry, and three vehicles, said the National Guard.

It provided no information on the timing of the operations or the nationalities of the suspects

The Tunisian government has taken a strong stance against drug trafficking, with hundreds of individuals involved in the crime arrested during recent nationwide operations, Xinhua news agency reported.



# Ghana's president-elect vows governance reforms to spur national development

Accra, Dec 17 (IANS): Ghana's Presidentelect John Dramani Mahama vowed to "initiate important governance reforms and sometimes severe measures" over the next four years to reset the nation and bring it back on track as "the Black Star of Africa." Mahama made the remarks in a speech to thousands of party supporters at his campaign office in the capital of Accra late Monday, shortly after being declared by Ghana's Electoral Commission the winner of the 2024 presidential election held on December 7, reports Xinhua news agency. "This mandate represents a call to action... This mandate marks a new beginning and sets the tone for a new direction for our beloved country. Ghana is not for one man or one family. It is for all of us, and we must not only be born and die here, but we must all live here with satisfaction," he said in the speech.



# South Korea vows unhindered preparations for US policy shifts amid political turmoil

**Seoul, Dec 17 (IANS):** South Korea's trade ministry said Tuesday it will work closely with related government agencies and local businesses to avoid any disruptions in preparing for the launch of the new US administration amid ongoing domestic political turmoil.

Trade Minister Cheong In-kyo discussed such strategies with trade and international relations experts in Seoul, a week after President Yoon Suk Yeol declared martial law, which was lifted just six hours later following a National Assembly vote to end it, Yonhap news agency reported. During the meeting, participants reviewed Seoul's progress in preparing for the incoming Donald Trump administration, which has hinted at shifts in Washington's trade policies, including the imposition of sweeping tariffs of at least 10 per cent on all imported goods.



# South Korean ex-defence chief issued order to prevent lawmakers from gathering at National Assembly

**Seoul, Dec 17 (IANS):** Former Defence Minister of South Korea, Kim Yong-hyun issued an order to prevent 150 lawmakers from gathering at the National Assembly on the night of last week's martial law declaration, a military commander said on Tuesday.

Lt. Gen. Kwak Jong-keun, chief of the Army Special Warfare Command, claimed at a parliamentary session that he did not follow Kim's order and explained it to troops dispatched to the scene last Tuesday, Yonhap news agency reported. Kwak is among military commanders involved in martial law operations who have been under investigation by the prosecution over their role in the decree enforcement.

# Jordan reaffirms support for Syria's efforts to restore stability

Amman, Dec 17 (IANS): Jordan's Foreign Minister Ayman Safadi on Tuesday reaffirmed his country's commitment to Syria's efforts to restore security and stability.

According to a statement by the foreign ministry, Safadi said in a speech at the Parliament that Jordan supports Syria in launching an inclusive political process where the Syrian people choose their own destiny and future. He urged coordinated Arab efforts in this regard, and stressed Jordan's readiness to provide necessary humanitarian aid to the Syrian people, the statement showed. Safadi also said that Israel's seizing of the

buffer zone with Syria violates international law and attacks on Syria's sovereignty, Xinhua news agency reported.

Preserving Syria's state institutions is vital to preventing the country from sliding into chaos, he added.

The Israeli army has seized control of areas near the Israel-Syria border and struck strategic weapons in Syria as of Monday, according to Syrian and Israeli sources. In a video statement released by



his office on Sunday, Israeli Prime Minister Benjamin Netanyahu said he had ordered the military to take control of the positions temporarily to ensure they would not fall into the hands of the mili-

tant groups led by Hayat Tahrir al-Sham, whose sweeping offensive across Syria since Nov. 27 resulted in the rapid fall of President Bashar al-Assad's government on Tuesday.



#### New Australian venture to target deadly disease-spreading mosquitoes

Canberra, Dec 17 (IANS)

: Australia's national science agency has announced a new venture aimed at fighting disease-spreading mosquitoes. Launched on Tuesday, Oxitec Australia, a collaboration between the Commonwealth Scientific and Industrial Research Organization (CSIRO) and UK biotechnology company Oxitec, will release genetically engineered male mosquitoes carrying a gene capable of reducing pest female numbers, reports Xinhua news agency. The joint venture will target two of the deadliest species of virus-carrying mosquitoes in the Pacific, Aedes aegypti and Aedes albopictus, to prevent the spread of dengue fever, Zika virus and yellow fever. # South Korean PM pleads for collective efforts to stabilise state affairs, unite nation

**Seoul, Dec 17 (IANS):** South Korean Prime Minister Han Duck-soo made a plea to political leaders and civil society to make efforts to stabilise state affairs and unite the nation to address political turmoil triggered by President Yoon Suk Yeol's botched martial law declaration.

Han made the remark during the first Cabinet meeting held after Yoon declared martial law last Tuesday and lifted it hours later, which shocked the nation and made his political fate uncertain, Yonhap news agency reported.

"The government will dedicate all its efforts to ensuring the early stabilisation of state



affairs, solely in accordance with the will of the people," Han said. Han said the Cabinet would make efforts to ensure the stable function of the government, urging public officials to conduct their duties with an "extraordinary sense of re-

solve." Yoon faces growing calls to resign and has been placed under a travel ban Monday as authorities have laun ched investigations into treason and other charges related to his imposition of martial law.

# Maldives seizes drugs worth \$84 million so far in 2024

Colombo, Dec 17 (IANS): The Maldivian government has stepped up efforts to combat drug trafficking and six times more drugs were seized so far in 2024 compared to 2023, President Mohamed Muizzu said.

Addressing a meeting, the President said the drugs seized so far this year are estimated to have a street value of around \$84 million.

He added that over 150 expatriates linked to drug trafficking have been deported so far this year, which is



twice that of 2023, Xinhua news agency reported quoting state-owned Public Service Media. The President said police have raided over 13,435 establishments this year amid the nation-wide crackdown on trafficking, adding that around 8,500 raids were conducted last year.

Geneva, Dec 17 (IANS): United Nations (UN) High Commissioner for Human Rights Volker Turk on Tuesday urged Syrian parties to engage in an inclusive dialogue to advance the country's transition process.



## South Korea: Ruling party to elect new floor leader this week amid martial law turmoil

Seoul, Dec 17 (IANS): South Korea's ruling People Power Party (PPP) said on Tuesday that it will elect a new floor leader this week to replace Choo Kyung-ho, who stepped down after a parliamentary motion to impeach President Yoon Suk Yeol was scrapped.

Choo resigned as the PPP's floor leader shortly after the National Assembly on Saturday failed to pass a motion to impeach Yoon to hold him accountable for the declaration of martial law last week. The motion was scrapped due to a lack of quorum, as only three lawmakers of the 108-member ruling party cast their ballots in the vote, which required a twothirds majority, Yonhap news agency reported. Choo has said he was resigning to 'take responsibility' for the situation where the Assembly pushed to impeach the president for the third time under the constitutional rule. The PPP plans to elect a new floor leader on Thursday, its chief spokesperson Kwak Kyutack told reporters.

#### Death toll in Indonesia's West Java landslide, floods rises to 10

Jakarta, Dec 17 (IANS): Hydrometeorological disasters that have hit Sukabumi in Indonesia's West Java province since last week have claimed at least 10 lives, with two others still missing, the local disaster mitigation agency said on Tuesday.

According to the Sukabumi Disaster Mitigation Agency acting chief Deden Sumpena, floods, strong winds, and landslides have occurred across approximately 40 sub-districts, forcing around 900 families to seek temporary shelter, reports Xinhua news agency.





# Foreign Secretary Misri calls on B'desh Chief Advisor Muhammad Yunus in Dhaka

Dhaka, Dec 17 (IANS): Foreign Secretary Vikram Misri wrapped up his one-day visit to Dhaka on Tuesday after calling on Muhammad Yunus, the Chief Advisor of the Interim Government of Bangladesh, during which he conveyed India's concerns, especially those related to the safety and welfare of minorities in the neighbouring country. Earlier in the day, the top Indian diplomat met with Bangladesh's Foreign Affairs Advisor Touhid Hossain and also held Foreign Office Consultations with the Foreign Secretary of Bangladesh, Jashim Uddin. The Ministry of External

Affairs (MEA) stated that, during these meetings, Foreign Secretary Misri highlighted India's support for a democratic, stable, peaceful, progressive and inclusive Bangladesh while reiterating New Delhi's willingness to build a positive and constructive relationship with Bangladesh.



#### Two security officers killed in clash with IS militants in Iraq

Baghdad, Dec 17 (IANS): Two Iraqi security officers were killed on Tuesday in an operation against Islamic State (IS) militants in Iraq's province of Anbar, the Iraqi National Security Service (INSS) said in a statement. Acting on intelligence reports and monitoring, members of an INSS force clashed with the IS militants after raiding a house in the province, the statement said.

The clash resulted in the killing of two officers from the INSS force as well as two IS militants.

## Intellectuals in Rajasthan urge UN intervention on human rights violations in B'desh

Jaipur, Dec 17 (IANS): Concerned over atrocities against Hindus and other religious minorities in Bangladesh, intellectuals from Rajasthan have submitted a memorandum to Governor Haribhau Kisanrao Bagde, calling on the United Nations to intervene.

# Israeli PM Netanyahu to testify in corruption trial

Jerusalem, Dec 17 (IANS): Israeli Prime Minister Benjamin Netanyahu is set to testify on Tuesday for the first time in his trial for bribery, fraud and breach of trust charges. His testimony will begin in an underground room in the Tel Aviv District Court after being moved from Jerusalem for security considerations. He will then testify three times a week for the following two weeks at least, local media reported. The trial marks the first time a sitting Israeli prime minister has been charged with a crime, reports Xinhua news agency, quoting local media.

The court partially accepted Netanyahu's legal team's request on November 24 for a 15-day postponement for the start of his testimony but rejected the latest call for postponement by 12 ministers in Netanyahu's cabinet. Netanyahu's domestic trial is further complicated by the International Criminal Court (ICC) arrest warrants issued in November against him and former Israeli Defence Minister Yoav Gallant for "crimes against humanity and war crimes" between at least October 8, 2023, and May 20, 2024.

# Over 7.7 lakh km rural roads constructed under PMGSY: Govt

New Delhi, Dec 17 (IANS): As many as 1.82 lakh roads measuring a total length of over 7.7 lakh km and 9,199 bridges have been completed till 6th December 2024 at an expenditure of Rs 3.32 lakh crore, under the Pradhan Mantri Gram Sadak Yojana (PMGSY) since the scheme was launched, Minister of State for Rural Development Kamlesh Paswan informed the Lok Sabha on Tuesday.

He also said that the Government of India had approved phase IV of PMGSY in September 2024 to provide all-weather connectivity to 25,000 unconnected habitations of population size 500+ in plains, 250+ in NE & States/UTs, special category areas (Tribal Schedule V, Aspirational Districts/Blocks, Desert areas) and 100+ in LWE affected districts, as per Census 2011. The PMGSY-IV covers unconnected habitations which have become eligible in view of their population increase as per the census 2011.

The minister said the Government of India, as a part of the poverty reduction strategy, launched the Pradhan Mantri Gram Sadak Yojana (PMGSY-I) on 25th December 2000 as a Centrally Sponsored Scheme to provide rural connectivity, by way of a single all-weather road, to the eligible unconnected habitations of designated population size (500+ in plain areas and 250+ in North-Eastern States, Himalayan States and Himalayan Union Territories and some special areas as per 2001 census) in the core network for uplifting the socio-economic condition of the rural population.

In the critical Left Wing Extremism affected blocks, habitations with a population of 100 persons and above as per the 2001 census are also covered. Various independent evaluation studies, conducted



Labour Organization (ILO), on Pradhan Mantri Gram Sadak Yojana (PMGSY), have concluded that it has improved access to education and health care facilities, facilitated employment generation in both farm and non-farm sectors and helped farmers in getting better farm prices, the minister said. The minister also said the government has implemented several measures to ensure seamless registration, particularly for SC, ST and OBC communities facing land ownership documentaother question, Union Minister of State for Agriculture Ram Nath Thakur said more than Rs 3.46 lakh crore has been disbursed in 18 instalments to farmers since the inception of the scheme.

To ensure the timely and transpar-

ent transfer of funds to farmers

through DBT, several technological interventions have been made under PM-KISAN, which includes integration with the Public Financial Management System (PFMS), UIDAI and the Income Tax Department, he explained. # Roundtable calls for harsh measures to prevent road deaths in Bulgaria

Sofia, Dec 17 (IANS): A roundtable discussion called for tougher measures to combat serious road accidents and reduce casualties in Bulgaria. The event was organised on Tuesday by two Bulgarian non-governmental organisations, the "European Center for Transport Policies" and "Angels on the Road," Xinhua news agency reported. European Commission data shows that Bulgaria had the highest road accident fatality rate in the European Union last year, with 82 deaths per million population.

A man, introduced simply as "Philip's father," shared his personal tragedy, recounting how his child was killed by a car last September. He identified recurring factors for high road accident fatalities such as significant speeding, alcohol or drug use, gross disregard for traffic laws, inexperienced young drivers with powerful cars, and poor road infrastructure. Officials at the discussion noted that since August 2023, Bulgaria has implemented measures allowing the state to confiscate vehicles from drunk or drugged drivers. This policy has shown a positive preventive effect. Peter Petrov, a member of parliament (MP), cited data from the Interior Ministry, revealing that from August 2023 to August 2024, cases of drivers caught with over 1.2 per mille of alcohol dropped by 545, while cases involving drug use decreased by 901 compared to the previous year.

#### **Netherlands starts** extra border controls for six months

The Hague, Dec 17 (IANS): The Netherlands tightened border controls on Tuesday as part of the government's efforts to address irregular migration and human trafficking.

"This measure aims to curb the flow of illegal immigrants into the Netherlands," Minister of Asylum and Migration Marjolein Faber told Dutch RTL News. "It is not merely symbolic. It will undoubtedly have an impact. Moreover, it may act as a deterrent."

The security forces on Tuesday conducted the operation in Dera Ismail Khan district of the province on reported presence of terrorists, the Inter-Services Public Relations (ISPR), Xinhua news agency reported quoting the media wing of the Pakistan Army.

"During the conduct of the operation, the terrorists' location was effectively engaged by own troops," the ISPR said, adding that two terrorists were killed while one was apprehended in injured

condition during the operation. According to the ISPR, a huge cache of weapons and ammunition were also recovered from the terrorists, who remained actively involved in terrorist activities against security forces as well as target killing of civilians in the area. Clearance operation is being carried out to eliminate the pres-



ence of other terrorists from the area, it added.

The military said the security forces of Pakistan are determined to wipe out the menace of terrorism from the country.



### Russia busts international fraud scheme linked to former Georgian defence chief

Moscow, Dec 17 (IANS): Russia's Federal Security Service (FSB) said that it has dismantled an international fraud network allegedly operating in the interests of former Georgian Minister of Defence Davit Kezerashvili.

The network of "call centres," which was part of a larger international organised crime group, was involved in mass fraud targeting citizens from the European Union, Canada, Brazil, India, and other countries, Xinhua news agency reported quoting the FSB.

The suspects deceived victims under the guise of making investment transactions, amassing approximately \$1 million in daily profits, the statement read, adding that around 100,000 individuals in over 50 countries were defrauded in the scheme.



# Zelensky says discussed with Trump prospects for freezing conflict

Kyiv, Dec 17 (IANS): Ukrainian President Volodymyr Zelensky said Tuesday that he discussed the prospects for freezing the Russia-Ukraine conflict with US Presidentelect Donald Trump, the UNIAN news agency reported.

"I told him that we want the war to end more than anyone else in the world. A diplomatic resolution would certainly save more lives, and we want that," Zelensky told reporters.

At the same time, he said that Ukraine requires additional weapons, including longrange systems, as well as an invitation to join the North Atlantic Treaty Organization (NATO) to ensure its security. Later in the day, Zelensky wrote on Telegram that if there is a "pause" while Ukraine is not in NATO, Kiev might consider French President Emmanuel Macron's proposal to deploy foreign troops on Ukrainian soil to guarantee security.

Zelensky also revealed plans to call US President Joe Biden to discuss prospects for inviting Ukraine to NATO, Xinhua news agency reported.

Zelensky, Trump and Macron met in Paris on Saturday on the sidelines of the inauguration ceremony of the restored Notre-Dame de Paris cathedral.

## Egyptian President's historic visit to Norway sparks key Middle East talks

Oslo, Dec 17 (IANS): Norwegian Prime Minister Jonas Gahr Store welcomed Egyptian President Abdel-Fattah al-Sisi to Oslo, marking the first-ever visit by an Egyptian head of state to

Their discussions centered on pressing regional and bilateral issues, with a strong focus on the Middle East's ongoing challenges, Xinhua news agency reported.

"The situation in the Middle East was central to the talks, not least the dramatic developments in Syria over the last couple of days," Store said, noting that both Norway and Egypt "are concerned about the need for a peaceful transition for the Syrian people and to safeguard stability in the region."

# Suspect arrested in shooting of CEO of largest US health insurer

After a six-day manhunt for the killer of the CEO of the largest US health insurer, authorities have had a breakthrough with the arrest of a suspect in the shooting.

Mayor Eric Adams said at a news conference that a man matching the suspect's description was arrested Tuesday morning in Altoona, 450 km from New York, and police were on their way there to question him. The man was identified as 26-year-old Luigi Mangione.

The killing of Brian Thompson, the CEO of UnitedHealthcare (UHC), on Wednesday outside a New York hotel when he was going there for an investor's conference sent shockwaves at the higher echelons of corporate America.

Acting on a tip from a McDonald's fast-food restaurant employee, local police arrested him. "He matches the description of the identification we've been looking for, and he's also in possession of several items that we believe will connect

New York, Dec 17 (IANS): him to this incident," Adams said. New York Chief of Detectives Joseph Kenny said Altoona police found on Mangione a "ghost gun" -made with a 3D printer - capable of firing .9 mm bullets that killed Thompson, a silencer, fake IDs like the one used by the suspect, and a three-page handwritten

The document, he said, listed grievances against the health insurance sector and corporate America.

He is reported to have graduated from the Ivy League University of Pennsylvania, where he studied computer science and lived in Hawaii.

The shooter displayed sophistication in carrying out the attack, waiting for Thompson outside the hotel around the time he would be there, getting away after the shooting on an electric bicycle, ditching a backpack in Central Park, taking a taxi to a bus station, and heading out of the city on a bus. He wrote on the bullets, "deny," "depose", and "defend", which are terms used by insurance companies when they refuse to pay for treatments claiming they are not

covered by the policies. They had some similarities to the



title of a book criticising the insurance industry, "Delay Deny Defend: Why Insurance Companies Don't Pay Claims and What You Can Do About It", by Jay Feinman.

Now police say that the document found on him had messages against the insurance industry. He also left behind a backpack

with play money from a game. Thompson, 50, became the CEO of the Minnesota-based UHC in 2021 after working his way up during his 20-year career with the company.

His annual salary was nearly \$10 million heading the company with 140,000 employees and annual revenues of \$281 billion.

A Senate panel's report criticised UHC for a high rate of denial of claims.

Many people shockingly expressed sympathy on social media with him because of their own grievances against health insurance companies and ideological opposition to big corporations.

Despite his careful planning and hiding his identity, Mangione dropped his mask when checking into a cheap hostel, and his full face was captured.

He was being held in Altoona on charges of using fake ID and illegally carrying a gun.

Under US laws, a person arrested in a state cannot automatically be sent to another state and police have to go through an extradition process in a local court to move a suspect.



# Gurbaz ruled out of Zimbabwe ODIs with quadriceps and hip flexor injuries

Harare, Dec 17 (IANS): Afghanistan wicketkeeperbatter Rahmanullah Gurbaz has been ruled out of the three-match ODIs series against Zimbabwe due to a Grade 2B quadriceps along with a hip flexor injury, said the Afghanistan Cricket Board (ACB).

Mohammad Ishaq has been named Gurbaz's replacement for the series, scheduled to commence on Tuesday. The 19-year-old Ishaq, who played five T20Is scoring 76 runs, is yet to make his ODI debut. ACB said confirmed spinner Mujeeb Ur Rahman was rested as the team management has "decided not to rush him back" after injury. "Additionally, after careful evaluation of Mujeeb Ur Rahman's recovery process, the team management has decided not to rush him back. He will be given a rest from the #ZIMvAFG ODI series, which side for the white-ball squad begins today in Harare," ACB posted on X.


Gurbaz in the three T2OIs against Zimbabwe scored only 26 runs as Afghanistan, after losing the first T2OI, bounced back to win the next two and seal the series 2-1. Mujeeb was sidelined since June due to right phalanx (hand) sprain and only returned to competitive cricket for the first time in five months at the Abu Dhabi T10 on November 21. Later, the off-spinner was added to the national for the Zimbabwe tour.

#### BGT: Hazlewood likely to be out for series as scans confirm calf strain

Brisbane, Dec 17 (IANS): Australia suffered a major injury blow as the experienced seamer Josh Hazlewood is likely to be ruled out of the ongoing Border-Gavaskar Trophy series against India after the scans confirmed he had strained his right calf. Hazlewood hurt his right calf during Australia's warm-ups on Tuesday morning. He bowled one over in the first session before leaving the field with calf soreness in the first session on Day 4.

The 33-year-old pacer then underwent scans to assess the severity of the injury. Medical scans later in the day confirmed he had strained his right calf and is likely to miss the rest of the series.

"Josh Hazlewood has sustained a rightsided calf strain, which will prevent him from playing any further part in the Test match against India in Brisbane. He is likely to miss the remainder of the Test series," Cricket Australia said in a statement as quoted by ICC.





# Mandhana climbs to second in ODI and third in T2OI batting rankings

**Dubai, Dec 17 (IANS) :** India's star opener Smriti Mandhana climbed three spots to second in the ICC women's ODI batting rankings and one place to third in the ICC women's T20I player rankings.

This rise comes on the back of stellar performances against Australia and the West Indies in recent matches. Mandhana, known for her graceful lefthanded stroke play, made headlines with a brilliant 105 in the final ODI of the ICC Women's Championship series against Australia in Perth. She followed it up with a crucial 54 in the opening T20I against the West Indies in Navi Mumbai. The latest ICC women's player rankings update also brought good news for other Indian players. Harmanpreet Kaur, India's captain, entered the top 10 in the T20I batting rankings. Jemimah Rodrigues moved up six slots to 15th after a stunning 73 in the T20I series opener. Deepti Sharma climbed two places to second in the T20I bowling rankings and retained her position as a key all-rounder for India. Arundhati Reddy made a significant leap in the ODI bowling rankings, moving up 48 places to 51st after an impressive four-wicket haul (4-26). Renuka Thakur, India's pace spearhead, rose to a joint-26th position in the ODI bowling rankings. Tammy Beaumont of England rose two places to 11th in the ODI batting rankings following an unbeaten 65 that secured a series victory against South Africa.
