# FIR against Rahul Gandhi diversion tactic of BJP: Telangana CM

Telangana Chief Minister A. Revanth Reddy on Friday termed the First Information Report (FIR) registered against Leader of Opposition in Lok Sabha Rahul Gandhi as a "diversion tactic "of the BJP. The Chief Minister alleged that BJP registered an FIR against the Congress leader for defending the legacy of Babasaheb B. R. Ambedkar. "This FIR is a diversion tactic in response to Rahul ji protesting against the Union Home Minister, for his highly objec-

Hyderabad, Dec 20 (IANS): tionable words about our beloved and revered icon, Dr Ambedkar," Revanth Reddy on Friday termed the First Information on 'X'.

"With 26 FIRs already against him, Rahul ji will fight against the divisive agenda of BJP tirelessly. Sadly, the Delhi Police has not acted against BJP leaders who physically attacked our women MPs," he added.

Meanwhile, Andhra Pradesh Congress Committee (APCC) President Y. S. Sharmila has also alleged that BJP is trying hard to divert public attention from Amit Shah's remarks on Ambedkar.



"The incidents that took place in Parliament on Thursday are proof of this. The BJP and the RSS have always been against Ambedkar. That is why they want to erase the memories of Ambedkar," the Congress leader said. Sharmila said that they were demanding the resignation of Amit Shah from the Union Cabinet and an apology from him for his remarks but BJP started a new drama.



### Over 42,500 Supreme Court

## judgments translated into regional languages using AI

New Delhi, Dec 20 (IANS): With an increasing use of Artificial Intelligence (AI) in legal work, 36,324 Supreme Court judgments have been translated into Hindi and 42,765 verdicts have been translated into 17 regional languages, as on date, and made available on the e-SCR portal,

the Parliament was informed on Friday. Minister of State (Independent Charge) of Law and Justice, Arjun Ram Meghwal said, in a written reply in Lok Sabha, that AI Translation Committees of the High Courts are monitoring the entire work relating to translation of the Supreme Court and High Court judgments into vernacular languages.

# **Uproar in Telangana Assembly over ACB case against KTR**

**Hyderabad, Dec 20 (IANS):** Corruption case booked against former minister K. T. Rama Rao in connection with the Formula-E car race rocked the Telangana State Assembly on Friday with the Bharat Rashtra Samithi (BRS) insisting on a debate on the issue. The House witnessed uproarious scenes as the BRS members stalled the proceedings to demand the debate.

As soon as the House met for the day, the BRS raised the issue of the Anti-Corruption Bureau (ACB) booking a case against the BRS working president and demanded a debate. Speaker Gaddam Prasad Kumar rejected the demand for the debate and tried to proceed with the listed agenda for the day. The

BRS tried to disrupt the proceedings by raising slogans against the government.

Congress MLA R. Prakash Reddy said when the Governor has given permission to register a case against KTR and the ACB has taken up the investigation, there is no scope for discussion in the House. He alleged that BRS was trying to create confusion among people.

# SC lawyer petitions for action against LoP Rahul Gandhi, seeks expulsion

New Delhi, Dec 20 (IANS) : A lawyer of the Supreme Court on Friday lodged a formal complaint against Congress leader Rahul Gandhi for alleged "criminal acts of physical assault and incitement" against BJP MPs within the premises of Parliament. In a petition addressed to Lok Sabha Speaker, the complainant said that on Thursday, when Members of Parliament belonging to the National Democratic Alliance (NDA) were peacefully demonstrating at the Makar Dwar entrance of Parliament against the blatant misinformation

being propagated by Opposition parties, particularly led by the Indian National Congress, Rahul Gandhi, the Leader of the Opposition (LoP), "physically harmed" NDA Members of Parliament. "At approximately 10:40 AM to 10:45 AM, Mr. Rahul Gandhi arrived at the scene. Despite requests from Parliament security to take the designated entry path.



## Government orders forensic audit on 'Dharani' portal: Ponguleti

Hyderabad, Dec.20 (NSS): Minister for Revenue Ponguleti Srinivas Reddy has announced that the State government is initiating a forensic audit of the Dharani portal, which serves as the land records management system.

The Speaker asked BRS members to participate in the debate on the Telangana Bhu Bharati (Record of Rights in Land) Bill, 2024. He remarked that the "Formula E-race relates to one person while the Bhu Bharati Bill relates to people." When Revenue Minister Ponguleti Srinivas Reddy was speaking on the Bhu Bharati (Record of Rights in Land) Bill, 2024, BRS members tried to advance towards the Speaker's podium while marshals intervened to stop them. Some BRS members threw pieces of paper towards the Speaker. Amid the pandemonium, some Congress MLAs tore papers and flung them towards BRS members, leading to utter chaos. BRS members alleged that Congress MLA Veernapally Shankar showed a shoe to a Dalit legislator. They demanded that a case be booked against the Congress MLA. Amid the uproar, the Speaker adjourned the House for 15 minutes. When the House reassembled, the BRS continued its protest demanding debate on the ACB case. Despite repeated appeals by the Speaker to allow the House to continue its proceedings, the BRS members remained in the well, demanding a debate.

Chautala passes away

Om Prakash Chautala was born on 1 January 1935 in village Chautala of Sirsa and became the Chief Minister for the first time on 2 December 1989.

The former Haryana Chief Minister breathed his last at around 12 noon in Medanta hospital in Gurugram.

He had difficulty in breathing and was undergoing treatment in Medanta for the last three-four years. On Friday, when his health suddenly deteriorated, he was brought to the emergency ward of Medanta but he suffered a cardiac arrest and could not be saved. Abhay Singh Chautala is a former MLA from the Ellenabad constituency and has also been the Leader of Opposition in the Haryana Legislative Assembly from October 2014 till March 2019.

"Occurrence and filling of vacancies, including the backlog reserved vacancies, is a continuous process," Minister of State for Personnel Jitendra Singh said in a written reply to the Rajya Sabha. Instructions have been issued to all ministries and departments of the central government to constitute an in-house committee for identification of backlog reserved vacancies, to study the root cause of such vacancies, to initiate measures to remove the factors causing such vacancies and to fill them up including through special recruitment drives, the minister said. The

minister said each ministry/department of the central government is required to designate an officer of the rank of Deputy Secretary and above, as Liaison Officer, to ensure due compliance of the orders and instructions pertaining to reservation. Each ministry/department is also required to set up a special reservation cell to assist the Liaison Officer. In answer to another question, the minister also said that the Government has undertaken the 'Initiative for Increasing Efficiency in Decision Making in Government' in alignment with the policy of 'Minimum Government, Maximum Governance'.

## Patna Metro project likely to be completed by August 15 next year

"We have directed officials to finish the remaining tasks promptly. The construction



work is in full swing and we are expecting to complete the Metro project by August 15 next year," Singh said. Delhi Metro Rail Corporation is the company responsible for the construction project of Patna Metro. A six-km stretch connecting Malahi Pakri, Khemnichak, Bhootnath, Zero Mile, and ISBT. Construction work is proceeding at an accelerated pace to meet the set deadline of August 15 next year. Singh emphasised the department's commitment to meeting the timeline. The Patna Metro project is steadily progressing with significant developments in its priority corridor, which is part of a broader network corridor. The Patna Metro comprises two main corridors --East-West Corridor and North-

In place of several separate documents (affidavit, indemnity bonds, undertakings), now the applicant needs to submit only one affida-



vit and one Indemnity bond as per the specimen prescribed, the MoS said.

Allotment letters, agreements, demand letters accompanied by proof of purchase with consideration and receipts of payments are now being accepted in lieu of Builder Buyer Agreement (BBA) as an alternative document, Sahu said.

#### **OPPOSITION'S IMPEACHMENT NOTICE AGAINST VICE PRESIDENT IS UNPRECEDENTED**

n an unprecedented move in the parliamentary history of India, the opposition INDIA bloc sub I mitted a notice on December 10, 2024, at the Rajya Sabha Secretary General P.C. Modi's office seeking removal of the Chairperson of the Upper House the Vice-President of India Jagdeep Dhankhar alleging him of conducting proceedings of the House in an "extremely biased" manner. Union Minister for Parliamentary Affairs Kiren Rijiju on December 11, during his address in the House, said, "We will not allow this." Amidst uproar in the House during Centre-Opposition faceoff, Rajya Sabha was adjourned for the day. Given the adamant attitudes of both the ruling establishment and the opposition, one can't but think that the issue may overshoot to a hazardous level having far reaching legal and political implications for the country. Since the NDA has majority in the Rajya Sabha, is can defeat the impeachment motion, if taken in the House for consideration, but the debate can impact politics in the country in a way that can impact the political fortune of the ruling establishment.

The immediate background of the joint move of the opposition INDIA bloc has enough indication of that. The opposition has been demanding discussion on the Adani issue alleging that the Union Government is protecting the friend of PM Narendra Modi at the cost of public money and the interest of the people. The Union Minister of Parliamentary Affairs Kiren Rijiju, on the other hand, to counterbalance the opposition raised alleged "nexus between US hedge fund tycoon George Soros and Congress ... posing a threat to national security." Opposition's six-point chargesheet notice was signed by not only the Congress but other opposition political parties too. Therefore, Kiren Rijiju's attack on only Congress over the impeachment notice, calling the allegations against the Chair baseless is not enough. If the entire opposition is not satisfied with the conduct of the Chair, they have right to raise their grievance, which they have been doing for several years in the house, but remained largely unheard, and resulted into the present joint move of impeachment notice.

Whatever may be the outcome of the impeachment notice, most likely to be defeated on account of majority of NDA in the House, if taken for consideration. Kiren Rijiju's statements suggest that it would not be taken for consideration at all, and in that case when the winter session of the Parliament will end on December 20, the notice for removal would expire automatically. Nevertheless, it will have serious implication on National politics, since the move would exert great pressure on the Vice-President who holds a significant role in the national political hierarchy, being only second in line to the presidency, and as Chairman of the Rajya Sabha. Oppositions move is therefore an effort of weakening the executive branch of the government, that has been allegedly lording over the legislative branch of the democracy through bending the proceeding of the Rajya Sabha. It will have repercussions on the future governance and elections, because the political narrative may go against the ruling establishment.

At a time when the opposition unity is being questioned, especially after the election defeats of IN-DIA bloc in Haryana and Maharashtra, and the statements made by opposition political parties were being highlighted by the ruling establishment as "IN-DIA bloc disintegrating", the joint move for removal of the Vice-President has just shown the opposition unity. INDIA bloc by its joint move has challenged the authority of the ruling establishment. The narrative is bound to come into public discourse. It is strategic calculation of the opposition for an agenda for change. It may lead to reform or alter the structure of India's legislative body, since Chairman of the Rajya Sabha and the Vice-President of India are two posts held by the same person. The opposition's six-point chargesheet focuses on the Chairperson's role, not the Vice-President's role. The impeachment notice underlines the importance of the separation of the role, but then there would be constitutional crisis.

#### Every 10 unit rise in annual PM2.5 exposure raising death risk in Indians: Study

Every 10 micrograms per cubic metre of air increase in annual exposure to fine particulate matter 2.5 (PM2.5) is associated with an 8.6 per cent increased risk for mortality across India, finds a study.

The study, published in the journal Lancet Planetary Health, revealed that longterm exposure to PM2.5 pollution concentrations higher than the 5 micrograms per cubic meter annual average recommended by the WHO is potentially associated with 1.5 million deaths a year in India.

The findings showed that the 1.4 billion people in India live in areas with PM2.5 concentrations above that recommended by the WHO guidelines. "High levels of annual PM2.5 exposures are observed in India causing a huge mortality burden (not limited to cities that are highlighted during the extreme pollution episodes), signaling the need for systematic and not symptomatic approach," said Suganthi Jaganathan, doctoral researcher, Centre for Health Analytics Research and Trends (CHART), Ashoka University.

pressed approval, stating, "This is a good step. A lot of government time and money is wasted on elections. This will save money and is a good initiative." Talking to IANS, BJP MLA Sanjay Upadhyay echoed similar sentiments, saying, "We have been demanding this for a long time. Earlier, elections stretched over a year, hampering development. I hope it is implemented soon."

BJP MLC Shrikant Bhartiya

emphasised the importance of regular elections in hindering development, adding, "If 'One Nation, One Election' is passed, it will be historic for India. It is not a political issue but one for the betterment of the people."

BJP leader Rakesh Sachan also welcomed the change, stating, "For five years, the country was constantly engaged in elections. Now, we are free from this headache, and this will bring positive change."

JD-U leader Sanjay Jha also supported the initiative, noting, "We welcome the Bill. Holding elections at both the state and central levels together will save money." However, Shiv Sena (UBT) leader Priyanka Chaturvedi voiced a cautious perspective, saying, "While we welcome the approval of the Bill, we are concerned about how

issues like Electronic Voting Machine (EVM)s and manpower will be managed. I hope this process will be used for progress and not political gain."

Meanwhile, the Bill is expected to be tabled during the current Winter Session of Parliament.

According to the Centre, the Bill, aimed at streamlining electoral processes, is expected to save money, enhance efficiency, and avoid hindering development by synchronising the elections for the Lok Sabha and state Legislative Assemblies.

By doing so, the government aims to address several challenges posed by the current system of staggered elections, which often lead to prolonged periods of electioneering, disruption in governance, and heightened expendi-

#### Syrian constitution, parliament suspended for three months: report

Damascus, Dec 20 (IANS): The Syrian constitution and parliament have reportedly been suspended for three months, according to Sawt al-Asima, a news outlet supportive of militant groups that overthrew the Assad government. The outlet reported the development on Friday, citing unnamed sources, but did not provide details on how the suspension would be implemented. Earlier, Syria's Military Operations Administration announced Wednesday that it has lifted the curfew previously imposed on Damascus and its surrounding areas, calling on residents to resume their daily activities and return to their workplaces. In a statement, the administration encouraged citizens to "contribute to building the new Syria".



#### South Korea: Concerns emerge over war readiness as multiple Generals suspended in martial law aftermath

Seoul, Dec 20 (IANS): Concerns are emerging in South Korea about the military's emergency readiness against North Korean threats, as multiple Generals and commanders have been removed or suspended from their duties for potential involvement in last week's short-lived imposition of martial law.

In addition to former Defence Minister Kim Yong-hyun, who stepped down and was arrested on charges of playing a key role in President Yoon Suk Yeol's martial law declaration on December 3, six Generals have so far been suspended for their involvement, including the chiefs of the Defence Intelligence, Capital Defense and Special

Warfare commands. In the latest such action on Friday, the Defence Ministry suspended the duties of Army Chief of Staff General Park An-su, who served as the Chief martial law commander during the brief martial law rule.

Shortly after the martial law announcement, a military decree barring all political activities was issued under Park's name. Park has argued he was not responsible for the drafting of the document.

The suspensions have left a vacuum in the top commands of major warfare units -- the Capital Defence Command, the Army Special Warfare Command, the Counterintelligence Command and the Defence Intelligence Command. Their commands are

seen as crucial missions in the military's operations against North Korea, from guarding the greater Seoul area to collecting military intelligence at home and abroad and conducting special operations against enemy entities.

Following Kim's departure, Choi Byung-hyuk, a retired Army General who currently serves as the ambassador to Saudi Arabia, has been tapped as the new Defense Minister, but it remains unclear when a parliamentary confirmation hearing for Choi's appointment could take place. Yonhap news agency reported.

Further stoking uncertainties is the fact that the chief command of the entire armed forces still lies with President Yoon. "Legally, (the control of military forces) currently lies with the commander in chief," Jeon Ha-kyou, the Defence Ministry's spokesperson, said in a regular briefing on Monday, a day after the president was booked as a suspect on insurrection charges. When asked about concerns about the military's emergency readiness in the fallout of the martial law declaration, the Defense Ministry still maintains that it sees 'no insufficiency' in maintaining a firm operational and readiness posture. "(The ministry) has clearly named substitutes and they are carrying out their duties," Jeon said in a press briefing earlier in the day. "Under such a command system, field and operations units are cur-

rently conducting duties and no

erational posture," he added. Breaking a weeklong silence, Pyongyang's state media on Wednesday reported on South Korea's martial law turmoil for the first time, followed by back-toback coverage of the issue the following day. The state media reports detailed the opposition's push to impeach Yoon, while blaming the president for causing nationwide chaos. Photos of candlelight protests were also published. The North has carried out no reported military provocations against the South so far this month after sending some 40 trash-filled balloons across the

border in late November.

Philippine authorities have raided suspected POGO hubs near the capital in recent months after Marcos ordered the ban in

and the central Philippines, to continue committing internetbased crimes, Xinhua news agency reported. "Marcos wants the Philippine Anti-Organized Crime Commission and the Philippine National Police to intensify their operations against POGOs that are still operating despite the ban," the PCO said.



#### UK govt unveils updated framework to boost house building

London, Dec 20 (IANS): The Labour government in the United Kingdom (UK) on Friday unveiled updated measures aimed at overhauling the planning system for new housing development, requiring local councils to commit to a house-building timetable.

As part of its broader plan to construct 1.5 million homes before the next general election, the government introduced housing targets for councils. This initiative builds on the Labour Party's commitment to deliver an annual target of 370,000 new homes in England, addressing the needs of approximately 1.3 million households currently on social housing waiting lists.

The updated measures also include specific guidelines for releasing land from the Green Belt -- protected areas surrounding urban regions designed to prevent urban sprawl and preserve natural landscapes.





## Islamic State claims responsibility for suicide bombing that killed Afghan minister


Kabul, Dec 20 (IANS): ghan caretaker government The extremist militant group Islamic State (IS) has claimed responsibility for a suicide bombing that killed Afghanistan's acting minister for refugees and repatriation on Friday. IS militant detonated his explosive vest, resulting in the deaths of Khalil Rahman Haqqani and several of his colleagues and bodyguards, a report issued by IS-affiliated news agency 'Amaq' stated.

Four people, including Haggani, were killed and four others, including Haqqani's guards, were critically injured following the attack, an official at the Afghan Ministry of Interior told Xinhua news agency. Haqqani is the first cabinet member killed since the Af-

took over power in 2021. "We have received with great sadness the news that the minister of refugees, Khalil Rahman Haqqani, was martyred this afternoon in a ferocious attack by the Khawarij (enemy)," said a statement released by Mufti Abdul Mateen Qani, a spokesman for the country's Ministry of Inte-

"Haqqani was a member of a great jihadi family. The enemies of Islam had set a 5-million-US dollar bounty for his elimination," the statement added.

## India votes in favour of UNGA resolution for 'immediate, unconditional, permanent' Gaza ceasefire

United Nations, Dec 20 (IANS): India has joined 157 other nations in supporting a United Nations General Assembly (UNGA) resolution demanding an "immediate, unconditional, and permanent" ceasefire in the wartorn Gaza Strip.

The UNGA overwhelmingly approved two resolutions on Friday, one calling for a ceasefire in Gaza and the other backing the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), which Israel has sought to ban.

The first resolution, demanding an immediate ceasefire, was passed with 158 votes in favour, nine, including the United States, Israel, Argentina, Czechia, Hungary, Nauru, Papua New Guinea, Paraguay, and Tonga, against, and 13 abstentions.

The second resolution, supporting the mandate of UNRWA, received 159 votes in favour, nine against, and 11 abstentions.

The resolutions follow two days of debate at the 193-member General Assembly, where speeches overwhelmingly highlighted the need to end the 14-month-long conflict between Israel and Hamas. Delegates also called for unhindered humanitarian access in Gaza to address the growing

Although General Assembly reso-

lutions are not legally binding, they carry significant weight as a reflection of global opinion. This vote came after the United States vetoed a UN Security Council resolution on November 20 that had also called for an immediate ceasefire in Gaza.

The US veto stemmed from the absence of a clause linking the ceasefire to the release of hostages taken during the October 7, 2023, Hamas attacks on Israel, which triggered the conflict.

The second resolution expressed support for UNRWA, established in 1949 to provide assistance to Palestinian refugees.

The ministry has been incentivising food processing entrepreneurs, including small and medium, for setting up and expansion of related industries through its Central Sector Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) Scheme, Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and centrally-sponsored PMFME scheme across the country. Under subschemes of PMKSY, the ministry provides mostly credit-linked financial assistance (capital subsidy) to entrepreneurs with total outlay of Rs 5,520 crore for 15th Finance Commission cycle.



#### Six arrested for firing in J&K's Jammu city

He said that the victim was taken to hospital by locals, adding that a case has been registered under relevant sections of law at Bishnah police station and a team formed to nab the accused. "All the six accused were arrested within 48 hours of the incident. During interrogation, they confessed to their involvement in the crime and based on their disclosure, a country-made pistol was recovered. The vehicle used during the crime was also seized," the official said.

### Sand shortage sparks row inside, outside Jharkhand Assembly



#### India's milk market stable with low inflation rates in November: Govt

New Delhi, Dec 20 (IANS) : The overall milk situation in the country is stable with the year-on-year Wholesale Price Index and (WPI) and Consumer Price Index (CPI) inflation rates for milk recorded at low levels of 2.09 and 2.85, respectively, for the month of November 2024, Department of Animal Husbandry & Dairying (DAHD) Secretary Alka Upadhyaya, said at a review meeting here, an official statement said on Friday. "There is an adequate commodity stock skimmed milk powder, whole milk powder, white butter, and ghee. At the same time, there has been an improvement in milk procurement and milk procurement prices over the year," she pointed out. The Secretary also highlighted that India holds the top position globally in milk production, generating approximately 239.3 million metric tons in the year 2023-24, according to an official statement. She advised all Milk Federations to take up active participation in the Midday Meal and Integrated Child Development Services (ICDS) programs of the Ministry of Women and Child Development (MoWCD) and the Ministry of Human Resource Development (MoHRD), as these represent the largest institutional domestic mar-

ket for the dairy sector. The meeting was attended by representatives from the National Dairy Development Board (NDDB), and the National Cooperative Dairy Federation of India (NCDFI) along with officials of the DAHD and State Cooperative Dairy Federations and Milk Unions across the country. The milk situation in the country and the progress being made by the State Milk Federations were discussed in detail during the review, Upadhyaya emphasised that Dairy Federations should focus on enhancing milk procurement and increasing the price paid to the farmers, while also considering consumer interests. During the meeting, the initiatives undertaken by the State Milk Federations such as (Gujarat), Nandini



(Karnataka), Saras (Rajasthan), and Megha (Jharkhand) were commended, and it was recommended that other Federations should undertake similar efforts. DAHD is also consistently collaborating with the MoWCD and the MoHRD to promote the inclusion of milk in the Midday Meal and ICDS programmes. It was ob-

served that commensurate with the production, consumption of processed dairy has increased by 20 per cent. A detailed discussion was held concerning the strategies and initiatives required to further enhance the processing of milk to value-added products and accordingly

Water bodies, including lakes, rivers and streams, also freeze partially during the Chillai Kalan hampering the movement of boats in the local water bodies. For centuries, Kashmiris have relied on the earthen firepot woven in a willow wicker basket filled with embers to ward off the winter cold. This is called the 'Kangri'.

Chembarambakkam Lake, located about 25 km from Chennai, is one of the two major rainfed reservoirs supplying drinking water to the city, along with the Puzhal Lake. It is to be noted that the Adyar River originates from Chembarambakkam Lake.

Notably, this artificial lake was first constructed by Rajendra Chola, the son of Raja Raja Chola, and Madeviyar, a prince of Kodumbalur.



### 5.15 crore cases pending in courts: Govt

New Delhi, Dec 20 (IANS): There are 5.15 crore cases pending in various Indian courts, including the Supreme Court, High Courts and District and Subordinate Courts, the Parliament was informed on Friday.

Minister of State (Independent Charge) for Law and Justice Arjun Ram Meghwal said in a written reply in Rajya Sabha that there are 82,171 pending cases in the Supreme Court, as per information available on National Judicial Data Grid (NJDG) till November 30.

He said the number of pending cases in High Courts is 57.82 lakh and in District and Subordinate Courts, it is 4.56 crore. MoS Meghwal said the pendency of cases in courts can be attributed to several factors, which include the availability of physical infrastructure and supporting court staff, the complexity of facts involved, the nature of evidence, cooperation of stakeholders like bar, investigation agencies, witnesses and litigants and proper application of rules and

"Other factors that lead to delay in disposal of cases include lack of prescribed timeframe by respective courts for disposal of various kinds of cases, frequent adjournments and lack of adequate arrangement to monitor, track and bunch cases for hearing," the MoS said.

The MoS told the House that based on the population as



per the Census 2011, which was 1210.19 million, and as per available information regarding the sanctioned strength of judges in the Supreme Court, High Courts and District and Subordinate Courts in the year 2024, the judge-population ratio in the country works out to be approximately 21 judges per million population. Giving details of the appointment of judges in High Courts, MoS Meghwal said: "In 2024, the number of fresh appointments was 34, in 2023 it was 110, in 2022 it was 165, in 2021 it was 120, in 2020 it was 66 and 2019 it was 81." ing mercy to people who have demonstrated remorse and rehabilitation, restoring opportunity for Americans to participate in daily life and contribute to their communities, and taking steps to remove sentencing disparities for non-violent offenders, especially those convicted of drug offences. "That is why, today, I am pardoning 39 people who have shown

successful rehabilitation and have

shown commitment to making their communities stronger and safer. I am also commuting the sentences of nearly 1,500 people who are serving long prison sentences - many of whom would receive lower sentences if charged under today's laws, policies, and practices," the President said.

The commutation recipients mostly included those placed in home confinement during the Covid-19 pandemic, those par-



doned were people convicted of non-violent crimes such as marijuana possession. A pardon wipes out a conviction. A commutation leaves the convict guilty but reduces or ends the punishment.

President Biden had pardoned his son Hunter Biden a few weeks ago for his conviction on charges of gun law violation and tax evasion. Biden still has 40 days left of his term and the White House said more such actions are expected. "While today's announcement marks important progress, there is more to come.

## Political agenda to provoke society: UP ministers slam LoP Rahul's Hathras, Sambhal visits

Following Leader of Opposition (LoP), Rahul Gandhi's visit to the family of the Hathras gang-rape victim and also to the kin of those who died in the Sambhal violence in Uttar Pradesh, the state's Cabinet ministers have accused him of pursuing a "political agenda to provoke society and mislead the public." LoP Gandhi on Friday met with the family of the Dalit girl who was gang-raped by four upper caste men in Hathras in 2020. The victim later succumbed to her injuries in a Delhi hospital.

Rahul Gandhi interacted with the family of the victim for

LoP Gandhi's visit came a day after he and his sister, Congress MP Priyanka Gandhi, met the families of those who lost their lives in the November 24 Sambhal violence. Speaking to IANS, Cabinet Minister Danish Azad Ansari slammed Rahul Gandhi's visit, alleging it was politically-motivated.

"Rahul Gandhi's visit to Hathras is akin to spreading poison -- a political agenda to provoke society and mislead the people. Our government is serious about the Hathras case. If Rahul Gandhi believes in democracy, why isn't he allowing the parliamentary session to proceed? The Congress party does not want



the country and society to progress," Ansari alleged. Regarding the Sambhal violence in which five people died, Ansari added, "Currently, the situation is peaceful, and all communities are maintaining harmony. The Opposition's rhetoric, aimed at boosting their political image, is inappropriate."

Cabinet Minister Anil Kumar questioned the timing of the Congress MP's Hathras visit, stating, "The incident happened

years ago. Now, after the 2024 elections, he suddenly remembers Hathras. Those guilty have already been sent to jail." Kumar, speaking to IANS, also commented on Rahul Gandhi's focus on the Sambhal incident. "A Judicial Commission has been formed, and action will be taken based on its report. What is the need to politicise this matter?" he questioned.



## OP Rajbhar slams LoP Rahul Gandhi's Hathras visit as 'political drama'

Lucknow, Dec 20 (IANS): Suheldev Bharatiya Samaj Party (SBSP) President, OP Rajbhar, on Friday criticised Leader of Opposition (LoP) in the Lok Sabha, Rahul Gandhi's visit to the family of the Hathras 2020 gang-rape victim, labeling it a 'political drama.'

"It's nothing but political drama. When the Congress was in power, entire slums were set ablaze, and violence and curfews were normal. Now that they're out of power, they are desperate to return. The people have rejected them, just as they did in the past," he claimed.

Rajbhar, however, emphasised that the LoP had the right to visit the family, but the UP government had insisted that such visits be approved for security reasons.

"The government is ensuring that proper arrangements are made for his safety," he added.



### ABVP members protest at school in MP's Bhind after student wears 'tilak', 'kalawa'

Pankaj Sharma, father of the student, talking to media persons claimed that his daughter was sent back home from school because she was wearing 'kalawa' and 'tilak'.



## Initiate talks with protesting farmers, Bhupinder Hooda tells Centre

Chandigarh, Dec 20 (IANS): Former Haryana Chief Minister Bhupinder Singh Hooda on Friday said the BJP government in the Centre should give up its rigid attitude and talk to farmers as their leader Jagjit Singh Dallewal has been on a fast unto death for the past 16 days, and his health is continuously deteriorating. Hooda said their demands should be resolved and Dallewal's fast should be ended immediately. Talking to the media here, Hooda said that farmers are not making any new demands, and are reminding the government of its own promise. Ghana has inaugurated a joint transition team comprising representatives of the outgoing government and incoming administration to facilitate the smooth power transfer.



#### South Korean Prez defends martial law decree as act of governance, rejects insurrection charges

Seoul, Dec 20 (IANS): South Korean President Yoon Suk Yeol on Friday defended his botched martial law declaration as an act of governance and denied insurrection charges facing him, while vowing to fight until the last moment against whether it is impeachment or a martial law probe.

Yoon defied calls to resign during a public address, as police and prosecutors are widening their investigation into his short-lived martial law declaration last Tuesday, Yonhap news agency reported. Yoon said he used his presidential power to declare martial law "to protect the nation and normalise state affairs" against the Opposition that paralysed the government, calling it a "highly calibrated political judgment."



## South Korea: Top court upholds two-year prison term for minor Oppn leader Cho Kuk

Seoul, Dec 20 (IANS): South Korea's Supreme Court on Friday finalised a two-year prison term for minor party leader Cho Kuk convicted of academic fraud involving his children and unlawful interference with a government inspection.

The top court handed down the two-year sentence and asked Cho to forfeit 6 million won (\$4,184), finding the 59-year-old guilty of using his influence to receive academic favours, including university admissions, for his children and interfering with an inspection into a corruption case by using his power as a presidential aide. Cho, who currently

heads the minor Opposition Rebuilding Korea Party, will also lose his parliamentary seat and his right to run in presidential elections for the next five years.

Shortly after the sentence was announced, Cho said he "humbly accepts" the court's decision. The Seoul Central District Pros-

ecutors Office ordered him to appear before the prosecution on Friday to begin serving his term. Cho, however, reportedly asked for a postponement citing the need to take care of official duties, including handing over his party leadership position, Yonhap news agency reported. Under prosecution guidelines, a person who has

received a sentence can postpone their appearance before the prosecution by up to three days in the event they need to undergo urgent medical treatment or attend to a family member's death or wedding. Depending on the prosecution's decision, Cho could begin serving his term on Friday but no later than next Friday.

Cho, a former law professor at Seoul National University, served as the senior presidential secretary for civil affairs from 2017-19 during the Moon Jae-in presidency. He was appointed as the justice minister in September 2019 before stepping down about a month later amid the scandal.

### Imran Khan and wife Bushra Bibi indicted in Toshakhana case

Petersburg. Moiseyev said that the naval nuclear forces are based in the Arctic and the eastern region of Kamchatka while emphasising that their combat readiness is currently at its highest modernization level. "The presence of this group (of forces), which addresses important global geopolitical tasks, should place responsibility on all partici-

pants in this region," the navy

chief noted, Xinhua news agency reported.

"It should inevitably heighten the sense of responsibility for everyone without exception, for us, of course... as well as those who seek to escalate tensions in the region," he said, adding that the naval nuclear forces will remain a guarantor of Russia's national security at the global level.

Moiseyev further noted that the United States and countries of the North Atlantic Treaty Organization have ramped up their military activity in the Arctic, focusing on training troops in harsh conditions, expanding their naval operations, and boosting aerial and naval reconnaissance.
