Hyderabad, Dec.21 (NSS): Chief Minister said the government is considering the 'Rythu Bharosa' as an ambitious scheme and it is seeking suggestions from the main opposition party to finalise modalities for the implementation of scheme. He alleged that the previous government had spent Rs.72,817 crore in the form of Rythu Bandhu in 10 years and

misued the scheme, giving money to uncultivated lands, layouts, and national highways. "Out of Rs.72,817 crore, almost Rs.22,000 crores have been given to the undeserving. Shall we continue extending the Rythu Bharosa to mountains, stones and roads," he questioned. The Chief Minister further stated that the Rythu

Bandhu was also given to Rajiv Road in Gajwel constituency, Srisailam roads in Amangal area, crusher units and mining lands. Moreover, some of the followers of the previous rulers also got Rythu Bandhu through fake title deeds. About 70 to 80 per cent of the land within a 50 km radius of Hyderabad is not being farmed.

While only a few countries have aced the space docking technology, it is key for India for its impending space missions including the Moon mission, and setting up the Indian space station.

"The launch vehicle has been integrated and now moved to the First Launch Pad, for further integration of satellites and launch preparations," ISRO said in a post on X.

"ISRO's SpaDeX mission,

launching with PSLV-C60, will demonstrate in-space docking using two small spacecraft. groundbreaking technology is key to future lunar missions, building Bharatiya Antariksh Station (BAS), and more. India aims to join the elite club of nations with space docking

capabilities," it added. The PSLV will lift off two small spacecraft -- SDX01, which is the Chaser, and SDX02, the Target -- weighing about 220 kg each. The mission will showcase the mous communication bedocking of the two spacecraft tween spacecraft.

in a low-Earth circular orbit. "In-space docking technology is essential when multiple rocket launches are required to achieve common mission objectives. Through this mission, India is marching towards becoming the fourth country in the world to have space docking technology," ISRO said. It will also demonstrate "the transfer of electric power between the docked spacecraft, which is essential for future applications such as in-space robotics -- composite spacecraft control, and payload operations after undocking".

ISRO has also developed indigenous technologies to enable this docking mission. This includes a docking mechanism, a suite of four rendezvous and docking sensors, power transfer technology, indigenous novel autonomous rendezvous and docking strategy, inter-satellite communication link (ISL) for autono-

CM's prejudiced rhetoric in Assembly undermines judiciary

Hyderabad, Dec.21 (NSS):

BRS party leader Dr Sravan Dasoju today excoriated Chief Minister Revanth Reddy for his prejudiced rhetoric in the Assembly regarding the tragic death of Revathi at Sandhya Theatre during the screening of Pushpa-2. Dr Dasoju expressed grave concern over the Chief Minister's conclusive accusations solely against actor Allu Arjun, labelling him as directly responsible for the mishap while covering up the failures of the police and administration, despite the matter remaining sub judice in the High Court. "This is nothing short of an attempt to influence judicial proceedings—a deliberate act of undermining judicial independence and the rule of law," stated Dr Sravan Dasoju. "Revanth Reddy's remarks not only prejudiced the pending case against Allu Arjun, but also deflect attention from the failures of the police and administration. These comments amount to contempt of court, especially considering the interim relief granted by the High Court." Dr Dasoju pointed out that the Chief Minister's statements violate the spirit of Articles 121 and 211 of the Constitution, which prohibit discussions in the Legislature on matters pending in courts.

Allu Arjun visited theatre despite denial of police permission: Telangana CM

Telangana Chief Minister A. Revanth Reddy said on Saturday that actor Allu Arjun visited Hyderabad's Sandhya Theatre for the premiere show of "Pushpa 2", despite police denying permission,

Hyderabad, Dec 21 (IANS): resulting in the stampede that killed a woman and injured her son. Speaking in the State Assembly, the Chief Minister stressed the police had told the actor not to visit the theatre but he still went there. He said the police did not

MP: Cold wave intensifies in most parts; school timings rescheduled in several districts

Bhopal, Dec 21 (IANS): Bone-chilling cold with icy winds continues in Madhya Pradesh as night temperatures in several districts dropped below 5 degrees Celsius on Saturday. Pachmarhi, the only hill station in the state remained coldest at a minimum of 3.4 degrees Celsius, while the night temperatures in Raisen, Rajgarh and Umariya districts also remained between 4.4 and 4.8 degrees Celsius. Similarly, the night temperature in the capital city of Bhopal remained at 6.8 degrees Celsius for the third consecutive day. Whereas, the minimum temperature in Indore was 10 degree Celsius.

Bengal school job case: SC orders Partha Chatterjee's release on bail by Feb 1

New Delhi, Dec 21 (IANS): The Supreme Court on Saturday said that former West Bengal Education Minister Partha Chatterjee should be released on bail on or before February 1 next year in connection with the money laundering case linked to the alleged cash-for-school-job

A bench headed by Justice Surya Kant asked the trial court to decide on framing of charges before the commencement of winter vacations or before December 31, whichever is earlier.

Further, it asked the court below to record the statements of prosecution witnesses who are most vulnerable in the second or third week of January next year.

Asking Partha Chatterjee to extend full cooperation in the trial, Justice Kant-led Bench clarified that in any case, he cannot be kept in custody beyond February 1, 2025. When released on bail, Partha Chatterjee will not be able to occupy any public office except his continuation as MLA, it clarified.

Last week, the Bench, also comprising Justice Ujjal Bhuyan, reserved its judgment after hearing the oral arguments of senior advocate Mukul Rohtagi, appearing on Partha Chatterjee's behalf and Additional Solicitor General (ASG) S.V. Raju, representing the Enforcement Directorate (ED).

Rohtagi contended that the former minister had been under custody for over two years and there was no likelihood of early completion of the trial. The senior counsel, assisted by advocate Misha Rohtagi, added that the other coaccused have been granted bail in connection with the money laundering case.

Opposing the bail plea, the ED said that Partha Chatterjee would indulge in influencing witnesses and evidence tampering if released. In an earlier hearing, the top court had hinted at granting relief to Partha Chatterjee and expressed concern over the delay in the commencement of the trial. Questioning the ED as to how long can Partha Chatterjee be kept behind bars, the Justice Kant-led Bench asked: "How long can we keep him behind bars? This is a case where more than two years have passed. If ultimately he (Chatterjee) is not convicted, what will happen?"



2 held, over 5 kg drugs seized in Bihar's Purnea

Patna, Dec 21 (IANS): Two individuals were arrested and a significant quantity of drugs was seized during a vehicle inspection drive conducted by Mufassil police in Bihar's Purnea district on Saturday, police said. 
NO CLEAR INDICATION ABOUT THE NOMINATION OF NEXT BJP PRESIDENT REPLACING J P NADDA

The BJP is in hurry to appoint a new national president by December end. Electoral process for the election of the new president is underway. But the contentious issue whose candidate, either of the RSS chief Mohan Bhagwat or of the Prime Minister Narendra Modi, will eventually occupy the office is still shrouded in the mystery. October meeting of the RSS national executive and later interaction of Bhagwat with some senior BJP leaders and also chief minister of UP, Yogi Adityanath had certainly turned the saffron ecosystem optimist of an agreement between the two before the year is out. Barely a fortnight is left for month to end, the name of the final incumbent still awaits announcement. It is still a mystery whether the leaders of warring factions have converged on a single name. Neither RSS chief Mohan Bhagwat has dropped any hint about the new face, nor Narendra Modi has proposed the name of successor of current BJP president JP Nadda. Nevertheless senior BJP leaders are unanimous in their view that it is not a major issue haunting either RSS or BJP and a common candidate, acceptable to both, Bhagwat and Modi would be announced soon.. They point out Modi is known for not opening his mind before the final days.. Modi selected two completely unknown as the chief ministers of Haryana and MP. Rest of the BJP leaders came to know only after he dropped their names in public.

These leaders are sure that Modi will not do anything which would hurt the RSS or goes against its mission and philosophy. He is simply buying time. But this strategy of Modi has turned the RSS cadres suspicious of his intentions. There is wide perception in the saffron circle that the conflict of supremacy and desire to control the saffron ecosystem has entered into a new phase. Insiders nurse that the latest development underlines that the electoral outcome would now be decided among others by Adani factor. The aggressive attitude of US against the BJP for its allegation that the U.S. State Department was behind targeted attacks against Prime Minister Narendra Modi and Indian businessman Gautam Adani has been taken note by the saffron leadership. The US posture has turned the political situation vulnerable for Modi. Obviously in this backdrop Modi would have to focus more on improving and cementing his relation with US administration. For this he needs a strong BJP organisation and a very cordial relation with RSS. Selecting a face which would will be friendly with him as also acceptable to Mohan Bhagwat is the crucial issue. The recent discord amongst the INDIA bloc members, especially opposition from TMC and Samajwadi Party, to consistently raising the issue in Parliament has come as a major respite to BJP, especially to Modi. Opposition of TMC and SP to Rahul's stand on Adani has in fact forced Congress to stay from all out attack on Adani directly during their morning demonstration on Parliament premises in the last two days. The tone is a bit diluted though the thrust continues. Adani is a favourite of RSS, but the manner in which Modi has put at stake his prestige to protect him and his business is not liked by Bhagwat. The RSS expects more tactical approach on Adani from Modi rather than giving the impression that the BJP government will go all out to protect Adani's interests. The fact is that Bhagwat has been approached by other non-Gujarati business houses who are aggrieved that the present government at the centre is granting too many facilities to the Adani group ignoring the interests of others. The RSS has to look after this as these houses are also pro-Hindutva and funds the BJP-RSS. In 2019 well before Amit Shah stepped down from the office of president, everyone had come to know about replacement by J P Nadda as the next president. But this time no one has any inkling of the new incumbent. With the RSS chief exercising his power and authority, to keep the image and prestige of the RSS intact, the situation has undergone a major change.

SC imposes Rs 5 lakh costs on employer for taking wage and termination dispute to arbitration

he Supreme Court has Dushyant Janbandhu, contended that the dispute with the respondent-employer is governed by statute under the Payment of Wages Act, 1936 and the Industrial Disputes Act, 1947. The appellant was appointed as an Assistant Manager in March 2019. After the Covid-19 pandemic, when Hyundai AutoEver India directed the employee to resume physical attendance, he refused to comply. He was issued a charge memo for violation of certain contractual

clauses, including non-cooperation and absenteeism and ultimately, an order of termination was passed in January 2021. During the pendency of disciplinary action, as the appellant was not paid his salary, he issued a legal notice for payment of wages under the Payment of Wages Act, 1936 and filed a petition before the concerned authority. As a counterblast, the employer issued a notice alleging that the disputes must be settled through arbitration and proceeded to unilaterally appoint an arbitrator.

When the unilaterally appointed arbitrator commenced the arbitral proceedings, the employee filed an application calling upon the arbitrator to rule on his competence.

The arbitrator himself held that the constitution of the arbitral tribunal was not in accordance with or in consonance with the provisions of Section 11 of the Arbitration and Conciliation Act and closed the arbitral proceed-




FROM BABRI MASJID DEMOLITION IN 1992 TO SAMBHAL IN 2024 - THE SAGA CONTINUING

t was a huge pile of debris left on the ground where ■ Babri Masjid, with its undeniable grandeur, stood. Space was slowly emptied, leaving behind a vast loneliness, desolate and wet. Nothing remained the same. It was not only an attack on a mosque, it injured our inheritance, inclusivity. Almost half of us lost the expanse that we had built up since centuries. Those responsible stand today merged with state, with majoritarian support. Whosoever stood up in search of justice, got lost in a crowd. Their defence became spontaneously defiance as once Maulana Abul Kalam Azad had said when he was falsely accused of sedition by British imperialism and was taken to the dock. He had told the court that it was only in battlefields and in court rooms, that greatest acts of injustice in the history generally have taken

place. Demolition was complete, entire structure was wiped out. Outcome that followed was horrific. Communal riots in Bombay started in December, 1992, soon after the demolition of Babri mosque. There was no interruption. Follow up was destruction of more Mosques. People living there were left homeless and also lost their dear ones. South Korea: National Assembly to question PM, ministers over imposition of martial law

Seoul, Dec 21 (IANS): South Korean National Assembly is set to hold a parliamentary session Saturday to question the Prime Minister and other officials who attended a controversial Cabinet meeting shortly before President Yoon Suk Yeol's botched martial law declaration. The main opposition Democratic Party (DP) will also report a new impeachment motion against Yoon over his failed bid to impose martial law, days after he survived impeachment due to a lack of quorum, Yonhap news agency reported.

During Friday's interpellation session, opposition lawmakers are expected to question the Cabinet members about Yoon's public address the previous day, which largely centred on defending his martial law declaration and denying it was an act of insurrec-

The opposition has requested the attendance of Prime Minister Han Duck-soo, Finance Minister Choi Sang-mok, Education Minister Lee Ju-ho and Foreign Minister Cho Tae-yul, among

At another interpellation session Wednesday, Han apologised over the martial law turmoil and said no one agreed with Yoon's plan at the brief Cabinet meeting held just minutes before the declaration. The DP plans to put Yoon's new impeachment motion up for a vote at a parliamentary plenary session on Saturday.

South Africa reopens border crossing with Mozambique

Cape Town, Dec 21 (IANS): Traveller movement at South Africa's main border crossing point with Mozambique is now open "until further notice," the country's Border Management Authority (BMA) announced. This came after the BMA temporarily suspended operations at the Lebombo Port of Entry on Saturday due to election-related protests in Mozambique near the border area. These protests have repeatedly forced the closure of the crossing since the results of the southeast African country's disputed elections were released on October 24, Xinhua news agency reported.

"The Acting Commissioner of the BMA, Jane Thupana, has provided the latest update on the Lebombo Port of Entry, that traveller movement is now open until further notice," the authority said in a statement. According to the statement, pedestrians and small vehicles are being processed, with statistics reflecting that 7,471 travellers were processed on Wednesday.





Belarusian President approves defence plan for 2026-2030

Minsk, Dec 21 (IANS): Belarusian President Alexander Lukashenko approved the country's defence plan for 2026-2030.

The military-political situation around Belarus has changed in recent years, Lukashenko said at the Security Council meeting on Saturday. Individual states continue to escalate the situation around Belarus, he added.

Lukashenko said that destructive rhetoric from European countries toward Belarus is growing, indicating ongoing attempts to destabilise the domestic political situation in the country, Xinhua news agency reported. The president stressed the Belarusian army does not threaten anyone and is an instrument for preventing war, and in the event of aggression, the army must be able to repel it. Belarusian Defence Minister Viktor Khrenin said the approved defence plan was developed on the basis of a deep analysis of the events of 2020 in Belarus and the Russian special military operation in Ukraine.

Chief of the General Staff of the Armed Forces of Belarus Pavel Muraveiko said one of the main directions of the plan for the next five years is reducing the level of military danger and preventing military conflicts. "Also among the main directions of the plan is the preparation of the state for defence which covers all areas from the economy to the military sphere.



Estonian parliament approves security tax

Tallinn, Dec 21 (IANS): The Estonian parliament, Riigikogu, has passed a government-proposed bill to introduce a security tax aimed at bolstering the country's defence capabilities. The security tax includes three key components: first, the value-added tax, or VAT, will increase by 2 percentage points starting in the middle of 2025; second, the personal income tax rate will also rise by 2 percentage points, with the change taking effect at the beginning of 2026; finally, a new corporate profit tax, set at 2 percent, will also be implemented starting at the same time as the personal income tax increase. Under the new law, the VAT rate will increase to 24 per cent from July 2025, and the personal income tax rate will also rise to 24 per cent starting in 2026, Xinhua news agency reported. The Ministry of Finance estimates that the new tax will generate additional budget revenue of 113 million euros (119 million US dollars) in 2025 and 751 million euros in 2026. Details regarding the allocation and use of these funds will be outlined in the 2025 state budget and the 2025-2028 budget strategy.

27 Palestinians killed in Israeli attacks in Gaza

Gaza, Dec 21 (IANS): At least 27 Palestinians were killed and dozens of others injured in Israeli attacks at residential houses in the refugee camp of al-Nuseirat in central Gaza Strip, Palestinian sources said.

Palestinian Civil Defence spokesman Mahmoud Basal told Xinhua that the Israeli bombing targeted a residential block that contains the government post office building, which was sheltering displaced people.

Rescue operations are still ongoing amid a lack of equipment and heavy overflight by Israeli warplanes, Basal said, adding that the death toll could rise as many of the injured are seriously wounded, Xinhua news agency reported.

There was no immediate comment from the Israeli military on the attacks.

Earlier on Wednesday at least 10 Palestinians were killed in an Israeli drone attack on a gathering in central Gaza City, said the Palestinian civil defence in the Gaza Strip.

Civil defence spokesperson Mahmoud Basal said in a press statement that the victims include children and women, Xinhua news agency reported.

The Israeli army has not commented on this incident yet.

The Israel Defense Forces said in a statement on Sunday that its troops recently completed a targeted operation to dismantle underground militant infrastructure in the Jabalia area in the northern Gaza Strip.

Israel has been conducting a largescale offensive against Hamas in the Gaza Strip to retaliate against a Hamas rampage through the southern Israeli border on October 7, 2023, during which about



1,200 people were killed and about 250 taken hostage. The Palestinian death toll from ongoing Israeli attacks in the Gaza Strip has risen to 44,835, Gaza-based health authorities said in a statement on Saturday.

Thai PM pledges more economic stimulus, debt relief measures

Bangkok, Dec 21 (IANS): Thai Prime Minister Paetongtarn Shinawatra pledged additional stimulus and debt relief measures on Saturday in a bid to shore up the Southeast Asian country's sluggish economy amid weak consumption and high household debt. The government will continue the second phase of its cash handout program, providing around 4 million senior citizens with 10,000 baht (about 295 US dollars) each by the end of January, Paetongtarn said in a televised address on her administration's performance during the first three months in office.

In September, authorities distributed a cash stimulus of 145.5 billion baht (about 4.3 billion dollars) to around 14.55 million underprivileged individuals and people with disabilities.

This initiative has helped spur private consumption and is expected to boost the kingdom's



economy, leading to growth exceeding 3 per cent in the final quarter of 2024, the prime minister said. Some 36 million Thais had registered for the handout scheme, a key campaign promise of Paetongtarn's ruling Pheu Thai Party. A third phase of the program is set to roll out later next year, she said, Xinhua news agency reported. Paetongtarn noted that the government will prioritize debt relief measures to aid struggling small businesses and retail borrowers, aiming to address rising household debt that has been weighing on the Thai economy.

Houthi infiltration attempts foiled in Yemen: Govt forces

Aden, Dec 21 (IANS): The Yemeni government forces said that they have repelled three infiltration attempts by the Houthi group in the country's southwestern province of Taiz, killing two militants and wounding several others. The Taiz Military Axis, representing government forces, issued a statement condemning

the continued Houthi escalation of hostilities, which includes targeting civilians and military installations of the government in Taiz, Xinhua news agency reported. According to the statement, government forces thwarted three separate infiltration attempts by the Houthi group during the past hours.

"During enquiry, it was revealed that the accused Satyaki

Pattanaik and Deeptikanta Choudhury in connivance with the officials of CT & CT, Bhubaneswar have siphoned off Rs 4,03,09,723 by filing forged and fabricated appeal on behalf of the original Firm M/s G.E Verona T&D Ltd (formerly known as GE T&D India Ltd)," said a senior Vigilance official.

The vigilance later registered a criminal case under various sections of the IPC and PC Act against Satyaki, Deeptikanta, Abinash, other public servants and private persons involved in misappropriating the government funds. The anti-corruption sleuths

The ongoing Special Summary Revision (SSR) Programme-2025 has been instrumental in updating and refining voter lists across the state. As per the data as of December 12, the male-female voter sex ratio now stands at 930 women per 1,000 men, exceeding the SSR-2025 target of 926.

Highlighting the BJP's achievements, the State BJP Chief emphasised that the public trusts only Prime Minister Narendra Modi's guarantees.

"We have successfully implemented the Women's Honour Grant in Madhya Pradesh, Odisha, and Haryana, even starting disbursements in Maharashtra before elections," he said.

Sachdeva also accused Kejriwal of being a "mastermind" in corruption, alleging that he prioritises building lavish residences and increasing electricity bills while neglecting infrastructure and public services like roads, sewage systems, and clean drinking

RG Kar tragedy: Karuna Nundy to represent victim's parents now as counsel

This is the second time that the counsel of the victim's family has been changed. Initially, senior advocate of the Calcutta High Court and CPI-M Rajya Sabha member

Bikas Ranjan Bhattacharya had been representing the victim's family. Nundy and Sabyasachi Chattopadhyay are already representing the Joint Platform of Doctors, West Bengal, an association of senior doctors in the state who had been extending support to the protest movement by the junior doctors in connection with the rape and murder case. Earlier in September this year, the counsel for the junior doctors spearheading the movement on the rape and murder case was also changed, with acclaimed lawyer and social activist Indira Jaising replacing senior advocate Geeta Luthra.

India pips China in creating ultra-high net worth individuals in 2024

New Delhi, Dec 21 (IANS): The country's ultra-high net worth individual (UHNI) count reached 13,600 in 2024, marking a 6 per cent annual growth, and is projected to soar by 50 per cent by 2028, far outpacing the global growth average of 30 per cent, a report showed on Saturday. While India's UHNI population grew by 6 per cent in 2024, China's grew by just 2 per cent, signalling India's rising economic prominence, according to the report by Anarock Group.

India ranks sixth globally in UHNI population and third in Asia, trailing only China and Japan. About 10 per cent of UHNIs secured alternate citizenships in 2024, favouring Portugal, Malta and the UAE for their global mobility and tax benefits.

"Approximately 14 per cent of UHNIs own properties abroad, with Dubai, London and Singapore as the primary hotspots. The average international property investment exceeded Rs 12 crore (\$1.44 million) in 2024," said Prashant Thakur, Regional Director and Head, Research, Anarock Group. Also, nearly 25 per cent of Indian UHNIs are diversifying abroad.



India's job market projected to grow by 9 pc in 2025: Report

The growth rate of remittances this year is estimated to be 5.8 per cent, compared to 1.2 per cent registered in 2023, according to a World Bank blog post

"The recovery of the job markets in the high-income countries of the Organization for Economic Co-operation and Development (OECD), following the onset of the COVID-19 pandemic, has been the key driver of remittances. This is especially true for the United States where the employment of foreignborn workers has recovered steadily and is 11 percent higher than the pre-pandemic level seen in February 2020."

Indian pharma sector 3rd largest globally, valued at \$50 bn in FY 2023-24

New Delhi, Dec 21 (IANS): India's pharma industry is considered to be the world's third largest by volume, and in FY 2023-24 the pharmaceutical market has been valued at \$50 billion, said Union Minister of State for Chemicals and Fertilizers Anupriya Patel.

In a written reply to Rajya Sabha Patel said that in FY 2023-24, the pharmaceutical market's domestic consumption value was at \$23.5 billion, and exports were valued at \$26.5 billion. The Indian pharmaceutical industry has a strong presence at the global level. It is also the 14th in terms of value of production with an extremely diversified product base covering generic drugs, bulk drugs, over-the-counter drugs, vaccines, biosimilars, and biologics.

"According to National Accounts Statistics 2024, published by the Ministry of Statistics and Programme Implementation, total output for industry that is, pharmaceuticals, medicinal and botanical products is Rs. 4,56,246 crores for FY 2022-23 at constant prices, of which value added is Rs. 1,75,583 crores. 9,25,811 number of persons are engaged in Pharmaceuticals, medicinal and botanical products industry during FY 2022-23," Patel said.





Brazil's Lula to seek reelection in 2026

Brasilia, Dec 21 (IANS): Brazil's President Luiz Inacio Lula da Silva will seek reelection in 2026, the presidency's Secretary of Social Communication Paulo Pimenta has confirmed. In an interview with CNN Brasil, Pimenta assured that the president was in good health following medical interventions to treat a brain bleed, adding he was "the most qualified and prepared person" to continue leading the country. Lula underwent emergency surgery on Saturday to drain a hematoma in his head and an embolization procedure on Saturday to prevent a recurrence. According to his medical team, the president will not suffer any aftereffects and should be discharged early next week, either Monday or Tuesday.

"President Lula is doing very well. This is a simple procedure. President Lula is a person who takes care of himself, who has demonstrated that constantly, with discipline. A person who knows Brazil and who is extremely prepared," said Pimenta.



Overnight temperature plunges to minus 42 degrees Celsius in western Mongolia

Ulan Bator, Dec 21 (IANS): Overnight temperatures dropped to a bone-chilling minus 42 degrees Celsius in Otgon soum, an administrative subdivision of Zavkhan province in western Mongolia, according to the country's weather monitoring agency.

This marks the coldest temperature recorded in Mongolia so far this winter, the National Agency for Meteorology and Environmental Monitoring announced in a statement on Saturday.

New Zealand's overseas visitor arrivals continue to rise

Wellington, Dec 21 (IANS): New Zealand's overseas visitor arrivals were 240,200 in October 2024, an increase of 14,200 from October 2023, with the biggest changes in arrivals from Australia, the United States, Singapore, and Britain, the statistics department Stats NZ said on Saturday. The total number of overseas visitor arrivals in October 2024 was 85 per cent of the 283,800 in October 2019, which was before the Covid-19 pandemic, Stats NZ said. Of the 240,200 overseas visitor arrivals in October 2024, 46 per cent were from Australia, 9 per cent from the United States, 7 per cent from China, 5 per cent from Britain, 3 per cent from India, and 3 per cent from Germany, statistics show.

In terms of annual arrivals, New Zealand's overseas visitor arrivals were 3.25 million in the October 2024 year, an increase of 413,000 from the October 2023 year, with the biggest changes in arrivals from China, Australia, the United States, South Korea and Japan, Stats NZ said, Xinhua news agency reported. New Zealandresident traveller arrivals were 2.97 million in the October 2024 year, an increase of 383,000 from the October 2023 year, it said. Regarding border crossings, there were 1.07 million border crossings



in October 2024, made up of 569,900 arrivals and 504,400 departures. In October 2023, 1.02 million border crossings were recorded, Stats NZ said, adding New Zealand's October 2024 border crossings were 92 per cent of the 1.17 million in October 2019, before the Covid-19 pandemic.

New Zealand has seen a strong boost in international student enrolments, according to the latest statistics. New Zealand's international education sector was rebounding strongly, Tertiary Education and Skills Minister Penny Simmonds said earlier this month.



Russia hopes to keep military bases in Syria, **Guterres urges deescalation**

Damascus, Dec 21 (IANS): Russia hopes to keep its military bases in Syria as they are important in the fight against terrorism, Russian Deputy Foreign Minister Mikhail Bogdanov said late Friday. "I think there is general agreement that the fight against terrorism and the IS is not over, it requires collective efforts. In this regard, our presence played an important role in the fight against international terrorism," state-run RIA news agency reported, citing Bogdanov.

The Russian diplomat added that Moscow has established contacts with the political committee of Syria's Hayat Tahrir al-Sham (HTS) group and discussed issues of ensuring the security of the Russian diplomatic mission and citizens in the country, Xinhua news agency reported.

Japan puts new evidence of historical germ-warfare unit on display

Australian opposition leader reveals \$210 billion price tag for nuclear plan

The leader of Australia's federal opposition party, Peter Dutton, has revealed his nuclear energy plan would cost hundreds of billions of dollars.

Dutton, the leader of the Coalition, on Saturday, released the long-awaited costing of his plan to build seven nuclear reactors on the sites of retiring coal plants if he is

Sydney, Dec 21 (IANS): elected Prime Minister (PM) at the 2025 general election, reports Xinhua news agency. According to the independent costing, the plan would cost 331 billion Australian dollars (\$210.7 billion). Under Dutton's proposal, the first two publicly-owned reactors would begin operation by the mid-2030s, with coal-fired power plants to fill the generation gap in the meantime.

In 2050 -- by which the remain-

ing five reactors would be operational -- Dutton said that nuclear power would account for 38 per cent of Australia's electricity generation, with renewables covering 54 per cent and the remaining eight per cent coming from a combination of storage and gas.

The governing Labor Party has committed to pursuing a renewables-only future, which the Coalition has claimed would cost over 600 billion AUD (\$381.9 bil-



lion). "This is a plan which will underpin the economic success of our country for the next century," Dutton told reporters on Saturday. "This will make electricity reliable. It will make it more consistent.

Govt inks Rs 13,500 crore deal for 12 Sukhoi fighter jets with HAL in big boost to self-reliance

The Ministry of Defence on Saturday placed a Rs 13,500 crore order to buy 12 Su-30MKI fighter jets with Hindustan Aeronautics Limited (HAL) in a major boost to the Aatmanirbhar Bharat

initiative of the government. "The aircraft would have an indigenous content of 62.6 per cent, enhanced due to indigenisation of many components to be manufactured by the Indian defence industry," according to a Defence Ministry statement. An official said that these aircraft will be manufactured at Nasik division of HAL. The supply of these aircraft would enhance the operational capability of the Indian Air Force and strengthen the defence preparedness of the country.

New Delhi, Dec 21(IANS): The Sukhoi Su-30MKI is a twoseater, twinjet, multirole air superiority fighter developed by Russian manufacturer Sukhoi and built under license by HAL for the Indian Air Force. 


Efforts towards TB elimination showing significant progress: Rajasthan BJP

G20 meeting: South Korea stresses tech innovation, zero-carbon energy

Seoul, Dec 21 (IANS): South Korea has called on major nations to seek ways of actively using zero-carbon energy resources and joining hands to achieve technology innovation in an effort to address various global economic challenges. the finance ministry said on Saturday. The Seoul government made the point during the Group of 20 (G20) meeting for finance and central bank deputies, which took place in Johannesburg, South Africa, on Wednesday and Thursday (local time), according to the Ministry of Economy and Finance. It was the first meeting

in the financial track for this year's G20 gatherings under South Africa's presidency, reports Yonhap news agency.

During the meeting, Deputy Finance Minister Choi Ji-young said the participating nations need to implement measures to ensure the stable global financial system and plans to reform multilateral development banks. Choi also stressed the need to come up with guidance on the efficient use of financing to respond to downside risks for the global economy, maximize zero-carbon energy resources and push for technology innovation centering on artificial intelligence so as to boost productivity and



achieve sustainable development, the ministry said. The G20 finance ministers' meeting is scheduled to take place in Cape Town in February to discuss economic and financial issues of mutual concern, it added. Meanwhile, the three major global credit appraisers shared a common view on Friday that South Korea's credit rating remains stable despite the recent political turmoil, the finance ministry said. The three credit appraisers -- Moody's Ratings, Fitch Ratings and Standard & amp; Poor's Global Ratings (S& amp; P) -- made the assessment during separate virtual meetings with Finance Minister Choi Sang-mok on the day, according to the Ministry of Economy and Finance.



Turkey, US discuss Syria's stability, Gaza ceasefire

Ottawa, Dec 21 (IANS): A senior official in the government of Ontario, Canada, recently warned that the province might ban USmade alcohol and restrict electricity exports to several American states if President-elect Donald Trump imposes tariffs on all Canadian products, according to media reports. FM Cho says martial law chaos caused 'serious damage' to South Korea's diplomacy

Seoul, Dec 21 (IANS): The martial law turmoil has caused "serious damage" to South Korea's diplomacy, its top diplomat said on Saturday, amid concerns over a foreign policy vacuum as President Yoon Suk Yeol faces another impeachment vote in parliament.

Foreign Minister Cho Tae-yul made the remark as he appeared at a parliamentary hearing to answer lawmakers' questions regarding the controversial Cabinet meeting held shortly before Yoon declared martial law on December 3, reports Yonhap news agency. "I think there has been serious damage," Cho said in the interpellation session of the National Assembly when asked by Rep. Cho Jung-sik of the main opposition Democratic Party whether he thinks the current situation amounts to a diplomatic emergency.

"We will maintain a firm South Korea-US alliance and focus on restoring the trust of the international community," Cho

said. Yoon has been banned from



leaving the country since law enforcement agencies launched investigations into his short-lived martial law imposition.

The political turmoil has effectively put all top-level and other key diplomatic engagements with other countries at a halt, including the cancelled trips to Seoul by US Defense Secretary Lloyd Austin and a Swedish delegation led by its prime minister.

Cho said he believes diplomacy will be back on track once "constitutional order is restored."

"What matters most is to restore constitutional order through democratic procedures and respecting the will of the people to recover and stabilize state affairs," Cho said. Asked why he avoided phone calls from US Ambassador Philip Goldberg on the night of the martial law, Cho said he didn't want to "mislead" the ally about the situation.

"I felt it was more important to consider what to communicate to the US," Cho said. Cho was one of the Cabinet members who strongly opposed Yoon's martial law. Cho said he told Yoon many times to rethink his decision.

Survey shows mixed sentiment among Japan's large companies

Tokyo, Dec 21 (IANS): The Bank of Japan (BOJ) survey released on Saturday revealed mixed business sentiment among Japan's large companies, with manufacturers showing signs of recovery and non-manufacturers facing notable challenges.

The business index for large manufacturers improved for the first time in two quarters, rising by 1 point to plus 14 for the October-December period, according to the quarterly Tankan survey by the Bank of Japan.

A positive number indicates that more companies are optimistic about business conditions than those pessimistic, reports Xinhua news agency.



Ukraine's energy infrastructure under massive missile attacks

Kyiv, Dec 21 (IANS): Explosions were heard all over Ukraine on Saturday morning as Russia launched a largescale missile attack on its energy infrastructure, Ukrainian media reported.

Ukrainian President Volodymyr Zelensky said on Telegram that preliminary reports showed 93 missiles and almost 200 drones were launched against Ukraine in "one of the largest strikes on our energy sector."

Explosions sounded in the northern Kyiv region, the southern Odesa region, and the western regions of Lviv and Ivano-Frankivsk, reported Xinhua, quoting the InterfaxUkraine news agency. Ukraine's state-run energy company, Ukrenergo, announced plans to toughen power supply restrictions in the wake of the attack. Russia's defence ministry said the massive strike, which involved high-precision longrange air- and sea-based weapons and drones, was in response to Ukraine's attack on its territory with US-made missiles.

Earlier on Saturday, the ministry said Ukrainian forces used six US-made ATACMS ballistic missiles to attack the Taganrog military airfield in Russia's Rostov region. Moscow had vowed to respond with "appropriate measures."


