### CM Revanth assures all support to film industry in Telangana

Hyderabad, Dec.26 (NSS): Chief Minister A Revanth Reddy has reiterated that the State government is ready to extend all support to the film industry in Telangana.

Around 50 film personalities, led by Telangana Film Development Corporation (TFDC) Chairman and producer Dil Raju met the Chief Minister at the Police Command Control Center in Banjara Hills on Thursday and discussed the issues of film industry. Deputy Chief Minister Bhatti Vikramarka, Minister for Cinematography Komatireddy Venkat Reddy, DGP Jithender and others attended the meeting. The meeting assumed significance in the wake of the stampede at Sandhya Theater and the aftermath of film actor Allu Arjun's arrest. Speaking on the occasion, the Chief Minister said that his main objective was to pro-

mote the film industry and assured that the State government would extend all the help to support the industry. "As the Chief Minister, it is my responsibility to enforce the laws. I do not have any personal preferences. Let us all develop the film industry together without confining to Telugu only," Revanth Reddy said. The Minister recalled that the INCOIS was conceptualised following the tragic Tsunami of 2004 and after 2014, with an unflinching support and priority received from Prime Minister Narendra Modi, it made rapid strides to be recognised as the world's most state-of-the-art institute of its kind.

Dr Jitendra Singh lauded PM Modi's pathbreaking ocean initiatives, including the 'Deep Sea Mission' which he had announced in his Independence Day address. He also highlighted India's quantum progress in ocean research and disaster preparedness. The Minister emphasized the nation's emergence as a global leader in providing world-class disaster warning systems, underscoring the pivotal role of scientific advancements in foster-

ing safety and sustainability. Reflecting on the catastrophic tsunami that claimed over 230,000 lives worldwide, including 10,749 in India, Dr Jitendra Singh remarked on the invaluable lessons learned and the transformative policies that followed. "The tragedy served as a catalyst for establishing institutions like INCOIS, which now stands as a testament to India's commitment to safeguarding lives and livelihoods," he said.

India's Tsunami Early Warning System, lauded internationally, was showcased as a cornerstone of the nation's disaster preparedness. The Minister also noted ongoing collaborations with UNESCO and the Tsunami Ready Initiative, which aims to bolster community resilience across vulnerable regions. He cited the recognition of 24 Indian communities under this program as evidence of a community-centric approach.

Dr Jitendra Singh underlined the growing significance of oceanic exploration in India's journey toward becoming "Viksit Bharat". With a 7,500km coastline and abundant marine resources, he advocated for their sustainable exploration and conservation. "Our deep-sea mission and initiatives like BioE3 [Biotechnology for Environment, Employment, and Economy] are creating an ecosystem that will not only enhance biodiversity but also contribute to national prosperity," he said.

Looking ahead, the Minister expressed optimism about concurrent breakthroughs in space and marine missions, envisioning an India that leads globally in both realms. "We are planning to deploy an Indian in the deep sea and another in space, possibly by 2026, marking a historic milestone," he announced.

Speaking to the media after meeting with the Chief Minister at the Police Command Control Center in Banjara Hills on Thursday, Dil Raju said that Telugu cinema was respected

at the national level and the Chief Minister suggested that Telugu cinema should work at the global level, not at the Indian level.

"The Chief Minister has assured that all facilities will be arranged so that even Hollywood films can be shot in Hyderabad.

He has also asked the film industry to take steps to create awareness on the issue of drugs. In return, the film personalities has promised that they would create awareness on the eradication of drugs," Dil Raju revealed.

He said there are misconceptions that there is a gap between the film industry and the government and the Sandhya Theatre incident led to such a discussion.

Dil Raju stated that a committee will be formed jointly by the in-



dustry, TFDC and the government and the committee will take a decision on the issues of the industry.

Interacting with the media after attending the Vijay Diwas celebrations here, the Chief Minister said that the killing of two migrant workers might be with a "political motivation". #### NHRC issues notice to Rajasthan govt over boy's death in bore-well

New Delhi, Dec 26 (IANS): The National Human Rights Commission (NHRC) has issued a notice to the Rajasthan government after taking suo motu cognisance of a media report about the death of a five-year-old boy on December 26 after being trapped in a 150-feet-deep borewell for nearly 56 hours in Dausa district. The boy allegedly fell in the bore-well while playing in a field, the Commission said while seeking details of the action taken against the lax public authorities

#### PM Surya Ghar Muft Bijli Yojana : Public awareness event held in Bihar's Motihari

Patna, Dec 26 (IANS) : A public awareness programme organised in Bihar's Motihari district about the PM Surya Ghar Muft Bijli Yojana and its implications for the common man. The event, organised under the Solar Energy Scheme saw participation of a large number of people.

During the day-long event, many officials associated with solar systems gave information about the Central government scheme and appealed to the people to take advantage of it. Officials associated with various firms as well as domain experts elaborated on the benefits of solar energy and also sought to give a brief overview on how the system of migration from non-renewable energy to solar energy was simple and affordable. They also shared arithmetic on how solar power will curtail the electricity expenses of households. "People will be able to save on their electricity bill as well as sell the surplus electricity. For installation, they will get a subsidy of Rs 78,000," they informed. Solar energy expert Abhishek Lohia told newsmen that the government intends to take the scheme to every part of the country. "A maximum subsidy of Rs 78,000 will be available on three kilo watts. If you install a three-kilo watt solar roof top, you



will get a subsidy of Rs 78,000. This will come directly into your bank account. You will have to pay the balance amount. Your electricity bill will be reduced by 80 to 90 per cent," he said. He further said that the government is looking to cover over 1 crore households under the scheme, in the first phase. "This will not only reduce their electricity bills but will also enable them to earn income by selling surplus electricity," he said. PM Surya Ghar: Muft Bijli Yojana is a landmark initiative,

launched by Prime Minister Narendra Modi on February 15, 2024. It aims to transform India's energy landscape by providing free electricity to households. The scheme is set to reshape the country's energy landscape by empowering millions of households with solar power. The government has set a target of reaching 10 lakh households by March 2025 and increasing its ambit to one crore by March 2027.

The BJP and the JD(U) are working to retain the state. Two political organisations—the Rashtriya Swayamsevak Sangh (RSS) and the CPI—will celebrate their birth centenary. The RSS will complete 100 years in September, while the CPI will begin its centenary celebrations in December this year. With its ups and downs, the RSS has strongly influenced Indian politics and society and now since 2014, India is being ruled by the RSS led BJP under the leadership of Prime Minister Narendra Modi. It will be of interest ti see whether RSS will announce its revised road map for their India dream during centenary celebrations in 2025.

he South Korean government will in vest 2.7 trillion won (\$1.9 billion) in developing technologies aimed at tackling climate change next year, the science ministry said. The figure marks a 3.9 per cent increase from the 2.6 trillion-won investment into the scheme in 2024, according to the Ministry of Science and ICT, Yonhap news agency reported.

The investment is part of the government's 10-year plan to advance science technologies by 2032 to respond to global warming.

South Korea has pledged to reduce its greenhouse gas emissions by 40 per cent from 2018 levels by 2030 and achieve carbon neutrality by 2050.

#### Rajasthan Forum protests neglect of local artists at 'Rising Summit'

The Rajasthan Forum has expressed deep resent ment over the exclusion of Rajasthan-origin artists from the recently organised threeday Rising Rajasthan Summit. In a letter addressed to the Chief Minister, Forum President and Padma Bhushan awardee Pandit Vishwa Mohan Bhatt, also a Grammy Award winner, termed it 'regrettable'.

The Rajasthan Forum, comprising 34 distinguished artist members—including 12 Padma awardees—has been committed to promoting the art and culture of the state for over a decade. Raising concerns, the Forum questioned the lack of representation for Rajasthan's artists in such a significant event.

#### Crackdown on illegal poppy farming in Manipur: Assam Rifles destroyed 6,228 acres in 5 years

he Assam Rifles has iden tified a staggering 16,250 acres of illegal poppy fields in different districts of Manipur in the past five years and destroyed 6,228 acres, officials said on Sunday.

The defence spokesman said that besides fighting against various unlawful activities and crackdown on the drug menaces, the combat against illegal poppy cultivation has been a consistent priority for Assam Rifles, as reflected in its sustained efforts over the years.

He said that in 2020 the paramilitary force identified an astounding 8,057 acres of illicit poppy fields in various districts and 1,695 acres were destroyed. Continuing the force's rigorous action, a total of 5,610 acres of unlawful poppy fields were identified and 1,976 acres were destroyed in 2021. And, the next year (2022) the force intensified 494 acres and destroyed 715 acres, including previously undiscovered patches.

In 2023, a total of 1,735 acres of illegal poppy cultivation areas were identified and 1,488 acres



were eradicated. This year so far, 354 acres of illicit poppy cultivation areas have been destroyed, primarily in the districts of Ukhrul, Churachandpur and Chandel. The spokesman said that by 2024 the area of identified poppy fields has declined significantly, reflecting the success of the state and Central governments' efforts and the security forces' multi-pronged strategy against illegal poppy farming.

The Assam Rifles has been identifying and destroying illegal poppy cultivation in mountainous and forest areas actively in coordination with state and central agencies, including the Narcotics Control Bureau (NCB), Manipur Police and other Central Armed Police Forces deployed in the area. The NCB, as the nodal agency for drug enforcement under the Ministry of Home Affairs, ensured synergy among all stakeholders during operations, especially during the opium harvesting seasons. Joint operations of different forces have focused on curbing cultivation, disrupting supply chains and dismantling the networks sustaining the illicit drug trade.

Beyond destruction operations, Assam Rifles has also prioritised addressing the socio-economic factors driving poppy cultivation, the spokesman said.

### 200 Russian, North Korean troops allegedly killed in combat against Ukraine: Kyiv

200 Russian and North Korean soldiers were estimated to have been killed while fighting in combined units against Ukrainian forces, Kyiv's intelligence authorities said, without specifying the number of casualties for each side.

The Defence Intelligence of Ukraine (DIU) made the revelation in a statement, noting that North Korean soldiers have been mobilised for asbined units of Russia's Marine Corps and airborne troops, Yonhap news agency reported on Thursday.

Claiming that the North Korean troops suffered 'irreversible losses' from Ukraine's attacks, the DIU said the language barrier is an issue for Russian and North Korean combined units in conducting coordinated operations.

"Because of this problem, North Korean soldiers opened 'friendly

Seoul, Dec 26 (IANS): Some sault operations as part of comfire' on the vehicles of the socalled Ahmat battalion. As a result, they killed eight Kadyrov soldiers," it said," referring to Chechen fighters. The Ukrainian military also released photos and footage of what appear to be dozens of North Korean soldiers killed along with Russian troops in Russia's Kursk border region, according to a Ukrainian media outlet. Ukrainska Pravda reported on Sunday, citing information from a drone unit, that the soldiers



whose bodies were shown covered in snow were killed during assaults in the Russian region bordering Ukraine on Saturday (local time). "The Madiar channel emphasised that this is a collaborative effort of FPV (first person view)-drone pilots of the 414th Unmanned Strike Aviation Systems Regiment, the Mahura Brigade, the 95th Air Assault Brigade.



#### **Cambodia launches** digital platform for informal economy

Phnom Penh, Dec 26 (IANS): The Cambodian government officially launched a digital platform for the informal economy on Thursday. Speaking at the launch event in Phnom Penh, Prime Minister Hun Manet said the portal marked an important milestone in implementing the National Strategy for Informal Economy Development 2023-2028. He emphasised the platform's significance in providing recognition and support for the informal economy. The move demonstrated the government's commitment to supporting the informal economy, aiming to create opportunities and enhance living standards and overall wellbeing, Manet said, Xinhua news agency reported.



### New Zealand sees increased prices for domestic flights, accommodation

Wellington, Dec 26 (IANS): New Zealand saw increased domestic air and hotel prices, which means the cost of exploring the country has become more expensive, according to the statistics department Stats NZ on Thursday.

New Zealand's domestic air transport prices were up 10.8 per cent in November 2024 compared with October 2024, the highest increase in domestic flight prices since July 2023, Stats NZ said.

New Zealand's domestic accommodation prices also rose, up 6.9 per cent over the month, it said. The increased prices for domestic flights coincided with performances by several

global artists around New Zealand, Stats NZ prices and deflators spokesperson Nicola Growden said. However, international airfares and international accommodation prices decreased 2.7 per cent and 4.6 per cent respectively, statistics show, Xinhua news

Meanwhile, monthly food prices fell 0.1 per cent in November 2024 compared with October 2024, which was contributed by the price fall of vegetables, down 7.9 per cent, Growden said, adding this was the third consecutive month that vegetable prices fell alongside rising fruit prices.

Annually, food prices increased 1.3 per cent in the 12 months to November 2024, contributed by butter, milk, and olive oil, following a 1.2 per cent increase in the 12 months to October 2024. According to Stats NZ, New Zealand-resident traveller arrivals were 2.97 million in the October 2024 year, an increase of 383,000 from the October 2023 year.

Regarding border crossings, there were 1.07 million border crossings in October 2024.



#### Outbreak of sheep, goat plague reported in western Mongolia

Ulan Bator, Dec 26 (IANS): An outbreak of a highly contagious disease affecting sheep and goats has been reported in the western Mongolian province of Khovd, local media reported on Thursday.

"Several cases of Peste des Petits Ruminants (PPR), commonly known as sheep and goat plague, have been confirmed in Bulgan soum (an administrative subdivision) of the province," the Bulgan soum governor's office said in a statement.

As a result of the outbreak, the soum has been placed under quarantine for an undetermined period, the statement added, Xinhua news agency reported.

The livestock sector is a cornerstone of the Mongolian economy, but frequent outbreaks of livestock diseases pose significant challenges to the industry.

Mongolia is one of the world's last surviving nomadic countries, where livestock husbandry plays a crucial role in diversifying the landlocked nation's mining-dependent economy. As of the end of 2023, the country had 64.7 million livestock, with goats comprising 38.1 per cent of the total, according to the National Statistics Office.



Kabul, Dec 26 (IANS): A total of 137 people lost their lives and more than 330 others sustained injuries following the blasts of unexploded ordnances, remnants of past wars, across Afghanistan since the beginning of 2024, local media reported.

"As of the start of 2024, approximately 240 separate incidents have taken place in Afghanistan, resulting in a total of 470 fatalities, including 386 children who have been either martyred or injured," TOLOnews quoted Nooruddin Rustamkhil, head of the Directorate of Mine Action Coordination, as saying. According to Rustamkhil, among the deceased, 125 children, 10 men, and two women were accounted for, while the injured comprised



264 children, 53 men, and

Doha, Dec 26 (IANS): A Qatari diplomatic delegation has arrived in Damascus, the capital of Syria, to complete the procedures for reopening Qatar's embassy in Syria, Qatari Foreign Ministry spokesperson Majed Al Ansari said.

The delegation met with representatives of "Syria's transitional government" and reaffirmed Qatar's commitment to supporting the Syrian people in their pursuit of security, peace, development, and prosperity, according to Al Ansari,

Xinhua news agency reported. Al Ansari also noted that participants of the meeting also discussed ways to enhance the flow of Qatari humanitarian aid and assessed the urgent needs of the Syrian population during this critical phase.

#### Bangladesh plans national election by late 2025 or mid 2026

Dhaka, Dec 26 (IANS): Bangladeshi interim government's Chief Advisor Muhammad Yunus Thursday said it may be possible to hold the next national elections at the end of 2025 or the first half of 2026. "The election can be scheduled between the end of 2025 and the first half of 2026," he said in a televised speech to the nation at 10 am local time on Thursday marking the country's Victory Day. Yunus said he repeatedly appealed to all to arrange the elections after completing all the necessary major reforms. But, due to political consen-

sus, it may be possible to hold the elections by the end of 2025 after completing minor reforms based on the preparation of an accurate voter list, he said. Yunus urged the Election Commission and all social institutions and political parties to take various creative programmes to achieve this goal.





#### Mentally stimulating down time activities linked to better brain health: study

Canberra, Dec 26 (IANS): Engaging in mentally stimulating activities during down time, such as reading, can be beneficial for brain health, according to an Australian research. In a new study, researchers from the University of South Australia (UniSA) found that some sedentary, or sitting, activities are better for cognitive function than others. The researchers assessed the 24-hour activity patterns of 397 adults aged 60 and above, and found that socially or mentally stimulating activities such as reading, playing musical instruments, crafting or talking to others are beneficial for memory and thinking abilities. Watching television or playing video games was found to be detrimental. The researchers said the findings could help reduce the risks of cognitive impairment, including from dementia. "We already know that physical activity is a strong protector against dementia risk, and this should certainly be prioritised if you are trying to improve your brain health. But until now, we hadn't directly explored whether we can benefit our brain health by swapping one sedentary behavior for another," Xinhua news agency quoted Maddison Mellow, a co-author of the study from UniSA, as saying in the report. She recommended breaking up time spent watching TV or gaming with fiveminute bursts of physical activity or more cognitively-engaged seated activity.



#### Jharkhand HC provides relief to CM Hemant Soren in ED summons case

Ranchi, Dec 26 (IANS): The Jharkhand High Court on Thursday granted relief to Chief Minister Hemant Soren in a case related to his alleged non-compliance with Enforcement Directorate (ED) summonses. During the hearing, the court extended the exemption from Soren's personal appearance in the MP-MLA Special Court of Ranchi until January 16, 2025. Previously, the bench of Justice Anil Kumar Chaudhary had issued a notice to the ED and directed the agency to file a reply. As the ED had not submitted its response so far, the court, granting the agency another opportunity, scheduled the next hearing for January 16, 2025.

The case originates from a complaint filed by the ED on February 19, 2024, in the Chief Judicial Magistrate's (CJM) court, accusing Soren of violating Sections 63 of the Prevention of Money Laundering Act (PMLA) and 174 of the Indian Penal Code (IPC). According to the complaint, the ED issued ten summonses to Soren for questioning regarding a land scam linked to the Bargain Zone of Ranchi. Soren appeared in response to only two summonses, which the ED claimed constituted non-compliance under the law. The CJM court took cognisance of the complaint on March 4, 2024, and subsequently transferred the matter to the MP-MLA Special Court.

#### 'Blatant violation': Kerala HC mulls contempt action against CPI-M over road blocking

Kochi, Dec 26 (IANS): The Kerala High Court on Thursday spoke tough as it heard a petition against CPI-M state Secretary M.V. Govindan for leading the party area conference on the main road in the state capital city and is mulling if suo moto contempt proceedings should be initiated against party leaders for this blatant violation of laws. What has irked the high court is this meeting venue opposite just Thiruvananthapuram district court and also the Vanchiyoor police station. One reason why the court took a strong position is they noted that 40,821 road accidents occurred in the state this year up till October, in which 3,168 persons died and 45,657 persons sustained injuries.

Those arrested have been identified as Gagandeep Singh and Navjot Singh, both residents of Amloh in Fatehgarh Sahib, Lakhwinder Singh, a resident of Bhadson in Patiala and Vipanpreet Singh, a resident of Faridkot.

Besides recovering arms and ammunition from them, the police have also impounded their white Swift car, in which they were travelling. DGP Yadav said the accused confessed to have fired at a car accessories showroom in Phase 11, Mohali on the intervening night of December 1 and 2 with an intention to intimidate the shop owner and extort money from him as directed by their foreign-based handler, Daljit Singh, alias Ninda.

He is a history-sheeter and fled to the US on a passport with fake particulars and is associated with a radicalised US-based gangster. The DGP said the module was linked to radical Arsh Dalla and was planning to execute more crimes in Punjab at his behest.

All the arrested accused have an extensive criminal history with a number of cases registered against them, the DGP said, adding further investigations are ongoing to identify more people involved in this module.

Additional Director General of Police, (AGTF), Promod Ban said following the firing incident at a car accessories showroom, special teams of the AGTF under the supervision of AIG Gurmeet Chauhan and AIG Sandeep Goel in coordination with Senior Superintendent of Police (Mohali), Deepak Pareek, were formed to crack the case.

The teams gathered CCTV footages, technical inputs and evidence from the crime spot which led to identification of the accused, including the two shooters involved in the crime, he said



Airtel lost 24 lakh subscribers in August 2024 and 16 lakh subscribers in July 2024. Vodafone Idea lost more than 19 lakh mobile subscribers in October, compared to a decline of 15.5 lakh in Septem-

The decline in the subscriber base for the private telecom player can be attributed to the tariff hike by the companies in mid-2024, which came into effect in July.

#### Hackers steal over \$12.7 billion in over 1,000 crypto heists to date

New Delhi, Dec 26 (IANS): Crypto criminals have stolen over \$1.71 billion worth of cryptos this year, pushing total thefts to shocking levels at \$12.7 billion across more than 1,000 heists to date, data showed on Thursday.

The high value and anonymity of cryptocurrencies make them a magnet for criminals, helping the total value of criminal crypto transactions to hit shocking highs, according to the report by CryptoPresales.com. In five of the past 10 years, including 2024, hackers have stolen over \$1 billion annually.



#### EV maker Ampere's revenue declines by 46 pc to Rs 612 crore in FY24

New Delhi, Dec 26 (IANS): Electric vehicle (EV) maker Ampere's total income from operations in FY24 declined by 46 per cent to Rs 612 crore, from Rs 1,124 crore in FY23. Ampere's losses also surged nearly 11 times to Rs 215 crore last fiscal, from Rs 20 crore in FY23.

If the company's non-operative (one-time cost) of Rs 477 crore is included, then the company suffered a massive loss of Rs 693 crore in FY24, as per its financials with the Registrar of Companies (ROC). The reason for the decline in the company's income was drop in its scooter sales. Ampere also offers three-wheeler electric vehicles along with electric scooters. Electric scooters accounted for 70 per cent of the company's sales in FY24. The company's income from EV scooters



fell 59 per cent to Rs 432 crore. However, sales of electric threewheelers grew 2.5 times year-onyear to Rs 178 crore. In the last financial year, Ampere earned Rs 29 crore from non-operational activi-

ties and Rs 2 crore from the sale of scrap. The share of material cost in the total expenses of the company was 61 per cent in FY24. It declined by 40 per cent to Rs 526 crore in FY24.



#### **Exporting MSMEs up from** 52,849 in 2020-21 to 1,73,350 in 2024-25

New Delhi, Dec 26 (IANS): The total number of exporting micro, small and medium enterprises (MSMEs) increased considerably from 52,849 in 2020-21 to 1,73,350 in 2024-25, the government said on Thursday.

MSMEs exports have witnessed a remarkable rise, increasing from Rs 3.95 lakh crore in 2020-21 to Rs 12.39 lakh crore in 2024-25, underscoring their critical role in boosting India's economy and strengthening global trade. MSMEs demonstrated an exemplary growth trajectory, contributing 45.73 per cent to exports in 2023-24, which increased to 45.79 per cent by May 2024, highlighting their growing impact on India's trade performance.

Notably, the gross value added (GVA) by MSMEs in India's GDP was 29.7 per cent in 2017-18 which rose to 30.1 per cent in 2022-23. Even amid the unprecedented challenges posed by the COVID-19 pandemic, the sector sustained a contribution of 27.3 per cent in 2020-21, rebounding to 29.6 per cent in 2021-22. These figures highlight the sector's pivotal role in driving economic growth and stability, reflecting its en-

during strength and importance to the Indian economy, said the Ministry of Micro, Small and Medium Enterprises. Between July 1, 2020, and July 24, 2024, a significant number of enterprises transitioned to medium enterprises. During the financial year 2020-21 to 2021-22, 714 micro enterprises scaled up to medium and 3,701 small enterprises were upgraded to medium enterprises, informed the ministry.

#### IREDA lines up Rs 3,000 crore for green energy projects in Odisha

Soon after the coaching centre's management called 108 ambulance services, and other students helped carry the unconscious individuals to a nearby private hospital.

A doctor from a private hospital had earlier confirmed that seven students were brought in with symptoms of suffocation and respiratory distress, while the remaining students were admitted to other medical facilities. "The affected students reported coughing and breathlessness but are now in stable condition," the doctor said. Amid the chaos, a clash broke out between the police and some student leaders.

Authorities have ruled out the possibility of gas leakage or the smell emanating from the kitchen of a nearby PG facility. The exact cause remains unclear.

On Monday, the municipal corporation's investigation team conducted a thorough examination of the premises.





### **Madras HC questions** TN govt on slow action in corruption cases

Chennai, Dec 26 (IANS): The ruption. The court highlighted Madras High Court has strongly criticised the Tamil Nadu government for its slow action in addressing corruption charges and misappropriation cases involving state government employees. A division bench comprising Justices Subramaniam and Jothiraman remarked on Thursday that despite numerous complaints, even basic services were not being provided to the public without the involvement of cor-

widespread complaints of corruption across state government departments, including uniformed services.

The bench directed the Tamil Nadu Home Secretary to respond by January 6, 2025, detailing the government's stance and actions against these allegations.

Justice Subramaniam observed: "It is painful to note that poor people have to shell out thousands of rupees as bribe money just to obtain nativity certificates, patta, and other essential documents. When government employees receive their salaries and allowances on time, why should the poor suffer?"

The court further questioned whether the state government was effectively monitoring and controlling the actions of uniformed personnel. It sought clarity on whether appropriate action was being taken against police and prison department officials for lapses, dereliction of duty, and abuse of power.

#### 21 'fake universities' operating in country; 8 based in Delhi

New Delhi, Dec 26 (IANS): There are 21 "fake universities" operating in the country and the respective state governments are taking action against them, the Parliament was informed on Thursday. Education Minister Dharmendra Pradhan said in a reply in Lok Sabha that the list of fake universities is available on the website of the University Grants Com-(UGC) at https:// www.ugc.gov.in/universitydetails/ Fakeuniversity. Out of these 21 "fake universities", a maximum of eight are functioning in Delhi, according to the website. The Minister said that to prevent these institutions from defrauding and cheating students by misrepresenting themselves as "Universities," the Central government has requested Chief Secretaries of all the states and Union Territories to take legal action for the closure of these institutions.





#### Crimes against female students in MP must be addressed on priority: BJP MLA

According to the MCG officials, arrangements have been made in the Bandhwari landfill site to deal with the fire. Six machines have been installed to detect methane gas. With the help of CCTV cameras, the landfill site is being monitored 24 hours a day. Entry of any outsider in this garbage dump has been banned. Claim-

ing to have made all necessary arrangements to deal with fire in future, Joint Commissioner of the MCG Akhilesh Yadav has filed an affidavit in the National Green Tribunal (NGT). Due to repeated incidents of fire in the Bandhwari



garbage dump, NGT had sought answers from the Central Pollution Control Board, Haryana State Pollution Control Board, Forest Department, District Deputy Commissioner and MCG in this matter. At present, garbage from Gurugram and Faridabad is being dumped here.

#### 209 Hindus killed in Sambhal since 1947: CM Yogi

Lucknow, Dec 26 (IANS): Uttar Pradesh Chief Minister, Yogi Adityanath, while addressing the Winter Session of the Assembly on Thursday, accused the Opposition of turning a blind eye to violence against Hindus in Sambhal in the state. Yogi Adityanath stated that 209 Hindus have been killed in communal incidents in Sambhal since 1947. Yogi Adityanath elaborated on the history of violence in the region, saying, "Riots started in Sambhal from 1947 itself. One person was killed in 1947, six more in 1948. Between 1958 and 1962, several riots took place, and five people were killed in 1976. In 1978, 184 Hindus were burnt alive in mass violence, leading to curfews lasting several months. Riots continued into the 1980s, which claimed more lives -- one in 1980, one in 1982, and four in 1986. Violence persisted in 1990-1992, with five deaths, and in 1996, with two more deaths." He accused the Opposition of remaining silent during these incidents. "Since

1947, 209 Hindus have been killed in Sambhal, but not a single word was spoken for the innocent victims. Those shedding crocodile tears today never stood for justice back then," he said. Yogi Adityanath also recounted the horrors of the 1978 riots, alleging that a Hindu moneylender who had provided loans to locals was targeted, along with others who had sought refuge in his home.

"They were surrounded, brutally attacked and murdered in the most inhuman ways. Yet, Opposition leaders dare to talk about harmony today," he said. Yogi Adityanath also pointed to Uttar Pradesh's improved law and order situation under his government.

#### I saw Nehru documents being shredded, says historian Rizwan Kadri

Ahmedabad, Dec 26 (IANS) : Historian Dr Rizwan Kadri on Thursday claimed that he had seen an elderly person shred many documents and letters related to first Prime Minister Jawaharlal Nehru.

Dr Kadri, a member of the Prime Ministers' Museum and Library (PMML) Society, told IANS, "An internal inquiry committee has been set up to look into allegations of destruction and non-availability of documents related to Nehru." The researcher said in 2008, a total of 51 carton boxes containing Nehru's letters written to various persons, including Aruna Asif Ali, Jaiprakash Narayan, Govind Ballabh Pant and Edwina Mountbatten, the last vicereine of India, were "withdrawn" from the PMML in New Delhi at the request of Congress leader Sonia Gandhi, as a representative of the donor family. He said before the withdrawal of the documents these were bifurcated as offi-



cial correspondence and private papers. Seeking an early return of the Nehru letters and documents to the museum to facilitate research, Dr Rizwan, known for his research on Sardar Vallabhbhai Patel, said, "I have no clue about the fate of the documents in 51 boxes that were withdrawn by Sonia Gandhi." He said researchers like him would continue to request and wait to get access to the crucial documents, hoping the documents would be digitized and shared with the public by Gandhi on a website at some stage. Dr Rizwan expressed regret that the documents were withdrawn -- something which should not have happened once these had been donated to the Museum. "This matter was also discussed in the institution and there were some who expressed that the documents could not be withdrawn once these had been donated. Legal opinion was also taken and a suggestion for auditing of documents was also given. An internal inquiry committee has also been set up to look into the matter," he said. Calling the withdrawn collection very important, he refused to speculate if the documents would still be safe.

#### Bhubaneswar: Bees attack Cong workers during protest against IAS officer

Bhubaneswar, Dec 26 (IANS): The workers of Odisha Chhatra Congress and Yuva Congress were attacked by a swarm of bees during their protest near the residence of senior IAS officer and principal secretary in the SC/ST welfare and Odisha language department, Bishnupada Sethi here on Thursday. #### Can basic safety be implemented in slums and JJ clusters, Delhi HC asks Fire Dept, MCD

New Delhi, Dec 26 (IANS): narrow and congested lanes," said The Delhi High Court on Thursday asked the city government's Fire Department and Municipal Corporation of Delhi (MCD) to examine the feasibility of implementing a basic level of safety for the residents of slums and JJ clusters.

A bench of Acting Chief Justice Vibhu Bakhru and Justice Tushar Rao Gedela was hearing a public interest litigation (PIL) highlighting the tragic incident in the slums of Neb Sarai, where a fire claimed the lives of a 12-yearold girl and a woman.

"This preventable disaster occurred because emergency services, including fire brigades, could not access the area due to the petition filed by Alliance For People's Rights, a network of NGOs.

The petition said that the fire caused immense hardship to approximately 100 individuals, most of whom belonged to economically vulnerable groups, and these families lost not only their makeshift homes but also their meagre possessions, plunging them further into despair.

Six commuters lost their lives and four others sustained injuries as a jeep plunged into a river in northern Badakhshan province last week. Poor conditions on roads, reckless driving and lack of security measures are among causes of deadly road accidents in the warravaged country.

Earlier this month, in an accident

that took place in northern Jawzjan province on a highway linking the province with neighbouring Sari Pul province, one person was killed on the spot and 10 others were injured.

In another accident, a car veered off the road and overturned in Shahr-e-Safa district of southern Zabul province along a highway linking Kandahar with the national capital Kabul, killing two and injuring two others.

The officials had blamed reckless driving for the mishaps, asserting that drivers' carelessness on congested roads often claimed commuters' lives.

On November 25, at least six people were killed after a passenger vehicle fell into the Kokcha River in the Badakhshan province. The mishap took place when the vehicle was heading toward Faizabad city, the capital of the province.

#### **Swachh Bharat Mission** drives toilet cleaner usage in India by 53pc in 2024

New Delhi, Dec 26 (IANS): country-wide campaign initiated Swachh Bharat Abhiyan or Clean India Mission has driven toilet cleaner usage in Indian households by 53 per cent in 2024, according to a report. 

# Pakistan to act against human traffickers after migrant boat capsizes in Greece

Islamabad, Dec 26 (IANS): Pakistan Prime Minister Shehbaz Sharif has taken serious note of the boat capsize incident in southern Crete Island of Greece, which was carrying dozens of Pakistanis trying to enter Europe illegally. He directed the country's interior ministry to identify and nab the mafia of human traffickers operating in the country.

So far, at least one Pakistani is confirmed dead while at least 47 others have been rescued following incidents of capsized boats in the south of Crete Island of Greece on Thursday. Pakistan foreign office stated that they cannot confirm the number of deceased or missing Pakistani nationals for now.

"According to initial reports, 47 Pakistanis are among those rescued following yesterday's incidents of capsized boats in Crete Island of Greece. One Pakistani is confirmed to be among the dead. At this stage, we are unable to confirm the number of deceased or missing Pakistani nationals," read a statement issued by Pakistan's foreign office.





# Mystery illness that causes 'excessive body shaking' affects about 300 people in Uganda

New Delhi, Dec 26 (IANS): About 300 people in Uganda have reportedly been affected by a mystery illness that causes 'excessive body shaking'. The disease, named 'Dinga Dinga' by locals in the country's Bundibugyo district, is majorly affecting women and girls, Ugandan newspaper The Monitor reported. The symptoms of the illness include fever and excessive body shaking which makes walking a challenge.

The illness is currently being treated with antibiotics, given by community health teams, and no fatalities have been reported so far, Dr. Kiyita Christopher, the district health officer, was quoted as saying.

"There is no scientific evidence that herbal medicine can treat this disease. We are using specific treatments, and patients usually recover within a week. I urge locals to seek treatment from health facilities within the district," he said. The doctor noted that no instances had been recorded in nearby areas outside of the Bundibugyo region.

He informed that samples have been submitted to the health ministry for analysis. The country's Health Ministry is yet to issue an official statement about the disease. The last such disease was recorded as the dancing plague of 1518, which occurred in Strasbourg, France. People would dance spontaneously, often for days on end, seemingly against their own will and without the ability to stop, and some reportedly died due to over-exhaustion. Meanwhile, another African country is also seeing a mysterious outbreak that has reportedly affected about 400 people.



# South Korean govt to expedite economic policy implementation to assist market stabilisation

Seoul, Dec 26 (IANS): The South Korean government will accelerate its implementation of key economic policy measures to help normalise financial markets, which have largely stabilised following the impeachment of President Yoon Suk Yeol over the weekend, the country's top economic policymaker said Thursday. Finance Minister Choi Sang-mok made the remarks during an emergency meeting with Bank of Korea Governor Rhee Chang-yong and other top financial officials, which has been held on a daily basis to discuss ways of minimising economic impacts of Yoon's short-lived imposition of martial law on December 3, Yonhap news agency reported. Officials at the meeting noted that the local stock market has shown significant stabilisation, thanks to active government intervention and a buying spree by institutional investors. Volatility in the foreign exchange market, which initially spiked, has also largely subsided, they added, according to the finance ministry.

# Israel launches first wave power plant

Jerusalem, Dec 26 (IANS): Israel has inaugurated its first power plant that generates electricity from sea waves, Israel's Ministry of Energy and Infrastructure said in a statement. Located at Jaffa Port in the Mediterranean city of Tel Aviv-Yafo, the power plant has an installed capacity of 100 kilowatts. It was developed by the Israeli energy company Eco Wave Power and built in collaboration with the French state-owned electricity utility EDF and the Tel Aviv-Yafo Municipality, with funding from the Ministry of Energy and Infrastructure, Xinhua news agency reported.

The facility consists of 10 buoys installed along the breakwater at Jaffa Port, each connected to a patented energy conversion unit that allows for



easy operation and maintenance. The buoys rise and fall with wave movements, driving a hydraulic motor and generator onshore. The system is capable of generating electricity from waves as low as 60 cm in height. Equipped with a smart control system, the technology raises the buoys above the sea surface during storms to prevent damage.

All electricity generated by the project is supplied to Israel's national grid, with the state-owned Israel Electric Corporation purchasing all the energy produced by the facility.

The ministry noted that the project is a step toward increasing energy production from renewable sources, reducing air pollution, and enhancing Israel's energy security.



#### Australia warns travellers to Fiji of methanol poisoning risk Canberra, Dec 26 (IANS)

: The Australian government has updated its travel advice for Fiji after several tourists were hospitalized with suspected alcohol poisoning. Australia's Department of Foreign Affairs and Trade (DFAT) has advised travellers to Fiji to be wary of potential methanol poisoning through alcohol.

It comes after seven tourists, including four Australians, were hospitalized after consuming alcohol at a resort bar in Fiji on Thursday night local time.

# Israel continues airstrikes across Syria, targeting military arsenals

Damascus, Dec 26 (IANS): Israeli warplanes launched multiple airstrikes early Thursday, targeting former military arsenals across Syria, according to a war monitor. The latest raids hit missile bases in Battalion 107 near Zama and weapons warehouses in rural Tartus, the Britain-based Syrian Observatory for Human Rights reported. Earlier on Thursday evening, an Israeli jet reportedly struck radar installations at the Deir Al-Zour Military Airport in eastern Syria. Israeli aircraft targeted former munitions depots dug into mountains in Rural Damascus, causing a series of powerful explosions.

There were no reports of casualties. These attacks are part of an ongoing military campaign by Israel that began on December 8, targeting any remaining military capabilities linked to Syria's former leadership, as the country's new authorities are working to stabilize the country's security situation.

Meanwhile, Syria's Hayat Tahrir al-Sham (HTS)



leader, Ahmad al-Shara, held a meeting with UN Special Envoy for Syria Geir Pedersen in Damascus to discuss the political transition in the country, according to a statement released by local al-Watan Online news outlet.

Al-Shara, also known as Abu Mohammed al-Julani, said that UN Security Council Resolution 2254, adopted in 2015 concerning Syria's political transition, now requires an update to reflect the current realities in the country, urging a "fresh approach" that aligns with Syria's new leadership and evolving circumstances.

# Peace talks over eastern Congo aborted

Kinshasa, Dec 26 (IANS): A peace summit scheduled for Thursday to address conflicts in the eastern Democratic Republic of the Congo (DRC) was called off at the last minute due to a tough negotiation standoff, it was revealed on Thursday.

Angolan President Joao Lourenco was set to host DRC President Felix Tshisekedi and Rwandan President Paul Kagame, in a bid to ease tensions gripping the eastern DRC by securing an agreement supposed to be signed by the three heads of state.

The summit was planned as part of the "Luanda Process," a peace initiative launched in 2022 and endorsed by the African Union, to accelerate re-

gional stabilization. Tshisekedi arrived in the Angolan capital of Luanda early Sunday for the summit and met with Lourenco and former Kenyan President Uhuru Kenyatta, broker of the "Nairobi Process," a parallel peace mechanism led by the East African Community (EAC). However, Kagame did not board a flight to Luanda and walked away from the summit, Xinhua news agency reported. "The agreement has been 99 per cent negotiated," Angolan Foreign Minister Tete Antonio told the press after the tripartite summit was called off. "One of the parties requested the postponement of the summit until there is a common language," said Antonio. The peace agreement was aborted due to a tough negotiation standoff. Meanwhile, tensions



have been on the rise on the ground with ongoing clashes between government military and rebels. According to Rwanda's Foreign Ministry, the ministerial meeting in Luanda on Saturday failed to reach a consensus between Rwanda and the DRC regarding a commitment to direct talks with the March 23 Movement (M23) rebel group. "The DRC had accepted the principle of a dialogue with the M23, before surprising us with a refusal on the eve of the summit," said Rwandan Foreign Minister Olivier Nduhungirehe.

The eastern DRC continues to face instability due to the M23 rebel group, which has been advancing and seizing large areas of territory.



# Lula vows to 'severely punish' coup plotters after recovery

Sao Paulo, Dec 26 (IANS): Brazilian President Luiz Inacio Lula da Silva has vowed to "severely punish" those involved in the 2022 coup attempt. "I believe that General Braga has every right to the presumption of innocence," Lula said during a press conference, referring to the detained retired general Walter Braga Netto, who served as minister of defence under former President Jair Bolsonaro.

The event, held at Sirio Libanes Hospital shortly after Lula's discharge, marked his first public appearance since undergoing emergency skull surgery last week.
