Rajanna Siricilla, Jan 2 (TIM Bureau): Rajanna Siricilla said that with the aim of ensuring that everyone who drives after 18 years of age has a license, the second phase of the license fair was organized under the auspices of the District Police Department and Road Transport Department for the young men and women in the district. Up to 700 applications were received.

They said that learning licenses were issued to all of them after conducting an online test in stages and those who passed it would be issued a driving test within a month. SP Akhil Mahajan said that 30 people who came from different police stations were given learning licenses after conducting license tests at the RTO office on

Thursday."Speaking on the occasion, the SP said that these days there is no house without a two-wheeler, and even if there is a vehicle, many people are coming on the roads without a driving license.

Those who drive vehicles without a license are at risk of accidents due to lack of awareness about road safety. Dense fog enveloped a few areas on the outskirts of Hyderabad and united Medak district on Thursday morning. According to the Telangana State Development Planning Society (TSDPS), some areas of Medak and Sangareddy districts recorded minimum temperature in single digit. Eleven out of 33 districts recorded a minimum temperature of 15 degrees Celsius or less.

Sirpur in Komaram Bheem Asifabad district was the coldest place in the state with a minimum temperature of 7.3 degrees Celsius. Tiryani, also in Komaram Bheem Asifabad, recorded a minimum temperature of 8 degrees Celsius. In Kohir of Sangareddy district, the minimum temperature dropped to 8.4 degrees Celsius. Algol in the same district recorded a minimum temperature of 9.1 degrees Celsius while it was 9.5 in Nyalkal.

Tekmal in Medak district recorded a minimum temperature of 11.5 degrees Celsius while Damarancha recorded 11.7 degrees Celsius.

The minimum temperature in Munigadapa saw a minimum temperature of 11.7 degrees Celsius while Kondapaka recorded 12.2 degrees Celsius.

Minimum temperatures also dropped in Hyderabad and its suburbs. University of Hyderabad (UoH) campus in Gachibowli recorded the lowest temperature of 11 de-

grees Celsius. As temperatures dropped considerably, a layer of thick fog enveloped several places, especially Hyderabad's outskirts like Kompally, Patancheru, L B Nagar and Vanasthalipuram. Minimum temperatures in Greater Hyderabad, which was hovering between 15 degrees Celsius and 19 degrees Celsius for the last few days, dropped to less than 15 degrees Celsius. At Moula Ali, the minimum temperature dropped to 12.1 degrees Celsius while Rajendranagar recorded a minimum of 12.3 degrees Celsius. According to the India Meteorological Department, low-level winds are blowing mainly from East / North East direction. Dry Weather is very likely to prevail over the state.

34 DAYS FROM JUNE 21 TO JULY 24, 1991 THAT SHOOK THE INDIAN ECONOMY

n June 21, 1991, the 70-year-old Congress veteran PV Narasimha Rao took oath as the Prime Minister of a minority government amidst massive political uncertainty over its survival. The Congress had got only 232 seats as against the usual majority of 272 in the Lok Sabha elections in 1991 out the total strength of 543. Only one month ago, on May 21, Rajiv Gandhi was killed in the course of campaign for the Lok Sabha elections. Sonia Gandhi was in mourning and Rao was also acting as the Congress president. The next 34 days from June 21 to July 24, the day, P V Narasimha Rao's first budget was presented by the Finance Minister Dr. Manmohan Singh, had all the elements of a high octane political and economic thriller which can be made use of by an ace director to make a top-class eco-political film. The soft-spoken Brahmin, the former chief minister of Andhra Pradesh who knew 17 languages, created history by pioneering the economic reforms through his first budget and the new industrial policy presented on the same day July 24.In full collaboration with the economist finance minister Dr. Manmohan Singh.

Those who had the opportunity to observe the developments from close quarters in those tumultuous days, saw how resolutely, Prime Minister P V Narasimha Rao protected his Finance Minister from all attacks by his senior Congress colleagues and led the senior bureaucrats to go ahead with the reforms programme despite continuous feedback from the Congress seniors that Rao was deviating from Nehruvian policies. Influential leaders like Arjun Singh, M K Fotedar and Natwar Singh were very angry and they were looking for gaps in the measures being proposed by Rao-Singh team.. Dr. N K P Salve even met the Prime Minister and told him that Dr. Manmohan Singh was a bad choice and he must

Dr. Manmohan Singh was under tremendous pressure since he was an outsider. Rao told him to go ahead as planned and he assured that he would take care of the political impact of the budget. Rao as both PM and the Congress President organised a series of meetings to explain to the seniors — including Arjun Singh, N K P Salve and Natwar Singh — the precarious status of the economy and why the steps proposed by him were absolutely needed to salvage the situation. But still, the draft new industrial policy was disapproved at the cabinet meeting on July 19. Rao agreed to make some changes, but peripheral to the main thrust of the policy, and finally succeeded in getting it approved at the meeting on July 23, just one day before its presentation in Parliament.

The Rao government had the benefit of a qualified team of senior bureaucrats who worked till late night in fine-tuning the explosive new ideas of the Prime Minister. And the Finance Minister. They were firmly behind the Rao-Singh team and did not waver even a little thinking that it was a minority government, even though Rao was also under fire from senior leaders from his own party. The team consisting of Naresh Chandra, A N Verma, Montek Singh Ahluwalia, S. Venkitaramanan and Dr. C Rangarajan was always available to assist Rao whenever there was any issue requiring any clarification. They were equally aware of the importance of their efforts in making a success of the economic reforms programme pursued by Rao. This team led by Naresh Chandra—the hefty general-like cabinet secretary, made the draft ready even before Rao took oath. They knew the priorities of the new government, irrespective of the combination and kept the emergency plan ready focusing on foreign exchange management, which was primarily the work of Dr. C. Rangarajan. It was a smooth affair as Rao took over and okayed their draft with small changes. The big advantage of Rao was that despite all adverse talks in the media about the Chandrasekhar government, both the short-term Prime Minister and the Finance Minister Yashwant Sinha were persons with sharp mind and they prepared an ad hoc programme for implementation by the new government which would take over. The IMF-World Bank prescriptions were there and Rao's advisers, after taking over, found many of the proposals made by the erstwhile Chandrasekhar government fit for imple-

ore often than not, patients and even nurses Association and other and doctors are skipping steps that help paint an accurate portrait of someone's blood pressure -- how someone sits and positions their arm, whether they just had a cup of joe or chitchat with their practitioner during the measurement, and other factors can produce readings that are higher or lower than normal blood pressure. "To really make a dent at improving people's cardiovascular health, we need to screen and treat people for hypertension, but we need to do it correctly," Tammy Brady, a pediatric nephrologist at the Johns Hopkins Children's Center in Baltimore who studies blood-pressure measurement and cardiovascular health in children and adults, told The Wall Street Journal.

"Getting the right reading is important for preventing heart attacks, strokes and other potentially fatal conditions," noted the newspaper, Xinhua news agency re-

What does it take to get the reading right? The patient should sit with both feet on the ground, legs uncrossed, back straight and your arm supported on a table or other surface, according to guidelines from the American Heart organisations. "A cuff should be positioned over your bare arm at the level of your heart. You shouldn't talk or scroll on your phone while it is being measured, and your bladder should be empty. And you should take your blood pressure at least a couple of times in a sitting," added the report. Meanwhile, last month, a research published by experts from an international academic collaboration led by the University of Sydney and University College London, had suggested that doing five minutes of physical activity, such as walking uphill or stair climbing every day may help to lower blood pressure.

Three killed, seven injured in hotel fire in Thailand

Bangkok, Jan 2 (IANS): Three people were killed and seven others injured as a fire broke out at a hotel in the Thai capital Bangkok, the local fire department said on Thursday. The fire broke out at a six-floor hotel building near Bangkok's popular backpacker area of Khao San Road, at about 9:21 p.m. local time (1421 GMT) on Thursday. The fire started from a room on the fifth floor, resulting in the immediate death of a woman tourist.

Two male tourists later died from their injuries at different hospitals. Among the seven injured, there were two Thai men and five foreigners, as reported by the local fire department.

Croatian Presidential election heads to runoff

Zagreb, Jan 2 (IANS): Croatia's Presidential election will head to a runoff on January 12 as no candidate secured more than half of the votes in the recent election, the Croatian State Election Commission (SEC) announced. With 99.88 per cent of votes counted, incumbent President Zoran Milanovic, backed by the largest opposition party, the Social Democratic Party, led the race with 49.10 per cent, narrowly missing a firstround victory. His main challenger, Dragan Primorac of the ruling Croatian Democratic Union, garnered 19.35 per cent, according to the SEC. Under Croatian election law, if no candidate wins an outright majority, the top two contenders proceed to a runoff two weeks later. Addressing his supporters, Milanovic expressed gratitude and confidence in securing victory.

"I believe that in two weeks we will celebrate the victory," he said. Primorac, speaking to his supporters, called the runoff "a great opportunity".

"Now a great opportunity is coming. Milanovic and I will be one one-on-one, so we will see who knows what and represents what," he said. "Croatia needs changes, and in two weeks, it will be a historic day."

The Croatian President serves a five-year term and can seek re-election once, Xinhua news agency reported. Although the Presidency in Croatia is primarily ceremonial, the elected President possesses political power and serves as the supreme commander of the military. Milanovic has expressed criticism towards NATO and



EU support for Ukraine, frequently asserting that Croatia should remain neutral and avoid involvement in international conflicts, despite its membership in organisations. Additionally, he has obstructed Croatia's participation in a NATO-led training initiative for Ukraine, stating that "no Croatian soldier will take part in somebody else's war." His principal opponent in the election, Primorac, has asserted that "Croatia's place is in the West, not the East." However, Milanovic's campaign for the Presidency has been overshadowed by a significant corruption scandal that resulted in the imprisonment of Croatia's Health Minister last month and was a central topic in pre-election discussions.



Sudan voices rejection to report on famine

Sudan rejected a report by an international organisation indicating the spread of famine in the country. The Sudanese government described the report, recently issued by the Integrated Food Security Phase Classification (IPC), a global hunger monitor, as based on inaccurate standards and speculative results.

"The report depended on outdated information, distant communications, and secondary sources, thereby raising concerns about its reliability," said a statement released by the Ministry of Foreign Affairs.

"The Sudanese government reiterates its unwavering commitment and keenness to alleviate the suffering of its people, enhance food security, and address the root causes of the humanitarian crisis," the statement added.

Khartoum, Jan 2 (IANS): In the report released earlier this week, the IPC said that famine is present in at least five areas of Sudan, including the Zamzam displacement camp in North Darfur and parts of the Western Nuba Mountains. The report also noted that 17 other areas in Sudan are at risk of famine.

Sudan has been gripped by a devastating conflict between the Sudanese Armed Forces and the paramilitary Rapid Support Forces since mid-April 2023, which claimed more than 29,680 lives and displaced over 14 million people, either inside or outside Sudan, according to the latest estimates by international organisations, Xinhua news agency reported.

Earlier on December 25, UN Secretary-General Antonio Guterres was alarmed by the rapidly worsening food security situation in Sudan and called for the parties to facilitate access to humanitarian assistance, his spokesperson said in a statement.

After over 20 months of conflict, more than 24.6 million people in Sudan — over half the population — faced high levels of acute food insecurity, the statement said, citing the latest UN-backed assessment.

In a report released by the Integrated Food Security Phase Classification (IPC), the global hunger monitor, famine was confirmed to be present in at least five areas of Sudan, including North Darfur's Zamzam camp and parts of the Western Nuba Mountains.

The crisis was projected to expand further, with five additional areas expected to face famine between December 2024 and May 2025.

South Korea: Investigators seek arrest warrant for Yoon in first for sitting Prez

Seoul, Jan 2 (IANS): South Korea's joint investigation team said on Thursday that it has sought an arrest warrant for President Yoon Suk Yeol over his short-lived imposition of martial law, making him the first sitting President to face arrest.

The team said it sought the warrant on insurrection and abuse of power charges after Yoon ignored three summonses to appear for questioning.

The request was filed with the Seoul Western District Court at midnight on Sunday, according to the team comprised of the Corruption Investigation Office for High-ranking Officials (CIO), the police and the Defence ministry's investigation unit.

Investigators say Yoon led an insurrection and abused his power when he declared martial law on December 3 and allegedly ordered troops to the National Assembly to stop lawmakers from voting down the decree.

Yoon has denied the charges, saying his declaration of martial law was an 'act of governance' to warn the opposition party against what he described as its abuse of legislative power.





Bengal CM hints at 'money game' influencing Sandeshkhali movement earlier this year

Kolkata, Jan 2 (IANS): West Bengal Chief Minister Mamata Banerjee, on Thursday, hinted at "money game" influencing the movement by locals at Sandeshkhali in North 24 Parganas district in West Bengal, especially women, earlier this year against sexual harassment and illegal land grabbing the local and non-suspended Trinamool Congress leader Sheikh Shahjahan.

In her first public meeting on Monday at Sandeshkhali, a conglomeration of islands in that coastal pocket of the district, since the movement broke out there, the Chief Minister directly did not refer to the protest movements there but gave clear hints on what she was meaning to say.

"There was a 'money game' at Sandeshkhali. The people were misled. But lies do not persist for long. So I request all of you to remain united. Do not fall in the trap of mischievous people. I request women to go anywhere if you are called by anyone," the Chief Minister said.

Speaking on the occasion, the Chief Minister also advised people to not pay any money to anyone to get the benefits under different social development schemes including rural housing schemes.

Guest teachers cheated by AAP govt: BJP MP Chandolia

They have also sought fixed monthly salaries with basic pay and dearness allowance and leave benefits.

The agitating teachers are also demanding reinstatement of terminated or released guest teachers. Chandolia said that the Delhi government has consistently exploited guest teachers. "The insensitive Kejriwal government only makes promises but fails to fulfil them," he said. The BJP MP lamented that it was an unfortunate situation where teachers, responsible for educating children in schools, were forced to protest on the streets for their rights.

He further highlighted that guest teachers, in service since 2010, are now overage and, therefore, no longer eligible to take competitive exams for reemployment.

"Guest teachers were a necessity for the government in the past, and now, the Delhi government has compelled them to protest on the streets to demand justice," he concluded.

Mumbai, Jan 2 (IANS): The asset quality of India's banks has improved further with their gross non-performing assets (GNPA) declining to 2.6 per cent of total advances in September 2024 which is the lowest level in the last 12 years, according to the RBI's latest financial stability report.

The net NPA ratio was around 0.6 per cent, according to the RBI's December 2024 issue of the Financial Stability Report (FSR). "Buoyed by falling slippages, higher write-offs and steady demand, the gross credit nonperforming assets (GNPA) ratio of 37 scheduled commercial banks (SCBs) fell to a multi-year low of 2.6 per cent," the report stated. The improvement in asset quality of SCBs was broad-based across sectors and bank groups, according to the report. According to the report, the share of large borrowers in the GNPA of banks has steadily declined over the past two years. The asset quality of banks' large borrower portfolios has improved considerably.

Hand over contractor suicide case to CBI or face protest on Jan 4: BJP to K'taka govt

CRPF head constable found dead in Kashmir, probe on

The head constable was found dead late Sunday evening. Officials said that he suddenly fell unconscious. "He was immediately shifted to the district hospital in Anantnag town where doctors said he was dead on arrival," said officials.

The head constable was identified as Kharat Prakash of G Coy 116 Battalion of CRPF. He was on duty in Anantnag district jail.

"Police have registered a case in this incident and investigation started to determine the exact cause of death of the CRPF head constable," the officials said.

Officials also said that an unidentified body was found on Monday near Tukutachloo village of Kulgam. "The body was first spotted by locals, who then informed the police. The police reached the spot and took the body into custody. The identity of the deceased is yet to be ascertained," officials said. The head of the cardiology department at the government medical college in Srinagar has issued an advisory based on international research about sudden deaths during extreme winters.



Bengal school job case: Charge framing process at special court postponed after accused hospitalised

Legal battles 2024: A look at bails granted to 5 key political leaders

New Delhi, Jan 2 (IANS): As 2024 nears its end, here are the key verdicts of the Supreme Court granting bail to influential politicians who were arrested by the Central Bureau of Investigation (CBI) or the Enforcement Directorate (ED) on corruption or money laundering charges. Bail to Arvind Kejriwal

In September this year, the Supreme Court directed former Delhi Chief Minister Arvind Kejriwal to be released on bail in connection with the corruption case linked to the alleged liquor policy scam.

While turning down his distinct plea challenging arrest by the CBI, Justice Surya Kant, heading a twojudge Bench, ordered Kejriwal's release on bail but restrained him from making any "public comments on merits of the case" pending trial before the court.

"The terms and conditions imposed by the coordinate Bench in the ED matter shall apply in this case also. The appellant

(Kejriwal) shall remain present before the trial court on each and every date of the hearing unless granted an exemption. He shall fully cooperate with the trial court for expeditious completion of trial proceedings," added the Justice Kant-led Bench.

In a judgment passed on July 12, another bench headed by Justice Sanjiv Khanna (now CJI) opined that former Delhi CM Arvind Kejriwal may be released on interim bail in the money laundering case, given the fact that the right to life and liberty is sacrosanct, and he has suffered incarceration of over 90 days.

The 2-judge Bench, also comprising Justice Datta, referred to a larger bench Kejriwal's plea challenging his arrest and subsequent remand by the ED in the alleged liquor policy scam for an authoritative pronouncement on the questions of law involved.

In the same judgment, the Justice Khanna-headed Bench had asked Kejriwal to take a call on stepping down from the CM post.

Bengal fake passport racket: Arrested agent had plans to escape to Bangladesh

Kolkata, Jan 2 (IANS): documents, including Indian Manoj Gupta, the agent associated with a fake passport racket in West Bengal and arrested by Kolkata Police, had plans to escape to neighbouring Bangladesh, said sources here. It was precisely with that motive, he had shifted to the rented accommodation at Gaighata in North 24 Parganas district which is close to the district's international border with Bangladesh.

Gupta was the seventh and last arrest made by the cops since December 15 for their involvement in the racket operating from the state and engaged in arranging fake Indian identity

passports, for the illegal infiltrators from neighbouring Bangladesh.

Sources from the city police said that following the subsequent arrest in this connection, Gupta, who was associated with a fake travel agency operating from Behala in south Kolkata, became sceptical that his turn of being arrested might be the next one. Gupta, said a city police official, became even more apprehensive about his arrest after the city cops arrested Dipankar Das, another associate of the same fake travel agency.





BJP MP Dinesh Sharma slams Akhilesh Yadav for not inviting people to Kumbh as CM

India's defence production poised to clock 20 pc annual growth in FY 2024-29

Mumbai, Jan 2 (IANS): On the back of robust government reforms and increasing private sector participation, India's defence sector production is set to grow at a compound annual growth rate (CAGR) of around 20 per cent during FY24-FY29, according to a report released on Thursday.

Indian defence sector companies are set to further enhance the country's defence capabilities, reduce import dependence, and elevate its global stature, the CareEdge Ratings report stated.

The collaboration between government and private sector entities in India's defence sector has driven advancements in arms and ammunition, aerospace, electronics, and naval technologies.

Private sector entities, both

domestic and multinational, are expected to play a pivotal role in advancing defence modernisation, leveraging their engineering and technological expertise, the report observed. This collaboration has been supported by policies such as 'Make in India' and liberalised FDI norms, which have enhanced domestic manufacturing capabilities, attracted international investments in defence innovation and driven notable growth in exports of military equipment, the report pointed out.

In recent years, India's defence budget has consistently ranged between 1.90 to 2.8 per cent of its gross domestic product (GDP). For the fiscal year 2024-25, a substantial allocation of Rs 6.22 lakh crore has been dedicated for the defence sector. Furthermore, India has set an ambitious annual defence production outlay of Rs 1.75 lakh crore for FY25 which is expected to grow at a CAGR of around 20 per cent to Rs 3 lakh crore (as per Ministry of Defence) by FY29, underscoring its commitment to becoming a self-reliant defence powerhouse, the report noted. Historically, India has been a net importer of defence equipment, heavily relying on foreign suppliers to meet its critical military needs. However, concerted efforts to promote indigenous defence manufacturing and technology development, supported by policy reforms such as the 'Make in India' initiative, are bringing about a gradual shift. Over the last six years ending FY24, Indian defence exports have grown at a healthy CAGR of approximately 28 per cent.





Prashant Kishor booked over students-cops clashes, says will lodge counter FIR in court

Patna, Jan 2 (IANS): Political strategist turned Jan Suraj Party chief Prashant Kishor on Thursday voiced strong criticism of police excesses on candidates protesting over irregularities in the 70th BPSC examination. He also vowed to file a counter FIR against the police, hours after he was booked for 'instigating' the students for violent stir.

Kishor announced his intention to approach both the court as well as Human Rights Commission to challenge the police's lathi charge on the protesting candidates. He criticized the government for filing FIRs against the protesters. "I would file cases in court and with the Human Rights Commission against the City Superintendent of Police (SP) who ordered the lathicharge," Kishor said.

"I am not going to be afraid of

anyone in uniform or kurta pajama," Kishor declared, signaling his resolve to 'confront' both administrative and political figures. Kishor also led a delegation of five students in meeting Bihar Chief Secretary Amrit Lal Meena to present a memorandum with five demands including the cancellation of the examination in light of allegations of a question paper leak and other irregularities. Kishor stated that if the demands are not addressed, he will lead an indefinite dharna (sit-in protest) in Patna to escalate the pressure on the government. Kishor denied allegations of his involvement in the police's lathi-charge on the students, asserting that the incident occurred 45 minutes after he left the protest site. He demanded accountability from the officers involved in it. Kishor criticized the FIR filed against 700 individuals,

including him and students like Aarti Mishra and Anand Mishra, calling the charges baseless. He demanded an immediate withdrawal of the FIRs. Kishor reiterated the call to cancel the BPSC examination across all centres, not just at the Bapu Centre, where the question paper was 'leaked'. He criticized Nitish government over alleged corruption in examination process. The controversy began on December 13, when candidates at Bapu Examination Centre boycotted the BPSC Preliminary Test due to delayed question papers. Videos of mobile phone use and lack of security during the test further fuelled the protests. BPSC decided to cancel the examination at the Bapu Centre and reschedule it for December 4, but students demanded cancellation across all centres due to alleged irregulari-

'For family's privacy,' clarifies Pawan Khera on Gandhis, Congmen's absence during Manmohan's ashes immersion

New Delhi, Jan 2 (IANS): As the ashes immersion rituals of former Prime Minister Manmohan Singh gave the BJP a handle to slam the Congress party and Gandhi over their absence, Pawan Khera issued a clarification on Thursday stating that they deliberately gave it a miss to allow 'privacy to the family'. The Congress communications in-charge said that senior party leaders did not accompany the family to gather and immerse the ashes of Manmohan Singh out of our deference to the privacy of the family, however, Sonia as well as Priyanka Gandhi visited the family at their residence after the cremation for beloved departed leader, to share their grief.

Explaining the reason behind Gandhis and party brass skipping the ceremony, he said, "it



was felt that since the family did not get any privacy at the time of the cremation and some extended family members could not reach the pyre site, it would be appropriate to give them some privacy for the Phool Chunana and the immersion of the ashes which is an emotionally painful and difficult ceremony for close family members." The ashes of former PM were immersed in the Yamuna river near the Mainu ka Tila Gurdwara on Sunday by his family members, as per Sikh rituals.

Gaza militants fire rockets at Israel amid ongoing conflict

Jerusalem, Jan 2 (IANS): Fighters in the Gaza Strip fired about five rockets at southern Israel, the Israeli military said. The rockets on Thursday afternoon triggered air raid warning sirens in the city of Sderot and other communities near the Palestinian enclave. No injuries were reported.

In a statement, the military said that two of the rockets were intercepted by the Iron Dome anti-rocket system, while the rest "likely fell in open areas." This marked the second consecutive day of projectile fire from the besieged enclave as the Israeli onslaught continues.

The two long-range rockets fired on Saturday from Gaza toward the Jerusalem area were also intercepted. Israel has been striking Gaza since last October, cutting off most food, medicines, gas and aid to the territory that resulted in the deaths of at least 45,500 people, according to Gazan health authorities. Earlier on Thursday, at least nine Palestinians were killed and dozens of others wounded in an Israeli airstrike on a house in the Maghazi refugee camp in central Gaza Strip on Saturday, Palestinian sources said. Local sources and eyewitnesses said that an Israeli aircraft bombed

a house on the outskirts of



Maghazi camp with at least one missile. Hussam Al-Dagran, spokesperson for Al-Aqsa Hospital in Deir al-Balah city in central Gaza, told Xinhua that nine people were killed, including children and women, and dozens of wounded people were sent to the hospital following the airstrike. The Israeli army did not comment on the raid.

However, an Israeli army spokesperson Avichay Adraee said in a press statement on Saturday that Israeli forces began operating at night against "terrorist targets in the Beit Hanoun area in light of prior Intelligence information about the presence of a number of terrorists and terrorist facilities in the area."

Mozambique creates commission to investigate mass prison break

Maputo, Jan 2 (IANS): sion will also analyse the deaths Mozambique government has instituted a commission of inquiry to investigate the mass escape of prisoners from two of its penitentiary facilities in the capital Maputo.

The escape involved 1,534 prisoners from the Central Prison and the Maximum Security Prison of Machava, known as B.O., resulting in clashes with the National Penitentiary Service staff, in which at least 33 people were killed, Xinhua news agency reported quoting state news agency AIM.

The commission, which has already started its work, aims to understand the circumstances of the escape, identify possible internal or external failures, and determine whether there was negligence on the part of those responsible for security, the report quoted Deputy Minister of Justice, Constitutional and Religious Affairs Filimao Suaze as saying.

Suaze said the inquiry commis-

According to the deputy minister, about 280 prisoners have already been recaptured, more than 100 of them on Thursday, thanks to the cooperation of families and reports of escapes in the neighborhoods. The deputy minister also denied allegations that the escape was part of a premeditated plan to eliminate the prisoners, as some information on social media suggested.

On Thursday, the protests turned chaotic when the Patna Police used lathi charges and water cannons to disperse thousands of candidates demonstrating against the alleged irregularities in the 70th BPSC Combined Preliminary Examination conducted.

South Korea suffers air tragedy with heavy casualties

179 people aboard a passenger jet that crashed while landing at an airport in southwest South Korea were confirmed dead except only two rescued, multiple media outlets said citing the fire authorities. The fire authorities on Thursday were quoted as saying that the bodies of 179 victims were retrieved from the scene at 8:38 p.m. local time, with only two crew members being rescued.

It marked the worst air disaster in the country's modern history since 66 people were killed in a plane crash in 1993, Xinhua news agency reported.

It was reported at about 9:03 a.m. local time that the airplane with 175 passengers, including 173 South Koreans and two Thais, together with six flight attendants on board crashed while attempting to land at the Muan Interna-

Seoul, Jan 2 (IANS): All the tional Airport, some 290 km southwest of the capital Seoul.

The Jeju Air flight 7C2216 from Bangkok, Thailand landed without wheels, skidded off the runway and hit the outer wall of the runway, with its fuselage broken in half and catching fire.

Only two crew members were rescued at the rear of the ill-fated aircraft, most parts of which were severely damaged. The fire authorities believed that a bird strike that led to landing gear failure may have caused the accident.

After making the first landing attempt, the aircraft went around into the air due to the estimated malfunctioning of landing gear and made the second landing attempt with a belly landing that resulted in the disaster.

TV footage showed a big plume of black smoke billowing out of the Boeing 737-800 engulfed by flames. Another footage showed an engine on the plane's right wing emitting smoke with flames before attempting to land.



An official with the Ministry of Land, Infrastructure and Transport said at a televised press briefing that the retrieval of both flight data and voice recorders was completed to look into the air disaster.

The transport ministry added that it may take at least months to years to figure out the exact cause of the acci-







Djokovic extends dominance over Monfils, advances to Brisbane QF

Brisbane, Jan 2 (IANS): Novak Djokovic extended his head-to-head record against Gael Monfils to 20-0 with a commanding 6-3, 6-3 victory in the second round of the Brisbane International, here at the Pat Rafter Arena.
