He reminded the Prime Minister that the State government has previously submitted proposals to the Centre for the development of the Hyderabad Metro Rail Phase-2 project and requested his assistance in facilitating its completion. Additionally, he noted that the State government has already formulated plans for a 370 km Regional Ring Road (RRR) in Telangana and urged the Union government to fully cooperate in the construction of both the RRR and the Regional Ring Rail.

The Chief Minister also urged Prime Minister Narendra Modi to provide assistance for the construction of new railway lines connecting Vikarabad to Krishna, Kalwakurthi to Macherla, and an additional two lines from Dornakal. Revanth Reddy expressed that the state government is committed to transforming Telangana into a one trillion dollar GDP economy, which would, in turn, contribute to the larger objective of achieving a five trillion dollar economy for India. He emphasised that the Union government should collaborate on the development.

The police informed that only KTR can enter and they would not allow his lawyer inside the ACB office. This led to an argument between the police and KTR. KTR spoke to senior police officials on the issue. KTR, who waited there for some time as the lawyer was not allowed inside the ACB office, returned from the ACB office without appearing for interrogation.

The ACB officials responded to KTR's return from the ACB office without appearing before them. They alleged that KTR had created high drama by bringing his lawyers and added that the lawyers were brought to their office to evade the ACB probe and violated the High Court's orders. "KTR did not pay heed to the High Court's advice to cooperate with the investigation and added that they would said take up the matter to the notice of the High Court. However, the ACB officials are ready to issue another notice to KTR either on Monday evening or Tuesday morning. In the meantime, it is learnt that KTR will approach the High Court seeking directions to conduct the hearing in the presence of a lawyer. It is already known that the High Court has reserved the verdict on KTR's petition. The ED has issued notices asking him to appear for questioning on Tuesday.

#### FARMERS' AGITATION MAY TURN **UNPRECEDENTEDLY** AGGRESSIVE IN 2025



he second leg of farmers' movement that had begun in the beginning of 2024, with a call for a March on Delhi from Punjab on February 13, is set to spillover into 2025, since the PM Narendra Modi led Centre was not even ready to talk to the agitating farmers until December 31. The farmers have displayed commendable patience so far but there are signs that the movement may turn startlingly aggressive in 2025. On December 31, the vacation bench of the Supreme Court was informed by Gurminder Singh, the Advocate General of Punjab, "As per the negotiators, there is a proposal given by the farmers to the Central Government that if they get an invite for a talk, then Mr. Dallewal is ready to take medical aid as desired." Solicitor General of India Tushar Mehta, however, submitted that he has no instructions on the submissions made by the AG of Punjab. Farmers' leader Jagjit Singh Dallewal has been on a fast-unto-death at the Khanauri border since November 26, demanding that the Union Government accept the farmers' demands including a statutory guarantee for Minimum Support Price (MSP) for their agricultural produce.

His fast entered 36th day on December 31, and his health is in precarious condition, since he is 70 years old and suffering from prostate cancer. At the beginning of the farmers' movement this year, on January 27, he had already lost his wife. On December 18, the Supreme Court bench had recorded the statement of the AG of Punjab that Dallewal needed immediate hospitalisation. Thereafter, on perusal of the medical reports, the bench had ordered on December 20 that the Punjab State authorities either shift Dallewal to a makeshift hospital (temporary hospital, which is said to have been set up at a distance of 700 meters from the site) or to any other well-equipped Hospital. On December 31, AG of Punjab reported to the Supreme Court that the farmers are in "siege" of the area and there are constant calls to the youth to join the protest site. The vacation bench of Justice Surva Kant and Justice Sudhanshu Dhulia of the Supreme Court said that the court is concerned with the compliance of the earlier order, while expressing strong remarks against the farmers who resisting any move to shift Dallewal to a hospital. Affidavits filed by both Punjab and Haryana plead that there could be a possibility of "collateral damage" of lives and property if there are attempts to move Dallewal from his current location. The AG of Punjab also informed the bench that interveners and negotiators had gone to the protest site. Efforts for compliance were made by mobilizing about 7000 personnel at the protest site. However, due to the Punjab Bandh held on December 30 by farmers' organisations, there were traffic blockades and hindrances. On December 28, the Court had orally had that it was "absolutely unsatisfied" with the compliance report filed by the Chief Secretary of the Punjab Government and the Director General of Police (DGP) of Punjab on the hospitalisation of Dallewal. Nevertheless, the bench has given two-days to comply with its orders and the contempt case has been posted for January 2, 2025. A call for a shutdown on December 30 was given last week by Samyukta Kisan Morcha (Non-political) and Kisan Mazdoor Morcha over the Centre not accepting the demands of protesting farmers, which crippled the movement of people and their economic activities in the state, which is another indication of the time to come which may witness very aggressive farmers movement in the country. The Samyukta Kisan Morcha (SKM) (non-political) and Kisan Mazdoor Morcha (KKM) had given a call for Delhi March on February 13, 2024 from Punjab. However, the farmers of Punjab were stopped by Haryana government on Shambhu and Khanauri border points. Farmers then tried to cross the police barricade which resulted in police using force, even firing. The farmers have been on a sit-in protest until now. The protests triggered farmers' protests in Haryana, Rajasthan, and Uttar Pradesh. A total of 5 deaths and injury of as many as 10 protestors have been reported.

#### SECTION 6A JUDGMENT: AN INCLUSIVE INTERPRETATION **OF FRATERNITY**

The Supreme Court's Constitution Bench judgment pronounced on October 17, 2024 in the challenge to Section 6A of the Citizenship Act, 1955, saw a fierce battle of ideas with the proponents and opponents of the provision both relying on varying, and often opposing, interpretations to the constitutional provisions in support of their respective arguments. While the arguments sought interpretation of various constitutional provisions from the right to preservation of culture as enshrined in Article 29 to the right to equality under Article 14, one of the key contentions raised by both parties.

#### **DISGRACEFUL SEND-OFF : DR. MANMOHAN** SINGH DISRESPECTED BY MODI-SHAH

deed! Even in death, former Prime Minister Dr Manmohan Singh was not spared. Prime Minister Narendra Modi did not hesitate in playing politics and avenging Singh's remark "it will be disastrous for the country to have Narendra Modi as Prime Minister" by denying Dr. Singh's mortal remains two yards of land at Raj Ghat for the last rites. Shockingly, Modi made a departure from past practice.

Modi, who graduated in Politics from the RSS School, which claims to

isgraceful in uphold Hindu and Sanatan traditions, took sadistic pleasure in demeaning and humiliating the late prime minister. In Hindu tradition it is taboo to denigrate the dead. Even ruffians and leeches are treated better after they have departed the world. Modi ought to know that the conscience of the people of India, barring the saffron-sort, are severely hurt. They did not imagine that a Prime Minister would stoop so low.

But then, it is known to everybody that Prime Minister Narendra Modi had a perverse dislike for both Jawaharlal Nehru and Dr. Manmohan Singh. He always felt dwarfed before the towering stature of Nehru, and in the case of Dr Singh, the threat to his politi-

cal credibility was real. Being the successor, Modi had to prove that he was Dr. Singh's equal in political acumen and administrative skill. Modi's speeches in Parliament devoted time and energy in debasing Nehru and Manmohan. Once, he mocked economists: "Hard work is more powerful than Harvard. #### LATE JIMMY CARTER WAS RIGHT ABOUT **ISRAEL'S APARTHEID**

Former US president Jimmy Carter, who passed away on Sunday at his home in Plains, Georgia, was a true friend of Palestine. Despite a decidedly checkered presidency on issues ranging from human rights abroad to austerity at home, he will be remembered as one of the first and most distinguished international observers to foresee Israel's apartheid system in Palestine.

In 2006, Carter published Palestine: Peace Not Apartheid, in which he equated Israel's occupation in the West Bank to the apartheid system of South Africa. Carter defined apartheid as the "forced separation of two peoples in the same territory with one of the groups dominating or controlling the other." What follows, he concluded, is that Israel was creating a "system of apartheid" where a minority of Israeli settlers were ruling over a Palestinian majority who are deprived of basic human and civil rights.

#### WAYANAD LANDSLIDES : CENTRE SCOFFS **AT KERALA'S SPECIAL ASSISTANCE PLEA**

The Union Government continues to rub salt into Kerala's wounds by ignoring the State's request for a special assistance package for the rehabilitation of survivors of the Wayanad landslide. The Union Government plumbed a new low when the Inter-Ministerial Central Team (IMCT) said it considered the landslides to be "of a severe nature for all practical purposes" but would not release any special assistance to the State. This amounts to denying Kerala's request to declare the Wayanad landslides as a "national calamity". Incidentally, Union Minister of State for Home Affairs, Nityanand Rai, in his reply to a question in the Rajya Sabha on November 27, conceded that the Wayanad tragedy was "of a severe nature", but

in the State Disaster Response Fund (SDRF), and in the National Disaster Response Fund (NDRF) guidelines, to declare any natural calamity as a "national calamity". The letter, which does not mention any financial assistance, says that in the event of a disaster of a severe nature, financial assistance towards notified disasters is met from the SDRF "already placed at their disposal, which is further supplemented from the NDRF in accordance with established procedure".

The Union Government has so far ignored the criticism of even the Kerala High Court on the Centre's callous response to the State's plea for special aid. Even the latest suggestion by the HC to exclude around Rs 120 crore of the Rs 132 crore that it had sought as the expense for rescue operations that were carried out in Kerala by the Indian Air Force(IAF) since 2006. The court's suggestion was that this amount could be utilized to rehabilitate victims of the July 30 Wayanad disaster. The Court further asked whether the norms that are binding on NDRF and SDRF can be relaxed so that the amount



could be used for their rehabilitation. In a direct criticism of the Union government's hostile attitude, the court termed as a 'psychological move' the Union Government sending the Rs 132 crore airlift expense bill soon after the State sought financial assistance for rehabilitation in Wayanad.

"It is for a noble cause, so the Central Government should not have a problem," the court while listing the matter on January 10, 2025, to await the Union Government's response on the issue. What is shocking is that a major portion – more than Rs 100 crore – of the outstanding bills is for the rescue operations undertaken during the 2018 floods which devastated the State. The bill also includes over Rs 13 crore for the IAF operations following the landslides that wiped away three villages in Wayanad district

on July 30 last year. The court's directions came while it was hearing a plea initiated by it for the prevention and management of natural disasters in the State in the wake of the Wayanad disaster of July 30, which claimed over 400 lives.

Meanwhile, a special Cabinet meeting chaired by Kerala Chief Minister Pinarayi Vijayan has decided to focus on expediting the rehabilitation of families displaced by the killer landslides. A draft rehabilitation plan presented by Chief Secretary Sarada Muraleedharan includes proposals from the Kerala Infrastructure Investment Fund Board (KIIFB) for the construction of 1,000 squarefoot single-storey houses for the survivors from Mundakkai and Chooralmala, which bore the brunt of the landslides in July. #### **UN chief condemns US New Orleans attack**

United Nations, Jan 6 (IANS): New Orleans Mayor LaToya UN Secretary-General Antonio Guterres strongly condemned the truck attack in New Orleans, the US state of Louisiana, his spokesperson said.

In a statement, the UN chief extended his condolences to the families and loved ones of the victims, and the government and people of Louisiana and the US. He also wished a swift recovery to those persons injured.

A man drove a pickup truck into New Year revelers in New Orleans early Monday morning. Officials of the Federal Bureau of Investigation said Thursday that 14 people were confirmed dead. Dozens more were injured.

A man, later identified as 42-yearold Shamsud-Din Jabbar, intentionally drove a pick-up truck into a crowd of revellers on Bourbon Street in New Orleans' French Quarter on New Year's Day in a deliberate act of carnage.

Jabbar, a US citizen from Texas, reportedly flew a black ISIS flag from the rear bumper of the truck.

Cantrell condemned the attack, while President Joe Biden expressed his condolences for the victims and their families, offering federal support. "My heart goes out to the victims and their families who were simply trying to celebrate the holiday," Biden said. "There is no justification for violence of any kind, and we will not tolerate any attack on any of our nation's communities." The investigation into the attack is now led by the FBI, with assistance from the Bureau of Alcohol, Tobacco, Firearms and Explosives, the Justice Department's National Security Division, and local authorities. President-elect Donald Trump also addressed the tragedy, offering his sympathies to the victims and first responders. "Our hearts are with all of the innocent victims and their loved ones, including the brave officers of the New Orleans Police Department," Trump said in a post on TruthSocial.



#### South Korea: Natl Assembly speaker presses acting President Choi to fill seat at Constitutional Court

Seoul, Jan 6 (IANS) : South Korea's National Assembly Speaker Woo Won-shik on Monday pressed acting President Choi Sang-mok to fill the one remaining vacancy at the Constitutional Court as Choi appointed two justices, partially meeting the opposition's demand to fill three vacancies before a ruling on President Yoon Suk Yeol's impeachment.

Earlier this week, Choi held off on the opposition-recommended justice Ma Eun-hyuk until the rival parties reach an agreement. In a Facebook post, Woo said the three judges were recommended via agreements between the ruling People Power Party (PPP) and the opposition Democratic Party (DP).

Presenting documents and remarks by the chiefs of two parties, Woo said, "It is confirmed that the ruling and the opposition parties have reached an agreement (on the recommendation of three judges), acting President Choi should swiftly appoint Ma as a Constitu-

tional Court judge." The DP had demanded former acting President Han Duck-soo appoint the three justices without delay once motions for their appointments passed the opposition-controlled National Assembly.

After Han refused last week, the DP railroaded the motions and impeached Han, suspending him from duty and putting Choi in his place as interim leader, Yonhap news agency reported.

By law, at least six votes are required to uphold an impeachment



motion, which means the appointment of three additional justices could improve the chances of Yoon's impeachment being upheld. The PPP voiced strong regret over Choi's appointments, accusing Choi of succumbing to the opposition's pressure and threats that it will also impeach Choi if he refuses to go ahead with the appointments.



#### Israel confirms September raid on Syrian 'underground missile factory'

Jerusalem, Jan 6 (IANS) : Israel's military revealed that around 100 of its troops conducted a raid in Syria in September last year to dismantle an underground missile factory allegedly funded by Iran.

In a rare admission of its activities in Syria, the military confirmed in a statement that the September 8 operation targeted and "destroyed an underground compound for manufacturing precision missiles" in the Masyaf area, near Syria's Mediterranean coast, Xinhua news agency reported. The Israeli military claimed that the facility housed "advanced assembly lines designed to manufacture precisionguided missiles and longrange rockets." These weapons, it said, would have significantly bolstered supplies to Hezbollah and other Iranian-backed groups in the region.

#### China adds 10 US companies to unreliable entities list

Beijing, Jan 6 (IANS) : China's Ministry of Commerce (MOC) announced on Monday that 10 US companies have been added to the unreliable entities list for selling arms to the Taiwan region. The companies include Lockheed Martin Missiles and Fire Control, Lockheed Martin Aeronautics and Lockheed Martin Missile System Integration Lab, according to the MOC announcement.

The last week of the year saw 1,933 migrants (according to rescue services) complete the dangerous crossing from the northwest coast of Africa to the Canary Islands, which is over 100 kilometres long at its shortest point, Xinhua news agency reported.

The arrival of these 1,933 people in a total of 34 boats, has stretched the resources of the Canary Islands, with the regional government calling on the Spanish central government and the country's 16 remaining Autonomous Communities to help relocate the migrants.

A total of 60,216 migrants have arrived in Spain irregularly from January 1 to December 15, 2024, 14.5 per cent more than in the same period in 2023 when 52,591 arrived. Of the total, 43,737 arrived in the Canary Islands, according to the latest figures from the Spanish Ministry of the Interior.

#### High-level probe ordered by Bengal CM for TMC councillor's murder in Malda : Minister

Kolkata, Jan 6 (IANS) : Firhad Hakim, the West Bengal Minister in charge of the Municipal Affairs and Urban Development Department and Kolkata Mayor, said on Monday that Chief Minister Mamata Banerjee has ordered the highest level of enquiry in the brutal murder of Trinamool Congress councillor from the English Bazar municipality in Malda district, Dulal Sarkar alias Babla, in broad daylight. "He was a very popular leader in the locality. We demand that the police immediately take the accused in custody, put them in jail and ensure strict punishment. Our Chief Minister Mamata Banerjee has already said there will be a highest level of probe in the matter. Whoever is behind this conspiracy will also be exposed and punished. We hope that the police will trace the culprits at the earliest," Hakim said.

Earlier on Monday, while addressing an administrative review meeting at the State Secretariat Nabanna, the Chief Minister criticised Malda District Police Superintendent Pradeep Kumar Yadav and held him accountable for the tragedy.

"Our councillor in Malda has been killed today due to the lackadaisical approach of the District Police Superintendent. He used to have security cover, which was later withdrawn. This is a clear lapse on the part of the police. Babla was with me since the beginning," Banerjee said.Sarkar, who suffered a bullet wound to the head, was in critical condition from the outset. Eyewitnesses reported that he was attacked while standing at a busy crossing in the area. Three helmet-clad assailants arrived on a motorcycle, and one of them opened fire. The first two bullets missed, but the third struck Sarkar in the head.

The orders cited Article 311 of the Constitution of India, which empowers the competent authority to dismiss, remove, or demote an officer without a formal inquiry if deemed not reasonably practicable.





### High Court appointed official inspects cleanliness arrangements in Gurugram

Gurugram, Jan 6 (IANS): The and the MCG has a population of Local Commissioner appointed by the Punjab and Haryana High Court arrived in Gurugram on Monday to inspect the cleanliness system here. A meeting was also held with the officials in the Municipal Corporation Gurugram (MCG) office in which matters, including cleanliness system, Construction and Demolition (C&D) waste, garbage disposal and the role of Bulk Waste Generators were discussed in detail.

In the meeting, the MCG Commissioner Ashok Kumar Garg told the delegation that the MCG area has been divided into four zones, which have 36 wards. Sixty-eight villages are also in-

The MCG Chief said that about 1,200 tonnes of garbage is generated daily in the corporation area, for which an agreement was made with Ecogreen Energy Private Limited in August 2017 to collect it from door to door, transport it to the Bandhwari plant and dispose of the garbage in the plant. When the work of the agency was not found satisfactory, a termination notice was issued to the company in June 2024.

Apart from mechanised sweeping

machines, the civic body has also employed sanitation workers for cleaning the roads and the services of a firm are being taken to collect garbage from door to door. Along with this, garbage is collected from secondary garbage collection points and sent to the Bandhwari garbage disposal plant. So far, 34.22 lakh metric legacy waste has been disposed of in the plant and the tender process is going on for the disposal of 14 lakh metric tonnes of garbage. Giving information about the debris generated from construction and demolition activities, it was told that 1,000 to 1,200 metric tons of debris is generated daily in the corporation area and about 11 lakh metric legacy debris is lying at various places.

#### India's smartphone market to cross \$50 billion in value this year : Report

#### Adani Ports' cargo volume grows 8 pc in December

The total cargo volume of Adani Ports and Special Economic Zone Limited (APSEZ) grew 8 per cent (year-on-year) to 38.4 million metric tonnes (MMT) in December 2024.

The company's container volume grew 22 per cent and liquids and gas volume grew 7 per cent on YoY basis in the last month. APSEZ is the country's largest private port operator.

Adani Ports had handled a total of 36 million metric tonnes of cargo in November, driven by higher container volumes. On a month-on-month basis, the total cargo volume saw 6.6 per cent growth.

Last week, Adani Ports placed an order for eight state-of-theart harbour tugs to Cochin



Launched in April 2022, ONDC is an initiative aiming at promoting open networks for all aspects of exchange of goods and services over digital or electronic networks. It is based on open-sourced methodology, using open specifications and open network protocols independent of any specific platform. With an authorised capital of Rs 500 crore, several public and private banks and financial institutions have contributed equity to ONDC till now, according to the Ministry of Commerce and Industry.



#### Japan's Nippon Steel to sue US government over decision to block acquisition

Tokyo, Jan 6 (IANS) : Japan's Nippon Steel Corp. is set to file a lawsuit in response to United States President Joe Biden's decision to block its takeover of US Steel Corp., local media reported Monday. Nippon Steel and US Steel are expected to claim in court that Biden did not present sufficient evidence to prove the proposed acquisition poses a threat to US national security, and that his decision violates due process under the US Constitution and the law governing the Committee on Foreign Investment in the United States, Kyodo News reported, citing sources close to the matter. Biden said Monday that he has decided to block the 14.1 billion US dollars sale of US Steel to the Japanese steel giant, citing risks to national security, while urging the two steelmakers

to "fully and permanently" abandon their plan. In a joint statement on Friday, the two firms said the US authorities' review of the international buyout project was "manipulated to advance President Biden's political agenda" and that they will "take all appropriate action to protect our legal rights." Meanwhile, Japan's Minister of Economy, Trade, and Industry Yoji Muto said, "It is incomprehensible and regrettable that this kind of decision has been made on the grounds of concerns over national security," Xinhua news agency reported. The Japanese government regarded Nippon Steel's plan to acquire US Steel as a deal "that would benefit both countries".

#### **Employment in Indian** manufacturing sector up for 10th month in a row

Not only did employment in the Indian manufacturing sector increase for the 10th month in a row during December, but also the rate of job creation quickened to the fastest in four months, according to a new report.

Around one-in-10 companies recruited extra staff, while fewer than 2 per cent of firms shed jobs in 2024, according to the 'HSBC India Manufacturing PMI' report.

"Ongoing improvements in new work intakes prompted manufacturing companies in India to purchase additional inputs for use in production processes. The rate of growth remained above its trend," the report noted.

New Delhi, Jan 6 (IANS) : India's manufacturing activity ended a strong 2024 with a soft note amid more signs of a slowing trend, albeit moderate, in the industrial sector. There was some uplift in the growth of new export orders, which rose at the fastest pace since July, said Ines Lam, economist at HSBC. The rise in input prices eased slightly, wrapping up the year when Indian manufacturers felt the strain of sharp cost pressures, Lam added.

"Although new export sales rose at a slower rate than total new business, the pace of growth for the former strengthened as firms were able to secure international orders from across the globe," according to the report.

Capacity pressures among Indian manufacturers remained mild, as seen by another marginal increase in work either pending completion or not-yet-started. Looking to 2025, Indian manufacturers were confident of a rise in output. Optimism reflected advertising, investment and expectation of favourable demand. Sentiment was nevertheless curbed by concerns around inflation and competitive pressures.







#### EV battery swapping, charging infra should be at every petrol pump, CNG station

New Delhi, Jan 6 (IANS) : There is a need for battery swapping facilities to coexist with charging infrastructure to accelerate the adoption of electric vehicles (EVs) in India, Union Minister of Commerce and Industry, Piyush Goyal, said on Monday. Speaking at the consultation meeting on the 'Development of Battery Charging and Swapping Infrastructure," co-organised by the Confederation of Indian Industry (CII) and the Department for Promotion of Industry and Internal Trade (DPIIT), the minister said that the adoption of EVs, led by creation of charging infrastructure, should be "a people's movement".



#### NSE clocks highest capital raised at

#### Rs 1.67 lakh cr globally via 268 IPOs in 2024

Mumbai, Jan 6 (IANS) : The Indian stock market witnessed an initial public offering (IPO) boom in 2024 as compared to any other global stock exchange, with the National Stock Exchange's (NSE) Rs 1.67 lakh crore (\$19.5 billion) capital raised through them becoming the highest in the world, according to a report by the exchange on Monday.

The 268 successful IPOs across mainboard (90) and SME (178) raised Rs 1.67 lakh crore, and were also the highest number of IPOs within Asia.

#### Don't see it through religious lens : Indian politicians on Switzerland's 'burga ban'

New Delhi, Jan 6 (IANS) : Indian politicians on Monday shared their reactions on the "burqa ban" in Switzerland, which came into effect on January 1 and stated that the decision was country's own and should not necessarily be viewed through a religious lens.

The prohibition, which bars facial coverings in public spaces, has sparked debates internationally.

As per the new Swiss law, those who unlawfully cover their faces in public, they will be imposed a fine of up to 1,000 Swiss francs (\$1,144). This includes covering nose, mouth, and eyes, with certain exceptions in private or sacred spaces and on planes or diplomatic premises.

BJP national spokesperson Mukhtar Abbas Naqvi said that Switzerland might have its reasons for implementing the ban. "Every country has its own rules and laws. They have their own security arrangements, and as per those, they form rules. I do not think there is a need to view this matter from a religious perspective," Naqvi told IANS. Similarly, NCP-SP leader Majeed Memon remarked that the law might not garner support from Muslim-majority nations but would likely have no bearing on India. "Switzerland is a small nation, and its population is nothing compared to India. The Muslim population there is very small. Their government must have taken these steps considering the conditions in their country," Memon said.

Drawing a comparison, Memon stated, "India's Muslim population is probably higher than the total population of Switzerland, with over 200 million Muslims residing here. Whatever happens, it will not have any effect on India. It is their matter, and I do not think it is necessary for anyone to intervene." "Many Muslim-dominated countries might criticize this idea. However, in India, where people of all faiths live together harmoniously, I do not think it will have any effect," he further added. The ban, which does not explicitly target Islam, was proposed by the right-wing Swiss People's Party (SVP) under the banner "Stop Extremism."

#### Farjiwada: Delhi BJP chief accuses AAP's Sanjay Singh of bogus vote registrations

BJP President Virendra Sachdeva on Monday accused the Aam Aadmi Party (AAP) Rajya Sabha MP Sanjay Singh of allegedly deceiving the public and violating electoral laws through bogus voter registrations. Sachdeva claimed that Singh was registered as a voter in multiple constituencies like Sultanpur Municipal Council in Uttar Pradesh, New Delhi Assembly, and Tilak Nagar Assembly constituencies. He alleged that Singh's actions were an example of creating fraudulent votes. "We

New Delhi, Jan 6 (IANS) : Delhi haven't just made allegations; we have presented facts from official government and municipal council voter lists. Sanjay Singh is listed in three places. It's Sanjay Singh who needs to respond. He has cheated the Election Commission and violated the law," Sachdeva told IANS. He pointed out discrepancies in the statements by the leader, stating, "On January 4, 2024, he announces that his vote in Sultanpur Assembly has been cut, and on January 8, 2024, his wife submits an affidavit stating she has a vote in Sultanpur."

He further reminded that creating bogus votes could result in a oneyear punishment under the law. Sachdeva questioned Singh's integrity, asking, "As a leader of the AAP, is this what you want to teach your party workers? To create bogus votes and register in two or three places?" At a press conference, Sachdeva presented voter lists and affidavits to substantiate his claims. He noted that in 2018 when Singh became a Rajya Sabha MP, his vote was registered in the Hari Nagar Assembly constituency. However, during the same period, his name appeared in the voter list of Sultanpur Municipal Council. "A person who is giving his affidavit for Rajya Sabha MP, claiming to be a resident of the Hari Nagar Assembly seat in Delhi, also has his vote registered in Sultanpur. This is deceit," Sachdeva alleged.

Sachdeva added that Singh's wife, Anita Singh, is listed in voter lists of both Sultanpur Municipal Council and Hari Nagar Assembly. Moreover, he accused Singh of registering votes in the New Delhi Assembly and Tilak Nagar



Assembly constituencies as well. "He wasn't satisfied with Hari Nagar and Sultanpur. He also registered in the New Delhi Assembly and Tilak Nagar Assembly. This is their farjiwada (fraud).

These are deceitful practices," Sachdeva claimed. Sachdeva urged the Election Commission and Delhi Police to take cognisance of the matter and initiate action against such violations.

#### A rare glimpse of religious tradition after 40 years amidst sea of devotion in Shimla

Shimla, Jan 6 (IANS) : Upper Shimla in Himachal Pradesh is currently witnessing a rare and age-old religious tradition as the revered deity Devta Bakralu hosts the "Bhunda Mahayajna." This grand ceremony believed to take place once in four decades, brings together deities from the Spail Valley, showcasing the region's vibrant cultural heritage.

The event, marked by processions of deities carried in intricately adorned palanquins to the sound of trumpets and drums, is a plea for peace, prosperity, and protection from natural calamities. Devta Bakralu resides in a temple at Dalgaon village in Rohru tehsil, 135 km from Shimla,

built in traditional hill architecture 1985, Surat Ram faced difficulty using wood and slate. The highlight of the ceremony is the ropesliding ritual, inaugurated last year by cutting "munji," a grass grown in inaccessible mountain terrains. A "jedi" (a man of the Beda caste) creates a sacred rope of "munji," adhering to strict rituals of celibacy and silence.

During the yajna, the divine oilsoaked rope spans 1 km between two hills, crossing a ditch. The jedi, seated on a wooden raft, slides down the rope in a spectacular display.

Surat Ram, a veteran performer, will undertake this ritual for the ninth time on January 4. Nearly five lakh people, including Chief Minister Sukhvinder Sukhu, are expected to witness the event. In the last "Bhunda Mahayajna" in while crossing the "valley of death" on a raft while sliding the rope vertically.

Surat Ram told IANS that it took two and a half months to prepare the sacred rope this time. Four people assisted him in this task. While preparing the rope, one has to follow celibacy. After eating at four in the morning, he would eat again the next day. During this time, maximum silence is observed.

Panchayat head Visheshwar Banshtu noted that this ceremony was last performed in Dalgaon in 1985. Steps have been taken this year to prevent fatalities during the ritual, ensuring safety for all participants.

The Bhunda Mahayajna is a testament to Himachal Pradesh's rich



spiritual traditions, often referred to as "Devbhoomi" or the land of gods. Devta Bakralu, the chief deity of Rohru and Rampur, has invited other deities, including Maheshwar, Bondra, and Moharrish, along with three Parshurams from Gumma, Andareyothi, and Khashkandi, believed to be incarnations of Lord Parshuram.

These deities, carried in processions, travel only on foot, avoiding modern routes like tunnels. The devotees meticulously follow strict rituals and schedules set by the deities themselves, highlighting a deep connection between the mortals and the divine.

"In earlier times, the Bhunda Yajna was performed every 15-20 years, but its frequency has reduced to once in 40-50 years," octogenarian R.P. Manta told IANS. Preparations for this event, estimated to cost Rs 100 crore, have been underway for months.

#### Tamil Nadu: Samba paddy farmers in Thanjavur seek more water from Mettur dam



### Maha govt to return 4,849 acre of fallow lands to farmers

Mumbai, Jan 6 (IANS) : The Maharashtra Cabinet chaired by Chief Minister Devendra Fadnavis, on Monday, approved the amendments to section 220 of the Maharashtra Land Revenue Code, 1966, paving the way for returning about 4,849 acres of fallow lands to farmers. These lands were auctioned due to pending government arrears and deposited with the government.

"As per Section 220 of the Maharashtra Land Revenue Code, 1966, due to non-payment of tax or similar arrears, such lands are auctioned and deposited with the government as arrears. There is a provision in the law to return such lands to the original account holders if the due amount and interest on it are paid within 12 years. However, there was no provision to return such lands to the original owners after the completion of the 12 years," said the statement issued by the Chief Minister's Office (CMO).

With the Cabinet's approval for the amendment to section 220 of the Maharashtra Land Revenue Code, 1966, such lands can be returned to the original account holders or their heirs by recovering 25 per cent of the prevailing market value.

The Bill will be introduced in the upcoming Budget session of the State Legislature. Meanwhile, the Chief Minister on Thurs-



day directed the administration to use artificial intelligence to ensure that citizens, government officers and staff coming to the Mantralaya get easy access without any hassle and thereby security remains strong.

Chief Minister Fadnavis gave these directives at the meeting which reviewed the present security at the Mantralaya where citizens from every corner of the state throng to Mantralaya to take up their various works with the ministers and the government officials. Due to this, the number of visitors is increasing day by day putting pressure on the prevailing security staff.

#### Israel to send delegation to Qatar for Gaza ceasefire talks : Netanyahu

Israel announced that it will send a delegation of senior security officials to Qatar next week to discuss a Gaza ceasefire deal. Prime Minister Benjamin Netanyahu confirmed in a statement that "a delegation of professional officials from the Mossad, Shin Bet, and the IDF (Israel Defense Forces)" will travel to Doha to continue the negotiations, Xinhua news agency reported. Earlier this week, the Israeli state-owned Kan TV

Jerusalem, Jan 6 (IANS) : reported that Hamas had proposed a one-week ceasefire, during which it would locate the whereabouts of hostages still held in Gaza and provide a list of those who could be released. Israel has not officially commented on the proposal. The talks, mediated by Qatar, Egypt, and the United States, have been ongoing for more than a year. Earlier on Monday Israeli Defence Minister Israel Katz issued a stern warning stating that Israel would intensify its military operations in Gaza if Hamas does not agree to a deal for the release of hostages "soon."

In a public statement, Gallant said that should Hamas fail to permit the release of Israeli hostages, the group would face "blows of an intensity not seen in Gaza for a long time."

When asked if his door was open for the Bihar Chief Minister, Lalu responded on Monday night, "My door is always open. Nitish Kumar should also keep his door open."

#### Second round of PTI-Pakistan govt talks to take place today in Islamabad

Islamabad, Jan 6 (IANS) : The Pakistan Tehreek-e-Insaf (PTI) and the government are set to engage in their second round of negotiations on Monday, at the Parliament House in Islamabad. This meeting follows a series of consultations within PTI to finalise their key demands.

The session, chaired by National Assembly Speaker Sardar Ayaz Sadiq, will take place in the Constitution Committee Room. The talks, aimed at resolving ongoing political tensions, come as PTI seeks to address critical issues, including the formation of a judicial commission to investigate the events of May 9 and November 26 and the release of political prisoners. These demands have been prioritised by PTI in light of the prevailing political and social unrest in the country. A spokesperson for the National Assembly confirmed that the meeting time had been adjusted at the request of members, underscoring efforts to accommodate both sides and ensure productive discussions. The negotiations are being facilitated and spearheaded by Speaker Ayaz Sadiq, who has emphasised the importance of dialogue in finding a resolution to the impasse.



Meanwhile, Khyber Pakhtunkhwa Chief Minister Ali Amin Gandapur has reiterated his party's commitment to pursuing peaceful negotiations, though he signaled PTI's readiness to mobilise a protest movement should the talks fail to yield results. Speaking to a private news channel, Gandapur highlighted that PTI founder Imran Khan had authorised party leaders to engage in talks with the government solely in national interest.

He added that while PTI was willing to explore solutions through dialogue, the party would not hesitate to launch a movement if their demands were not met. "Our demands are clear: the formation of an independent judicial commission and the release of our leaders and political workers."



#### After Himachal, K'taka govt may face situation of withdrawing guarantees: BJP

Bengaluru, Jan 6 (IANS) : Following Himachal Pradesh CM SS Sukhu's appeal to well-off consumers to forgo power subsidy, the BJP claimed on Monday that the Karnataka government may soon face a similar situation with its five welfare guarantee schemes for the people. ### SC asks UP govt to give copy of Mukhtar Ansari's death enquiry reports to family

New Delhi, Jan 6 (IANS) : The Supreme Court on Monday ordered the Uttar Pradesh government to furnish enquiry reports pertaining to the death of gangster-turned-politician Mukhtar Ansari, including medical reports, to his son Umar Ansari.

A bench headed by Justice Hrishikesh Roy told Additional Solicitor General K.M. Natraj, appearing for the Uttar Pradesh

government, to provide a copy of reports within a period of two weeks.

Seeking inquiry into the death of his father, Umar Ansari claimed that it was not a death simpliciter but the result of slow poisoning in jail and has filed an application calling for an inquiry into it.

Umar Ansari alleged that food given to his father in jail was poisoned and he was denied the requisite medical treatment.

In an earlier hearing, the top court had asked the Uttar Pradesh government to file a response within four weeks to the application seeking modification of the prayers. In a writ petition filed before the apex court in December 2023, Umar Ansari apprehended that there was a plan to assassinate his father in Banda jail prior to the 2024 polls and sought the transfer of Mukhtar Ansari to any jail outside UP.

The Uttar Pradesh government had assured the Supreme Court that if needed, it would enhance the security of Ansarif to ensure

no harm is caused to him within jail precincts.

On January 16 last year, after going through a confidential note detailing the security arrangements made by the state authorities, the SC had expressed satisfaction with the steps taken and observed that the security measures appeared "formidable enough".

It ordered the matter to be taken up for further hearing in the third week of July 2024.

In the meantime, Mukhtar Ansari



died of cardiac arrest at the Rani Durgawati Medical College in Banda district on March 28 last year while serving jail time. His viscera test report confirmed that no poison had been found and the cause of death was found to be heart attack. The post-mortem was conducted by a panel of five doctors in the rank of Chief Medical Superintendent.


