



DMK-led TN govt is dictatorial, not democratic: Khushbu Sundar



Chennai, Jan 7 (IANS): BJP leader and actor-turned-politician Khushbu Sundar has criticised the DMK-led Tamil Nadu government, calling it as "dictatorial rather than democratic". Speaking to reporters at the Chennai airport on Tuesday, she alleged that the Tamil Nadu government had displayed bias in granting permissions for political events. Khushbu accused the DMK government of granting permission for a rally organised by MDMK leader Vaiko but denied it for a BJP protest march. She said, "I will raise my voice whenever women are affected. I won't wait for a miracle like Ghajini to happen before I take action. Having been a part of the DMK, I know how they function. I will not remain silent;

I will speak out." The actor-turnedpolitician emphasised the importance of women's safety over monetary benefits, stating, "Money is not the most important thing for women -- safety is. The ruling party, DMK, is responsible for protecting women's dignity, modesty, and safety. Women cannot be silenced with money." Calling on the government to prioritise women's safety, Khushbu urged women not to remain silent and criticised the DMK's governance, claiming that its schemes were ineffective. She questioned the government's tendency to compare Tamil Nadu with other states, asserting that the southern state is an integral and significant part of India.

Khushbu also criticised the politicisation of sexual assault cases, pointing out the lack of response from DMK leaders to similar incidents in other states.

India concerned with Chinese mega project on trans-border river, new counties in illegally and forcibly occupied territory

ore than a week after the Chinese gov ernment approved the construction of a hydropower project in the lower reaches of the Yarlung Tsangpo river, India on Friday vowed to "take necessary measures" while urging Beijing to ensure that the interests of downstream states are not harmed by the decision. The river, also known as Yarlung Zangbo, flows through Tibet into Arunachal Pradesh and Assam and is known as the Brahmaputra in India. The hydropower project is located in southwest China's Xizang Autonomous Region. "We have seen the information released by Xinhua on 25th December 2024 regarding a hydropower project on the Yarlung Tsangpo River in the Tibet Autonomous Region of China. As a lower riparian state with established user rights to the waters of the river, we have consistently expressed, through expert-level as well as diplomatic channels, our views and concerns to the Chinese side over mega projects on rivers in their territory," Randhir Jaiswal, spokesperson for India's Ministry of External Affairs (MEA), said during a weekly media briefing in New Delhi on Friday. "These concerns have been reiterated, along with the need for transparency and consultation with downstream countries, following the latest report. The Chinese side has been urged to ensure that the interests of downstream states of the Brahmaputra are not harmed by activities in upstream areas. We will continue to monitor and take necessary measures to protect our interests," he added.

As a lower riparian state, with considerable established user rights to the waters of the trans-border rivers, the Indian government carefully monitors all developments relating to the Brahmaputra river, including plans by China to develop hydropower projects. In its 12th Five Year Plan for the period 2011-2015, China had planned to develop three more hydropower projects on the main stream of Brahmaputra River in Tibet Autonomous Region. Of the three, the first unit of the hydropower project at Jiacha was operationalised in August 2020.

In March 2021, China adopted its 14th Five Year Plan which mentioned plans for hydropower development on the lower reaches of the Brahmaputra river.

"The Chinese side has conveyed to us on several occasions that they are only undertaking run-ofthe-river hydropower projects, which do not involve diversion of the waters of the Brahmaputra. Various issues relating to trans-border rivers are discussed with China under the ambit of the institutionalized expert-level mechanism as well as through diplomatic channels. We intend to remain engaged with China on the issue of trans-border rivers to safeguard our interests," V Muraleedharan, the then Minister of State for External Affairs, had said while replying to a question in Lok Sabha in July 2021.

Meanwhile, New Delhi has also reacted strongly to Beijing's announcement of establishment of two new counties in Hotan Prefecture of China, parts of jurisdiction of which fall in India's Union Territory of Ladakh.

"We have never accepted the illegal Chinese occupation of Indian territory in this area. Creation of new counties will neither have a bearing on India's longstanding and consistent position regarding our sovereignty over the area nor lend legitimacy to China's illegal and forcible occupation of the same. We have lodged a solemn protest with the Chinese side through diplomatic channels," stated the MEA spokesperson.



Small milk fat globules promote good bacteria growth: study

An Israeli study has revealed that small milk fat globules promote the growth of beneficial bacteria, according to a press release issued by the Hebrew University of Jerusalem (HU) on Thursday. The study, published in Food Chemistry, explored how the structure and size of milk fat globules influence their interactions with both beneficial and harmful bacteria. The researchers tested milk fat globules from mammary gland cells and raw milk, focusing on their impact on bacterial growth and biofilm formation.

The study found that the structure of the globules, rather than their chemical composition, was key in shaping these interactions, Xinhua news agency reported. Consequently, small milk fat globules promoted the growth of Bacillus subtilis, a beneficial bacterium, while larger globules triggered biofilm formation, which is linked to bacterial resilience.

Furthermore, a synthetic lipid mixture mimicking the chemical composition of small milk fat globules failed to stimulate bacterial growth, underscoring the critical role of structural properties over mere chemical makeup.

Blinken plans to visit Seoul as part of his overseas trip that will also take him to Japan and France, Matthew Miller, the department's spokesperson, said. The three-nation trip runs from Friday to Thursday, reports Yonhap news agency.

Seoul's foreign ministry has said Foreign Minister Cho Tae-yul and Blinken will hold talks in Seoul on Tuesday. "In the ROK, Secretary Blinken will meet with senior ROK government officials to reaffirm the ironclad US-ROK Alliance and discuss ways our two nations can build on our critical cooperation on challenges around the world based on our shared values," Miller said in a statement.



Israel had ordered more evacuations for civilians in Gaza because of impending attacks: UN

United Nations, Jan 7 (IANS): UN humanitarians said that Israelis have ordered more relocations in besieged North Gaza because of impending attacks in retaliation for rocket fire into Israel.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said the latest directive was for civilians in the Al-Bureij area of Deir al Most people across the Gaza Strip, Balah governorate to move west, Xinhua news agency reported.

OCHA said the newest evacuation order came as Israeli authorities continued to deny United Nations' attempts to coordinate the safe movement of humanitarian workers. "On Tuesday, 6 out of 10 coordination attempts were outright rejected," the office said. "Of the remaining four, only two went ahead fully, while the other two encountered serious impediments. Among the rejected attempts today was our plan to deliver supplies to the besieged areas of North Gaza governorate," the office said.

"Amid this situation, humanitarian organisations are doing every-



thing they possibly can to support people wherever they are," the office said. Since October 2023, more than 5,300 patients have been evacuated abroad, while over 12,000 patients are awaiting evacuation. "It would take 5-10 years to evacuate all these critically-ill patients, including thousands of children," said WHO Director-General Tedros Adhanom Ghebreyesus on social media platform X. "In the meantime, their conditions get worse and some die."

Italy reports record cyber-fraud cases in 2024

Rome, Jan 7 (IANS): Italy's Postal Police said that they investigated 18,714 cyber-fraud cases in 2024, resulting in over 181 million euros (\$186 million) in stolen funds, both record highs. In their annual report, the Postal Police said that 26 per cent of the cyber-fraud cases investigated involved fraudulent online trading of securities. Despite being a smaller portion of total cases, these crimes accounted for 80 per cent of the overall value of cyber-fraud. Fraud linked to electronic commerce made up the largest share at 46 per cent of all cases but represented just 5 per cent of the total stolen funds, Xinhua news agency reported.





Minister sets out 10 govt priorities for 2025

Kyiv, Jan 7 (IANS): Ukrainian Prime Minister Denys Shmyhal has outlined ten priorities of his government's agenda this year, the cabinet's press service reported.

The development of the defence and security sector will remain Ukraine's key task, Shmyhal said, noting that special attention will be given to the long-range component and the missile program.

South Korea: Presidential security officials snub police request for questioning

The top two officials of South Korea's Presidential Security Service (PSS) snubbed a police request to appear for questioning Tuesday, a day after foiling the state anti-corruption agency's attempt to arrest impeached President Yoon Suk Yeol.

In a message to the media, the PSS said neither its Chief Park Chong-jun nor Deputy Kim Seong-hoon could leave their

Washington, Jan 7 (IANS): positions "even for a moment," citing the gravity of the situation in providing security for Yoon. The PSS added they were in talks with police to reschedule the questioning session, reports Yonhap news agency.

However, the CIO halted its attempt after a standoff with PSS officials and soldiers for some six hours, saying some 200 people had formed a human wall that blocked entry to the presidential residence.





Judge says no prison term for Trump in 'hush money' case

New York, Jan 7 (IANS): The judge in the "hush money" case has said that President-elect Donald Trump will escape a prison sentence while upholding his conviction.

Judge Juan Marchan said on Tuesday that he would give Trump an "unconditional discharge" when he comes up for sentencing on January 10, just 11 days before taking over as the US President. Upholding the conviction, he dismissed Trump's lawyers' contention that a Supreme Court ruling on presidential immunity applied to this case because his actions were not official.



Austrian coalition talks collapse as NEOS quits

Vienna, Jan 7 (IANS): Talks on forming a three-party coalition government in Austria collapsed after the smallest party NEOS withdrew from negotiations. However, the remaining two parties have confirmed their intention to continue discussions.

At a press conference, NEOS party leader Beate Meinl-Reisinger cited the People's Party and the Social Democratic Party, the other two parties in the coalition talks, for their lack of reform willingness as the reason for her party's withdrawal.

Meinl-Reisinger said that in view of Austria's recession and the unstable global situation, her party entered the negotiations seeking profound changes, but there has been "no significant progress, but rather setbacks" in the talks.

There is a need for battery swapping facilities to coexist with charging infrastructure to accelerate the adoption of electric vehicles (EVs) in India, Union Minister of Commerce and Industry, Piyush Goyal, said on Tuesday.

Speaking at the consultation meeting on the 'Development of Battery Charging and Swapping Infrastructure," coorganised by the Confederation of Indian Industry (CII) and the Department for Promotion of Industry and Internal Trade (DPIIT), the minister said that the adoption of EVs, led by creation of charging infrastructure, should be "a people's movement".

The NIA said that the attachment was carried out under Sub-section (1) of Section 25 of the Unlawful Activities (Prevention) Act. Uzair Khan was killed in the encounter, which had taken place in Guri Nad forest area of Kokernag area in 2023.

"Four security personnel were martyred in the encounter. Mohammad Akbar Dar was arrested on 20th September 2023, after 40 live rounds of AK-47 ammunition and other incriminating materials were recovered from his residence.





FIIs remain net buyers through primary market in India

foreign institutional investors' (FII) selling in India continues to dominate headlines, the clear message is that FII selling is due to high valuations in the secondary market and in the primary market where the valuations are fair, they have been sustained investors, market watchers said on Tuesday. Amid persistent FII outflows, domestic institutional investors (DIIs) have also maintained their optimistic stance.

According to experts, the general perception that the market has turned weak due to sustained FII selling during the last three months is largely true.

"However, what is not generally appreciated is that even while selling in the cash market through exchanges, FIIs have been buyers through the primary market. They have been big investors through

The delay in the salary hike, which is usually implemented at the beginning of the year, indicates that the domestic IT sector is still facing uncertainties.

Meta goes to NCLAT against CCI's Rs 213 crore penalty on WhatsApp

New Delhi, Jan 7 (IANS): Social media platform Meta on Tuesday moved the National Company Law Appellate Tribunal (NCLAT), challenging a recent Competition Commission of India (CCI) order imposing a Rs 213 crore penalty on the firm related to WhatsApp's 2021 privacy policy update. In November last year, the competition watchdog directed WhatsApp to not share user data collected on its platform with other Meta products or companies for advertising purposes for a period of five years, along with imposing a penalty of Rs 213.14 crore on Meta for allegedly abusing its dominant position. Meta has now informed the NCLAT that the CCI order has wide ramifications for the industry as a whole and therefore.

Sensex projected to rise 18 pc by end of 2025: Morgan Stanley

Mumbai, Jan 7 (IANS): Morgan Stanley expects India to be one of the best performing emerging markets in 2025, with a base case projection for Sensex to rise by 18 per cent by December end.

In its latest note, the US-headquartered investment bank sees 18 per cent base case upside for the BSE Sensex by the December end.

"India's macro stability is strong due to improving terms of trade and flexible inflation target," said the global brokerage, forecasting earning of 18–20 per cent earning growth over the next four to five years.

Private capital expenditure cycle, re-leveraging of corporate balance sheets and unfolding of a structural rise in discretionary consumption are among reasons for this. A reliable source of domestic risk capital also contributes to the capital expenditure Infrastructure spending, restructuring GST rates, direct tax reforms, more free trade agreements, and focus on energy transition are other areas that will contribute to India's macro stability, said Morgan Stanley in its

As far as interest rates are concerned, Morgan Stanley expects a shallow cycle of 50 basis points with the rate cuts starting from February. It expects two consecutive rate cuts of 25 bps each. The Reserve Bank of India (RBI) is now committed to durable liquidity. Regulatory tightening may loosen in the weeks ahead, according to the brokerage. Initial issuance in the Indian markets is running at about 1.3 per cent of GDP versus the previous peak of over 3.5 per cent and set to rise further, Morgan Stanley said in the note. The base case estimate also entails robust domestic growth, no recession in the US and benign oil prices. "We use a modest re-



positive liquidity environment as the base case for monetary policy. We do not anticipate a bunching of issuances, and the retail bid keeps its nose ahead of the supply," Morgan Stanley said.

ArcelorMittal shutting down loss-making long steel business in South Africa, 3,500 jobs likely to go

Johannesburg, Jan 7 (IANS) : Steel producer ArcelorMittal South Africa Ltd announced on Tuesday that it is shutting down its loss-making long steel business in the country, a move that is likely to hit about 3,500 direct and indirect jobs. The closure of the operations has been on the anvil since November amid prolonged weak economic conditions, logistics and energy challenges and a

flood of cheap imports from China. The firm's shares fell as much as 15 per cent in early trading, after the announcement.



Sales of imported cars in South Korea decline for 2nd year in 2024

Seoul, Jan 7 (IANS): Sales of imported cars in South Korea fell for the second straight year in 2024, while hybrid vehicles emerged as the top-selling fuel type for the first time, industry data showed on Tuesday. The number of newly registered imported passenger cars in 2024 totalled 263,288 units, down 2.9 percent from the previous year, according to the data from the Korea Automobile Importers & Distributors Association.

It marked a second consecutive annual decline, following a 4.4 percent on-year drop in 2023, reports Yonhap news agency. Hybrid was the most popular fuel type, with 134,426 units sold.





Odisha Cabinet approves several

key proposals; pension for elderly, disabled hiked

Bhubaneswar, Jan 7 (IANS): The Odisha Cabinet on Tuesday approved nine key proposals including the hike in pension amount for the Persons with Disabilities and elderly persons of 80 years of age or above. The decision was taken during a Cabinet meeting held under the chairmanship of Chief Minister Mohan Charan Majhi here on Tuesday.

"State Cabinet have approved the proposal to enhance the pension amount of the eligible pensioners aged 80 years and above or PwDs having disability percentage of 80 per cent and above under both Madhu Babu Pension Yojana and National Social Assistance Programme to Rs 3,500 per month with effect from January 2025," a press note issued by the state government read.

In another significant decision, the state Cabinet on Friday gave its nod to the proposal allowing the state government to stand as guarantee for the new loans to be availed by the Odisha State Civil Supplies Corporation (OSCSC) Ltd. It is pertinent here to mention that OSCSC, the Implementing Agency (IA) of Paddy Procurement operations and Public Distribution System (PDS) on behalf of the Odisha government, makes the payment of MSP to the farmers within 24 to 48 hours of the purchase of paddy. The OSCSC Ltd also makes the payment to millers to get the Custom Milled Rice (CMR) out of the procured paddy.

The OSCSC Ltd. incurs all these expenditures by borrowing loans from banks and repays after release of subsidy from the Government of India.

Top Ajit Pawar camp leader puts to rest possibility of reunion between two NCP factions

Mumbai, Jan 7 (IANS): The Ajit Pawar-led Nationalist Congress Party (NCP) on Tuesday ruled out the possibility of a reunion with the Sharad Pawar faction, saying that it will remain with its stand of allying with the BJP-led National Democratic Alliance (NDA) at the Centre, and MahaYuti in Maharashtra. "The party is an ally of the NDA at the Centre and in MahaYuti in the state. The NCP has recorded a thumping win in Maharashtra under the leadership of Ajit Pawar. Our agenda and stand taken in July 2023 is quite clear. We will continue with NDA and MahaYuti. There is no rethinking in our stand," Maharashtra unit NCP chief Sunil Tatkare told reporters.

To a question about whether a reunion is possible if NCP-SP changes its present political stand (of not aligning with BJP-led MahaYuti), Tatkare remarked: "There are no ifs and buts in politics and I cannot answer such a question." He added that "family and politics are two different things".





Complete all development works on time: Rajasthan CM tells officials

Maharashtra govt to launch drone-based vigilance to curb illegal fishing

MahaYuti government in Maharashtra will soon put in place a drone-based monitoring and digital data maintenance mechanism for fishing vessels from January 9 in a serious bid to prevent illegal fishing and implement the state's Marine Fishing Regulation (Amendment) Act, 2021. Newly appointed Minister of Fisheries Nitesh Rane said on Tuesday that nine drones have been made available on lease for the state's maritime district, including two units each in Raigad and Ratnagiri and one each in Palghar, Thane, Mumbai, and Mumbai Suburban. A control room will be established in the office of the Commissioner of Fisheries. The minister said that the department's vessels conduct patrolling, but it is not possible for the patrol boats to inspect every boat.

"Unauthorised boats often escape, and they are difficult to catch. The drone monitoring system will be effective to

Mumbai, Jan 7 (IANS): The curb illegal fishing," he added. 6-yr-old girl raped and murdered in Madhya Pradesh; accused held

Bhopal, Jan 7 (IANS): In a shocking incident, a six-year-old tribal girl was allegedly raped and then brutally murdered in Madhya Pradesh's Seoni district, the police said on Tuesday, adding the accused has been apprehended.

Police recovered the minor girl's body from near a canal in Nayapura village surrounded by a dense forest area in Seoni around 4.30 p.m. on Tuesday.

The girl had been missing from home since morning. She was abducted from her house while she was sleeping. The police, after tracing and recovering the minor girl's body, went to a community health centre where the post-mortem was conducted. The post-mortem confirmed that the toddler was first raped and then smothered to death.

Mohan Mandal had non-bailable warrants issued against him after

ment read.

As per the NIA statement, Mondal is the third accused to be nabbed in the case, the other two being Naba Kumar Mondal and Suvendu Bhowmick, who were arrested earlier. Naba Kumar Mondal was arrested in November last year. NIA registered the case after taking over the investigation from the Moyna police on the directions of the Calcutta High Court through an order in April 2024.

"NIA is continuing with its investigation as part of its efforts to unveil the whole conspiracy behind the abduction and murder of Bhunia and to arrest the remaining absconders," the statement read. Bhunia was murdered at Moyna in May last year. Initially,



Calcutta High Court's singlejudge bench of Justice Rajasekhar Mantha ordered a sub-divisional police officer (SDPO)-level probe in the matter. However, later there were allegations against the state police of a flawed investigation into the matter.

The first complaint was that the event of recovery of bombs from the place of the murder was not mentioned in the charge sheet.

The accusations against the state police were also that their investigating officials had not included the names of a number of accused in the chargesheet.



Delhi: No power bill hike for 70,000 consumers, assures NDMC

New Delhi, Jan 7 (IANS): In a big relief for over 70,000 power consumers in the New Delhi Municipal Council (NDMC) area, Vice Chairman Kuljeet Singh Chahal announced that the civic agency would not hike power tariffs for any consumer. If needed, the NDMC will absorb the hike resulting from the electricity regulator's higher tariff order, he said. The electricity tariff rate for both domestic and commercial consumers will not be hiked despite the new power purchase adjustment charge (PPAC) order by the Delhi Electricity Regulatory Commission on December 31, 2024. The current PPAC order, which proposes an increase in the cost of power for consumers, will not be implemented by NDMC, said Chahal,

ruling out any increase in electricity charges for consumers in the near future. Addressing the media, Chairperson Keshav Chandra said NDMC would take all steps to retain the current electricity charges for its consumers. There are nearly 70,000 power connections in NDMC areas, of which over 60 per cent are domestic households. Council Members Anil Valmiki, Sarita Tomar and Dinesh Pratap Singh were also at the press conference. Chahal said DERC had not issued a tariff order since 2021-22. It is pertinent to mention that DERC issued a tariff order for FY 2021-22 in September 2021, in which the average PPAC for NDMC was Rs 7.26 per unit. In the absence of a tariff order, PPAC petitions were submitted by discom quarterly, indicating the

difference in the actual cost of purchasing power and the cost of power mandated by the DERC through its order, Chahal said. PPAC orders are ad-hoc in nature, and they are reconciled during the truing up of accounts of a discom, he said. At the press conference, he said that the PPAC is a surcharge provided by the electricity regulatory commission to compensate for variations in the power purchase costs incurred by distribution companies. But NDMC has decided not to increase the electricity tariff rate for its consumers despite PPAC orders by DERC. Chahal said that Secretary (Power), GOI, in a meeting held on July 15, mentioned that the Central government desires NDMC to be a smart city using 100 per cent renewable energy.

German, French FMs visit Syria, pledge support for 'peaceful transition'

Damascus, Jan 7 (IANS): German Foreign Minister Annalena Baerbock and her French counterpart Jean-Noel Barrot arrived in Damascus on Tuesday for high-level talks with Syria's interim administration, led by Ahmed al-Sharaa. This marks one of the most significant Western diplomatic visits since the downfall of the previous government.

In remarks reported by local media outlets such as al-Watan Online and Syria TV, Baerbock said the EU sees potential for "a new political relationship with Syria," emphasising that Syrians now have "an opportunity to reclaim their country's destiny after the painful Assad era." She added that Germany wanted to back the new administration in achieving "a comprehensive and peaceful transition of power" and aid with reconstruction. Barrot, for his part, underscored a commitment to bolstering Syria's path to stability, Xinhua news agency reported

"We aim to enhance a peaceful transition that benefits both the Syrian people and regional security," said the French minister.

The two officials are set to meet with al-Sharaa, the leader of Hayat Tahrir al-Sham.

Since December 8, several Arab and Western diplomatic delegations, including Americans, have visited Syria and met with the new authorities. On Wednesday, Oman's Foreign Minister Sayyid Badr bin Hamad bin Hamood Albusaidi had emphasised the importance of mutual cooperation and efforts for development and stability in Syria and the region.

During a phone conversation with Syria's interim Foreign Minister Asaad Hassan Al-Shaibani, Albusaidi reiterated Oman's unwavering support for the Syrian people.

Cambodia records 74 per cent drop in malaria cases in 2024: Official

Phnom Penh, Jan 7 (IANS): Cambodia has reported a 74 per cent decrease in malaria cases in 2024, marking significant progress in the fight against the disease, a health official said on Tuesday.

Huy Rekol, Director of the National Centre for Parasitology, Entomology and Malaria Control, said malaria cases in the Southeast Asian country plummeted by 74 per cent from 1,384 cases in 2023 to only 355 cases in 2024.

"It's wonderful to hear about the remarkable progress Cambodia has made in reducing malaria cases in 2024. It is truly impressive," he told.

"Moreover, Cambodia has reported zero



fatalities since 2018 and no local Plasmodium Falciparum cases since January 2024," he added. Rekol said this achievement could be attributed to improvement in surveillance response, increased awareness among citizens, and availability of adequate equipment, such as malaria testing devices, insecticide-treated mosquito nets, and anti-malarial drugs. He added that the efforts of healthcare professionals and the government, along with effective malaria diagnostic tests and treatments like Artesunate-Mefloquine (ASMQ), have been instrumental in this success.

WFP seeks 404 million USD to provide food aid in South Sudan Juba, Jan 7 (IANS): The World Food

Programme (WFP) said it requires \$404 million to support the urgent humanitarian needs of millions of crisis-affected people in South Sudan over the next six months. In its latest report, the WFP said that South Sudan is facing crises that continue to push millions of families into new levels of vulnerability.

The country continues to grapple with a long-standing humanitarian crisis marked by chronic food and nutrition insecurity, the report said, adding that the ongoing conflict in Sudan has worsened the situation, driving 892,000 people into South Sudan by November 30, 2024.

Tokyo, Jan 7 (IANS) : Heavy snow is expected to hit northern and eastern Japan through Tuesday, mainly in mountainous areas along the Sea of Japan coast, due to a winter pressure pattern and a cold air mass, the country's weather agency said Tuesday. As of 5 am local time Friday, 412 centimetres of snow had accumulated in Sukayu in the Hakkoda mountain range in Aomori Prefecture.

South Korea: Engine from Jeju Air crash retrieved; black box to be sent to US next week for analysis

Muan, Jan 7 (IANS): South Korea's government investigators on Tuesday recovered the aircraft engine from the Jeju Air crash as they are focusing on determining the cause of the accident that claimed 179 lives this week. Investigators of the Aviation and Railway Accident Investigation Board have retrieved the engine of the crashed B737-800 from the accident site at Muan International Airport and transported it to a secure location for analysis, according to officials. The government is also working to recover the tail section of the aircraft. Authorities briefly halted the process after blood traces were discov-

ered inside the fuselage. Officials plan to determine whether the blood belongs to a passenger or an animal, such as a bird, through detailed forensic analysis. Additionally, work on converting the audio from the cockpit voice recorder into text is nearing completion, officials said.

The aircraft's Flight Data Recorder (FDR) was found to be partially damaged, making data extraction impossible on-site. Officials plan to send the FDR to the US National Transportation Safety Board in Washington for analysis on Monday.

Separately, authorities have begun the process of returning victims' personal vehicles to their families, with applications being accepted



from relatives, Yonhap news agency reported. Digital forensic analysis is also being conducted on 107 mobile phones recovered from the crash site under the consent of the families.

Investigators are hoping the analysis might yield critical information that might shed light on the incabin situation just before the crash. Meanwhile, Jeju Air Co. on

Thursday said it planned to reduce flight operations as early as the following week in response to growing concerns over the safety of flights operated by the leading low-cost carrier after this week's fatal crash.

Security forces seize arms, ammunition in Afghanistan

Kabul, Jan 7 (IANS): Afghan security forces have discovered a vast quantity of arms and ammunition in Kunar and Nuristan provinces, the Ministry of Defence said in a statement. The weaponry, which includes 49 Kalashnikovs, four rocket launchers, 29 rocketpropelled grenades, 66 hand grenades, a large number of cartridges

and bullets, and other illegally preserved military equipment, have been seized during a series of operations in different districts of the said provinces, the statement added.

The statement offered no further information regarding the timing of the seizure of the confiscated weapons.
