

No more Kingfisher beers in Telangana

Breweries Telangana Beverages Corporation Limited (TGBCL), the makers of Kingfisher brand beer, has decided to stop the supply of all brands of Kingfisher beer with immediate effect due to 'significant, ongoing operating losses'.

In compliance with Regulation 30 of the SEBI Listing Regulations,

Hyderabad, Jan.8 (NSS): United it has informed that the Company has decided to suspend the supply of its beer to Telangana Beverages Corporation Limited (TGBCL) with immediate effect. The decision of the Company has arisen because the TGBCL has not revised the basic price of the Company's beer since 2019-20, resulting in huge losses in the State and significant overdues remaining unpaid by TGBCL for the past supply of beer by the Company. As a result, the continued supply of our beer to TGBCL has been rendered unviable.

Hyderabad, Jan.8 (NSS): The Telangana High Court has allowed one advocate to accompany BRS working president KT Rama Rao to the ACB office during the questioning session scheduled for Thursday. The court, hearing a lunch motion moved by Rama Rao earlier in the day, said the BRS leader's senior counsel should be seated in

the library of the ACB from where Rama Rao and the advocate could see each other. The Court also said that if there was any procedural irregularity on part of the ACB, KT Rama Rao was free to approach the court anytime.



Reacting to Akash Anand's remarks, Sandeep Dikshit said, "No matter which party it is, ever since we started highlighting the failures of the Aam Aadmi Party one by one in Delhi, other parties like the BJP and others have begun raising the same issues.

Kumaraswamy had expressed his displeasure after he was not provided with the official vehicle and was asked to use former MP Sumalatha Ambareesh's car.



"Kumaraswamy refused to use the car of former Mandya MP Sumalatha Ambareesh. What can we do? We don't understand why Kumaraswamy is unwilling to use the vehicle which was used by former MP and senior BJP leader Sumalatha Ambareesh," the minister said. "We have never refused to provide a car to Kumaraswamy.

ICMR detects 2 cases of HMPV in Karnataka with no travel history: Centre

New Delhi, Jan 8 (IANS) : The Indian Council of Medical Research (ICMR) has detected two cases of the Human Metapneumovirus (HMPV) in Karnataka with no travel history, the Ministry of Health and Family Welfare said on Wednesday.

The HMPV infections were detected via routine surveillance in a 3-month-old girl and an 8-month-old boy in Bengaluru. The infection was identified after the children were admitted to Bengaluru's Baptist Hospital. Both children had a history of bronchopneumonia -- a form of pneumonia, a lung infection. Bronchopneumonia affects both the alveoli in the lungs and the bronchi. "Both cases were identified through routine surveillance for multiple respiratory viral pathogens, as part of ICMR's ongoing efforts to monitor respiratory illnesses across the country," the health ministry statement said.

The ministry noted that while the baby girl "has been discharged", the baby boy "is now recovering". "It is important to note that neither of the affected patients have any history of international travel," the Ministry said.



Big milestone : Indian metro network now third-largest in the world

ndia has achieved a remarkable milestone by reaching 1,000 kilometres in its metro network, L solidifying its position as the world's third-largest metro system. This remarkable achievement follows the announcement of new metro projects and the Namo Bharat initiative for Delhi under the leadership of Prime Minister Narendra Modi. The journey of India's metro network, which began in 2002 with the launch of the modern metro by former Prime Minister Atal Bihari Vajpayee in Delhi, has now reached this nationwide milestone. The transformation and expansion have been unprecedented under PM Modi's leadership, particularly since 2014.

In the past decade, the metro network has seen a threefold increase, with an additional 1,000 kilometres added to its length. Home-cooked veg thali's cost declines 3 pc in Dec, non-veg thali gets costlier

The cost of preparing a vegetarian thali at home declined 3 per cent (month-on-month) in December, while the cost of a nonvegetarian thali is estimated to have increased at a similar pace, according to a report on Monday. While tomato prices fell 12 per cent on-month, helped by fresh supplies from Madhya Pradesh, Maharashtra and Gujarat, the cost of nonvegetarian thali grew at a faster pace due to an estimated 11 per cent on-month increase in broiler prices on a dip in production triggered by a cold wave in the north, said the CRISIL Market Intelligence and Analytics report. "This, coupled with a rise in festive- and wedding-season demand, along with an elevated feed cost, exacerbated the woes," the report mentioned.



'A travesty': Musk slams Biden for awarding Soros Presidential Medal of Freedom



Sesla CEO and close aide to President-elect Donald Trump, Elon Musk, joined the wave of online trolling directed at billionaire George Soros, following US President Joe Biden's decision to award him the Presidential Medal of Freedom, the highest civilian honour in the US. Musk's meme post comparing Soros to a Star Wars villain has quickly gained traction across social media. The meme depicts Soros as Sheev Palpatine, also known as Darth Sidious, from the Star Wars saga. In the film series, Palpatine appears as a kind, democratic ruler while secretly plotting to take control of the galaxy as the Sith Lord Darth Sidious. Musk's meme suggested that Soros might similarly be hiding his true motives while presenting himself as a philanthropist, with the caption, "George Soros looking quite good here. Must be the lighting". The post added a layer of humour, which sparked widespread attention. The trolling came after President Biden named Soros as one of the 19 recipients of the Presidential Medal of Freedom on Saturday. The White House lauded Soros for his contributions to global democracy, human rights, education, and social justice through his Open Society Foundations. Other recipients included former Secretary of State Hillary Clinton, football legend Lionel Messi, and actors Michael J. Fox and Denzel Washington. Musk's comments are just the latest in a series of controversies surrounding Soros. The billionaire investor and philanthropist has long been a target of criticism, particularly from conservative figures. In addition to the online uproar in the US, Soros has been at the centre of a political storm in India.

Ethiopia earns over **\$216** million from horticulture exports

more than \$216 mil lion from exports of horticultural commodities during the first five months of the current fiscal year, the country's Ministry of Trade and Regional Integration has disclosed. The East African country exported 39,225 tonnes of flowers to the international market, earning over \$186 million during the first five months of the current Ethiopian 2024/2025 fiscal year, which started on July 8. Flower exports secured the largest share of the total revenue generated from the export of horticultural commodi-

T thiopia has earned ties during the reported period, the ministry disclosed in a statement issued on Friday. The country also exported 71,305 tonnes of fruits and vegetables to the international market, generating more than \$30 million. The ministry said the Netherlands, Saudi Arabia, and the United Kingdom are the top three destinations for Ethiopia's flower exports, while Somalia, Djibouti, and the Netherlands are the top three destinations for vegetable exports. According to recent data from the ministry, Ethiopia has generated some \$2.63 billion in export revenue during the first five months of the current fiscal year amid strong performance in major agricultural export com-



modities, Xinhua news agency reported. Horticulture is a field of agriculture that encompasses the science and technology of production, improvement and consumption of crops, which includes vegetables, fruits, spices,

condiments, herbs, aromatic and ornamental plants. To obtain desirable agricultural outputs, these crops require immense care.

Tanzania gears up for energy summit to expand power access

Tanzanian authorities announced that preparations for the African Heads of State Energy Summit, scheduled for January 27-28, are well underway. The summit, also known as the Mission 300 Africa Energy Summit, is a landmark event aimed at accelerating energy access across the continent, Xinhua news agency reported. Noel Kaganda, director of the Department of Multilateral Cooperation in the Ministry of Foreign Affairs and East African Cooperation, told editors and journalists in Dar es Salaam that Tanzania has co-organised the summit, which will bring together over 1,500 delegates, including representatives from the African Union, the African Development Bank Group, and the World Bank Group. Kaganda highlighted the summit as a platform for governments, private sector leaders, development partners, and civil society to advance the goal of providing electricity access to 300 million Africans by 2030. Innocent Luoga, commissioner for electricity and renewable energy in the Ministry of Energy, said 14 pilot African countries are expected to endorse the Africa Energy Compact.

He noted the Iranian government's principled policy of developing friendly ties with all countries, especially neighbouring ones, and called for maintaining and boosting ties between Iran and Saudi Arabia in cultural.

Austrian President to meet **Freedom Party**

Vienna, Jan 8 (IANS) : Austrian President Alexander Van der Bellen said that he would meet the Freedom Party' leader Herbert Kickl on Wednesday to discuss the formation of a new government while the conservative People's Party softened its stance, saying it is now open to talks with the far-right party. The move came after the collapse of three-party coalition talks among the People's Party, the Social Democratic Party and the NEOS party.



Canadian PM Trudeau likely to resign this week as Liberal Party leader: Reports

Toronto, Jan 8 (IANS) : Canadian Prime Minister Justin Trudeau is reportedly preparing to step down as leader of the Liberal Party, according to a media report citing three anonymous sources.

The Liberal caucus is set to meet on Wednesday, with growing demands from party lawmakers for Trudeau to resign as party leader.

The sources, speaking on the condition of anonymity, revealed to the Globe and Mail that while the exact timing of Trudeau's announcement remains uncertain, they anticipate it will occur before the pivotal caucus meeting. It is also unclear if Trudeau will simultaneously vacate

his position as Prime Minis-

ter or continue until a new party leader is chosen. His resignation as party leader would spark a leadership contest, with the winner expected to assume the role of Prime Minister.

Trudeau has faced mounting challenges, particularly after Chrystia Freeland's abrupt resignation as Finance Minister on December

16. Freeland publicly slammed Trudeau in her resignation letter, intensifying pressure on his leadership. Adding to his troubles, Trudeau's minority Liberal government lost a critical ally in September 2024 when Jagmeet Singh's New Democratic Party (NDP) withdrew its support.

Ethiopian govt launches evacuation as recurring earthquakes strikes eastern parts of country



seven earthquakes have hit eastern Ethiopia in the past two days, marking a significant increase in intensity compared to previous weeks' moderate tremors. In a Saturday evening statement, the Ethiopian National Disaster Risk Management Commission highlighted the urgent need for action in affected areas. About 15,000 people across six localities in the Awash Fentale district, Afar region, are at risk, with 7,000 already relocated. In the Dulecha district, around 20,000 individuals have been impacted, and 6,223 have been moved to safer zones. Tremors from the earthquakes were felt as far as Addis Ababa, the Ethiopian capital, about 190 km west of Abomsa. The government has deployed emergency teams, including experts from various sectors, to assess damages across 12 localities in the Afar, Oromia, and Amhara regions. The Ethiopian Government Communication Service noted a rise in both the intensity and frequency of recent earthquakes, stating that the government.

South Korean industry minister to visit US for broader bilateral economic ties

Seoul, Jan 8 (IANS) : Industry Minister Ahn Duk-geun plans to visit the United States this week to discuss bilateral economic exchanges with business and government officials ahead of the launch of the second Donald Trump administration, his office said on Wednesday.

Ahn plans to leave for the US state of Georgia on Wednesday to meet with Gov. Brian Kemp and seek the state's support for South Korean businesses operating in the region, according to the Ministry of Trade, Industry and Energy, reports Yonhap news agency.

The minister will also visit the production line of SK On Co., the battery unit of SK Group, and hold a conference with South Korean businesses operating in Georgia to discuss ways to address business challenges and bolster bilateral cooperation in cutting-edge industries. Ahn's planned trip to the U.S. comes amid growing uncertainties in global trade ahead of the upcoming launch of the second Donald Trump administration, which has signalled protectionist trade policies, including the imposition of sweeping tariffs of at least 10 percent on all goods.

Addis Ababa, Jan 8 (IANS) : The Ethiopian government said that it is coordinating evacuations in response to successive and recurring earthquakes wreaking havoc around eastern parts of the country. 

ing the importance of fulfilling the aspirations of the Syrian people. For his part, Al-Shaibani praised Qatar's prominent role in supporting the Syrian people, noting that Qatar would be a key partner in the peace phase.

On December 21, 2024, Qatar reopened its embassy in Damascus, Syria, becoming the second country to do so after the collapse of Bashar al-Assad's government. This marked the first time in 13 years that Qatar's national flag was

raised over the embassy building.



As many as 10.33 crore LPG connections have been released under the Pradhan Mantri Ujjwala Yojana (PMUY) for poor families who get the cooking gas at a subsidised price. Since the inception of the Scheme, about 222 crore LPG refills have been delivered to the PMUY households as about 13 lakh refills are being taken daily.

"GDP growth came in at a disappointing 5.4 per cent in the quarter ending September. Our analysis of 100 activity indicators suggests that the growth momentum



has improved in the quarter ending December," the report stated. As many as 65 per cent of the indicators are growing at a positive clip in the December quarter compared to 55 per cent in the previous one. The improvements have been the clearest in agriculture, exports and construction.

Mumbai, Jan 8 (IANS) : The Reserve Bank of India (RBI) bought another eight tonnes of gold in November 2024 as Central banks around the world continued their buying spree with a collective purchase of 53 tonnes of the precious metal during the month, according to the latest World Gold Council (WGC) report. The decline in gold prices during November, following the US election, may have provided some central banks with the added impetus to accumulate the precious metal, the report pointed out.

RBI has, like other central banks,

ing gold is primarily aimed at hedging against inflation and reducing foreign currency risks, especially in times of uncertainty triggered by geopolitical tensions. With the addition of eight tonnes of gold to its reserves in November, the RBI has increased its buying to 73 tonnes in the first 11 months of 2024 and its total gold holdings to 876 tonnes, maintaining its position as the second largest buyer during the year after Poland. The People's Bank of China (PBoC) has resumed gold purchases after a six-month gap, adding five tonnes of gold to its reserves, increasing its year-to-



ings to 2,264 tonnes (5 per cent of total reserves), the report said. Meanwhile, the Monetary Authority of Singapore was the month's largest seller, reducing its gold reserves by 5 tonnes, bringing the year-to-date net sales to 7 tonnes and overall gold holdings to 223 tonnes, it added. New Delhi, Jan 8 (IANS) : External Affairs Minister (EAM) S. Jaishankar on Wednesday met US National Security Advisor (NSA) Jake Sullivan in New Delhi to discuss a wide range of strategic, regional, and bilateral issues.

The meeting took place as Sullivan, the outgoing US NSA, embarked on a two-day visit to India, concluding one of the last high-profile engagements of the Biden administration before the inauguration of Donald Trump as the 47th President of the United States on January 20.

Sullivan's visit is aimed at reviewing the India-US Initiative on Critical and Emerging Technologies (iCET), a significant partnership framework to expand strategic ties between the two nations. His itinerary includes meetings with NSA Ajit Doval and a visit to the Indian Institute of Technology (IIT) Delhi, where he will interact with young Indian entrepreneurs and deliver a speech on the bilateral innovation alliance under iCET. In his discussions with Doval, Sullivan is expected to delve into the implementation of iCET initiatives. These include cooperation in areas such as space, defence, strategic technology, and shared security priorities in the Indo-Pacific region.

UNIFIL accuses Israel of destroying its property, Lebanese army infrastructure in Lebanon

Beirut, Jan 8 (IANS) : The United Nations Interim Force in Lebanon (UNIFIL) accused the Israeli Defense Forces (IDF) of destroying its property and a Lebanese army's infrastructure in southern Lebanon. "This morning peacekeepers observed an IDF bulldozer destroying a blue barrel marking the line of withdrawal between Lebanon and Israel in Labbouneh, as well as an observation tower belonging to the Lebanese Armed Forces immediately beside a UNIFIL position there," UNIFIL said on social media platform X.

"The IDF's deliberate and direct destruction of both clearly identifiable UNIFIL property and infrastructure belonging to the Lebanese Armed Forces is a flagrant violation of resolution 1701 and international law," it said.

UNIFIL called on all actors to avoid any actions, including the destruction of civilian property and infrastructure, that could jeopardise the cessation of hostilities, Xinhua news agency re-



ported. Also on Saturday, International Committee of the Red Cross (ICRC) President Mirjana Spoljaric said during her visit to Lebanon that "civilians cannot

afford for the ceasefire to lapse, plunging them back into heavy fighting that would bring more death and destruction.'



UN agency warns of impending disruption in services for Palestinian refugees

Gaza, Jan 8 (IANS) : The UN agency for Palestine refugees warned that its operation could be crippled as an impending Israeli ban on it is expected to take effect by the end of January. In a brief statement, the UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) on Wednesday said, "Time is running out for a possible ban on the agency that would prevent it from providing services to millions of Palestinian refugees," Xinhua news agency reported. The statement added that the United Nations "does not plan to replace the agency, and the Knesset, the Israeli parliament, must reverse its decision to ban it." On October 28, 2024, the Israeli parliament approved two laws -- one bars UNRWA from operating in Israel, set to take effect in three months, while the other ends all Israeli dealings with the UN agency, nullifying all previously signed agreements.

Earlier, UN humanitarians said that Israelis have ordered more relocations in besieged North Gaza because of impending attacks in retaliation for rocket fire into

Israel.

The UN Office for the Coordination of Humanitarian Affairs (OCHA) said the latest directive was for civilians in the Al-Bureij area of Deir al Balah governorate to move west, Xinhua news agency reported.



Cong should apologise to Hema Malini first: Bidhuri defends 'road like Priyanka's cheeks' remarks

New Delhi, Jan 8 (IANS) : Ramesh Bidhuri, the BJP candidate from Kalkaji Assembly constituency, who stoked controversy with his 'road like Priyanka's cheeks' remarks, issued a clarification on Wednesday, stating that his intention was not to hurt anyone's feelings or sentiments. He however rejected Cong's demands for apology and sought to turn the tables on the Opposition by stating that it was they who first need to apologize for Lalu Yadav's comparison of Bihar's roads to Hema Malini's cheeks. Defending his statement, Bidhuri pointed out that Lalu Yadav had made a similar comment about BJP leader Hema Malini years ago.

No end to violence in Pakistan's Khyber Pakhtunkhwa

province as Kurram DC critically shot

Islamabad, Jan 8 (IANS): The Deputy Commissioner (DC) of the Kurram District of Pakistan's restive Khyber Pakhtunkhwa (KP) province was critically injured as his vehicle came under attack in Mandoori, Kojalai Baba village near Bagan, on Wednesday. The incident took place three days after the rival sectarian tribes of Shia and Sunni Muslims signed a 14-point peace agreement that was supposed to pave the way for a ceasefire in the region devastated by violence for over two months now.

The peace deal was supposed to finally see the arrival of humanitarian aid in the region which has been cut off from the entire country for over 88 days, resulting in deaths of more than 150 people, including women and children, due to lack of food supplies and non-availability of medicines.

However, the 75-truck convoy with aid supplies for the suffering residents of the district capital of Parachinar could not move due to the closure of the Thall-Parachinar Sadda highway and firing on DC Kurram Javaid Ullah Mehsud and two other security personnel on Saturday.



The UN has expressed grave concern over the adoption of the laws, calling on the Israeli government to continue to allow UNRWA to operate and to respect Israel's obligations under international law.

Austrian chancellor to resign after coalition talks collapse

Vienna, Jan 8 (IANS) : Austrian Chancellor Karl Nehammer said that he would step down in the coming days after coalition talks between his People's Party and the Social Democrats collapsed earlier that day.

He will also resign as the leader of the People's Party. Nehammer on Wednesday said

on X that his party has ended the negotiations with the Social Democratic Party to form a new government due to disagreement over key issues, Xinhua news agency reported. His surprise move came just one day after the NEOS party pulled out of the coalition negotiations to form an unprecedented three-party government. Following the NEOS' with-

drawal, the People's Party and the Social Democratic Party confirmed late on Friday to continue their two-party coalition talks. Negotiations between the three parties had dragged on since mid-November following Austrian President Alexander Van der Bellen's decision in October to task the People's Party with forming a government. In September's

parliamentary election, the farright Freedom Party came first with around 29 per cent of the vote, followed by the People's Party and the Social Democratic Party with 26.3 per cent and 21.1 per cent respectively. While the Freedom Party won the parliamentary presidency, it has so far been unable to find coalition partners to form a government.



'Action only if probes name anyone', says Ajit Pawar on calls for Munde's resignation

Amid demand for NCP minister Dhananjay Munde's resignation following the murder of Massajog sarpanch Santosh Deshmukh from Beed district, Maharashtra Deputy Chief Minister and party chief Ajit Pawar on Wednesday clarified that no action will be taken until the three ongoing investigations name anyone.

Ajit Pawar on Monday revealed the party's official stand

26 Myanmarese nationals deported from Manipur

Imphal, Jan 8 (IANS): Manipur March 8 last year, 141 Chief Minister N. Biren Singh on Wednesday said that 26 Myanmarese nationals, who had earlier entered India through the state's border, were deported to their country.

Biren Singh, who also holds the Home portfolio, in a post on X said: "A group of 26 Myanmarese nationals who entered India through Manipur's porous border were deported to their home country today. "The government of Manipur reaffirms its commitment to providing humanitarian assistance to those fleeing war, ensuring their care and dignified departure. However, the state maintains a firm stance against allowing illegal migrants to stay back in Manipur."

A senior Manipur Home Department official said that the Myanmarese were handed over to the authorities of the neighbouring country by Manipur police and the central forces deployed along the bordering Moreh town. Since

Myanmarese nationals, including women and children, in four different phases have been deported to their country. In coordination with the Ministry of External Affairs (MEA) and central security forces, last year deported 115 Myanmarese nationals, including women and children, in three phases. After the military junta seized power in Myanmar on February 1, 2021, around 35,000 people, including women, elderly people and children, from the neighbouring country took shelter in 11 districts of Mizoram. The Myanmarese are staying in more than a hundred relief camps in six districts while several thousand others live in relatives or friends' houses as well as in rented accommodation, a Mizoram Home Department official said. Over 6,000 Myanmarese nationals took shelter in Manipur's different bordering districts.

2 MW solar power plant installed in remote

Shimla, Jan 8 (IANS) : Himachal Pradesh Chief Minister Sukhvinder Sukhu on Wednesday said a two megawatt (MW) solar power plant has been installed to ensure and improve the power supply in the remote region of Kaza in Lahaul-Spiti district.

He said within a few months the plant would be fully operational with the addition of a one MWh battery storage system. DD Upadhyaya junction, Patliputra, Barauni junction, Katihar, New Jalpaiguri, New Coochbehar and New Bongaigaon railway station during its both-way journey.

The train will consist of Sleeper class and AC-3 tier coaches for the accommodation of tourists. This Bharat Gaurav Special train aims to offer a unique travel experience, celebrating the cultural diversity and heritage of India, the CPRO

said. The statement stressed that these patrols operate around the clock through teams trained to deal with geographical and security challenges in rugged border areas.

35 evacuated after fire breaks out in Singapore

Singapore, Jan 8 (IANS) : About 35 residents were evacuated on Wednesday morning after a fire broke out in a vacant threestory semi-detached house in eastern Singapore, authorities said.

The Singapore Civil Defence Force (SCDF) reported that it was alerted to the fire at about 12:45 a.m.. Firefighters from the Kallang Fire Station and the Paya Lebar



Fire Station arrived to find the blaze engulfing the first floor and spreading to the upper levels.

Five Indian-origin men charged with murder in New Jersey

New York, Jan 8 (IANS) : Five Indianorigin men have been arrested and charged with the murder of an Indian, whose bullet-ridden body had been found in a forest in New Jersey, according to officials. The last of the five, Sandeep Kumar, was arrested on Wednesday, Ocean County Prosecutor Bradley Billhimer and New Jersey Police Colonel Patrick Callahan said on Wednesday. Kuldeep Kumar's body was found with gunshot wounds in the Greenwood Wildlife Management Area, a nature preserve in New Jersey, on December 14. Although Kumar's family in New York had reported him missing on October 26, according to the prosecutor's office, it was almost two months before someone discovered his body and informed the prosecutor's Major Crimes Unit. The alleged murder happened around October 22, leaving the body in a stage of "advanced decomposition" and the Federal Bureau of Investigation (FBI) helped identify Kumar, the prosecutor's office said.





South Korea : Court dismisses Yoon's objection to execution of detention warrant

Seoul, Jan 8 (IANS) : A Seoul court on Wednesday dismissed the injunction filed by President Yoon Suk Yeol that sought to invalidate the court warrants to detain him and search the Presidential residence, court officials said. The Seoul Western District Court made the decision days after Yoon's legal defence team lodged the objection to suspend the effect of the warrants that they called "illegal." No details on the grounds for the court's dismissal were immediately available. Yoon's legal team said they would consider appealing the ruling. "We will consider whether to file an appeal with the Supreme Court," Yun Gap-geun, Yoon's lawyer, said. "The dismissal does not mean that the warrants are legally valid."

The same court approved the warrant to detain Yoon for questioning over his role in the failed December 3 martial law bid. It also issued a warrant to search the presidential residence compound in central Seoul.



Zambia reports fourth monkeypox case

Lusaka, Jan 8 (IANS) : Zambia's health authorities have reported the country's fourth case of monkeypox, also known as mpox. The case involves a oneyear-old boy who possibly contracted the virus through close contact with a known case, said Minister of Health Elijah Muchima. "The child is under home isolation, receiving medical care, and in stable condition," he told reporters during a press briefing.

Last month, the health authorities reported two cases from the Kitwe city in the Copperbelt province, Xinhua news agency reported. In October 2024, Zambia reported the first mpox case involving a Tanzanian national who came for a visit.

In August, 2024, the World Health Organization (WHO) declared mpox a Public Health Emergency of International Concern (PHEIC), sounding the alarm over its potential for further international transmission. The ongoing global outbreak of clade II mpox has caused more than 100,000 cases in 122 total countries.

Egyptian, US top diplomats discuss developments in Gaza, Syria

Cairo, Jan 8 (IANS) : Egyptian Foreign Minister Badr Abdelatty held phone talks with US Secretary of State Antony Blinken, where they discussed the developments in the Gaza Strip and Syria, said the Egyptian Foreign Ministry in a statement. During the talks held Wednesday night, Abdelatty stressed the importance of continuing regional and in-

ternational efforts to achieve "an immediate ceasefire" in Gaza and ensure unhindered access of humanitarian aid to the enclave, according to the statement.

The Egyptian foreign minister emphasised the need for Israel to stop its aggressive policies towards the Palestinian people, expressing Egypt's complete rejection of Israel's systematic targeting of health infrastructure and hospitals in Gaza, Xinhua news agency reported. Israel has been launching an ongoing large-scale offensive in Gaza to retaliate a rampage by Hamas militants through the southern Israeli border on October 7, 2023, during which about 1,200 Israelis were killed and nearly 250 taken hostage. Since then, the Israeli war in Gaza has killed 45,805 Palestinians and injured 109,064 others, according to the latest update released by Gaza's health authorities

fied from November 2023 to April 2024, about 70 percent were women and children

Washington, Jan 8 (IANS) : Outgoing US President Joe Biden on Wednesday will present the 'Presidential Medal of Freedom' - the country's highest civilian honour - to 19 individuals, including former first lady, senator and US Secretary of State Hillary Clinton and controversial Hungarianborn billionaire US investor George Soros. The list also includes basketball legend Earvin 'Magic' Johnson, soccer star Lionel Messi, singeractivist Bono, actor Denzel

Washington and fashion designer Ralph Lauren. "The Presidential Medal of Freedom is the Nation's highest civilian honour, presented to individuals who have made exemplary contributions to the prosperity, values, or security of the United States, world peace, or other significant societal, public or private endeavours," read a statement issued by the White House. "President Biden believes great leaders keep the faith, give everyone a fair shot, and put decency above all else. These nineteen individuals are great leaders who have made America and the



world a better place. They are great leaders because they are good people who have made extraordinary contributions to their country and the world," it added. The awards will be presented at the White House on Saturday night, India time. "Secretary Clinton made history many times over decades in public service, including as the first First Lady elected to the United States Senate. After serving as Secretary of State, she became the first woman nominated for president by a major United States political party."

Russia vows strong response after Ukraine's ATACMS attack in Belgorod

Moscow, Jan 8: Russia on Wednesday issued a stern warning to Ukraine, saying it will respond to the Ukrainian Armed Forces' attempts to strike the Belgorod Region with American ATACMS operational-tactical missiles. "These actions by the Kyiv regime, supported by Western curators, will be met with retaliatory measures," read a statement issued by the Russian Defence Ministry.



ing burst at the MCG. At the SCG, he dismissed Khawaja and Labuschagne early but bowled just one over after lunch on Day 2 with the match finely poised.
