both surpassing the national average of 9.75 per cent, officials said.

However, from 2019-20 to 2023-24, the economic gap between the two states widened significantly. While Telangana managed to maintain a relatively stable growth trajectory, Andhra Pradesh's growth rate declined. Telangana's per capita income dropped slightly from 13.21 per cent to 11.45 per cent, reaching Rs 3,56,564, whereas Andhra Pradesh's growth rate fell more sharply from 13.21 per cent to 9.18 per cent, reducing per capita income to Rs 2,37,951.

This has resulted in a growing disparity of Rs. 1,18,613 between the two states. Andhra Pradesh's GSDP growth

Rate cut complements consumption-boosting Budget, sets stage for another cut in April



The 25bps rate cut by the Reserve Bank of In dia (RBI) is anticipated to complement the consumption-boosting measures announced in the Union Budget 2025-26, providing a boost to domestic demand drivers, industry leaders said on Friday. According to RBI Governor Sanjay Malhotra, the MPC has also unanimously decided to continue with a neutral stance and will focus on inflation while supporting growth. "This calibrated approach by the Central Bank reflects a careful balance between fostering economic growth and maintaining financial stability," said Chandrajit Banerjee, Director General, CII. Importantly, the recent series of liquidity easing measures introduced over the past two weeks will aid in the effective transmission of the rate cut to the productive sectors of the economy.

Additionally, the RBI's indication that it will inject liquidity as needed to address any tightening of frictional and durable liquidity in the system will ensure that monetary policy transmission remains effective, said Banerjee. According to Lakshmanan V, Group President and Head-Treasury (treasurer), Federal Bank, the MPC was on reasonably expected lines on all counts -- rate cut, stance and statement on liquidity measures. "This decision was a logical extension to the liquidity measures taken in January, along with clear assurances given by the RBI to support liquidity whenever necessitated going forward. Today's outcome sets the stage for rate cut expectations in April, unless inflation and global macro-conditions play havoc," Lakshmanan commented. The decision to lower the policy rate comes amid moderating growth momentum, increasing challenges from external factors, and a slowdown in inflationary pressures. "The GDP growth for the upcoming year is projected at 6.7 per cent, which is in line with our projection. On the liquidity front, the governor has assured proactive measures ensuring comfortable liquidity conditions," said Rajani Sinha, Chief Economist, CareEdge Ratings. With the Donald Trump Administration in the US shaking up global markets, we expect the RBI to be proactive in using liquidity and forex management tools. S&P Global expects the US Federal Reserve to move more gradually, cutting just 25 basis points (bps) in the first half of 2025 after slicing 100 bps between September and December 2024. "The MPC moves will depend more on domestic inflation. We expect healthy kharif and rabi crop to ease food inflation and likely drive CPI inflation down to 4.4 per cent next fiscal," said Dharmakirti Joshi, Chief Economist, Crisil Limited. "We expect the MPC to cut another 75-100 bps off the policy rate next fiscal," he added.

Zambia assures stable HIV drug supply despite US funding halt

Lusaka, Feb 11 (IANS) : The stock levels are sufficient to last Zambian government has assured the public of a stable supply of life-saving HIV drugs despite the decision by the US government, the major supplier, to halt the supply. The Zambia Medicines and Medical Supplies Agency, a government agency responsible for the procurement, storage and distribution of medicines and medical supplies, said there are sufficient antiretroviral (ARV) drugs to meet the needs of all patients nationwide. "There is no cause for concern, as supply continuity is assured. As of today, our current ARV

until June 2025," Bradley Chingobe, the agency's senior manager for corporate communications, said in a statement.

He said that the central warehouse and seven regional hubs are wellstocked to ensure the availability of first-line, second-line and thirdline ARV regimens for all patients requiring treatment. According to him, the agency remains committed to its structured nationwide distribution network covering 3,500 health facilities. The US government announced a 90-day suspension of funding for international development programmes,

including those in Zambia, on January 20, 2025, Xinhua news agency reported. According to the Ministry of Health, as of September 30, 2023, Zambia had an estimated 1.5 million individuals living with HIV, with almost 1.3 million of them on antiretroviral therapy. On February 6, Botswana rolled out stopgap measures to support patients affected by the closure of Civil Society Organisations (CSOs) and Non-Governmental Organisations (NGOs) that had been providing both prevention and treatment services related to HIV/AIDS due to the suspension of US foreign aid.

South Korea: Police raid Gimhae International Airport over Air Busan plane destroyed by fire Busan, Feb 11 (IANS) :

South Korean Police on Tuesday raided Gimhae International Airport to secure evidence related to last week's fire in an Air Busan plane.

The Busan Metropolitan Police Agency said investigators aimed to secure surveillance camera footage from around the time the plane caught fire on January 28, shortly before taking off from the airport in Busan, about 320 kilometres southeast of Seoul. "It will take several days just to receive documents (from the airport) due to their large quantity."

The measure places financial and visa restrictions on individuals and their families who assist in ICC investigations of American citizens

UN Secretary-General Antonio Guterres has also urged for more efforts to end the crisis in the eastern Democratic Republic of the Congo (DRC).

During a press conference at the UN headquarters in New York, Guterres described the situation in DRC as "deeply concerning." Fighting between the March 23 Movement (M23) rebel group and Congolese government forces escalated in January. The rebels claimed they had taken control of

Goma, the capital of North Kivu province and a key regional hub, before heading south toward Bukavu, the capital of South Kivu province. The conflict in the eastern region "is having an enormous human toll," with thousands of people killed, and hundreds of thousands forced from their homes in the eastern country, he said. The humanitarian situation in and around Goma is perilous, Guterres said. "Meanwhile, the conflict continues to rage in South Kivu and risks are engulfing the entire region."

"My message is clear: Silence the guns. Stop the escalation. Respect the sovereignty and territorial in-



tegrity of the Democratic Republic of the Congo. Uphold international human rights law and international humanitarian law," Guterres said. Highlighting there is no military solution to the crisis, the UN chief said, "It is time for mediation. It is time to end this crisis. It is time for peace." He urged all players, including neighbouring countries, subre-

gional organisations. the African Union and the United Nations, to play an active and constructive role toward an end of the conflict.

Also, the women covered under this scheme inadvertently, have been excluded and therefore there is a decrease in the number of beneficiaries. There is no intention to stop the Ladki Bahin Yojana." The women, having an annual family income of Rs 2.50 lakh, are also ineligible. Samant's statement comes a day after Deputy Chief Minister Eknath Shinde, at the Shiv Sena rally in Nanded.

Concerns raised over potential data leak to China via BYD cars

Seoul, Feb 11 (IANS) : With the BYD's first model launched here, recent entry by China's BYD into South Korea's passenger electric vehicle (EV) market, concerns have been raised over potential personal data leaks to China through the vehicles manufactured by the company, industry observers said on Tuesday.

The security risks of private data leaks to China emerged following BYD's official entry into the South Korean passenger vehicle market last month, reports Yonhap news agency

the Atto 3, is equipped with connected car features, such as overthe-air (OTA) software update capability and navigation features, through which sensitive driver data could be transferred to China, according to the market watchers. "BYD must disclose exactly what types of data are collected and how they are processed," said Yom Heung-yeol, professor emeritus of cybersecurity at Soonchunhyang University. He stressed that an "opt-out

mechanism," allowing consumers to reject the collection of personal data if they choose, was necessary.

BYD Korea has addressed data protection concerns, stating, "We fully understand Korean customers' concerns regarding personal data security and strictly comply with the Personal Information Protection Act."

It said that data collected in South Korea is managed locally and not shared with BYD headquarters in China.

Coal demand in India projected to reach 1,755 MT by 2047

New Delhi, Feb 11 (IANS) : The coal demand in India is projected to reach 1,462 million tonnes (MT) in 2030 and 1,755 MT by 2047, the government said on Tuesday.

With the fifth-largest geological coal reserves globally and as the second-largest consumer, coal continues to be an indispensable energy source, contributing to 55 per cent of the national energy mix.





Apollo Hospitals reports 4 pc drop in Q3 net profit, revenue slips

Mumbai, Feb 11 (IANS) : Apollo Hospitals has reported a net profit of Rs 379.4 crore in the third quarter this fiscal (Q3 FY25), a decline of 4.12 per cent from Rs 395.7 crore profit in the second quarter (Q2 FY25). The company's total income in Q3 stood at Rs 5,590.7 crore, slightly lower than Rs 5,627.5 crore reported in the second quarter (Q2). Its revenue from operations also saw a decline of 1.79 per cent at Rs 5,527 crore in Q3, compared to Rs 5,627.5 crore in the previous quarter. EBITDA was down 6.6 per cent (on-quarter) to Rs. 762 crore, while EBITDA margin stood at 13.8 per cent (down 81bps QoQ) in Q3, led by contraction in gross margins by 135bps QoQ to 47.5 per cent. The healthcare major announced an interim dividend of Rs 9 per share for the financial year ending March 31, 2025. This represents 180 per cent of the face value of Rs 5 per share. Apollo Hospitals is also focusing on expansion and plans to add 3,512 beds across 11 locations over the next three to four years, starting from FY26. The hospital chain is seeing strong demand for healthcare services, particularly in tier-2 and tier-3 cities.

'Make in India' booster: Nothing to locally manufacture new smartphone series

New Delhi, Feb 11 (IANS) : Aligning with the government's 'Make in India' initiative, London-based technology company Nothing on Tuesday announced that its latest Phone (3a) series will be manufactured in the country.

The Nothing Phone (3a) Series is being produced at the company's factory in Chennai, which employs over 500 workers. Notably, 95 percent of the workforce in this facility consists of women, the company said.

Gold prices on Tuesday surged to new record highs in the domestic futures market as uncertainty over the US President Donald Trump's tariff policies increased demand for the yellow metal as a safe-haven investment.

According to the India Bullion and Jewellers Association, the price of 24-carat gold was Rs 8,537 per gram, while 22-carat gold was Rs 8,332 per gram. On the Multi Commodity Exchange (MCX), gold futures for April 4 expiry touched an all-time high of Rs 85,384 per

New Delhi, Feb 11 (IANS): 10 grams in early trade. The same contract was trading 0.51 per cent higher at Rs 85,325 per 10 grams. In the international market, gold prices also remained near record levels due to growing fears of a global trade war. Last week, spot gold reached a new peak of \$2,886.62 per ounce.

The uncertainty surrounding Trump's latest trade decisions has pushed investors towards gold, which is traditionally considered a safe investment during times of economic and geopolitical instability. Trump plans to impose a 25 per cent tariff on all steel and aluminum imports into the US. He



was expected to make a formal announcement later on Monday (US time). Trump may introduce additional tariffs on several countries. The trade policies have raised concerns about inflation in the US, which could prevent the Federal Reserve from cutting interest rates in the near future. Meanwhile, the gold reserves in India went up by \$1.242 billion to \$70.893 billion in the previous week, according to the Reserve Bank of India (RBI) data. The apex bank said that the Special Drawing Rights (SDRs) were also up by \$29 million to \$17.889 billion.

'Kuno cheetahs to soon roam in Rajasthan via proposed wildlife corridor'

Jaipur, Feb 11 (IANS) : Cheetahs from Madhya Pradesh's Kuno National Park will soon be able to move freely into Rajasthan, as a new wildlife corridor is in the works, state Forest Minister Sanjay Sharma confirmed this to IANS. "A corridor will be developed to connect Madhya Pradesh and Rajasthan, allowing free movement of tigers and cheetahs between the two states. With this, cheetahs from Kuno will be able to enter Rajasthan naturally," Sharma said. The project will be jointly

monitored by both state governments, with a memorandum of understanding (MoU) set to be signed soon in the presence of Rajasthan Chief Minister Bhajan Lal Sharma and Madhya Pradesh Chief Minister Mohan Yadav.

The corridor, spanning approximately 6,500 square km, will stretch from Dholpur to Sita Mata Wildlife Sanctuary, facilitating a more natural habitat for the big cats. India's ambitious cheetah reintroduction program saw eight cheetahs brought from Namibia, which Prime Minister Narendra

Modi released into Kuno National Park on September 17, 2022, marking the species' return to the country. Meanwhile, Madhya Pradesh Chief Minister Mohan Yadav released five more cheetahs into the wild at Kuno on Wednesday. Among them was Veera, a female cheetah who gave birth to two cubs on February 4. The other released cheetahs included Asha and her three cubs. Additionally, two cheetahs, Agni and Vayu, have been roaming freely since their release on International Cheetah Day, December 4, 2024.

January 2025 the warmest on record: Copernicus


Brussels, Feb 11 (IANS) : January 2025 was the warmest on record globally, with the average surface temperature 0.79 degrees Celsius above the 1991-2000 January average, the EU-funded Copernicus Climate Change Service (C3S) reported on Tuesday.

Its temperature was 1.75 degrees Celsius above pre-industrial levels, while the average temperature over European land rose 2.51 degrees above the 1991-2000 January average.

"Outside Europe, temperatures were most above average over northeast and northwest Canada, Alaska and Siberia. They were also above average over southern South America, Africa and much of Australia and Antarctica," it said in a report.

The average sea surface temperature between 60 degrees north and 60 degrees south reached 20.78 degrees Celsius, the second-highest January level on record, behind January 2024.

"January 2025 is another surprising month, continuing the record temperatures observed throughout the last two years, despite the temporary cooling effect of La Nina conditions in the tropical Pacific," said Samantha Burgess, Deputy Director of the C3S.



According to the report, Arctic Sea ice reached its lowest extent for January, measuring six per cent below average, Xinhua news agency reported. Last month, C3S confirmed that 2024 was the first calendar year in which the average global temperature exceeded 1.5 degrees Celsius above pre-industrial levels -- a critical threshold set by the Paris Agreement. The agreement aims to limit global warming to well below 2 degrees Celsius above preindustrial levels, with an aspiration to cap it at 1.5 degrees Celsius by the end of the century.



The average annual construction of National Highways has jumped by a massive 130 per cent during 2014-2024, as compared to the previous 10 years from 2004-2014, and has taken the length of those coming up in the last 10 years to 1,01,900 km, Minister of Road Transport and Highways Nitin Gadkari told the Parliament on Tuesday. Presently 1,366 projects having a total length

AI, Blockchain and other tech advancements planned under eCourts Phase III Project: Law Minister

New Delhi, Feb 11 (IANS) : Futuristic technological advancements such as Artificial Intelligence, Blockchain and others are planned under the eCourts Phase III Project, the Parliament was informed on Tuesday. With a significant outlay of Rs 7,210 crore, the eCourts Phase III Project underlines the importance that the government attaches to the infrastructural needs of the judiciary in the country, said Minister of State for Law (Independent Charge) Arjun Ram Meghwal told the Rajya Sabha in a written reply. Meghwal, who is also the Minister of Parliamentary Affairs, added that several initiatives have been planned and are under progress to strengthen and expand the capacity of the existing infrastructure at the district and sub-district levels. "Some of the major initiatives under the eCourts Phase III project include, making fully functional advanced e-Sewa Kendras in all court complexes, interlinking of all courts across the country, including High Courts and District and subordinate courts, Information and Communication Technology (ICT) enablement of the Indian judicial system and making the justice delivery system accessible, cost-effective, transparent, and accountable," he added.



Besides, infrastructure is being developed for paperless courts in a phase-wise manner, expansion of the virtual courts for hearing court cases by creating a robust digital infrastructure, live streaming of court proceedings, digitisation of the entire court records, E-filing of cases and provision for video conferencing facilities, the minister apprised the Parliament. He highlighted that some of the futuristic technological advancements such as Artificial Intelligence, Blockchain and others are also planned under the eCourts Phase III Project. For ensuring seamless availability of ICT infrastructure, solar power facilities are being installed and obsolete hardware is being replaced, Meghwal said. Migrating the District Court websites to the Secure, Scalable, & amp; Sugamya Website as a Service (S3WAAS) platform is an ongoing process and efforts are on to provide adequate cloud storage facilities in the courts, he added.

Arunachal Christian body to launch stir against 46-year-old anti-conversion law

Itanagar, Feb 11 (IANS) : The Arunachal Christian Forum (ACF), an apex Christian body in the border state, on Tuesday announced to launch series of protests against the state BJP government's move to implement a 46-year-old anti-conversion law. US cannot withdraw from a body it no longer belongs : UNHRC

Geneva, Feb 11 (IANS) : The United Nations Human Rights Council (UNHRC) has said that as of January 1, 2025, the US' term as a member had ended, making it ineligible to withdraw from an intergovernmental body it was no longer part of. "For the record, the United States was a member of the Human Rights Council from January 1, 2022, to December 31, 2024. Since January 1, 2025, the United States is no longer a member of the Human Rights Council and automatically became an observer state, like any of the 193 UN member states that are not Council members. An observer state of the Council cannot withdraw from an intergovernmental body it is no longer a part of," Pascal Sim, spokesperson for the UNHRC, said on Tuesday in a statement sent to Xinhua news agency.

"As a matter of principle, and in the spirit of multilateral dialogue that characterises the Council, we welcome and encourage the engagement of every UN Member State -whether as a Council member or an observer -- in the work of the Council and its mechanisms," the statement added.

US President Donald Trump on Tuesday signed an executive order, withdrawing the US from the UNHRC, Xinhua news agency reported. The UNHRC is composed of 47 member states, with nearly one-third of its seats up for election each year.

Prime Minister Christopher Luxon joined the celebration in Akaroa in New Zealand's South Island instead of the major dawn ceremony.





Planned 'return hubs' must respect migrants' rights : EU agency

Vienna, Feb 11 (IANS) : The European Union (EU) Agency for Fundamental Rights (FRA) has said that the proposed "return hubs" for rejected asylum seekers must comply with fundamental rights laws and must not become "rights-free zones". The EU is considering establishing "return hubs" in non-EU countries as temporary facilities for asylum seekers whose applications in the EU were denied and who are awaiting deportation to their home countries, Xinhua news agency reported.

In a position paper released on Tuesday, the FRA issued a pointed warning to the Commission, insisting any project to establish "return hubs" must come with

strong safeguards to guarantee lawful and dignified treatment.

Even if located outside the EU, these return facilities must adhere to fundamental rights safeguards under EU law, and member states would remain "accountable for rights violations at the hubs and during any transfers," according to a position paper by the Vienna-based FRA. "The planned return hubs cannot become rightsfree zones," FRA Director Sirpa Rautio said.

Syrian military continues offensive against former govt forces, drug traffickers

Damascus, Feb 11 (IANS) : Syria's interim Defence Ministry has said that its forces are continuing operations against remnants of the ousted Bashar al-Assad government and drug traffickers along the Syrian-Lebanese border. According to the Syrian Observatory for Human Rights, a war monitor, the military on Tuesday also deployed heavy weaponry and drones to eliminate entrenched fighters linked to the Lebanese armed group Hezbollah and a drug cartel. The military targeted militant positions in the village of Hawik in the central province of Homs with artillery.



Iran never seeks to develop nuclear weapons: Pezeshkian

President Masoud Pezeshkian stressed on Tuesday that his country has never sought to develop nuclear weapons. He made the remarks at a ceremony in Tehran to mark the 46th anniversary of the victory of Iran's 1979 Islamic Revolution, according to a statement by his office. The ceremony

Tehran, Feb 11 (IANS) : Iran's was attended by foreign ambassadors and representatives of international organisations in Iran's capital. Pezeshkian said, "We do not seek (to develop) nuclear weapons. Iran's (Supreme) Leader (Ali Khamenei) has explicitly declared this by issuing a fatwa (religious decree)." Verifying that Iran does not intend

to develop nuclear weapons is not

difficult at all, he added, noting, "They (inspectors) have so far come and investigated it whenever they have wanted, and from now on, can come and check that again a hundred times. We will never go after developing nuclear weapons." The remarks came as US President Donald Trump on Tuesday took an executive action to restore the "maximum pressure"

campaign against Iran, aiming to prevent the country from obtaining nuclear weapons. On Tuesday night, Iran's Foreign Minister Seyed Abbas Araghchi said on social media platform X that "the so-called maximum pressure is a failed experience," warning repeating this would only cause "maximum resistance" by Iran, Xinhua news agency reported.

"We are a sovereign and democratic country committed to human dignity, equality, and rights, championing non-racialism and non-sexism while placing our constitution and the rule of law at the forefront," Lamola said.

Lamola noted that since assuming the G20 presidency from Brazil, South Africa has proposed tackling a number of issues, including rising indebtedness affecting emerging economies. "Solidarity promotes collective problem-solving.


