#### Andhra Pradesh bans transport of chickens from bird flu-hit districts

Amaravati, Feb 12 (IANS): Godavari, West Godavari, NTR Andhra Pradesh's Minister for Agriculture and Animal Husbandry K. Atchannaidu on Wednesday ordered authorities to ban the transport of chickens from bird-flu-affected districts until the situation comes under control

The minister reviewed the situation created by the death of chickens due to the outbreak of Highly Pathogenic Avian Influenza (HPAI) in Godavari and undivided Krishna districts on Wednesday.

The minister held a teleconference with top officials of the Veterinary Department in East

and Krishna districts.

Bio-security measures have been implemented at poultry farms in the affected areas. Officials have been directed to ensure that there is no movement of transport vehicles around the affected poultries.

The minister directed the veterinary doctors to be available in their respective areas to render the services.

Atchannaidu directed all district officials to collect samples from dead chickens, send them to laboratories and remain on alert. He wanted officials to ensure fullscale surveillance and monitor the



situation by creating zones. Following the outbreak of HPAI in Andhra Pradesh, neighbouring Telangana has sounded an alert and banned the import of chickens and eggs. Telangana officials are turning back poultry vehicles coming from the neighbouring state.

# Agriculture sector growth stronger, steadier than UPA's volatile years

n a sharp riposte to the Congress Party's criticism over the performance of the agriculture sector, L the BJP has in its factsheet highlighted that the growth rate in recent years is much stronger and steadier, backed by the government's higher budgetary support, than during 2004 to 2014 when the UPA was in power. "The UPA regime from 2004 to 2014 was the epitome of volatility for Indian agriculture. The growth of Agriculture and allied sectors GDP stood at 5.1 per cent in 2005-06, but the sector declined by 0.1 per cent in 2008-09, highlighting how the Congress miserably failed in its agricultural ventures," the factsheet said. "Any claims of agricultural stagnation under the NDA are outrightly false, as India's agriculture sector has exhibited strong growth in recent years, with an average annual increase of 5 per cent from FY17 to FY23. Further in the first and second quarters of 2024-25, the agriculture sector recorded growth rates of 2 per cent and 3.5 per cent, indicating a strong growth in the sector," it further states. The factsheet highlights that the financial situation of farmers is on an upward trajectory, with an annual increase of 5.23 per cent in agricultural income over the past decade. Despite a one-off fall in employment rate during the pandemic, the NDA Government spearheaded a strong recovery, with the unemployment rate now falling to 3.2 per cent, far below the pre-pandemic levels of 6 per cent even. It also states that while Congress betrayed farmers, the NDA is ensuring that MSP is 1.5 times the average cost of production regularly. The landmark PM KISAN scheme, just one of the various measures, has benefited 11 crore annadatas between 2019 and 2024, with over Rs 3.45 lakh crore in disbursements done through DBT (direct benefit transfer). Farmers' purchasing capacity has jumped significantly over the

#### Egg shortage cracks wallets, scrambles food businesses across California

gripping California and the western United States as a deadly avian flu outbreak continues to decimate poultry flocks, driving egg prices to record highs and forcing food businesses to adapt their operations.

The price for cage-free large white eggs reached 8.65 US dollars per dozen in California when delivered wholesale, while organic brown eggs were sold at 9.39 dollars per dozen, said the US Department of Agriculture (USDA)'s Daily National Shell Egg Index Report on Friday. The report shows that egg prices in California have more than doubled since 2024.



Beth, a Bay Area resident who gave only her first name, shared her recent struggles with egg shopping. "I checked several grocery stores in my neighbourhood, but eggs were either sold out or too expensive," she said.

severe egg shortage is A trip to a Costco store proved fruitless, with empty shelves greeting her as well. Store staff advised her to return early in the morning to improve her chances. Small businesses are bearing the brunt of the shortage. At Victoria Pastry Company in San Francisco's North Beach neighbourhood, co-owner Merie Belluomini expressed deep concern about securing ingredients for their handmade baked goods. "Since late October, prices are high, high, high. Today I was wondering when this is going to stop. We are worried we won't get any eggs. What are we going to do?" Belluomini told ABC7 News, Xinhua news agency reported.

On Tuesday, Waffle House, a 24hour restaurant chain, introduced a 50-cent surcharge per egg in response to the most severe egg shortage and dramatically increased costs in decades.


Restaurants are getting creative to manage costs without alienating



customers. In San Diego, Breakfast Republic owner Johan Engman told NBC San Diego they are adjusting portion sizes rather than compromising quality. Some establishments are exploring plant-based alternatives, with Zareen Khan, owner of Zareen's restaurants in Palo Alto and Mountain View, California, considering increased use of tofu as an egg substitute. The crisis stems from an ongoing outbreak of highly pathogenic avian influenza (HPAI), which, according to USDA data, led to the culling of over 20 million egg-laying hens in the last quarter of 2024 alone. The

virus has caused recurring waves of infection since 2022, severely disrupting egg production nationwide. Outbreaks of HPAI in commercial table egg layer flocks continue into February, with new cases reported in Ohio and the first case reported in Pennsylvania, according to the USDA's Weekly Egg Market Overview published on Friday.

Shell egg availability is still limited in many stores. To manage supply, grocers are restricting how many eggs customers can buy, stopping sales promotions and keeping prices high to control demand, according to the report.



#### Woman dies of heart attack while dancing at marriage in MP

23-year-old woman died of cardiac ar rest while she was dancing during a mar Triage function at a resort in Madhya Pradesh's Vidisha district. The deceased has been identified as Parinita Jain, a resident of Indore, who had come to Vidisha to attend the marriage function of her cousin's sister. A video surfaced on social media showed that Parinita was dancing on stage during the 'haldi' function where more than 200 guests were present. A viral video showed while Parinita was dancing to a Bollywood song 'lehra ke balkha ke', she collapsed all of a sudden on stage on Saturday night. It came to light when the video of the incident surfaced on social media. Family members, who are doctors and were present at the function, tried to give her CPR (cardiopulmonary resuscitation), however, she didn't respond. She was immediately rushed to a private hospital where doctors declared her dead. Parinita, who was a MBA graduate was living with her parents in Indore's South Tukoganj. According to official information, one of her younger brothers also died of a heart attack at the age of 12. However, this is not the first such incident when people dancing to music tunes collapsed and died in Madhya Pradesh.

Eli Sharabi, one of three Israeli hostages released on Saturday, was unaware that his wife and two daughters had been killed in the October 7, 2023, Hamas attack until his release. When asked about his feelings upon being freed, Eli (52) expressed joy, saying, "I am very happy today. I am happy to be back to my family and friends, my wife and daughters." However, after spending 491 days in captivity, he did not know that his wife, Lianne, and daughters, Noya (16) and Yahel (13), had been murdered in their home in Kibbutz Be'eri. Adding to the heartbreak, he was also informed that his brother, Yossi Sharabi, had died in captivity, with his body still being held in Gaza. The Israeli Defense Forces (IDF) shared a photo of Eli with his mother and sister on social media, stating, "In these moments, we remember his wife, Lianne, and two daughters,

Yahel and Noiya, who were murdered by Hamas on October 7, along with his brother Yossi, who was kidnapped and murdered in captivity." Eli Sharabi was one of three hostages freed by Hamas as part of the latest prisoner exchange deal, which saw Israel release 183 Palestinian prisoners under an internationally brokered ceasefire agreement.

#### Afrikaner groups in South Africa reject Trump's resettlement offer

Johannesburg, Feb 12 (IANS): Organisations representing Afrikaners in South Africa have said that they will not accept US President Donald Trump's offer of resettlement in the United States.

These Afrikaner organisations, including Solidarity and AfriForum, held a media briefing on Wednesday in Pretoria to respond to Trump's executive order issued on Friday, which accused South Africa of "seizing ethnic minority Afrikaners' agricultural property," and offered Afrikaners the opportunity to seek refugee status in America. In a telephone interview on Sunday, Kallie Kriel, chief executive officer of the Afrikaner lobby group AfriForum, told Xinhua that representatives of Afrikaners would be traveling to the US to meet with Trump's administration later this month. When asked about the alleged "land confiscation," Kriel said the situation had occurred but was not done by the government. "Land grabs are carried out by politically motivated people. The reason the government should be blamed is that they don't take this seriously or stop it," Kriel said.



#### UAE condemns Netanyahu's remarks on

Palestinian state in Saudi Arabia

Abu Dhabi, Feb 12 (IANS) : The United Arab Emirates (UAE) strongly condemned remarks made by Israeli Prime Minister Benjamin Netanyahu, who suggested that a Palestinian state could be established on Saudi Arabian territory. The UAE's official news agency, WAM, reported that the country had expressed its "strong condemnation and denunciation" of Netanyahu's "unacceptable and provocative" remarks, calling them "a blatant violation of international law and the United Nations Charter." UAE Minister of State Khalifa Bin Shaheen Almarar reiterated his country's unwavering solidarity with Saudi Arabia, emphasising its commitment to Saudi Arabia's security, stability, and sovereignty, Xinhua news agency reported.

#### Israeli army kills four Palestinians in Gaza: Health authorities

Gaza, Feb 12 (IANS) : Israeli troops killed four Palestinians, including an elderly woman, in two separate incidents in the north and south of the Gaza Strip, the Gaza-based health authorities said. "Three Palestinians were killed by Israeli forces while returning to their homes near the Kuwait Roundabout, east of Gaza City. Their bodies were transferred to the Baptist Hospital," the health authorities said in a press statement.



Juba, Feb 12 (IANS) : The Intergovernmental Authority on Development (IGAD), an East African bloc, has endorsed the appointment of George Aggrey Owinow of Kenya as the new chair of the Reconstituted Joint Monitoring and Evaluation Commission (RJMEC), the South Sudan peace monitoring body said. Owinow, a retired major-general, was nominated by the Kenyan government and approved by IGAD to replace Charles Tai Gituai, who served in the same capacity since August 2020, the RJMEC said in a statement issued in Juba, the capital of South Sudan. "Owinow's arrival comes at an important juncture of the revitalized peace agreement where a range of critical pending tasks need to be implemented to pave the way for elections in December 2026," the statement said. "Owinow has had a distinguished military and diplomatic career spanning more than four decades, serving in dif-

#### Lebanese army launches retaliatory strikes in response to attacks from Syria


Beirut, Feb 12 (IANS) : The Lebanese army announced that it had launched retaliatory strikes in response to artillery fire from Syria.

#### BJP reels out data on household savings, wealth & equity to refute Congress's claim

New Delhi, Feb 12 (IANS) :The BJP has released a factsheet reeling out statistics on household savings and wealth creation in the country to refute the Congress's claim that under the Modi government real wages have declined and household savings and consumption have fallen while the debt burden and income inequalities are rising.

The factsheet highlights that the increase in household debt is not due to rising indebtedness per borrower but due to a

greater number of borrowers, reflecting improved credit access. The sharp decline in net household savings and an increase in household liabilities is because Indians are investing in physical assets (real estate and automobiles). The increased number of education loans and consumption of experiences are also leading to the trend, it notes. Countering the Congress claim that income inequality is rising in the country, the factsheet points out that under the Modi government, income brackets have expanded, with an

8.1 per cent rise in the Rs 5–10 cent of the overall monthly spendlakh bracket and a 3.8 per cent rise in the Rs 10-20 lakh bracket. The wealth generation has trickled down to rural India with 9 out of 10 rural entrepreneurs being the first-generation entrepreneurs. As more Indians are investing in real estate, India has seen a 21 per cent rise in the average price of an average residential unit in the top seven cities, it observes.

The factsheet further states that for the first time since independence, average household spending on food was less than 50 per

ing because of increased income. At the all-India level, the urbanrural gap in Monthly Per Capita Consumption Expenditure (MPCE) has declined to 70 per cent in 2023-24 from 84 per cent in 2011-12 showing the rural-urban divide is narrowing.

Across social groups, MPCE increased across all categories, with the highest growth observed among Scheduled Tribes (ST) and Scheduled Castes (SC), reducing historical disparities, it added. "The Gini Coefficient, which



measures inequality in consumption expenditure, has declined across all major states. The bottom 5 per cent of the rural population witnessed a stunning 22 per cent growth in monthly consumption expenditure," the factsheet states. Most significantly, even the poorest 5 per cent of households now spend above the poverty line, with rural MPCE at Rs 1,677

against a poverty line estimate of Rs 1,622 as per an SBI Report (based on the Suresh Tendulkar methodology). Besides, with the implementation of GST, the price of almost all household goods has come down, leading to at least 4 per cent of total household savings as per a survey, the factsheet states. The BJP said that the Congress's claim that income inequality in India is worse than during the British Raj is based on a World Inequality Lab report riddled with methodological and data issues. The quality of life has significantly increased with 97 per cent of households having electricity access.

#### **SEBI bans LS Industries,** promoters for stock manipulation

The Securities and Exchange Board of India (SEBI) on Wednesday took strict action against LS Industries Limited, its promoter Profound Finance, and four other entities, barring them from the securities market for manipulating stock prices.

The probe uncovered suspicious trading patterns, misleading disclosures, and questionable financial transactions, including money transfers to a non-resident Indian (NRI).

During the investigation, the regulator observed wild fluctuations in the company's share price.

Between July 23, 2024, and September 2024, the stock price witnessed a staggering

Mumbai, Feb 12 (IANS) : 1,089 per cent increase from Rs 22.5 to Rs 267.5 apiece. However, by November 2024, the price had crashed to Rs 42.39. In December 2024, it rebounded to Rs 136.87, only to settle at Rs 67.95 in February 2025.

SEBI identified a group of traders behind this manipulation, including Multiplier Share & amp; Stock Advisors, Setu Securities, Paresh Dhirajlal Shah, and Ruchira Goyal.

These traders allegedly placed large buy orders to artificially inflate prices and later dumped shares, causing the stock to hit lower circuits and crash in value. The investigation also found that LS Industries made several misleading announcements to lure investors.

These included plans to enter ar-



tificial intelligence (AI) and robotics, hiring foreign directors, launching a Dubai subsidiary, and acquiring Robochef India Private Limited.

SEBI discovered that directors of Robochef were actively trading in LS Industries' shares when the stock price was at its peak.

In its detailed order, SEBI Whole Time Member Ashwani Bhatia stated that the investigation must be completed by May 15, 2025. "At the same time, I deem it fit to sound a note of caution for the in-

vestors. It is noted that the investors at times act in a manner bereft of any caution or rationale," Bhatia said in the order. He further added that

the investors in blind pursuit of profit through investment in a company without any fundamentals are like children following the proverbial pied-piper of Hamelin.

New Delhi, Feb 12 (IANS) : Real estate developer Signature Global has reported an increase in its total expenses to Rs 835.89 crore during the third quarter of the financial year 2025 (Q3 FY25), up by 6.54 per cent from Rs 784.60 crore in Q2.

The company's expenses rose by nearly 179 per cent from Rs 299.70 crore in the year-ago period (Q3) FY24). According to its stock exchange filing, the jump in total expenses was due to a higher cost associated with project execution and completion. At the same time, the company's total liabilities saw a steep rise to Rs 11,525.72 crore in Q3, compared to Rs 9,852 crore in Q2 and Rs 7,181 crore in the year-ago period. This was a 16.99 per cent increase from Q2 to Q3, while the total liabilities surged by 60.50 per cent from the year-ago period.

## Firms in 10 major manufacturing sectors to invest \$81.8 billion in 2025

Seoul, Feb 12 (IANS): South Korean companies in 10 key manufacturing sectors, including the semiconductor industry, plan to invest a combined 119 trillion won (\$81.8 billion) this year to foster sustainable growth, the industry ministry here said on Wednesday. The figure marks a 4 percent increase from the 114 trillion-won investment made in those



#### Black Box reports highest-ever PAT at Rs 56 crore in Q3, up 37 pc YoY

New Delhi, Feb 12 (IANS): Black Box Limited, Essar's technology arm, on Wednesday announced its results for third quarter (Q3) with highest-ever profit after tax (PAT) at Rs 56 crore which rose by 37 per cent year-on-year (YoY).

For 9M FY25, the PAT increased to Rs 144 crore with a growth of 49 per cent YoY, according to its stock exchange filing. PAT margins improved by 120 bps YoY and stood at 3.7 per cent in Q3 whereas for 9M FY25, PAT margins rose by 130 bps YoY at 3.3 per cent. In its filing, the company said that the strong operating performance has resulted in better profitability, despite higher exceptional items. Revenue for Q3 stood at Rs 1,502 crore as compared to Rs 1,655 crore in the year-ago period (Q3 FY24). For 9M FY25, revenue stood at Rs 4,422 crore compared to Rs 4,801 crore in same period last fiscal.

Revenue was predominantly affected due to subdued order book as a result of delayed decision making with some of our large customers coupled with company's strategy to exit the tail customers. However, the company's pipeline for digital infrastructure, across industry verticals including hyperscalers, continues to grow, positioning Black Box for sustained growth and market leadership.





## Patanjali Foods' Q3 expenses surge 11.2 pc, FMCG segment's revenue drops 18.4 pc

New Delhi, Feb 12 (IANS) : Swami Ramdev's Patanjali Foods has reported a significant increase in its total expenses for the third quarter of the financial year 2024-25, which rose by nearly 11.2 per cent to Rs 8,653 crore in Q3, compared to Rs 7,781.64 crore in Q2 FY25.

This increase was mainly driven by the higher costs of materials consumed, according to its stock exchange filing.

The fast-moving consumer goods (FMCG) segment saw a decline of 18.4 per cent, with revenue dropping to Rs 2,038 crore from Rs 2,499 crore in the same quarter last year (Q3 FY24).

The shares of Patanjali Foods dropped by 2 per cent to Rs 1,817.80 on the BSE in intra-day trade on Wednesday.

However, the company's net profit jumped by 71 per cent in the quarter ended on December 31, 2024. For the period from October to December 2024, Patanjali Foods recorded a net profit of Rs 370 crore, up from Rs 217 crore in the same quarter last year.

Along with this, the company's revenue from operations rose by 15 per cent to Rs 9,103 crore as compared to Rs 7,911 crore in the same quarter of the previous fiscal. A major contributor to the company's revenue was its edible oils business, which saw a 23 per cent increase in sales at Rs 6,717 crore, compared to Rs 5,483 crore last fiscal. Over the past year, the company has delivered a 19 per cent return to its investors, and its stock price has risen 2.49 per cent year-to-date (YTD).The company's market capitalisation stands at Rs 67,088.51 crore, and its shares reached a 52-week high of Rs 2,030 in September 2024. Additionally, the company's board of directors has also approved the issuance of 4,25,478 Employee Stock Options (ESO) under the PFL Employee Stock Option Plan 2023. These options will be granted to eligible employees as part of the company's efforts to reward and retain talent.

# **Bengal govt announces formation** of synergy committee for easy clearance of investment proposals

Kolkata, Feb 12 (IANS) : The West Bengal government, on Wednesday, announced the formation of a state-level investment synergy committee (SLISC) as a single window for clearance of investment proposals for the state. According to a notification issued from the office of Chief Secretary Manoj Pant on Saturday, this committee has been formed to facilitate growth and enhance the "ease of doing business" in the state and expedite the process of obtaining necessary approvals and clearances for setting up and op-

erating industrial projects and other investments. As per the notification, besides the said statelevel synergy committee, there will also be a district-level investment synergy committee in each district.

"The initiative is to provide a streamlined, single-window interface for approvals, enabling entrepreneurs and investors to obtain required clearances without unnecessary delays," the notification read.

The objective is also, the notification claimed, to provide a single-point interface and provide

a centralised platform for all investment proposals and businessrelated services. This will also facilitate timely approvals, eliminate bottlenecks, and support investments across sectors besides ensuring real-time monitoring, grievance redressal and data integration, the state government has claimed in the notification.

"The committee will convene fortnightly to review and address pending applications. Entrepreneurs/investors may present their projects, if so representing the meetings, for real-time resolution of queries and clarifications," the notification read. The secretariat assistance to the committee will be provided by the state industry, commerce & amp; enterprises department. "This State Level Investment Synergy Committee would further strengthen West Bengal's position as a leading investment destination and provide unmatched support to the investors," the notification read. Earlier this week, the two-day Bengal Global Business Summit (BGBS)-2025 was organised, the annual event to showcase the state as an investment destination. Chief Minister Mamata Banerjee claimed that this time the event has attracted total investment proposals worth Rs 4,40 lakh crore for West Bengal.


#### Police investigating after teenager with gunshot wound arrives at Sydney hospital

Sydney, Feb 12 (IANS) : Sydney police have launched an investigation after a teenager arrived at a hospital with a gunshot wound. Police in Australia's state of New South Wales (NSW) said on Wednesday that officers were called to a hospital in Bankstown, about 18 km southwest of central Sydney, on Wednesday night when the 17-year-old presented to the emergency department with a gunshot wound to his right leg. The 17-year-old male, whose injuries were not considered life-threatening, was accompanied by an 18-year-old man. Both men refused to assist the officers with inquiries, NSW Police said.

Police attempted to arrest the 18-year-old for concealing an offence when he allegedly assaulted two officers, injuring one. He was taken to a nearby police station where he allegedly "made a number of threats towards officers." The 18-year-old was charged with six offences, including assaulting a police officer, hindering or resisting arrest and three counts of intimidating a police officer. Police seized a vehicle that they believe was used by the males to attend the hospital and com-

menced an investigation into the shooting, Xinhua news agency reported. Anyone with information about the incident has been urged to contact police. Earlier this week, Police in South Australia (SA) said that it has established a new task force to combat violent crimes committed by youth gangs. SA Police announced the new Youth and Street Gangs Task Force on Wednesday as part of a boost to police resources allocated to investigating youth crime, domestic and family violence, cybercrime and retail theft.

Commissioner Grant Stevens said that the new task force would respond to crimes as well as undertake preventive and rehabilitative work. "Youth crime is not just about



the criminality, but the recruitment of younger members, so the task force provides an opportunity to break this cycle," he said in a statement. "This permanent task force will disrupt and reduce the criminal activities of a target group of offenders, particularly focusing on crimes of violence that pose a significant risk to community safety."

The task force has been formed by merging two existing police operations and adding 13 police officers to its ranks. SA Police data released earlier in January revealed that the number of crimes committed by offenders aged 10-17 rose by 140 per cent from 6,938 in 2018-19 to 16,710 in 2023-24.



#### UN human rights chief urges action to prevent further conflict in Congo

Geneva, Feb 12 (IANS) : The United Nations (UN) High Commissioner for Human Rights Volker Turk on Wednesday warned that the escalating violence in the eastern Democratic Republic of the Congo (DRC) could lead to a further deterioration of the situation if no action is taken.

"I am deeply disturbed to see the violence escalate once again," Turk said at a special session of the UN Human Rights Council.

He cautioned that if the current situation continues unchecked, "the worst may be yet to come," with consequences not only for the people of the eastern DRC, but also for the wider region.

"The risk of violence escalating throughout the sub-region has never been higher," Turk said, urging all parties with influence, including state and non-state actors, to intensify efforts to prevent further conflict and support peace processes.





#### No one has power to displace **Palestinians: Turkish President**

Istanbul, Feb 12 (IANS) : Turkish President Recep Tayyip Erdogan said that no one has the power to displace Palestinians from their homeland. "No one has the power to expel Gazans from their ancient and eternal homeland. #### Bodies of 18 SAMIDRC soldiers killed in DR Congo conflict transported to Uganda for autopsy

Kampala, Feb 12 (IANS) : The bodies of 18 soldiers from other African countries killed in the conflict in the eastern Democratic Republic of the Congo (DRC) were transported to Uganda for post-mortem examinations, an official said.

The remains of the deceased soldiers, who were part of the Southern African Development Community Mission in the DRC (SAMIDRC), were transported overland and taken to the Mulago National Referral Hospital mortuary in Kampala for autopsy, Henry Okello Oryem, Uganda's minister of state for foreign affairs in charge of international cooperation, told Xinhua by telephone. Oryem said the remains of the 13 slain South African, three Malawian and two Tanzanian troops will be processed and repatriated to their respective countries, Xinhua news agency reported.

Trump warned of "tangible and significant consequences" for those involved.

Johannesburg, Feb 12 (IANS) : South Africa expressed concern over a US executive order to cut financial assistance to the country, the Department of International Relations and Cooperation (DIRCO) said. US President Donald Trump signed an executive order on Wednesday to cut financial assistance to South Africa, citing disapproval of its land policy and accusing the country of "seizing ethnic minority Afrikaners' agricultural property."

#### **New York live poultry markets** shut down for five days to rein in bird flu

New York, Feb 12 (IANS) : New York Governor Kathy Hochul announced that live poultry markets in New York City, and Westchester, Suffolk, and Nassau counties would be shut down for five days to combat the spread of highly pathogenic avian influenza (HPAI).

Those markets have been ordered to sell down all inventory and complete cleaning and disinfection procedures.

Seven HPAI cases were detected in markets in Queens, The Bronx, and Brooklyn boroughs during routine surveillance since January 31, according to a release by the New York State government.

"While there is no immediate threat to public health and no known cases of HPAI in humans in New York State, we support the

Department of Agriculture and Markets' latest proactive measures to prevent the spread of the disease between animals and humans by temporarily closing live



bird markets in New York City and surrounding counties," said New York State Health Commissioner James McDonald. Those who have regular contact with livestock.

#### Afghanistan seizes 731 kg of illicit drugs, arrests 25 smugglers

Kabul, Feb 12 (IANS) : Afghanistan's security forces have seized 731 kg of illicit drugs and arrested 25 drug smugglers in the eastern Nangarhar province over the past week, the country's Ministry of Interior Affairs said in a statement on Wednesday. The drugs were confiscated during military operations conducted by security forces on the outskirts of Jalalabad city and in various districts of the province, the statement added. According to the statement, 3,499 stimulant tablets have also been discovered during the operations, Xinhua news agency reported. The Afghan caretaker government has committed to combating illegal drugs, as well as the production and trafficking of narcotics throughout the Central Asian country.

Police have discovered 12 kg of illicit drugs in northern Afghanistan's Baghlan province and detained an individual for involvement in drug trafficking from the area, district police chief Qari Naqibullah Muhammadi said on Saturday. The contraband, including 12 kg of hashish, was discovered in the Banu district of this province, the official said, adding the police have also arrested one drug smuggler. Police won't allow anyone to produce or smuggle hashish, poppy, or the objects used in manufacturing heroin in the province, the official said.

#### Egypt to host emergency Arab summit on Palestine on Feb 27

Cairo, Feb 12 (IANS) : Egypt announced on Wednesday that Cairo will host an emergency Arab summit on February 27 to address the latest developments concerning the Palestinian issue and the Gaza Strip, the Egyptian Foreign Ministry said in a statement.

The summit was decided to be held after Egypt's high-level consultations with Arab nations, including Palestine, which requested the summit, and coordination with Bahrain, the current chair of the Arab League (AL) summit and the AL Secretariat, according to the statement.

The announcement followed controversial remarks by US President Donald Trump suggesting the relocation of Palestinians from Gaza to neighbouring countries, including Egypt and Jordan. The proposal has been widely rejected both regionally and internationally, Xinhua news agency reported. #### Mpox deaths in Africa exceed 100 since beginning of 2025

Addis Ababa, Feb 12 (IANS) : A total of 107 people have died in the ongoing mpox outbreak in Africa since the beginning of 2025, according to the Africa Centres for Disease Control and Prevention (Africa CDC).

More than 13,500 mpox cases have been reported in 12 African countries, of which 3,683 were confirmed, Africa CDC Director-General Jean Kaseya told an online media briefing.

In the past week alone, eight African countries reported 2,634 new cases, including 878 confirmed ones and 21 deaths, according to data from the African Union's specialised healthcare

agency. Among the 21 African countries affected by the ongoing mpox outbreak since the start of last year, 12 are currently experiencing active transmission of the virus, while nine countries are in the control phase, five of which have gone more than 90 days without any confirmed cases.

Meanwhile, Kaseya expressed concerns regarding the challenges in responding to the mpox outbreak in the eastern Democratic Republic of the Congo (DRC), especially in the city of Goma, where fighting escalated between the DRC army and March 23 Movement (M23) rebels. Data from the Africa CDC show

that the DRC, which is at the epicentre of the current mpox outbreak in Africa, has recorded 1,842 mpox cases in the past week, of which 481 were confirmed.

The Africa CDC chief said that the conflict has disrupted laboratory services, hindering mpox testing and reporting in North Kivu, Tshopo, and other provinces.

Citing "a steep decline" in mpox reporting over the past week across provinces reliant on testing facilities in Goma, he said that the ongoing insecurity has led to interruptions in the collection, transportation, and confirmation of mpox samples.

#### Kremlin spokesman 'neither confirms nor denies' report of conversation between Putin, Trump

Moscow, Feb 12 (IANS) : Kremlin Spokesman Dmitry Peskov said on Wednesday that he could "neither confirm nor deny" reports of a conversation between Russian President Vladimir Putin and US President Donald Trump regarding Ukraine, media reported. "As the administration in Washington unfolds its work, there are many different

communications. And these communications are carried out through different channels," TASS news agency quoted Peskov as saying. "And of course, given the multiplicity of these communications, I personally may not know something, not be aware of something. Therefore, in this case, I can neither confirm nor deny it," he added. #### North Korean leader says US causing 'conflicting structure,' vows to bolster nuclear forces

Seoul, Feb 12 (IANS) : North Korean leader Kim Jong-un has accused the US of standing behind the world's disputes, reaffirming the country's policy to further develop its nuclear forces, the North's state media reported on Wednesday. Kim made the remarks during his visit to the Ministry of National Defence the previous day in celebration of the 77th anniversary of the founding of its armed forces, the Korean People's Army, Yonhap reported quoting the Korean Central News Agency (KCNA). Delivering a speech to military and political commanding officers of the ministry, Kim referred to a series of new plans for bolstering "all deterrence" and reaffirmed the country's "unshakable policy of more highly developing the nuclear forces," KCNA said, without providing details of the plans. The leader claimed that US nuclear strategic assets deployed on the Korean Peninsula, the US-led nuclear war simulation exercises and the US-Japan-South Korea military cooperation are "inviting military imbalance" on the peninsula and in Northeast Asia, causing "a new conflicting structure" and posing a grave challenge to North Korea. North Korea "does not want unnecessary tension" in the region, Kim said, adding that, however, it will take "sustained countermeasures to ensure the regional military balance" to prevent the outbreak of a new war and ensure peace and security on the peninsula.

#### Israel expands West Bank operation, raids Nur Shams refugee camp

Jerusalem, Feb 12 (IANS) : Israeli forces expanded their military operation in the occupied West Bank on Wednesday, launching a raid in the Nur Shams refugee camp, a military spokesperson said. The Israel Defense Forces (IDF) said in a statement that large forces from the IDF, Shin Bet security agency, and Border Police began operating overnight in Nur Shams, Xinhua news agency reported. According to witnesses, Israeli troops forced several families out of their homes in the camp, converting them into military outposts. The military offensive involved a large number of Israeli forces, reinforced with bulldozers, which entered the camp and imposed a blockade on it, they said. Witnesses said that bulldozers began demolishing the entrance to the al-Maslakh neighbourhood in the camp.





#### **Afghan Police arrest** 34,000 beggars to end begging culture: Official

Kabul, Feb 12 (IANS) : Police in Afghanistan have arrested more than 34,000 beggars from across the country over the past year to give an end to the culture of begging in society, a deputy on counter-narcotics of the Ministry of Interior Affairs said.

"We have arrested 34,377 beggars over the past year," the National Radio and Television of Afghanistan (RTA) quoted Mullah Abdul Haq Akhund Hamkar on Wednesday as saying. Major parts of the collected beggars were fake and professional, the official told the stateowned media outlet, saying the police after investigation have allocated a monthly allowance to the needy one and referred the professional beggars to the concerned entities for further investigation, Xinhua news agency reported. A commission was established to register beggars and categorise

them as "professional", "destitute" or "organised", which involves taking their biometric data and fingerprints. According to Taliban officials, nearly 60,000 beggars have already been "rounded up" in Kabul alone. The death of detainees rounded up under anti-begging laws is factored into the wording of the Taliban's new law, in which Article 25 states: "If a beggar dies while in custody and has no relatives or if the family refuses to collect the body, the municipal officials will handle the burial." Under the new laws, those classed as "destitute" are legally entitled to financial assistance after their release, but none of the women said they had received any help. Officials in Balkh said that they have begun a campaign to round up beggars in Mazar-e-Sharif city and other parts of the northern province.
