CM Revanth inaugurates new campus building of Microsoft in Hyderabad

Hyderabad, Feb.13 (NSS): Chief Minister A. Revanth Reddy, along with Minister for IT and Industries Duddilla Sridhar Babu, on Thursday inaugurated a brand-new campus building of Microsoft as the company celebrates its glorious 25 years in Hyderabad.

This state-of-the-art 1.1 million sq. ft. LEED-certified building in Gachibowli will house 2,500 additional employees. This is already Microsoft's largest R&D hub outside US Headquarters and the inauguration of the new campus further consolidates Hyderabad's position as the leading global IT powerhouse.

Microsoft employs over 20,000 professionals in India, over half of which work in Hyderabad

ing, Microsoft plans to hire another 4,800 employees.

On the occasion, Microsoft also announced another landmark initiative in partnership with Govt of Telangana to impart AI training to over 1.2 lakh persons in the State. Under the first program **ADVANTA** (I) GE TELANGANA, Microsoft is With the launch of the new build- launching an AI Foundations

Academy to introduce AI education to 500 government schools benefiting 50,000 students. In addition to this, the AI-Industry Pro programme will upskill 20,000 industry professionals across Telangana. The third programme AI-Govern initiative will further train 50,000 government officials in critical areas such as digital productivity, Generative AI and cybersecurity. Moreover, Microsoft will establish and operate an AICoE in collaboration with the Government of Telangana and other stakeholders. This CoE will establish cloud-based infrastructure for AI development, including a centralised AI Knowledge Hub.



President's Rule imposed in Manipur

Imphal, Feb 13 (IANS): President's Rule has been imposed in Manipur on Thursday under Article 356 of the Constitution five days after the state Chief Minister N Biren Singh resigned from the post following the directions from the central BJP leaders.

A notification issued from the Ministry of Home Affairs said on Thursday that the President has received a report from the Governor of Manipur and after considering the report and other information received by the President, she was satisfied that a situation has arisen in which the government of that state cannot be carried on in accordance with the provisions of the Constitution.

Telangana minister Ponnam asks BRS leaders to participate in caste survey

(IANS) : Telangana Backward Classes Welfare and Transport Minister Ponnam Prabhakar on Thursday asked the leaders of the main opposition Rashtra Bharat Samithi (BRS) to prove their sincerity by participating in the caste survey.

Hyderabad, Feb 13 He told media persons in Karimnagar that since some people did not share their details during the survey conducted in November-December 2024, the government has decided to give them an opportunity from February 16 to February 28.

The minister said this was not a re-survey as BRS leaders claimed. He said the BRS leaders, who did not participate in the survey, were making baseless allegations.

"If top BRS leaders have faith in democracy, they should prove this by participating in the survey," he said. Branding BJP as a party of businessmen, he alleged that the party does not want caste census.

PM Modi meets US Intelligence chief Gabbard, discusses 'India-US friendship'

Washington, Feb 13 (IANS): In what was his first formal official meeting after arriving here, Prime Minister Narendra Modi met with Tulsi Gabbard fresh off from her Senate victory confirming her as the Director of National Intelligence. Following the meeting on Wednesday night, PM Modi posted X: "Congratulated her on her confirmation. Discussed various aspects of the India-USA friendship, of which she's always been a strong votary."

Gabbard overcame strong opposition and scepticism to win the Senate vote on Wednesday for her confirmation for the nation's top intelligence job and was sworn in just hours before meeting PM Modi.

She received 52 votes to 48, with only one Republican, Senator

Mitch McConnell, joining the Democrats to vote against her.

She is an American Hindu with parents who have embraced the faith. Some of those opposed to her used her religion in their campaign against her.

During her 11 years in the House of Representatives, she was a strong supporter of India.

She was the co-chair of the Congressional Caucus on India and Indian Americans.

She also served on the House Intelligence Subcommittee and the Armed Forces Committee.

A former Vice President of the Democratic Party, she left the party and joined the Republican Party and campaigned for Trump last year.

Attorney General Pam Bondi administered the oath of office to



Gabbard, who Trump called "an American of extraordinary courage and patriotism".

He noted that she was deployed three times in the Army National Guard and that she is a former Democratic Congresswoman, riffing, "Can you believe that?" Gabbard, 43, a former Democratic Congresswoman from Hawaii, had faced bipartisan scepticism about her suitability for oversee-

ing the spy agencies. Gabbard thanked the President for his trust in her and vowed to "refocus our intelligence community" after she was sworn in.

"Unfortunately, the American people have very little trust in the intelligence community, largely because they've seen the weaponisation and politicisation of an entity that is supposed to be purely focused on ensuring our national security," the new Intelligence Chief said.

Delhi HC grants 2-day custody parole to Engineer Rashid

New Delhi, Feb 13 (IANS) dent Omar Abdullah (now Chief :The Delhi High Court on Thursday granted two-day custody parole to Lok Sabha MP Engineer Rashid to attend the ongoing Parliament session.

Engineer Rashid, who won the Lok Sabha election from J&K's Baramulla constituency by defeating National Conference (NC) Vice PresiMinister) by over two lakh votes while staying in Tihar Jail, is accused in a terror funding case being probed by the National Investigation Agency (NIA).

A bench of Justice Vikas Mahajan granted custody parole to Engineer Rashid for February 11 and 13 while imposing a slew of conditions. As per the Delhi HC order, Engineer Rashid will not interact with any person except for his limited responsibility of attending the House and will not address the media in any manner. On February 7, Justice Mahajanled Bench reserved its verdict on Engineer Rashid's plea seeking interim bail, or alternatively, custody parole, to attend the ongoing Parliament session, after hearing

the oral arguments advanced by the counsel representing the federal anti-terror agency and Engineer Rashid's lawyer.

During the hearing, senior advocate Sidharth Luthra, appearing on behalf of the NIA, argued that there are security issues and custody parole is not a vested right of a legislator.

Engineer Rashid has petitioned

the Delhi High Court seeking directions to the trial court judge to expedite a decision on his pending regular bail application or decide the matter itself.

Earlier, a court here, instead of passing an order on the application for regular bail, had recommended the District Judge to transfer his case to the MP/MLA court as Rashid became an MP.



In his plea pending before the Delhi HC, he sought interim bail to attend the ongoing Budget session of the Parliament.

Massive 300-km traffic jam on route to Maha Kumbh leaves lakhs of pilgrims stranded

sea of vehicles stretching up to 300 kilometres turned the roads leading to the ► Maha Kumbh Mela in Uttar Pradesh's Prayagraj into a massive parking lot, leaving lakhs of devotees stranded for hours, unable to reach the world's largest religious gathering. The unprecedented congestion forced many to remain stuck in their vehicles, some even hundreds of kilometres away from the fair site on Sunday and Monday. A day earlier, heavy traffic heading toward Prayagraj had already led to police stopping hundreds of vehicles in different areas of Madhya Pradesh to prevent overcrowding. The extreme bottleneck, which social media users dubbed the "world's biggest traffic jam," reportedly extended across 200 to 300 kilometres, affecting pilgrims travelling through Madhya Pradesh. The situation prompted the state police to halt traffic across multiple districts, leaving travellers stuck for long hours on highways.

Taking a swipe at the Uttar Pradesh government, Samajwadi Party chief Akhilesh Yadav blasted the administration's handling of the event, urging authorities to address the plight of stranded devotees.

"The hungry, thirsty, distressed, and exhausted pilgrims stuck in traffic jams should be looked at with a humane perspective. Are common devotees, not human beings?" Yadav asked in a post on X. The former Chief Minister also demanded that vehicles be made toll-free across Uttar Pradesh during the Maha Kumbh to ease congestion and ensure a smoother journey for devotees. "On the occasion of Maha Kumbh, vehicles should be made toll-free in LIP

This will reduce travel problems and also the issue of traffic jams. When films can be made entertainment tax-free, then why not exempt vehicles from tolls for this religious event?" he wrote. He further highlighted specific trouble spots, mentioning major jams at Nawabganj, 30 km before entering Prayagraj from the Lucknow side, a bottleneck at Gauhania, 16 km before Rewa Road, and a traffic snarl extending 12-15 km towards Varanasi. He also cited reports of overcrowding in trains, with passengers even squeezing into engines to reach their destination. "Normal life has become difficult," he added. Meanwhile, authorities in Madhya Pradesh responded by halting vehicular movement in multiple districts. In Katni, police announced through loudspeakers that traffic had been stopped until Monday. In Maihar, officers advised vehicles to turn back toward Katni and Jabalpur to find temporary shelter.

Several videos circulating on social media captured the extent of the congestion, with endless lines of cars and trucks clogging roads across the Katni, Jabalpur, Maihar, and Rewa districts. Eyewitnesses reported that the traffic jam spanned nearly 250 kilometres from Katni to the MP-UP border at Chakghat in Rewa district. As the crisis unfolded, Madhya Pradesh BJP president V.D. Sharma urged party workers to assist stranded pilgrims in their respective regions. "All workers are requested to help the devotees heading to Maha Kumbh in every possible way. Arrange food and shelter if needed.

Ensure that no devotee faces inconvenience. Let us play our role in this Maha Yagya," he posted on X. Frustrated devotees have also voiced their grievances over the mismanagement of the traffic situation. Pilgrims from Faridabad reported that what should have been a routine journey took them over 24 hours to reach Prayagraj. A family from Jaipur shared their frustration, saying they were stuck for hours just to cover a mere four-kilometre stretch. With the Maha Kumbh continuing until February 26, authorities face mounting pressure to resolve the traffic chaos and ensure smoother movement for the remaining weeks of the grand religious gathering.



"According to diplomatic sources, during this meeting, Bangladesh would like to convey a message aimed at preventing further strains in the relationship between both nations," reported Prothom Alo, Bangladesh's leading Bengali daily. The 8th Indian Ocean Conference is being organised by India Foundation in association with the Ministry of Foreign Affairs of Oman on Feb-

ruary 16-17 in Muscat, Oman. The theme for this year of the conference, which serves as a key platform for regional dialogue, is 'Voyages to New Horizons of Maritime Partnership'. EAM Jaishankar and Hossain had last met on the sidelines of the UN General Assembly in New York in September, marking the first highlevel engagement between India and Bangladesh's interim government after former Prime Minister Sheikh Hasina's ouster in August 2024. Even though India continues to bat for normalisation of relations between the two neighbouring countries, the current regime in Dhaka has faced massive criticism for making groundless accusations and also targetting the Hindu community in Bangladesh since the mass upris-

ing of students and the dramatic fall of Hasina's Awami League government on August 5, last year. In December, Foreign Secretary Vikram Misri visited Dhaka on a day-long visit, conveying New Delhi's concerns, especially those related to the safety and welfare of minorities in Bangladesh, to the top leadership of the interim government. The Ministry of External Affairs (MEA) stated that, during these meetings, Misri highlighted India's support for a democratic, stable, peaceful, progressive and inclusive Bangladesh while reiterating New Delhi's willingness to build a positive and constructive relationship with Bangladesh, based on mutual trust and respect and mutual sensitivity to each other's concerns and interests.

Ladakh hot springs to be thrown open as battlefield tourism destination from June 15

adakh hot springs located in Galwan Val ley area close to the Line of Actual Con trol (LAC) with China are being thrown open for visitors as part of battlefield tourism from June 15. Officials said on Monday, "Hot springs in Eastern Ladakh will be thrown open for the tourists on June 15 this year, the fifth anniversary of martyrdom of 20 Indian soldiers in clash with People's Liberation Army (PLA) of China which lost its 42 jawans. "At present, even the locals can't visit Galwan Valley. The requisite infrastructure is being generated to promote tourism. "The Ministry of Defence has taken a decision to this effect and the Indian Army is on board. The Union Territory administration of Ladakh has been briefed about the decision and is making all arrangements for converting Galwan Valley into a battlefield tourism destination. "The Hot Spring area which also falls close to the LAC in Ladakh is also being opened to tourists with infrastructure development and recce operations already underway." Officials said, "The move is expected to



boost border and rural tourism in the region, providing economic benefits to local communities. From establishing war memorials to commemorate the sacrifices of Indian soldiers to promoting wildlife and cultural tourism, the initiative holds promise for Ladakh's tourism industry and regional development."

A recce of the Galwan area was conducted

A recce of the Galwan area was conducted on January 19 by a 10-member team of Tourism Enablers representing ALTOA, Taxi Union, Tempo Union, Bike Union and ALGHA Tourism. "The recce was organised by the GOC Kharu Division and initially, the plan is to open the area to domestic tourists. Pangong Lake already attracts a large number of tourists and the addition of Galwan as a destination is expected to give a significant boost to tourism.

IMF scans Pakistan's judicial, regulatory system

Islamabad, Feb 13 (IANS): The International Monetary Fund (IMF) was scrutinising the judicial and regulatory system of Pakistan as part of the ongoing \$7 billion Extended Fund Facility (EFF) to address governance and corruption vulnerabilities, according to the Ministry of Fi-

According to the Government of Pakistan, the IMF team will engage with financial, revenue, and election bodies in the country. An assessment must be published in July sharing measures to address corruption and governance vulnerabilities, reports Dwan, quoting the Ministry of Finance.

Under the United Nations framework, Pakistan is required to publish the corruption report immediately after a review. A technical mission of the IMF is in Pakistan for a week-long examination of six key governance-related sectors and institutions, the ministry stated.

In October, Pakistan committed to the IMF to strengthen institutional capacities to fight corruption, support inclusive growth, and provide a level playing field for businesses and investments.

As a result, a structural benchmark had been set to publish by July 2025 a report on the Governance and Corruption Diagnostic Assessment (GCDA) to analyse critical governance and corruption vulnerabilities and identify priority structural reforms moving forward, the ministry said.

According to the media report, the mission would also be engaging with leading members of the superior judiciary besides the leadership of the financial, revenue, and election bodies to review their process. The mission will examine six core state functions, including fiscal governance, central bank governance and operations, financial sector oversight, market regulation, rule of law, and antimoney laundering and counter-financing terror.

In 2024, The IMF approved \$7 billion to Pakistan under a 37month loan program, with \$1 billion earmarked for immediate disbursement. Pakistan has been dependent on IMF funds to meet its needs for decades and has struggled after years of financial mismanagement. It is currently its fifth-largest debtor and has taken 24 loans from the IMF since 1958.

South Korea: NHRCK meets over agenda on Yoon's right to fair trial Seoul, Feb 13 (IANS): South nary meeting on the issue amid

Korean state human rights watchdog began a meeting on Thursday to discuss whether to adopt a recommendation to guarantee President Yoon Suk Yeol's right to defence during his impeachment trial at the Constitutional Court.

The National Human Rights Commission of Korea (NHRCK) convened its ple-

growing demand among Yoon's supporters that the impeached president should be guaranteed a fair trial at the Constitutional

The meeting came after an NHRCK standing commissioner proposed the recommendation as part of an agenda to address the national crisis triggered by Yoon's short-lived martial law declaration on December 3 last year. But the commission failed to hold discussions on January 13 and 20 amid strong protests from supporters of liberal opposition

Earlier on Monday, pro-Yoon demonstrators attempted to enter the NHRCK building in central Seoul in a bid to block protesters opposing the proposed recommendation but were scattered later after police intervened, Yonhap news agency reported.



Yoon's supporters have demanded the commission adopt the recommendation in his favour, whereas opposition parties and their supporters have come out against the move. Ahead of the meeting, ruling and opposition party lawmakers visited the commission to express their opinions on the agenda.

Pakistan: Massive protest by lawyers leads to chaos in Islamabad

Islamabad, Feb 13 (IANS): to the Red Zone in the federal Chaos ruled in Pakistan's capital Islamabad once again as lawyers of the country took to the streets on Thursday, protesting against a meeting being held at the Supreme Court to finalise names of eight Supreme Court judges. The Judicial Commission of Pakistan (JCP) is considering elevating eight High Court judges to the Supreme Court in spite of calls from some several judges and thousands of lawyers to defer the meeting. The legal organisations in Islamabad have also been strongly opposing the recent transfers of five judges to the Islamabad High Court (IHC), terming the move as an attempt to divide the judiciary. Authorities and security forces in Islamabad have blocked and barricaded all routes leading to the Supreme Court and deployed additional forces to handle any situation in case the protest intensifies.

Islamabad Police have also closed several key entry points

capital in response to the protest called by lawyers.

The protest also led to the suspension of Metro bus services on multiple routes between Islamabad and Rawalpindi, causing significant inconvenience for commuters. The lawyers have gathered in big number outside the Supreme Court in Islamabad, raising slogans of freedom of judiciary and carrying banners in support of the protest. The protesting lawyers have called the 26th Constitutional Amendment as completely "unacceptable".

The Lahore High Court Bar Association (LCBA) also moved an application before the apex court, expressing opposition to the 26th Constitutional Amendment, seeking postponement of the JCP meeting. The matter of transfer of judges had aggravated after Justice Sarfaraz Dogar was transferred from the Lahore High Court (LHC)





Australian homelessness services report surge in demand for assistance

Sydney, Feb 13 (IANS): Australia's homelessness services have reported a major surge in demand for assistance amid the country's housing crisis. According to a survey conducted by NGO Everybody's Home, 87 per cent of Australia's frontline homeless support organisations experienced a major increase in their workload in December and January compared to previous years.

Among the organisations that were surveyed, 98 per cent reported increased workloads last year and said they expect demand to continue rising in 2025. Two-thirds of organisations said they have been unable to provide long-term housing solutions for clients, 71.7 per cent reported increased waitlists and half said they have fewer resources per client than a year ago.

Everybody's Home spokesper-

son Maiy Azize said that the organisations reported "the worst summer on record" as high rental prices and the rising cost of living continue to impact Australians. "The services at the coalface of Australia's housing crisis are at breaking point. They can barely keep up with the rising number of people facing housing stress and homelessness," Azize said in a statement on Monday. A separate report published on Monday by Melbourne-based think tank the Grattan Institute found that two-thirds of retired Australians who rent in the private market are living in poverty, Xinhua news agency reported.

Over 70 per cent of retired single women and men who rent are living in poverty, the report said. Data released by government agency the Productivity Commission at the end of January said that 37,779 Australians were experiencing persistent homelessness in 2023-2024, up from 30,306 people in 2019-2020. Homelessness can expose people to violence and victimisation, result in long-term unemployment and lead to the development of chronic ill health. People experiencing homelessness have significantly higher rates of death and chronic illness when compared with the general population.



Australian police seize 41 kg of

Sydney's Port Botany from Chile and Belgium in January. They said that officers have observed a recent drug import trend where cocaine is hidden by criminal syndicates in refrigerated containers used by legitimate businesses to import goods. Once the container has arrived in Sydney, local members of the syndicates attempt to break into the docks or other storage areas to recover the drugs. The AFP and ABF said in a joint statement that there has been a significant increase in the use of the tactic since April 2023 and that they are now actively targeting refrigerated containers arriving in Sydney.

They said that more than one tonne of cocaine has been seized in total from the containers since 2023, as well as tracking devices used by organised crime gangs to monitor and identify the containers.

2 pc rise in vote share a step forward: Cong on Delhi election defeat

New Delhi, Feb 13 (IANS): Congress National Spokesperson Ragini Nayak on Thursday acknowledged the party's underwhelming performance in the Delhi Assembly elections, where 67 of its 70 candidates lost their security deposits. However, she pointed out that the party's vote share had increased by 2 per cent, marking what she called a step forward. Despite fielding 70 candidates, only three managed to save their security de-

Speaking to IANS, Nayak said, "The result has not been as per the Congress party's wish. But it cannot be denied that our vote share has increased by 2 per cent. We have taken a step forward from the last time and in many seats in Delhi, where we have got more than double the votes than the last time."

She expressed optimism, drawing an analogy to a hopeful outlook, stating that just as an optimist sees the glass as half full, every Congress worker and leader would embark on the next five years with determination.

She assured that the party "would stand by the people" in every constituency and work towards strengthening its role as a "strong Opposition."

"While introspection is necessary, the focus would also be on action. I am confident that the party would not only reflect on how to multiply its votes tenfold but would also take concrete steps to achieve that goal soon," Nayak added.

While acknowledging the slight increase in vote share as a positive indicator, she said, "I am happy that our vote percentage has increased. But this is not a matter of overconfidence or overexcitement. We have to accept that we wanted to bring a much better result than this. We failed in that. Failure is a challenge and we accept it," she said.

Among the 699 candidates contesting the Delhi Assembly elections, 555 lost their security deposits. Congress, once a dominant force in Delhi, failed to win a single seat for the third consecutive election





Indian companies increasing AI investments, focus on open source and governance: Report

New Delhi, Feb 13 (IANS): Indian businesses are making significant strides in AI adoption, with 87 per cent of surveyed companies have advanced their AI strategies for 2024 and 76 per cent already seeing positive returns on their investments, a report said on Thursday.

Companies are not only investing in AI for the long term but are also increasingly leveraging open-source tools to drive innovation and maximise returns.

A remarkable 89 per cent of surveyed companies have already launched more than 10 AI pilot projects in 2024, according to new research by IT major IBM.

Looking ahead, 93 per cent of respondents plan to increase their AI investments in 2025, and 71 per cent aim to leverage open-source ecosystems to optimise their AI implementation.

However, governance has emerged as a key concern, with businesses recognising the importance of responsible AI practices. Implementing AI responsibly requires a structured approach that ensures fairness, transparency, privacy and explainability.

The biggest challenges in AI adoption include a lack of governance (53 per cent), insufficient AI expertise (51 per cent), difficulties in technology integration (51 per cent), data management issues (41 per cent), and struggles to generate business value (39 per cent). Despite these challenges, Indian enterprises remain committed to AI investments.

About 97 per cent of surveyed organisations plan to either increase or maintain their AI spending in 2025.



QIP fundraising reaches record high in India, real estate leads with Rs 22,320 cr in 2024

Fundraising through qualified institutional placements (QIPs) reached an all-time high in India in 2024, with 99 issues raising a massive Rs 1,41,482 crore across sectors, a report said on Thursday. QIPs are a capital-raising method for listed companies without having to submit legal paperwork to market regulators. Real estate emerged as a key contributor, with eight developers and one real estate investment trust (REIT) collectively raising Rs 22,320 crore.

Mumbai, Feb 13 (IANS): This accounted for 16 per cent of the total QIP fundraising for the year, according to the report by Anarock Group.

Compared to 2023, when only 43 QIP issues raised Rs 55,109 crore and real estate saw no activity in this space, 2024 marked a significant shift.

It saw the highest QIP fundraising year in the past 11 years, with real estate making a strong comeback as institutional investors showed confidence in the sector's long-term growth.

Bengaluru, Feb 13 (IANS): Boeing's supply chain in India is exporting an impressive Rs 10,000 crore worth of aerospace components every year, making the US plane maker the largest foreign manufacturer in the country, Boeing India President Salil Gupte has said.

He dismissed the idea that hightech aviation manufacturing was not happening in India. "That may have been true 10 years ago, but today, India has an interesting opportunity," he observed in an interview to NDTV Profit. Gupte pointed out that Boeing has expanded its operations in

India with as many as 5,000 aeronautical engineers working at its 43-acre site in Bengaluru who are mostly looking at domestic work but also supporting some overseas projects.

Boeing also has an extensive

supply chain in India, with suppliers in Bengaluru, Hyderabad, Gujarat and northern India. "These suppliers export about Rs 10,000 crore worth of aerospace components every year, making us the largest foreign OEM (original equipment manufacturer) in India," Gupte said on the sidelines of the 'Aero India 2025' show here. He further highlighted that Boeing is working under the 'Make in India' and 'Atmanirbhar Bharat' initiatives in the defence sector.

"A key factor in defence manufacturing is localisation. Any final assembly for a defence contract today requires 50 per cent indigenous content. That's why we have been investing in localisation efforts," Gupte explained.

He also underscored the importance of partner companies like US tech giant GE, which is setting up an engine manufacturing

unit with Hindustan Aeronautics Ltd (HAL).

"GE has a big place in a lot of our platforms for both civil and defence," Gupte noted.

"For final assembly in India, you need tier-1 suppliers and engine manufacturers already present which is already happening," he remarked.

Gupte said that Boeing has been in India for eight decades, but over the last 10 years its presence has really started to grow.

Boeing has been actively supporting civil aviation customers, and in defence, it has introduced several key platforms such as the C-17 cargo aircraft, P-8 maritime patrol aircraft, and Apache helicopters. "The head of the state fleet, where we get to fly the Prime Minister and the President of India, is also a Boeing fleet," he pointed out.

Sensex ends flat ahead of key PM Modi-Trump meet, Nifty holds 23,000 level

Mumbai, Feb 13 (IANS): The Indian stock market on Thursday saw a choppy session as benchmark indices gave up early gains and ended flat, with investors awaiting the outcome of the meeting between Prime Minister Narendra Modi and US President Donald Trump that aims to boost the growing relations between the two largest democracies.

The Sensex closed at 76,138.97 by slipping 32.11 points or 0.04 per cent from its previous close. The index moved within a range of 76,764.53 and 76,013.43 during the day.

The index touched an intra-day high of 23,235.50 but also slipped to a low of 22,992.20 before closing.




Crime Branch to probe Rs 1,000 crore Kerala CSR scam

Thiruvananthapuram, Feb 13 (IANS): Amid rising complaints from the public about being duped in a massive fake Corporate Social Responsibility (CSR) fund scam, estimated to exceed Rs 1,000 crore, Kerala State Police Chief (SPC) Sheikh Darvesh Sahib has handed over the investigation to the Crime Branch.

The decision, taken after extensive consultations, was announced on Thursday.

The probe will be led by Additional Director General of Police (ADGP) H. Venkatesh, with separate teams being formed in all 14 districts of the state to handle the mounting complaints. Initially, 34 cases have been transferred to the Crime Branch. However, early scrutiny of bank accounts linked to the NGO 'Muvattupuzha Socio-Economic Development Society' and the alleged mastermind, 26-year-old Anandhu Krishnan, suggests the number of cases could exceed 30,000, as nearly one lakh individuals are believed to have fallen victim to the scam.



SC questions Gujarat govt over FIR against Cong MP Imran Pratapgarhi

New Delhi, Feb 13 (IANS): The Supreme Court on Thursday raised questions over an FIR registered against Congress Rajya Sabha MP and poet Imran Pratapgarhi for allegedly disturbing social harmony. The complaint dates back to January 3, 2025, when a complaint was filed at Jamnagar police station by an advocate's clerk.

The complainant alleged that a video posted by Pratapgarhi on Instagram, which featured a poem, was inciting unrest and harming social peace.

"Please see the poem. It's ultimately a poem. It is not against any religion. It is not against any particular community. Please apply your mind to the poem," remarked a Bench of Justices Abhay S Oka and Ujjal Bhuyan as it adjourned a hearing on the request made by the Gujarat government's counsel.

The matter will be heard next after three weeks. Earlier on January 21, the Justice Oka-led Bench, in an interim order, shielded Imran Pratapgarhi from arrest as it issued a notice to the Gujarat government and posted the matter for further hearing on February 10.

Does this mean we should cede state elections to the BJP? The INDIA bloc is visible only in Parliament right now, but it must unite and take a strong stand on critical issues." Taking a jibe at the Congress, Raut remarked, "When elections come, we don't need a 'Big Brother' just for seat-sharing. A leader's job is to coordinate, not just secure a larger share of seats. We have seen this in Uttar Pradesh and Maharashtra during the Lok Sabha elections.

German Chancellor Scholz criticises Trump's Gaza plan as 'scandal'

Berlin, Feb 13 (IANS): German Chancellor Olaf Scholz criticised US President Donald Trump's plan to relocate Palestinians from the Gaza Strip, calling it "a scandal." Scholz and Friedrich Merz, leader of the opposition Christian Democratic Union (CDU), engaged in the first televised debate on Thursday evening ahead of Bundestag elections on February 23.

One of the key topics discussed was how Germany should engage with the United States under Trump's administration. Addressing the Middle East issue, Scholz reaffirmed his opposition to Trump's Gaza proposal,

Xinhua news agency reported. Speaking at a campaign event on Friday, Scholz had voiced his disapproval, stating, "We must not resettle the population of Gaza to Egypt," and expressing his "complete rejection" of the plan.

During Sunday's debate, Scholz described his strategy for dealing with Trump as involving "clear words and friendly conversations." Merz, while also expressed concerns over Trump's proposal, described it as "part of a series of irritating proposals from the American Administration."

South Korea holds emergency meeting on US tariffs on steel, aluminum imports

Seoul, Feb 13 (IANS): South Korea's industry ministry held an emergency meeting on Thursday to assess the possible impact on local businesses from the United States' plan to impose a 25 per cent tariff on all steel and aluminium imports. The Ministry of Trade, Industry and Energy held a meeting with officials from major local steel companies, including POSCO Holdings Inc. and Hyundai Steel Co., to discuss responses to the proposed US tariffs, according to ministry officials. Earlier in the day, US President Donald Trump said he would announce on Monday (US time) the imposition of a new 25 per cent tariff on all

steel and aluminium imports into the US. The announcement stoked concerns South Korean companies could be directly influenced by the anticipated US tariffs unlike the Trump administration's previous move to impose tariffs on Canadian, Mexican and Chinese goods. South Korea accounts for some 13 per cent of US steel imports, according to data from the Korea International Trade Association (KITA). Trump imposed a 25 per cent tariff on all steel imports to the US in 2018, citing national security concerns.

At the time, the US waived the tariffs on South Korean steel products in return for a yearly import quota of 2.63 million tons, which



accounted for about 70 per cent of Seoul's average export volume between 2015-2017.

In the emergency meeting, Deputy Trade Minister Park Jong-won said the government will "proactively" respond to the shift in US trade policy by using "all available networks" and closely collaborating with related industries. Officials at local steelmakers Hyundai Steel and POSCO Holdings said they are closely monitoring the situation as there are uncertainties surrounding the US trade policies at the moment.

Hyundai Steel had been considering constructing a steel mill in the US, prior to Trump's recent announcement.

Israeli army says struck Hezbollah targets in Lebanon despite ceasefire

Jerusalem, Feb 13 (IANS): The Israeli military said Thursday that it has launched airstrikes on Hezbollah targets in eastern and southern Lebanon.

An Israeli aircraft struck an underground tunnel used by Hezbollah for arms transfers in eastern Lebanon's Bekaa region, which extended from Syria into Lebanese territory and had previously been targeted by Israeli forces, an Israeli military spokesperson said.

The Israeli Air Force also struck sites in southern Lebanon that contained "munitions and rocket launchers that posed an imminent threat," the spokesperson added. Meanwhile, Israeli fighter jets carried out multiple airstrikes on Sunday evening targeting areas in the Nabatieh region of southern Lebanon, the rugged outskirts of Hermel near the Lebanese-Syrian border, and areas in the eastern Bekaa region, Xinhua news agency reported quoting Lebanon's state-run National News Agency.



Trump says he will announce 25 pc duties on steel, aluminum imports; threatens more to come

New York, Feb 13 (IANS): US President Donald Trump has said that he will announce a 25 per cent duty on all steel and aluminum imports, a long-standing contentious category of trade for India and the US. President Trump said on Thursday that he will announce the tariffs on Thursday covering imports from all countries.

"Any steel coming into the United States is going to have a 25 per cent tariff, aluminum, too", Trump said while flying to New Orleans for the Superbowl. He said that reciprocal tariffs would also be coming for all countries.

"Very simply, if they charge us, we charge them"; he said. Those tariffs will be announced on Tuesday or Wednesday and take effect immediately, he added.

The tariff threat came ahead of Prime Minister Narendra Modi's visit to Washington this week.

India exported steel worth \$4 billion and aluminum worth \$1.1 billion during 2023. Steel and aluminum trade has been a contentious - and complicated issue – for India and the US with Washington accusing New Delhi of subsidising those exports. During PM Modi's visit to Washington in 2023, the two countries agreed to settle six disputes before the World Trade Organisation involving the metals. However, in October, the US slapped duties of as much as 39.5 per cent on some categories of aluminum imports.

The Moroccan authorities were able to rescue only 36 people and 50 passengers died in the in-

Following the incident, Pakistan government launched a major crackdown against human traffickers and their facilitators as the government.



UN urges more resources against worsening droughts in Somalia

Mogadishu, Feb 13 (IANS): The United Nations relief agency on Thursday called for efforts to mobilise more resources in response to an escalating drought crisis in several areas of Somalia. The UN Office for the Coordination of Humanitarian Affairs (OCHA) warned that the spread of prolonged, extreme dry conditions is worsening an already dire humanitarian situation in Somalia. "To mitigate the situation, hu-

manitarian agencies must urgently mobilise and coordinate resources to address the escalating drought crisis and prepare for the anticipated challenges of the Gu (rainy) season," OCHA said in its humanitarian update released in Mogadishu, the capital of Somalia. It said the poor performance of the October-to-December 2024 deyr (short) rains led to drought conditions in southern and central regions.

Bangladesh Election Commissioner vows to remain 'neutral' in elections

Dhaka, Feb 13 (IANS): Chief Election Commissioner (CEC) of Bangladesh, AMM Nasir Uddin, has said the commission does not intend to support or oppose any political party and vowed to remain neutral, local media reported.

"We, in the commission, do not want to engage in politics. We do not want to stand for or against any political party," he said, adding, "We want to remain neutral."
