New Delhi, Feb 14 (IANS) : Under Prime Minister Narendra Modi's leadership, the road network in India has grown bigger than that of the US, Union Road Transport and Highways Minister, Nitin Gadkari said on Friday.

Addressing an event to inaugurate two projects - Munshi Pulia flyover and Khurram Nagar flyover, Union Minister Gadkari said, "I can guarantee that in two years, Uttar Pradesh's National Highway network will be better than that of the US." Announcing approval for highway projects worth crores of rupees in Uttar Pradesh (UP), Union Minister Gadkari said there was no shortage of funds in the country but what was needed was leaders with honesty and



integrity. "PM Modi has the dream of making India a 'Vishwa Guru' and the third-largest economy of the world. For this, we will need a big infrastructure push that will attract investment and create jobs," he said, adding that the government is determined to bring down the logistics cost to 9 per cent that will increase Indian exports 1.5 times.

"Today India and UP are changing and the state is becoming a growth engine for the country. I wish that before the end of my five-year term as minister, I manage to execute highway projects worth Rs 5 lakh crore - so far I have managed to execute projects worth only Rs 3.5 lakh crore," he said.

"Under this initiative, they committed to a results-driven agenda with initial outcomes this year to demonstrate the level of trust for a mutually beneficial partnership," said the press release.

The leaders reaffirmed their unwavering commitment to a dynamic defence partnership spanning multiple domains. To advance defence ties further, the leaders announced plans to sign this year a new ten-year Framework for the 'US-India Major Defense Partnership' in the 21st Century.

The leaders welcomed the significant integra-

tion of US-origin defence items into India's inventory to date, including C-130J Super Hercules, C-17 Globemaster III, P-8I Poseidon aircraft; CH-47F Chinooks, MH-60R Seahawks, and AH-64E Apaches; Harpoon antiship missiles; M777 howitzers; and MQ-9Bs. The leaders determined that the US would expand defence sales and co-production with India to strengthen interoperability and defence industrial cooperation.

NGT issues notice to Odisha govt, state pollution control board over environmental violations

Bhubaneswar, Feb 14 (IANS) : The National Green Tribunal (NGT) has issued notice to the Odisha government, Odisha State Pollution Control Board (SPCB) and others seeking a reply in connection with allegations of environmental pollution against a private company engaged in manufacturing of various stainless steel products. The NGT issued the order while hearing a petition filed by Harihar Samal of Dhenkanal

district and Rajib Gopal Swain of Angul district. The authorities have been asked to submit their replies within four weeks from the receipt of the order. The tribunal also constituted a factfinding Committee including senior scientists from the Ministry of Environment, Forest and Climate Change, the Central Pollution Control Board (CPCB), and the Odisha State Pollution Control Board (OSPCB).





MP govt to give state honour to promote organ donation

Bhopal, Feb 14 (IANS) : persons will be transported Madhya Pradesh Chief Minister Mohan Yadav on Friday announced that people, who will donate organs before death to give a new lease of life to others, will give state honour during their last rites.

The Chief Minister said the bodies and organs of the deceased through air ambulance service with the consent of the family members and a provision will be made to facilitate them with a posthumous award on national festivals.

Chief Minister Yadav made this announcement after meeting with a patient, who got a new lease of life after a successful heart transplant was performed at AIIMS Bhopal on January 26.

The heart was procured from a 61-year-old brain-dead patient at NSCB Medical College in Jabalpur and transplanted into a 53-year-old patient from Itarsi. It was the first heart transplant case at AIIMS Bhopal.



Congress to oppose President's rule in Manipur

Imphal, Feb 14 (IANS) : A day after the resignation of Chief Minister N Biren Singh, the opposition Congress on Friday announced that they would oppose any move to promulgate President's rule in Manipur. Manipur Congress President Keisham Meghachandra Singh in a post on the X said: "For the people of Manipur, Congress party opposes any move to impose President's Rule in Manipur now as well as the party also opposes any move to place Manipur Legislative Assembly under suspended animation now."

CBI books chief engineer of USBRL project for bribery

Jammu, Feb 14 (IANS) : Officials said on Friday that the Central Bureau of Investigation (CBI) had booked a chief engineer of the Konkan Railways for alleged bribery to clear the pending bills of a company involved in the construction of the Katra-Dharam section of the Udhampur-Srinagar-Baramulla railway link project (USBRL). Sumeet Khajuria, a 2005-batch IRSE (Indian Railway Service of Engineers) officer has been named as an accused in an FIR lodged by



the CBI along with Paras Railtech Private Limited and its directors Rajesh Kumar Jain, Pushp Raj Singh, and Sulabh Rawat, under the Bharatiya Nyaya Sanhita (BNS) sections related to criminal conspiracy.

Funds for Construction of Houses under PMAY-G

he Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) aims at providing pucca houses for all persons having kutcha houses up to 2 rooms or less and whose names are included in properly verified Permanent Waiting List (PWL) & Awaas+ list. The beneficiaries have been identified based on the housing deprivation parameters and exclusion criteria prescribed under Socio Economic Caste Census (SECC)- 2011. On application of exclusion criteria, a priority list called the Permanent Wait List (PWL) is prepared for the States/UTs. The PWL is further subjected to verification by Gram Sabhas and completion of an Appellate Process thereafter. This process of exclusion is also applied to beneficiaries registered by the States/UTs in Awaas+.

The Union Cabinet has approved the implementation of the scheme for 5 more years during FY 2024-25 to 2028-29 to provide assistance for the construction of 2 crore additional rural houses. Approval has also been provided for updating the Awaas+ List for identifying eligible rural households using modified exclusion criteria under the scheme. In line with the approval of the Union Cabinet, a survey is being conducted for the identification of additional eligible rural households under the scheme. The survey is being conducted through Awaas+ 2024 Mobile App which has already been launched on 17.09.2024 with modified exclusion criteria.

(b) & (c): Under PMAY-G, the unit assistance of Rs. 1.20 lakh in plain areas and Rs. 1.30 lakh in North Eastern States, Hilly States (including UTs of J&K and Ladakh) is provided. In addition to the unit assistance, the beneficiaries are facilitated with 90/95-man days of unskilled labour wages through mandatory convergence with Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS). Support of Rs. 12,000 for construction of toilet is also provided through Swacch Bharat Mission - Gramin (SBM-G), MGNREGS or any other dedicated source of funding. The Union Cabinet has approved the continuation of PMAY-G till March, 2029 as per the existing unit assistance for construction of 2 crore more houses.



Blueprint for change: NITI Aayog's policy report sets ambitious goals for higher education

groundbreaking policy report titled 'Expanding Quality Higher Education through States and State Public Universities' was released on Monday, providing a comprehensive analysis of the challenges and opportunities in India's higher education system. The report was launched by Suman Bery, Vice Chairman of NITI Aayog, BVR Subrahmanyam, CEO of NITI Aayog, and other officials. The report offers a detailed ex-

amination of the decadal transformation in higher education across the states and state public universities (SPUs). It focusses on the goals outlined in the Na-

2020. It also presents a set of policy recommendations aimed at improving the quality of education, funding, governance, and employability in these institutions. "We must ensure that our higher education system is not only growing in number but is also delivering quality," said Suman Bery, Vice Chairman, NITI Aayog, during the release of the report. "This report highlights critical areas where action is needed to enhance the quality, accessibility, and global competitiveness of our state public universities."

The report is the first of its kind, featuring a quantitative analysis

tional Education Policy (NEP) of the performance of SPUs and The report stresses enhancing capturing insights from consultations with officers from 20 states and UTs, 50 Vice Chancellors, senior academics, and heads of State Higher Education Councils. It includes over 80 policy recommendations across four key areas: Quality, Funding & amp; Financing, Governance, and Employability, along with a detailed implementation roadmap that spans short-term, medium-term, and long-term actions.

Key policy recommendations that the NITI Aayog report has come out with include the following important areas: Quality

research capabilities and "improving pedagogy" in SPUs. Key recommendations include the introduction of a National Research Policy, creating Centres of Excellence in clusters of SPUs to tackle local challenges, and promoting Humanities Research. The report also calls for the creation of Multidisciplinary Education and Research Universities (MERUs) to bridge gaps in research and education.

"To strengthen the research ecosystem in India, we need to ensure that SPUs are not only centres of education but also hubs of innovation and entrepreneurship," says an official.



Israel's cabinet will convene on Friday to discuss the next phase of the Gaza ceasefire, a spokesperson for Prime Minister Benjamin Netanyahu said in a statement on Friday.

The Israeli delegation for the talks in Qatar over the Gaza ceasefire returned to Israel on Monday morning, according to the statement. The delegation travelled to Doha on Sunday for indirect negotiations between Israel and Hamas concerning the second phase of the fragile ceasefire, follow-

Jerusalem, Feb 14 (IANS) : ing Netanyahu's visit to Washington last week. However, according to Netanyahu's office, the delegation focused only on technical matters, not major issues that have yet to be agreed upon, including the administration of Gaza after the war. Under the ceasefire, which took effect on January 19 after 15 months of devastating war, 21 hostages -- 16 Israelis and five Thais -- were released from Gaza in exchange for hundreds of Palestinian detainees freed from Israeli jails. More than 70 hostages are still in Gaza. Under the first phase of the agreement,

which spans six weeks, a total of 33 hostages and about 2,000 detainees are expected to be released, Xinhua news agency reported.

On Sunday, reiterating US President Donald Trump's firm stance, US Secretary of State Marco Rubio called for the immediate release of all Israeli hostages taken by Hamas, following the return of three captives. Taking to X, Rubio posted, "After 490 harrowing days in captivity, Eli, Or, and Ohad are finally home in Israel.





Trump moves to end 'politically-motivated' prosecution of New York Mayor

New York, Feb 14 (IANS) : In a move to clear up some of the politically controversial prosecutions, US President Donald Trump has moved to drop a case against New York's mayor Eric Adams. Acting Deputy Attorney General Emil Bove ordered the federal prosecutors in the city on Friday to drop the case of alleged corruption against Adams pointing out that the charges were filed after he criticised President

Joe Biden's immigration policy. Bove cited Trump's order "Ending the Weaponisation of the Federal Government" as a factor in his instruction to the prosecutor. Damian Williams, the Biden-appointed federal prosecutor who brought the charges against the mayor, has resigned with the change in administration and an acting prosecutor is running the office. Williams was also the prosecutor behind the case filed

against a former Research and Analysis Wing (RAW) officer Vikas Yadav and another Indian, Nikhil Gupta, accusing them of plotting to have Khalistani leader Gurpatwant Pannun killed. Adams is a Democrat like Biden, but ran afoul of him with his criticism.. Although Adams has not switched parties, he hasn't criticised Trump either and has met with him and got an invitation to his inauguration,

Jordan sends 4,000 tents to Gaza

Amman, Feb 14 (IANS) : Jordan said that a convoy carrying more than 4,000 tents has arrived in Gaza to help provide safe shelter for families who have lost their homes amid the growing humanitarian challenges due to the war. The aid was sent by the Jordanian Hashemite Charity Organisation (JHCO) as part of Jordan's efforts to support the Palestinians affected by the difficult conditions they are going through, according to a statement by the organisation released on Friday.

The organisation said it will continue to provide all necessary support and relief to the people of Gaza in these challenging times, Xinhua news agency reported. JHCO emphasised that this aid reflects Jordan's steadfast commitment to supporting the people of Gaza through the uninterrupted land bridge delivering essential relief and humanitarian supplies.

The organisation reaffirmed that its humanitarian convoys will continue, driven by the humanitarian and fraternal duty to provide all necessary aid and relief to the people of Gaza during the current circumstances.

The Higher Committee for Reconstruction in Palestine delivered 4,500 tents to the JHCO on February 3 to be sent to the war-torn Gaza Strip.

The committee, which has been formed by the Jordanian Engineers and Contractors Association, has launched a campaign to support people in Gaza.

Head of the committee Ahmad Zo'ubi, said that the committee will deliver an additional 3,500 tents to JHCO next week and another 4,000 tents from China during this month, bringing the total number of tents to 12,000. He said that these efforts are part of the committee's commitment to supporting the steadfastness of the people of Gaza and alleviating their large-scale suffering in coordination with various official and charitable organisations to ensure the quick delivery of aid.

So far, Jordan has sent 24,891 tents to support displaced individuals, including 11,000 tents that were delivered since the latest humanitarian truce began.

Jordan, represented by the JHCO, has been actively sending relief aid including shelter materials, clothing, and other essentials over the past months to alleviate the suffering of Gaza's population.

To date, Jordan has dispatched 152 aid convoys, comprising 5,992 trucks carrying over 100,000 tons of humanitarian assistance, including food, shelter, and medical supplies.

BJP issues show-cause notice to Kirodi Lal Meena over phone tapping claims

Jaipur, Feb 14 (IANS) : Rajasthan unit BJP president Madan Rathore on Friday issued a show-cause notice to state Cabinet minister Kirodi Lal Meena, citing indiscipline over his phone tapping claims. The party has viewed Kirodi Lal Meena's statements as a breach of discipline and asked him to respond within three days. Kirodi Lal Meena has been making controversial statements that have repeatedly been troubling the party.

His actions were reported to the central leadership by both the Chief Minister's Office (CMO) and party officials, a party worker told IANS.

However, due to the Delhi elections, no immediate action was taken, he said. Sources indicate that state president Rathore consulted BJP national president J.P. Nadda over the phone before deciding to issue the notice. Rathore, meanwhile, is in Delhi to participate in the upcoming Parliament session.

WB school jobs case: SC reserves judgment on cancellation of over 25K appointments

New Delhi, Feb 14 (IANS) : The Supreme Court on Friday reserved its verdict on a batch of petitions, including the West Bengal government's appeal, filed against the Calcutta High Court's order cancelling 25,753 appointments in teaching and nonteaching posts made by the West Bengal School Service Commission (WBSSC) in 2016.

A bench headed by CJI Sanjiv Khanna and comprising Justice Sanjay Kumar reserved its decision after hearing the oral arguments of both sides. In an earlier hearing, the top court had directed the completion of pleadings and granted "one last opportunity" to the private respondents (i.e. individuals who had instituted writ petitions before the Calcutta HC) to file their counter-affidavits.





Illegal Bangladeshi citizen with fake Indian passport nabbed near Kolkata Mayor's office

Kolkata, Feb 14 (IANS) : An illegal Bangladeshi infiltrator along with forged Indian identity documents was arrested on Friday near the office of Kolkata Mayor Firhad Hakim within the Kolkata Municipal Corporation (KMC) premises.

The arrested person has been identified as Rafiqul Islam. A number of forged Indian documents, including birth certificates, AADHAR card and a fake Indian passport, have been recovered from his

possession. Sources said that Islam was spotted by the plain-dress cops posted at KMC offices loitering around at different sections within the corporation premises including the room of the mayor.

Finally, when he was challenged by the cops, Islam said that he is a resident of Chapra in Nadia district and he had come to KMC for the purpose of verification of some documents. This explanation created further

doubts in the minds of the cops on the necessity of coming to KMC for document verification despite being a resident of Chapra. Thereafter, the police detained him and started interrogating him. In the face of interrogation, Islam admitted that he is a resident of Bangladesh and he entered the Indian side after crossing the border illegally. He also admitted that he first arranged for his fake AADHAR and EPIC cards in Kolkata and on the basis of those arranged for his fake Indian passport.

Bihar Police arrests mastermind in Danapur jewellery shop heist case

Patna, Feb 14 (IANS): Bihar rection of the Senior Superintendent of Police has arrested two key accused, including the mastermind, in connection with the Jiva Jewellery Shop heist on Friday. The broad daylight heist occurred 11 days ago near Saguna Mor under the Danapur police station jurisdiction and had created a sensation in the state.

Advocates' delegation met Bihar Dy CM, submit budgetary demands

Patna, Feb 14 (IANS) : Ahead of the Bihar Budget 2025, a delegation of Patna High Court advocates, led by senior lawyer Yogesh Chandra Verma, met Deputy Chief Minister and Finance Minister Samrat Choudhary on Friday. The advocates submitted a memorandum outlining their key demands, seeking financial support and infrastructural improvements.

The delegation urged the state government to make budgetary provisions for better seating arrangements in 101 sub-divisional courts and 38 district courts to facilitate judicial work. The accommodation of lawyers inside court premises has long been a challenging issue for administrators in Bihar. Many advocates, especially

young and junior lawyers, struggle with proper seating arrangements, often managing with just a table and a chair to conduct their legal practice.

While senior lawyers have access to designated chambers, the majority of practising advocates face space constraints, making it difficult to work efficiently. This lack of infrastructure has been a longpending demand among the legal community, leading to repeated requests for government intervention. The delegation also de-



manded an annual financial allocation for the Advocate Association to support legal professionals and a monthly stipend of Rs 5,000 for new lawyers for the first five years of their practice. Increase in financial assistance from the

Advocate Welfare Trust-raising compensation from Rs 7 lakh to Rs 15 lakh in case of an advocate's demise.

Rajasthan HC reprimands state govt in Dhariwal's single-lease case

Jaipur, Feb 14 (IANS) : Rajasthan High Court on Friday strongly reprimanded the state government over delays in the 11-year-old single-lease case. The government had sought additional time to submit documents related to the case, prompting a sharp response from Chief Justice MM Srivastava. Expressing displeasure, Chief Justice Srivastava said, "First, you went to the Supreme Court to get an order for an early settlement of the case. Then, you seek more time here in the High Court." He further noted that the Supreme Court had already directed the case to be resolved within six months.

The next hearing has been scheduled for March 19. Earlier, the state government filed a fresh petition in the High Court, challenging the closure report that had given a clean chit to former minister Shanti Dhariwal and other officials. The government argued that the report was based on an incomplete and flawed investigation. To reassess the case, the government set up a high-level committee under retired judge R.S. Rathore. The committee's preliminary report pointed out serious lapses in the investigation and the filing of the closure report.

According to the findings, key documents and crucial evidence were overlooked, leading to an unfair conclusion. The Rajasthan government hence decided to correct these procedural errors and ensure a fair.

Paytm Money pays Rs 45.5 lakh fine to SEBI over regulatory lapses

Securities and Exchange Board of India (SEBI) on Friday passed a settlement order against Paytm Money after the company paid Rs 45.5 lakh to resolve allegations of regulatory violations.

The settlement order allows the financial services firm to avoid further legal proceedings related to the issue. The case originated from a show-cause notice issued by SEBI to Paytm Money on July 24, 2024, over non-compliance with the regulator's technical glitch framework. The regulator had accused the company of failing to adhere to key operational and regulatory guidelines designed to ensure smooth and secure trading operations.

One of the main concerns raised

Mumbai, Feb 14 (IANS) : The by SEBI was Paytm Money's inability to maintain the required 70 per cent threshold for generating timely alerts for critical assets.

> These alerts play a crucial role in protecting investor interests, especially during periods of market volatility. The failure to meet this requirement raised doubts about the company's risk management practices. Additionally, the markets regulator found that Paytm Money had not provided necessary documentation regarding the peak load on its systems during the inspection period. This raised concerns about the company's infrastructure and its ability to handle high trading volumes during market surges or technical issues.

India's CPI inflation falls to 5-month low of 4.31 pc in Jan

New Delhi, Feb 14 (IANS) : cent in November and 5.22 per India's retail inflation rate, based on the Consumer Price Index, fell to a five-month low of 4.31 per cent in January as prices of vegetables and pulses eased during the month bringing respite to household budgets, according to figures released by the Ministry of Statistics on Friday.

The easing of inflation reflects a steadily declining trend after having touched a 14-month high of 6.21 per cent in October. CPI inflation had declined to 5.48 per

cent in December. The food inflation at 6.02 per

cent in January 2025 is the lowest after August 2024.



India's auto sector not likely to face major impact due to US tariff hike

Indian automotive manufacturers are not likely to face any major impact due to US President Donald Trump's reciprocal tariffs as these companies sell their products largely in the fast-growing domestic market, according to analysts.

"OEMs (original equipment

"India is also a preferred partner of the US, and the only alternative to China for American automakers to source auto components," he added





Industrial production registered 3.2 per cent growth in Dec 2024 : Data

India's industrial growth, based on the Index of Industrial Production (IIP), was recorded at 3.2 per cent in December 2024, according to the data released by the Ministry of Statistics on Friday. The manufacturing sector, which accounts for more than three-fourths of the index of industrial production (IIP), posted a 3 per cent growth during December 2024.

The sector plays a key role in providing quality jobs to the young graduates passing out from the country's engineering institutes and universities.

Within the manufacturing sector, 16 out of 23 industry groups at

It includes 14,28,009 two-wheelers, 1,64,180 three-wheelers and 22,548 fourwheelers. The Ministry of Heavy Industries has implemented several schemes to strengthen the EV ecosystem and accelerate adoption of electric vehicle in the country. The production-linked incen-

tive (PLI) Scheme for Automobile and Auto Component Industry in India (PLI-Auto) was approved on September 23, 2021 for automobile and auto component industry for enhancing India's manufacturing capabilities for advanced automotive technology (AAT) products with a budgetary outlay of Rs 25,938 crore.

Seoul, Feb 14 (IANS) : The head of an investment consulting firm was sentenced to 25 years in prison here on Friday over a massive stock manipulation scheme that rocked local financial markets. The Seoul Southern District Court said it also ordered Ra Deok-yeon, the head of the unregistered firm, to pay a fine of 146.5 billion won (\$101 million) and a forfeit of 194.4 billion won. Ra was indicted on charges of pocketing 737.7 billion won from 2019 to 2023 by selling off the stocks of eight listed companies after raising their prices through fixing, reports Yonhap news agency.

Two of his accomplices, surnamed Byun and An, were sentenced to prison terms of six years and 3 1/2 years, respectively.

"The stock manipulation was unprecedentedly



large in scale," the court said in delivering the ruling. "Multiple innocent investors suffered irrecoverable losses." The court also said Ra denies the charges and shows no remorse despite having planned and led the crime. In another development, the Supreme Court here on Thursday upheld an appeals court ruling that overturned the TV media watchdog's 2020 decision to impose a six-month shutdown penalty on cable channel MBN over illegal financing and accounting fraud.

Maha Dy CM defers meeting to discuss annual plans for Raigad & Nashik districts

Mumbai, Feb 14 (IANS) : Maharashtra Deputy Chief Minister Ajit Pawar on Friday did not hold the District Annual Plan meetings for the financial year 2025-26 of these two districts. After the announcement of NCP minister Aditi Tatkare as the Raigad district guardian minister and BJP minister Girish Mahajan as the Nashik district guardian minister in January, Shiv Sena took strong objection that led to the stay given by Chief Minister Devendra Fadnavis on these appointments. As a part of the preparations for the upcoming state budget, which is expected to be presented on March 10 in the legislature, Pawar has been holding a series of meetings with departments. Pawar, who also holds the Finance Ministry portfolio, has also been meeting with district administration to discuss the annual plan for the fiscal year 2025-26. On Monday, Ajit Pawar held meetings of the Konkan and Nasik divisions. However, the meetings of Raigad and Nasik were not held as both the districts do not have a guardian minister as a result of the ongoing rift between NCP and Shiv Sena.

Maha Congress demands action in Somnath Suryavanshi's murder & Beed Sarpanch killing cases

Mumbai, Feb 14 (IANS) : Maharashtra Congress on Friday demanded the dismissal of the police officer responsible for Somnath Suryavanshi's Murder in Parbhani and the filing of charges against him.

The party further demanded strict action against the killers of Massajog sarpanch Santosh Deshmukh from Beed district. Maharashtra Congress chief Nana Patole said that in Parbhani and Beed incidents lives have been lost with the police's in-

Bengaluru, Feb 14 (IANS): city's traffic congestion, and we Demanding immediate rollback of the Metro fare hike, a BJP delegation met with the Metro MD M. Maheshwar Rao on Friday, condemning the steepest metro fare hike in the country.

Speaking to the media persons after the meeting, Bengaluru MLA Ravi Subramanya stated, "Metro is a public service sector, not a revenue-generating department. It was implemented to reduce the

He criticised the state government for already burdening the public with multiple price hikes and further increasing metro fares by 46 per cent. He also insisted that essential facilities should be provided at metro stations.

"The metro is meant for the public. Prioritising profits is not the right approach. The project was implemented to ease Bengaluru's traffic congestion, and even the central government has provided financial aid for this purpose. The fare increase is unfair," he stated. Subramanya demanded that the fare hike be withdrawn immediately and that proper parking facilities be provided at metro stations. He warned that if their demands are not met, protests will be held. Another Bengaluru MLA C.K. Ramamurthy stated that the BJP delegation met with the Metro MD to highlight the concerns of Bengaluru commuters.

"Metro fares in other states are

lower, but Bengaluru's fares have been increased significantly. The hike was implemented based on a committee report without discussing it with local MLAs, which is unacceptable," he said.

He also criticised the lack of basic infrastructure at metro stations, including toilets and parking facilities, and warned that if the fare is not reduced, protests will be launched.

The BJP Bengaluru Metropolitan Unit has demanded that the fare hike be scrapped. If an increase is necessary, it should be limited to 5 per cent, they suggested.

Patna, Feb 14 (IANS) : JD-U Chief Spokesperson Neeraj Kumar, has intensified its attack on Prashant Kishor's Jan Suraaj party, raising serious questions about its financial transparency and funding sources.

Kumar, along with JD-U leader Ajit Patel, accused Prashant Kishor of running a shadowy financial operation under the guise of political activism.

"Prashant Kishor calls himself the patron of Jan Suraaj, yet his name is missing from the Election Commission's official documents. This raises concerns about who actually controls the party," said Neeraj Kumar.

He further claimed that Jan Suraaj is not receiving direct political donations, but instead, funding is being funnelled

through an NGO - 'Joy of Giving Global Foundation'. Kumar said that this NGO received Rs 48.75 crore in the financial year 2023-24, with the largest donation of Rs 14 crore coming from Ram Setu Infrastructure Private Limited.

"Why are major donations for Bihar politics coming from companies based in Telangana and Hyderabad? Many of these companies have negligible capital but are donating crores. Frequent changes in their directors indicate possible money laundering," Neeraj Kumar alleged.

JD-U leaders compared Prashant Kishor's financial model to the East India Company, accusing him of attempting to bring corporate lobbying into Bihar's politics.

North Korea sent 200 long-range artillery pieces to Russia, additional supply likely

Seoul, Feb 14 (IANS) : North Korea is estimated to have sent about 200 pieces of long-range artillery to Russia and is likely to send more troops and weapons in support of Moscow's war against Ukraine, South Korea's defence ministry said on Friday. The assessment came after South Korea's spy agency earlier estimated the North to have sent some 11,000 troops to support Russia, of which 300 are believed to have been killed, with some 2,700 others wounded. "(North Korea) has provided some 11,000 troops, missiles, 200 pieces of long-range artillery and a substantial amount of ammunition and there is the possibility of (the North) additionally supplying troops, weapons and ammunition going forward," the ministry said in a briefing to the parliamentary defence committee. The ministry said the North is expected to double down on its weapons development this year, the final year in its five-year plan to develop sophisticated weapons, such as nuclear-powered submarines, spy satellites and solid-fuel intercontinental ballistic missiles (ICBMs). It raised the possibility of the North receiving Russia's technological assistance in exchange for military support, specifically mentioning technologies for nuclear-powered submarines and atmospheric re-entry technology for ICBMs.

Regarding the North's relations with the United States, the ministry said Pyongyang appears to be seeking to establish favorable circumstances for talks with Washington through a display of tough rhetoric and provocations, Yonhap news agency reported. The North has not responded to US President Donald Trump's expression of his intent to reengage with leader Kim Jong-un. Instead, it has conducted missile tests and unveiled Kim's visit to a nuclear-material production base, the ministry noted.

Trump formally announces 25 pc tariffs on all steel, aluminium imports

Washington, Feb 14 (IANS) :US President Donald Trump has announced plans to impose 25 per cent tariffs on all steel and aluminum imports coming into the United States "without exceptions or exemptions," raising concerns over its ramifications on South Korean and other exporters.

Trump signed two proclamations regarding the sweeping tariffs, while affirming a plan to announce "reciprocal" tariffs "over the next two days" -- duties on U.S. imports designed to match tariff rates that other countries impose on U.S. exports, reports Yonhap news agency.

During his first term, Trump imposed a 25 per cent tariff on steel imports and 10 per cent on aluminium imports on national security grounds.

Flood-damaged railway services resume in Bosnia

Railway services in southern Bosnia and Herzegovina (BiH) have fully resumed following a four-month suspension caused by severe flooding, the national railway operator said.

Flooding in early October heavily damaged railway infrastructure in the Jablanica area of central Bosnia, bringing operations to a halt. As of Friday, passenger train



Russia-US ties 'on verge of rupture': Russian Deputy FM



"However, the topic does exist, and as the situation becomes clearer, I believe there will be agreements on this matter and they will be announced ... at the appropriate time," Ryabkov said. At the same time, Ryabkov said that the new US administration has expressed interest in resuming dialogue with Moscow. "Trump's team, despite the conflicting statements made by him and his people, has at least shown interest in resuming dialogue with Russia, which was interrupted by

the Democrats," Ryabkov said. He reiterated that Moscow remains ready for dialogue, including discussions on a potential settlement of the Ukraine crisis, however, such dialogue would only be possible based on equality and mutually acceptable terms. "A small window of opportunity" has emerged under the Trump administration for normalising bilateral ties, he said, adding that Washington must decide whether to take advantage of this.

The use of ultimatums, provocative remarks, or attempts to pressure Moscow into accepting unreasonable demands will not be effective for Russia-US relations or dialogue between the two countries, he added, Xinhua news agency reported.

UN agency accuses paramilitary forces of obstructing aid delivery in Sudan

Khartoum, Feb 14 (IANS) : A United Nations agency on Friday accused the paramilitary Rapid Support Forces (RSF) of hindering delivery of humanitarian aid to the needy, particularly in the Darfur region in western Sudan. "The persistent restrictions and bureaucratic hurdles imposed by the Sudanese Agency for Relief and Humanitarian Operations (SARHO), an affiliate of the RSF, are preventing life-saving assistance from reaching those in desperate need," the UN Office for the Coordination of Humanitarian Affairs (OCHA) said in a statement.

Despite repeated commitments made by the SARHO, humanitarian actors continue to face obstruction, undue interference, and operational restrictions that contravene international humanitarian

law and the obligations outlined in the Jeddah Declaration of Commitment to Protect the Civilians of Sudan, it said.

The OCHA called on the SARHO to take immediate and concrete measures to engage with the humanitarian community as a whole to guarantee the delivery of urgent life-saving aid, simplify procedures for aid convoys by eliminating unnecessary approvals, and end interference in humanitarian operations, including demands for logistical support.

"The humanitarian community in Sudan calls on the SARHO to do its utmost to ensure the safety of humanitarian workers, assets and operations to ensure their ability to function without threats or coercion," the statement added. On August 13, 2023, the RSF announced the establishment of the

SARHO to coordinate with the international humanitarian community in Sudan regarding the delivery of humanitarian aid to the areas under its control, namely in the Darfur region, Xinhua news agency reported. Previous UN reports indicated that more than half of Sudan's population is now facing acute hunger. According to official statistics, 28.9 million people in Sudan need humanitarian assistance due to the ongoing war in the country. Sudan has been gripped by a devastating conflict between the Sudanese Armed Forces and the RSF since mid-April 2023, which claimed at least 29,683 lives and displaced over 15 million people, either inside or outside Sudan, according to the latest estimates by international organisations.

Raducanu set for Dubai Tennis Championships debut after accepting wildcard

Dubai, Feb 14 (IANS): Former US Open champion Emma Raducanu is set to make her first appearance at the Dubai Tennis Championships after the Brtiton was awarded a wildcard for the WTA 1000 event, scheduled from February 16 to 23.

Raducanu, currently ranked No. 60 in the world, recently competed in both the Qatar Open and Abu Dhabi Open after accepting wildcard entries into the main draw but lost in the first round on both occasions. She reached the last 32 of the Australian Open in January, where she was beaten in straight sets by five-time Grand Slam winner Iga Swiatek.

"It's fantastic to see Emma participating in the WTA Tour event in Dubai for the first time. It's clear for all to see that Emma possesses an enormous amount of talent and we look forward to watching her on court at this year's Championships," said tournament director Salah Tahlak. The world's top 10 women's players will take centre stage at the Championships this year as the WTA event celebrates its 25th anniversary.
