Telangana committed to implementing SC categorisation: CM Revanth

Chief Minister Revanth Reddy has affirmed the State government's dedication to executing the Supreme Court's ruling regarding the classifica-

Hyderabad, Feb.4 (NSS): tion of Scheduled Castes. During his address to the Assembly on Tuesday, Revanth Reddy informed members that the State government has established a commission comprising a single member to facilitate the implementation of the court's decision. This commission conducted a thorough study and presented a report, independent of any government involvement.

The single-member commission recommended a classification system. It visited various districts and produced a detailed report after engaging directly with the populace to gather their grievances. Additionally, some individuals submitted their concerns online to the commission.

The commission completed its report in just 82 days. It recommended allocating a 15 percent reservation for Scheduled Castes among three distinct groups. Furthermore, it proposed that a total of 58 sub-castes within the Scheduled Castes be categorized into

Groups 1, 2, and 3, as disclosed by Revanth Reddy.

The Commission in its report stated that 1 percent reservation should be provided to 15 subcastes in Group-1 (population 3.288 percent), 9 percent reservation should be provided to 18 SC sub-castes in Group-2 (population 62.74 percent), and 5 percent res-

ervation should be provided to 26 sub-castes in Group-3 (population 33.963 percent).

The Commission also recommended the implementation of roster points and creamy layer provision for the SC caste group, the Chief Minister said.

"Many political parties have seen the issue of SC categorisation as a vote bank and have not tried to provide a permanent solution to the problem. That is why, the Congress government has resolved to provide a permanent solution to this problem and bring justice to those who have been neglected and exploited for generations in society," he added.





KCR, KTR, Harish Rao didn't participate in caste census survey: CM Revanth

Chief Minister Revanth Reddy has stated that leaders from the BRS, including former Chief Minister K. Chandrashekar Rao, along with former ministers KT Rama Rao, Harish Rao, and Padma Rao, as well as BJP MP DK Aruna, did not take part in the caste census survey conducted by the State government. During his address in the Assembly, the Chief Minister noted that

Revanth Reddy questioned, "If the comprehensive family survey carried out by the previous BRS administration is considered an official document, why has it not been presented to the cabinet? He reaffirmed that the Congress party is committed to allocating 42 percent of seats to BCs in the upcoming local body elections and challenged both the BJP and BRS parties to accept this proposition.

BJP MP Nishikant Dubey seeks privilege motion against Rahul Gandhi over China charges in LS

New Delhi, Feb 4 (IANS): Bharatiya Janata Party (BJP) MP Nishikant Dubey has urged Lok Sabha Speaker Om Birla to initiate a breach of privilege motion against Congress MP and Leader of Opposition, Rahul Gandhi, for his comments in Parliament that Chinese troops were present on Indian soil.

Dubey accused the Congress leader of distorting facts and making baseless claims that "lower the prestige of our Republic".

Rahul Gandhi, while responding to the President's address during the Budget Session, launched a direct attack on Prime Minister Narendra Modi-led government, accusing it of failing to boost the manufacturing sector under the 'Make in India' initiative. He claimed this failure had led to the pres-

ence of Chinese troops on Indian soil, adding: "The reason China is inside our territory is because 'Make in India' has failed. India is refusing to produce, and I'm worried India is going to give up this revolution to the Chinese again."

Rahul Gandhi also raised concerns about unemployment, alleging that India had handed over production jobs to China.

In a letter to Lok Sabha Speaker Om Birla, Dubey slammed the Congress MP for making "an attempt to ridicule our country" and demanding action against the Leader of Opposition, for misleading Parliament.

He argued that Rahul Gandhi "shamelessly distorted historical and substantive facts" in his speech.

Families try to come to terms with loss; survivor recalls moments leading up to Maha Kumbh stampede

fter Prayagraj witnessed a stampede at the Maha Kumbh Mela early on Wednesday morning, leaving at least 30 people dead and around 60 others injured, people were still coming to terms with their loss on Thursday. Some recalled moments leading up to the stampede that left them separated from their groups. Among the deceased, four victims were from Uttar Pradesh's Ballia district. While two of the deceased hailed from Nasirabad, the other two victims were from the Nagra police station area. The stampede occurred at the mela ground when an overwhelming crowd surged towards Triveni Sangam for the holy dip on the occasion of Mauni Amavasya, according to Uttar Pradesh DIG Vaibhav Krishna. Dilip Patel, a grieving relative, recalled the loss of his sister-in-law and niece in the tragedy. "Our sister-in-law and niece are no longer with us. They had gone to Prayagraj for the holy dip. My niece was just 12 years old, and my sister-in-law was 35," he told IANS. Durgesh Singh, a resident of the Nagra police station area, also mourned his loss. "My sister-in-law, Rinki Singh, went with 12 to 13 people and lost her life in the stampede," he told IANS. The tragedy extended beyond Ballia, claiming the life of Nankan Kori, a resident of Gonda. His nephew recounted how Nankan had travelled to the Maha Kumbh with 12 family members and hundreds of others from the Gonda Gram Sabha.

"When the stampede broke out, my uncle got separated from his companions. After the situation was brought under control, his companions started searching for him. Hours later, they found him in a hospital in an injured state, but the doctors declared him dead," said Betu Lal, Nankan's nephew. The administration arranged an ambulance to transport Nankan's body back to Gonda, where his family is inconsolable.

"He was brought to the hospital by the police, but it was too late. The administration helped us take his body home," Betu Lal added.

Amidst the tragedy, a survivor of the stampede shared her harrowing experience with IANS.

"When we proceeded towards the Sangam, a stampede occurred. Out of our group of 12 people, only I am here. The rest are missing — we all got separated," she said. She described the chaotic moments leading up to the disaster. "People were all passing through the same place, leading to collisions. I came from Ballia and spent the night on the road. I don't know how I will return or what happened to the others in my group," she added. Authorities are investigating the circumstances that led to the deadly stam-

As soon as the discovery was made, hundreds of villagers gathered at the site, grief-stricken and enraged over the suspected murder. Upon receiving information, local police from Gawan police station arrived at the scene.

Fresh tripartite talks on opposition to creation of 7 Manipur districts held

meeting between the **L** Centre, Manipur government, and the United Naga Council (UNC), over the Naga body's demand for rollback of the "arbitrary creation" of seven new districts in the state, discussed the issue in detail on Thursday, officials said.

A senior Manipur Home Department official said that after the threadbare discussion in the meeting, it was mutually agreed that a proposal would be presented by the representatives of the state government in the next round of tripartite meetings which would be held in April.

In Thursday's meeting, held in Naga-dominated Senapati district, Ministry of Home Affairs (MHA) advisor, North East Affairs, A. K. Mishra, Manipur Chief Secretary

crucial tripartite Prashant Kumar Singh and Home Commissioner N. Ashok Kumar, four Naga community leaders including UNC's President N.G.Lorho and General Secretary Vareiyo Shatsang were present. The previous round of tripartite talks, held on November 29 last year, did not yield any result.

> Those controversial seven districts were created on December 8, 2016, by the then Congress government led by three-term Chief Minister O Ibobi Singh (2002-2017) amid opposition from the UNC, the apex body of Naga tribes in Manipur.

> The UNC has been strongly opposing the creation of the seven new districts, claiming that those districts encroached upon the ancestral territories of the Nagas.

> The Congress government had then asserted that the seven new districts were created aimed at administrative convenience and to better serve the people.



The representatives of the Manipur government in the previous meetings expressed an inability to present a concrete proposal in view of certain difficulties. The UNC in October last year temporarily suspended its 48-hour shutdown after the MHA called for a tripartite meeting to discuss the issue. The UNC organised a series of agitations demanding the rollback of the "arbitrary creation" of seven new districts in December 2016 and the reinstatement of the status quo. It had, on September 11 last year, issued an ultimatum to Union Home Minister Amit Shah for redressal of the pending issue of "arbitrary creation" of

seven new districts in Manipur in 2016 and warned of intense agitation if the matter was not resolved within 15 days.

The Naga body claimed that the seven new districts were created "dishonouring" the four memoranda between the government of Manipur and the Naga people besides the assurance from the Centre in 2011.

Naga people mostly inhabit six Manipur districts Tamenglong, Chandel, Ukhrul, Kamjong, Noney, Senapati, which are along the Nagaland and Myanmar bor-

Three cyclones potentially developing across Australia: Bureau of Meterology

ustralia's Bureau of Meteorology (BoM) has warned that as many as three cyclones could form off the country's north coast within days. According to the BoM's tropical cyclone seven-day forecast, five tropical low storms could develop across northern Australia in the coming days, reports Xinhua news agency.

Of those, it said that three have at least a moderate 25-per cent chance of reaching cyclone strength between Sunday and Wednesday. Tropical lows are declared cyclones by the BoM when average wind speeds exceed 63 km per hour.

It said that a tropical low off the northwest coast of Western Australia in the Indian Ocean has the highest chance of reaching cyclone strength and could increase thunderstorm activity in the area.

The other two could develop in the Gulf of Carpentaria, the body of water between the Northern Territory and the northern parts of Queensland, and in the Coral Sea off Queensland's northeast coast.





Gujarat Governance Model offers best practices that can be replicated: Jitendra Singh

nion Minister Jitendra Singh said on Thursday that the "Gujarat Governance Model" offers several best practices which can be successfully replicated elsewhere, too. Speaking at the National Conference on Good Governance here, the minister recalled that many of the governance innovations successfully implemented at the Central level were first introduced in Gujarat under Prime Minister Narendra Modi's leadership as Chief Minister.

Addressing a pan-India audience of policymakers, senior bureaucrats, and governance experts, Jitendra Singh praised the transformation in governance over the last decade. "This transformation did not happen overnight. Many of the reforms introduced at the national level were first tested and perfected in Gujarat, and today they are being replicated across the country," he remarked. Jitendra Singh underscored the

fundamental shift in governance culture under Prime Minister Modi, which has taken policymaking beyond the traditional administrative strongholds of Delhi and into various regions of the country. He cited the Prime Minister's directive to decentralise governance by ensuring that major policy discussions, conferences and outreach programmes are held in different parts of the country and not necessarily in Delhi.

He also referred to the evolution of India's administrative framework, recalling how Sardar Patel envisioned a robust bureaucracy as the 'steel frame' of India, a vision that has been further refined through PM Modi-led government's approach of 'Maximum Governance, Minimum Government.'

He pointed to landmark reforms, such as the scrapping of nearly 2,000 obsolete laws, the elimination of the requirement for attested

documents and the removal of interviews for junior-level government jobs as measures that have streamlined bureaucracy and enhanced transparency.

One of the standout examples of governance innovation, Jitendra Singh noted, was Gujarat's early implementation of the 24-hour rural electrification scheme in the early 2000s.

"At a time when electricity supply was erratic across the country, Gujarat pioneered uninterrupted rural electrification, a model that was later scaled up at the national level," he said.

Recounting the scale of transformation, Jitendra Singh spoke about how electricity shortages used to be commonplace in many parts of India.

"There was a time when people clapped when the lights came back on after an outage. Today, power cuts are rare, and uninterrupted electricity is an expectation, not a luxury.

South Africa calls for more efforts to end Congo conflict after 13 soldiers killed

South African President Cyril Ramaphosa on Tuesday called for intensified diplomatic efforts to resolve the ongoing conflict in the eastern Democratic Republic of the Congo (DRC) following the deaths of 13 South African peacekeep-

The South African troops, part of the Southern African Development Community (SADC) Mission in the DRC (SAMIDRC), have been killed in escalating fighting involving the March 23 Movement (M23) rebel group and the Armed Forces of the DRC since last week. In a statement issued on Wednesday, Ramaphosa extended his condolences to the families of the fallen peacekeepers, calling on the country to rally behind its soldiers "who have dedicated their lives to bringing peace on our continent."

The President reaffirmed

Cape Town, Feb 4 (IANS): South Africa's commitment to of inclusive development and peace, urging all parties to respect the DRC's territorial integrity and engage in diplomatic processes to end the ongoing conflict.

"We call on all parties to this conflict to fully embrace the current diplomatic efforts that are aimed at finding a peaceful resolution," he said. "We must silence the guns on our continent for the attainment

prosperity." Ramaphosa welcomed the United Nations Security Council's recent position on the situation in the DRC, which calls for an immediate cessation of hostilities, the reversal of territorial expansion by the M23, the withdrawal of external forces from the DRC.

The report, 'Community Participation and Livelihoods', focuses on 10 key guiding principles for community-led conservation strategies, while the study 'Potential for Community-Based

Wildlife Management in Central Asia' presents real-world insights into how community-led initiatives can achieve biodiversity conservation and sustainable livelihoods. Indigenous peoples and local communities are custodians of over a third of the world's most important places for biodiversity and play a vital role in the conservation of migratory species and their habitats.

Integrating their traditional knowledge and practices with modern wildlife management approaches can lead to successful management, conservation, and sustainable use of wildlife and their habitats.

"For many migratory species of wild animals, having the engagement and expertise of local communities and traditional knowledge is vital for effective conservation. We are very pleased to issue these two reports on the critical role that local communities can play in ensuring that migratory species will continue to thrive for generations to come," said Amy Fraenkel, CMS Executive Secre-

Hamas frees eight hostages in Gaza; Israel delays prisoner release

Jerusalem, Feb 4 (IANS): Palestinian militants in Gaza, led by Hamas, released eight hostages, three Israelis and five Thais, on Tuesday. But Israel delayed the release of 110 Palestinian prisoners in a swap agreed under the ongoing temporary ceasefire, citing chaotic scenes during the handover. The hostages were released in two groups. Agam Berger, a 20-year-old Israeli soldier, was freed first. Video showed her, wearing a khaki uniform, emerging from damaged buildings in Jabalia, northern Gaza, escorted by Hamas militants, before walking to a Red Cross vehicle. She was then taken to a compound outside



Gaza to reunite with her parents. Later, in Khan Younis, southern Gaza, two Israelis, Arbel Yahoud, 29, and Gadi Mozes, 80, along with the five Thai nationals, were handed over to the Red Cross. Footage showed chaotic scenes as hundreds of Gazans gathered, and militants struggled to control the crowd and clear a path for the hostages.

South Korea: Black boxes retrieved from fire-destroyed Air Busan plane; French team to join probe

Seoul, Feb 4 (IANS): South Korean authorities on Tuesday retrieved black boxes from an Air Busan passenger plane that caught fire at a South Korean airport earlier this week, as they sought safety measures in the run-up to launching a probe, the land ministry said. On Tuesday, the Airbus plane operated by budget carrier Air Busan and bound for Hong Kong caught fire at Gimhae International Airport in the country's southern city of Busan before takeoff. All 176

people on board were safely evacuated using an escape slide, though seven suffered minor injuries, Yonhap news agency reported. The cause of the blaze was not yet known, though some raised the possibility of the fire having been caused by a portable battery or other items stored in an overhead bin. The aviation and railway accident investigation board under the ministry held a meeting with local police, firefighting agencies and the National Forensic Service on Thursday to discuss how to ensure safety in conducting a joint probe, as 35,000 pounds of fuel was stored at the wings of the plane. They are expected to decide on detailed plans for investigation after visiting the scene to check relevant circumstances and safety measures later in the day.

Bengaluru, Feb 4 (IANS): Karnataka government on Tuesday conveyed the second highlevel meeting on issues faced by the public due to the highhandedness of microfinance institutions.

The meeting was chaired by Chief Minister Siddaramaiah where it was decided to review the provisions of the proposed Ordinance and implement a stronger law.

SC modifies earlier directions on appointment of ad hoc judges in HCs

New Delhi, Feb 4 (IANS): The Supreme Court on Tuesday modified an earlier apex court order regulating the timeline and conditions of appointment of ad hoc judges in High Courts under Article 224A of the Constitution.

A Special Bench, headed by CJI Sanjiv Khanna and comprising Justices B.R. Gavai and Surya Kant, stressed the filing of vacancies to tackle the rising backlog of pending cases.

Article 224A empowers the President to make temporary appointments of judges in case the number of judges in a particular High Court is insufficient. The bench kept in abeyance the earlier observations which required that appointment of ad hoc judges should not be made unless 80 per cent of the sanctioned strength is already working or recommended.

It directed that the strength of ad hoc judges, who will primarily act as puisne judges on criminal benches, should not exceed 10 per cent of the sanctioned strength.

Tata Chemicals' revenue from operations declined by 3.8 per cent to Rs 3,590 crore in Q3 compared to Rs 3,730 crore in the same quarter last year (Q3 FY24).

The company also saw a sharp decline in its operating performance, with EBITDA falling by 19.9 per cent to Rs 434 crore from Rs 542 crore a year ago.

The EBITDA margin for the quarter stood at 12.1 per cent, down from 14.5 per cent in the previous year's corresponding quarter. EBITDA refers to earnings before interest, tax, depreciation, and amortisation. The company's financials also reflected a rising debt burden, according to its stock exchange filing.

Tata Chemicals' gross debt increased by Rs 810 crore on-year at Rs 6,722 crore as of December 31, 2024.

Meanwhile, net debt rose by Rs 952 crore to Rs 5,329 crore, largely due to lower EBITDA and higher working capital requirements across its operations in the US, Kenya, and India.

India's fiscal roadmap: Strong growth and stability despite tax cuts, says S&P Global

New Delhi, Feb 4 (IANS): India's Union Budget aligns with the expectations of steady fiscal consolidation, reinforcing a positive outlook on the country's sovereign credit ratings, according to a report on Tuesday. The central government revised its fiscal deficit estimate to 4.8 per cent of GDP for the year ending March 31, 2025, slightly lower than the earlier projection of 4.9 per cent in the Union Budget presented on February 1.

For fiscal 2026, the govern-

ment has set an even lower deficit target of 4.4 per cent aligning with a commitment to financial discipline and sustainable growth.

Despite adjustments in income tax thresholds and a gradual normalisation of economic growth, India is expected to achieve these fiscal targets, the S&P Global Ratings report

The government's financial position is supported by strong dividends from the Reserve Bank of India and efficient capital expenditure management. Additionally,



India's fiscal discipline is expected to improve as state government deficits gradually decline over the coming years, the report added. According to S& P Global, the fiscal 2026 budget is designed to stimulate growth, prima-

rily by boosting domestic demand. Tax reductions for households will provide more spending power, while the government continues to emphasise investment-led expansion and agricultural reforms.

Operating profits of offshore rig operators to surge by 30-35 per cent in 2025-26: Crisil

New Delhi, Feb 4 (IANS): Indian offshore rig operators will see their operating profits surge 30-35 per cent in the next financial year, after a 25-30 per growth in the current fiscal year, according to a Crisil Ratings report released on Tuesday. "This increase will be on the back of continued renewal of rig contracts at more than double their existing day rates for expiring contracts bagged 3-4 years back on sustained demand amid a muted rise in global rig supply," the report said. The average day rates are expected to improve to around \$56,000 this fiscal and to \$67,000 next fiscal, 1.5-1.7 times higher than the average day rates witnessed over fiscal 2021-2024 and thus drive sharp improvement in operating profits, it observes.

This will help strengthen the debt metrics and credit profiles of rig operators in the absence of any significant investment towards new rig purchases, the report further stated. The Crisil Ratings study is based on domestic jack-up rig operators accounting for around 50 per cent of the domestic supply.



Hiding failures, blaming others is Kejriwal's mantra: BJP's Hitesh Jain

Mumbai, Feb 4 (IANS): Hitesh Jain, Vice President of the Mumbai BJP, has launched a scathing attack on former Delhi Chief Minister Arvind Kejriwal, accusing him of consistently misleading the public and failing to deliver on his promises over the past decade. He said hiding failures and blaming others is his working style.

Jain criticised Kejriwal for making baseless allegations against the Haryana government regarding the contamination of Yamuna water and for shirking his own responsibilities as the leader of the national capital. Sivagnanam and Justice Hirnamay Bhattacharya and it rejected the petition on the grounds that the court cannot interfere with a scheme floated by the state government for public interest.

Swasthya Sathi scheme was introduced in 2016 after the Mamata Banerjee-led Trinamool Congress regime in West Bengal was elected for the second term. Under the scheme, each family in the state is entitled to health insurance coverage of up to Rs 5,00,000 a year.

However, the opposition BJP has frequently complained that a similar Central scheme, named Ayushman Bharat, is deliberately not being allowed by the state government to be operational in West Bengal.

Nagaprasanna passed the order after the submissions. Senior counsel Prabhuling Navadgi, representing Ravi, said that as the incident occurred on the floor of the Legislative Council, his client will have exemptions. He argued, "The legislature has taken note of the incident and given a verdict. Despite this, can an institution like the Criminal Investigation Department (CID) investigate the matter?" The bench questioned what if the subject on which comments were passed had no con-

nection with the legislature. Counsel Prabhuling Navadgi referred to the Supreme Court verdict in Sita Soren vs Central government case and stated as per Article 194 (2), that when members are present in the House, they are under the jurisdiction of the laws of the state legislature. It will not differ as per the situation. Article 194 (2) allows a legislator to speak without fear. The legislators will have full powers within the House in this regard.

The bench questioned at this juncture whether it allows complete liberty to speak anything. Can the alleged statements be made?

The counsel replied that even after the remarks were considered to be denunciations under the law, the legislature has the jurisdictional power to take a decision in this regard and no other outer agency has this right.

CRPF jawan kills wife, shoots himself dead in Bhopal

Bhopal, Feb 4 (IANS): A Central Reserve Police Force (CRPF) jawan allegedly shot his wife dead before killing himself in his rented flat in Bhopal's Misrod area, police said on Tuesday. The incident occurred on Wednesday-Thursday intervening night at Green Park colony.

The CRPF jawan was identified as Ravikant Verma. The officials said that he dialled the police control room and informed them that he had shot his wife, Renu Verma around 1.30 a.m. on Wednesday.

Upon receiving information, a team from Misrod police station rushed to the spot and found the CRPF jawan and his wife lying in a pool of blood in their house.

The couple were living with their two children -- a six-year-old son and a two-and-ahalf-year-old daughter.

Upon arrival, officers found the two children weeping in one room, while the bloodstained bodies of 35-year-old Ravikant Verma and 32-year-old Renu Verma lay in another.





Siddhivinayak temple treasurer reveals reason behind dress code directive

Mumbai, Feb 4 (IANS): As the iconic Siddhivinayak Temple in Mumbai introduces a new dress code starting Tuesday, Acharya Pawan Tripathi has opened up about the reasons behind the decision.

The temple management has made it clear that visitors wearing skirts, jeans or revealing outfits will be denied entry.

In an effort to maintain decorum and respect at one of Mumbai's most revered religious sites, the temple will offer clothing to visitors who do not meet the dress code, allowing them to cover up before they can proceed for 'darshan (the viewing of the deity)'. Acharya Pawan Tripathi explained the motive behind the rule saying, "Siddhivinayak Temple is a significant centre of faith for Sanatanis and Ganesh devotees from all over the world. Every day, lakhs of devotees come seeking blessings,

and their wishes are fulfilled. "However, some devotees suggested that certain visitors arrive dressed inappropriately, with clothing that is indecent. To address these concerns, the trust Board and temple administration decided to implement this rule to ensure everyone comes dressed in a respectful and dignified manner."

Tripathi emphasised the importance of proper attire when visiting a holy place like Siddhivinayak, noting that while there are no restrictions on specific types of clothing, visitors are expected to wear full attire.

Will make proposals based on NE's

socio-economic & geographical situations: Arvind Panagariya

Agartala, Feb 4 (IANS): The 16th Finance Commission while making its recommendations would keep in mind the socio-economic and geographical situations of the northeastern states, the panel chairman Arvind Panagariya said here on Tuesday. Panagariya added that like other states, the northeastern states also demanded to increase the tax devolution from the Centre from the present 41 per cent while the Tripura government has demanded an increase by 50 per cent. Briefing the media on the second day of his visit, Panagariya said that Tripura is the 17th state in the country and the Commission has already visited and heard the demands and views of the state governments. "Out of eight northeastern states, the Commission is yet to visit Mizoram and Arunachal Pradesh," he said.

Appreciating the satisfactory forest cover of the northeastern states, the Finance Commission Chairman said that due to the hilly nature of the region like other mountainous states, higher costs are required in the region for building infrastructure or ferrying goods.

He said for the core Centrally Sponsored Schemes (CSS), the funding pattern for the northeastern states in the ratio of 90:10, where 90 per cent of the total expenditure was borne by the Union government and 10 per cent contributed by the state concerned while for the other states the ratio is 60:40 ratio. The Commission would make its recommendations based on the population ratio by October this year, the chairman said, adding that as per the 15th Finance Commission the tax devolution ratio was 59 per cent for the Union government and 41 per cent for the 28 states of the country. The panel chairman asserted that Tripura's economy is well managed and the state's finances are in a sound position.

The finance panel also held a meeting with the Tripura Chief Minister Manik Saha. Chief Secretary J K Sinha, Finance Secretary Apurba Roy and top officials of all departments were also present in the meeting.


K'taka govt to implement stronger law against microfinance menace

Bengaluru, Feb 4 (IANS): Karnataka government on Tuesday conveyed the second highlevel meeting on issues faced by the public due to the highhandedness of microfinance institutions.

The meeting was chaired by Chief Minister Siddaramaiah where it was decided to review the provisions of the proposed Ordinance and implement a stronger law.

"A decision has been made to review the provisions of the ordinance formulated to prevent harassment by microfinance institutions and to implement a stronger law as soon as possible. A team of senior officials from the Law and Finance Departments will be formed for this purpose," said Siddaramaiah.

He added that it was also decided that the law must be completely constitutional and free from any loopholes, adding that a strong law is being drafted to prevent the harassment faced by borrowers and to regulate forced recoveries by lenders. "The law will grant greater authority to the police. Ombudsmen will be appointed, and strict punishments, including non-bailable offences and heavy penalties, will be imposed on those who engage in inhumane and forceful loan recoveries," the Chief Minister said. He further assured that a stringent law is being enforced to prevent harassment by unregistered moneylenders. "The existing legal framework already has provisions to control harassment by microfinance institutions. The question arises as to why they are not being effectively implemented. The police must take suo motu action and register cases without waiting for complaints," he said.



Kolkata, Feb 4 (IANS): A trial court has slapped a show-cause on Central Bureau of Investigation (CBI) for procedural lapses in passing on information to the court about West Bengal government's nod for framing charges and trial process against former R.G. Kar principal Sandip Ghosh in the case related to financial irregularities in the institution.

Heavy snow intensifies in eastern Japan

Tokyo, Feb 4 (IANS): Heavy snowfall is expected to continue through the early morning of Tuesday in eastern Japan as a strong winter pressure pattern and cold air bring intensified snowfall, according to the Japan Meteorological Agency (JMA). Due to the prevailing winter pressure pattern, snowfall has intensified across northern and eastern Japan. As of 11 am local time, the snowfall in the past six hours reached 23 cm in Nishiaizu, Fukushima Prefecture, 22 cm in Oguni, Yamagata Prefecture, 17 cm in Ashibetsu, Hokkaido, and 16 cm in Nagahama, Shiga Prefecture. Snow clouds are expected to move further south, bringing in-

termittent heavy snowfall to

Niigata Prefecture and the Hokuriku region through early Tuesday, Xinhua news agency reported. Authorities have warned of potential disruptions to transportation and urged caution against avalanches and other snow-related hazards.

Earlier this month, heavy snow hit Sea of Japan coastal areas in northern, central and western Japan, disrupting bullet train operations and forcing the closure of some sections of expressways and national roads.

On January 10, snow forced the temporary suspension of Yamagata Shinkansen bullet train services between Fukushima Station in the northeastern prefecture of Fukushima and Shinjo Station in another northeastern prefecture of Yamagata, affecting 12 inbound and outbound trains and some 1,600 people.

Trains on the Tokaido Shinkansen Line also ran at reduced speeds between Nagoya and Shin-Osaka stations and delays were experienced also on the Sanyo Shinkansen Line, the train operators stated. The JMA had also revealed that the country's average temperature in 2024 was the highest on record, driven by global warming and westerly winds.

The average temperature from January through December 2024 was 1.48 degrees Celsius higher than the mean temperature for the 30-year period through 2020, marking the biggest difference since comparable data became available in 1898 and surpassing the previous year's record of 1.29 degrees Celsius.



Quran burner Salwan Momika shot dead in Sweden, five arrested

Stockholm, Feb 4 (IANS): daily Dagens Nyheter. According Salwan Momika, the 38-year-man who held several demonstrations in Sweden and was accused of burning the Quran, has been shot ing in Hovsjo at 11:11 pm, local dead in the city of Sodertalie in Stockholm County in east central Sweden, Swedish media reported on Tuesday. Momika was allegedly shot dead while he was conducting a live broadcast on social media from his apartment in Hovsjo late on Wednesday, a day before a verdict was scheduled to be announced by the Stockholm District Court in an incitement case against him. "I can confirm that five people have been arrested, suspected of murder," prosecutor Rasmus Ohman was quoted as saying by Sweden's leading

to the spokesperson for the Stockholm Police Region, the police received a report of the shoottime. The newspaper detailed that the crime scene was investigated overnight and the apartment building remains cordoned off on Thursday with several police officers on site. It was reported that drones have also been sent up over the area. "The police have been questioning me and they confirmed that he has died," Salwan Najem, a friend of Salwan Momika, told Swedish state broadcaster SVT.

Najem, who said that he has been told "you're next", had also spoken during the night with

Momika's girlfriend. "She started crying and said they killed him," Najem told SVT. The desecration of the Quran had sparked an angry reaction from

several countries, including Saudi Arabia, which strongly condemned the burning of a copy of the Islamic holy book in the Swedish city of Malmo by Momika, an individual of Iraqi origin, in October 2023.

The Saudi Foreign Ministry had "reiterated the Kingdom's rejection of such flagrant acts," and said such a move had inflamed the feelings of millions of Muslims worldwide. Momika had allegedly torn pages of the holy book and also burnt it in full public view during demonstrations.

New Zealand sets second international climate target

Wellington, Feb 4 (IANS): New Zealand on Tuesday announced its second international climate target under the Paris Agreement of reducing emissions by 51 to 55 per cent by 2035, compared to 2005 levels. The target must be achieved by the end of 2035 and builds on the initial target of a 50 per cent reduction by 2030, a requirement under the Paris Agreement, the global climate treaty seeking to limit global warming to 1.5 degrees Celsius, to set Nationally Determined Contributions for reducing greenhouse gas emissions, said Climate Change Minister Simon Watts. The minister said the target was "both ambitious and achievable", reinforcing New Zealand's commitment to the Paris Agreement and global climate action.

"Meeting this target will mean we are doing our fair share towards reducing the impact of climate change, while enabling New Zealand to be stronger and thrive in the face of a changing climate," he said



New Zealand can focus its efforts on the actions that will make the biggest difference towards reaching the net zero 2050 target, with Thursday's new target bringing the country's international and domestic climate change commitments into line, Watts added.



No survivors yet of mid-air Washington DC collision

Washington, Feb 4 (IANS) : No survivors have yet been found of American Eagle Flight 5342 that collided with a US Army Black Hawk helicopter near the Reagan National Airport in Washington DC Tuesday night.

Both aircraft fell into the Potomac river.

The plane was carrying 60 passengers and four members of the crew while the helicopter had three service members. Rescuers had pulled out several bodies from the icy cold water of the river till early Thursday morning, but no survivors. The temperature of the water in the river was dangerously low around 0 degree celsius.

NBC's Washington affiliate has reported rescuers have recovered 30 bodies from the river. The plane was carrying passengers from Wichita in the state of Kansas to the National Airport. DC authorities have said the plane had broken into pieces and the helicopter was found upside down in the river. Rescue helicopters hovered over the river with flood lights as boats and rescuers combed the river for survivors and bodies. The collision reportedly took place around 8:47 pm, local time. The Army helicopter was a UH-60 Black Hawk on a training flight, US military officials have said. It was assigned to Bravo Company of the 12th Aviation Battalion, which operates out of Davison Army Airfield at Fort Belvoir, in nearby Virginia. Two renowned former Russian figure skaters were on board the passenger plane, the Kremlin has said according to reports.

American woman refuses to leave Pakistan, sits outside lover's house in Karachi

Karachi, Feb 4 (IANS): In a bizarre love story that has gone wrong, Onijah Andrew Robinson, an American national, has refused to leave Pakistan as her 19-year-old lover in Karachi failed to get his family's approval for marriage. Robinson refused to take a flight back home on Tuesday and created a major scene at the Karachi International Airport, first refusing to undergo immigration procedures and then later refusing to board the Qatar Airways' flight to New York. The entire drama eventually led to the flight being delayed by nearly one hour.

The 33-year-old had travelled from the United States to Pakistan in October to get married to her online lover Nidal Ahmed Memon. Robinson states that while the boy agreed to marry her, his family refused and relocated to a new place from their Garden area residence in Karachi city. Abandoned by her lover, the American woman had been sitting outside his house since then, refusing to go back to America and demanding a compensation of at least \$3,000 per week along with a Pakistani citizenship.

Australian PM labels caravan filled with explosives in Sydney as 'act of terrorism'

Canberra, Feb 4 (IANS): on January 19, reports Xinhua Australia's Prime Minister Anthony Albanese has agreed with police assertion that a caravan full of explosives in Sydney was an act of terrorism. Authorities in the state of New South Wales (NSW) announced on Tuesday night that the caravan filled with explosives was found in the suburb of Dural -- about 25 km northwest of central Sydney --

news agency. Speaking at a press conference, NSW Police Deputy Commissioner David Hudson said that a major investigation had been launched into whether the explosives were intended to be used in an antisemitic attack. NSW Premier Chris Minns labelled the caravan filled with explosives as an act of terrorism.





Chad announces full pullout of French troops

N'djamena, Feb 4 (IANS): Chad on Tuesday announced a full withdrawal of French troops from the Central African country.

"The three bases of French elements in Chad have all been handed over to the Chadian national army," Chadian Army spokesman Chanane Issakha Acheikh said in a statement. "The very last one has just been handed over today."

If Rohit, Kohli perform well, it will benefit India in Champions Trophy: Raina

New Delhi, Feb 4 (IANS): With just a couple of weeks left for the ICC Men's Champions Trophy 2025, former India batter Suresh Raina shared his thoughts on how crucial star batter Virat Kohli and skipper Rohit Sharma's form will be for the upcoming mega event and said that if the duo perform well, then India's campaign will benefit immensely.

Rohit and Kohli are two of the three surviving members from India's successful Champions Trophy side that won the final against England at Edgbaston in 2013.

But the current form of the two stalwarts of India's batting unit are a bit shaky.

The veteran duo endured a tough time during the 2024-25 Border-Gavaskar Trophy, which India lost 3-1. Rohit managed only 31 runs in five innings, while Kohli contributed just 190 runs in nine innings. In response to their struggles, both players have returned to domestic cricke to regain form ahead of the major tournament. But unfortunately, they could not get back among the runs. Rohit scored 3 and 28 in Mumbai's

match against J&K, while well, India's ICC Men's Champi-Kohli was bowled for 6 in Delhi's game against Railways.




Joel Paris returns to Perth Scorchers for BBL 15 after stellar season with Stars
