#### CM Revanth asks Congress MLAs to ensure victory in local body elections

**Hyderabad, Feb 6 (NSS):** Chief Minister Revanth Reddy and AICC Telangana Affairs In-charge Deepadas Munshi have urged the Congress MLAs to ensure that both newly-appointed and established leaders collaborate effectively to secure victory in the upcoming local body elections.

They emphasized that the party's success in local bodies hinges on the coordinated efforts of all leaders within

their respective constituencies. On Thursday, the Chief Minister convened a meeting with Congress MLAs and Ministers at the Dr. MCR HRD Institute of Telangana, which lasted over three hours. During the discussion, Revanth Reddy noted that the BC

caste census was conducted in line with the Kamareddy Declaration, while opposing parties have been unnecessarily raising objections regarding this matter.

It was advised that each MLA should launch a counter-initiative at the constituency level in re-

sponse to the BC census survey. The Chief Minister affirmed the Congress government's commitment to the categorization of Scheduled Castes and expressed readiness to implement this in Telangana.



## PM Modi attacks Congress for 'family-first', polarisation

New Delhi, Feb 6 (IANS): Prime Minister Narendra Modi on Thursday trained his gun at the Congress for pursuing politics of "family first and polarisation" and adopting a "predatory approach" and harming its allies. ### CM Chandrababu Naidu holds cabinet meeting

Amaravati, Feb 6 (NSS): Chief Minister N Chandrababu Naidu today chaired a cabinet meeting in Amaravati on Thursday. Several key issues learnt to have come up for discussion in the meeting. It is also learnt that the CM has given several important instructions to the higher officials on this occasion.

The CM has given clear instructions to the officials to clear Rs 900 crore kept for Neeru-Chettu scheme. He suggested that the

dues of pre-2019 houses should also be cleared. CM Chandrababu reminded that many activists and leaders were roaming around them for the clearance of the dues. He instructed the district incharge ministers to focus on the issue of the dues when they visit districts. There was a long discussion on revenue in this conference.

Chandrababu stressed the need for the ministers and officials to pay attention to bogus passbooks and registrations. Stating that a Memorandum of Understanding (MoU) has also been signed in renewable energy during his recent Davos visit, he asked the ministers and the officials to focus on the grounding of the projects. He asked the officials to focus on setting up a training institute of Customs department in Anantapur district.

# Govt should remove confusion over BC Reservations: Talasani

#### Six states pass resolution opposing draft UGC regulations 2025 : Sridhar Babu

Hyderabad, Feb 6 (NSS): Minister for IT and Industries Duddilla Sridhar Babu has taken a firm stand against the draft UGC Regulations 2025, which seek to clip the wings of State governments in appointing university vicechancellors. Representing the Telangana government in place of Chief Minister Revanth Reddy, Sridhar Babu participated in a crucial meeting in Bengaluru, where Education Ministers and representatives from six (non-BJPruled) states—Karnataka, Tamil Nadu, Kerala, Telangana, Jharkhand, and Himachal Pradesh—closed ranks to challenge the Centre's move. At the meeting, Sridhar Babu pulled no punches, slamming the central government's attempt to tighten its grip on higher education.

"For years, States have had the final say in appointing vice-chancellors, and now the Centre wants to call the

shots. Telangana alone spends nearly Rs.4,000 crore annually on higher education, setting up new universities, fostering research and innovation, and ensuring quality education. What gives the Centre the right to meddle in our affairs?" he asked. The Minister tore into the proposal that would allow industry leaders, bureaucrats, and external individuals to be appointed as vicechancellors.

#### 11T Mandi to establish extension campus in Palampur

Shimla, Feb 6 (IANS): In a significant achievement for higher education and technological advancement in Himachal Pradesh, the Indian Institute of Technology (IIT), Mandi will establish an extension campus in Palampur on nearly 52 hectares of land. The announcement was made on Thursday by Gokul Butail, Principal Advisor (Innovation, Digital Technologies, and Governance) to Chief Minister Sukhvinder Singh Sukhu, in Palampur. Butail, who also serves on the Board of Directors of IIT Mandi Catalyst, the institute's startup incubator, said he had actively advocated for the expansion of IIT to Palampur. For this purpose, 22 hectares of land at Bhagotla village have already been allotted for lease to IIT Mandi under the Technical Education Department, while an additional 31 hectares will be sent for forest clearance to the Central government. Palampur, already home to prestigious institutions like Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya Agricultural University and CSIR-Institute of Himalayan Bioresource Technology, of fers a strategic advantage with improved connectivity.



#### Driven by 'political motives': Cong's Udit Raj on Union Budget

New Delhi, Feb 6 (IANS): Congress leader Udit Raj, while responding to the Union Budget, said on Thursday that it was driven by political motives eying Delhi voters. Commenting on the tax rebates announced in the budget, he said, "It was awaited for many years, the way inflation has increased. When salaries are being increased, this tax exemption limit was also needed to increase. In such a situation, tax collection will also increase. This has been done keeping in mind the Delhi elections." "But, there is not much relief in the times of inflation. The most important thing is that inflation should come down. That is not happening, inflation is increasing. You may give income tax exemption. Now if inflation increases, there is no net benefit," Udit RaJ told IANS. Criticising the budget, the Congress leader said, "In the budget, there is no mention of farmers' MSP.

#### Faizabad MP breaks down over Dalit woman's rape-murder in Ayodhya; CM Yogi responds

New Delhi, Feb 6 (IANS): Awadhesh Prasad, the Samajwadi Party MP from Faizabad, burst into tears on Thursday during a press conference over the rape and murder of a Dalit woman and declared that he would resign from his position if the perpetrators of heinous crime were not caught and punished.

Prasad's teary outburst was in response to the murder of a 22-year-old Dalit woman whose body was found in Ayodhya, which is a part of the Faizabad constituency.

According to reports, the naked body of the woman was recovered from a canal near her village. As per her family members, she was violated before the murder and her eyes were also gouged out.

The Samajwadi Party MP, speaking to the press, started crying over the incident, lamenting that he could not save her. A video of Prasad breaking down also circulated on the social media. In the video, he can be seen crying while fellow colleagues were consoling him. "I will raise this matter in Lok Sabha before the Prime Minister. I will resign from Lok Sabha if we do not get justice. We are failing to save our daughters. How did this happen to our daughter," he could be heard saying in the video.

#### Gurugram: Man kills wife on suspicion of having affair, arrested

Gurugram, Feb 6 (IANS): A man was arrested for allegedly killing his wife in Gurugram's Sector-61 area over suspicion that she was in an illicit relationship with another person, police said on Thursday. The accused has been identified as Abrar of Uttar Pradesh, they said.

Police received information on January 28 that a 20-year-old woman identified as Saloon was brought to the hospital.

A team from the Bhondsi police station reached the hospital, took custody of the body, and kept it in the mortuary. On January 29, the deceased's sister told the police that her sister used to live with Abrar in a rented accommodation in Sector-61. The victim died due to an illness. An autopsy report of the deceased disclosed that she was strangulated to death.

#### Fugitive gangster deported from Philippines, arrested at 1G1 airport

New Delhi, Feb 6 (IANS): In a significant development, a dreaded gangster, Joginder Gyong, was deported from Philippines on Thursday and arrested at Delhi's IGI airport by the Special Cell of Delhi Police over his role in multiple criminal cases. The criminal is wanted by Haryana and other states over criminal conspiracy and murder charges besides other heinous crimes. The gangster was ar-

rested in Philippines and brought back Delhi via Bangkok, where his custody was taken by the Special Cell of Delhi Police.

Joginder Gyong has been guilty of engaging in criminal activities along with his brother Surinder Geong. He has multiple cases

against him, with murder charges lodged against him at Panipat police station in 2017.

The fugitive gangster was involved in multiple criminal cases with cases lodged against him in Delhi also, over offences of robbery, murder, attempt to murder.





#### School admissions dipped, pollution spiked under AAP govt: Ajay Maken

New Delhi, Feb 6 (IANS): A drop in admissions in government schools and shortage of public transport buses are the dark facts about the Aam Aadmi Party (AAP) government's failed education and transport models in Delhi, former Union Minister and AICC Treasurer Ajay Maken said on Thursday. Addressing media persons, Maken said the Arvind Kejriwal and Atishi governments had misled Delhiites by promising world-class education and transport facilities in the city but failed to deliver them.

The Congress leader said that it was surprising that despite Delhi's population increasing sharply, the number of admission of students in government schools under the Kejriwal government came down, with fewer students passing out of Class XI. He said the AAP government in Delhi was the only one in the world where the Education and Excise Minister was the same person -- Manish Sisodia -who wore the mask of education to commit the crime of liquor scam.

He added that the people of Delhi have now fully

understood the fake models of Kejriwal and were determined to vote in the Assembly election for the Congress on February 5, to bring back the Sheila Dikshit-led Congress government's model of development.

The AICC Treasurer said that during the Congress regime in 2008-09, 75,974 students had passed the Class 12 Board exams, and the number rose to 147,420 when Congress left office in 2013-14.

Under the AAP government in 2015-16, the students who passed the Class 12 Board exams came down to 116,792 and the number further slumped to 109,098 in 2019-20, he added.

Similarly, under the Congress government in 2013-14, 166,257 students appeared for Class 12 Board exams while under the AAP government in 2023-24, the number came down to 15,1429 -- instead of going up in proportion to the increase in the Capital's population.

#### 118-member foreign delegation takes sacred bath at Maha Kumbh, praises Indian culture



#### Namibia tracks two lions outside protected areas

vironment, Forestry and Tourism (MEFT) said it is tracking two lions that strayed from protected areas into farmland. The first lion, a female, was spotted between Tsumeb and Oshivelo, both towns in northern Namibia along a key route connecting the country's interior to Etosha National Park, a major wildlife conservation area, MEFT spokesperson Romeo Muyunda said in a statement on Saturday. According Muyunda, the lioness is part of a pride with two adult lions and four cubs at Onguma Farm, a private reserve bordering Etosha, reports Xinhua news agency.

"We believe that one female lion went out from the farm and was spotted and captured by travellers in the circulating video," Muyunda said. "Our staff have tracked the spores of the lion to the Punyu farm."

The affected area consists mainly of private farmland, re-

amibia's Ministry of En ducing the risk of direct encounters with people, he said, urging farmers and nearby communities to take precautions while officials work to return the lion to Onguma. Another lion was reported at Oromowa, a farming area on the western periphery of Etosha National Park, and is suspected to have strayed from the park.

"Equally, our staff members are tracking the lion and caution communities in those areas to be vigilant and ensure the livestock are safe," Muyunda said.

The ministry confirmed that no livestock losses, property damage, or attacks on humans have been reported.

#### With calm being restored in DR Congo, risk of disease outbreaks increases: UN

Thile calm is being re stored in Goma, the key eastern city in the Democratic Republic of the Congo (DRC), the risk of disease outbreaks, including cholera and Mpox, increases on the outskirts. according to the United Nations officials.

"In Goma, currently, the situation remains tense and volatile, with occasional shooting continuing within the city, but I would say that overall, calm has been gradually restored," said Under-Secretary-General for Peace Operations Jean-Pierre Lacroix at a press briefing on Friday.

"Water and electricity have been restored in much of the city, but we continue to grapple with the challenge of unexploded ordnance ... a very serious obstacle to freedom of movement," he said. Runways at the city's airport sustained significant damage in the recent fighting and are unusable. Aid cannot be flown in as only roads into neighboring Rwanda are open.

The GDP per capita for 2024 is estimated at \$36,024, up \$454, or 1.28 percent, from a year earlier, according to the data compiled by the Ministry of Economy and Finance, the Bank of Korea and Statistics Korea. The

Japan and Taiwan, which stand at \$32,859 and \$33,234, respectively, according to estimates from the International Monetary Fund (IMF), reports Yonhap news agency. South Korea's per capita GDP was calculated based on a nominal growth rate of 5.9 percent from the nominal GDP of 2.4 quadrillion won (\$1.65 trillion) in 2023 and the average won-dollar exchange rate of 1,363.98 won last



year. South Korea's total population in 2024 was estimated at 51.75 million. For this year, the country's per capita GDP is forecast to rise above the \$37,000 threshold if it meets the growth

forecast. Seoul logged a per capita GDP of over \$30,000 for the first time in 2016 and hit the highest mark of \$37,503 in 2021 before dropping to \$34,810 the following year.

#### Africa CDC calls for immediate action amid escalating health crises across Africa

Addis Ababa, Feb 6 (IANS): The Africa Centers for Disease Control and Prevention (Africa CDC) has called for "immediate action" to address the "unprecedented convergence of crises" that threaten to undo the decades of progress in Africa's health security. The Africa CDC said in a statement issued Thursday that the number of health emergencies in Africa has been surging over the years.

Calling for concerted efforts from African countries and international partners, the Africa CDC expressed concern over the shifting global landscape, which has seen many "wealthy nations turning inward," reducing development assistance to prioritise domestic



needs, including the recently announced 90-day pause in US foreign aid. "The repercussions are dire. Africa CDC projections warn that without urgent intervention, these financial constraints could reverse health gains, pushing morbidity and mortality rates back to the early 2000s levels. An estimated 2 to 4 million additional deaths per year from preventable and treatable diseases could occur," it said.

#### Mexico hits back at US after Trump's decision to impose tariffs

Sheinbaum firmly stated that Mexico would not accept any form of foreign interference. "We outright reject the White House's baseless claims that the Mexican government is aligned with crimi-

nal organisations, as well as any attempt to intervene in our country's affairs," she declared. Stressing the importance of diplomacy, Sheinbaum emphasised Mexico's preference for coopera-



tion over conflict. "We advocate for collaboration between neighbouring nations. Our efforts must be based on shared responsibility, mutual trust, and respect for sovereignty, which is non-negotiable. Coordination, yes; subordination, no," she posted on X. Responding to Trump's accusations that Mexico has failed to control fentanyl trafficking and illegal migration, Sheinbaum highlighted her government's extensive anti-drug efforts.

#### Budget 2025: Relief for homeowners as no tax on second self-occupied house

New Delhi, Feb 6 (IANS): The Union Budget 2025 presented brought good news for homeowners, as Finance Minister Nirmala Sitharaman announced new tax benefits. Under the proposed changes, homeowners will now be able to claim a nil valuation for two self-occupied houses instead of just one, as was previously allowed. The Budget suggests amending Section 23, sub-

section (2) of the Income-tax Act Parliament. She also added that which allows the annual value of a house or part of it to be considered as nil if the owner occupies it for personal residence or is unable to do so for any reason.

"Presently taxpayers can claim the annual value of self-occupied properties as nil only on the fulfillment of certain conditions," Finance Minister Sitharaman said during a Budget presentation in considering the difficulties faced by taxpayers, it is proposed to allow the benefit of two such selfoccupied properties without any condition.

In addition, the government has proposed raising the annual threshold for Tax Deduction at Source (TDS) on rent from Rs 2.4 lakh to Rs 6 lakh.

This increase will benefit small

taxpayers and landlords by reducing the number of transactions liable for TDS.

The monthly TDS limit on rent has been increased from Rs 24,000 to 50,000, which amounts to Rs 6 lakh annually.

"I propose to rationalise TDS by reducing the number of rates and thresholds above which TDS is deducted," FM Sitharaman said in her Budget speech. The Finance



Minister added that further. threshold amounts for tax deduction will be increased for better clarity and uniformity. According

to the Finance Minister, this change will provide relief to small taxpayers receiving modest rental payments.

#### Global oil prices likely to stay in \$75 to \$80 per barrel range over next 6 months: CareEdge

New Delhi, Feb 6 (IANS): Crude oil prices are expected to remain range bound at an average of \$75-\$80 a barrel over the next 6 months, essentially on the back of higher overall global crude oil production aided by increase in crude oil production by the US while demand growth is expected to remain relatively subdued in the backdrop of a slowdown in major global economies, according to a CareEdge Ratings report released on Thursday.

The higher thrust towards Electric Vehicles (EVs) and alternative fuels is also expected to dampen demand for oil.

CareEdge Ratings observed a softening of Gross Refining Margins (GRMs) for Indian public sector oil marketing companies (OMCs).

#### Car sales clock 15.5 per cent surge to 4.66 lakh units in Jan

Car sales in India surged by a robust 15.53 per cent to 4,65,920 in January this year, according to data released by the Federation of Automobile Dealers Associations (FADA) on Thursday. Sequentially, month-on-month car sales were up 58.77 per cent. "PV (passenger-ve-

### Kenya on high alert over Sudan Ebola virus outbreak in Uganda

Nairobi, Feb 6 (IANS): Kenya's Ministry of Health has intensified surveillance at all entry points across the country following an outbreak of Sudan Ebola Virus Disease in neighbouring Uganda. "As a precautionary measure, surveillance systems have been enhanced in all counties and points of entry," Principal Secretary of the Ministry of Health Mary Muthoni said in a statement issued in Nairobi, the capital of Kenya. Muthoni said a rapid assessment of the country's capacity to respond to a similar outbreak is un-

derway, shortly after which a comprehensive plan will be developed to guide countrywide preparedness and response to Ebola.

She encouraged the public to seek accurate information from qualified healthcare workers, community health promoters or the Ministry of Health through its website. The statement came after the Ugandan Ministry of Health on Thursday declared an Ebola outbreak after a 32-year-old male nurse succumbed to Sudan Ebola virus Wednesday, marking the eighth outbreak of the deadly dis-

ease in the East African country, Xinhua news agency reported.

The World Health Organization (WHO) said it is "working closely with Ugandan health authorities to revitalise a robust surveillance and case management system, community mobilization, and risk communication in response to the outbreak."

Last September, Uganda's Ministry of Health had announced the launch of a comprehensive Ebola preventive vaccination campaign targetting 25,000 people at high risk of contracting the deadly dis-

ease. Charles Olaro, Director of Health Services at the ministry, said that the initiative aimed at safeguarding vulnerable populations and enhance preparedness against the viral disease in the country.

Olaro said that the ministry had acquired 25,000 Ebola vaccine regimens. The two-dose regimen has previously been used in the neighbouring Congo and Rwanda, with "Zabdeno" administered first and "Mvabea" given about eight weeks later as a second dose. The Ebola virus is highly conta-

gious and causes a range of symptoms, including fever, vomiting, diarrhea, generalized pain or mal-

aise, and, in many cases, internal

and external bleeding. According to the World Health Organization, the mortality rates for Ebola fever are extremely high.



#### Power cuts return to South Africa after 10 months

Johannesburg, Feb 6 (IANS): South Africa will experience load-shedding, or rolling blackouts, over the weekend after more than 10 months of uninterrupted electricity supply, Minister of Electricity and Energy Kgosientsho Ramokgopa said.

During a media briefing Thursday afternoon, Ramokgopa explained that several factors, including a number of unit failures at state power utility Eskom's power stations, led to a "perfect storm," triggering the necessity of initiating load-shedding.

"We had units out for planned maintenance, and then there were unit failures at Matimba and Lethabo power stations. For most of the week, we had to rely on the open-cycle gas turbines. We had to rely on diesel. We exhausted our reserves," he said. This came after Eskom announced that stage 3 load-shedding would be implemented Friday and run for the weekend, Xinhua news agency reported.

"This is a potentially temporary setback. Load-shedding is largely behind us due to the structural improvements in our generation fleet," said Eskom Group Chief Executive (CEO) Dan Marokane in a statement. "However, over the past seven days, we have experienced several breakdowns that require extended repair times. This has necessitated the use of all our emergency reserves, which now need to be replenished over the weekend."

As the country prepared for a resumption of load-shedding later Friday, Rethabile Melamu, CEO



of the South African Photovoltaic Industry Association, said it is important not to lose focus and not to lose hope, urging all stakeholders to work with the government to address the power cuts.

"This is indeed a sad setback, but our work needs to continue. We are within touching distance of the finish line. I call on all stakeholders and role-players to remain committed to finally ending loadshedding permanently," she said.

Scheduled power cuts, commonly referred to as load-shedding in South Africa, have hindered the country's economic growth for over a decade. Since March last year, however, there have been no power cuts due to a significant improvement in Eskom's electricity supply, resulting in more than 300 consecutive days without outages.

# Young residents drive Tokyo's population influx

Tokyo, Feb 6 (IANS): Tokyo saw a net population inflow of approximately 79,000 people in 2024, marking an increase of over 11,000 from the previous year, according to the Ministry of Internal Affairs and Communications.

Young people moving to Tokyo for education and employment were the primary contributors to this trend, reinforcing the continued centralization of population in Tokyo, the ministry noted.

In 2024, a total of 461,454 people moved into Tokyo, an increase of 7,321 from 2023, while 382,169 people moved out, a decrease of 3,679 from the previous year, resulting in Tokyo's third consecutive year of rising net inflow.

By age group, the largest net influx was among 20 to 24-year-olds (64,070 people), followed by 15 to 19-year-olds (14,286 people). Following Tokyo, the top prefectures with net population inflows were Kanagawa.

Islamabad, Feb 6 (IANS): At least 18 soldiers of Pakistan's Frontier Corps (FC) have died during an operation in Mangocher, a city located in the Kalat district of Balochistan province, the country's military authorities confirmed on Thursday. "On the night of January 31/February 1, terrorists attempted to

establish roadblocks in Manocher, Kalat District of Balochistan. Security forces and law enforcement agencies were immediately mobilised, who successfully thwarted the evil design and killed 12 of them, ensuring security and protection of local populace," read a statement issued by Inter-Services Public Relations (ISPR), the media wing of the Pakistani mili-

Beirut, Feb 1 (IANS): Egypt and Iran reaffirmed their commitment to supporting Lebanon across multiple sectors, pledging assistance for the country's recovery from the conflict between Israel and Hezbollah.

During a meeting with Lebanese President Joseph Aoun, visiting Egyptian Foreign Minister Badr Abdelatty conveyed a message on Thursday from Egyptian President Abdel-Fattah al-Sisi, underscoring Egypt's solidarity with Lebanon and its willingness to contribute to rebuilding Lebanon's key sectors, including electricity and gas, Xinhua news agency reported. According to a state-



ment released by the Lebanese presidency, Abdelatty highlighted that Egyptian companies are prepared to participate in Lebanon's reconstruction. He also stressed Egypt's unwavering support for Lebanon's stability, the implementation of UN Security Council Resolution 1701, and Israel's un-

conditional withdrawal from occupied Lebanese territories. He reaffirmed Egypt's commitment to supporting the Lebanese military and facilitating the return of displaced residents to their homes in Lebanon's southern area and western Bekaa region.

#### Iran to make 'immediate, decisive reaction' to attack on its nuclear sites: FM

Tehran, Feb 6 (IANS): Iran will make an immediate, decisive reaction to any attack on its nuclear facilities, Iranian Foreign Minister Seyed Abbas Araghchi has warned. US participation in potential Israeli attacks on Iran's nuclear sites would be one of the "biggest historical mistakes," Araghchi said in an exclusive interview with

Qatar's Al Jazeera TV network, while responding to a question about Israeli Prime Minister Benjamin Netanyahu's threats of attacking Iran's nuclear facilities and a possible US involvement.

In the interview aired late Friday, Araghchi noted that Iran's nuclear programme was domestically developed, and the country has managed to acquire the nuclear capability and technology relying on its own capacities. "Iran's nuclear programme is inside the Iranian scientists' brains, not on the ground. Such a capability and programme will not be destroyed through bombardments and airstrikes," he said. In addition, Iran's nuclear facilities are not located in one or two regions, but in several areas across the country, and in places that are "very difficult and even impossible" to tar-

get via airstrikes and protected by "very good air defence," said the minister. "Unlike the previous times, if any attack is carried out against Iran's nuclear facilities, the country's reaction will be immediate and decisive," said Araghchi, Xinhua news agency reported. Should such an attack be launched,

"we will enter an all-out war in the region, a disaster nobody, neither inside nor outside the region,



wants," he said. "I do not think Americans would make such a big miscalculation."



#### Sri Lanka plans elephant corridors to curb human-elephant conflict

Colombo, Feb 6 (IANS): Sri Lanka is planning to establish five elephant corridors in its north-central province to reduce human-elephant conflicts, media reported on Thursday. The north-central province has experienced the highest number of human-elephant conflict incidents compared to other regions, according to the state media. Out of the province's 29 Divisional Secretariat Divisions, 27 have seen a sharp increase in human-elephant conflicts in recent years, according to the report. To address the issue, authorities have decided to create five elephant corridors. Additional measures include preventing encroachment on protected areas, managing elephant habitats by cultivating grasslands, and rehabilitating water tanks in conservation zones, the state media reported. Human-elephant conflict is a serious problem in Sri Lanka, Xinhua news agency reported. In 2024, 388 wild elephants and 155 people lost their lives due to these conflicts, according to official data. The Human-Elephant Conflict (HEC) in Sri Lanka is a critical and multifaceted issue posing significant challenges to the conservation of the endangered Asian elephant.

#### Union Budget has rightly focused on green economy progression: Environmentalists

Kolkata, Feb 6 (IANS): The good aspect of the Union Finance Minister Nirmala Sitharaman's Budget proposals for the Financial Year 2025-2026 had been the Union government's focus on the country's transition to green economy, feel a section of the green technologists and environmentalists.

# New technology bolsters South Africa's border security, says minister

Johannesburg, Feb 6 (IANS): The implementation of new technology has significantly strengthened South Africa's border security, resulting in a 215-per cent increase in the prevention of illegal cross-border movements at ports of entry during this festive season, Home Affairs Minister Leon

Speaking at a briefing Thursday on the Border Management Authority (BMA) festive season campaign, Schreiber said the piloting of new technology, including drones and body cameras, has demonstrated the power of digital transformation to secure and enhance border management.

"It is now time for the BMA to permanently acquire these capabilities, as we accelerate our work to digitalise South Africa's port environment, including automating all entry and exit procedures," the Minister said. He revealed that 50,312 undocumented individuals were intercepted while attempting

to cross into South Africa illegally in the 2024/2025 festive season, Xinhua news agency reported.

The minister attributed the increase to the deployment of drones at five ports of entry. During the 2023/2024 festive season, the number of intercepted individuals stood at 15,924.

"Another 6,159 people were detected for overstaying, and a further 1,923 were refused entry due to fraudulent documentation or non-compliance with entry requirements," he added.

Schreiber commended the success registered at ports of entry to curb illegal activities.

Schreiber also disclosed that BMA border guards, in cooperation with the police, made 322 arrests, including 132 wanted criminals, and

seized illicit goods worth 690 million rand (about \$37 million), including illegal ciga-

Additionally, he said the BMA processed the legitimate movement of 5,084,251 travelers across the country's ports of entry. The use of technology at border crossings led to an increase of 51,680 travellers compared to the 2023/2024 festive pe-



#### **Daycare cancer centres** in every district in India a timely initiative

New Delhi, Feb 6 (IANS): The Union Budget's plan to establish daycare cancer centres in every district over the next three years is a timely initiative, experts said on Thursday. Cancer incidence in India is rising, with cases expected to increase by 27.7 per cent from 2015 to

According to the 'National Cancer Registry Programme Report' 2020, one in nine people is likely to develop cancer in their lifetime.

The Budget move "aims to improve access to cancer treatment and support, particularly in remote areas, bridging a critical gap in healthcare services," said Ashok Varma, Partner, Grant Thornton Bharat.

The Government will facilitate the setting up of daycare cancer centres and 200 such centres will be established in 2025-26. Moreover, the Budget announced 36 life-saving drugs and medicines (mainly for cancer and rare diseases) to be added to the list of medicines that are fully exempt from basic customs duty (BCD).





#### Rwanda aims to achieve universal health coverage by 2030

Kigali, Feb 6 (IANS): Rwanda on Thursday launched a comprehensive blueprint to advance progress toward universal health coverage by 2030.

The Health Sector Strategic Plan V (HSSP V) for 2024-2029, launched in Kigali, the capital, aims to create a healthier, more productive population that drives Rwanda's development goals, authorities said.

The launch coincided with the unveiling of Mission 2027, an initiative to accelerate the elimination of cervical cancer.

"With HSSP V, we are not just continuing our progress. We are accelerating it," said Yvan Butera, Rwandan minister of state in the Ministry of Health. "We will expand our health workforce, strengthen primary healthcare, and ensure quality services reach every Rwandan."



#### Uganda starts mpox vaccination targetting high risk populations

Kampala, Feb 6 (IANS): Uganda on Thursday launched mpox vaccination campaign targetting highrisk populations in Kampala, the Ugandan capital, the current epicentre of the virus outbreak in the east African country.

Charles Olaro, Director General of Health Services at the Ministry of Health, told Xinhua news agency by telephone that phase one of the vaccination exercise, which targets high-risk populations and health workers, aims to stop human-to-human transmission of the highly infectious virus.



#### **Budget outlay for Jal Jeevan Mission** hiked to Rs 67,000 crore

New Delhi, Feb 6 (IANS): Finance Minister Nirmala Sitharaman on Thursday enhanced the total outlay for Jal Jeevan Mission to Rs 67,000 crore in her proposals for Budget 2025-26 and said that the Mission stands extended until 2028. FM Sitharaman stated that 15 crore households representing 80 per cent of India's rural population have benefitted from the Jal Jeevan Mission since 2019. She added that access to potable tap water connections is provided under this Mission, and in the next three years, the target is to achieve 100 per cent coverage.

Jal Jeevan Mission's focus will be on the quality of infrastructure and operation and maintenance of rural piped water supply schemes through "Jan Bhagidhari".

Separate MoUs will be signed with states and UTs to ensure sustainability and citizen-centric water service delivery, she explained. 

#### WHO donates over 2000 doses of Ebola trial vaccine to Uganda following new outbreak

World Health Organization (WHO) has donated 2,160 doses of Ebola trial vaccine to Uganda to evaluate the efficacy of the vaccine in combating the virus which in the recent outbreak has killed a health worker in Kampala, the country's capital.

WHO is working with Uganda's Ministry of Health, Makerere University Lung In-

Kampala, Feb 6 (IANS): The stitute and the Ugandan Virus Research Institute, as well as worldwide filovirus and trial experts and regulators to initiate the trials, according to a statement posted on the website of the WHO.

> Uganda's Ministry of Health on Thursday declared an Ebola outbreak after a 32-year-old male nurse working at Mulago National Referral Hospital in Kampala succumbed to Sudan Ebola Virus Disease (SVD), marking the eighth

outbreak of the deadly disease in the east African country.

"The aim of the vaccine trial is to evaluate a potentially efficacious candidate vaccine, and if efficacious, to possibly contribute to ending the ongoing outbreak and protect populations at risk in the future," said WHO. "Those eligible to join the trial are those at highest risk of SVD, like close contacts of a person who has been confirmed to have had SVD or

who has died from the disease. The study sites will therefore be the locations where contacts of the case or cases reside."

There are no approved treatments or vaccines for Sudan virus, but early initiation of supportive treatment has been shown to significantly reduce deaths from Sudan virus disease, according to WHO. Uganda's previous SVD outbreak started in September 2022 and ended in January 2023.





#### World Bank warns Zimbabwe on climate-induced economic losses

Harare, Feb 6 (IANS): The World Bank (WB) has warned that climate change could erode up to 12 per cent of Zimbabwe's Gross Domestic Product (GDP) annually if the country does not implement robust measures to tackle the phenomenon.

In its latest Zimbabwe economic update report launched in Harare, Zimbabwe's capital, the WB urged Zimbabwe to bolster resilience against climate-related shocks, focusing on agriculture as a critical pillar of the economy.

Statistics from the Zimbabwean government show agriculture contributes from 11 per cent to 14 per cent of GDP and provides employment for some 70 per cent of the population and about 60 per cent of all raw materials for the industry.

The country's heavy reliance on rainfed systems and maize production, however, leaves it vulnerable to increasingly severe climate events, the WB noted.

#### Uganda reaffirms commitment to wetland conservation amid progress

Kampala, Feb 6 (IANS): As the world prepares to mark World Wetlands Day Thursday, Uganda is reaffirming its commitment to wetland conservation, citing progress in its restoration efforts. In a statement issued before the day, the Ugandan Ministry of Water and Environment announced that the country will commemorate the day under the theme, "Conserving Wetlands Today for a Secure Tomorrow." Beatrice Anywar, minister of State for Environment, emphasised the role of wetlands in sustainable development. "By acting now, we can ensure that these vital ecosystems continue to thrive and support biodiversity, filter water, provide a buffer against extreme events like floods and storms, avail water for domestic use and agriculture," she said. "Therefore, by investing in wetlands today, we are essentially investing in a more resilient and sustainable future."

Despite their importance, wetlands face increasing threats from unsustainable urban expansion, agriculture, and pollution. According to the National Environmental Management Authority (NEMA), the state environmental watchdog, Uganda's wetland coverage has declined from 13 per cent to about 8 per cent of the country's total land area.





#### South Korea: Massive rallies in Seoul oppose, urge Yoon's ouster

Seoul, Feb 6 (IANS): Crowds of protesters gathered in South Korea's Seoul on Thursday in massive rallies, either opposing the ouster of impeached South Korean President Yoon Suk Yeol or urging his removal from office, following his recent indictment under physical detention.

An estimated 3 million people, according to organisers, thronged Seoul's central Gwanghwamun area, waving the Taegeukgi and the Stars and Stripes and calling for Yoon's release in a rally opposing his impeachment.

Last Sunday, prosecutors indicted Yoon with physical detention on insurrection charges over his short-lived declaration of martial law on December 3. The following week, the National Assembly voted to impeach Yoon, prompting a Constitutional Court trial to decide whether to reinstate or permanently remove him from office.

#### At least 45 civilians killed, 82 injured in paramilitary attack in Sudan's Omdurman city

Khartoum, Feb 6 (IANS): At least 45 civilians were killed and 82 others injured in a shelling by the paramilitary Rapid Support Forces (RSF) on Thursday on a crowded market in Omdurman, north of the Sudanese capital Khartoum, a volunteer group and a medical source said. "The RSF militia committed a new massacre today (Saturday) with a deliberate bombing of the Sabreen Market in the Karari locality," the Al-Thawra Resistance Committee, a volunteer group, said in a statement. "So far, 45 civilians have been killed and 82 others injured," the statement added, without providing further details. Meanwhile, a medical source at Al-Nao Hospital in Omdurman said, "The hospital has received over 24 bodies, along with dozens of injured individuals."

"The situation is catastrophic in every sense of the word. We need blood donors and medical supplies."



#### Qatari PM meets Turkish FM on cooperation, developments in Gaza, Syria

Doha, Feb 6 (IANS): Qatari Prime Minister and Minister of Foreign Affairs, Mohammed bin Abdulrahman bin Jassim Al Thani, met with Turkish Foreign Minister Hakan Fidan to discuss bilateral cooperation and the latest developments in the Gaza Strip and Syria.

According to a statement by

Qatar's Foreign Ministry, the two officials reviewed ways to strengthen bilateral ties, as well as the latest developments in Gaza, the Palestinian territories, and Syria, along with several issues of mutual concern. During the meeting on Sunday, Al Thani emphasised the need for both parties involved in the conflict to continue implementing the ceasefire agreement in Gaza, expressing his appreciation for the strong Qatari-Turkish partnership in promoting peace and stability in the region, Xinhua news agency reported. In a joint press conference following the meeting, Al Thani stressed the importance of all parties adhering to the full implementation of the agreement's provisions

and commencing negotiations on the second phase, as stipulated in the agreement. He further urged the partners in the international community to maintain pressure to ensure the success of these negotiations. He emphasised that no party should be allowed to obstruct them to prevent the closure of this irreplaceable window.



#### 50 patients from Gaza enter Egypt via Rafah crossing

Cairo, Feb 6 (IANS): Fifty patients from the Gaza Strip entered Egypt on Thursday through the Rafah crossing, the only link between the Palestinian enclave and Egypt, Egypt's state-run Nile TV reported. They are the first group of Gazan patients entering Egypt via the crossing for medical treatment since last May. TV footage

showed the patients entering the Egyptian side of the crossing one by one and boarding ambulances waiting at the border.

An Egyptian Red Crescent source told Xinhua news agency earlier on Saturday that 30 wellequipped ambulances were stationed at the Egyptian side of the crossing to transport the patients.

#### North Korea says US arms aid cannot 'save' South Korea from strategic deficiency

Seoul, Feb 6 (IANS): North Korea on Thursday accused the US of stepping up weapons aid to allies in what it called an attempt to cement its hegemonic status, saying such weapons provisions are still not sufficient to "save" South Korea from a strategic deficiency.

The North's state media made the

accusation after the US Defence Security Cooperation Agency recently announced proposed sales of weapons to South Korea, which will include BQM-177A subsonic seaskimming aerial targets for Aegisequipped destroyers and GQM-163 target drones, Yonhap news agency reported. "The US, the world's big-

gest war merchant, is getting worked up, more than ever, on its weapons sales scheme to nations that follow (the US)," the Korean Central News Agency (KCNA) said in a commentary, stressing that such sales to South Korea are increasingly becoming "persistent." The KCNA claimed such arms provisions to the South reflect the US' attempt to destroy the balance of power in the region and solidify its hegemonic status. "No weapons aid from the US can redeem (South Korea) from its fate of strategic deficiency ... the US will not be able to realise its ambition due to our righteous power," it said. The commentary came as the North has long denounced military cooperation between South Korea and the US, calling joint military drills between the allies rehearsals for invasions while using them as a pretext for provocations. Last week, Pyongyang vowed to maintain "the toughest counteraction" to the US as long as it rejects the country's sovereignty and security interests.

#### Mexican president confirms death of 6 Mexicans in plane crash in Philadelphia

Mexico City, Feb 6 (IANS) : Mexican President Claudia Sheinbaum confirmed the death of six Mexicans aboard a plane that crashed Thursday evening in northeastern Philadelphia, the US.

The Mexican president lamented the death of her compatriots and announced that the consular authorities are "in permanent contact with the family members."

"I have asked the Secretariat of Foreign Affairs to support everything required. My solidarity with the loved ones and friends," she said on the social media platform X.

Jet Rescue Air Ambulance, the company operating the plane, confirmed that the aircraft was carrying four crew members, a pediatric patient who had just finished treatment in Philadelphia, and the patient's escort, Xinhua news agency reported.

The crash came just two days after a deadly collision between an American Airlines jet and a US Army Black Hawk helicopter over Washington, DC, which claimed 67 lives.

Earlier on Friday evening another plane crash occurred in US when a small aircraft crashed in Philadelphia in the nearby state of Pennsylvania setting several homes on fire.

It was a medical flight, according to local news reports, carrying six

Multiple homes were on fire in a neighbourhood new Roosevelt



Boulevard and Cottman Avenue. A local news outfit, said witnesses on social media have reported seeing an orange flash near Roosevelt Mall, an outdoor shopping centre off the boulevard, which is what Route 1 is called as it runs through the city before the Bucks County border. Homes surround the shopping centre. The news site cited emergency services dispatches to say the aircraft crashed near the 7200 block of Calvert Street, a residential street, shortly after 6 p.m. Friday.

#### Arab countries reject attempt to displace Palestinians from Gaza, West Bank

Cairo, Feb 6 (IANS): Egypt, Jordan, Saudi Arabia, Qatar, the United Arab Emirates (UAE), the Palestinian Authority (PA), and the Arab League (AL) stressed in a joint statement on Thursday the rejection of any attempt to displace Palestinians from the Gaza Strip and the occupied West Bank.

The statement was issued after a meeting in Egypt's capital Cairo attended by top diplomats from Egypt, Jordan, Saudi Arabia, Qatar, and the UAE, as well as high-ranking officials from the PA and AL. Participants of the meeting expressed their commitment to working with US President Donald Trump's administration "to achieve a just and comprehensive peace in the Middle East based on the twostate solution," according to the statement. They also voiced full support for the Palestinians and their legitimate rights, rejecting any attempt to displace the Palestinian people, whether by eviction or ef-

forts to transfer or remove them from their land under any circumstances. The statement also urged the international community to coordinate efforts for planning and implementing a comprehensive process for the reconstruction of Gaza to improve the Palestinians' daily lives and address the problem of internal displacement, Xinhua news agency reported. On January 25, Trump proposed a controversial plan to displace Palestinians from Gaza to Egypt and Jordan, which was strongly

rejected by both countries. On Friday, thousands of people gathered near the Egyptian side of the Rafah crossing, the only channel linking Egypt with Gaza, to express opposition to the displacement of Palestinians. Earlier this week, the Arab League (AL) had reaffirmed that stability and peace in the Middle East will only be achieved after settling the Palestinian cause and implementing the two-state solution. The AL said that "any attempts to displace the Palestinian people from their



land, either through deportation, annexation or settlement expansion," have proved to be failures and are rejected as a violation of international law. The pan-Arab group stressed that the current

stage requires continuous work by all to consolidate the Gaza truce and ensure its continuation in preparation for the immediate start of rebuilding Gaza after a 15-month brutal war.

#### Trump fires Biden-appointee Rohit Chopra who headed consumer protection

New York, Feb 6 (IANS): US President Donald Trump has fired Rohit Chopra, who was appointed the head of the Consumer Financial Protection Bureau (CFPB) by former President Joe Biden. In a letter to Trump on Thursday, Chopra acknowledged that his term as the director of the CFPB "has concluded". Media reports said that he was informed of his firing in an email.

Chopra, whose five-year term was to end next year, was caught in the Trump purge of Biden administration hold-overs. He was among the last of the Indian Americans appointed by Biden to senior, high-visibility positions left after Trump took over. Chopra had served on the Federal Trade Commission as a nominee of the Democratic Party before Biden picked him to head the CFPB. The bureau says its mission is to protect consumers from "unfair, deceptive, or abusive practices" and deal with consumer complaints. In his last major action at CFPB, Chopra fined the international remittance company Wise about \$2.5 million on Thursday for inaccurately advertising fees and not properly disclosing exchange rates.





#### Eight Palestinians freed by Israel to be deported: Egyptian media

Egyptian side of the Rafah crossing received on Thursday eight Palestinian prisoners set for deportation after being released by Israel as part of the ongoing ceasefire deal with Hamas, Egypt's Al-Qahera News TV channel reported.

An Egyptian source, who required anonymity, told Xinhua that the released Palestinians, convicted of murder by Israel, will be deported to Turkiye, Qatar, Algeria, and Tunisia, af-

ter being transferred to Cairo. The source explained that Egypt would serve as a transit point for these released Palestinian prisoners until their departure to other countries. The decision on their destinations is coordinated with Israel, which required the deportation of Palestinian murder convicts, Xinhua news agency reported. According to a report by the Times of Israel on Wednesday, Israel demanded that Palestinians convicted of the most serious crimes not be released to the Gaza Strip or the West Bank. Egypt agreed to temporarily host these individuals, including 70 prisoners released last week, who are now in Cairo. Egyptian authorities are ramping up preparations to receive more

prisoners at the Rafah crossing,

Mohammed Zaqout, director general of hospitals in Gaza, told Xinhua that more than 6,000 wounded and sick Palestinians require urgent treatment, with 12,000 in need of care abroad.

> Israeli media outlets reported that the Israeli army withdrew from the Rafah crossing on Friday, handing control to international forces, and approved the list of patients permitted to leave.

New York, Feb 6 (IANS): China, Canada, and Mexico, the three biggest trading partners of the U.S., are bracing for tariff hikes threatened by President Donald Trump, who

also warned of "short-term disruption". Trump has said he would raise the tariffs on imports from Canada and Mexico by 25 per cent to strong-arm them to stop illegal migration to the US and the inflow of drugs, and on China by 10 per cent to end the export of the deadly Fentanyl drug and its components that find their way to the US. Although Trump has asserted

that the added cost would be absorbed by the exporters, he conceded on Thursday, "There could be some temporary, short-term disruption, and people will understand that." "But the tariffs are going to make us very rich and very strong - and we're going to treat other countries very

fairly," he added. The impact of the higher tariffs would not be fully felt immediately and will take time to seep into the retail markets.


#### 1st ODI: Kohli's injury appears minor, likely to get into action in next match

While disappointing, it does present a great opportunity for other players to perform for Australia in a world event," national selection panel chair George Bailey said in a statement.

Both Cummins Hazlewood will require extensive rehabilitation before they are declared fit to play. The big double blows mean Australia have four vacancies to fill in their Champions Trophy squad, after Mitchell Marsh was ruled out due to back injury and Marcus Stoinis surprisingly announced his retirement from the format.

#### Fritz prevails in Dallas opener for season's first home win

Dallas, Feb 6 (IANS): American No. 1 Taylor Fritz notched up his first home win of the 2025 ATP Tour season, cruispast Arthur Rinderknech 6-4, 6-2 at the Dallas Open on Thursday (IST) to open his campaign at the newly upgraded ATP 500 event.
