"The coalition government has been brazenly arresting people and foisting false cases to create an atmosphere of fear to subdue the opposing voice, but it's time we stand up for the people and start questioning the state," he said.

Jagan Mohan Reddy said that since a case of irregularities in liquor sales during the previous TDP rule was registered against Chief Minister N. Chandrababu

Naidu, he was trying to implicate YSRCP leaders in fabricated cases.

The former chief minister alleged that the government is making all efforts to suppress issues of public interest, irregularities, corrup-

We don't blame him for defending Indian industries. Rather, we question why past American leaders didn't do the same for our workers," he said. Expressing optimism about ongoing bilateral trade talks, he noted, "We're making good progress on the terms of reference for a trade agreement".

Addressing defence cooperation, Vance highlighted the growing strategic partnership between the two countries. "In defence, our nations enjoy a close relationship. We can co-develop advanced military platforms," he said.

The ED initiated an investigation on the basis of an FIR registered by the Vigilance.



Siddaramaiah neglected backward communities, claims K'taka BJP

Vijayapura, Apr 22 (IANS) : He said that the Congress and CM Karnataka BJP has held Janakrosh Yatra against the Congress government over price rise and Muslim quota in tenders in Vijayapura city in north Karnataka on Tuesday. Speaking at a public gathering

during the Janakrosha Yatra, BJP State President and MLA B.Y. Vijayendra claimed that ever since Siddaramaiah became the Chief Minister, he has completely neglected all the backward communities in the state.

Siddaramaiah have abandoned backward communities and are working only in favour of minorities.

Reiterating Siddaramaiah's recent budget announcement, Vijayendra stated that he promised 4 per cent reservation for Muslims in government contracts, Rs 50,000 financial aid for the marriages of Muslim women, and Rs 30 lakh in assistance for Muslim youth pursuing higher education abroad. He said Prime Minister Narendra Modi scrapped triple talaq to ensure dignity for Muslim women. Initiatives like the Bhagyalakshmi scheme and the Bicycle scheme introduced by B.S. Yediyurappa benefited not just Hindus but Muslims as well. He recalled that during the UPA regime, numerous scams had erupted, and youth had lost hope in the country's future. "But Prime Minister Modi revived that hope and proved that India has a bright future," he said.

Leader of the Opposition in the Legislative Council, Chalavadi

Narayanaswamy, in his address, stated that it is the BJP that has truly honoured B.R. Ambedkar. "We increased Dalit reservation and regularised civic workers," he said.

Narayanaswamy reminded that Ambedkar himself had referred to the Congress as a "house of destruction" and appealed to Dalits to understand this and join hands with the BJP.

He said the BJP government is correcting the "historical mistakes" committed by the Congress.



NIA files charge sheet against 5 more individuals in 2022 Coimbatore blast case

According to a statement, in its fourth supplementary charge sheet in the case RC-01/2022/ NIA/CHE, the NIA has charged Sheikh Hidayathullah, Umar Faaruq, Pavas Rahman, Sharan Mariappan and Aboo Hanifa for their involvement in terror financing and other activities linked with the terror attack that had targeted a Hindu temple, Arulmigu Kottai Sangameshwarar Thirukovil, in Coimbatore in October 2022.

'Act assault on constitutional values': Congress welcomes SC interim relief on Waqf Act

New Delhi, April 22 (IANS) : The Congress on Tuesday welcomed the Supreme Court's interim relief on the recently passed Waqf Act, which it termed "retaliation in the guise of reform".

The party highlighted that it was not defending a particular community but a "constitutional principle". It contended

the act was not aimed at improving but "infiltrating" and "controlling" the institutions.



Patna HC stays proceedings in National Anthem insult case against Nitish Kumar

Patna, Apr 22 (IANS) : The





Patna High Court (HC) has granted interim relief to Bihar Chief Minister Nitish Kumar by staying proceedings in a complaint case alleging insult to the National Anthem on Tuesday. The court has also issued a notice to the complainant in the matter. The order was passed by Justice Chandra Shekhar Jha during the hearing of a criminal petition filed by the Chief Minister seeking quashing of the complaint.

The controversy erupted following a video that went viral on social media platforms, showing Chief Minister Nitish Kumar waving his hands while the National Anthem was being played during the inauguration of the Sepak Takraw World Cup 2025 at Patliputra Sports Complex in Patna's Kankarbagh locality last



month. Acting on the video, Vikas Paswan, a resident of Begusarai, filed a complaint in the court of the Chief Judicial Magistrate (CJM), Begusarai, on March 22, 2025, accusing the Chief Minister of disrespecting the National Anthem. Due to the CJM being on leave, the matter was transferred to Judicial Magistrate

Mayank Kumar, who accepted the case for hearing and issued a notice to Nitish Kumar on March 25, asking him to present his defence by April 4, 2025. Appearing on behalf of the Chief Minister, Advocate General P.K. Shahi argued that the complaint was politically motivated and constituted a misuse of criminal law.

DoNER Minister bats for accelerating the Special Economic Zone in Manipur



India saved Rs 3.48 lakh crore as DBT cut leakages in last 10 years: Report



India's Direct Benefit Transfer (DBT) system has resulted in cumulative savings of Rs 3.48 lakh crore through a reduction in leakages that were taking place earlier, and a 16-fold expansion in ben-

sidy rationalization, and social outcomes. The newly developed Welfare Efficiency Index (WEI), which quantifies fiscal and social gains, surged from 0.32 in 2014 to 0.91 in 2023, underscoring systemic improvements, the policy document states.

According to the document, despite a rise in welfare budgets from Rs 2.1 lakh crore in 2009-10 to Rs 8.5 lakh crore in 2023-24, subsidy allocations declined proportionally, reflecting DBTdriven efficiency. It points out that food subsidies accounted for 53 per cent of total savings (Rs 1.85 lakh crore), while programs like MGNREGS and PM-KISAN achieved 98 per cent timely wage transfers and Rs 22,106 crore in savings, respectively. Aadhaar-linked authentication eliminated ghost beneficiaries, enabling coverage expansion without proportional fiscal expenditure. The study employs a mixed-methods approach, synthesizing Union Budget data, DBT portal records, and secondary sources. Analytical tools include correlation analysis, Granger causality tests, and the WEI-a composite metric weighting DBT savings of 50 per cent, subsidy reduction of 30 per cent), and benefi-

ciary growth of 20 per cent. The

policy recommendations emanating from the study include expansion of DBT coverage through the transition of resubsidy-based maining schemes to direct benefit transfer. It also recommends the strengthening of digital infrastructure and the prioritisation of rural and semi-urban banking access to bridge inclusion gaps. Besides, the study has come out in favour of leveraging advanced analytics with the integration of AI-driven

By replacing inefficient subsidies with targeted transfers, India has achieved measurable gains in welfare efficiency," the report states. Future efforts must focus on scaling up DBT's reach, harnessing technology, and sustaining inclusive growth to en-

sure equitable welfare governance, the report concludes.

MP Ordnance Factory received threat e-mails, search continues

"It cannot be revealed at this stage," commented one official. Given the gravity of the threat, senior officers assured that investigations are proceeding rapidly. Security within the factory has been significantly bolstered to prevent any untoward incidents. The factory, established as part of the Ordnance Factory Board (OFB) in 1979, was one of several facilities aimed at meeting India's defence equipment needs. The legacy of Indian Ordnance Factories stretches back to the 18th century when gunpowder factories were set up in Ishapore near Kolkata by the British East India Company. These facilities evolved into India's first Ordnance Factories in Cossipore, Kolkata.

Iran ready to expand all-out cooperation with Saudi Arabia : President Pezeshkian

Tehran, April 22 (IANS): Iranian President Masoud Pezeshkian met here with visiting Saudi Defence Minister Prince Khalid bin Salman bin Abdulaziz Al Saud, calling for expanding cooperation between their two countries in all areas.

Pezeshkian said on Tuesday that Iran is fully prepared to expand its relations with Saudi Arabia in all fields and extend bilateral cooperation to other Islamic countries, according to a statement published on the website of his office.

He also welcomed the establishment of joint working groups in various political, economic, and security areas, emphasising that Iran and Saudi Arabia could coordinate to resolve many of the problems in the region, without the need for foreign intervention, Xinhua news agency reported. The Saudi Defence Minister, for his part, described his meetings with Iran's Supreme Leader Ayatollah Ali Khamenei and Chief of Staff of the Iranian Armed Forces Mohammad Bageri earlier on Thursday as "very useful, positive, and constructive". He called Iran and Saudi Arabia "two main pillars of the region," stressing their strong relations could be an effective model for convergence and synergy in the Muslim world.

"We discussed our bilateral relations and topics of mutual interest," the Saudi Defence Minister wrote on X.

"Our belief is that the relationship between the Islamic Republic of Iran and Saudi Arabia is beneficial for both countries," Iranian state media cited Khamenei as saying in the meeting on Thursday. "Ties between the Saudi and Iranian armed forces have been improving since the Beijing agreement," Baqeri said after the meeting, according to Iranian state media.

Saudi Arabia has welcomed Iran's nuclear talks with the US, saying it supported efforts to resolve regional and international disputes.

Bangladesh demands US\$ 4.32 billion, apology for 1971 genocide from Pakistan

Dhaka, Apr 22 (IANS) : Bangladesh on Tuesday raised the issue of financial claim to the tune of USD 4.32 billion from Pakistan as a fair share from the assets of undivided Pakistan before 1971 besides also seeking a formal apology for the genocide committed by the Pakistani armed forces during the Liberation War.

The issues were raised during the Foreign Secretarylevel Foreign Office Consultation (FOC) held in Dhaka between the two countries after a gap of 15 years.

Bangladeshi Foreign Secretary Jashim Uddin led the Bangladesh delegation while the Pakistani side was represented by its Foreign Secretary Amna Baloch.

During the meeting, Bangladesh also demanded USD 200 million - the foreign aid from countries and agencies to East Pakistan during the extremely deadly Bhola cyclone.

"We said that as a friendly neighbour of Bangladesh in South Asia, we seek Pakistan's cooperation in building a strong, welfareoriented and forward-looking relationship with Paki-



stan by resolving the existing historical unresolved issues at the earliest and we emphasise on working together towards this end," Bangladesh Foreign Secretary Jashim Uddin told reporters at the Ministry of Foreign Affairs after the talks.

"These issues need to be resolved for having a solid foundation of our relations," he added.

Interestingly, the local media reported that the Pakistani side refused to comment on the outcomes of the meeting. During her visit, Baloch held separate meetings with Bangladeshi interim government's Chief Advisor Muhammad Yunus and Foreign Affairs Advisor Touhid Hossain, where they discussed issues of mutual interest.

During his meeting with the visit-

ing Pakistani Foreign Secretary, Yunus called for strengthening ties with Pakistan to boost mutual cooperation and explore trade and business potentials. "There are certain hurdles. We have to find ways to overcome those and move forward," Yunus said after Baloch called on him at the State Guest House Jamuna. Referring to the past, Baloch said Bangladesh and Pakistan must find ways to "harness the potentials between the two countries". "We have huge intra regional markets on our

own rights. We should use it. We can't miss the bus every time," Baloch said.

Following the FOC talks held for the first time between the two nations since 2010.

The weakening US dollar and interest rate cuts by the Federal Reserve have made gold, a non-yielding asset, more attractive to investors. Lower interest rates reduce the cost of holding gold, which leads to higher investments in the yellow metal.

Another major reason behind the price surge is central banks across the world, including India and China, increasing their gold reserves. This strategy, known as



'de-dollarisation,' is aimed at reducing reliance on the US dollar and preparing for economic uncertainties by investing more in gold.

On Tuesday, the Nifty marked its 29th anniversary, continuing to serve as a reflection of India's economic growth, investor confidence, and market sentiment. Launched by the National Stock Exchange (NSE) on April 22, 1996, the Nifty was introduced just two years after the exchange began operations. The index was created with a base date of November 3, 1995, and a base value of 1,000. Today, it tracks the performance of 50 of the most traded and largest companies in India across 15 sectors and represents about 55.48 per cent of the NSE's total free-float market capitalisation as of March 28, 2025.

JB Chemicals shares

fall over 13 pc in 6 months amid weak results, stake sale concerns

New Delhi, Apr 22 (IANS) : Shares of JB Chemicals and Pharmaceuticals Limited have seen a significant decline in recent months, dropping Rs 250.65 or 13.15 per cent over the last six months. The downward trend has continued through 2025, with the stock losing Rs 222.80 or 11.86 per cent yearto-date (YTD). On a yearly basis, the shares have slipped by Rs 132.55 or 7.41 per cent.

Even though the stock managed to close flat on the National Stock Exchange (NSE) on Monday at Rs 1,655.40, up slightly by Rs 9.10 or 0.55 per cent, the overall sentiment around the stock remains subdued.

The weakness in JB Chemicals' shares can be traced back to March 27, when the stock plunged 7.4 per cent in a single session.

The sharp fall came after reports surfaced that promoter Tau Investment Holdings Pte was planning to offload a 10.2 per cent stake in the company through block deals.





India's real estate sector saw 47 pc jump in investments in Jan-March: Report

New Delhi, Apr 22 (IANS) : Institutional investments in the real estate sector during Q1 (January-March) this year reached \$0.81 billion, marking a 47 per cent yearon-year increase, reflecting a renewed sense of confidence among investors, according to a report by real estate consultancy firm Vestian.

As investments approach the billion-dollar mark in Q1 2025, the residential sector has emerged as the frontrunner, dominating with 62 per cent of the total share up from 41 per cent in the same period last year. In value terms, investments reported an annual increase of 125 per cent, reaching \$506.1 Mn in Q1 2025, the report states. Commercial assets witnessed investments worth \$307.2 Mn in Q1 2025, accounting for 38 per cent of the total investments received during the quarter. While the share declined from 42 per cent in Q1 2024 to 38 per cent in Q1 2025, investments surged by 33 per cent in value terms during the same period.

Interestingly, the industrial and warehousing sector did not record any significant investment in Q1 2025. However, it is expected to garner investments in the future on the back of the rapidly growing e-commerce sector.

RBI issues new LCR guidelines for banks

Mumbai, April 22 (IANS) : The RBI has issued new Liquidity Coverage Ratio (LCR) guidelines which will require a bank to assign additional run-off rates of 2.5 per cent to internet and mobile banking-enabled retail and small business customer deposits with effect

from April 1, 2026. Banks will also have to adjust the market value of Government Securities (Level 1 HQLA)



Cement demand in India poised to rise 7.5 pc in 2025-26: Report

New Delhi, Apr 22 (IANS) : The cement sector is expected to see a 6.5-7.5 per cent demand growth this fiscal, driven by a 10 per cent rise in budgetary allocation for core infrastructure ministries and on expectation that an abovenormal monsoon will boost agricultural profitability -- in turn lifting rural housing demand, according to a Crisil report released on Tuesday. In fiscal 2025, cement demand growth was moderate at 4.5-5.5 per cent owing to a sluggish start to the year because of the general elections.





Sensex, Nifty extend winning streak for sixth day, rise nearly 8 pc in 6 sessions

Mumbai, April 22 (IANS) : The Indian stock market continued its upward journey for the sixth straight trading session on Tuesday, supported by gains in fastmoving consumer goods (FMCG) and private banking stocks. The Sensex began the day with a strong start, opening 320 points higher at 79,728. However, it soon slipped into the red, touching a low of 79,253, as investor sentiment was affected by steep losses in the US markets overnight. Despite the early fall, the Sensex recovered quickly and remained in positive territory for the rest of the trading day. It even touched an intra-day high of 79,824 before finally closing 187 points or 0.24

per cent higher at 79,596. With Tuesday's gains, the Sensex has now climbed 5,749 points, or 7.8 per cent, over the last six trading sessions, showing strong momentum in the domestic markets.

The Nifty also followed a similar trend. It slipped to a low of 24,072 during early trade but bounced back sharply to hit a high of 24,243. The Nifty finally ended the intra-day trading session with a gain of 42 points or 0.2 per cent at 24,167.

"Those who built their political empires on corruption, casteism, mafia power, and dynastic politics are now silent on incidents like Murshidabad," he remarked. Citing the example of Uttar Pradesh, he said that the mafia raj has been eliminated and today the state has turned into a safer and peaceful place.

"In the past, mafias used to control entire districts. They took over government contracts, caused riots, and harassed women and busi-



nessmen. People used to be scared during festivals. Today, festivals in UP are celebrated peacefully and with grandeur," CM Yogi stated. CM Yogi also drew a parallel between Murshidabad violence and what cities like Muzaffarnagar, Bareilly, Aligarh, and Lucknow faced in the past. The Chief Minister further blasted the Opposition for insulting national heroes like Shivaji, Maharana Pratap, and Rana Sanga, while glorifying figures like Aurangzeb, Babur,

and Jinnah, who he said were against the idea of India. He accused opposition parties and leaders of spreading propaganda and hatred in society for votebank politics. "To build a prosperous Uttar Pradesh and a self-reliant, developed India, it is important to respect our national heroes. This is also one of the pledges of the Prime Minister's 'Panch Pran' vision," he highlighted.

news." He added, "This has become a day-to-day activity. The use of ED and CBI as political weapons is a standard operating procedure under the BJP government." Bharti further alleged that the timing of the raid on Pathak was politically driven, given his growing promi-

nence within the party and his recent appointment as co-incharge for AAP's Gujarat campaign ahead of the 2027 state elections.

"There is massive anti-incumbency in Gujarat. Congress has never posed a real challenge to the BJP there. But AAP's entry has disrupted their comfort zone.

Agartala, April 22 (IANS) : Tripura Chief Minister Manik Saha on Tuesday said that the Waqf (Amendment) Act 2025 has been passed in the Parliament, aiming to address allegations of misuse of Waqf properties by a section of leaders, misuse of Section 40, land grabbing, and other corruption. Will not form coalition govt with BJP: AIADMK

Chennai, Apr 22 (IANS) : Senior AIADMK leader and Rajya Sabha MP M. Thambidurai on Tuesday ruled out the possibility of forming a coalition government with the BJP in Tamil Nadu, asserting that the AIADMK would form the government on its own if the alliance secures victory in the 2026 Assembly elections. Speaking to reporters, Thambidurai said: "Tamil Nadu has never had a coalition government - not under Congress veterans like C. Rajagopalachari and K. Kamaraj, nor under Dravidian

stalwarts like M.G. Ramachandran and M. Karunanidhi. Similarly, in 2026, Edappadiyar (Edappadi K. Palaniswami) will form the government alone.

There is no place for a coalition government in Tamil Nadu, and it will never happen." Thambidurai's remarks reinforce the statement made by AIADMK General Secretary and Leader of the Opposition Edappadi K. Palaniswami (EPS) on Wednesday, clarifying that the party's renewed alliance with the BJP is strictly for the 2026 Assembly elections and does not extend to governance. Palaniswami, addressing reporters after leading a walkout from the Tamil Nadu As-



sembly - in protest against the House's refusal to take up the AIADMK's no-confidence motion against the DMK government - said: "He (Amit Shah) never spoke about forming a coalition government. We have entered into an electoral alliance, not a governance pact." The AIADMK leader was responding to persistent media queries regarding Union Home Minister Amit Shah's comments during his visit to Chennai.

AAP Punjab chief slams Congress leader Bajwa for threatening state's peace

Chandigarh, April 22 (IANS) : Aam Aadmi Party (AAP) Punjab unit president Aman Arora on Tuesday slammed Congress legislator and Leader of Opposition (LoP) Partap Singh Bajwa for making "reckless" statements that threaten Punjab's peace and align with the agenda of the state's adversaries.

He called out the Congress and the BJP for their "failure" to clarify their positions on these "provocative" remarks, particularly those endorsed by controversial figures like designated terrorist Gurpatwant Singh Pannun. Arora told the media here that certain political leaders, desperate to revive their fading political relevance, are resorting to reckless and dangerous statements. "These politicians, instead of addressing the real issues of the people, are engaging in baseless rhetoric to further their political agendas," he said. He pointed out that such actions not only undermine the state's security but also create fear and panic among the people. Arora criticised Bajwa for his

statements regarding grenades allegedly entering Punjab, which he had earlier claimed in a media interview. Bajwa had linked these claims to intelligence reports, asserting that his sources were credible, though he later admitted that his information had come from a newspaper report. "If Bajwa had simply acknowledged that his source was a news article, the situation would have ended there. Instead, he chose to make sensational claims and spread fear," said Arora. He expressed disappointment that Bajwa, despite being a seasoned politician, failed to act responsibly and undermined public trust in state institutions. "Bajwa's comments have fueled fear and confusion," he said. He also highlighted the High Court's direction for Bajwa to co-



operate with the Punjab Police and refrain from making further inflammatory statements.

Arora also condemned the fact that extremist elements such as Pannun had used Bajwa's comments to justify their anti-national rhetoric. He pointed out that Pannun, who had previously threatened to destroy statues of B.R. Ambedkar in Punjab, had now echoed Bajwa's claims. "When leaders like Bajwa make such statements, it emboldens anti-national forces like Pannun, who then use the opportunity to further their divisive agenda," Arora said.

India's sugar production touches 254.97 lakh tons in current season

New Delhi, Apr 22 (IANS) : Sugar production in the current sugar season touched 254.97 lakh tons, as on April 15, with 38 factories operating across the country, according to a statement issued by the Indian Sugar and Bio-energy Manufacturers Association (ISMA) on Tuesday.

Around 35 lakh tons of sugar is expected to be diverted towards ethanol production this year, compared to last year's diversion of 21.5 lakh tons, the statement said.

As many as 22 factories are still operational during the current season in Uttar Pradesh, out of which 16 factories are operating in western UP.

Owing to the improved yield of plant cane, cane availabil-



ity has improved in UP, and these factories are expected to remain in operation up to late April 2025 or May 1st week. Moreover, sugar recovery has also shown improvement in the second half of the season, resulting in better output of sugar, the statement said.

In Maharashtra, one sugar mill in Pune district is expected to remain in operation up to the 2nd week of May this year.

At the same time, some factories

in south Karnataka are expected to restart operations during the special season from June/July to September 2025. Historically, Karnataka and Tamil Nadu collectively contribute around 4-5 lakh tons of sugar in the special season. ISMA is also optimistic on the outlook for the 2025–26 sugar season due to better crop prospects in the southern and northern states.

Uddhav Thackeray hijacked Shiv Sena, faked Balasaheb's legacy, claims Shinde faction

Mumbai, April 22 (IANS) :The Eknath Shinde-led Shiv Sena on Tuesday accused the Shiv Sena UBT chief Uddhav Thackeray of hijacking the Shiv Sena by emotionally blackmailing Balasaheb Thackeray during a crucial leadership transition.

Shiv Sena MP and spokesman Naresh Mhaske claimed that Uddhav Thackeray had threatened to leave the Thackeray household when Balasaheb was considering handing over party reins to leaders like Raj Thackeray, Ganesh Naik, and Narayan Rane.

"He used the same pressure tactic with Narayan Rane to consolidate his control," he added.

He recalled that Raj Thackeray had once offered to take charge of the party in regions where Shiv Sena was struggling, and that Balasaheb was willing to trust him with that responsibility - until Uddhav Thackeray intervened.

"It was emotional blackmail that pushed Balasaheb into handing over power to Uddhay," he alleged. Mhaske also slammed the Uddhav faction for what he called "manipulating Balasaheb's legacy" through doctored videos and fabricated statements. "You



misuse Balasaheb's voice because you lack the courage to directly criticise Eknath Shinde or Devendra Fadnavis," he said. Highlighting electoral performance, Mhaske said that Uddhav Thackeray's group contested 100 seats and won just 20, while the Shindeled Shiv Sena contested 80 and won 60.

'Nothing surprising': Mehbooba Mufti on Dulat's controversy

The father-son duo (Farooq Abdullah and Omar Abdullah) went to meet them (Prime Minister, Narendra Modi) on August 3, 2019. Farooq Sahib did not even go to Parliament on August 5, 2019. He stayed back. So nothing is surprising for me," said the former Chief Minister while addressing a PDP workers' convention in Srinagar.

Article 370, granting special status to the erstwhile state of Jammu and Kashmir, was abrogated by the Parliament on

also claimed that in 2014, Omar Abdullah met Amit Shah for government formation in Jammu and Kashmir. "He told Amit Shah not to form a government with the PDP, but to go with the NC and that too unconditionally," she alleged.

Dulat's book, titled 'The Chief Minister and the Spy', will be released on April 18. Trump signs memo to extend federal hiring freeze through July : White House

Washington, Apr 22 (IANS) : US President Donald Trump has signed a memorandum extending the federal hiring freeze through July 15, White House principal deputy press secretary Harrison Fields wrote in a post on social media platform X. The move is part of President

Trump and Elon Musk's aggressive efforts to cut spending within the federal government, CNN reported. The original action dictated that no new federal civilian positions could be created and no vacant positions could be filled. It specifies that it does not prohibit hirings to "maintain essential services, and protect national security, homeland security, and public safety". A fact sheet put out by the White House called the move "a critical step in shrinking the federal government and ensuring taxpayer dollars are used efficiently". "The American people elected President Trump to drain the swamp and end ineffective government programs that empower government without achieving measurable results," it said. The hiring freeze stops federal agencies from filling vacant positions or creating any new ones. The only exceptions are for immigration enforcement, national security or public safety positions. The freeze is now through July 15, and once that is up, agencies will still only be able to hire one employee for every four that leave. Trump first implemented the hiring freeze through executive order on his first day in office, and it was set to expire on Sunday.

"The President will usher in a Golden Age for America by reforming and improving the government bureaucracy to work for the American people," the administration said in January. "He will freeze bureaucrat hiring except in essential areas to end the onslaught of useless and overpaid Diversity, Equity, and Inclusion (DEI) activists buried into the federal workforce." The hiring freeze mirrors an initiative Trump took at the beginning of his first term. A memorandum he signed in January 2017 put a freeze on federal government hiring except for military and other positions that were deemed necessary. Since January, several federal agencies have been turned upside down with mass firings, while others have been liquidated altogether by the work of Elon Musk, whom Trump made the head of the Department of Government Efficiency (DOGE). The Department of Education has been reduced by nearly 50 per cent, and the Health and Human Services Department by around 24 per cent.

A government spokesperson said wheat has been procured from more than 2 lakh farmers, and Rs 1,400 crore has been transferred directly to the farmers' bank accounts. Last year, 18.24 lakh metric tonnes of wheat were procured.

Naveen Patnaik files nomination for BJD's president position for 9th time



Chennai, Apr 22 (IANS) : Justice N. Anand Venkatesh of the Madras High Court on Tuesday questioned Tamil Nadu Forest Minister K. 

At the storm's peak, over 8,700 Northland homes were affected, Xinhua news agency reported quoting Radio New Zealand (RNZ). Telecommunications were also impacted, with power outages affecting cellphone towers, RNZ reported on Tuesday. Air New Zealand cancelled multiple flights, and some Auckland ferry services were suspended. Motorists were urged to take care on the Auckland Harbour Bridge due to

high winds, with the local council receiving 284 storm-related calls between Wednesday night and Tuesday afternoon, local media reported. MetService, in its precautionary measure, has decided to continue referring to the weather system as Cyclone Tam, despite its technical downgrade. This is being done to emphasise and spread the seriousness of the situation.

The storm is now moving toward Coromandel, Bay of Plenty, and the upper South Island, prompting

warnings for a wild and wet Easter weekend, according to MetService forecast. Cyclone Tam, which formed earlier this week near New Caledonia, is bringing widespread disruption from Northland to Auckland and is expected to track further south by the end of the week. On April 16, a yacht reportedly sank off the Northland coast, while wind gusts reached up to 130 km/h at Cape Reinga. In Auckland, strong winds forced multiple lane closures on the Harbour Bridge throughout the




afternoon and evening.

Northland has so far borne the brunt of the storm, with residents warned to brace for continued strong winds, large swells, and possible thunderstorms. MetService meteorologist Georgina Law noted that "some locally intense bursts of rainfall" are also likely.

First India-Africa multinational maritime exercise will boost ties with African nations : MEA

New Delhi, Apr 22 (IANS) : India on Tuesday said that the first edition of the India-Africa Multinational Maritime Exercise, being co-hosted by India and Tanzania off the coast of Africa, marks a significant milestone in strengthening relations between India and the African nations.

The exercise, involving participation from nine countries - including Tanzania, Comoros, Djibouti, Kenya, Madagascar, Mauritius, Mozambique, Seychelles and South Africa - ends on April 18. It positions both India and African nations in leadership roles as far as security of the Indian Ocean Region (IOR) is concerned and is in line with India's maritime Mutual and Holistic Advancement for Security and Growth Across Regions (MAHASAGAR) vision, the Ministry of External Affairs (MEA) stated.





Sydney teenager charged with organising overseas contract killings

Sydney, Apr 22 (IANS) : Australian authorities have arrested and charged a teenage foreign national for allegedly facilitating contract killings in Europe. The Australian Federal Police (AFP) said on Tuesday that the 15-year-old was arrested on Wednesday after officers executed a search warrant in western Sydney.

In a joint statement with Danish Police and the Swedish Police Authority, the AFP said that the teenager is accused of using an encrypted application to facilitate plans for contract killings in Denmark and Sweden on behalf of a transnational crime syndicate. The Australian Broadcasting Corporation reported that the 15year-old is a Swedish national. He has been charged with one count

of using a telecommunications device to commit conspiracy to murder and one count of using a telecommunications device to commit murder. The AFP said that it commenced an investigation earlier in April after receiving information from Danish Police about a foreign national living in Australia allegedly linked to attempts to organise crimes-as-a-service contract killings in Europe.

Working closely with Belgium for Mehul Choksi's extradition to India, says MEA

New Delhi, Apr 22 (IANS): India on Tuesday said that it continues to "work closely" with the authorities in Belgium for the extradition of fugitive diamantaire Mehul Choksi to India. "Based on our extradition request, he was arrested in Belgium. We are working closely with the Belgium side for his extradition to India so that he can face trial in the country," said Randhir Jaiswal, spokesperson for the Ministry of External Affairs (MEA) at a regular media briefing in New Delhi on Tuesday. The Belgian Federal Public Service (FPS) of Justice on Monday confirmed the arrest of Choksi, who is wanted in connection with the Punjab National Bank (PNB) loan fraud case in India, revealing that the Indian authorities have introduced an extradition request for him already.

"The Belgian federal public service of Justice can confirm that Mr. Mehul Choksi was arrested on the Saturday 12th of April 2025. He is being detained in anticipation of further judicial proceedings. Access to his legal counsel has been assured," the FPS said.

"Please note that the prosecution services retain the right to refrain from comment in ongoing cases. Finally, the Belgian federal public service of Justice can confirm that the Indian authorities have introduced an extradition request for Mr.



Choksi. As is standard in individual cases, no further details can be released at this stage," it added.

The FPS acts like the Ministry of Justice and assists in preparation and implementation of legislation while supporting the Minister of Justice in the areas for which he is responsible. It also provides the guidance and operational support of the judiciary, with a focus on coordination and organisational development. It is responsible for the supervision of the adequate implementation of legal and administrative decisions, while guaranteeing legal certainty and equal treatment of all parties involved.

65-year-old Choksi was apprehended by the police in Belgium at India's request for his extradition. He was reportedly living in Antwerp with his wife, Preeti Choksi, after obtaining a 'residency card'.

Singapore PM outlines vision for regional, global cooperation amid global tensions

Singapore, April 22 (IANS) : To navigate an "increasingly fragmented and turbulent world," Singaporean Prime Minister Lawrence Wong has proposed three key thrusts to strengthen the city-state's regional and global partnerships.

Speaking at the S Rajaratnam Lecture, Wong said the first thrust is to "contribute actively to the stewardship of the global commons." Singapore, while maintaining its focus on Southeast Asia, will set aside more resources for partners further afield, including those in Africa, the Middle East, Latin America, the Pacific, and the Caribbean.

The second thrust is to "champion deeper regional cohesion and integration." Noting that the Association of Southeast Asian Nations (ASEAN) remains "central to Singapore's foreign policy," Wong called for eliminating 100 per cent of tariffs across the region, further reducing non-tariff barriers, and concluding the ASEAN Digital Economy Framework Agreement.

He also urged the upgrading of ASEAN's free trade agreements with key partners such as China, India, and South Korea, Xinhua news agency reported.

The third thrust is to strengthen Singapore's global network of partnerships. Wong advo-



cated for greater collaboration between the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) and the European Union (EU), while also deepening the ASEAN-EU Strategic Partnership.

Beyond economic ties, Singapore seeks to expand strategic partnerships with like-minded countries and forge new connections in regions like the Middle East, Africa, and Latin America, he said. To that end, Singapore plans to open new diplomatic missions in Africa and Latin America in the coming years.

Wong proposed the three thrusts in response to what he called "deeply worrying" global trends. While such practices, like using economic tools to advance national interests, are not new, he noted that they have reached new intensity with the latest US tariff moves.

New Delhi, April 22 (IANS) : India and China continue to make progress on finalising the modalities resume to Kailash Manasarovar Yatra which can start soon, the Ministry of External Affairs (MEA) announced on Tuesday.

"We will soon issue a notice for the public on the Kailash Mansarovar Yatra. There is a possibility of resumption of the Yatra soon," said Randhir Jaiswal, spokesperson for the Ministry of External Affairs (MEA) at a regular media briefing in New Delhi on Thursday. The Kailash Manasarovar Yatra has not taken place since 2020 following the Covid-19 outbreak and the subsequent non-renewal of Yatra arrangements by the Chinese side.
