



Trump offers to mediate Kashmir solution after announcing India-Pakistan ceasefire

Trump on Sunday ex pressed willingness to mediate a resolution to the decades-old Kashmir dispute between India and Pakistan, sarcastically terming it a conflict of "a thousand years," even as Pakistan breached a fresh ceasefire agreement within hours of its announcement.

New Delhi has been opposed to any third-party mediation on the issue as Kashmir is an integral part of India.

Posting on his social media platform, Truth Social, Trump lauded the ceasefire "understanding" between India and Pakistan that followed four days of escalating military hostilities triggered by the Pahalgam terror attack. He warned that the situation could have led to the deaths of millions if not controlled in time. "I am very proud of the strong and unwaveringly powerful leadership of India and Pakistan for having the strength, wisdom, and fortitude to fully know and understand that it was time to stop the current aggression that could have led to the death and destruction of so many, and so much. Millions of good and innocent people could have died! Your legacy is greatly enhanced by your brave actions," Trump wrote. Claiming credit for the de-escalation, which Islamabad broke nearly two hours after Trump's announcement, he added, "I am proud that the USA

was able to help you arrive at this historic and heroic decision. While not even discussed, I am going to increase trade, substantially, with both of these great Nations." Trump also proposed to mediate the Kashmir issue, a highly sensitive subject between India and Pakistan. "Additionally, I will work with you both to see if, after a 'thousand years', a solution can be arrived at concerning Kashmir. God Bless the leadership of India and Pakistan on a job well done!!!" he posted. However, hours after the ceasefire agreement took effect on Saturday evening, Pakistani forces violated the understanding by launching drone attacks and shelling Indian territories.

'Pak is rogue state, can never be trusted,' Army veterans slam ceasefire violations

In the wake of ceasefire violations by Pakistan, Indian Army veterans, Retired Lt Col Anil Bhatt and Major General P.K. Sehgal, have come down heavily on Islamabad's aggression, saying Pakistan is a rogue state which can never be trusted.

Lt Col Anil Bhatt (Retd) sharply criticised Pakistan's repeated breaches of the ceasefire agreement and likened its behaviour to that of a "rogue nation."

He remarked, "They have been caught lying so many times. And secondly, it's often said, though I hesitate to use the phrase, that it's like a dog's tail, which can never be straightened. This reflects the behaviour of the entire rogue state. In English, such a country is called a 'rogue state.'



Ayushman Bharat turns lifesaver, Uttarakhand woman shares her story of treatment

Ayushman Bharat Yojana is proving to be a lifesaver for many, particularly those belonging to poor families.

While lakhs of people from across the country benefit from the scheme, an elderly woman named Rasila from Mehuwala Mafi in Dehradun shared her story of recuperation, with help from government assistance.

She is a heart patient and had her heart operated some time

Beneficiary Rasila's daughter-in-law informed that she also got her son treated using the Ayushman card.

The beneficiary's daughter-

in-law, Sajida, said, "My motherin-law was very ill. She did not know that she had a heart problem. She has taken advantage of the Ayushman Card scheme. After reaching the hospital, it was found that she had a heart problem. Initially, two to three lakh rupees were needed."

She further said that they came to know that patients get benefits using the Ayushman card.

"After getting the Ayushman card made, we contacted the hospital and after this treatment of the mother-in-law became possible. Through this card, we have got free treatment up to Rs. 1.5 lakh," she said. She further stated that poor people do not have enough

money to get treatment for serious diseases. Every poor person should take advantage of this; with this card, one can get treatment up to Rs. 5 lakhs.

Sajida also said that if they didn't get the benefit of this scheme, they wouldn't have been able to get

Operation Sindoor: Pakistan punished through military and non-military means

Operation Sindoor marked a significant demonstration of India's military and strategic prowess through a blend of military and non-military means. while maintaining strategic restraint and international support. India employed a range of precise and deliberate military actions to achieve its objectives. The Indian Armed Forces carried out coordi-

This multi-dimensional operation successfully neutralised terrorist threats, deterred Pakistani aggression, and reinforced India's zero-tolerance policy toward terrorism, all while maintaining strategic restraint and international support. India employed a range of precise and deliberate military actions to achieve its objectives. The Indian Armed Forces carried out coordinated precision missile strikes on the nine terrorist facilities - four in Pakistan (including Bahawalpur and Muridke) and five in Pakistan-occupied Kashmir (such as Muzaffarabad and Kotli).

These facilities were key command centres for Jaish-e-Mohammed (JeM) and Lashkar-e-Taiba (LeT), responsible for attacks like Pulwama (2019) and Mumbai (2008).

In response to Pakistan's retaliatory drone and missile attacks on May 7, 8, and 9th, 2025, targeting multiple Indian cities and military installations, India launched kamikaze drones to destroy Pakistani

air defences across the country, including neutralising the air defence system of Lahore. India's air defence system proved instrumental in neutralising all incoming threats, resulting in near-zero casualties or material losses, and exposing flaws in Pakistan's HQ-9 system. India's counter-military actions on the night of 9th and 10th May also became the first instance of a country damaging the air force camps of a nuclear country. Within three hours, 11 bases were attacked, including Nur Khan, Rafiqui, Murid, Sukkur, Sialkot, Pasrur, Chunian, Sargodha, Skaru, Bholari and Jacobabad.

The scale of destruction was clearly visible in the before and after photos of Shahbaz airbase at Jacobabad.

In the strikes, various ammunition depots and bases like Sagodha and Bholari that housed F-16s and JF-17 fighter jets were hit. This led to the destruction of 20 per cent of the infrastructure of Pakistan's Air Force.

India bombed Pakistan's Bholari Air Base, killing over 50 people, including Pakistan's squadron leader Usman Yousuf, four airmen among others, as well as destroying Pakistan's fighter jets. Over the course of Operation Sindoor, multiple terror and military locations across Pakistan were attacked by India.



'Thumping Yes': IAF declares success in strikes against Pak under 'Operation Sindoor'

In a significant joint press briefing held by defence officials here on Sunday, Air Marshal AK Bharti confirmed that the Indian Air Force (IAF) successfully repelled Pakistani attempts to breach Indian airspace in the wake of India's decisive cross-border counter-terror strikes launched under 'Operation Sindoor'.

The large-scale Indian military operation, which began on May 7, was initiated in response to a brutal Pakistan-backed terror attack in Pahalgam, Jammu and Kashmir, that claimed 26 lives. The Indian military's swift and coordinated response marked one of the most comprehensive military actions in recent years.



Putin proposes direct talks with Kyiv in Istanbul to end Russia-Ukraine war

Russian President Vladimir Putin on Thursday proposed holding direct talks with Ukraine in Istanbul on May 15, hours after Kviv and European leaders called for an unconditional 30-day ceasefire to start on Monday.

Putin did not explicitly address that call in his statement, delivered after 1 a.m. in the Kremlin, instead outlining the counter-proposal for fresh Russia-Ukraine negotiations.

"We propose to the Kyiv authorities to resume the talks that they broke off in 2022, and, I emphasise, without any preconditions," Putin said. The leaders of Ukraine, Brit-

Moscow, May 15 (IANS): ain, France, Germany and Poland had in Kyiv on Saturday threatened Moscow with fresh sanctions and military support for Ukraine if Russia did not agree with the proposal.

Russian and Ukrainian negotiators held direct talks in Istanbul in the first weeks of the conflict, but failed to agree to halt the fighting, which has been raging ever since.

"We propose to start (negotiations) without delay on Thursday, May 15 in Istanbul," Putin said, adding that he would talk to Turkish President Recep Tayyip Erdogan soon to ask for his help to facilitate the talks.

Putin said he was "committed to serious negotiations with Ukraine" and that he wanted talks to "eliminate the root causes of the conflict and to establish a long-lasting peace".

Hamas to free Israeli-American hostage in bid to secure ceasefire

Gaza, May 15 (IANS): Hamas said that it will re-istration in recent lease Israeli-US hostage Edan Alexander from the Gaza Strip as part of efforts to secure a ceasefire and reopen border crossings for aid delivery.

Jerusalem, May 15 (IANS): Israel's military issued an urgent warning, advising all civilians and workers to evacuate three Red Sea ports in Yemen controlled by Houthi forces, citing the risk of a possible new strike. In a statement on the social media platform X, Israeli military spokesperson Avichay Adraee identified the ports as Ras Isa, Hodeidah, and Al-Salif.

Ceasefire agreement reflects India, Pakistan commitment to regional peace: UNGA president

United Nations, May 15 (IANS): United Nations General Assembly President Philemon Yang has said the cease-fire agreement between India and Pakistan reflects their commitment to regional peace. Welcoming the ceasefire, he said on Thursday, "It is a meaningful step towards de-escalation reflecting the commitment of both nations to regional peace and stability." Secretary-General Antonio Guterres sees the ceasefire agreement between India and Pakistan as a "positive step" towards easing tensions and hopes it will contribute to "lasting peace," according to his Spokesperson Stephane Dujarric. India and Pakistan reached a cease-fire agreement on Saturday. However, hours after the agreement, Pakistan violated the ceasefire. Foreign Secretary Vikram Misri said that the Indian armed forces have been responding adequately to the ceasefire violations. Speaking at a press briefing, Misri said the government has taken a serious note of the Pakistani actions. "This is a breach of understanding. The army is monitoring the situation closely," he said. He informed that the agreement to halt the ongoing hostilities over the past few days was reached this evening. However, in the past



few hours, there have been serious violations of this agreement from the Pakistani side. Notably, India launched 'Operation Sindoor' on Wednesday, targeting "terrorist infrastructures" in retaliation against last month's killing of 26 people in the Kashmir tourist spot Pahalgam by The Resistance Front, an offshoot of the Pakistan-based Lashkar-e-Taiba. While the tension was mounting last week, Guterres had expressed deep concern over the conflict, saying.

Iran says nuclear talks 'more serious,' rejects US call to dismantle facilities

Tehran, May 15 (IANS): Iranian Foreign Minister Abbas Araqchi said that indirect negotiations with the United States in Oman to revive the 2015 nuclear deal had become "much more serious and frank," as President Masoud Pezeshkian rejected US demands for Tehran to dismantle its nuclear infrastructure.

The talks in Muscat, facilitated by Oman, mark the latest effort to salvage the Joint Comprehensive Plan of Action. The United States unilaterally withdrew from the accord in 2018 under US President Donald Trump's first term, prompting Iran to reduce compliance with its nuclear commitments gradually, Xinhua news agency reported.

Araqchi, speaking to Iran's staterun IRIB TV after the fourth round of negotiations in Oman's capital, said the discussions had infrastructure. shifted from general topics to more specific proposals. He characterised the talks as "forward-moving" but acknowl-

edged the growing complexity of the issues. Both sides agreed to continue the discussions.

The latest round, lasting about three hours, follows previous sessions in Muscat on April 12 and 26, and in Rome on April 19. Meanwhile, President Pezeshkian firmly rejected US calls to dismantle Iran's nuclear

"This is unacceptable. Iran will not relinquish its peaceful nuclear rights," he declared, reaffirming Tehran's stance that its

nuclear program is for civilian purposes. He also referenced a religious decree from Supreme Leader Ali Khamenei banning nuclear weapons development. US notifies Israel Hamas plans to release Israeli-American hostage: PM Netanyahu office



Jerusalem, May 15 (IANS): The office of Prime Minister Benjamin Netanyahu confirms that the United States has informed Israel that Hamas will release hostage Edan Alexander "without any compensation or conditions," in what Washington described as a goodwill gesture expected to pave the way

for broader negotiations. The release, possibly set for Thursday, would be the first not tied to the exchange of Palestinian prisoners. Alexander, a US-born soldier, was abducted on October 7, 2023, when Hamas-led gunmen killed around 1,200 people and took around 250 hostages in a cross-border assault

on southern Israel, Xinhua news agency reported. "The United States conveyed to Israel that this move is expected to lead to negotiations based on the original Witkoff framework, which Israel already accepted," Netanyahu's office said, referring to a US-backed plan proposing a phased release of hostages in return for an extended ceasefire. The Witkoff plan, unveiled in March, envisions the release of roughly half of the surviving hostages in exchange for a 50day truce and subsequent talks. It does not include Hamas's demands for a full Israeli withdrawal from Gaza or the release of Palestinian prisoners.

UN to host first high-level meeting on North Korea's human rights violations

Seoul, May 15 (IANS): The United Nations General Assembly (UNGA) will hold its first high-level meeting next week over human rights abuses and violations by North Korea, diplomatic and civic group sources said Thursday. In a circulated letter, UNGA President Philemon Yang announced a plan to convene a high-level plenary meeting on May 20 to address North Korea's human rights violations, in accordance with a relevant UNGA resolution adopted in December last year, the sources said. It marks the first time that a high-level meeting on the North Korean human rights situation will be hosted by the UNGA, Yonhap news agency reported. A previous high-level meeting on the subject, held in September 2014 during a UNGA session, was hosted by the South



Korean and US governments along with the Office of the United Nations High Commissioner for Human Rights. No new sanctions against North Korea have been passed since 2018. In May 2022, Russia and China vetoed a new sanctions package proposed by the United States in response to North Korean ballistic missile tests, a violation of UN sanctions. A foreign ministry official told Yonhap News Agency that the ministry is currently reviewing options to dispatch a senior official from Seoul, the top envoy to the UN or another representative to the meeting.

Tiger mauls woman to death in MP

Bhopal, May 15 (IANS): In another tragic and horrifying incident of human-tiger conflict, a woman lost her life to a tiger attack in Madhya Pradesh's Seoni district. The incident occurred in the forest near Bichhua village in the Kurai area, within the Rukhad buffer zone of the South General Forest Division on Saturday. Confirming the report, a senior forest official told IANS, the attack happened early in the morning when the victim ventured into the forest to pluck tendu leaves. The tiger, estimated to be around four to five years

old, struck suddenly and fatally wounded the woman.

"We are working to rescue the animal, but first, we need to determine the reason behind its aggression. Typically, older or injured tigers seek out easy prey and sometimes attack humans out of desperation. However, in this case, the tiger was not old," the officer said. The victim has been identified as 50-year-old Hemlata Daharwal. Tendu leaves are used as a wrapper for beedi. Fresh leaves are hand-picked by the tribals in summer. The activity generates additional income for

them. The State Government gives the license for the collection and processing of the tendu leaves through a tender every year. According to police, the animal lunged at her, sinking its claws and teeth into her neck and other parts of her body. She died instantly. The tiger then dragged her remains to few meters into a dense area of the forest.

Witnesses nearby responded quickly - more than 50 villagers swarmed the scene upon hearing the commotion, and loud cries startled the tiger, forcing it to abandon the body and flee.

Nation won't accept anti-national voices: Giriraj Singh

New Delhi, May 15 (IANS): the recent understanding reached Union Minister Giriraj Singh, on Thursday, strongly asserted that the nation stands united in support of the Indian Army and the government's handling of the India-Pakistan border situation, warning that "anyone who speaks against the nation will never be accepted by the country."

His remarks come amid a wave of political reactions following on a ceasefire between India and Pakistan after days of cross-border tensions.

Commending the Indian Army, Singh said, "The entire nation is proud of the bravery of the Indian Army, which has demonstrated its valour. People have full faith in the country's leadership. Both Prime Minister Narendra Modi and the Army have made the nation proud. We say with pride, we are Indians." Interestingly, the ceasefire decision has garnered bipartisan support, with several senior opposition leaders backing the move and lauding the government's stance.

Former Union Minister and senior Congress leader P. Chidambaram described the decision as "wise" and credited Prime Minister Modi for not escalating the situation further. Chidambaram's support of the government's action drew considerable attention, leading to reactions across the political spectrum. Congress MP Shashi Tharoor echoed Chidambaram's sentiment, stating that the message India intended to send had already been delivered. "Prolonging the conflict was never the intention," Tharoor said, suggesting that the ceasefire was a responsible step towards de-escalation.

Congress leader Manish Tewari also highlighted the rare political unanimity, saying, "The entire opposition has welcomed and praised the actions taken by the Indian Army. The whole nation, be it the ruling party, the opposition, or the common people, has stood united. This is a living example of India's internal strength and unity." Mrityunjay Tiwari of the RJD welcomed the ceasefire but cautioned against complacency. "India is a peace-loving country, and any steps towards peace will



be welcomed. However, the violation of the ceasefire is the real concern here. India does not start wars, but will not sit silently if attacked. Further clarity on the circumstances that led to this ceasefire is still awaited," he noted.

Ceasefire is just a means to expose Pakistan before the world: Nishikant Dubey

New Delhi, May 15 (IANS): BJP leader and member Lok Sabha, Nishikant Dubey, on Thursday said the ceasefire was a means to expose Pakistan before the world, which will continue with terrorism and in that case, the fight will be fierce and Pakistan-occupied Kashmir will be taken.

He said he has faith in Prime Minister Narendra Modi and that this will be the last battle. Hours after India and Pakistan reached an understanding on stopping military actions, Pakistani drones were sighted and intercepted in various locations in Jammu and Kashmir, including Srinagar, parts of Gujarat, and Barmer in Rajasthan. Blackouts had to be reimposed in several border areas. India said Pakistan violated the ceasefire, adding that the armed forces were giving an "adequate and appropriate response".

Govt tightening rules to check gas emissions in upstream oil sector

New Delhi, May 15 (IANS): The Centre's new draft policy framed for the upstream oil & gas exploration and production sector aims to minimise the environmental impact of mineral oil operations, including gas flaring activities, and closer monitoring of greenhouse gas emissions and flared gas.

Routine flaring of gas takes place during production from oilfields due to the absence of facilities for gas utilisation, such as reinjection, on-site use, or transportation to market. The draft policy stipulates that all lessees and contractors shall submit reports specifying the volume of gas flared and the associated emissions on a quarterly basis in accordance with the format specified within fifteen days from the end of each calendar quarter.

The rules make it clear that every lessee and contractor will adopt measures to reduce greenhouse gas emissions that take place during the course of mineral oil operations and comply with the applicable environmental laws and

The draft rules state that every lessee and contractor shall submit a monitoring plan within 180 days of the commencement of production of mineral oil from the leased area for the identification of sources of greenhouse emissions from mineral oil operations, and the methodology and frequency of



and update the monitoring plan submitted from time to time as may be necessary. Every lessee and contractor will also submit to the government reports of their greenhouse gas emissions in the manner as may be specified by the government from time to time. The new draft also provides for

clear steps in the authorisation for greenhouse gas (GHG) sequestration, injection and storage permit. Any lessee or contractor intending to assess the feasibility of geological storage of greenhouse gases (GHGs) within a leased or contract area shall, prior to commencement of any such activity, obtain an authorisation for such assessment from the Government.

Bharti Airtel's Q4 net profit slips 23 pc, sales up as India market grows

Mumbai, May 15 (IANS): Bharti Airtel on Thursday reported a 22.68 per cent sequential decline in its net profit for the fourth quarter (O4) of FY25, as a sharp swing in tax expense weighed on earnings. The company's net profit dropped to Rs 12,475.8 crore from Rs 16,134.6 crore in the previous quarter (Q3), according to its stock exchange filing. The profit decline was largely driven by a shift from a tax

gain of Rs 757.3 crore in Q3 to a tax expense of Rs 2,891.9 crore in Q4, putting pressure on the bottom line despite revenue growth. The telecom major's revenue from operations grew 6.1 per cent quarter-on-quarter (QoQ) to Rs 47,876.2 crore in Q4, up from Rs 45,129.3 crore in Q3.

The increase was supported by solid momentum in the India market, a rebound in Africa's reported currency revenues, and the fullquarter impact of Indus Towers consolidation. However, one segment that saw a pullback was Airtel Business, which posted a 2.7 per cent year-on-year (YoY) decline in revenue.


This was due to a deliberate move to phase out low-margin services like global wholesale commodity voice and messaging.

The company said this strategic transformation is part of its broader goal to focus on highervalue, sustainable business areas. In India, quarterly revenues grew by 6 per cent to Rs 36,735 crore, supported by better realisations in

the mobile segment and strong performance in the homes business. Average revenue per user (ARPU) rose to Rs 245 in Q4, up from Rs 209 in the same quarter last financial year -- reinforcing Airtel's premiumisation strategy.

The company's homes business saw impressive growth, with a 21.3 per cent jump in revenue YoY, helped by strong customer additions and accelerated fiber and home-pass expansion.

The company added over 800,000 new customers during the quarter, bringing the total base to 10 million. Vice-Chairman and MD Gopal Vittal said the company ended the financial year on a strong note, despite the dip in profit. He added that Airtel remains focused on premium growth areas, supported by solid



cash generation and disciplined capital spending. Airtel also prepaid Rs 5,985 crore in highcost spectrum dues last quarter, bringing total prepayments to over Rs 42,000 crore in the past two years, which has strengthened the balance sheet.

Bengal areas under intelligence surveillance after three JMB activists arrested

Kolkata, May 15 (IANS): After the arrest of three Jamaat-ul-Mujahideen Bangladesh (JMB) activists in West Bengal in the last two days, the intelligence agencies, both central and state, have increased surveillance in pockets that have records of the presence of sleeper cells of various fundamentalist and terrorist groups.

On interrogating them, the investigating officials came to know of their associate, Abasuddin Molla, who was arrested on Saturday from his residence at Patra village under Diamond Harbour Lok Sabha constituency in South 24 Parganas district of West Bengal. Similarly, some pockets in East Burdwan district, especially the minority-dominated ones.

According to police, Ayyappan's scooter was found abandoned on the riverbank. The Srirangapatna police, who are handling the case, said a missing person complaint had been filed earlier by his family with the Vidyaranyapuram police station in Mysuru.

'War is not India's choice': NSA **Doval speaks to Chinese Foreign** Minister Wang Yi amid India-Pak tensions

New Delhi, May 15 (IANS): In a highlevel diplomatic exchange, Indian Na-

tional Security Advisor (NSA) Ajit Doval on Saturday held a telephonic conversation with Chinese Foreign Minister Wang Yi and reaffirmed that "war was not India's choice" and emphasised India's commitment to ceasefire and restoring peace with Pakistan.

The talks between India and China were held following the deadly terrorist attack in Jammu and Kashmir's Pahalgam that claimed the lives of several Indian personnel. During the call, Doval reportedly conveyed that the recent terrorist attack in Pahalgam resulted in serious casualties and necessitated counter-terrorism actions by India. The conversation, disclosed by China's Ministry of Foreign Affairs, focused on regional stability and the imperative of maintaining peace amid escalating India-Pakistan tensions.

According to Beijing's readout, NSA Doval described the Pahalgam attack as a grave incident necessitating counter-terrorism responses, but reaffirmed that "war was not India's choice" and emphasised India's commitment to ceasefire and restoration of peace with Pakistan. Foreign Minister Wang Yi condemned the attack and reiterated China's firm opposition to terrorism in all forms.

"The Pahalgam terrorist attack caused serious casualties among Indian personnel and that India needed to take counter-terrorism actions. War was not India's choice and was not in the interests of any party. India and Pakistan would be committed to a ceasefire and look forward to restoring regional peace and stability as soon as possible," Chinese Foreign Ministry quoted NSA

"Peace and stability in the Asian region is hard-won and deserves to be cherished," Wang said, adding that both India and Pakistan, as immediate neighbours of China and each other, should resolve disputes through dialogue and avoid further escalation.

"China appreciates your statement that war is not India's choice," Wang told NSA Doval, expressing hope that both India and Pakistan would remain calm, exercise restraint, and reach a "comprehensive and lasting ceasefire" through mutual consultations -- an outcome China believes aligns with the fundamental interests of both countries and the expectations of the global community.

However, events on the ground soon painted a grim contrast to the diplomatic tone. Just hours after India and Pakistan announced a mutual understanding to halt military actions, the truce appeared to collapse under renewed hostilities.

In a late evening press briefing, Foreign Secretary Vikram Misri accused Pakistan of violating the ceasefire terms agreed upon by the Directors General of Military Operations (DGMOs).

Employment figures in both public and private sectors have shown remarkable growth, with the total number of workers rising from 2.9 crore in 2020-21 to 3.87 crore by 2024-25. The government credited several flagship schemes, such as Makkalai Thedi Maruthuvam, Illam Thedi Kalvi, Naan Mudhalvan, and Kalaignar Kanavu Illam, for the rapid development.

3 sacks of decomposed flesh: Mystery chase lands Delhi cops at caterer's doorstep

New Delhi, May 15 (IANS): The mystery behind the recovery of three sacks of decomposed flesh in south Delhi's upscale Malviya Nagar colony has been solved with a caterer admitting to disposing of goat slaughter waste irresponsibly, a police official said on Thursday. Initially suspected to contain human or communally sensitive cattle body parts, the sacks' contents turned out to be hides, bones and offal of goats that were slaughtered by the caterer to cook mutton for hundreds of guests at a mega wedding reception.

"We have managed to identify and reach the culprit," said an aide of Deputy Commissioner of Police, South District, Ankit Chauhan. The discovery of the three sacks – with blood oozing from them and stench of decomposed flesh hanging in the air had caused a commotion in the area on April 21 with some residents.

The Chief Minister, who reached Nangal town to protest against the move of BBMB to release water, said. "It's unfortunate that on one hand Punjab is bravely confronting the enemy on the international border and on the other, the BJP government at the Centre is playing dirty games to deprive state of its waters". He said Punjab "is on high vigil as Punjab Police are helping the Army to safeguard the 532-km border along with Pakistan".





Punjab BJP chief Jakhar meets shelling victims, seeks Central package for state

Ludhiana, May 15 (IANS): Punjab BJP chief Sunil Jakhar on Thursday visited DMC Hospital here to meet victims from Ferozepur who were injured in Pakistani shelling and drone attacks in a village. Jakhar emphasised the need for collective action. "Given Punjab's strategic location and the economic constraints, especially in terms of disrupted trade, border zone restrictions and heightened security risks, it is imperative that we now pursue a structured and sustained form of the Central (government) support," he was quoted as saying. At the all-party meeting, attended, among others, by Governor Gulab Chand Kataria and Chief Minister Bhagwant Mann, Jakhar raised the need for a special economic package for Punjab, keeping in mind the continuing losses the state suffered owing to a border state. The state BJP president specifically proposed that Punjab should be considered for a special status on the lines of what is extended to states like Jammu and Kashmir.

Indian Army taught Pakistan a lesson : Jitan Ram Manjhi

Patna, May 15 (IANS): A day after the ceasefire between India and Pakistan, Union MSME Minister Jitan Ram Manjhi praised the Indian Army's swift and decisive action during Operation Sindoor, asserting that Pakistan was forced to seek U.S. mediation due to the pressure exerted by India's military might.

"Within just two days of Operation Sindoor, the Indian Army taught a tough lesson to Pakistan. Now they understand the power of our defence forces," Manjhi said, addressing the media in Gaya on Thursday.


He further added that the Indian government's stance on terrorism remains unchanged despite the ceasefire, highlighting the termination of the Indus Waters Treaty as a strong diplomatic move post-Pahalgam terror attack. "Any terrorist activity from now on will be treated as an act of war.



Operation Sindoor: Know what India has achieved

New Delhi, May 15 (IANS) : India, rattled and angered by the dastardly April 22 Pahalgam terror attack, launched a massive strike deep inside Pakistan and Pakistan-occupied J&K in the early hours of May 7, targeting the terror launchpads, to avenge the brutal killing of its civilians. The operation was an absolute success. Let's have a look at what India has achieved. Nine Terror Camps Destroyed India neutralised 9 high-value terror launchpads across Pakistan and PoK. Targets belonged to Lashkare-Taiba, Jaish-e-Mohammed, and Hizbul Mujahideen. The locations were identified as key training and operational centers for planning attacks against India. Deep Strikes into Pakistan's Mainland India has changed the terms

of engagement, displaying willingness to strike deep into Pakistan's heartland. India shredded the notion that terrorists are separate from terrorist backers and thus targeted both, shifting to a new paradigm. Strikes extended



hundreds of kilometers inside Pakistan, not just PoJK. India struck targets even in Punjab province, considered a strategic stronghold of Pakistan's military.

India struck at sensitive terror hubs such as Bahawalpur, places which even the US had not dared to send its drones, sources said. India has made it clear that neither the LoC nor internal Pakistani geography is off-limits if terror emanates from its soil. Through its strikes, India has proved to the world that every inch of Pakistan was under reach.

Red line drawn

India's response asserted a doctrinal shift toward calibrated deterrence. Operation Sindoor has drawn a red line Pakistan can no longer ignore - that terrorism as state policy will trigger targeted, visible consequences. New paradigm against terror For the first time, India decisively rejected the distinction between terrorists and their sponsors, taking action against both. It also undermined the long-standing assumption that certain influential rogue elements within the Pakistani state could orchestrate terrorist activities with impunity. Exposed Pakistan's Fragile Air Defence Indian forces successfully bypassed or jammed

Pakistan's air defence grid. The swift and precise nature of the strikes, conducted within a 23-minute window, highlighted gaps in Pakistan's air defense systems. Indian Rafale jets equipped with SCALP missiles.

The tour match is the visitors' only fixture ahead of their much-anticipated return to Test cricket on English soil for the first time since 2003. The one-off Test at Trent Bridge, scheduled for 22-25 May, marks a historic chapter in the team's red-ball journey. For Zimbabwe, the warm-up match represents a crucial opportunity to acclimatise to English conditions ahead of the highly anticipated encounter. "Look, there's a few things that we're really looking forward to getting out of this match," Zimbabwe assistant coach Dion Ebrahim said after the



Ebrahim underscored the importance of refining Zimbabwe's game plan ahead of the Trent Bridge showdown. "It's also for, I guess, all the players to start really narrowing and solidifying what their game plans will look like as we hit England," he said. "It's like it's part and parcel of



being an international cricketer — so the need to be able to adjust and adapt to different conditions is a necessity. "So rather than, I guess, create too many demons around it, it is what it is. We've got to find the tools and the strategies to overcome the differences. "And, look, it's not something that's too foreign. It's just

ensuring that we're able to narrow our basics and be able to do them for a long period." Ebrahim also spoke about the broader significance of Zimbabwe's return to Test cricket in England, describing it as a chance to reclaim their place on the global stage.
