

Hyderabad, June 3 (IANS): Telangana Deputy Chief Minister Mallu Bhatti Vikramarka has said that the Congress government brought the Bhu Bharati Act to permanently solve the land woes faced by people, especially farmers.


He, along with Revenue Minister Ponguleti Srinivas Reddy and Agriculture Minister Tummala Nageswara Rao, attended 'Revenue Sadassu' in Mulugumadu village of Yerrupalem mandal in Khammam district on Tuesday. Bhu Bharati Revenue Sadassu are being organised from June 3 to 20 to create awareness among farmers about the Bhu Bharati (Record of Rights) Act, which came into force in April.

Bhu Bharati portal was launched by the state government as a solution to land-related issues, which cropped up after the introduction of the Dharani portal by the previous Bharat Rashtra Samithi (BRS) government.

The Deputy Chief Minister claimed that the Congress government brought the legislation in a transparent manner. Vikramarka described Bhu

Bharati as the best revenue legislation in the country. The legislation aims to conduct a survey of farmers' lands and fix their boundaries without any disputes.

### KTR meets students of **University of Texas Dallas**

Dallas today and promised to provide legal support to Telugu students facing difficulties in the U.S. He advised the students to understand American laws and the changes happening in their society. He also asked the students to take inspiration from the life of KCR and strive to achieve goals. "For India to compete globally, the youth studying abroad must contribute. He advised the students to complete their higher education and establish companies in our country", he added.

KTR stated that his party would stand by Indian students in the US, who are facing difficulties for various reasons. He emphasized that many students come to the U.S. for higher education with great hopes, and if they unknowingly make mistakes due to a lack of awareness, BRS' U.S. wing would work to provide the necessary legal assistance. He acknowledged the emotional toll when students have to return due to such situations, affecting not just them, but their families too. Hence, he said, a decision was made to support them. KTR also advised that students must understand U.S. laws and societal changes and adapt accordingly. Every student should be aware of local laws and social dynamics, he added.

Today, KTR interacted with students studying at the University of Texas at Dallas. He responded to several questions raised by the students. He said going to the U.S. and studying there involves significant effort and expenses, but the world is changing rapidly, and many opportunities are now available. He pointed out that U.S. education has become more accessible to many.

KTR urged students to focus not just on ranks

and grades but on life goals. He noted that life passes by quickly, and one should strive to fulfil dreams and aspirations within this short span. Even if there are obstacles or people trying to pull you back, he emphasized moving forward with commitment. Students should not aim only for jobs but work towards bringing positive change in society and the world.

KTR highlighted that innovation is happening globally, and India must compete with other countries in this domain. He encouraged Indian students studying in U.S. institutions to focus on innovations. He cited KCR's life as proof that dreams come true when one takes risks. He mentioned how KCR, at an age considered young in politics (early 40s), gave up positions to fight for the creation of Telangana. Many ridiculed him at that time, but after 14 years of persistent struggle, he succeeded in achieving statehood, earning praise from all sections of society. KTR answered several student queries and encouraged them to return to India after their studies and start their own companies.

#### Rajasthan: Jodhpur, Kishangarh airports closed till May 10; leaves of Rly officials cancelled

Jaipur, June 3 (IANS) :A high alert has been issued across Rajasthan in the wake of air strikes by Indian Armed Forces in Pakistan and Pakistan-occupied Kashmir, prompting stringent security measures across the desert state, an official said on Tuesday. Authorities have suspended all flight operations from Kishangarh and Jodhpur airports until May 12.

Additionally, Bikaner airport has been closed for the day, and IndiGo Airlines has canceled all its flights to Bikaner until further notice.

According to Jodhpur Airport Director Dr. Manoj Unival, nine flights were canceled on Tuesday, and passengers were promptly informed through text messages. A Help Desk has also been established at the airport to assist travelers. A total of 16 flights operating from Kishangarh and Jodhpur will be affected due to the suspension over the next three days. As a precautionary measure, schools in Sri Ganganagar, Barmer, Jaisalmer, and Bikaner -- all located near the international (India-Pakistan) border -- were closed on Wednesday. Ongoing school examinations were also canceled following directives issued by respective District Collectors. In Bikaner and Sri Ganganagar, all government employees have been instructed not to leave their headquarters.



Their holidays have been cancelled, and they need to remain available for emergency duties as needed. In a significant move, the North Western Railway has canceled all holidays of its officers and employees amid the heightened alert. A circular issued by the General Manager of the railway zone directed all Divisional Railway Managers and department heads to ensure their staff report back to duty immediately. These emergency steps are part of a broader state-level response to the regional security situation and aim to ensure preparedness for any eventuality along the border.

#### After month-long exposition in Vietnam, holy Buddha relics return to India

he holy relics of Lord Buddha returned to In dia on Tuesday after a spiritually significant month-long exposition tour across Vietnam. The relics were ceremoniously received at Palam Air Force Station in New Delhi. The delegation accompanying the relics was led by Hari Babu Kambhampati, Governor of Odisha, along with representation from the International Buddhist Confederation (IBC), led by Ven. Shartse Khensur Jangchup Choeden Rinpoche, Secretary General, and National Museum officials.

"The holy relics will be publicly displayed at the National Museum, Delhi, for a day, allowing devotees and dignitaries to offer their respects. A formal prayer meeting with senior monks, IBC officials, and diplomats will follow," the IBC said in a post on X. "On June 4, the relics will travel in a Presidential cavalcade to Sarnath via Varanasi, where they will be ceremonially enshrined at Mulagandha Kuti Vihar, marking the grand conclusion of this historic international pilgrimage," it added. The extraordinary spiritual movement swept across Vietnam as millions of devotees participated in a historic veneration pilgrimage of the Buddha's sacred relics from India.

The sacred tour, spanning multiple revered locations from the south to the north of the country, drew more than 17.8 million devotees in total, uniting Buddhists and spiritual seekers in a profound display of reverence and cultural solidarity.

External Affairs Minister (EAM) S. Jaishankar had called the exhibition of these relics in Vietnam an "expression of close and friendly ties over centuries." The veneration not only affirmed Vietnam's deeprooted Buddhist heritage but also became a vibrant expression of national unity and peace.

Ceremonies included relic processions, meditative gatherings, chanting, and educational sessions, fostering spiritual mindfulness among attendees of all ages. The holy relics arrived in Vietnam from India on May 2 with an Indian delegation led by Union Minister of Parliamentary and Minority Affairs Kiren Rijiju which also included Andhra Pradesh Minister Kandula Durgesh and senior monks and officials.

The relics were supposed to remain in Vietnam until May 21 as part of the UN Day of Vesak celebrations. However, responding to a formal request from the Vietnamese government after receiving a recommendation from the Committee for Ethnic and Religious Affairs, India agreed to extend the enshrinement of sacred relics of the Buddha in Vietnam beyond May 21, according to the reports of Vietnamese local media. The relics were displayed at Thanh Tam Pagoda in Ho Chi Minh City, then in Ba Den Mountain in Tay Ninh province, Quan Su Pagoda in Hanoi, Tam Chuc Pagoda in Ha Nam, Bai Dinh Pagoda in Ninh Binh province, Phuc Son Pagoda, Bac Giang Province, Truc Lam Yen Tu Monastery in Quang Ninh, Chuong Pagoda in Hung Yen and Quan Am Ngu Hanh Son Pagoda in Da Nang City of Vietnam.

### TN's Mettur dam sees sharp rise in water level, farmers cheer

Chennai, June 3 (IANS): The level stood at only 15,632 Stanley Reservoir in Mettur, mcft, which was a mere popularly known as the Mettur Dam and a lifeline for millions in Tamil Nadu, has witnessed a remarkable increase in water levels this year, due to the sustained rainfall brought by the southwest monsoon.

As of June 2, the dam is holding 81,983 million cubic feet 2022 when the reservoir (mcft) of water -- 87.71 per cent of its full storage capacity of 93,470 mcft. This marks a significant improvement compared to the same period last year, when the storage

Officials of the Water Resources Department (WRD) described the current storage as among the highest in the past six years, second only to reached 89,431 mcft or 95.68 per cent of its capacity. The WRD revealed that Tamil Nadu received 305 thousand million cubic feet (tmcft).

### Tamil Nadu to launch organised cancer screening programme in 12 districts

In a major step towards improving cancer detection and treatment in rural areas, the Tamil Nadu Health Department is set to launch an Organised Cancer Screening Programme across 12 districts. The initiative, aimed at early diagnosis and timely medical intervention, will be implemented under the National Health Mission (NHM). The pilot project will be rolled out in Thiruvallur, Kanchipuram, Vellore, Coimbatore, Tiruppur, Dharmapuri, Thanjavur, Tiruvarur, Theni,

Madurai, Tiruchy, and Karur districts, and the launch is tentatively scheduled for May 9, according to a senior health department official. "The primary objective of the programme is to diagnose cancer at the earliest possible stage and provide necessary medical support to affected individuals," the official said. He noted that district-level training sessions have already been conducted for healthcare personnel who will be deployed on the ground.

Explaining the rationale behind the initiative, the official pointed out that cancer diagnosis and treatment are currently concentrated in



government and private hospitals, making them less accessible to people in remote areas.

"Many in rural regions may misinterpret symptoms or delay seeking treatment due to a lack of awareness or access. This programme aims to bridge that gap by bringing screening services directly to the village level," he added. Through the screening camps, residents will be encouraged to undergo health checkups. Those exhibiting cancerrelated symptoms will receive counselling and be referred to nearby government hospitals for further evaluation and treatment.

"This proactive approach will enable early detection and significantly improve the chances of successful treatment," the official emphasised.

#### Bihar youths benefit from Udyami Yojana; Saharsa's Dilkhush shares success story

The fortunes of unemployed youths in Bihar are changing due to the Mukhyamantri Udyami Yojana. Dilkhush Kumar, a 22-year-old resident of Saharsa district, has seen drastic changes in his life because of this scheme.


Having lived life in penury, he thought of starting his own business after completing graduation.

# **UNESCO** renews call for enhanced protection of Africa's heritage sites

The United Nations Educational, Scien tific and Cultural Organization (UNESCO) has renewed its call for enhanced protection and recognition of Africa's heritage sites, given their contribution to cultural pride and tourism. Louise Haxthausen, UNESCO Regional Director for Eastern Africa, told an international conference on cultural heritage in Africa, taking place in Nairobi, the Kenyan capital, that the continent is a repository of world-famous archeological sites and priceless artifacts that should be preserved for future generations. Haxthausen said that a sound policy and legal framework is required to boost the protection of Africa's heritage sites amid threats posed by climate change and human activities. A more inclusive approach involving policymakers, local communities and multilateral partners is required to enrich discourse related to the conservation of heritage sites

on the continent, Haxthausen said, noting that the Africa Union Agenda 2063 champions for safeguarding the health of historic sites and monuments in the continent, given their intrinsic value to indigenous communities. According to UNESCO, Africa accounts for 12.26 per cent of World Heritage Sites globally, but the sites' future is uncertain given the threat of rapid urbanization, weak protection laws and climatic stresses. Attendees at the May 6-9 conference, convened by UNESCO, the Kenyan government, and the African World Heritage Fund, include senior policymakers, scholars and cultural enthusiasts.

# No impunity for terrorists: Rishi Sunak justifies India's 'Operation Sindoor'

London, June 3 (IANS): Former UK Prime Minister Rishi Sunak on Tuesday justified the strikes conducted by Indian defence forces on the terror camps operating in Pakistan and Pakistan-occupied Kashmir (PoK), saying that there can be no impunity for terrorists. In a post on social media platform X, Sunak said, "India is justified in striking terrorist infrastructure. There can be no impunity

Earlier, reacting to the terror attack in Jammu and Kashmir's Pahalgam that claimed 26 innocent lives, Sunak had affirmed that his country stands in solidarity with India and added that "terror will never win". Meanwhile, backing India's move, Reuven Azar, the Ambassador of Israel to India, said, "Israel supports India's right to self-defence. Terrorists should know there's no place to hide from their heinous crimes against the innocent."

After India's action against terrorists codenamed 'Operation Sindoor', United Kingdom Trade Secretary Jonathan Reynolds said that his country is ready to support both India and Pakistan to de-escalate tensions. Calling upon India and Pakistan to show "restraint", Russia said that it hoped that tensions could be resolved through peaceful and diplomatic means.



#### Russia, Japan express concern over escalating **India-Pak tensions**

Moscow, June 3 (IANS): Russia and Japan expressed deep concern on Tuesday over escalating military tensions between India and Pakistan. "We are deeply concerned by the heightened military tensions between India and Pakistan in the wake of a terror attack near the town of Pahalgam," Russian Foreign Ministry Spokesperson Maria Zakharova said.

The remarks came after the Indian armed forces launched Operation Sindoor, targeting nine high-value terror locations in Pakistan and Pakistan-occupied Kashmir (PoK) in response to the dastardly April 22 terror attack, which killed 26 innocent civilians. "Russia resolutely condemns acts of terrorism as it opposes any manifestations of it and accentuates the need to join forces globally for an effective fight against this evil," Zakharova said.



#### Syria's diplomatic outreach unfolds as it grapples with internal unrest

Damascus, June 3 (IANS): As Syria's new leadership ramps up diplomatic efforts with visits to world capitals, it finds itself simultaneously confronting a deepening sectarian crisis at home, posing a critical test of its capacity to govern a fractured country.

Interim leader Ahmed al-Sharaa's arrived in Paris on Tuesday, marking his first official trip to a European nation since assuming office after the ouster of Bashar al-Assad in December 2024. According to Syria's state-run SANA news agency, al-Sharaa will discuss with French President Emmanuel Macron reconstruction efforts, cooperation in energy and aviation sectors, regional security challenges, and particularly the Israeli airstrikes that have increasingly targeted Syrian military installations.

This diplomatic outreach comes on the heels of foreign affairs chief Asaad al-Shibani's visit to the United States, where he raised Syria's new flag at the United Nations and engaged with senior US officials. Both visits signal the new government's bid to break the international isolation Syria has endured, and to attract investment and support for the country's economic revival.

#### 'Support India's right to self-defence,' Israel backs 'Operation Sindoor'

New Delhi, June 3 (IANS): Israel has extended its support to India's right to defend itself from terrorism as Indian armed forces carried out 'Operation Sindoor' against nine high-value terror targets in Pakistan and Pakistan-occupied Kashmir. In a calculated military strike following the April 22 terror attack in Pahalgam, the Indian armed forces launched Operation Sindoor late on Tuesday night. "Israel supports India's right for self-defence. Terrorists should know there's no place to hide from their heinous crimes against the innocent," Reuven Azar, Ambassador of Israel to India, posted on X. The military operation struck camps and logistical hubs linked to terror groups held responsible for orchestrating the Pahalgam attack, which claimed the lives of 26 innocent civilians in Jammu and Kashmir.

#### **UK's terrorism charges** against seven Iranian nationals baseless: Tehran

Tehran, June 3 (IANS): Iran's Foreign Ministry has rejected allegations made by the UK Home Office and certain British parliamentarians following the arrest of several Iranian nationals over terrorism charges, state media reported on Tuesday. The British Police arrested the suspects in separate operations from different parts of the United Kingdom. Alireza Yousefi, the Director General for the Western Europe department at Iran's Ministry of Foreign Affairs, warned about the "negative consequences" of the "baseless accusations" and urged London to immediately inform the legal basis for detention of the Iranian nationals and to facilitate consular visits without delay, country's official news agency IRNA reported.

#### Israel says to move entire Gaza population to south

Jerusalem, June 3 (IANS): Israeli Defence Minister Israel Katz said on Tuesday that a planned expanded military operation in the Gaza Strip would force the enclave's entire population to either relocate to a confined area in the south or to "voluntarily" emigrate, as Israeli forces prepare to seize control of the entire territory.

"We will act with full force and will not stop until all objectives are achieved, including the voluntary emigration plan for Gaza residents," Katz said during a a situational assessment meeting with senior commanders held in preparation for the operation, according to a statement issued on his behalf. The announcement came amid growing international concern over the worsening humanitarian crisis in Gaza, where populations have faced mass starvation and famine since Israel blocked all humanitarian aid on March 2. Katz said the new operation, approved by the Israeli security cabinet on Monday, is intended to dismantle Hamas's military and governing capabilities and to secure the release of 59 hostages still held in the enclave. Unlike past operations, "the IDF (Israel Defense Forces) will remain in every area it captures," he said, Xinhua news agency reported.





# Kenya lauds sentencing in wildlife crime case over smuggling of 5,000 ants

Nairobi, June 3 (IANS): The involved. "The smuggling of these Kenya Wildlife Service (KWS) on Tuesday welcomed the sentencing of four individuals, including three foreigners, for attempting to traffic more than 5,000 live garden ants out of the East African country.

The KWS, a state corporation mandated to conserve and manage Kenya's wildlife, said the decisive action against two Belgian nationals, a Vietnamese citizen and a Kenyan national, who were each fined one million Kenyan shillings (about 7,740 US dollars), sends a clear and resounding message that Kenya will not waver in its fight against wildlife crime, no matter the species ants is not merely a wildlife crime. It is an act of biopiracy," the KWS said in a statement issued in Nairobi, the capital of Kenya, Xinhua news agency reported. The offenders were apprehended

last month in Nairobi and the lakeside town of Naivasha for illegal possession of the ants, valued at 9,288 dollars, without the requisite permits.

The ants were destined for the European and Asian exotic pet trade, where rare and ecologically unique species can command prices of up to 1,350 dollars each. Senior Principal Magistrate Njeri Thuku on Wednesday sentenced each offender to pay a fine of 7,740 dollars or serve 12 months in prison in case of default. Thuku underscored the collective

responsibility to safeguard Kenya's biodiversity, saying that no species is too small to protect. "Our wildlife, from ants to elephants, sustains our ecosystems and national heritage," she said. The seized ants (Messor cephalotes), a critical species in maintaining soil health and ecosystem balance, are to be handed over to the National Museums of Kenya if no appeal is lodged within 14 days.

"Today's ruling sends an unequivocal message: Kenya will not tolerate the plunder of its biodiversity.



# Amarinder Singh warns Pakistan against attempt to escalate conflict

Chandigarh, June 3 (IANS): Warning Pakistan against trying to escalate the conflict, BJP leader and former Punjab Chief Minister Amarinder Singh on Tuesday hailed the Indian defence forces' precision strikes on terror camps inside Pakistan and Pakistan-occupied Kashmir (PoK).

Reacting to the strikes, Singh observed that "the action was overdue, as Pakistan had not been desisting from exporting terror into our country".

He pointed out that just two weeks ago, 26 innocent people were killed in Pahalgam by "Pakistan-trained terrorists". The former Punjab Chief Minister, himself a former army officer, congratulated the defence forces for exercising utmost restraint by specifically targeting the terror camps inside Pakistan and PoK. # Six kids among seven killed in road accident in Punjab's Samana

Samana (Punjab), June 3 (IANS): In a terrible road accident on Tuesday, six schoolchildren and a driver lost their lives when a car carrying students collided with a tipper truck near Samana in Punjab's Patiala district, officials said.

The students were returning home from Bhupindra International School in Patiala when the accident occurred.

# Anyone spreading fake news will be strictly dealt with: CM Banerjee

Kolkata, June 3 (IANS): West Bengal Chief Minister Mamata Banerjee on Tuesday cautioned against the circulation of fake news or fake information that might aggravate internal tensions in the wake of 'Operation Sindoor' crushing terrorist bases in Pakistan and Pakistan-occupied-Kashmir.

The Chief Minister said that her administration would take strong action against offenders in the matter.

"I will not speak anything on the proceedings of the meeting. I also request you not to ask me any questions today. All I can say is that this is not the time to spread wrong information. This is the time to present factually correct information or news. So I request all to refrain from spreading information based on speculations or rumours," Chief Minister Banerjee said.

Chief Minister Banerjee also requested media channels to refrain from broadcasting television debates in the wake of the current situation in the country.



# **Gurugram: Three arrested with illegal weapons for planning robbery**

Gurugram, June 3 (IANS): A crime branch team of the Gurugram Police has arrested three accused with illegal weapons to commit robbery at gunpoint, police said. A senior official said that the team received information regarding an attempt by three suspects to rob passers-by at gunpoint near Laser Valley Park, Gurugram. He said that the police team acted promptly on the information and formed a special police team and raided the place, where three accused were arrested with weapons.

A case has also been registered against the accused under the relevant sections in police station DLF Sector-29, Gurugram," he said. "After examining the criminal records of the accused, it was found that accused Roz Mohammad has 11 cases registered against him for theft, one case under the Arms Act in Faridabad, and one case in relation to theft in Gurugram, while the accused Anand Kumar has seven cases registered against him for theft under the Arms Act in district Faridabad," he said.

The official said that the accused will be produced before the court for further action in the case, adding that the investigation of the case is ongoing.

#### J&K L-G attends high-level security meeting chaired by HM Amit Shah



India is poised to become the world's fourth-largest economy in 2025 with the country's nominal GDP rising to \$4,187.017 billion during the year to surpass Japan's GDP pegged at \$4,186.431 billion, according to the IMF's latest 'World Economic Outlook' report. On free trade agreement (FTAs), Rogers told IANS that more free trade is better for the world, especially India. "It will be extremely exciting for the world, including foreign investors," he mentioned. India has signed 13 FTAs with its trading partners.

#### Sensex, Nifty clock best single-day rally in 4 years; investors richer by Rs 16 lakh crore

New Delhi, June 3 (IANS): The understanding for a ceasefire between India and Pakistan brought cheers for investors who were richer by more than Rs 16 lakh crore in a single day -- as Sensex and Nifty gained a massive nearly 4 per cent in a bull rally seen after February 2021. The Indian stock markets delivered their best single-day performance in four years, as positive global and domestic cues boosted market sentiment.

At the close of trade, Sensex soared 2,975.43 points, or 3.74 per cent, to end at 82,429.90, while Nifty jumped 916.70 points, or 3.82 per cent, to finish at 24,924.70. This was the second-biggest percentage gain for both indices in the last four years, with the only larger rally recorded on February 1, 2021, when the indices rose over 4.7 per cent. The bull rally came amid a string of encouraging developments, including an understanding for a ceasefire between India and Pakistan, a breakthrough in US-China trade talks, and reports of peace negotiations between Russia and Ukraine.

These developments helped ease geopolitical tensions, improving the global risk appetite and lifting investor confidence. All sectoral indices ended in the green, showing a broad-based recovery across sectors. Even the Nifty Pharma index, which had opened with a 2 per cent loss after US President Donald Trump's comments about slashing drug prices by up to



**Seoul, June 3 (IANS):** The South The review panel must notify Korean government will decide by August whether to allow Google to transfer the country's high-precision map data overseas amid heated debates over national security, digital sovereignty and other trade issues, officials said on Tuesday.

In February, the U.S. tech giant submitted an application to the state-run National Geographic Information Institute, seeking approval for the transfer of 1:5,000scale high-precision map data to its data centres abroad.

The company posted a net profit of Rs 76.25 crore, down from Rs 78.15 crore in the same quarter last fiscal (Q4 FY24), according to its stock exchange filing. Despite a marginal revenue increase of just over 1 per cent from Rs 659.99

In contrast, advertisement and sales promotion expenses provided some relief, declining 10.61 per cent to Rs 53.41 crore, down from Rs 59.75 crore last financial year. Still, total expenses in Q4 increased slightly by 0.97 per cent, reaching Rs 571.23 crore, up from Rs 565.73 crore. #### Armed robbers loot jewellery worth Rs 4.5cr from bank in Bihar's Samastipur

Patna, June 3 (IANS): In a daring daylight robbery, eight armed robbers stormed a Bank of Maharashtra branch in Kashipur locality of Samastipur on Tuesday, looting jewellery worth Rs 4.5 crore and Rs 15 lakh cash, an official said.

The bank, situated in one of the busiest areas of the city, witnessed the crime unfold in broad daylight, leaving the residents in shock.

According to Superintendent of Police Ashok Mishra, the incident was carried out by a gang of eight, of which three posed as customers intending to open accounts. Soon after, five more individuals entered, taking bank employees



and customers hostage at gunpoint. They locked the employees and customers in one room, broke the lockers and took away the jewellery.

"The miscreants looted valuables from both the bank counters and the lockers. They also snatched mobile phones from the staff and customers to prevent any alarms or communication," Mishra said.

#### Jharkhand HC extends stay on CGL exam result; CID finds no evidence of paper leak

Ranchi, June 3 (IANS): The Jharkhand High Court on Tuesday extended the stay on the publication of the state Combined Graduate Level (CGL) examination results conducted by the Staff Selection Commission in 2024. The decision came during a hearing on a Public Interest Litigation (PIL) seeking a CBI probe into alleged irregularities in the examination.

A division bench headed by Chief Justice M.S. Ramachandra Rao heard the matter, where the state government, represented by Advocate General Rajiv Ranjan, informed the court that the CID is currently investigating the allegations. He said that no concrete evidence of a paper leak has emerged so far, and the investigation is expected to be completed within a month.

The government also told the court that a charge sheet has been filed against three individuals who had allegedly taken money from candidates under the pre-



text of providing them with the leaked question paper. The court directed the state to submit an up- the exam, the Commission had dated investigation report in the next hearing. Meanwhile, the petitioners sought additional time to present their arguments. After hearing both sides, the court decided to continue the stay on the exam results and scheduled the next hearing for June 18.

The CGL exam, conducted on September 21 and 22, 2024, was held across 823 centres in Jharkhand to fill over 2,000 government posts.

A total of 3,04,769 candidates appeared for the test. Based on shortlisted 2,145 candidates on December 5, 2024. Following allegations of a paper leak, Rajesh Kumar and others filed a PIL in the High Court seeking a CBI inquiry. Responding to the plea, the court had, on December 17, 2024, imposed an interim stay on the result and directed the state to register an FIR under the Jharkhand Examination Conduct Act, 2023, and submit a report after investigation.



#### **CBI Director Praveen Sood gets** one-year extension amid lack of consensus on successor

New Delhi, June 3 (IANS): In the absence of a consensus on appointing a new chief, the Central government on Tuesday ex tended the tenure of CBI Director Praveen Sood by one year. Sood, a 1986-batch Indian Police Service (IPS) officer of the Karnataka cadre, was originally scheduled to complete his twoyear fixed term on May 24 this

However, a decision on his successor could not be finalised following deliberations by the highpowered selection committee.

# Rajasthan: Leaves of police personnel cancelled amidst border tensions

Jaipur, June 3 (IANS): Rajasthan Chief Minister Bhajan Lal Sharma has cancelled leaves of all police personnel amidst rising border tensions between India and Pakistan following 'Operation Sindoor'.

"Leaves of all police personnel stand cancelled. They should ensure their mandatory presence at headquarters. ADG Range In-Charges and Secretaries should maintain close coordination with district officials and oversee the strict implementation of these directives," said the Chief Minister while chairing a high-level meeting with senior police and administrative

officials at the Chief Minister's Office to review and reinforce the state's internal security and civil preparedness.

During the meeting, the Chief Minister issued key directives, emphasising strict vigilance in border areas, especially given Rajasthan's strategic location adjacent to Pakistan, tight security measures across the state, ensuring full compliance with national standards, swift and strict action against individuals attempting to disturb communal harmony or spread misinformation via social media, among others.

He also directed close coordination with the Union Home Ministry and central security agencies to tackle any potential threats, en-



suring basic services such as water, electricity, medicines, oxygen, and ambulances are readily available and operational in all districts and conducting effective mock drills and blackout preparedness exercises for civil defence.

He underlined the importance of disaster management readiness, directing hospitals to ensure the availability of essential medicines, healthcare personnel, and emergency infrastructure.

He also reviewed the civil security mechanisms and emphasised

maintaining seamless public services during emergencies. He also praised the Indian Air Force for executing a successful and precise air strike at nine locations inside Pakistan. He said this was a befitting response to the cowardly attack on Indian tourists in Pahalgam, reaffirming that 'New India', under the leadership of Prime Minister Narendra Modi, is fully committed to bringing terrorists and their handlers to justice.



#### **Macron criticises Israeli** airstrike in Syria 'bad practice'

Paris, June 3 (IANS): French President Emmanuel Macron has criticised Israeli strikes in Syria, warning such actions would not guarantee "Israel's long-term security"

He made the remarks on Tuesday during a joint press conference with Syrian interim leader Ahmed al-Sharaa at the Elysee Palace in Paris, Xinhua news agency reported.

"As far as bombing and incursions are concerned, I think this is bad practice. You don't ensure the security of your country by violating the territorial integrity of your neighbours," Macron said. "The right method is increased cooperation," he added. Macron's comments followed a series of Israeli airstrikes early Friday targeting a site near the official residence of the Syrian President in central Damascus. Loud explosions were heard across wide areas of the capital.

Israeli aircraft were also reportedly observed flying reconnaissance missions over Damascus shortly after the strikes.

#### Lalu Prasad Yadav expresses pride in armed forces over Operation Sindoor

The Israeli side said previously that 59 Israeli hostages remain in Gaza, with 24 of them believed to be alive.

Israel halted the entry of goods and supplies into Gaza on March 2, following the expiration of the first phase of a January ceasefire

Jerusalem, June 3 (IANS): Is- agreement with Hamas. It resumed attacks on Gaza on March 18, which have so far killed 2,545 Palestinians. proved operation expansion plan. Families of the hostages held in Gaza said in separate statements that the Israeli government's moves are expected to kill their loved ones in Gaza, accusing Netanyahu of sabotaging efforts to reach a ceasefire deal.

#### Foiled nefarious design of BBMB to steal our waters: Punjab CM

Chandigarh, June 3 (IANS): Asserting that the state was fighting twin battles, one against Pakistan to safeguard the borders and the other against the Union and Haryana governments to protect its water rights, Punjab Chief Minister Bhagwant Mann on Tuesday said they "foiled the nefarious design" of Bhakra Beas Management Board (BBMB) to steal the state's waters.

Chief Minister Mann staged a sit in at Nangal town to ensure that the BBMB Chairman cannot divert the waters of the state to Haryana. He said, "If Punjabis can protect the borders of the state, then they are capable enough to save its water also. It is shameful the BJP-led Union government is playing dirty games over the waters of the state in this crisis when the country is supposed to fight the enemy unitedly." CM Mann said on Thursday, "When in the entire country sirens are being blown for blackout as a part of a strategy to battle Pakistan, the BJP is playing petty politics with Punjab." He said the BJP and its allies were in a haste to steal the waters of Punjab whereas Haryana has been using 4,000 cusecs for the entire year.

#### SC rejects BJP MLA's plea, directs him to surrender in two weeks



Jaipur, June 3 (IANS): The Supreme Court (SC) on Tuesday rejected the Special Leave Petition (SLP) of Baran Anta MLA, Kanwarlal Meena of the BJP, and directed him to surrender before the trial court within two weeks. Meena was earlier sentenced to three years in prison for pointing a pistol at an SDM and destroying government property during a 2005 incident.

A SC bench comprising Justices Vikram Nath, Sandeep Mehta, and Sanjay Karol heard the case. Meena's lawyer, Namit Saxena, argued that no revolver had been recovered and therefore, the charge of using criminal force could not be sustained. He also pointed out that the alleged video cassette, said to have been broken and burned, was never recovered.

However, the bench rejected all arguments, upholding the findings of the lower courts. On May 1, the Rajasthan High Court upheld the conviction by the Appellate Court (ADJ, Aklera, Jhalawar), which had found Meena guilty of obstructing government work, intimidating officials, and damaging public property. According to the Representation of the People Act, 1951, any lawmaker sentenced to more than two years in prison is disqualified from the legislature. With the High Court upholding his sentence, Meena's legislative membership is under threat.

Following the High Court's ruling, the Congress party approached the Assembly Secretary demanding action. A notice was then issued to Meena, requiring him to submit a SCt stay order by 12 noon on May 7. In response, Meena's counsel mentioned the matter before the SC, which had earlier granted a temporary stay on his surrender on May 5, but did not stay the High Court's entire judgment.

The case relates to an incident on February 3, 2005, near the Dangipura-Rajgarh turn in Jhalawar, where villagers had blocked the road demanding re-polling for the Khatakhedi Deputy Sarpanch elections. Officials, including then SDM Ramnivas Mehta, IAS probationer Pritam B Yashwant, and Tehsildar Ramkumar, had reached the spot to control the situation.

# Iran rejects report of proposing direct talks with US

Tehran, June 3 (IANS): Iran's Foreign Ministry spokesman Esmaeil Baghaei has dismissed a recent media report and the speculations about a proposal by Tehran on direct nuclear talks with Washington and an imminent meeting between the Iranian and US Presidents. He made the remarks on Tuesday to Iran's Press TV while reacting to a recent report by the Israeli news website Ynet, which claimed that Iranian Foreign Minister Seyed Abbas Araghchi had approached US Middle East envoy Steve Witkoff, requesting direct nuclear negotiations with the US delegation due to "frustration" with Omani mediation efforts to bridge the gap between the two sides. Baghaei also rejected media speculations that US President Donald Trump, during his upcoming visit to Saudi Arabia next week, may meet with his Iranian counterpart, Masoud Pezeshkian, Xinhua news agency reported. The spokesman described the media report and rumors as "fabricated and baseless," saying that "all updates on Iran's diplomatic activities, including indirect talks with the US, are communicated transparently, professionally, and in a timely manner by the (Iranian) Foreign Ministry"

The delegations of Iran and the US, headed by Araghchi and Witkoff, have so far held three rounds of indirect talks. The first

and third rounds were held in the Omani capital Muscat on April 12 and April 26, and the second one in Rome on April 19. The fourth round, which was originally scheduled for May 3 in Rome, was postponed due to what the mediator Oman described as "logistical reasons".

Nour News, affiliated with Iran's Supreme National Security Council, reported on Tuesday that the fourth round of indirect talks between Iran and the US would be



held in Muscat on Sunday. However, Baghaei said earlier on Wednesday that the definite date



and venue of the fourth round of Iran-US dialogue have not been determined yet.

#### Issue would've been resolved if similar strike followed Mumbai attacks: K'taka BJP leader

The Leader of Opposition in the Karnataka Assembly, R. Ashoka, said on Tuesday that if Operation Sindoor-like counterstrike had been carried out after the 26/11 Mumbai terror attacks, the issue would have been resolved then only.

Therefore, I request the court to consider the submitted report as final, take cognisance of the objections and documents provided by me, allow me to present my arguments, and issue appropriate orders," he stated. He further submitted in his petition that there was little likelihood of the Lokayukta police filing a report against accused number one, CM Siddaramaiah, and others who have already been given a clean chit in the interim report.

The Enforcement Directorate (ED) has also registered its objection to the closure report in the MUDA case involving CM Siddaramaiah, his wife and others. The court earlier stated that the Lokayukta has not completed

#### Trump offers 'help' to stop tensions escalate between India and Pakistan

Washington, June 3 (IANS) : Amid escalating tensions with Pakistan after India launched airstrike on terror launchpads in Pakistan and Pakistan Occupied Kashmir, US President Donald Trump has expressed concerns and said that "he will be there" to offer help and wants the escalating conflict between the two countries to "stop".

"It's so terrible. My position is I get along with both. I know both very well and I want to see them work it out. I want to see them stop and hopefully they can stop now. They have gone tit for tat so hopefully they can stop now. I know them both, we get along with both the countries very well," Trump said.

"I have good relationships with both and I want to see it stop. And If I can do anything to help I will be there," Trump said in response to a question on the 'war' between India and Pakistan.

India launched Operation Sindoor early Wednesday hitting nine terror targets in Pakistan-occupied Kashmir (PoK) and Pakistan in retaliation for the terror attack in Jammu and Kashmir's Pahalgam on April 22 that killed 26 people.

#### NYT calls Pahalgam attackers 'terrorists' after backlash but retains disputed Kashmir terminology

Islamabad, June 3 (IANS): As India executed 'Operation Sindoor', a notable shift was observed in the editorial tone of prominent American daily The New York Times, which for the first time referred to the perpetrators of the Pahalgam massacre as "terrorists" in its headline -- a marked departure from its earlier usage of softer terms such as "militants" and "gunmen".

The front-page headline on the NYT website stated: "India Strikes Pakistan Two Weeks After Terrorist Attack in Kashmir," signalling a distinct editorial change that has come amid growing criticism over the paper's earlier coverage.

The Pahalgam attack, which occurred on April 22, left 26 people dead, including 25 Indian tourists and one Nepali citizen, when they were gunned down in cold blood in Jammu and Kashmir's Baisaran valley. Despite the headline change, the NYT continued to use controversial terminology within the body of its report, referring to the region as "Indian-administered Kashmir".





#### India heading to become 3rd largest economy, Pakistan on brink of collapse

New Delhi, June 3 (IANS): While Pakistan has threatened to respond forcefully to India's attack on terrorist infrastructure in the neighbouring country, the stark economic contrast between the two countries also bears testimony to the disparate paths that the two neighbours have been pursuing since they became independent from British rule.

India has emerged as the world's fastest-growing economy, with World Bank figures for 2024 showing that the country's GDP is close to \$3.88 trillion, which is more than 10 times the size of Pakistan's economy at a mere \$0.37 trillion.

India is poised to become the world's fourth-largest economy in 2025, with the country's nominal GDP rising to \$4.187 billion during the year to surpass Japan, according to the IMF's World Economic Outlook report. India has a massive forex kitty of \$688

Pakistan is on the verge of economic collapse and is surviving on IMF loans, with its forex reserves down to \$15 billion.

#### Will wrap up tensions if India backs down, says Pak Defence Minister Khawaja Asif

Islamabad, June 3 (IANS): Pakistan's Defence Minister Khawaja Asif has said that the current tensions and escalated confrontation between India and Pakistan can come to a halt only if New Delhi backs out of its aggressive position. Asif's remarks came after India launched 'Operation Sindoor', targetting nine locations in Pakistan and Pakistanoccupied Kashmir (PoK) striking alleged terror hideouts. Pakistan also claimed to have responded to Indian airstrikes with counter-offensive measures along the Line of Control (LoC). Speaking to Bloomberg, Asif said that Pakistan holds the right to respond to any aggression by India, insisting that Islamabad "was only responding" to India's attacks and should not be seen as the aggressor in the current conflict.

"This has been initiated by India. If India is ready to back down, we will definitely wrap up this tension," he said.

"As long as we are under attack, under fire, we have to respond. We have to defend ourselves. But if India backs down, we will wrap up this tension", the Pakistani Defence Minister added.

Pakistan's Inter-Services Public Relations (ISPR) Director



General Lt. General Ahmed Sharif Chaudhry said that at least 26 people have been killed and 46 others injured in the airstrikes that New Delhi stated were conducted on terror camps in Pakistan-occupied Kashmir (PoK) and Punjab province.

The country has been put on a 'red alert', with government hospitals ready for any emergency; airspace for all domestic and international flights closed for at least 24 to 36 hours; all educational institutions in capital Islamabad and the Punjab province closed; and, all forces on stand by following the late night Indian air strikes on terror hideouts in different parts of the country. The Indian strikes and Islamabad's retaliation has jolted locals who fear that it could potentially lead to a fullscale war between the two countries. The strikes targeted six different locations inside Pakistan, including Masjid SubhanAllah - the alleged hideout of Jaish-e-Mohammed (JeM) chief Maulana Masood Azhar in Ahmedpur Sharqia area of Bahawalpur city in Pakistan's South Punjab province.



#### Danish Foreign Minister to summon US Ambassador over reported espionage against Greenland

Oslo, June 3 (IANS): Danish Foreign Minister Lars Lokke Rasmussen has said that he will summon the US Ambassador to Denmark for a meeting following media reports suggesting that Washington plans to intensify espionage activities targeting Greenland.

The move comes after The Wall Street Journal reported on Tuesday that US intelligence agencies have been instructed to identify individuals in Greenland and Denmark who support American strategic objectives for the Arctic island, citing anonymous sources.

"I have read the article, and it worries me a lot -- because we do not spy between friends," Rasmussen told Danish broadcaster DR on Wednesday on his way to a meeting of Foreign Ministers in Warsaw, Poland.

Acknowledging that the report could not be verified, Rasmussen noted that it had not been strongly denied by US officials, Xinhua news agency reported. "That worries me," he added. He confirmed that the American Ambassador will be summoned.

#### **World Central Kitchen to** halt Gaza operations due to supply depletion

Gaza, June 3 (IANS): The food relief organisation World Central Kitchen (WCK) has announced that it will halt cooking in the Gaza Strip due to the depletion of humanitarian supplies.

"After serving more than 130 million total meals and 26 million loaves of bread over the past 18 months, World Central Kitchen no longer has the supplies to cook meals or bake bread in Gaza," the Washington, D.C.-headquartered charity said on Tuesday in a press statement. "Since Israel closed border crossings in early March, WCK has been unable to replenish the stocks of food that we use to feed hundreds of thousands of Gazans daily."

#### **UN** monitors in Kashmir safe: Spokesperson

United Nations, June 3 (IANS): UN ceasefire monitors in Kashmir and in the Pakistan-occupied area are safe and accounted for after the Indian missile strikes on "terror infrastructure" and the Pakistan shelling, according to a UN spokesperson.


"We checked with our colleagues in peacekeeping, and they said everybody was accounted for, and everybody was safe," Stephanie Tremblay, the UN Secretary-General's associate spokesperson said on Tuesday.

Formally known as the UN Military Observers Group in India and Pakistan (UNMOGIP) has 44 military personnel and 75 civilian staff posted on both sides of the Line of Control (LOC) in Kashmir. Now headed by Mexican Major General Ramon Guardado Sanchez, UNMOGIP began operations in 1949 monitoring the fragile ceasefire in Kashmir under a UN Security Council mandate. India has called the UNMOGIP redundant and called for its termination. The Resistant Front, an offshoot of the Pakistan-based Lashkar-e-Toiba (LeT) terrorist organisation,



owned responsibility for the religiously targeted massacre of 26 people in Pahalgam, a tourist spot in Kashmir. India launched a missile attack in retaliation, hitting nine places in Pakistan and Kashmir territory it occupies that New Delhi identified as terrorist locations. Pakistan shelled India across the Line Of Control killing at least 10 people, and downing three Indian jets, according to media reports. On Tuesday night, Pakistan served notice that it was preparing for further attacks on India, telling the UN Security Council that it reserves the right to hit back.

Earlier on Wednesday, UN Secretary-General Antonio Guterres remains "very concerned" about India's military operation against Pakistan, saying "the world cannot afford a confrontation between the two countries."
