US pharma giant Eli Lilly to invest over \$1 billion in Telangana

Hyderabad, Oct. 6 (NSS): Telangana secured a massive investment of \$1 Billion by US Pharma major Eli Lilly, which will expand its manufacturing and global medicine supply capacity in Hyderabad.

The expansion will be facilitated through new contract manufacturing, adding huge opportunities Telangana's youth.

The announcement was made



after the company's global delegation met Chief Minister A Revanth Reddy and Industries Minister D. Sridhar Babu at the Integrated Command Control Centre on Monday.

The investment decision reiterates the company's trust in Telangana's leadership and effective governance, after having inaugurated the global capability centre in Hyderabad in August this year. Despite strong interest from sev-



eral states, Eli Lilly chose Telangana owing to the favorable ecosystem in terms of availability of highly skilled manpower, infrastructure, and support from the government.

The investment by Eli Lilly marks the company's interest in Telangana beyond GCCs and addressing new medicines to treat diabetes and obesity.

Prepare comprehensive report on revenue land allocations : Ponguleti

Hyderabad, Oct. 6 (NSS): Minister for Revenue, Housing, Information and Public Relations Ponguleti Srinivasa Reddy has directed officials to compile a detailed report regarding the lands assigned to government departments by the Revenue department over the past 30 to 40 years. This report should include information on the usage, current condition, and any related issues of these lands.

The Revenue department has distributed thousands of acres to various departments, notably the Irrigation and Forest departments, for a range of projects. However, following the bifurcation of Telangana State, there have been modifications and new additions to these



projects, with some being canceled altogether. Officials were instructed to take these developments into account when preparing the report and conducting their analyses. In a statement here on Monday, the Minister recommended that the two departments collaborate on a report outlining the amount of land the Revenue department has allocated to the Forest department.

Alzheimer's disease, cancer and autoimmune conditions. The company will begin recruitment immediately, with openings across roles such as engineers, chemists, analytical scientists, quality control and assurance professionals, and management positions.

With the setup of the new facilities, Eli Lilly is set to do contract manufacturing in Telangana, and supply globally.

The Chief Minister thanked the Eli Lilly delegation for having chosen Telangana and assured them of full support from the government for the company's future plans. He at-

tributed the transformation of Hyderabad as a Pharma hub with the establishment of IDPL in Hyderabad in 1965.

"We have built this school with corporate-level standards and will soon introduce digital classrooms and airconditioned rooms. This reflects our government's strong commitment to quality education," he said.

Highlighting Chief Minister A. Revanth Reddy's vision for the education sector, the Minister said the government has taken up construction of Young India Integrated Residential Schools across all constituencies with an outlay of ?20,000 crore.

"The integrated school in Nalgonda has already reached the slab stage. Telangana is setting a new

standard for modern learning infrastructure," he said, while commending MLA Danam Nagender, Collector Harichandana, R&B engineers and the construction agency for their efforts.

In a sharp counter to former Minister T. Harish Rao, Komatireddy asserted, "Mr. Harish Rao, ours is a government of deeds, not words. We are giving top priority to education and healthcare. The hospitals that were left abandoned at the foundation level are now being completed within just 21 months." He said the present government inherited ?40,000 crore in pending bills from the previous regime, yet continued to push forward development works. "We are clearing old dues while accelerating key projects. Works are happening round the clock. The TIMS Hospital at Sanathnagar will be inaugurated by October 31. At Alwal Hospital, around 1,000 workers are working in a single shift and it will be ready by March. SC dismisses petition against **BC** reservations in Telangana

Hyderabad, Oct. 6 (NSS): In a significant development, the Supreme Court on Monday dismissed a petition challenging the 42% reservations for Backward Classes (BCs) in Telangana. The Apex court granted liberty to the petitioner to approach the jurisdictional High Court for appropriate reliefs. The matter was listed before the Telangana High Court on Oct 8. The SC bench comprising Justice Vikram Nath and Justice Sandeep Mehta refused to entertain the plea filed under Article 32 of the Constitution by Vanga Gopal Reddy, questioning why it



was moved when two similar petitions were already pending before the Telangana High Court. Appearing for the Telangana government, senior advocates Siddhartha Dave, Abhishek Manu Singhvi, and ADN Rao argued that the matter was

sub judice in the High Court.

India, US actively working to resolve tariff issues: Jaishankar

Txternal Affairs Minister S. Jaishankar on Sun day said that India and the United States are ✓ actively working to resolve the ongoing tariff issues through dialogue, expressing confidence that these challenges will not affect the broader trade relationship between the two nations. Speaking at the Kautilya Economic Conclave (KEC 2025), he said a large part of India's trade with the US remains "business as usual" despite the current differences. Jaishankar explained that the ongoing trade tensions largely stem from the inability of both sides to reach a common ground on several issues. "We have issues with the US and a big part of it is because we have not arrived at a landing ground. The inability to reach there has led to tariffs being levied," he said. The minister revealed that negotiations are ongoing regarding the 50 per cent tariffs imposed on Indian exports.

He stressed that India's "red lines have to be respected" while finding a solution. "There has to be an understanding with the US because it is the number one market and because a lot of the world has reached that understanding," Jaishankar said.

Despite the tariffs, the minister underlined that trade between the two countries is largely continuing smoothly.

"I don't think this will percolate to every dynamic of trade. Some issues will need to be negotiated, but I would hesitate to read very much more into it than the issues themselves," he said.

Jaishankar also highlighted the challenges that tariffs pose for policymakers in today's global trade environment.

"When you have a world where the central consideration of trade has become tariffs, please explain to me where comparative advantages and competitive advantages go," he remarked.

He noted that additional tariffs have been imposed on India's energy trade, but assured that both nations are engaged in active negotiations to resolve these matters. The minister pointed out that India has successfully signed trade agreements with several Asian countries, though some of these economies are highly competitive. "And in many cases, because of the supply chain nature, they have also provided a pathway for China. Our focus should be on FTAs with economies that are not competitive," he said.

NEWLY ELECTED CONSERVATIVE PARTY LEADER KEMI BADENOCH IS SURE TO GIVE A TOUGH FIGHT TO STARMER

The election of Kemi Badenoch, as the new leader of Britain's Conser vative Party seems to have rattled not just the common public but even the diehard Tories. But this should also be seen as the last-ditch efforts by the Conservatives to revive the party's fortunes to take on te ruling Labour Party. Last week, Britain's chastened Conservative Party, which faced its biggest defeat and the lowest tally of seats in the House of Commons, in the general elections earlier this year, elected Kemi Badenoch as its new leader. This marks the Tories' looking-up to a right-wing favourite who has raised concerns about identity politics, transgender

rights, and state spending, to rebuild its reputation after a devastating election defeat. Badenoch defeated Robert Jenrick in a vote of party members by 53,806 votes to 41,000, after a months-long contest to replace Rishi Sunak as the party's leader. She's the first Black woman to lead a major British political party, and the Tories are brandishing this as being a diverse and inclusive party as compared to Labour, which so far has been led by White men only.

Pakistan: Protest by teachers leaves thousands of students without education

Peshawar, Oct 6 (IANS):
More than 22,000 students across primary schools in Pakistan's Khyber Pakhtunkhwa (KP) have no option but to sit at home as the province's All-Primary Teachers Association (APTA) are holding a major sit-in protest at Peshawar's Jinnah Park to press for their demands.

APTA Provincial President Azizullah has said that the protest will continue until the KP Education Minister issues an official notification for teachers' upgradation.

On the other hand, the KP Education Department has taken the forced closure of schools

Peshawar, Oct 6 (IANS): as a challenge to the provincial government's authority, warning across primary schools in Pakistan's Khyber Pakhtunkhwa (KP) have no APTA had warned last month that it would shut down all 26,000 primary boys and girls schools from November 5 and would not reopen them until their demands are met.

Azizullah, meanwhile, continues to mobilise support, insisting that the government plans to launch a crackdown on the protest.

"Our phones are off and we are

all keeping a low profile. Schools will only reopen once the government issues an official upgradation notification for teachers, as there will be no compromise on this demand. Teaches are united; they have made sacrifices in the past and are prepared to face any difficulty to secure their rights," he said.

APTA had warned last month that it would shut down all 26,000 primary boys and girls schools from November 5 and would not reopen them until their demands are met. "The sit-in would mark a historic event, as it is being held to demand the notification of upgradation, and regularization of 13,500 teachers, the restoration of forced promotions, and the revival of the fargo option", remarked Azizullah.

Along with the demand of regularization of teachers, the teachers' protest also opposes the privatization of primary schools. APTA is demanding creation of senior primary school teacher posts with position codes in



merged districts of KP, class-wise teacher appointments at every primary school and teacher regularization under the 2022 Act and its inclusion into the General Provident (GP) Fund.

APTA says that even though it remains open to positive negotiations, no flexibility would be shown in their demands and the primary education system of KP

province will remain completely shut. The protest by the teachers is fast becoming a major challenge for the KP government as thousands of primary teachers, including men and women, take to the streets and force the education system of the province to shut down completely for an indefinite period of time.



Germany to continue commitment to defence : Scholz

Berlin, Oct 6 (IANS): German Chancellor Olaf Scholz said Germany will continue its commitment to strengthening defence forces in the coming years, including modernising the Bundeswehr with a special fund of 100 billion euros (\$108 billion).

Scholz made the remarks at a joint press conference with visiting NATO Secretary General Mark Rutte in Berlin on Monday, reports Xinhua news agency. Noting that Germany has reached the target of spending 2 per cent of its economic output on defence for the first time this year.

Nigerian president orders release of minors arrested in recent protests

Abuja, Oct 6 (IANS): Nigerian President Bola Tinubu ordered the unconditional release of dozens of minors allegedly arrested during recent hunger protests in the country while calling for a probe into their detention. Minister of Information and National Orientation Mohammed Idris told reporters in Abuja, the Nigerian capital, that the president's directive to the country's attorney-general took immediate effect, not minding the ongoing legal processes instituted against the young citizens, reports Xinhua news agency. Tinubu also directed that all the law enforcement agents involved in the arrest and the legal processes be investigated, the minister said, adding that "if there are any infractions found to have been committed by any official of the government ... appropriate disciplinary action will be taken against him or her." The minors, whose ages were below 18 years, according to local au-



thorities, were arrested in the northern part of the country during the hunger protests across Nigeria in August and prosecuted for treason last week in Abuja. Their arraignment sparked a nationwide debate after a local court gave strident bail conditions, including 10 million nairas (approximately \$6,000) and two sureties for

each of them. "The president has also directed the Ministry of Humanitarian Affairs and Poverty Reduction to immediately see to the welfare of those minors and also take part to ensure that they have a smooth reunion with their parents or guardians, wherever they are in the country," Idris said.



Teachers catalysts of Cambodia's Al transformation: PM Hun Manet

Phnom Penh, Oct 6 (IANS) Cambodian Prime Minister Hun Manet said on Monday that teachers are the catalysts of Artificial Intelligence (AI) transformation in the Southeast Asian country.

Brussels, Oct 6 (IANS) European Commission President Ursula von der Leyen been facing increasing scrutiny since the beginning of her second mandate.

The two bids have one common thread which is criticism over the European Union-US trade deal and the disfavourable terms it has placed on European exporters. The agreement, which includes non-binding commitment to spend •750 billion on US-made energy and invest •600 billion in the American market, faces intense criticism from all sections of the political spectrum.

In a recent poll, 52 per cent of respondents have termed the deal a "humiliation" for Europe. Ursula von der Leyen has acknowledgement that the deal is "imperfect." However, he stressed that it is "solid" enough to deal with the commercial turmoil unleashed by US President Donald



Trump.

PfE and The Left, which have tabled the motion against Ursula von der Leyen, have expressed concerns about the damaging impact of EU-Mercosur free trade deal on European farmers. The EU-Mercosur free trade deal was concluded by Ursula von der Leyen in December last year and whose legal texts are now up for adoption. They also slammed von der Leyen's lack of transparency. The Patriots for Europe (PfE) and The Left, however, differ on other issues. The PfE has issues regard-

ing the Commission's handling of irregular migration and "misguided" green policies, while The Left slams EU's "failure" to address the climate and social crisis, and Israel's war on Gaza.

The Left spokesperson, Thomas Shannon, was quoted by the Euro News as saying, "The plan is to topple the Commission." He said, "It is not the plan to actually create something where we're constantly bringing this up over and over and over again.

Seven 'terrorists' killed in military operations in Pakistan

Islamabad, Oct 6 (IANS): Seven "terrorists" were killed and three others injured in separate operations by the Pakistani military across the country.

The Inter-Services Public Relations (ISPR), the media wing of Pakistan's military, said one incident happened in the North Waziristan tribal district where a "terrorist" was killed in an intelligence-based operation. The second incident took place in the neighbouring South Waziristan district where troops intercepted "terrorists" trying to infiltrate through the Pakistan-Afghanistan border, Xinhua news agency reported quoting ISPR. The incident triggered an exchange of fire, in which five "terrorists" were killed, while three others got in-



Philippine troops kill two suspected rebels in clash

Manila, Oct 6 (IANS): Philippine troops killed two suspected rebels during a clash in Philippines on Monday morning, the military said.

The military said the clash broke out in Northern Samar province and lasted several minutes before the New People's Army (NPA) retreated, leaving behind their two dead members.

No government soldier was killed or wounded in the clash, Xinhua news agency reported.

NPA rebels have been fighting government troops since 1969. Military data showed that the NPA's personnel strength has declined since its peak of around 25,000 armed members in the 1980s. Despite its dwindling fighters, the NPA continues to launch small-scale attacks in the countryside.



Canadian ports lock out dock foremen following strike notice

Ottawa, Oct 6 (IANS): Maritime employers in Canada's British Columbia locked out more than 730 dock foremen across the country's west coast ports, including the largest port, Vancouver, in a labour dispute.

The British Columbia (BC)
Maritime Employers Association said on Monday that its
plan to lock out workers was

meant to "facilitate a safe and orderly wind-down of operations" in light of escalating and unpredictable strike action.

Last week, International Longshore and Warehouse Union Local 514 issued a 72-hour strike notice for job action, which was due to start at 8 am PT (1300 GMT) on Monday. The union's main task was said to protect jobs from automation.

The lockout began at 4:30 pm PT (2130 GMT) and will remain until further notice, the B C Maritime Employers Association said in a news release. In a joint written statement, Alberta Premier Danielle Smith and Transportation Minister Devin Dreeshen on Monday called on the federal government to take whatever steps are necessary to maintain critical port operations and urgently intervene

with binding arbitration in future disputes, Xinhua news agency reported. "Alberta is a landlocked province that relies on the safe, dependable movement of goods to and from west coast ports. These ports export about 50 million Canadian dollars (\$36 million) worth of Alberta's key commodities every day including agricultural, energy and manufacturing-related products," the statement said.



'Exposed serious shortcomings in safety standards': Sachin Pilot on Jaipur hospital fire

lowing the devastating fire at Jaipur's Sawai Man Singh (SMS) Hospital Trauma Centre that claimed the lives of eight patients, former Deputy Chief Minister Sachin Pilot has termed the incident a result of "clear negligence" and called for accountability at every level. "The fire that broke out late Sunday night at SMS Hospital in Jaipur is ex-

claimed the lives of several patients and created widespread panic. The accident at the state's largest government hospital is deeply concerning and demands a thorough investigation. The families of the patients who lost their lives should receive appropriate assistance and justice. This incident has exposed serious shortcomings in safety standards and systems," he said on his X handle.

Jaipur, Oct 6 (IANS) Fol-tremely serious. The incident Pilot, addressing the media, said, "The accident at SMS Hospital is very tragic. I express my heartfelt condolences to the families of those who died. Such an accident at the state's most renowned hospital was certainly due to negligence." His comments came as rescue operations continued and investigators began collecting forensic evidence from the ICU where the fire broke out late Sunday night. The blaze, which origi-

nated in a locked storeroom inside the Trauma Centre's ICU, quickly spread thick smoke throughout the unit, leading to the suffocation of patients who were unable to be moved in time. Pilot emphasised that the tragedy highlighted serious lapses in safety measures and emergency preparedness at one of the state's most advanced hospitals. He called on the state government to ensure that those responsible are held accountable



and that systems are reviewed to prevent such disasters in the future. "It's not enough to offer condolences. The government must

ensure strict action against any negligence and urgently revisit fire safety protocols across all hospitals," he added.

Arunachal musician booked for publicly killing chicken, drinking its blood

Itanagar, Oct 6 (IANS): Arunachal Pradesh Police registered an FIR against artist Kon Waii Son for publicly killing a chicken by slitting its throat and then drinking the bird's blood during a recent performance in Itanagar, officials said on Monday.

Police officials said that the FIR has been registered under the Bharatiya Nyaya Sanhita (BNS), 2023, and The Prevention of Cruelty to Animals (PCA) Act, 1960, against Kon Waii Son.

Kon Waii Son, who hails from Seppa in Arunachal Pradesh's East Kameng district, is a songwriter, composer, and musician. Following the killing of the chicken and drinking of its blood, police filed the FIR at the Itanagar Police Station on



Monday against Kon Waii Son based on a complaint made by People for the Ethical Treatment of Animals (PETA), India.

Controversy widely erupted in Itanagar after the artist killed the chicken and drank its blood during a performance on October 28.

The video of the incident widely circulated on social media led to criticism of the artist.

Eight killed in ICU fire at **SMS Hospital** in Jaipur; CM orders probe

Jaipur, Oct 6 (IANS) A devastating fire broke out late Sunday night in the ICU of the Trauma Centre at Sawai Mansingh (SMS) Hospital in Jaipur, claiming the lives of eight patients, including three women. The fire reportedly started around 11.20 p.m. in the storeroom of the Neuro ICU ward, where paper, ICU equipment, and blood sampler tubes were stored.

A short circuit is suspected to be the cause, according to the Trauma Centre's nodal officer and senior doctor.

At the time of the incident, 11 patients were in the Neuro ICU, while 13 were in an adjacent ICU. In response, the government has constituted a six-member committee to investigate the cause.

Unable to stand 'injustice', govt staffer commits suicide in K'taka

Bengaluru, Oct 6 (IANS): A government staffer committed suicide, allegedly over the injustice meted out to him by his seniors and Personal Assistant to State Women and Child Welfare Minister Laxmi Hebbalkar in Karnataka's Belagavi district.

The deceased, identified as Rudaranna Yadavanna who worked as the Second Division Assistant (SDA) at the Tehsildar's office, named the Personal Assistant of Hebbalkar in his death note.

Following the incident, the Karnataka BJP demanded the minister's resignation. Yadavanna sent a message in the staffer's WhatsApp group mentioning the names of Tehsildar Basavaraja Nagarala and the Minister's PA Somu holding them responsible for his death. He also stated that too much injustice was taking place in the office and he could not bear it. The deceased officer had asked other employees of the Tehsildar's office to fight the "injustice" unitedly. Even as the victim posted the message around 7.30 p.m. on Monday, no action was taken.



Yadavanna, who was working for many years, was recently transferred. Yadavanna's wife also works as the village accountant in the Tehsildar's office.

The jurisdictional Khadebazar police have taken up the investigation.

Stubble burning : AAP slams Centre for rejecting Punjab's demand of Rs 1,200 crore

Chandigarh, Oct 6 (IANS): The Aam Aadmi Party (AAP) on Monday criticised the BJP-led central government for rejecting Punjab's demand of Rs 1,200 crore to prevent stubble burning, and has accused it of discriminating against the state.

A statement issued by SECI said that as per the requirements of the tender, the bank guarantee against the EMD (issued by a foreign bank) submitted by the bidding company was "fake". This discrepancy was found after the e-reverse auction. Due to

this, the SECI had to cancel the

tender process.



Consolidated net sales decreased by 3.7 per cent to Rs 16,946.3 crore from Rs 17,605.7 crore, the company said in its regulatory filing. The paint industry faced a subdued demand environment during the quarter.

California to sue over **Trump sending National Guard to Portland**

Los Angeles, Oct 6 (IANS) California Governor Gavin Newsom announced that the US State of California would sue the Trump administration for deploying National Guard from the state into Portland, Oregon, saying Trump "is using the US military as a political weapon against American citizens."

In a press release, Newsom disclosed that US President Donald Trump is deploying 300 California National Guard troops to Portland after a federal judge temporarily denied Trump the ability to federalize the Oregon National Guard, Xinhua news agency reported.

"They are on their way there now," the press release said. "This is a breathtaking abuse of the law and power. The Trump Administration

unapologetically attacking the rule of law itself and putting into action their dangerous words -ignoring court orders and treating judges, even those appointed by the President himself, as po-



litical opponents." "We will take this fight to court, but the public cannot stay silent in the face of such reckless and authoritarian conduct by the President of the United States," Newsom said. Trump claimed that the deployment of federalized troops was necessary because the city of Portland was under siege by protesters opposing the immigration enforcement actions conducted by federal agents.

On September 27, Trump ordered to send "all necessary troops" to Portland, putting 200 members of the Oregon National Guard under the command of Defence Secretary Pete Hegseth. Oregon State and the city of Portland filed a lawsuit in response to this order on September 28.

The average number of cases reported by about 500 medical institutions nationwide was 2.01 per institution in the week ended on October 20, with the figure surpassing two for the first time, Xinhua news agency reported quoting Jiji Press, citing data from the National Institute of Infectious

Patient numbers have been at the highest-ever weekly total since the current reporting method was introduced in 1999.

Before the recent surge in mycoplasma pneumonia cases, the record weekly average number of patients was 1.64 logged in October 2016.

Former VP of China **Development Bank receives** 15-year sentence for bribery

Beijing, Oct 6 (IANS): Zhou Qingyu, former Vice President of China Development Bank, was on Monday sentenced to 15 years in prison for bribery crimes, according to a verdict handed down by a court in Changchun, Jilin Province.

Zhou has also been fined 5.2 million yuan (about 732,000 US dollars), and his illegal gains are confiscated and turned over to the state treasury, according to the verdict by the Changchun Intermediate People's Court. An investigation into Zhou's case revealed that between 2013 and 2023, he took advantage of his various positions at the bank to assist others in such matters as loan financing, project contracting, business operations and personnel arrangements. In



return, Zhou accepted money and valuables worth over 67.43 million yuan. It was also established that Zhou, after leaving the bank, had used his influence to seek illegal benefits for others in project contracting and other matters, and accepted money and valuables worth approximately 1 million yuan in return. The court noted that Zhou had been cooperative throughout the investigation and in returning his illegal gains, and he was given a lenient sentence in accordance with the law, Xinhua news agency reported.

Vehicles burnt in alleged Sydney arson attack

Sydney, Oct 6 (IANS): Police in Australia's Sydney are investigating after multiple vehicles were damaged in an alleged arson attack on Monday. Police said in a statement that two vehicles were set alight in the driveway of a home in the suburb of Green Valley, approximately 32 km southwest of Sydney, at about 12:50 am local time on Monday.

Emergency services were called to the scene and the fire was extinguished by Fire and Rescue New South Wales (NSW), Xinhua news agency reported. "Minor damage was caused to the home, and there



have been no reports of injuries," NSW Police said. Local officers established a crime scene and have launched an investigation into the fire, which is being treated as suspicious. Anyone with information about the incident, or dashcam footage, has been urged to come forward.

Poland enforces extended border controls with Germany, Lithuania

Warsaw, Oct 6 (IANS) Poland has extended temporary border control measures with Germany and Lithuania for another six months, with the regulation taking effect on Monday and remaining in force until April 4 next year. According to Polish media reports, the decree was signed by Polish Minister of the Interior and Administration Marcin Kierwinski on Wednesday. Poland introduced the temporary border controls on July 7 at its western border with Germany and northeastern border with Lithuania, later extending them to October 4. Checks are currently conducted at 50 points along the Polish-German border and 13 along the Polish-Lithuanian border, according to the Polish Press Agency. Speaking at a press conference after the Munich Migration Meeting on Saturday, Kierwinski said Poland is unwilling to agree to any regu-



lations on relocating migrants within the European Union, Xinhua News Agency reported. He added that Poland has already paid a heavy price for guarding the bloc's external border, with nearly 25,000 illegal crossings recorded on the border with Belarus so far this year. Earlier in September, Poland reopened its border with Belarus at midnight on Thursday.

Three injured in stabbing attack at Melbourne shopping centre

Sydney, Oct 6 (IANS): A man has been arrested after he allegedly stabbed multiple people at a shopping centre in Melbourne on Monday. Police in the state of Victoria said in a statement that emergency services were called to the Fountain Gate shopping centre in Melbourne's southeast at about 2:25 p.m. local time on Tuesday following reports that three people were attacked at a bus stop.

The three victims, two men and a woman, were taken to a nearby hospital with nonlife-threatening injuries, Xinhua news agency reported.

CM Stalin to begin state tour in Coimbatore; sanitary workers, traders to raise grievances

Chennai, Oct 6 (IANS) : Tamil Nadu Chief Minister M. K. Stalin will visit Coimbatore as part of his statewide tour to monitor government schemes. During his visit, he will meet with government officials, elected representatives including MPs, MLAs, and local body representatives to assess the implementation of Dravidian model of governance under his leadership.

In a letter to party cadres, Stalin announced plans to conduct ground-level inspections across districts to evaluate the functioning of various state schemes. Sanitary workers and traders from Coimbatore will have the opportunity to present their grievances to the Chief Minister. Sanitary workers displaced by the Ukkadam flyover project continue to live in temporary shelters. Sumana (43), a sanitary worker, expressed her concerns: "We were displaced for the Ukkadam flyover project and promised new homes on the land of the old corporation fish market, which is still operational." The ongoing presence of this fish market has delayed progress on their housing. Traders from the fish market



are also seeking approval to relocate to a newly built facility. The Ukkadam-Aathupalam flyover project, initiated in 2018 and completed in 2024, required the demolition of 727 homes within the Coimbatore City Municipal Corporation (CMC). Temporary shelters were provided at Pullukadu, with promises of permanent housing in the same area. Under the Tamil Nadu Urban Development Habitat Board's (TNUHDB) Ukkadam Phase IV Project, 235 homes have been constructed and allocated to displaced residents.

However, for the remaining 492 families, housing remains incomplete. Although work on a 222-unit housing block began in 2020, it is yet to be completed.

Bank deposit growth in India outpaces credit offtake for 1st time in last 30 months



New Delhi, Oct 6 (IANS): Bank deposits rose at 8.6 per cent compared to December 2023, reaching Rs 218.1 lakh crore (as of October 18), a report showed on Monday, adding that on an annual basis, deposit growth has outpaced

credit offtake for the first time in the last 30 months. This growth can be attributed to rising term deposit rates of Scheduled Commercial Banks (SCBs), said the report by CareEdge Rat-

In absolute terms, deposits have expanded by Rs 17.3 lakh crore over the last nine months.

"Deposits have remained prominent in FY25 as banks have intensified efforts to strengthen their liability franchise. The banks are also sourcing funds via the certificates of deposits at a relatively higher cost," the report mentioned.

> GRSE is building four NGOPVs for the Indian Navy. According to chairman and managing director Cmde P R Hari, IN (Retd), though the keels of the first two vessels were ceremoniously laid during the day, work has already begun on all four.

"We are presently working on 43 platforms, including 17 warships for the Indian Navy. These 17 warships include the four NGOPVs. We are also handling eight export orders. These include a warship and two other platforms for Bangladesh. To date, we have delivered 72 warships to the Indian Navy and 36 to the Indian Coast Guard," Cmde Hari informed the gathering of senior officers of the Indian Navy, Indian Army, Indian Air Force, Indian



Coast Guard and classification societies. In the past, GRSE has built and delivered several Offshore Patrol Vessels (OPVs) to the Indian Navy and Indian Coast Guard. The shipyard also built the OPV CGS Barracuda, the first warship exported by India to Mauritius in 2014. GRSE bagged the Defence Minister's Award of Excellence for its in-house Design Effort for that warship.

The NGOPVs will be much larger warships than the OPVs built earlier and have greater endurance and firepower. These platforms will be about 113 metres long and 14.6 metres wide, with a displacement of 3,000 Tons. The NGOPVs will achieve speeds of up to 23 knots. Their endurance will be 8,500 nautical miles at a speed of 14 knots. The crew will comprise 20 officers and over 100 sailors.

The contract for these four warships was signed by GRSE on 30 March 2023. The total value of the order is Rs 3,555.75 crore and the first vessel is to be delivered in 44 months after the date of contract signing. The others are to follow in sixmonth intervals.

Greece uncovers 'terrorist' attack plan by domestic group



Athens, Oct 6 (IANS): Greek authorities have uncovered a "terrorist" attack plan by four Greek nationals suspected of participating in a domestic group, Greek Citizen Protection Minister Michalis Chrysochoidis said. A bomb that exploded prematurely in a central Athens apartment last Thursday, resulting in one casualty, one injury and severe material damage in the building, would have caused major destruction to any intended target, Chrysochoidis told local media on Monday.

The findings of an ongoing police investigation into the explosion so far indicate that a 36-year-old man who died, a 33-year-old woman who is hospitalised, a 31year-old man who was arrested last week and his 30-year-old girlfriend who was arrested on Monday, were members of a group of Greeks "aspiring to become the next generation of domestic terrorists," Xinhua news agency quoted the official as say-

The suspects have already been charged with formation and participation in a "terrorist" group, possession of explosives, construction of a bomb and involvement in "terrorist" acts, authorities said.



Spain: Floods hit Barcelona as rescue work continues in Valencia region

Madrid, Oct 6 (IANS): The region of Catalonia in the northeast of Spain was hit by flooding, as rescue work continues in the neighbouring region of Valencia in the wake of the floods that claimed 217 lives six days previously.

Spain's Minister for Transport, Oscar Puente, on Monday, confirmed that local rail services in the region had been cancelled after the Spanish Meteorological Agency (AEMET) issued a red alert for torrential rain for the provinces of Castellon, Tarragona and Barcelona, reports Xinhua news agency.

"Do not travel unless strictly necessary," informed Puente.

Barcelona's El Prat airport was badly hit by rainfall, estimated to be around 150 litres per square metre, with over 80 flights cancelled or delayed and numerous arrivals diverted to other airports. Images posted on social media from the airport show large areas under water, while parts of the terminal buildings were also flooded, with water cascading down flights of stairs. Several roads in the region have also been closed by the flooding, but fortunately, no lives have been reported lost.



UK to raise university tuition fees for first time in 8 yrs

London, Oct 6 (IANS): UK Education Secretary Bridget Phillipson has announced that university tuition fees in England will increase by 3.1 per cent next year, the first rise since 2016.

The hike, attributed to inflation, will bring the maximum annual fee up to 9,535 pounds (\$12,335). Alongside this, maintenance loans for students will also see a 3.1 per cent increase to help cover living expenses, reports Xinhua news agency. Phillipson highlighted financial challenges in higher education and hinted at upcoming reforms aimed at expanding access for disadvantaged students.



Iraqi militia claims six drone attacks on Israeli targets

Baghdad, Oct 6 (IANS): The Islamic Resistance in Iraq, a Shiite militia group, on Monday claimed respon-

94,000 children vaccinated in polio campaign in Gaza

United Nations, Oct 6 (IANS) : The UN-supported third phase of the polio vaccine campaign concluded in the besieged northern Gaza Strip, with 94,000 children vaccinated, but thousands still remain out of reach, according to UN agencies. Nearly 79 per cent of children in northern Gaza have been vaccinated against polio, the UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) said on social media on Monday. The third phase of the vaccine campaign, which had been postponed since October 23 due to the escalating conflict, resumed from Saturday to Monday during agreed-upon humanitarian pauses, reports Xinhua

news agency. Early Saturday morning, 216 medical teams, supported by the Palestinian Ministry of Health, the World Health Organization (WHO), the UN Children's Fund (UNICEF), UNRWA, and partners, deployed across 106 fixed sites in the north. In addition, more than 200 social mobilisers engaged communities and raised awareness around vaccination efforts, according to UN agencies. Richard Peeperkorn, a WHO official, said the target was to reach all children in the north with the second and final dose. "We covered many more children

than we expected, but we missed some," he said at a briefing via video for reporters at UN headquarters on Monday.

Sudan records 2 to 3 million malaria cases annually: Health minister Port Sudan, Oct 6 (IANS): the Sudanese Health Ministry

Sudanese Health Minister Haitham Mohamed Ibrahim said that Sudan records between two and three million malaria cases annually.

"Sudan records the highest rate of malaria infection in the Eastern Mediterranean Region," Ibrahim said on Monday at a press conference in Gedaref, the capital city of Gedaref State in Sudan. "Sudan also records the highest malaria death rate in the Eastern Mediterranean Region, accounting for 50 per cent of the total deaths," he noted, referring to the interventions undertaken by the ministry to reduce the malaria death rate, Xinhua news agency reported. launched the integration of the malaria vaccine into routine childhood vaccinations, covering Gedaref State and Blue Nile State in Sudan. "We have started introducing the

malaria vaccine approved by the World Health Organisation in the two states, to be followed by the rest of the high-risk states next year," the minister said.



New Delhi, Oct 6 (IANS) The chess world was marred by controversy when Japan-born American GM Hikaru Nakamura defeated the world champion Gukesh Dommaraju to secure a 5-0 victory for Team USA over Team India at the Checkmate: USA vs India and grabbed the Indian GM's king, tossing it into a cheering crowd and waved his arms in celebration.

The act sparked mixed reactions on social media, with many calling his celebration disrespectful. A video of Nakamura's act rapidly went viral on social media. FIDE CEO Emil Sutovsky also criticised Nakamura for his behaviour by posting on X, "The event was a show. Fans were ecstatic. Players were encouraged to behave accord-
