

### Telangana poised to lead way in digital agriculture: Sridhar Babu

#### Jubilee Hills by-election: Telangana Congress leader booked for 'violating' ECI guidelines

Hyderabad, Oct 7 (IANS) Congress leader Naveen Yadav, who is seen as the front-runner for the party ticket to the by-election to the Jubilee Hills Assembly constituency in Telangana, was on Tuesday booked by police for "violating" the Election Commission of India guidelines. On a complaint by an election officer, a case was registered against him for distributing voter ID cards and allegedly attempting to influence voters. The case has been registered at Madhura Nagar Police Station on a complaint by Electoral Registration Officer G. Rajinikanth Reddy. The action came after a local Telugu daily carried a report with photographs about a programme in Madhura Nagar, where Naveen Yadav distributed voter ID cards.

#### Seethakka pays tributes to Komaram Bheem on his death anniversary

Hyderabad, Oct. 7 (NSS): Minister for Panchayat Raj, Rural Development, and Women and Child Welfare Seethakka on Tuesday paid tributes to legendary tribal martyr Kumaram Bheem on his 85th death anniversary on Tuesday. She honoured the statue of Komaram Bheem by offering floral tributes at the Tank Bund in Hyderabad. The programme was organised by the Tribal United Forum Telangana. As she placed a garland on Komaram Bheem's statue, Seethakka received a warm welcome from tribal drummers and chanted the slogan, "Johar Komaram Bheem... We will fulfill the dreams of Komaram Bheem." Speaking on the occasion, the



Minister stated that the State government is dedicated to realising the aspirations of Komaram Bheem through initiatives aimed at tribal development. She highlighted that special Indiramma houses have been allocated for tribal families, land rights have been established under Sonia Gandhi's guidance, and specific measures have been introduced to promote tribal recruitment.



#### Congress rule filled with betrayal: KTR

Hyderabad, Oct. 7 (NSS) **BRS** Working President K.T. Rama Rao strongly criticised the Congress party, questioning how it could ask for votes again without fulfilling even a single promise it made.

"What face does the Congress have to seek votes from people after deceiving them for 22 months in power?" he asked. In a statement here on Tuesday, the BRS leader said the people across all sections of society are angry with the Congress and that it is certain the public will reject them in the upcoming elections.

#### Kavitha pledges Jagruthi's fight for tribal rights

Hyderabad, Oct. 7 (NSS): Telangana Jagruthi President Kalvakuntla Kavitha on Tuesday paid floral tributes to the statue of Komaram Bheem at the Tank Bund, Hyderabad to commemorate his birth anniversary. During her speech, Kavitha highlighted that Komaram Bheem was a remarkable leader who inspired the nation on how to fight for their communities across generations. "While the birth of some individuals enters the annals of history, the death of others also shapes history. Komaram Bheem, through his sacrifice, secured numerous rights for tribal people," she remarked. "Since the formation of Telangana State, appropriate recognition has been given to Komaram Bheem. The previous gov-



ernment provided annual funding of Rs. 25,000 to each tribal village for Gussadi festivals. In light of rising costs, the Congress government should increase this amount to Rs. 50,000 for these events.

#### Centre will buy **Cotton from Telangana farmers**

New Delhi, Oct. 7: Union Coal and Mines Minister Kishan Reddy has assured that the central government would support cotton farmers. He clarified that the farmers should not sell the cotton outside at a low price. He clarified that the CCI was buying cotton although it was delayed. #### Telangana set to break records with 148 lakh MT Paddy Production: Uttam

Hyderabad, Oct. 7 (NSS) Telangana is poised to achieve historic paddy production and procurement during the Kharif 2025–26 season, with an estimated output of 148.30 lakh tonnes and procurement target of 80 lakh tonnes, announced Irrigation and Civil Supplies Minister N Uttam Kumar Reddy. The total fund requirement for procurement at the Minimum Support Price (MSP) has been es-

timated at Rs 21,112 crore, of which Rs 19,112 crore is directly towards MSP payments to farmers.

Chairing a high-level review at Civil Supplies Bhavan, the Minister highlighted that 67.57 lakh acres has been cultivated this season - 40.75 lakh acres.

#### CEO holds meeting with political parties on jubilee hills by-election

Hyderabad, Oct 7 (NSS): Chief Electoral Officer C. Sudhar Reddy convened a meeting with representatives of various political parties on Tuesday, following the announcement of the schedule for the Jubilee Hills Assembly Constituency Bye-Election. Representatives from major political parties, including the Bharatiya Janata Party (BJP), Indian National Congress, Bharat Rashtra Samithi (BRS), Aam Aadmi Party (AAP),

and All India Majlis-e-Ittehadul Muslimeen (MIM) participated in the meeting. During the meeting, the CEO stated that the upcoming bye-election would be conducted under the new electoral reforms introduced by Chief Election Commissioner (CEC) Gyanesh Kumar, which are being rolled out for the first time during the Bihar Assembly Elections and the byeelections to eight Assembly constituencies across the country.

These reforms aim to enhance voter convenience, transparency, and efficiency in the conduct of elections. The key measures include, capping the number of voters per polling station at 1,200, to reduce overcrowding and improve voter experience.

Similarly, affixing colour photographs of contesting candidates on Electronic Voting Machines (EVMs) and ballot units, to help voters easily identify their preferred candidates. Deployment of additional women polling personnel to encourage greater participation of women voters. There is an enhanced accessibility measures for senior citizens and persons with disabilities, including ramps, wheelchairs, and pick-up/drop-off facilities.

There will be real-time voter turnout monitoring through digital dashboards.



#### Blood in PoK exposes Pakistan's narrative, silence of Kashmiri leaders

Tt is ironic that Pakistan, which calls Kashmir its "jugular vein", has unleashed a reign of terror in Lethe illegally occupied part of India's union territory. Innocent civilians are being mercilessly killed, communication lines have been cut, and their tales of horror are deliberately suppressed. Yet, videos emerging from Pakistan-occupied Kashmir (PoK) have exposed the falsehood Islamabad has been peddling since 1947. They have also unmasked those who, for decades, mischievously amplified anti-India propaganda regarding the situation in Jammu and Kashmir. For over 35 years, separatist voices claimed that the Muslim majority in J&K was "subjugated". Pakistan-backed leaders like Syed Ali Shah Geelani, Shabir Shah, Yasin Malik, Abdul Gani Bhat, and others bitterly attacked the Indian government while openly advocating Pakistan's cause.

Their sinister campaign, disguised under the slogan of "azadi", included the forced exodus of Hindus from the valley, clearing the way for an Islamic Kashmir to merge with Pakistan. But their lies never materialised. After the abrogation of Article 370 on August 5, 2019, Jammu and Kashmir has been fully integrated with the Union of India.

And, today, Pakistan's sustained lies about Kashmir are haunting its rulers. The uprising in PoK not only shatters their narrative but also exposes the forces within India who aligned themselves with Islamabad's propaganda and still are swayed by Pakistan's deceit. Curiously, those who accuse India of human rights violations in Kashmir are silent about Pakistan's atrocities in PoK. Where are the so-called champions of "human rights" now? Farooq Abdullah, Omar Abdullah, Mehbooba Mufti, Sajad Lone, Engineer Rashid, and members of the banned separatist groups are silent. These leaders never hesitate to raise their voice against human rights violations -- rare as they are -- but remain quiet when the Pakistani Army massacres its own people. Shouldn't they be leading protests in the streets? The selective silence has laid bare their hypocrisy. Instead of speaking out, some leaders continue to provoke valley youth against the Indian government. Mehbooba Mufti, for instance, posted on X: "From Uttarakhand to Ladakh & Damp; across the border in Kashmir, Gen Z is rising. Because when your future feels bleak & amp; your dreams are shattered -- resistance knows no borders." By equating Pakistan's brutal crackdown with domestic issues, she avoided condemning the violence in PoK -- perhaps to avoid upsetting Pakistan's deep state. But leaders like her must recognise that today's blood-soaked PoK is the result of seven decades of rot created by Pakistan itself.

The people of PoK are demanding bread, electricity, education, hospitals, jobs, and dignity. Instead of building industries and schools, Pakistan's rulers have turned PoK into a hub of terror camps. Since 1988, it has been used as a launchpad for terrorism against India. India's surgical strikes -- and the recent Operation Sindoor -- have destroyed many of these camps, eliminating hundreds of terrorists.

In stark contrast, today's Jammu and Kashmir is on a path of peace and prosperity. Crores of tourists are visiting, businesses are thriving, and the Central government schemes are reaching villages. The development is now reaching the grassroots and the marginalised. This sharp contrast has shaken the PoK residents. While J&K enjoys peace, prosperity, education, and healthcare, PoK continues to struggle for basic needs. The ongoing uprising should serve as an eye-opener for those in Kashmir misled into believing that Pakistan can offer a "better life" because it is an Islamic country. If that were true, why has PoK erupted in protest?

What we are witnessing in PoK is a grassroots revolution against decades of exploitation -- against hunger, unemployment, poor healthcare, lack of education, elitist privilege, and systemic corruption.

This unrest has been simmering for years, but came to the fore in May 2023 when people protested against skyrocketing electricity bills and wheat shortages. The movement, led by the Joint Awami Action Committee (JAAC), intensified in May 2024 with a long march to Muzaffarabad. Protesters were killed in violent clashes, and the agitation was temporarily halted with hollow promises by Islamabad.





IL-35 is a specific protein of IL-12 alpha and IL-27 beta chains which is encoded by the IL12A and EBI3 genes. The IASST team showed that IL-35 protects the immune system by lowering particular immune cells that produce inflammatory chemicals. This can help reduce pancreatic cell infiltration -- a key contributor to type 1 diabetes and autoimmune diabetes mellitus.



NHRC seeks answers from MP govt in incidents of child branding, electrocution deaths Bhopal, Oct 7 (IANS) The Na-

tional Human Rights Commission (NHRC) has taken suo motu cognisance of two separate incidents in Madhya Pradesh that raise grave concerns over the safety and dignity of children.

The Commission has issued notices to senior district officials, demanding detailed reports within two weeks.

The first incident, reported from Jhabua district, involves three children suffering from pneumonia who were allegedly branded with a hot iron rod by a local faith healer. Shockingly, the parents themselves had taken the children to the healer, believing in traditional practices over medical treatment. Doctors later confirmed that the children were indeed suffering from pneumonia.

The conservative CDU has taken a position against the AfD, but the CDU is not agreeable to any coalition understanding with Die Linke for their communist past. However, the CDU has agreed to discussions with the BSW, led by the former Di Linke stalwarts.

In the Thuringia parliament, the total seats number 89, so 45 seats are required to get a majority. The AfD has got 32 seats, but since no other party is ready to support AfD to form a government, the other three parties with a total of 46 seats are in a position to form a government if they agree on programme.



#### 'Six and eleven, NDA...': Lalu Yadav taunts Nitish govt after Bihar poll dates announcement

A day after the Election Commission announced polling dates for Bihar Assembly elections, former Bihar Chief Minister and Rashtriya Janata Dal (RJD) chief Lalu Prasad Yadav took potshots at the Nitish government, suggesting that the double-engine government in the state was staring at a departure from power.

#### **BJP'S KERALA UNIT BADLY** BATTERED BY HAWALA EXPOSE

**¬**he Bharatiya Janata Party's (BJP) Kerala unit has been shaken to the core by the 'expose' by the former office secretary of the party in Thrissur, Tirur Satish. The damning disclosure is that the Rs 6 crore of "black money" stolen from a car at Kodakara in Thrissur district in the run -up to the 2021 Assembly elections was part of a tranche of secret election funds for the BJP in the State. Not surprisingly, the expose has touched off a demand for re-investigation. Kerala Chief Minister Pinarayi Vijayan has had a meeting with the State police chief and decided to re-investigate the scam. Legal experts are learnt to have told the Government that it could go for a re-investigation in the matter.

The immediate effect of the expose will be that it will badly affect the BJP candidate's chances of a victory from the Palakkad assembly constituency, a BJP stronghold, which is going to the polls on November 20. The by-election has been necessitated after the Palakkad MLA Shafi Parambil won the parliamentary election from the Vadakkara Lok Sabha constituency. The raging controversy has exposed the party's claim of being a party with a difference. In the wake of the expose, the party has become the butt of many a joke. Political rivals say the BJP has now metamorphosed into a party with full of differences! It all began with the Tirur Satish

dropping the bombshell that the black money sent from Karnataka was meant for BJP's election campaign. Satish claimed he guarded the six bags containing the black money at the BJP's Thrissur office, allegedly in the presence of party state president K. Surendran. In an ambush operation, which



took place days later, anonymous persons stole the cash which was being transported to Alappuzha in a car. The Kerala police acted fast and arrested 23 people in connection with the theft. Satish said he had not reported the matter to the police at the party leadership's instance. His statement to the police was that the six bags contained only election material! He came to know that the bags contained cash only when it was opened in the presence of BJP

leaders and the money distributed

to various party leaders later. The

man who brought the money from

Karnataka, Dharmarajan, was close to K. Surendran, according to a statement he made to the police. One of the first persons Dharmarajan contacted on phone after the theft was K. Surendran's son. And he reportedly made as many as 11 calls. Dharmarajan's claim was that he was caring only Rs 25 lakh while on his way to Alappuzha. But the police recovered over Rs 1.75 crore from the arrested persons. The Kerala police had submitted a detailed report to both the Enforcement Directorate(ED).



#### **Three Palestinians killed** by Israeli gunfire in West Bank: Health ministry

Ramallah, Oct 7 (IANS): Three Palestinian men were killed by Israeli army gunfire in the town of Qabatiya, south of Jenin in the northern West Bank. Local sources and witnesses said Israeli soldiers fired live ammunition at a car after ramming it with a military vehicle to force it to stop. The Palestinian Red Crescent Society confirmed that its workers transported the bodies of two men from inside the vehicle to a medical complex in Qabatiya.

A third victim, according to Palestinian security sources, was on the roof of his family's home when Israeli soldiers shot him. He was taken to Al-Razi Hospital in Jenin, where he was later pronounced dead.

### IMF sends team to Pakistan for early review; govt cynical of visit

The International Monetary Fund (IMF) has decided to do an early review of Pakistan's \$7 billion bailout package, scheduling a dispatch of its mission to Islamabad in the coming week.

This is a decision that many believe is a result of Islamabad's uneven performance in compliance with its implementation agreement with the global lender.

As per official sources, a dispatch mission of the IMF to Pakistan will be landing in Islamabad next week, at least four months ahead of its planned schedule to evaluate Islamabad's performance with the IMF on its \$7 billion bailout package under the Extended Funding Facility (EFF).

IMF Pakistan Mission Chief Nathan Porter will lead the delegation, which will be

Islamabad, Oct 7 (IANS): tasked to review Islamabad's performance and its compliance with around 40 conditions mutually agreed upon at the time of the loan approval.

> Economist Shahbaz Rana said that the early arrival of the IMF mission to Pakistan underscores the importance of the programme for IMF board members.

"While the early arrival of the IMF mission provides Pakistan with an opportunity to reassess targets, some of which, the government of Pakistan believes may have already become irrelevant one month after the loan's approval," he said. Pakistan government sources maintain that the IMF visit is to review the performance during July-September quarter.

Pertinently, IMF has conducted performance reviews of Pakistan on a quarterly basis. However, as per the new bailout programme, both parties agreed to have biannual assessments.

On the other hand, the early re-



view of Pakistan's performance by the IMF also rings alarm bells due to the mixed performance and early setbacks. Pakistan Prime Minister Shehbaz Sharif-led government is also cynical about the early visit of the IMF team.

Voices within the government quarters maintain that while the opportunity gives way for resetting certain targets through negotiations during the early review; others suspect a tough session and questionnaire by IMF, arguing that the IMF's stance during the loan approval left less or no room for renegotiations.

Experts believe that if the Paki-

stan government retains the original targets as committed to the IMF, it would be compelled to table a minibudget and handle the shortcomings of the first quarter and address the gaps forecasted for the second quar-

As per details, Pakistan has witnessed a mixed performance in the first quarter with the State Bank of Pakistan (SBP) meeting its targets and finance ministry surpassing its quarterly target. However, FBR (Federal Board of Revenue).



#### **Heavy rains** kill five in Panama

Panama City, Oct 7 (IANS): Heavy rains caused by a recent tropical depression have killed at least five people, including two minors, in Panama. The National Civil Protection System (Sinaproc) said on Tuesday that four of the five fatal victims were drowned and the other one was killed in a landslide.

On Monday, the National Hurricane Center reported that the tropical depression located north of Panama strengthened into tropical storm Rafael, with winds of more than 63 kph, Xinhua news agency reported.



#### Three killed in landslide in Cameroon

Yaounde, Oct 7 (IANS): At least three people were killed in a landslide in Cameroon's West region, according to the region's Governor Augustine Fonka Awa

Heavy rains triggered a landslide at a steep hill at La Falaise locality in Dschang town of the region, blocking road access, Xinhua news agency reported. The authorities deployed excavators to reopen the closed roads, but a sub-

sequent landslide buried emergency workers and vehicles that were waiting for the road to be cleared, Awa told reporters on Tuesday evening. "Three passenger buses, motorcycles and vehicles that were working on the site were buried in the debris. At the moment three corpses have been extracted. Rescue workers are still searching for missing people in the rubble," Awa said.

#### North Korean leader Kim tells Putin that alliance will 'invariably' carry forward in future

Seoul, Oct 7 (IANS) North Korean leader Kim Jong-un has told Russian President Vladimir Putin that their alliance "will be invariably carried forward in the future," as Pyongyang and Moscow have deepened military cooperation over Russia's war against Ukraine.

Kim made the remarks in a letter sent to Putin that congratulated the Russian leader on his birthday, according to a report by the North's Korean Central News Agency (KCNA).

"I do not doubt that the relations of alliance between the two countries, which have greeted the great heyday, will

be invariably carried forward in the future, too, thanks to the warm friendly relations and close comradely ties between us, and will make a great contribution to powerfully propelling the comprehensive development of bilateral relations and establishing a just and multi-polarized world order," Kim told Putin, according to the KCNA report.

Since October last year, North Korea had sent about 15,000 troops and weapons to aid Russia's war efforts, according to South Korea's spy agency.

In the letter, Kim also said he will fully support the "just struggle" of Russia in defending its national sovereignty, apparently referring to Moscow's invasion of Ukraine,



Yonhap news agency reported. Earlier on August 13, North Korean leader Kim Jong-un had expressed his "full support" for Russia during his phone talks with Russian President Vladimir Putin, as the two nations have been deepening military cooperation.

Kim and Putin had held phone talks the previous day, KCNA had reported, marking the first time that the North has disclosed details about its leader's phone con-

versation with a foreign leader. Kim had "expressed firm conviction that the DPRK would always remain faithful to the spirit of the DPRK-Russia treaty and fully support all measures to be taken by the Russian leadership in the future," the KCNA said.

DPRK is the acronym of North Korea's full name, the Democratic People's Republic of Korea.



#### **UN continues to deliver** humanitarian aid to Lebanon

**United Nations, Oct 7 (IANS)** : UN agencies and partners continue to deliver humanitarian aid to the crisis-impacted people in Lebanon amid escalating hostilities, Stephane Dujarric, spokesperson for the UN chief, said at a daily briefing. On Tuesday, UN Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) delivered medical supplies and fuel for generators to the Burj Shimali Palestinian refugee camp in Tyre in Lebanon. A humanitarian convoy also delivered medical supplies, medicine and hygiene kits to a health care centre in Labweh, located in the Baalbeck-El Hermel area. Meanwhile, the World Food Programme (WFP) has already reached over 2 million vulnerable people in the country through its emergency assistance as well as regularly initiatives.

#### Pakistan: Politicians fight over flood relief efforts, **Zardari summons Interior Minister**

Islamabad, Oct 7 (IANS) The ongoing dispute between the governments of Sindh and Punjab provinces in Pakistan over flood relief efforts has intensified, the local media reported on Tuesday.

It was reported that the country's President Asif Ali Zardari stepped in to ease tensions between the Sindh and Punjab governments after a heated exchange over flood relief efforts turned into a public debate challenge between top provincial leaders.

"According to sources, President Zardari spoke with Federal Interior Minister Mohsin Naqvi over the phone and discussed the escalating rift between the two provinces. The President has summoned the Interior Minister to Karachi for an immediate consultation on the matter," Pakistan's leading media outlet Samaa TV reported.

The move aims at de-escalating growing political tensions as both provincial governments have accused each other of mismanagement and lack of transparency amid the devastating floods that has

displaced millions across the country. "The dispute intensified when PPP leader and MNA Sharmila Farooqi, in a morning show last week, criticised Punjab's handling of relief operations and challenged the province to a performance comparison. Punjab government spokesperson Uzma Bukhari swiftly responded, accepting the challenge and asserting that Punjab had maintained a transparent and systematic relief mechanism," Samaa TV reported. PPP Chairman Bilawal Bhutto's spokesperson and



Karachi Mayor Murtaza Wahab added to the heated exchange by slamming Punjab's stance.

As heavy rains and strong winds wreaked havoc across several districts of Pakistan's Punjab province over the past 24 hours, four people were killed and 28 others injured due to roof and wall collapses, according to the Rescue 1122 spokesperson, local media reported on Monday.

Two people were injured in Lahore after parts of buildings collapsed due to the storm. Punjab province has witnessed record rainfall during the past 24 hours, according to the Provincial Disaster Management Authority (PDMA).

The PDMA spokesperson warned that rainfall is expected to continue in the majority of districts over the next 24 hours, including Rawalpindi, Murree, Galyat, Attock, Lahore, Jhelum, Gujrat, Sialkot and Gujranwala.

## Committed towards delivering six more ASW SWCs to Navy within schedule: GRSE

Visakhapatnam, Oct 7 (IANS) The Navy will receive six more Anti-Submarine Warfare Shallow Water Crafts (ASW SWCs) well within schedule, Commodore P R Hari, IN (Retd), chairman and managing director, Garden Reach Shipbuilders and Engineers (GRSE) Ltd, assured during the commissioning ceremony of the INS Androth at the Naval Dockyard in Visakhapatnam.

The INS Androth is second in a series of eight ASW SWCs being built by GRSE for the Navy. "GRSE is proud to build these highly potent ASW SWCs for the Indian Navy, and we are confident of delivering the balance ships of the project as per the contractual delivery schedule," Cmde Hari

The ship was delivered by GRSE on September 13, 2025. Named after Androth Island in the Lakshadweep Archipelago, this warship is also the second warship of this class on which an indigenous 30 mm Naval Surface Gun (NSG), manufactured by GRSE, has been fitted.

The Indian Navy has placed an order for 16 Advanced ASW

SWCs, with eight (08) to be built by GRSE and eight (08) to be built by Cochin Shipyard Ltd. GRSE has already delivered the first two of these 16 vessels.

ASW SWCs have nearly 88 per cent indigenous content, displaying GRSE's commitment towards the Government of India's Atmanirbharta and 'Make in India' vision.

These ships are capable of fullscale sub-surface surveillance of coastal waters, as well as Search and Attack Operations. They can also carry out coordinated antisubmarine operations with aircraft. These ships have Combat Management Systems on board and will be armed with lightweight torpedoes as well as anti-submarine warfare rockets. These ships will have a complement of 57 personnel, including seven officers. With three water jets (fitted to marine diesel engines), Androth is extremely agile and maneuverable. A great advantage is that she only requires a draught of 2.7 metres, allowing her to access the coasts easily in search of sub-surface threats. These are also the largest water-jet platforms to be operated by the Navy. "In this journey of Atmanirbharta, the support provided by the Indian shipbuilding industry, especially GRSE, one of our finest defence PSU shipyards, has been invaluable. Constructed by the GRSE, Androth, with more than 80 Per cent of the indigenous content, stands as yet another testament to India's growing capability to design, develop, and deliver sophisticated platforms that meet the highest operational standards. The ship symbolises what can be achieved when Indian skill, technology, and above



all determination come together in pursuit of a common national purpose," Vice Admiral Pendharkar, Flag Officer Commanding-in-Chief, Eastern Naval Command, said during the ceremony. GRSE is currently building 13 more warships, including two P17A advanced stealth frigates, six ASW SWCs, a Survey Vessel (Large), and four Next Generation Offshore Patrol Vessels. Apart from this, the shipyard is building 30 other vessels, thirteen of which are export platforms.

## India-Qatar bilateral trade can surpass \$28 billion by 2030: Piyush Goyal

New Delhi, Oct 7 (IANS) The bilateral trade between India and Qatar, standing at around \$14 billion, could be doubled by 2030, with a renewed focus on promising sectors such as electronics, automobiles, pharmaceuticals, processed food, textiles, gems and jewellery, IT, and emerging hightech industries and solar energy, according to Commerce Minister Piyush Goyal. He also underscored the importance of greater business interactions, and the success of the first face-to-face Joint Business Council meeting in fostering deeper economic ties.

Goyal co-chaired the Qatar–India Joint Commission on Economic and Commercial Cooperation with H.E. Sheikh Faisal bin Thani bin Faisal Al Thani, Minister of Commerce and Industry of Qatar. The event focused on strengthening bilateral trade and investment ties, addressing existing trade barriers and non-tariff challenges, and identifying new opportunities to boost economic cooperation across key sectors. Both sides reaffirmed their shared commitment to pursuing an ambitious India-Qatar Comprehensive Economic Partnership Agreement. While appreciating Qatar's energy exports, including the long-term LNG supply agreement of 7.5 million tonnes per year from 2028. Goyal stressed the need to boost India's exports to Qatar.

A bilateral meeting of commerce and industry ministers of both sides was also held, where both Ministers reviewed the overall trade and economic relationship, addressed existing trade barriers, and explored new areas for cooperation in sectors such as finance, agriculture.





#### State finances, dept budget disturbed due to Ladki Bahin Yojana: Maha minister Bhujbal

Mumbai, Oct 7 (IANS) Maharashtra minister of food and civil supply Chhagan Bhujbal on Tuesday said that the implementation of much debated Mukhyamantri Majhi Ladki Bahin Yojana has disturbed the state finances and the budget of all departments. This is for the first time since the launch of the scheme ahead of the state assembly elections last year, a minister from the MahYuti government has made this statement. "I feel that the expenditure on Ladki Bahin Yojana is affecting the implementation of Anandacha Shidha (distribution of sugar and food grains during festive season under the public distribution scheme). Because almost Rs 40,000 to 45,000 crore are spent on Ladki Bahin Yojana and if you are to compensate these.

## EAM Jaishankar calls for balanced approach to Al, says trust and safety must guide innovation

New Delhi, Oct 7 (IANS) External Affairs Minister (EAM) S. Jaishankar, addressing the inaugural session of the Trust and Safety India Festival (TASI) 2025, underscored the transformative potential of Artificial Intelligence (AI) while urging a balanced and responsible approach to its governance.

The event, held on Monday, served as a pre-summit gathering ahead of the AI Impact Summit scheduled for February 2026. Speaking at the event, Jaishankar highlighted how technology has always shaped human progress but warned that its outcomes depend on the choices societies make.

"In human history, the advancement of progress has been determined by the march of technology. Yet, that has not always been a linear path. The promise and the perils have always been two sides of the same coin. Choices made in the deployment and application decided the difference between empowerment and exploitation, between democratisation and domination, and between partnership and polarisation," he said. "Today, we are at the cusp of an immense change, and decisions made by us, individually and collectively, will help decide the fate of the foreseeable future," he said. The EAM noted that AI, in the coming years, would profoundly transform economies, reshape work habits, create innovative health solutions, enhance access to education, improve efficiencies, and even redefine lifestyles.

"The difference with the past is that this particular transformation that is going to come upon us -- this will be all-pervasive and not just sectoral. It will impact every citizen in every corner of the world. New efficiencies and new possibilities will certainly emerge, but so too will new players and new power



centres," he said. He stressed that this makes it vital "to adopt a balanced approach to the governance of AI and to ensure that there are adequate guardrails in place to protect digital nagriks".

Quoting Prime Minister Narendra Modi, Jaishankar said, "Technology is a force for good, but only if humanity guides it."

He added that trust and safety form the cornerstone of responsible AI governance. For a country like India, he explained, this requires the development of indigenous tools and frameworks, self-assessment protocols for innovators, and the creation of appropriate guidelines.

"Only then can we be assured that the development, deployment, use and governance of AI is safe and accessible," he said. Emphasising India's global leadership in digital governance, the EAM said, "India bears a special responsibility because many other nations -- especially those of the Global South -- look to us for inspiration. Certainly, in the case of digital public infrastructure, what we have achieved in the last decade, the scale of delivery, the improvement in governance, and the efficiencies with which we serve the public are already resonating across the world."

## Cyber crimes and online propaganda pose new threats: Arunachal Guv Itanagar, Oct 7 (IANS) versity (RRU), Pasighat



#### IPOs in S. Korea rise 19 pc through Q3

Seoul, Oct 7 (IANS) Initial public offerings (IPOs) in South Korea rose 19 per cent in the first nine months of the year from a year earlier, data showed on Tuesday.

The proceeds from IPOs stood at 3.41 trillion won (\$2.43 billion) in the January-September period, compared with 2.85 trillion won for the same period last year, according to the data from consulting service provider IR Kudos Corp, reports Yonhap

A total of 55 companies made their debuts on the main bourse KOSPI and the techheavy KOSDAQ markets during the cited period, up from 47 companies going public a year earlier.

LG CNS Co., an information technology affiliate of LG Electronics Inc., amassed the largest amount of IPO money at 1.19 trillion won, followed by DH Shipbuilding Co. with 500 billion won and Seoul Guarantee Insurance Co. (SGI) at 182 billion won, according to the data.

The consulting firm said IPOs will increase during the rest of the year amid a bullish run, the data said.

The country's benchmark index, the KOSPI, has advanced more than 43 per cent so far this year.

#### Gold hits fresh record high on MCX amid US economic uncertainty

Mumbai, Oct 7 (IANS) Gold prices hit fresh record highs in morning trade on the Multi Commodity Exchange (MCX) on Tuesday, as investors turned to the precious metal amid growing global uncertainties and expectations of more rate cuts by the US Federal Reserve. MCX Gold December futures touched an all-time high of Rs 1,20,769 per 10 grams. Around 9:15 am, gold was trading 0.43 per cent higher at Rs 1,20,769 per 10

grams, while MCX Silver December futures were up 0.12 per cent at Rs 1,47,701 per kg.

In the international market, gold prices also surged to record highs as investors sought safe-haven assets due to rising economic and political tensions in the United States.



#### Zomato introduces feature to 'rescue' over 4 lakh cancelled food orders a month

New Delhi, Oct 7 (IANS): Online food delivery platform Zomato on Tuesday launched a new feature called 'Food Rescue' to save more than 4 lakh orders being get cancelled on the platform every month for various reasons by customers. Zomato CEO Deepinder Goyal said cancelled orders will now pop up for nearby customers, who can grab them at an unbeatable price, in their original untampered packaging, and receive them in just minutes. The original customer, and those in their immediate vicinity, will not receive the option to claim the order. "The canceled order will pop up on the app for customers within a 3 km radius of the delivery partner carrying the order. To ensure freshness, the option to claim will only be available for a few minutes," said Goyal.

He said that Zomato will not keep any proceeds (except the required government taxes).

"The amount paid by the new customer will be shared with the original customer (if they made payment online), and with the restaurant partner," said the CEO on X social media platform. According to Zomato,



orders containing items sensitive to distances or temperature such as ice creams, shakes, smoothies, and certain perishable items, will not be eligible for Food Rescue. "Restaurant partners will continue to receive compensation for the original cancelled order, plus a portion of the amount paid by the new customer if the order is claimed. Most restaurants have opted in for this feature, and can opt of it easily whenever they want, directly from their control panels," informed Goyal. According to the company, 99.9 per cent of its restaurant partners want to be a part of this initiative. Delivery partners will also be compensated fully for the entire trip, from the initial pickup to the final drop-off at the new customer's location, he added.

#### Time to buy a property in India down to 26 days, ultra-luxury homes selling faster

### SIP inflow hits Rs 25,000 crore for 1st time, equity fund inflows at record Rs 41,887 crore

Mumbai, Oct 7 (IANS): The monthly systematic investment plan (SIP) inflow made a new all-time high in India at Rs 25,323 crore in October, from Rs 24,509 crore in September, according to the latest data from the Association of Mutual Funds in India (AMFI) on Tuesday. The SIP inflow was recorded at Rs 16,928 crore in the same month last year.

The number of SIP accounts stood at its highest ever at 10.12 crore in October 2024. It was 9.87 crore in September. Net 24.19 lakh SIP accounts were added in the last month. According to AMFI data, open-ended mutual funds performed well in October. This was the 44th consecutive month that inflows into equity mutual fund schemes have been positive. Open-ended equity mutual fund

inflows surged 21.69 per cent on a month-on-month (MoM) basis to Rs 41,887 crore in October. Last month, strong investment was recorded in all categories including smallcap, midcap, and largecap. Inflows into the largecap fund category doubled on a monthly basis in October to Rs 3,452 crore. Net investment in the midcap fund category increased by 50 per cent on a monthly basis to Rs 4,683 crore. Inflows into the smallcap fund category surged by 23 per cent on a monthly basis to Rs 3,772 crore. The increase in mutual fund inflows came at a time when the stock market per-



formance remains weak. Sensex and Nifty have fallen by 5.77 per cent and 6.22 per cent, respectively in October. Inflows into sectoral and thematic funds fell 7 per cent month-on-month to Rs 12,279 crore in October. Last month, new fund offers in the sectoral and thematic funds cat-

egory raised Rs 3,517 crore. There was an inflow of Rs 1,57,402.30 crore in the fixedincome category, debt mutual funds. The highest investment of Rs 83,863 crore was recorded in the short-duration liquid fund category in October.

Gangtok, Oct 7 (IANS): The tion, with Prof. Mahendra P. Lama, a senior economist and professor. Lama has been given the vice-chairman position in the committee.

The committee comprises distinguished members from various academic, administrative, and social backgrounds, including experts in anthropology, sociology, and public administration.

The committee will conduct an ethnographic and anthropological study of the 12 communities in question – Bhujel, Gurung, Jogi, Kirat Khambu Rai, Kirat Dewan (Yakha), Khas (Chettri-Bahun), Mangar, Newar, Sanyashi, Sunuwar (Mukhia), Thami, and Majhi. "They will assess sociocultural, historical, ecological, and constitutional factors to substantiate why these communities



should qualify for ST status, aligning with criteria laid out in the Indian Constitution," the official added. Meanwhile, the high-level committee will also analyse potential socio-economic, cultural, and national interest benefits that the inclusion of these communities could provide, particularly for Sikkim and the wider Himalayan region.

There is a law that grants equal status to the safety, rights, and expression of every citizen. What happened in Raebareli is a grave crime against the Constitution of this country. It is a crime against the Dalit community and a stain on this nation and society." The party said that the number of crimes against Dalits, minorities, and the poor has "increased beyond limits", adding that "this violence disproportionately affects those who are deprived, marginalised.



#### Nigerian national detained in Delhi for overstaying visa, deportation initiated

New Delhi, Oct 7 (IANS) In a significant crackdown on illegal foreign nationals, the Operations Cell of the South West District Police has successfully traced and detained a Nigerian national found to be overstaying in India, Delhi Police said on Tuesday. The team was briefed to identify illegal migrants by conducting thorough checks, particularly in vulnerable areas of the South-West District," the police statement read.

According to the officials, on October 3, the team received a tip-off about a suspicious foreign national roaming in the Nangal Raya and Vasant Kunj South area. Upon intercepting the individual and conducting a thorough verification, it was revealed that Malachy had entered India on March 15, 2021, on a medical visa.

#### Nepali gangster Bhim Jora, wanted in multiple cases, killed in Delhi encounter



New Delhi, Oct 7 (IANS) A wanted Nepali gangster, Bhim Mahabahadur Jora, was shot dead in a police encounter at Astha Kunj Park near New Delhi's Nehru Place, officials said on Tuesday. The 30-year-old criminal, carrying a cash reward of Rs one lakh, was wanted in multiple heinous crimes, including murder, dacoity, and a recent Rs 20 lakh burglary in Gurugram, Haryana, at the residence of a BJP functionary, according to the police. One sophisticated automatic pistol, one live round, empty cartridges and a bag containing housebreaking tools have been recovered by the police.

The officials also mentioned that the operation was led by Inspector Narendra Sharma of the Sector 43 Crime Branch.

#### No arrests in connection with attack on BJP MP Khagen Murmu yet

Kolkata, Oct 7 (IANS) Even after 24 hours since While Ghosh sustained minor the attack on BJP MP Khagen Murmu, no one has been arrested so far in this connection.

On Monday night, the BJP filed a complaint against eight people at Nagrakata Police Station in Jalpaiguri district and staged a protest outside the police station, demanding action against the accused. The police on Tuesday said the matter is being investigated. "We have received a complaint. Based on that, an investigation has started. However, no one has been arrested so far," said a senior officer of Jalpaiguri district police.

BJP Maldaha Uttar MP Khagen Murmu and MLA Shankar Ghosh were brutally attacked by miscreants while on their way to meet the North Bengal landslides-affected people and distribute relief mabruises, the two-time BJP MP sustained serious injuries to his face and head.

The BJP MP was immediately rushed to a primary health centre for treatment. At present, the BJP MP is undergoing treatment at a hospital in Siliguri, and his condition is stable.

Following the attack, the BJP pointed fingers at the Trinamool Congress for the crime and slammed Chief Minister Mamata Banerjee for her "failure" to ensure security to an elected MP. In the wake of that incident, the

### After Karur stampede, Vijay plans volunteer force, new leadership

Chennai, Oct 7 (IANS) In the wake of the devastating stampede at the TVK rally in Tamil Nadu's Karur, which claimed 41 lives and left over 100 injured on September 27, party president and actor Vijay is preparing to overhaul the organisation and tighten event safety.

According to party insiders, Vijay is working on a comprehensive restructuring plan that includes creating a dedicated

volunteer force and nurturing a fresh tier of second-line leadership to strengthen the party ahead of the 2026 Assembly elections.

The Karur tragedy, described by eyewitnesses as a result of "gross mismanagement" and poor crowd control, has deeply shaken the TVK leadership.

The rally venue, which could accommodate just 2,000-3,000 people, saw nearly 30,000 supporters gather, and chaos broke

out when Vijay climbed onto his campaign vehicle to greet the crowd.

The stampede exposed glaring lapses in safety protocols and left the party facing both public outrage and legal scrutiny. Learning from the disaster, Vijay is now planning to establish a special volunteer force similar to those maintained by major Dravidian parties like DMK, AIADMK, MDMK, and DMDK.

We call upon the British government, whose predecessor governments were responsible for pillaging and brutalizing us, to take responsibility and not remain indifferent to the cries of Zimbabweans for justice," he said.

Mnangagwa made the same call to Britain last Friday while announcing an initiative to study the impacts of Britain's colonial-



and apology. On Tuesday, Mnangagwa hailed the Zimbabwe National Elders Forum for the initiative, Xinhua news agency reported.

"I applaud our elders for this great initiative that will document the suppressed and untold story of the injustices, trauma, and loss of lives as well as livelihoods suffered at the hands of the British government," he said.

Tally Einav, the UNIDO representative to Kenya, Eritrea, South Sudan, Seychelles and Comoros, said that for African nations to sustain industrialization, harnessing local innovations, and sharing of best practices and skills development is critical.

Speaking at a forum here ahead of the African Industrialization Week, which will be held in Kampala, Uganda, from November 25 to 29, Einav said the continent is on the cusp of an industrial takeoff that promises shared prosperity, competitiveness of locally manufactured goods and job creation.

"We acknowledge that industrialization is vital to addressing socioeconomic challenges including poverty, unemployment and inequality," Einav said. Sustainable industrialization must be at the core of Africa's efforts to meet the sustainable development goals and achieve the aspirations of Agenda 2063, she added, Xinhua news agency reported. This year's Africa Industrialization Week will be held under the theme of "Leveraging Artificial Intelligence (AI) and Green Industrialization to Accelerate Africa's Structural Transformation." Einav said that multilateral institutions have rallied behind the continent's industrialization agenda that seeks to boost value addition and exports besides injecting vitality into supply chains.

#### IAEA chief warns of 'growing risks' after shelling near Zaporizhzhia nuclear plant

Vienna, Oct 7 (IANS) Multiple rounds of shelling were heard at the Zaporizhzhia Nuclear Power Plant (ZNPP) amid the longest off-site power loss of the plant, posing "growing risks" to its nuclear safety and security, according to a UN nuclear watchdog statement. The shelling occurred in the afternoon, totalling about 15 rounds at near and middle distance from the site. The ZNPP informed the International Atomic Energy Agency (IAEA) that two rounds of shelling struck around 1.25 km from the site perimeter, the IAEA statement said. No casualties have been reported and there was no immediate information of any damages. However, IAEA Director General Rafael Grossi said the shelling further underlined the constant dangers facing the ZNPP, Xinhua news agency reported. "The nuclear safety and security situation is clearly not improving. On the contrary, the risks are growing," Grossi said. "The plant has now been without offsite power for almost two weeks, forcing it to rely on emergency diesel generators for the electricity it needs to cool its shutdown reactors and spent fuel. This is an extraordinarily challenging situation." In the statement, Grossi called for "maximum military restraint near nuclear facilities" and said he will continue to engage with Russia and Ukraine to restore the plant's off-site power as soon as possible. The ZNPP lost the connection to its last remaining 750 kilovolt line on September 23 during the conflict.

#### **Drone technology is expected** to revolutionise India's marine fisheries sector

Kochi, Oct 7 (IANS): From early detection of algal blooms to feed broadcasting in mariculture to rescue operations during emergency situations, drone technology is expected to revolutionise India's marine fisheries sector. A joint effort of the Union Ministry of Fisheries, National Fisheries Development Board (NFDB) and ICAR-Central Marine Fisheries Research Institute (CMFRI) is on to promote and popularise drone applications in the country's marine fisheries. This initiative aims to significantly enhance the efficiency of fisheries management,



sea cage farming, disaster management and ecosystem conservation. An awareness workshop and drone demonstration for fishermen and fish farmers will be held at CMFRI on November 8 to showcase the prospects of drone applications for various purposes.

### Govt promoting straw as manure: Haryana minister

Chandigarh, Oct 7 (IANS): Haryana Agriculture Minister Shyam Singh Rana on Tuesday said the government is promoting the use of straw as manure by encouraging farmers to incorporate it into their fields. This practice not only enhances soil fertility but also

provides economic benefits to farmers. Rana said incorporating crop residue into the soil boosts the levels of carbon and other nutrients, leading to higher yields in subsequent crops.

"Scientific research has demonstrated that mixing straw into the soil strengthens the nutrient cycle and increases soil carbon levels, which in turn improves the yield of future crops," he said.

He said many progressive farmers are now using crop residues as fertilizer by incorporating them into the soil. This approach not only boosts crop yields by three to five quintals per acre annually


but also reduces costs by lowering urea consumption.

Citing the example of farmer Rajesh Saini from Bakana village in Yamunanagar district, the minister said instead of burning stubble, Saini has been mixing it into his fields for the past three years. As a result, his crop yield

has increased by about six quintals per acre, leading to an annual income boost of Rs 10,000 to Rs

15,000 per acre. Haryana cultivates paddy on approximately 28 lakh acres, and the government's awareness campaign has significantly reduced stubble-burning cases this season.




